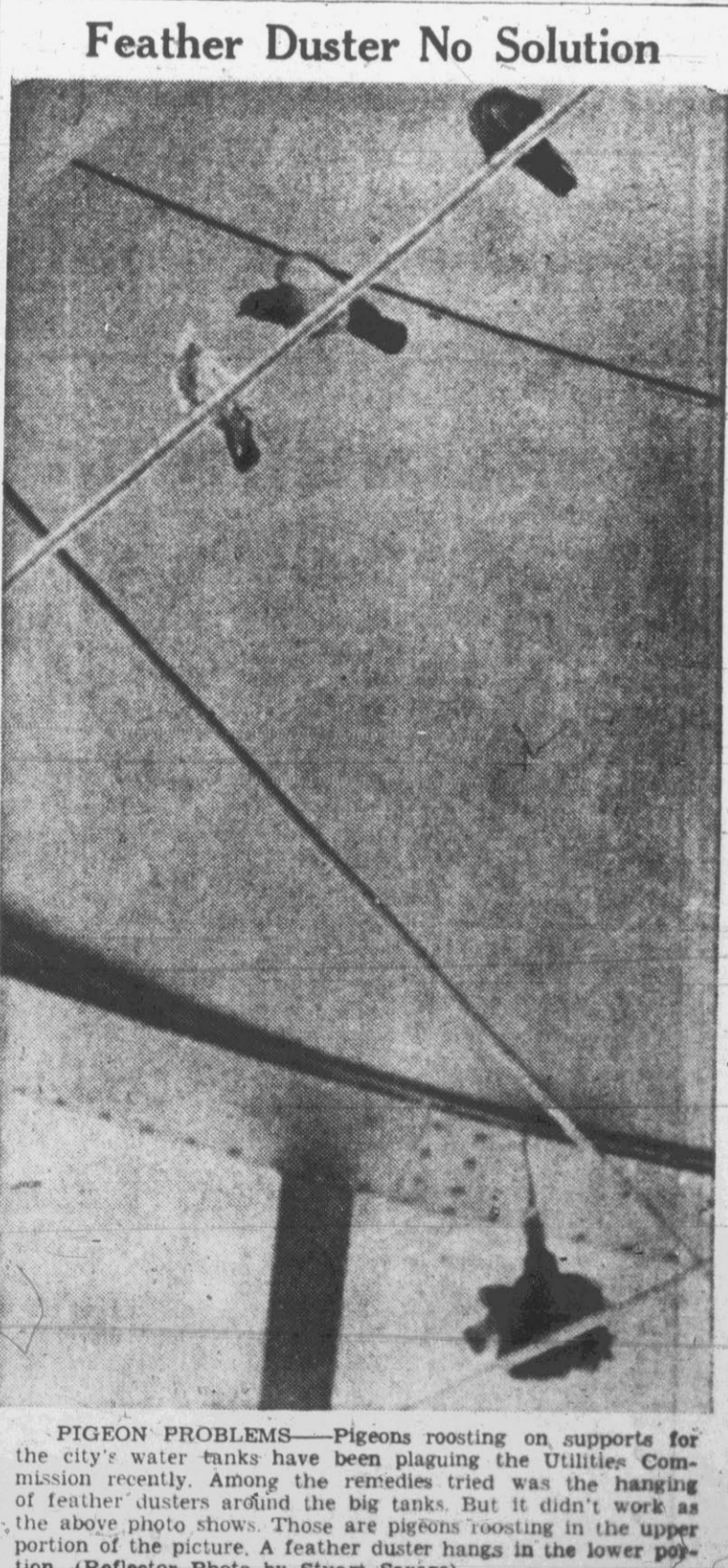

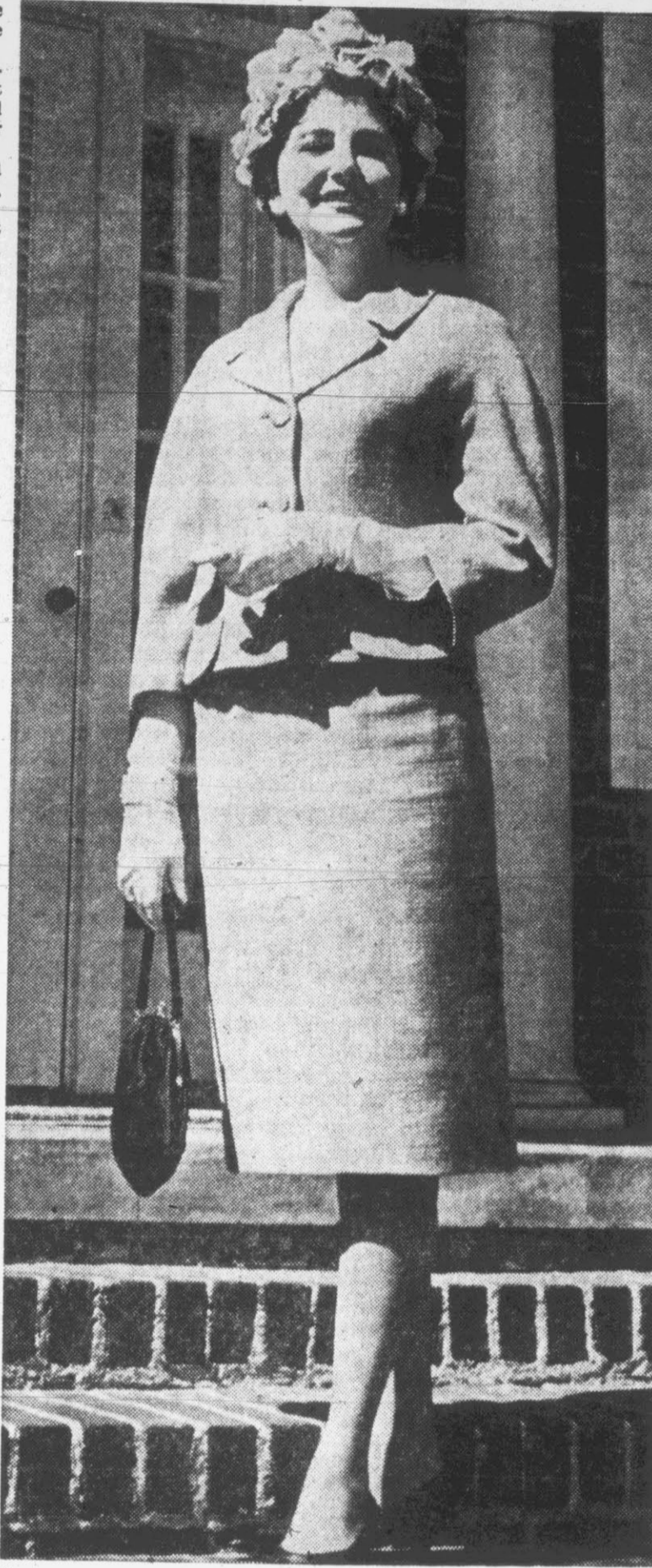

School Improvement Plan Opposed?

In recent weeks it has been the consensus among Tar Heels that a vast majority of North Carolinians favor the proposals of Gov. Sanford to bring far-reaching improvements in the public schools.

While numerous objections have been raised to the governor's proposals for providing sufficient additional revenue to finance his program, the opinion has prevailed that most North Carolinians were willing to pay the cost of the improved program through some sort of tax increases.

The results of a proposed school tax increase in Winston-Salem and Forsyth County this week may cause a revision in that prevailing opinion. School officials of both Winston-Salem and Forsyth County had indicated they may have to cut down on educational services unless additional local revenues were provided to finance the local school system. Voters of the city and county went to the polls to vote on the increase in school taxes, and turn them down by a

vote of 4 to 1 in the county and almost 2 to 1 in the city.

This should raise important questions in the minds of the leaders of the state:

If the people of Winston-Salem and Forsyth County are unwilling to increase their local taxes to provide for their local school needs, do they feel the same way about increasing state taxes to provide for school needs?

Does the result of the referendum in Forsyth County reflect the feeling of people in other counties across North Carolina?

Although there was considerable criticism two years ago of assertions by Gov. Hodges that local governments should assume a larger share of the burden for public schools, it is evident that local governments will have to do more for schools at the local level even under the far-reaching state-wide program proposed by Gov. Sanford. If local governments are not willing to move forward to enhance their local public school programs in conjunction with a state-wide effort, North Carolina will not be able to make the progress in education now envisioned.

It is to be hoped that the recent vote in Winston-Salem and Forsyth County does not reflect the attitude of North Carolinians as a whole toward providing additional revenue to meet the needs of public education. At the same time, state officials and educational leaders should not ignore the possibility that there is considerably more opposition to the much-needed school improvement program than heretofore has been evident.

Reverberations In 'Little Bill'

LITTLE BILL — The "little bill" introduced early in the session by Rep. Mack Isaac of Avery to change the word "may" to the word "shall" turned out to be more far-reaching than even the introducer and his Republican colleagues thought. The purpose was to require rather than just permit the county boards of election from nominees made by the county chairmen of the respective political parties. It looked good on its face, and some of the most rabid Democrats on the committee supported it. In fact, a motion for a favorable report was made by an eastern Democrat. That motion was withdrawn at request of other members in order to give time for further study.

BIG — The study disclosed that it was in fact a very "big bill" that might disrupt the whole election machinery in the state. Every Democrat who spoke against it at the second committee consideration and most of them had original opinions that insisted on an attitude not influenced by partisan politics.

Two illustrations were given: In one county last year the Democrats were pretty evenly divided into two factions. The winning faction had a narrow margin, but obtained control of the county committee. A few days later the new chairman demanded the county board of elections to fire every registrar and poll-holder and name an entire new slate recommended by the incumbent Democratic chairman. And in another county there were rival factions, each claiming control of the party organization. So the elections board could not know which set of nominees to accept.

Although the Isaac bill was admittedly designed to take care of bad situations in just three or four counties, when the committee looked into it was evident that it would seriously affect every county in the State.

STATE RULE — The laws now impose upon the State Board of Elections with respect to appointing county boards the same mandatory limitations which the Isaac bill would have put upon the county boards with respect to precinct officials. The statute says that the state chairman of each political party "shall have the right" to nominate personnel for county election boards. Then "it shall be the duty" of the State board to name members from that list.

Some years ago the late George McNeil of Fayetteville, a member of the State board of elections, refused to go along with a recommendation of the county chairman and insisted on naming another man to the Cumberland county board. The matter went to court and the late Judge W. C. Harris in Wake superior court overruled the State Board and ordered that the county chairman's nomination be named.

inee be named. The State board did not appeal, but changed the appointment to conform to the Harris ruling.

Later when Charles Britt of Asheville was chairman of the State board he declined to accept nominations from about a dozen mountain counties and substituted friends of his political faction. That situation did not get into court, but there was public clamor and upon advice of their Attorney General Harry McMullan the State board held a second meeting, rescinded the original appointments and named county boards from the list of nominees.

CONTROL — Since the Isaac bill was reported unfavorably by the committee, discussion of its provisions is academic. The issue, however, is not settled. There is question whether either the State or the county boards of elections should be hamstrung by specific legislation which places control over election machinery in the hands of unsworn non-public partisan officials rather than in the hands of the legally constituted public officials who have taken oaths of office.

NON-PARTISAN — Because the bill was introduced by a Republican there was evidence of partisan color in the early debate. Some Democrats opposed, more or less frankly, just because of its Republican sponsorship. Other Democrats supported it because on its face it seemed to be fair and they did not want to be put in position of opposing it just because of its sponsorship.

Further study proved that party affiliation had very little to do with the whole business. In fact, most of the later opposition came from counties which have no Republican vote of consequence. It was not brought out at the committee meeting, but learned from other sources, that the newly formed State Association of County Election Officials was 100 percent opposed to the idea.

State law requires that not more than three of the five members of the State Board of Elections shall be from the same political party, and not more than two of the three members of the county boards. Under existing conditions that means a Democratic majority on every board. In event of a Republican state administration it would mean a majority of Republicans on every board.

The question is not representation of the minority party, but how these representatives shall be selected, whether by unsworn non-public party chairmen or by sworn public officials responsible to all the people of the state.

There is growing sentiment that instead of extending the mandatory provisions to county boards, the State board should be relieved of the statutory obligation to accept partisan nominees.

UN Could Fall Apart For Failure To Share

It is difficult to visualize a United Nations that has withstood the siege of international crises for more than a decade being undermined and destroyed because its members refuse to financially support it, its members refuse to financially support it.

And yet, that is the situation today as the U.N. faces bankruptcy because few of its members are willing to share in defraying the cost of the U.N. action in the strife-torn Congo. Without the efforts of the United Nations in the period since World War II it is highly probable that the nations of the world would have been drawn again into global conflict. Short of another global war, there can be no doubt that the U.N. has prevented many times in those years smaller wars that would have reached into every segment of the globe.

Such open conflicts would have cost the nations of the world many times what it has cost to support the United Nations as a forum to iron out international difficulties. Those same nations which now refuse to pay a share of the cost U.N. operations would have paid many times more—not only in money but in blood—had it not been for the work of the organization.

Now they say for various reasons they cannot afford to participate in the cost of financing the organization's operations. Indeed, history appears to indicate they cannot afford not to pay the cost of the organization's operations.

Without the United Nations, international relationships today would be vastly more chaotic than they are. Future efforts toward establishing real and lasting peace in the world would be rendered wholly ineffective.

Individual governments took the position several decades ago that they could not afford to support the League of Nations, and so they deserted the organization . . . only to become embroiled in World War II.

In a very real sense, it is not merely the organization known as the United Nations which is at stake in the current financial crisis. The future of civilization is likewise at stake, and nations large and small, strong and weak, rich and poor should quickly recognize this fact.

Technique Has Good Dividends

WASHINGTON (AP) — The "quiet, please" technique of the Kennedy Administration has paid pretty good dividends so far at home and abroad, in handling both Congress and the Russians. Latest home example: The comfortable House vote Wednesday for President Kennedy's program to help depressed areas. This about clinches it for him. The Senate already had passed a similar measure.

And this week, too, he seems to have persuaded the Russians to cool off a bit on Laos. In foreign affairs Kennedy, like President Eisenhower, has avoided loud noises, except that in Eisenhower's case his secretary of state, John Foster Dulles, made enough noise for both of them.

Kennedy's secretary of state, Dean Rusk, just the opposite from Dulles, is letting the President do the main talking in foreign affairs. And Kennedy, while plenty tough, has pitched everything in a low key.

In one important way in dealing with Congress Kennedy is following President Eisenhower's policy, although it seems to be natural with him anyway. But in one important way he isn't.

Eisenhower avoided name-calling, personal attacks, and fights with senators and representatives, even when they were undercutting him. So does Kennedy.

There the similarity ends. Where Eisenhower seemed to pat his programs on the head, send them trotting up to Congress, and wish them well without fighting to put them through, Kennedy does the opposite.

Still, while Kennedy and his aides work over the members of Congress, in person and by phone, there's no blood on the ground when it's over. But to see what a roughhouse it was, look at some of the close votes, even when he lost.

When he wanted the House to enlarge the Rules Committee—

so as to outnumber the combination of conservative Republicans and Southern Democrats who could strangle his programs — he won by only 217 to 212.

Last week his side fought to keep Republicans and Southern Democrats from chopping up his minimum wage bill and lost 186 to 185. The House went on then to pass a much weaker measure than Kennedy wanted.

It's been reported since he had enough House votes to win, if the votes had only shown up in time. But they didn't. They were either still in their office or on their way to vote.

This was Kennedy's first big setback. The Senate still has to act on minimum wages. Before it's over, the President may wind up a little better.

Congress has passed his bill to extend unemployment pay, one of his major items, but only after a skin-tight 44-42 vote killed an amendment which would have hashed up what he wanted.

Before this year is over, judging by the skinny margins of his victories, Kennedy may yet get clubbed and clobbered by Congress. It's too soon for him to develop comfortable feelings.

What remains to be seen is this: If Congress roughs him up, will he — like others before him in adversity — get tougher, publicly and privately.

He talked sternly with the Russians, but not roughly, to get them to agree to a cease-fire in Laos. They haven't yet, but they are not responding with any tough talk.

If he had done otherwise the Soviets, to save face, might have pushed their luck in Laos even if it meant war. But his dealings with them, like his dealings with Congress, are still in their infancy.

But if one conclusion about Kennedy's performance at home and abroad can be made, this early, it's this: He acts like a man looking for success and not for personal triumphs.

Long Era Of Change

Historical mistakes can never be corrected. A chain of events is set in motion, often universally, from which there is no retreat except by revolution or war. Events move too rapidly and become too complex to leave time to erase the error of statesmen.

The world today is living in a period of the consequences of World War I. These consequences may be listed as follows:

1. The collapse of great empires, some of which had a thousand years of history. The immediate pressures demanded that wherever a political vacuum appeared, it immediately be filled; that wherever an economic impediment established itself, it be removed. The result was the collapse of the Hapsburg, Romanov, Hohenzollern Empires during World War I. I left much of Europe in political chaos. The so-called successor and liberated countries were only, in a few instances, ready for self-government. The League of Nations served no effective purpose between the beginning of World War I and the end of World War II. The British and Dutch Empires collapsed. The Japanese Empire, patiently built since 1868, disappeared. The Romanov Empire was succeeded by the Soviet Universal State. The European economic interest in China and India was destroyed.

2. Four non-European powers rose to prominence, namely, the United States, Soviet Russia, the Moslem Arab Society (still in formation), the Latin American Confederation (still in its embryonic state). These changes are keeping the entire world in chaos.

To them must be added the Sino Society in the East of Asia which is emerging as an enormous power with satellites that are larger in population and potential wealth than many countries of Europe. What the historic influence of the Sino Society will be, it is impossible to foretell at this moment but its physical influence extends far into the Indian Ocean. Its present physical objective is the Chienlung Line, which extends from Turkestan, through Tibet, down along the eastern boundary of India to the Bay of Bengal. Take a look at a map and draw the Chienlung Line and recognize that the Sino Society, if successful, must ultimately absorb India.

3. The above political and geographical changes are not explaining what has happened to mankind in half a century. The Western world has lived under an umbrella of a moralistic philosophy based upon Judaism, Christianity and Aristotelianism for at least 2,000 years. The ways of life were fixed by the Natural Law, a concept of the rights revealed by God in the West. Particular rights of the individual were recognized as fundamental, extending far beyond the rights of the state. The Common Law of England, the Scandinavian Laws with which it is associated, the Code of Napoleon which grew out of Roman Law and the Constitutional system of the United States represent the moralistic philosophy that freed the individual human being from the shackles of state whimsicalities tantamount to tyranny.

This concept has been challenged by Hegelianism-Marxism in its various formulations, particularly by different Communist and Socialist governments which have come into existence. It needs to be remembered that Fascism, Nazism and the Welfare State are born of the same parentage as any other form of Socialism. It needs also to be noted that such countries as the United States and Great Britain and most of the new nations that have come into existence are directly influenced by this central change in thought. No country on Earth is today unaffected positively or negatively by Marxism which seeks to replace Christianity as the prevailing thought of the period. New scientific developments and unproved postulates of the social sciences are producing an antagonism to religion and the family which can, in time, destroy our particular civilization.

4. The result has been a moral revolution, the consequences of which move more swiftly and more daringly than political and economic change. The moral standards of all peoples have

Laos Affair To Affect Business

Whatever the outcome of the Laotian crisis, there are certain to be effects on business.

If sweet compromise prevails, it may be expected that the United States will assume the burden of greater economic aid to Laos; the local economy will have to be strengthened to improve the lot of the Laotians. If there is limited assistance by Southeast Asian nations, then the United States will be expected to increase its military assistance to Thailand, South Viet Nam and other participants. And if another Korea develops, we will have all the impact that the war in Korea had.

The situation has already had significant effects on business. The "war" stocks have risen on stock exchanges. They are shares in companies that manufacture munitions or supply materials for them.

COMMODITIES AFFECTED
It is true that the speedup of government spending as a counter-recessionary measure would

have made many of these stocks more attractive, but they probably would not have shown quite as much strength as they did.

The commodity market has also been directly influenced by the Laotian trouble. Although Laos is not one of the principal rubber suppliers, rubber prices have fluctuated, largely upward, in recent days.

Copper prices have gone up, but this was partly due to the port strike in Chile. Lead and zinc prices have shown a greater steadiness.

Grain prices have also shown strength. Here again the Ad-

Laos affair will be expected to have a positive effect. Supplies of basic materials have changed over the last decade; military conceptions have altered; the pattern of government contracts has changed. Some stocks that shot up during the Korean War may lag behind the market as we get to shooting in Laos; others that lagged then may be jet-propelled.

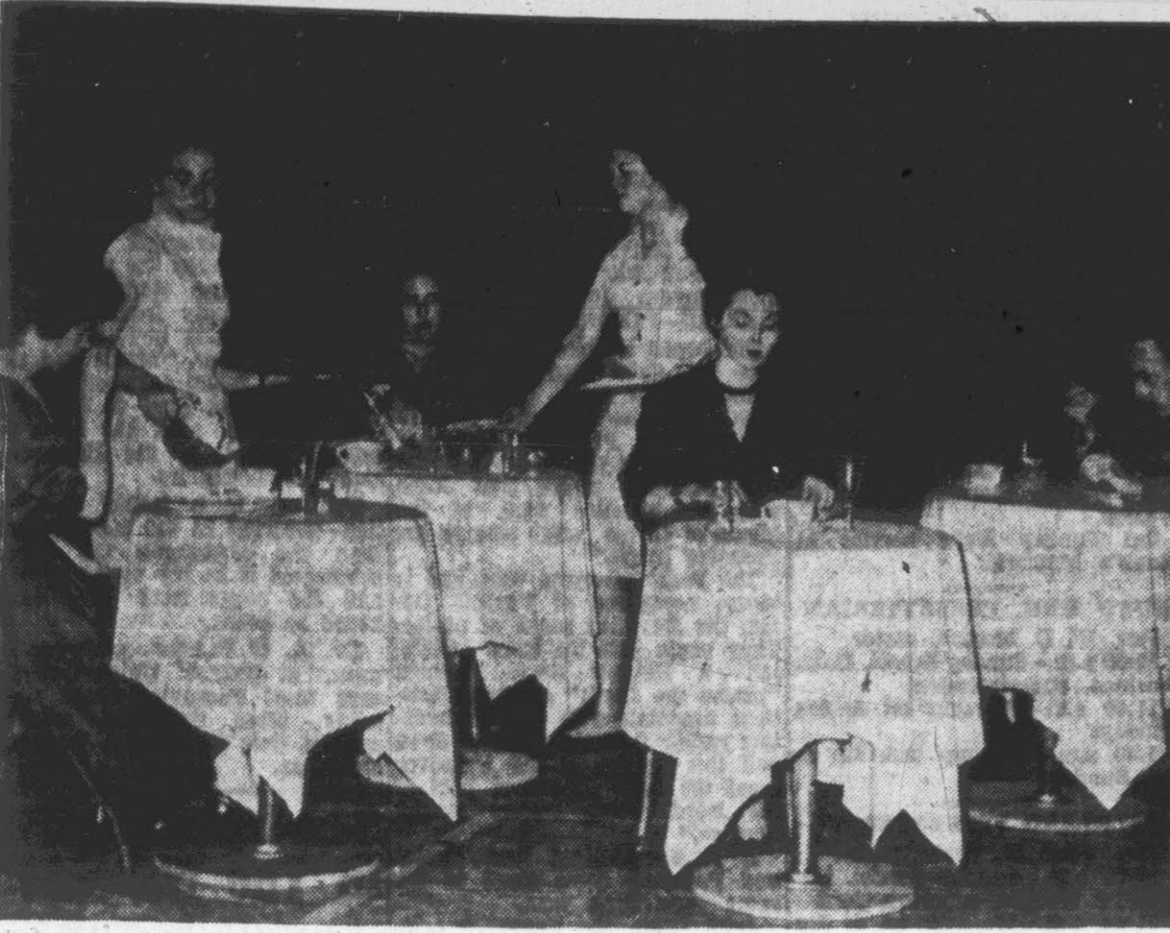

Last Supper Was Happy Occasion

By JULES LOH

NEW YORK (AP)—Was the Last Supper a happy occasion? Hardly, from the Christian point of view. But actually Jesus was celebrating with his apostles the most joyous Jewish festival of them all—Passover.

The bread He blessed and broke was an unleavened wafer, the matzos of the Jews. The wine He drank likewise was an integral part of the Passover meal, or seder, then as it is today.

St. Matthew writes that Jesus and the apostles went to the Mount of Olives "after singing the Passover hymn."

The Passover hymn was, and is today, composed of Psalms 113-118, the Egyptian songs of praise. They begin with the word hallelujah—a Hebrew word meaning "praise the Lord."

It is no accident that Easter and Passover come close to the same time each year. Jews begin the Passover celebration (it lasts eight days) on the 14th day of the Jewish month of Nisan which begins about a week before the first full moon of spring. Easter falls on the first Sunday after the same full moon.

Passover begins with two seders, this evening and Saturday evening. These are meals, like the one Jesus ate. Seder is Hebrew word for order; the order of the ritual—and it's quite a ritual.

There are 14 steps, and the meal can last as long as five hours or more.

The whole procedure is called a Haggadah, the Hebrew word for "retelling." That is what Passover is—an annual retelling of the deliverance of the Jews from the Egyptians; the story of how they "passed over" from slavery to freedom.

Each part of the Haggadah is significant to the story. The matzos for instance, remind the Jews how their ancestors had to clear out of Egypt even before the

bread had a chance to rise. Bitter herbs (usually horseradish) are eaten to remind them of the bitterness of slavery.

The Old Testament tells how Moses commanded the annual observance so the story could be passed unforgettably from father to son. It also tells how, when the exodus was over, "Moses and the children of Israel sang this song"—history's first song of freedom.

Consequently song has been an essential part of the Haggadah since the beginning.

Passover is a family celebration—observed in the home rather than the synagogue (as Jesus celebrated it in the upper room), and the songs may vary from house to house.

Dr. A. W. Blinder, professor of music at Hebrew Union College, says most Passover songs sung today, other than the ancient psalms, date from about the Middle Ages.

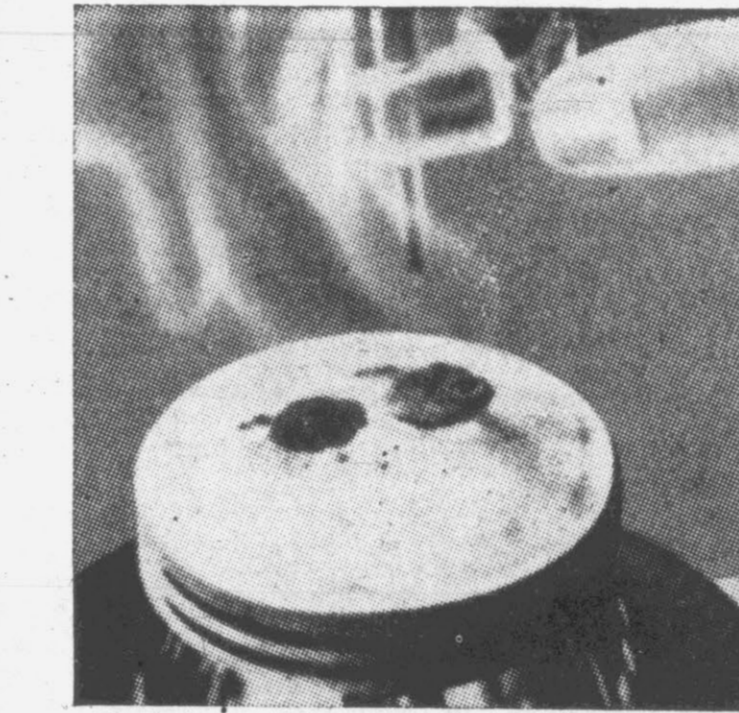

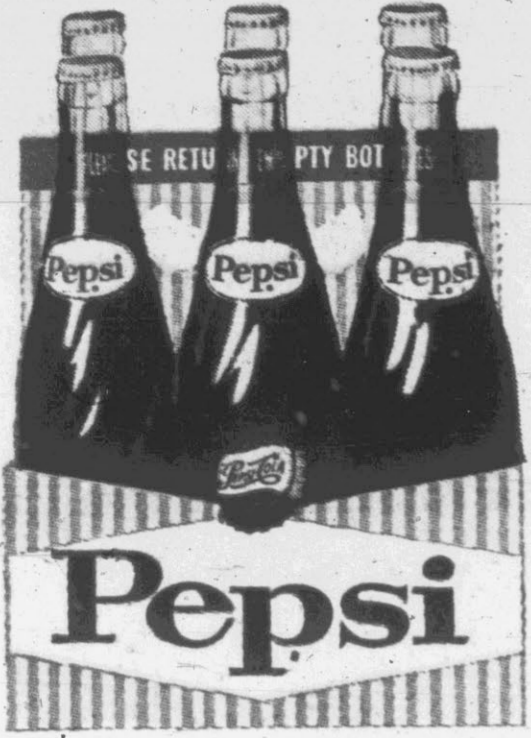

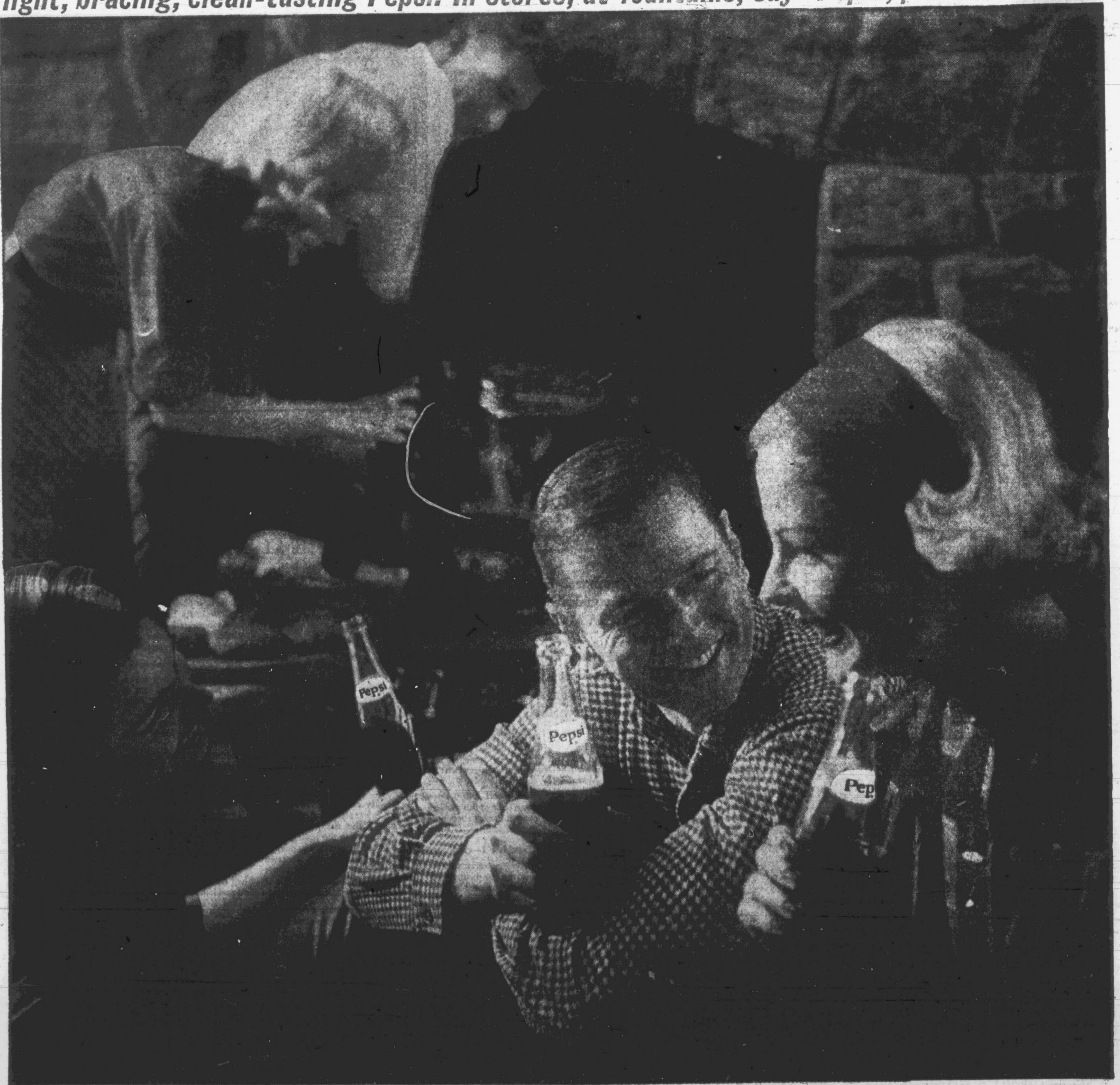

Other games today, Virginia plays at South Carolina, and Maryland at Clemson, both conference affairs.

Roman Gabriel, widely known as the strong-armed quarterback of the N.C. State football team, was the hero of the Wolfpack's victory over Maryland.

Gabriel went to bat in the ninth inning with two out, two runners on base and the score tied 3-3. He walloped a 400-foot homer to provide the margin of victory.

Wake Forest got only four hits, but beat Jacksonville with the aid of three errors that provided two unearned runs.

North Carolina also took advantage of errors by the Southern Georgia team. Southern committed six errors. The Tar Heels also got 11 hits, including three each by Jim Mooring and Tommy Camp.

Narleski Quits LAKELAND, Fla. (AP) — Ray Narleski, who possibly could solve the Detroit Tigers' relief pitching woes, has quit the club in a huff and gone home to New Jersey.

The right-hander stalked out of the Tigers' spring camp Thursday after a dispute with personnel director Rick Ferrell.

Few Name Players Entered In Azalea Golf Tourney

WILMINGTON, N.C. (AP) — Name players were harder to find than the eggs at an Easter hunt today as the 13th annual Azalea Open golf tournament got under way at the Cape Fear Country Club course.

With the tournament knocked down to a three-day, 54-hole affair carrying a modest \$12,000 purse, most of the top-notchers have elected to lay off over the holiday weekend or to go to Augusta, Ga., and tune up for next week's Masters.

Twelve major tournaments have been conducted by the PGA since January and not a winner is here. Of the top 25 money winners for 1960, the Azalea has drawn only two.

The field of 87 includes 20 amateurs, 20 Carolinas and Virginia club pros and 47 touring players. In the absence of the habitual coin collectors, three men loom as most likely to pick up the top check of \$1,200 Sunday.

The trio is made up of Jerry Barber, the little veteran from Los Angeles, Dow Finsterwald, 1958 PGA champion from Jupiter, Fla., and Dave Ragan, 1959 Eastern Open winner from Orlando, Fla.

Finsterwald, although never a winner here, over the years has pocketed \$3,300, second only to the \$6,700 won by Mike Souchak, who is among the missing.

Dow was No. 3 man in last year's official money list with \$38,500 won. He finished third at Pensacola, Fla., earlier this month.

Barber, who'll be 45 next month, is improving with age. He was 17th on the 1960 official list with \$21,900 in earnings. His first major victory was scored here eight years ago.

Ragan, who has tied for fourth twice in the just ended swing through Florida, tied for second in the January Crosby tournament on the West Coast. He's been closing fast in recent starts and may be ready to score a victory.

Tom Nieporte of Bronxville, N. Y. is defending the title he won last year with a 277 for 72 holes over the par 72 course which measures 6,500 yards. He scored a par 72 in Thursday's \$2,500 amateur competition on a card that included 16 pars.

Houston LeClair of Birmingham, Ala., led the 45 pros with a five under par 67 to win top money of \$250. Bob Shave of Willoughby, Ohio was a stroke back at 210.

Tied for third at 69 were Harold Kneece, Aiken, S.C., Ronnie Reif, Singing Hills, Calif., and Jack McGowan of Toledo. Each won \$163.33.

Tommy Aaron, Walker Cup player two years ago as an amateur, won the \$200 pro prize as pro on the team with the lowest best ball score of 59. Aaron from Gainesville, Ga., had amateurs R. G. Higgins of Charlotte, Bryan Broadfoot of Wilmington and Claude King of Virginia Beach as partners.

Houston played Oklahoma State today and North Texas met Louisiana State.

North Texas State and Texas A&M shared second place in team medal play with 598. Next in order, were Louisiana State 606, Oklahoma State and Florida State 607, Florida 612, New Mexico 616, Texas Tech and Wesleyan 632, Alabama and Baylor 628, Southern Methodist 629, Texas Wesleyan 632, Western Illinois 634, Stephen F. Austin (Texas) 644.

WORLD RECORD

MYRTLE BEACH — A common pompano caught on South Carolina's Grand Strand has been certified as a world record by Great Outdoors Association, it was announced today by Singleton, chairman of the Grand Strand Fishing Rodeo Committee of the Greater Myrtle Beach Chamber of Commerce.

Harry Taylor of Conway, S. C. established the new world record when he reeled in a 6-pound 11-ounce pompano of the common variety last October. Using live shrimp for bait, he was fishing from a small boat at Murrells Inlet.

Taylor's record-breaking catch was weighed at Alex's Marina in Murrells Inlet and entered in the Grand Strand Fishing Rodeo. He won a cash prize and broke an all-time rodeo record in the pompano class.

The world record citation from the Great Outdoors Association will be presented to Taylor at the Myrtle Beach Chamber Annual meeting on April 20.

A total of three world Pompano records have apparently been established by Grand Strand fishermen since 1959. The previous record for common pompano was listed at six pounds in Rube Allyn's Dictionary of Fishes, a publication of the Great Outdoors Association.

In October, 1959, Ben Utley of Marion, S. C. caught a 6-pound 1-ounce at Murrells Inlet. He entered it in the Grand Strand Rodeo at Sam's Bait & Tackle Shop. Charles C. Cutts of Conway landed a 6-pound 2-ounce specimen in August, 1960 while surf fishing near the Second Avenue Pier at Myrtle Beach. Two months later, Taylor hauled in his 6-pound 11-ounce whopper at Murrells Inlet.

The Greater Myrtle Beach Chamber of Commerce is now contacting the Great Outdoors Association in efforts to obtain world record certificates of Utley and Cutts, since their catches had apparently established records.

BOAT SHOW

GREENSBORO — A special exhibit of racing craft that ride on the water, rather than in it, will be shown at the Southeastern Bokarama in War Memorial Coliseum here April 1-3.

Griffith, Minnesota After Success Story

ORLANDO, Fla. (AP) — After years of austerity, Calvin Griffith, owner of the Minnesota Twins, formerly the Washington Senators, is striking it rich. Unless all signs fail, Griffith and his transplanted Twins are headed for a success story that may approach or equal that of Lou Perini and his Braves when the Boston franchise was moved to Milwaukee eight years ago.

Last year in Washington, the club's advance season ticket sale totaled only \$127,000. So far, in Minneapolis-St. Paul, more than \$750,000 has been banked from season tickets. Club officials are confident the amount will exceed \$1,200,000 before opening day. "We drew 743,000 in Washington last year," said Herb Heft, the club's publicity man. "We're disappointed if we don't come close to doubling that figure. We know we're going to sell out opening day and we're already assured of at least 12,000 fans at every one of our games. We're going to start out with more money in the bank than Washington grossed all last year."

The seating capacity at the Bloomington Park has been increased from 22,000 to 30,463. By September, the stadium will be able to seat 40,000. "We've already tripled the number of tickets we sold in Washington last year at this time," said Heft. "The way the fans have been clamoring for tickets, a million attendance our first year in Minnesota should be a snap. Some of our people are envisioning a million and a half."

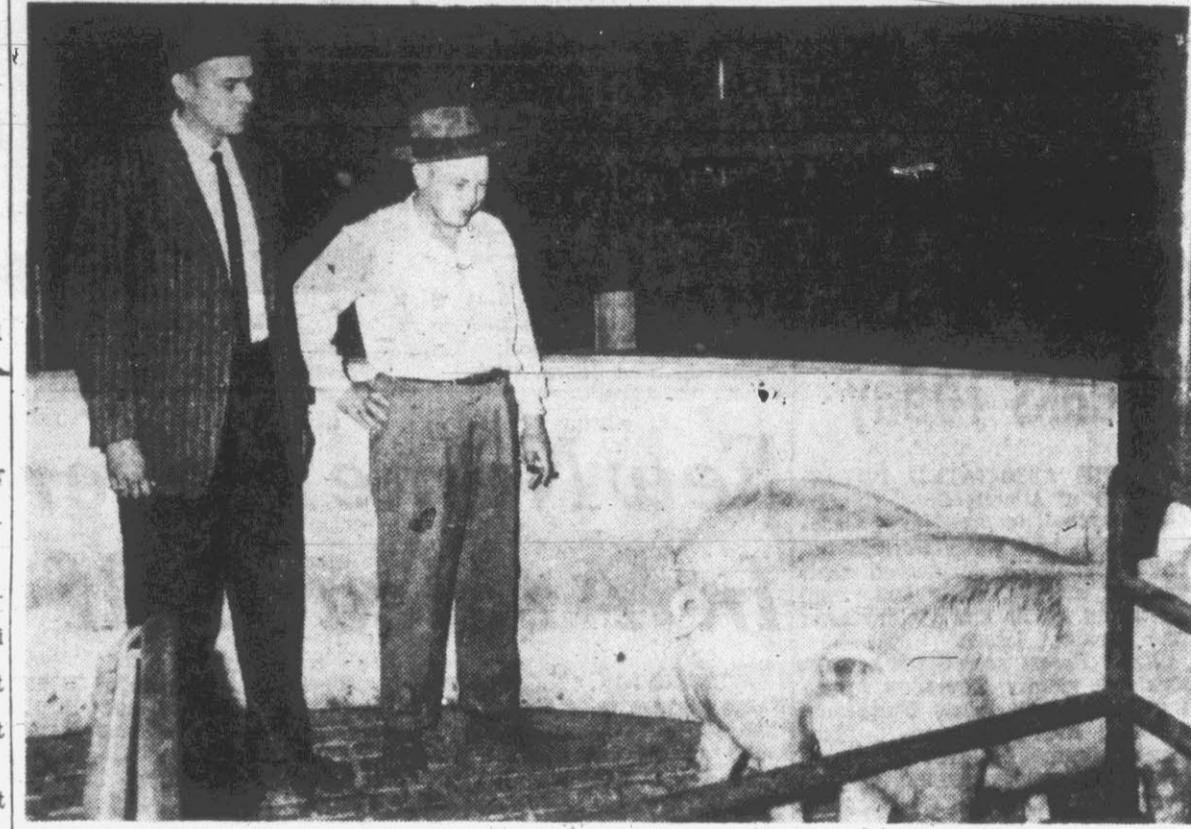

Years Devoted To Public Service And Helping Others

After many years of public service and helping others, Mrs. John B. Spilman, State Director of the North Carolina Mental Health Association whose offices are here in Greenville says the most satisfying thing about serving the public is to "know when night comes I have been of help to someone."

Mrs. Spilman, a native of Chowan County, received her education at Elm Grove Academy, a private school in Chowan County, Franklin Seminary in Franklin, Virginia, and at Strayer's Business College in Baltimore. She then taught for several years in grade school and high

school in Elizabeth City and Manteo before coming to Greenville as a teacher in 1915. She conducted a private business school here for four years, after teaching for two years in the public schools.

After closing her business school, Mrs. Spilman became Assistant Treasurer for what was then East Carolina Teachers College.

Mrs. Spilman was married to the late John Barham Spilman in December 1917. Mr. Spilman was Bursar at ECTC at the time.

Mrs. Spilman's deep interest in public affairs ultimately led her into politics and she became the first woman to direct a

Governor's Campaign, acting as Woman's Chairman in the Campaigns of Clyde R. Hoey for Governor in 1936. She also served eight years as vice-chairman of the Pitt County Executive Committee and served as vice-chairman of the State Executive Committee.

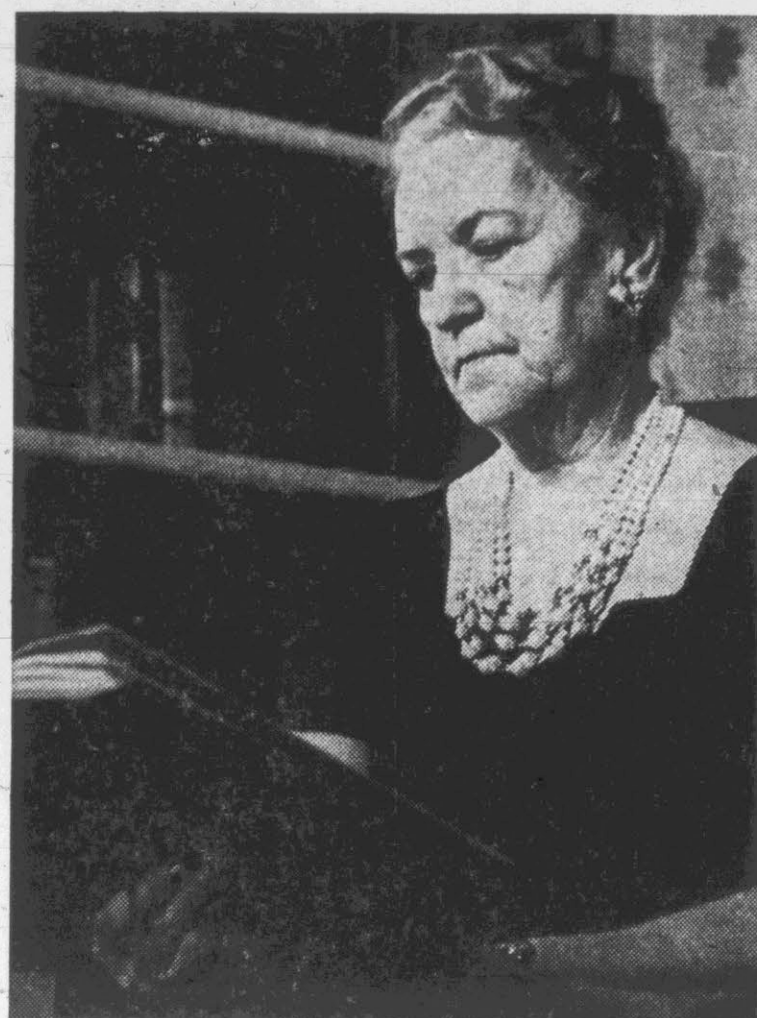
In December of 1936, Mrs. Spilman received an appointment as Vice Chairman of the North Carolina Unemployment Compensation Commission (later changed to the Employment Security Commission) and was, until her resignation in 1941, the only full-time woman UCC commissioner in the United States.

After leaving the UCC post, Mrs. Spilman went to Washington, D. C., as Director of a

residence hall in which 942 Waves were housed. Mrs. Spilman returned to Greenville in 1942 as manager of the Greenville Employment Security Commission office here, where she remained for two years before retiring and making a trip to Europe.

Mrs. Spilman returned to public service work in 1950 when she became assistant director of the 1950 Census for the First Congressional District, then became Executive Director of the County T.B. Association, a post she held until March of 1957 when she became Director of the N.C. Mental Health Association.

As director of the volunteer lay organization which works

toward better mental health, her duties include organizing local Mental Health Associations across the state, and supplying information and material on mental health to those wanting information or help.

Mrs. Spilman noted that the purpose of the organization, which is controlled by 60 directors from across the state, is to create an awareness on the part of the public that there is a great need for preventive measures in the field of mental health.

Working closely with the State Hospital Board of Control, the organization can, through its 26 present local associations, reach more citizens with a true picture of mental health than the centralized state agency.

She explained that "one of the nicest things that has happened" to her while being Director of the State Group is being selected to attend college summer school sessions on mental health for the past four years sponsored by different foundations. She added that she is scheduled to attend

a summer-session at the University of Indiana this summer. The mental health worker said the most satisfaction comes from being able to answer the "great number of letters and cards" I get from across the state" stating the difficulty they are having . . . and being able to respond to their cry for need for help in areas where they have no one to help them. By answering these letters and getting pamphlets, booklets and information to them, "I know, when night comes, I have helped someone".

Mrs. Spilman praised the other mental health employees, the seven local association secretaries and the two office workers here, for their work in the organization and said, without their help, the job could not be done.

At present Mental Health is not her only activity, for the State Director is a charter member of the Altrusa Club, the Business and Professional Women's Club, the Executives Club, the End of the Century Book Club, United Daughters of the Confederacy, the American Legion Auxiliary, the National Staff Council of Mental Health, the Public Health Association, and the American Mothers Committee.

Her hobbies include "work" and in her "spare" time, flower gardening and reading. She is a member of the Baptist Church.

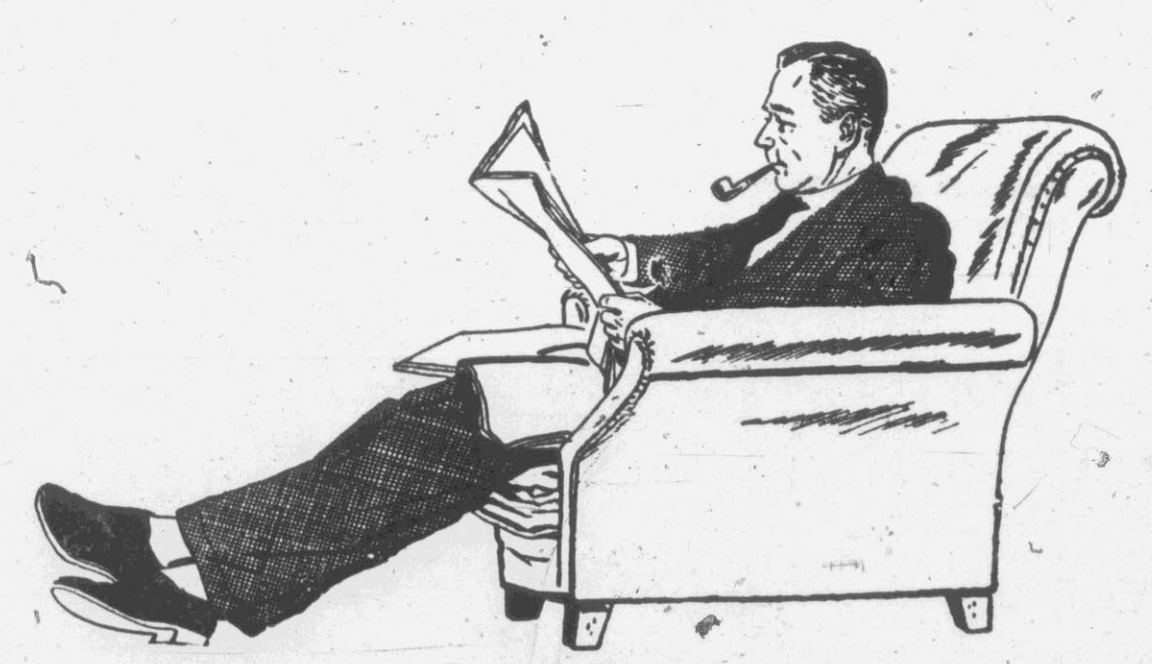

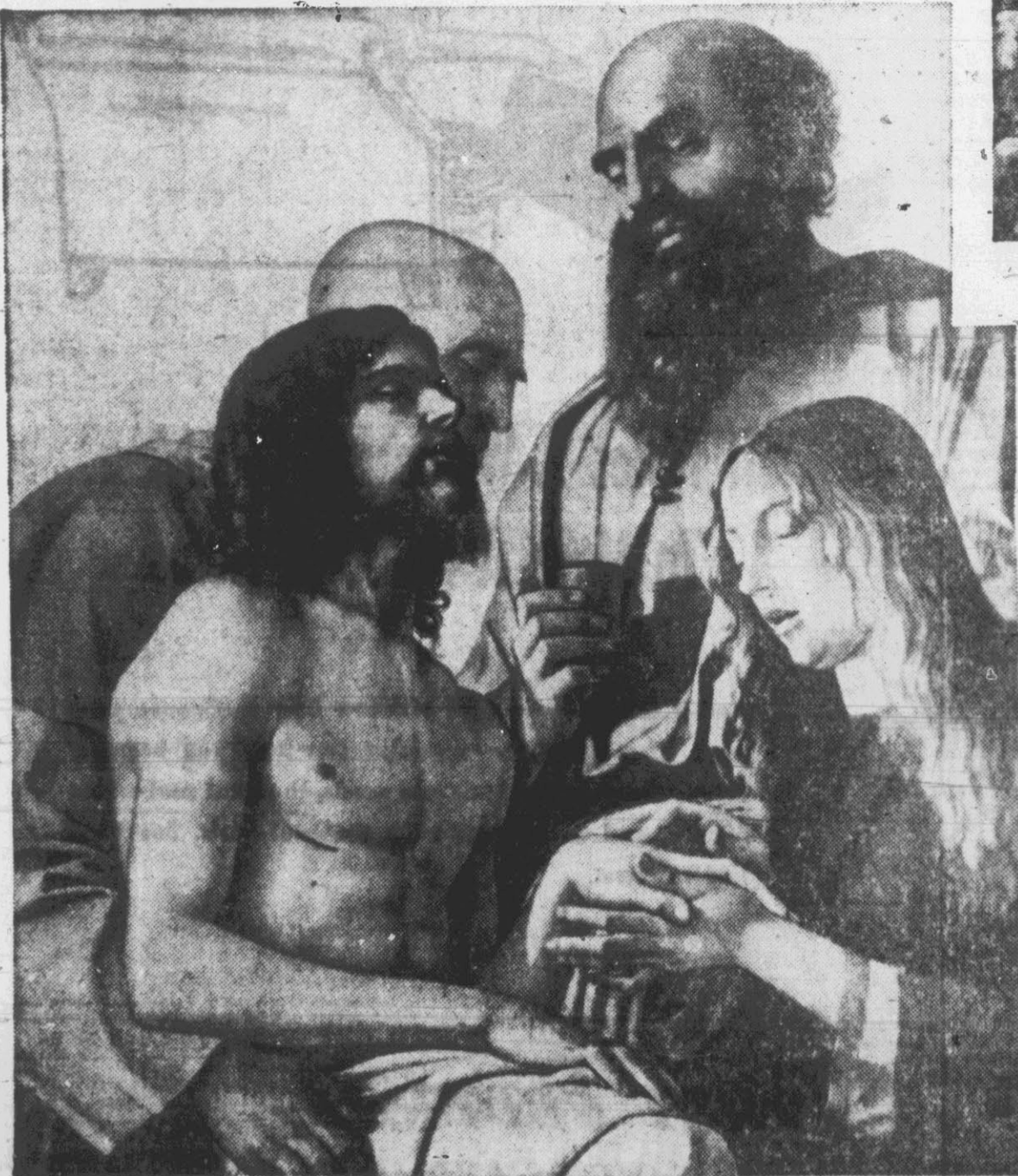

The cherry blossoms made a pink fairyland down by the Jefferson Memorial. The magnolia trees burst almost overnight into pale pink and lavender blooms all over town. The newly scrubbed government buildings gleamed white behind the yellow forsythia.

Across the avenue from the green expanse of the White House grounds, hundreds of pansies splashed Lafayette Square with color.

Blossoming trees and shrubs

gave a festive air to the stretch of Massachusetts Avenue where magnificent embassies rub shoulders.

And the tourists arrived.

Nobody could prove it, but some oldtimers around town said they believed the combination of cherry blossoms, Easter and spring all at the same time brought a record number of visitors to the capital.

But then they always come about this time, said a policeman. That was a policeman out by the Capitol steps.

The most oft asked question, he said, was about what went on in the Capitol and did the President live there.

The question asked the second most often, the policeman figured, is what is the statue on top of the Capitol. (It's a draped woman, not an Indian, representing freedom).

The third question involves directions — how do you get there? "And they all ask how to get to the White House," the policeman said. (It's 16 blocks down Pennsylvania Ave.)

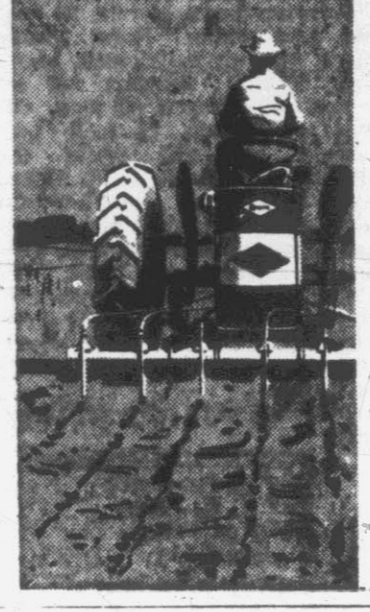

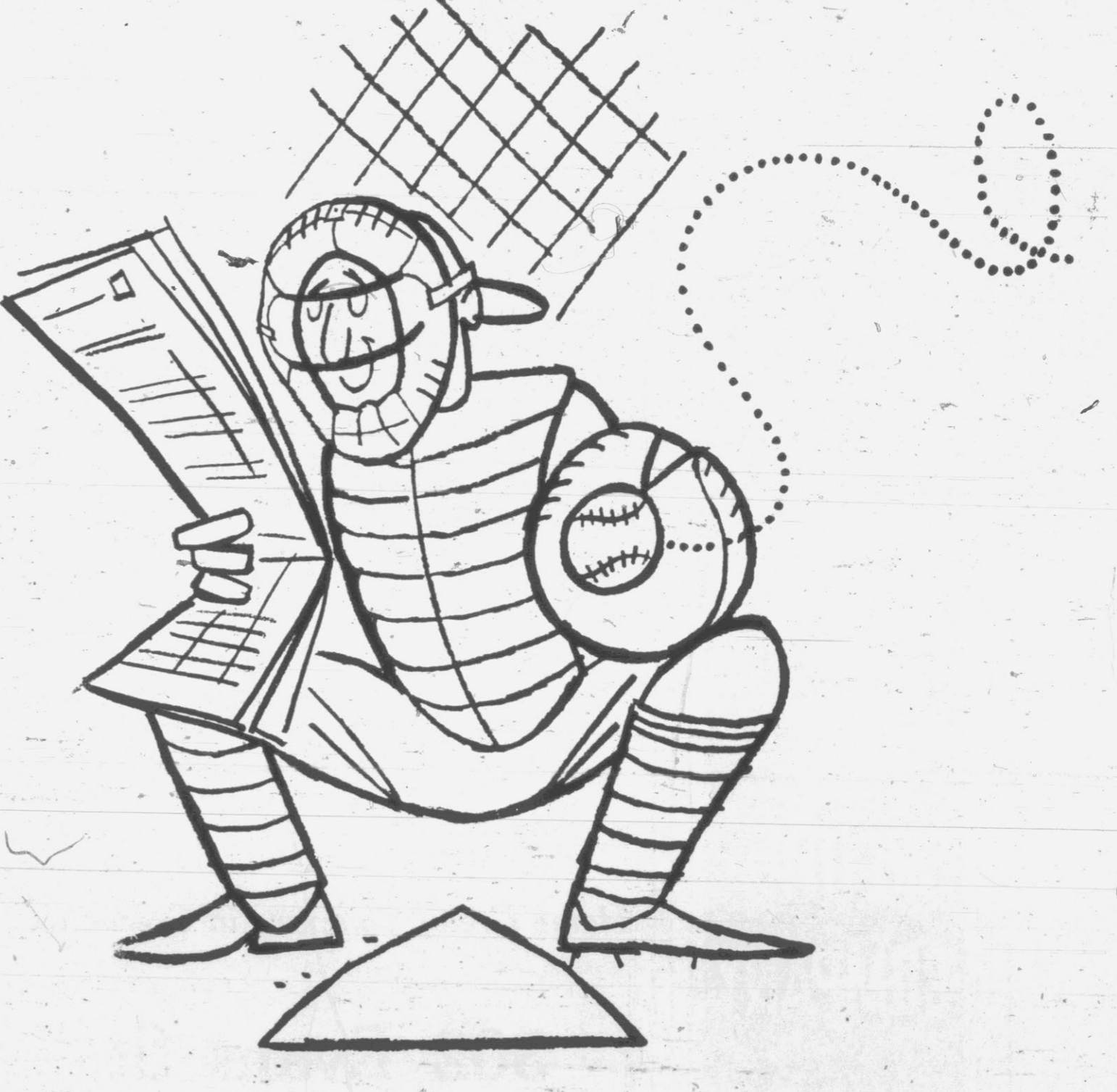

Approve Buying Farmers Market

RALEIGH (AP) — A budget recommendation that the state purchase the Raleigh Farmers Market for \$500,000 and operate it, drew strong support Thursday from a group of farmers, produce buyers and farm organizations.

They urged the legislature's Joint Appropriations Committee to approve the purchase, which was recommended by the Advisory Budget Commission.

The request was one of several heard by the committee during a 2 1/2-hour session. A delegation headed by Agriculture Commissioner L. Y. Ballentine consumed almost 1 1/2 hours.

Rep. John W. Umstead of Orange was scheduled to present a brief on behalf of the North Carolina Hospitals Board of Control but asked that it be postponed until next week. He told the committee, "I have too much regard for time, which other people do not seem to have."

The committee also heard opposition to the proposal to purchase the farmers market. Paul Barwick of LaGrange, weekly newspaperman and farm news writer, declared such markets are "a thing of the past." They cannot support themselves. The cooperative system is the trend today. He called for legislation which would make it easier for farmers to form cooperatives.

Considering Rival For Grandfather Mountain

RALEIGH—Somewhere on the coast of North Carolina there may be placed a rival for Grandfather Mountain.

Three towns, Wilmington, Morehead, and Southport, are in the race to be the permanent home of the Battleship North Carolina, and a joint legislative committee has been told that the exhibition of the battleship could well become a major tourist attraction in the state, surpassing Grandfather Mountain in popularity. Though perhaps not as tall as

the mountain, the U.S.S. North Carolina has been described as taller than any building in the state, and extending a distance of three to four blocks.

Orville Campbell, chairman of the North Carolina Battleship Commission and publisher of the Chapel Hill Weekly, told a joint Senate and House Conservation and Development Committee that, in addition to becoming the state's number one tourist attraction, the battleship North Carolina, if placed on display in a coastal town, might well be one of the only two such remaining battleships in the nation, and would save the historical vessel from the scrap heap.

The U.S.S. Texas is now preserved and draws larger crowds each year, Campbell told the lawmakers.

"In mothballs" at present, the U.S.S. North Carolina, first battleship of its class to be built, would be given free to this state. An act of Congress, however, is necessary for the transaction.

Campbell told the legislators that the Battleship exhibition would be self-supporting from nominal fees of tourists, and that donations were expected to cover costs involved in transporting the ship from its present location in New Jersey and in setting it up.

Earthslide Near Kiev Killed 145

MOSCOW (AP)—An earthslide near Kiev killed 145 people and caused millions of dollars in damage on March 13, the Kiev newspaper Pravda of the Ukraine announced today.

Another 143 persons were hospitalized, but by Thursday 84 had been released.

It was one of the worst natural disasters reported in the history of the Soviet Union.

The slide occurred near Babbar, the tragic ground where the Nazis massacred tens of thousands of Jews and Ukrainians during World War II.

Rumors of the disaster had circulated in Moscow for the past two weeks. The report in the Kiev Pravda was the first confirmation.

It has not been mentioned by the Moscow papers, the Soviet news agency Tass or by the Soviet radio.
