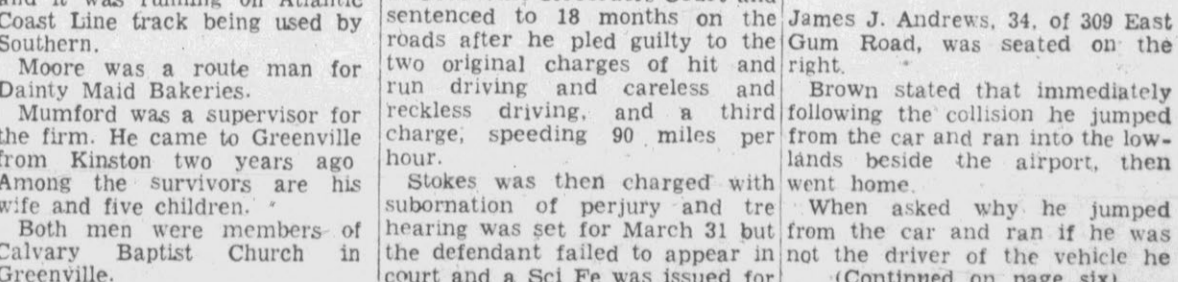

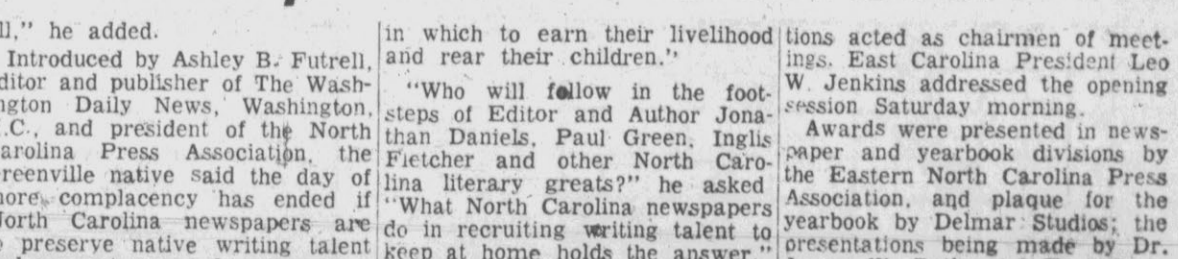
TARBORO — A bakery truck pulled past blinking warning signals and into the path of a Southern Railroad freight train at Speed yesterday to bring death to two Greenville men.

It was through the efforts of the members that the citizens of Greenville had their first free library, Shepard Memorial Library.

# Urban Renewal Program's Start

(First in the Series of Editorials on the mechanics of Urban Renewal and Public Housing. This editorial deals with the background of the proposals on the local level.)

It was in December of 1958 that the City Council created the Greenville Redevelopment Commission and authorized it to formulate and recommend plans for carrying out an urban renewal program in an area designated by the city's Planning and Zoning Commission.

The five-man Redevelopment Commission appointed by the Council is composed of M. E. Cavendish, chairman, J. H. Rose, J. Dixie McGlohon, F. Badger Johnson and Howard L. Hodges, Jr. The area designated for possible redevelopment by the Planning and Zoning Commission is the area now known as the Shore Drive area.

In February of 1960 a formal application was submitted to the Atlanta office of the Urban Renewal Administration for planning funds for the proposed project in Greenville. This application was approved last June and the city was granted \$45,732 to carry out its planning of the project. If the project is finally undertaken, this amount will become part of the total

cost of the urban renewal program and shared by the city and the federal government. If the project is not carried out, the city will not be required to repay any part of the planning fund to the Urban Renewal Administration.

In October the Greenville Redevelopment Commission employed W. I. Cochran, Jr. as its executive director to work with the commission in planning the urban renewal project. As an employee of the local Redevelopment Commission, Cochran works under the direction of the Commission and carries out its policies.

At present, planning for redevelopment of the designated area is in its most preliminary stages. At the outset it was determined that two basic stipulations would have to be met in order to carry out any sort of urban renewal program:

1. It would have to be shown that the area proposed for redevelopment under the urban renewal program would be marketable in a reasonable period after its redevelopment.

This stipulation was satisfied by a special study made of the marketability of the proposed area by a St. Louis firm employed by the Redevelopment Commission.

2. It would have to be shown that families who would be removed from the area because of the redevelopment project could be adequately housed in standard housing elsewhere within the city.

Since most communities with urban renewal projects have found some public housing necessary to provide sufficient housing to meet this stipulation, local citizens are being asked in the forthcoming referendum whether they favor the city's constructing public housing if it is needed in connection with the project.

Unless it can be ascertained that sufficient housing—private or public—will be available for persons who are removed from the redevelopment area, the program cannot be carried out. Thus, officials have determined that this second question must be answered before further planning is done on the redevelopment project.

In the referendum to be held on May 2, local voters will indicate whether or not they favor continued study of the proposed urban renewal project and whether or not they favor establishment of a local housing authority which could initiate steps for public housing units if they are needed.

It must be assumed that the outcome of the referendum will provide guidance for the city's governing board in future steps in connection with the urban renewal program.

If a majority of local voters cast their ballots against both the urban renewal and public housing questions, we must assume that the matter would not be considered further. If there is an affirmative vote on urban renewal, but a negative vote on the question of public housing, then the question of providing sufficient housing through private means would have to be answered before the urban renewal project could be carried out.

If a majority of local voters indicate their approval of both urban renewal and public housing, if needed, we must assume that study and planning on the project will be continued and a final plan for the proposed project presented for consideration at a later date.

## Robt Kennedy's Test Still Ahead

WASHINGTON (AP) — Robert Kennedy produced no sensations at his first news conference as attorney general.

This tough, 35-year-old Kennedy who used to try to give the master boss Jimmy Hoffa the miseries when he was chief counsel for the Senate-rackets committee was mild, humorous, and unprovocative.

He talked about what he wanted to do rather than anything done. His humor and his mildness will get a workout later when he's in the job longer and has to answer questions about what he's done.

It was hardly more than a get-acquainted session with a record, standing-room only crowd of 174 reporters, men and women, in the Justice Department Thursday afternoon.

Some of the same men and women who always get up to ask at least one question at the news conferences of his brother, President Kennedy, got up as expected and asked the new attorney general some.

He seemed prepared and, like the President, responded pleasantly. But some of these same people used to get under President Eisenhower's skin and he showed it.

He talked of his plans for dealing with organized crime, juvenile delinquency, and Negroes' civil rights in the South.

## Other Editors Saying Time For Tete A Tete Opinions In Brief

(Greensboro Daily News)  
President Kennedy and President de Gaulle have many differences to discuss when they meet in Paris on May 31. Post-war France's independent line has become even more so during the term of Charles de Gaulle.

At the Southeast Asia Treaty Organization conference in Bangkok, France's representative insisted on watering down the resolution on SEATO intervention in Laos—a time when almost everyone agreed that a strongly worded statement would be more likely to deter aggressive Soviet and Chinese maneuvers.

In a move described by Ambassador Adlai Stevenson as "a most unfortunate development," France is withholding its contribution to the United Nations operation in the Congo.

And just when progress toward a settlement in Algeria at last seemed assured last week France suddenly raised the question of which Algerian faction it would consult at the independence talks in Evian-les-Bains.

General de Gaulle's nationalistic line within NATO has long been a headache for allied military leaders. And the French leader is currently piqued about the Geneva nuclear disarmament talks.

With such a long list of trouble spots, Presidents of the two traditionally allied nations have their work cut out for them. General de Gaulle is respected not only for his long service to the cause of freedom but also as the only man who can pilot the French ship of state through the perilous waters ahead.

President Kennedy has talked with British Prime Minister Macmillan; West German Chancellor Adenauer is due shortly for a Washington visit. May 31 is not a moment too soon for a frank discussion of U.S.-French differences.

Happily the President will take Mrs. Kennedy along to return to scenes of her university days and speak in the language she knows and loves. The French, never much at learning other languages, will appreciate the gesture. Indeed, a bit of the bad blood between the two countries stems from the unhappiness of a great nation now having to take painful adjustments to a world of rebelling colonials and "rising expectations."

A little of the tactful deference toward his elders, for which young Mr. Kennedy is famous, might be just the ticket at the same time Mrs. Kennedy can flatter the French by speaking their language and admiring a great culture.

Our President will need some extra flourishes. He is the man who as senator suggested it was past time for France to pull out of Algeria.

One of the most savage economic battles of the 60's will be the fight over a large chunk of American freight.

That's the chunk that can be carried piggyback by the railroads. On one side are the American railroads, eager to regain part of the business truckers and airlines have taken away from them. On the other side is James Hoffa and his Teamsters Union, equally eager to maintain the jobs the trucking industry has created.

In the middle are the trucking companies. In general, they give lip service to the Teamsters—Jimmy Hoffa is not a man to cross. In practice, they want to make more money and, if they can do so by moving trailer loads on railroad flatcars instead of behind trucks, they are for it.

TAX IS FACTOR  
Perhaps inadvertently, the Kennedy Administration has entered the picture with the proposal to increase taxes on truckers to help pay for the Federal roads program. Higher taxes on truckers' fuel will make savings by piggyback even greater.

# Birch Society Review

I think that I wrote the first article (January 14) calling attention to the John Birch Society. Since then there has been a plethora of discussion, some competent, some absurd. Let us analyze the position with some objectivity:

Any American citizen is free to organize an associate or express his ideas and to advocate his purposes. This is guaranteed in the Constitution. However, no organization may be established to commit crime like the Mafia, or to sell narcotics or overthrow the government of the United States by force and violence.

No accusations have been made against the John Birch Society which brings it within these categories. The worst crime this Society is accused of having committed is that it is to the right of Louis XIV. But is it a crime to ask whether these days bring more contentment than those?

Disagree with the John Birch Society's campaign to impeach the Chief Justice, Earl Warren. I wrote that it is both strategically and tactically unsound and received a whale of a mail, couched in identical language, pitying me for being so wrong. If an organization wishes to have its members write letters to such men, who can say them nay. The public men do not have to read the letters; they may weigh them on scales to see how many pounds of mail came from this one group.

There is no law which forbids citizens to organize to have an official impeached by due process of the law. It is possible to believe that those citizens are incorrect in their views and to say so. But neither side to the controversy commits a crime by being controversial. As a matter of fact, this country would be improved if more of us were controversial. We are not suffering from objecting too much; we are suffering from too much conformity.

Robert Welch, Jr., who is the founder of the John Birch Society, is opposed to Communism and believes that it is sound to fight fire with fire. Most fire departments prefer to fight fire with water or with chemicals. Welch organized as he thinks the Communists organize, namely by arranging for small cells, often unknown to each other. Communists do not organize that way at all. It is the State espionage organizations that are organized that way. No one can question Welch's sincerity or his desire to serve his country. How deeply he has studied Hegel, Darwin, Marx, Engels, Lenin, Bukharin, Bernstein, and the history of the 19th century, I do not know. He jumps at conclusions often based on misapplication of terms.

None of this is as criminal as the treason of the Communists and many of their fellow-travelers. Bob Welch may not understand all the deviations and revisions of the Social Democratic movement or the synthesis that Marx produced of Darwin, Huxley, Hegel, Feuerbach and Bakunin.

It is not sound to believe that everyone who disagrees, in 1961, after two world wars and a universal depression, with the economics of Mark Hanna is a Communist. As a matter of fact, Conservatives who are firm believers, for instance, in the free market, cannot find one upon the face of the Earth.

Nevertheless, a man has the right, in this country, to organize an association which recognizes the status quo ante bellum as preferable, just as an architect may organize a society to prefer Michelangelo to Lloyd Wright or as a musician might organize a society to advocate Stravinsky in preference to Wagner.

Robert Welch, Jr., has requested a public hearing from a Congressional Committee. The risk is that his associates may sound like crackpots; the benefit is that they will be able to state their case. Such a Committee would ask Robert Welch if he really believes that ex-President Eisenhower is a Communist. Obviously, the former President is not a Communist. (Continued on page six)

back or shoulders, but not the more colloquial "piggyback." A century ago Englishmen frequently loaded stagecoaches on flatcars to spare the horses on the run to Dover, where the boats for the continent departed. At the same time, Long Island farmers drove horses to railroad sidings and loaded wagons onto flatcars to get their produce to the New York markets.

In the early 1950's, railroads, finding they were losing profitable traffic to truckers, decided to join them. They devised a system whereby trailers could be loaded on flatcars and transported over long distances far cheaper than a Teamster could tool truck and trailer over the same distance.

POOLING CARS  
The standard flatcar could carry only one trailer, but railroads soon developed 85-foot flatcars that could handle two. Thirty-one roads formed Trailer Train Co., to standardize equipment and to provide a free exchange of cars. Trailer Train has bought 5,000 85-foot piggyback cars in the last two years and had 1,000 more on order for delivery this year. Piggyback flatcars are being built by Pullman, American Car & Foundry, Bethlehem and General American Transportation.

Almost every important railroad now provides piggyback services for shippers. Loadings this year are reported to be 35 per cent above 1960. More and more truckers are gathering and consolidating trailer loads of freight, taking the trailers to railheads, and sending them by flatcar across the country. At destinations, truckers pick up the trailers and deliver them to consignees. Operations and both ends are handled by dues-paying Teamsters, which will tend to postpone a boycott of piggybacking.

# Gary Player And Palmer Deadlock In 2-Man Show

AUGUSTA, Ga. (AP) — The Palmer Method was challenged today by a jaunty South African who writes his own golf ticket as the silver anniversary Masters Tourney sped into its third round — a virtual two-man show.

The deadlocked leaders—Arnold Palmer, the defending champion, and Gary Player, the PGA top money winner from Johannesburg—carried a four-stroke lead over 36 other pros and three amateurs into 18-hole semifinals.

The tied pacemakers reached the halfway mark of the 72-hole medal play classic with 137s, seven under par.

Player was the only shooter on Augusta National's sunny, scenic acres Friday who refused to concede that Palmer is a gold-plated clinch to win second straight Mas-

ters and his third in four years. Player sniped the par 72, 6,980-yard course for five birdies in a 35-33-68 round. That put the pressure on first-round leader Palmer who shot a 69.

The yips apparently hit bespectacled Bob Rosburg, who matched Palmer's 68 Thursday but wavered to a 73 and a third place grading of 141 at 36 holes.

A stroke behind Rosburg was Don January, who rallied for the only other 68 second-round score and moved into fourth spot with 42, two under par for the distance.

After that, it was a cavalry charge in the quest for the winner's purse which could exceed Palmer's \$17,500 swag last year since the base \$20,000 over-all purse—\$5,000 to the champ—is fattened by total receipts for the four-day meet.

The folks are swarming here. An estimated 25,000 attended Friday. Last year \$70,000 was paid off to the players.

Knotted at 143, six strokes back of Palmer and Player, were seven players—pros Byron Nelson, 49 a two-time Masters champion, Ken Venturi, Lionel Hebert, Tommy Bolt, Ted Kroll, and Walter Burkemo, and the top amateur, Charley Coe—twice U.S. amateur champion.

Only one contender was notched at even par 144, slender Paul Harney, while bracketed at 145 were five players — former U.S. Open champions Lew Worsham and Jack Fleck, Gene Littler, and the other two surviving amateurs, Jack Nicklaus and Bob Gardner.

Packed between 146 and 149—cutoff point for the final 36 holes—were 24 players, among them three-time Masters champion Sammy Snead and two-time winner Ben Hogan, each at 147.

Among those who fell by the wayside were seven former Masters champions, including 1955 winner and 1956 U.S. Open champion Cary Middlecoff; three-time Masters king Jimmy Demaret; and Horton Smith, the 1934 inaugural winner and also 1936 champ. Other ousted winners were Gene Sarazen (1935); Craig Wood (1941); Herman Keiser (1946); and Claude Harmon (1948).

Other casualties included former U.S. Open champions Julius Boros and Ed Furgol and last year's British Open champion, Kel Nagle, who finished 151 or worse.

All other teams, including the new Los Angeles Angels get under way Tuesday. The largest crowd probably will be in Los Angeles where the Dodgers will play the Philadelphia Phillies under the lights before approximately 50,000.

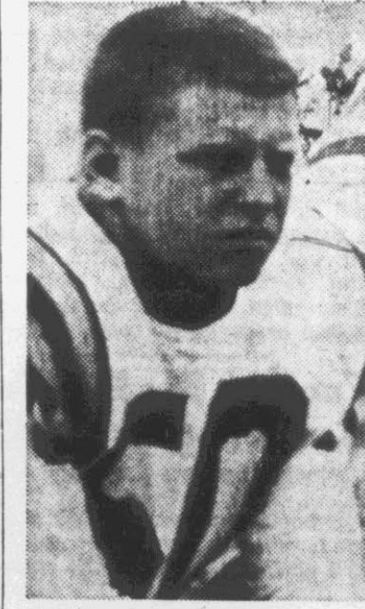

## Fibber's 'Molly' Is Victim Of Cancer

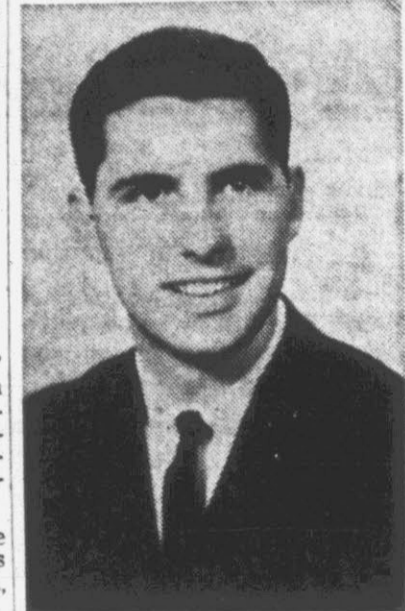

"But why New Mexico?" Fairlie asked. "Why does the Smithsonian want me to go out there?"

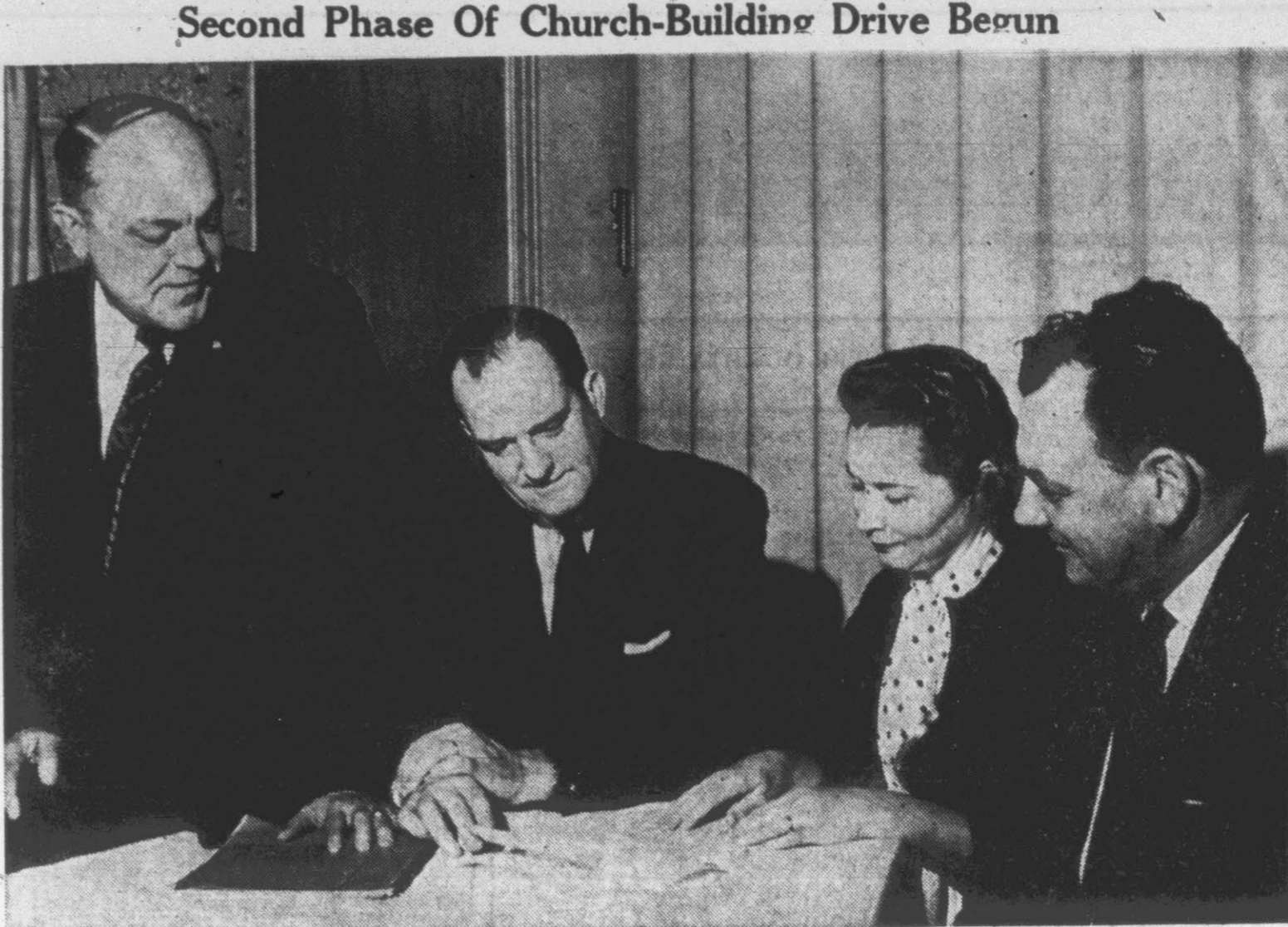
