WASHINGTON (AP)—Communist diplomatic sources hinted today that Nikita Khrushchev may turn up with some spectacular new proposals when he meets President Kennedy in Vienna.

# Outdoor Dining Simple But Chic

Now is the time for clever hostesses to get ready for major entertaining. The outdoors with its built-in scenery, casual atmosphere and simple table service requirements permits the lady of the house to give a chic luncheon or supper party with the minimum of effort. What's more, she can do it on a budget.

A patio, terrace or porch party gives one the opportunity of decorating in the popular Far Eastern motif. Colorful paper fish and dragons may be hung from the porch roof or terrace walls. Strings of miniature Japanese lanterns can add to the gaiety after dark.

Table service could include red lacquered Japanese trays and bowls, salts and peppers. Stainless flatware with lacquered bamboo handles follows the theme and can be used any time. Chop sticks are fun for adventurous guests. Plastic dinnerware is chic and can withstand juggling by the guests. Patterns lend themselves to whatever theme you dream up. A Melmac dinnerware includes a

misty pine pattern that resembles a Japanese scroll. A glass bowl of pussy willows can complete the Oriental table setting, along with a Japanese hibachi, a charcoal cooker that may be used on the buffet table.

If the party is at the shore, an island theme can be complete with table cloth of brilliant pink, orange or blue. Chowder could be served in clay pots, dessert in large sea shells. A fish net table cloth, napkins with fish motif and bibs with lobster motif could carry out the idea.

If you are a bean specialist, try a Mexican party. Use straw mats and clay table ware, a good background for chile, tamales and tortillas. A large Mexican sombrero could be filled with colorful flowers for a centerpiece decoration.

An outdoor barbecue of steak or hamburgers is traditionally American, especially for family parties. One of the new charcoal lighters in an aerosol can is an instant torch for barbecue buffets, which may take the fun out of the before-fire arguments but it'll be a joy to the long-suffering family

## Asks Reports On State Prisoners

RALEIGH (AP)— Gov. Sanford said Monday he has asked the State Paroles Board to furnish him reports and recommendations on a long list of prisoners—including the seven union men still in prison in connection with the Henderso textile strike.

The governor said this in answer to a question at his weekly news conference.

Sanford gave no indication whether he may extend clemency to the seven, who were convicted of conspiring to destroy facilities of the struck Harriet - Henderson Mills.

The Textile Workers Union of America officially will end its 2½-year strike on Thursday. Most of the unionists were replaced and there is no labor organization at the plant now.

Malcolm Jarrell, an eighth union man who was convicted along with the others, completed one-fourth of his 2 to 3-year term recently and was paroled.

Among the seven still in prison is Boyd Payton, Carolinas regional director of TWUA, serving 6 to 10 years.

## Short End Again For Teachers

RALEIGH (AP)—All state employees except teachers will receive a 5 per cent pay raise during the next biennium if the legislature approves the action of its Joint Appropriations subcommittee.

The subcommittee Monday voted for the pay boost, which would cost \$10 million dollars. A proposal to give school teachers a pay raise of nearly 22 per cent already has been approved by the subcommittee.

In other actions, the subcommittee:

Approved a total of \$4,720,200 in increases over the recommended budget.

Added \$25,000 to the capital improvements budget for Broughton Hospital at Morganton. The money will be used to build a chapel there to replace an outmoded one.

Added \$50,000 to the welfare appropriation for the Asheville Orthopedic Hospital. This makes a total of \$150,000 the privately operated institution will receive in state aid during the biennium.

Turned down a proposal to pay \$103,353 for five fire-fighting tractor units to combat forest fires in an area ranging from Elizabeth City to Hoke County.

## Boys Beat, Rob, Kill 76 Year-Old

NEW YORK (AP) — Teen-age robbers brutally beat Harry Heisler, 76, shot him fatally and fled with his wallet containing \$3 Monday night.

Heisler was attacked in a self-service elevator in a lower East Side housing project where he lived with his wife.

Police described the attackers as Spanish-speaking boys ranging in age from about 14 to 19.



# A Blow To Democrats Everywhere

It is a blow to Democrats everywhere—not just those in Texas—that the Lone Star state has elected its first Republican to the Senate to occupy the seat formerly held by Vice President Lyndon Johnson.

For the Republican Party the victory of John G. Tower, 38-year-old former college professor, represents a major achievement in spite of predictions last fall that Texas would have been in the Republican column in the national election had not Johnson been on the national Democratic ticket.

The victory of Tower in the Texas senate race will be a tremendous boost for GOP spirits throughout the country, and particularly for those in other Southern states where the 1960 election saw some unprecedented gains in the number of GOP ballots. It points up the fact that the former feeling that it was almost impossible for a Republican to be elected to the Senate from the South has now been exploded. If the Republicans can elect a Senator in Texas, one might ask, can they later elect a governor and increase their hold on state offices and seats in Congress?

While the Texas election will in all probability stimulate Republican activity in the South, it should likewise stimulate Democratic activity in these same states. Since the general election in North Carolina

last fall, we have seen a more concerted effort than ever before to solidify and build the strength of the Democratic party. The fact that the Republican party showed considerably more strength in both the national and state campaigns in this state than heretofore had been experienced is certainly one reason for the renewed emphasis on strengthening the Democratic Party.

While the Republican strength in North Carolina last fall has set Democratic leaders working to strengthen their party, it likewise has put new life into the building of the Republican party in this state.

The election of a Republican to the Senate from Texas is another indication that the Solid South in Democratic terms cannot be taken for granted in future years. In states where complacency in Democratic ranks leads to neglect of the party fences, the Republicans can build fences of their own to channel voters to the polls on election day.

It happened in Texas in spite of the fact that the Vice President and the Speaker of the House of Representatives are from that state, it can certainly happen in other Southern states.

# Assembly Looks After Its Own

**PAY RAISES** — Bills introduced last week by Rep. Tom Woodard of Wilson, chairman of the House appropriations committee, and virtually assured of enactment, would increase the pay of principal clerks of the House and Senate from \$20 to \$30 a day, and of reading clerks and sergeants at arms from \$16 to \$24 a day, retroactive to the beginning of the current legislative session. That means a fifty per cent raise in pay. All other clerical workers and personnel attached to the General Assembly will get raises ranging from 15 per cent to 25 per cent under the Woodard bill.

These pay raises for legislative employees contrast with provisions in the general appropriations bill for approximately 20 per cent pay raise for school teachers and some 3 per cent for the rank and file of State agency and departmental employees.

Members of the General Assembly in voting these increases for their own employees were consistent with extra money voted for themselves. The salary of legislators is fixed in the constitution at \$15 per day for a limit of 120 days. The members could not increase their per diem pay, but they are not restricted in voting expenses money for their use. So — a few weeks ago they voted to raise the daily expense allowance from the statutory \$8 a day to \$12 a day — also a 50 per cent increase. (Although it developed that legislators had been drawing \$9 a day, despite the \$8 statutory limit, because in 1959 the subsistence allowance for other State employees was raised to \$9.)

Pending legislation would raise that limit, and also would provide special consideration for higher spending by certain favored employees.

**CONSTITUTION** — The North Carolina General Assembly has often manifested disregard for the constitution. Most widely publicized instance has been failure to apportion membership in the Legislature. Other less widely publicized instances have been of perhaps greater significance — such as enactment of special acts specifically barred by the constitution and raising the expense allowance of members. The amendment adopted several years ago providing for per diem subsistence specifically sets out that "such allowances shall not exceed those established for members of the State boards and commissions generally." In face of the general rate of \$9 per day, and the special statutory rate of \$8 for members of the Legislature, the legislators this year voted them-

# Strike Memories Will Long Haunt Henderson

Although the once-bitter Harriet-Henderson Cotton Mill strike in Henderson will officially end June 1, memories of the strike will haunt union officials, owners of the mills and citizens of North Carolina for many years to come.

For all practical purposes the strike has been over for many months in spite of the fact that a few pickets have remained at the plants. The mills months ago returned to full production, and many of those who did not return to work at the mills have found jobs elsewhere. There are still others among the strikers at Henderson, however, who still have remained out and have not found other employment.

Though the 2½ year strike was the most costly in the history of the Textile Workers Union of America which has reportedly paid out \$1,250,000 in strike relief to union members in Henderson, this figure does not begin to represent the total cost of the bitter labor dispute.

The loss of work during the period of the strike must be taken into consideration in counting the overall cost; and so must the production lost by the mills. Then too there is the cost of local police and other officials in striving to maintain order when tempers mounted in Henderson, the cost of National Guard troops who were called in to maintain law and order when the situation became too much for local officers to cope with. Also in the cost must be considered the intangibles of the effect the bitter strike and the accompanying nation-wide publicity has had on further industrial development in North Carolina both in the textile and other industries.

Suffice it to say that North Carolina has never before suffered such a costly labor dispute as that of the Harriet-Henderson Cotton Mill in Henderson. It is to be hoped that with the official end of the strike, the state will never again be faced with a similar situation in Henderson or anywhere else in North Carolina.

# Progress, Or A Road To Ruin?

**WASHINGTON (AP)**—Federal spending will hit the \$100-billion mark within the next few years. Will this prove a symbol of national progress or a milestone on the road to fiscal ruin?

The Republican leaders in Congress, Sen. Everett Dirksen of Illinois and Rep. Charles Halleck of Indiana, already are talking about "a jungle of unprecedented spending and loose fiscal policies."

They say President Kennedy is headed for a budget of \$125 billion by 1965.

Dirksen and Halleck sounded off after Kennedy last week unveiled new plans to boost spending for space research, defense, foreign aid, civil defense and jobs.

According to Budget Bureau estimates, these plans will add about \$800 million to spending in the 1962 fiscal year which begins July 1.

Kennedy two months ago predicted a fiscal 1962 deficit of \$2.8 billion. Now the Treasury is talking about a deficit probably reaching \$4 billion; some others in the administration say \$5 billion or more.

If Congress once again ignores a presidential plea for higher postal rates, as seems likely, an additional \$800 million would be added to the deficit. Barring higher postal rates, spending in fiscal 1962 probably will total at least \$96.5 billion as against predicted revenues of about \$81.4 billion.

Although red ink spending on such a scale is a distinct possibility, Kennedy had this to say in making his latest spending proposals: "I am not requesting additional taxes to finance the very

# Other Editors Saying Court Decisions Awaited

(Rocky Mount Telegram)

A U. S. Supreme Court decision awaited with a great deal of interest is expected soon. It concerns the question of whether the union can spend dues, which it collected from persons who were compelled to join the union by a union-shop contract, to promote legislative and political goals opposed by those persons.

The court's decision is awaited by those who are not union members, as well as by those who belong to various labor organizations. The reason for this is because millions of non-union members may very well have many political and legislative issues decided for them through funds used for lobbying, issues non-union citizens might oppose, issues pushed by funds forced from union members not in sympathy with such views.

Against such spending, the repercussions will be tremendous. Unions as a matter of course support legislation and political education drives, both at the state and national levels, with money taken from members' dues. National unions spend hundreds of thousands of dollars each year on lobbying alone.

The AFL-CIO, for example, spent \$129 million on lobbying in Washington last year. Also in 1960 James Hoffa's Teamster crowd spent over \$95,000. This is typical of union expenditures to exert pressure on politicians at all levels.

If the court rules adversely, what will the unions do? Most likely all this high-powered spending of members' dues would have to be refinanced through voluntary contributions rather than dues money, or dropped altogether. To drop such activity would be a blow to the unions which have become accustomed to dictating to the national parties, particularly the Democrats, in order to gain their support.

The Supreme Court decision is expected in the case which brought legal action in the first place — the Street and Loper case. It was originally brought in Georgia by several employees of the Southern Railway System. They asked the Georgia courts to outlaw the enforcement of a union-shop contract requiring all employees to join the union and pay dues within 60 days or lose their jobs.

The courts in Georgia, right up to the State Supreme Court, backed the railroad employees in their fight against this arbitrary requirement. If the U. S. Supreme Court fails to reverse the decision, it will be a major blow on behalf of workmen who oppose compulsory joining of unions. It will also be a blow on behalf of those states now supporting right-to-work laws. It is hoped, of course, that such laws will be sustained, for the arbitrary powers of unions in deciding the work rules of U. S. citizens are against the principles of our Constitution.

# Advice Full Of Flaws

In its effort to plug the holes in income tax collections, the Internal Revenue Service and President John Kennedy have been receiving some astonishingly ridiculous advice. Some of it is difficult to understand as before he became President of the United States, John Kennedy got around not a little. He knows that a \$30 a day expense account will not help sell in big volumes. His own hotel in New York is the Commodore, where \$30 a day will barely get a room, to say nothing about food. In fact, it will not go far in a less expensive hotel.

But it is not this matter that I wish to discuss at this moment. It is the proposed ban on institutional advertising. The Treasury does not wish that this form of advertising should be regarded as a proper business expense. Yet, the same U. S. Treasury engages in and promotes its own institutional advertising. Let me cite:

"How time turns into dollars when you invest in U. S. Savings Bonds." This is part of a very large advertisement, the last lines of which read:

"The U. S. Government does not pay for this advertisement. The Treasury Department is grateful to Perpetual Building Association and The Advertising Council for patriotic support."

Another large advertisement contains the following: "For twenty years America's newspapers have published Savings Bonds ads at no cost to the Government. The Treasury Dept. is grateful to The Advertising Council and this newspaper for their patriotic support."

The Treasury is willing to take the space for these advertisements for free or to permit a business firm to use it to mention its own name. But the Internal Revenue Service refuses to permit a business to charge off as a business expense, let us say, an advertisement warning against inflation or rejecting some concept of management—for instance, labor relations.

In a word, the Treasury does not have a general guiding principle about institutional advertising. Instead, it has set up a censorship on the Press: If the Treasury will determine what is permissible advertising and what is not permissible advertising, this has nothing whatsoever to do with plugging up holes in income tax collections. Such holes can be found in Switzerland, Panama, Hongkong and other places. It can be found to be big holes full of green dollars. What the censorship means is that the Treasury permits as a business expense that which pleases the Treasury.

But who in the Treasury is so erudite, so omniscient, so knowledgeable, as to be able to determine for the whole American people what should and what should not appear in the Press? What is the name of this genius? Is he the fellow who decided that giving Castro blackmail money is charity?

The Secretary of the Treasury knows how wrong some of the schemes that he is supposed to endorse are. His life as a man of wealth, as the son of a banker, as a businessman and government official have provided ample opportunity to know what it costs to get around in a big city. He knows what it costs to do business from experience. He knows that he cannot manage to do much on \$30 a day either in Washington or New York. Why does he not talk up when he is made to be responsible for non-sense?

There is something about those who inherit millions which makes them antagonistic to those who do not inherit millions. A salesman, working for a living, who is required to cover big cities, to dress not elegantly but passably well, who has to take customers out for lunch or dinner or to theater, cannot do it on \$30 a day. Either he takes the money out of his own pocket

### Approve Bill For Summer Schools

RALEIGH (AP)—Legislation to authorize the operation of summer schools in North Carolina's public schools was passed by the House Monday night and sent to the Senate.

Rep. Glenn Hawfield of Union, who introduced the bill, told the House it was permissive legislation. He urged that school units wanting to tax themselves for a 12-month school year be allowed to do so.

Rep. Jack Felmet of Haywood sent up an amendment to exempt his county from the bill and it was approved. Felmet argued that state funds should also be used. He said that rural areas would be at a disadvantage since school buses would not be available.

Rep. Roger Kiser of Scotland, a school teacher for 40 years, told the House "Children are worn out after nine months of school. They need a rest."

Meanwhile, the Senate received a bill which would give lawyers accused in disbarment proceedings a choice of being tried in the courts or by fellow lawyers.

Sen. Edwin B. Clark of Bladen was joined by Sens. Frank Banzet of Warren and James W. Hoyle in offering the bill. Clark said the measure partly stemmed from a case in which the State Bar Council tried to disbar Warrenton Attorney James D. Gilliland.

In other legislative developments:

The House passed a bill to extend for 60 days, until Aug. 1, the period during which small loan firms may not begin operating. The action was taken to give the Legislature time to complete action on bills to regulate the small loan industry.

Sen. Cutlar Moore of Robeson introduced a bill that would require attachments for seat belts on new cars sold in North Carolina after July 1, 1962.

### British Trawler Fired On By Danish Navy Frigate

COPENHAGEN, Denmark (AP)—A British trawler was boarded by the Danish Navy off the Faroe Islands but broke away from her captors and fled across the North Atlantic today. The trawler was fired on and hit several times.

A Danish Admiralty spokesman said the trawler, the 274-ton Red Crusader out of Aberdeen, Scotland, was boarded Monday night by three Danish Navy men because it was fishing in what Denmark regards as restricted waters.

The British skipper agreed to set course for Thorshavn, capital of the Faroe Islands, with the Danish sailors aboard, the Admiralty said. However, the spokesman added, the trawler suddenly veered off course and sped away. Several warning shots were fired by the Danish frigate Niels Ebhessen, the spokesman said.

When they went unheeded the frigate fired at the trawler—despite the presence of Danish sailors on the trawler—and scored several hits.

The Admiralty said the trawler continued without slowing. The Niels Ebhessen commander said it would be impossible to board the trawler and it was decided to stay near the fleeing trawler until further notice.

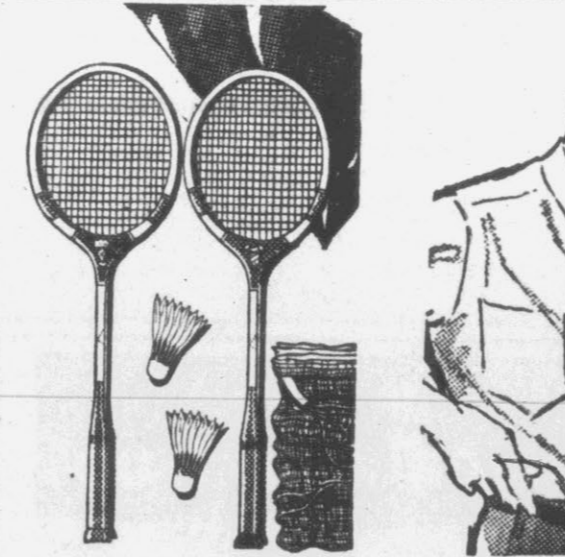

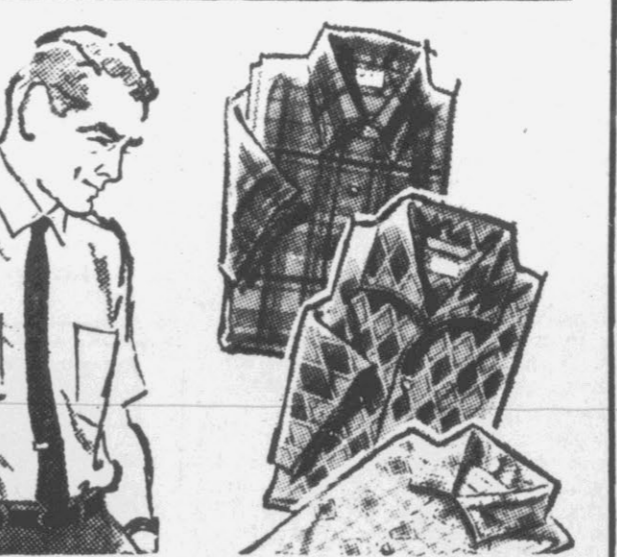

## '500' Classic Opens Today With Big Crowd Expected

INDIANAPOLIS, Ind. (AP) — Possibly the biggest paying crowd ever attracted by a sports event collects today on the 550-acre Indianapolis Motor Speedway grounds for the golden anniversary 500-mile auto race. Whether they came to see blood or competition by brave men—a point argued hotly among anti-speedy groups and the auto racing buffs—they poured in by scores of thousands from throughout the world. The total tradition-ally was a Speedway management secret.

Despite the sentimental bravos for Brabham, the hard fact was that the potential winner probably was among a dozen Americans who had driven thousands of miles on the old 2 1/2-mile brick and asphalt track. High in the list were Roger Ward, Indianapolis, and Jim Rathmann, Miami, Florida, who made a two-man race out of the last two 500s. Ward beat Rathmann by 23.27 seconds in 1958. They swapped the lead 10 times in the last 125 miles last year and Rathmann won by 12.67 seconds after Ward's right front tire wore down to the fabric.

Troy Ruttman of Dearborn, Mich., the 1952 winner, also was in the field. He led early last year before his machinery failed. Other stout contenders included Eddie Sachs, Center Valley, Pa., who started in No. 1 position, inside on the first three-car row, for the second straight year. He won the honor and strategic advantage by being the fastest qualifier on opening day at a dazzling 147.481 miles an hour in a Dean Special, built by Wayne Ewing.

Sach's 10-mile qualifying run was the fastest in Speedway history excepting an almost unbelievable 149.056 last year by then rookie Jim Hurtubise of Lennox, Calif. Hurtubise was in the first row today in his sophomore year with a 146.396 trial, along with Don Branson, 40, of Champaign, Ill., who did 146.843 in a Hoover Special and was rated another solid contender. Brabham was one of eight first-time starters, the biggest crop of rookies in 10 years. Highest regarded of the newcomers among auto racing experts was Parnelli Jones of Torrance, Calif., a stand-out in nine years of competition on smaller tracks.

## Detroit Tigers Settle Back With Lead In American Play

The Detroit Tigers, hardly puffing after a 17-game road trip that did nothing at all to discourage their pennant hopes, settled down at home with a 3 1/2-game lead as the American League race reached the Memorial Day mark. The Tigers left home with a 2 1/2-game edge. They padded it to five midway through the trip and even after losing three of their last four games, still arrived home better off than when they left. In all, they were 10-7 on the tour. Detroit now plays eight at home, goes to Chicago for two and then hustles back to Tiger Stadium for a 12-game stay. Only one game was scheduled in the AL Monday, and righthander Ike Delock of the Boston Red Sox pitched a five-hitter that beat New York 2-1 and ended Whitey Ford's winning streak at six. The loss dropped the third place Yankees five games behind Detroit going into today's single game at Boston.

In the National League, Cincinnati knocked off first place San Francisco 5-1, and the second place Los Angeles Dodgers edged within 1 1/2 games of the Giants by beating St. Louis 2-1.

The rest of the AL's holiday schedule puts Minnesota at Cleveland for a pair with the second place Indians while fourth place Baltimore is at Chicago for two with the White Sox. The Los Angeles Angels are at Washington for a single game. The Yankees were shut out on two singles by Delock (3-1) until Mickey Mantle hit his 11th home run with one out in the seventh for a 1-1 tie. But Boston, after losing eight in a row to New York since last Sept. 6, put it away in the bottom of the seventh. Jackie Jensen, who had homered for the first run in the second inning, walked and came across on an infield out and a single by Vic Wertz. Delock struck out seven and did not walk a man. Ford (6-2) gave up four hits and four walks while striking out eight in his seven innings.

Durham's Bulls scored six runs in the first two innings and went on to defeat Raleigh 8-5. Each team got 11 hits, but Durham's Harry Stigman did a better job of spacing Raleigh's blows. Tonight's games: Greensboro at Winston-Salem, Raleigh at Wilson and Burlington at Durham.

Twice the ball was overthrown as Ron Clark, safe on a ground ball error, scored the winning run in the ninth inning. Manatee (2-2) wound up third in the double-elimination tourney. A third homer helped Wilmington whip Mesa. Benny Broome smashed it with a teammate aboard. The bases were empty when Mesa's Warner Brooks hit a home run in the sixth. Durham's pitching victory was his third of the tournament. Twice before he won in relief.

Atty. Gen. Wants Every Bus To Carry A Placard

WASHINGTON (AP) — If Atty. Gen. Robert F. Kennedy has his way, every interstate passenger bus in the country soon will carry a conspicuous placard reading: "All seats aboard this vehicle are by law available at all times to any passenger without regard to race, color, creed, or national origin."

Similar plain notice to ban any discriminatory policies would be posted at all facilities maintained in connection with interstate bus travel — such as waiting rooms, rest rooms, eating and drinking facilities and windows for ticket sales.

These proposals were the key features of a formal petition which the attorney general filed late Monday with the Interstate Commerce Commission.

Kennedy's aim is to bring the full powers of the commission's vast regulatory authority to bear on ending racial discrimination in the interstate passenger bus system.

Acting in the wake of race riots in Alabama and the continued arrests of mixed white and Negro "Freedom Rider" groups at a bus terminal in Jackson, Miss., Kennedy told the ICC:

"Just as our Constitution is color-blind, and neither knows nor tolerates classes among citizens, so too is the Interstate Commerce Act. The time has come for this commission, in administering that act, to declare unequivocally by regulation that a Negro passenger is free to travel the length and breadth of this country in the same manner as any other passenger."

The Kennedy petition called attention to the fact that the ICC and the Supreme Court over the last several years repeatedly have struck down racial discriminations in interstate travel by railroad and bus.

What he asked the ICC to do was to clear up any doubts by putting into a single brief document a summation of the prohibitions

against any form of racial segregation in the interstate service.

Kennedy suggested that the ICC skip the usual recommendations by a hearing examiner and proceed "as expeditiously as practical" to dispose of the matter directly itself.

In effect, he appeared to be saying that since he was simply asking the ICC to codify a long series of previous decisions, it should not take too much time or "procedure" to do this.

ICC Chairman Everett Hutchinson, a Texas Democrat and an appointee of former President Dwight D. Eisenhower, said in response to an inquiry he did not consider it appropriate to comment on the attorney general's petition, other than to say "it will be considered carefully."

The attorney general told the commission a federal bus code, prominently displayed throughout the interstate system, would lessen the possibility of mob violence involving interstate travelers, and protect such travelers against "inconsistent and unlawful action by state or local authorities."

His aides said that any local action interfering with the federal regulations would be invalid "under the supremacy clause of the Constitution" which says that federal law shall prevail where conflicts occur between federal and local statutes.

Current ICC records show a dozen pending complaints concerning alleged racial discriminations against interstate travelers.

Kennedy blueprinted for the ICC what he wants the regulations to spell out, in seven relatively brief sections. These are:

1. A flat ban on segregated bus seating.
2. The conspicuous display of the placard relating to equal seating rights.
3. The outlawing of any separation of interstate bus service facilities at terminals or "any regular stop" maintained in connection with the interstate service.
4. Definition of the term separation to cover the entire range of meanings.
5. A requirement that the full text of the ICC regulations be displayed at terminal facilities with a heading in large black type—"Public Notice: Requirements of law for terminal facilities at stops of interstate motor carriers of passengers, by authority of the interstate motor carriers of passengers, by authority of the Interstate Commerce Commission of the United States government."
6. A provision that nothing in the regulations "shall be construed to relieve any interstate motor carrier of passengers of any of its obligations as such under the Interstate Commerce Act or its certificate of public convenience and necessity."
7. A requirement that every bus operator must report to the ICC "any interference by any person, municipality, county, parish, state or body politic, with its observance of the requirements of law."

Study Tours, Workshops And Clinics In ECC Summer Plans

As special events of the 1961 Summer School, East Carolina College will offer a series of travel-study tours, workshops, conferences, and clinics.

The summer session will include two terms, the first scheduled for June 5-July 11 and the second for July 12-August 17.

This year for the first time the college will also make available to students an expanded curriculum so that those wishing to complete their work in three years will have no difficulty in scheduling courses required for their majors and minors. Many of these courses have previously been offered only during the regular fall, winter, and spring quarters.

Two travel-study tours have been organized for the first summer session. Thirty-seven students and teachers will travel through the Southwestern states of this country June 4-July 3 on a geography tour designed to give them an understanding and appreciation of geographical conditions and problems of the area. Twenty student-tourists are enrolled in East Carolina's second "Grand Circle Tour" of nine European countries June

12-July 20. One of three conferences held in the United States this summer under the sponsorship of the Gregg Publishing Division of McGraw-Hill Book Company will be held at East Carolina June 26-June 30. Several hundred teachers of business from eastern states of the nation will participate.

Other workshops scheduled for the first session will focus attention on the following topics of educational interest: Training Teachers for the Mentally Handicapped, June 5-July 11; Drawing and Painting for the Elementary School Teacher, June 5-16; Improvement of Instruction in Secretarial Science, June 5-16; Elementary Music Education, June 5-16; Alcoholism in Health Education, June 5-16; Church Music, June 12-16; Theatre Arts for Elementary School, June 19-30; and School Health Education, June 19-29.

A workshop featuring directed observation in the kindergarten will be offered, with students attending one of five sections, as follows: June 5-9, June 12-16, June 19-23, June 26-30, and July 3-7.

The annual Summer Reading Clinic, offered June 5-July 11, will give teachers opportunity to participate in the remedial teaching of special reading cases and to use new experimental techniques and practices.

A group of children admitted for clinical instruction, all problem readers, will represent typical cases found in various levels of instruction. A two-week Reading Institute June 19-July 1 will operate relatedly with the clinic.

Events of the second term include workshops in the Junior high school, July 12-25; visual aids; July 17-27; and secondary choral and instrumental music, July 17-28; The annual Summer Music Camp for junior and senior high school students and for music teachers is scheduled for July 16-29.

Russian Buys Up Tolstoy Letters

LONDON (AP) — The Soviet Union sent an emissary to a London auction sale Monday and bought up 12 signed letters by Count Leo Tolstoy.

At the fashionable Sotheby's saleroom, V. Sazonchuk of the Soviet Embassy paid 620 pounds — \$1,736 — for the letters, which dwell on Christianity and socialism. The author wrote them to an Englishman named J. C. Kenworthy in 1874-96.

The embassy man paid 26 pounds — \$73 — for a signed letter by Peter Kropotkin, an anarchist who lived in London in the last century.

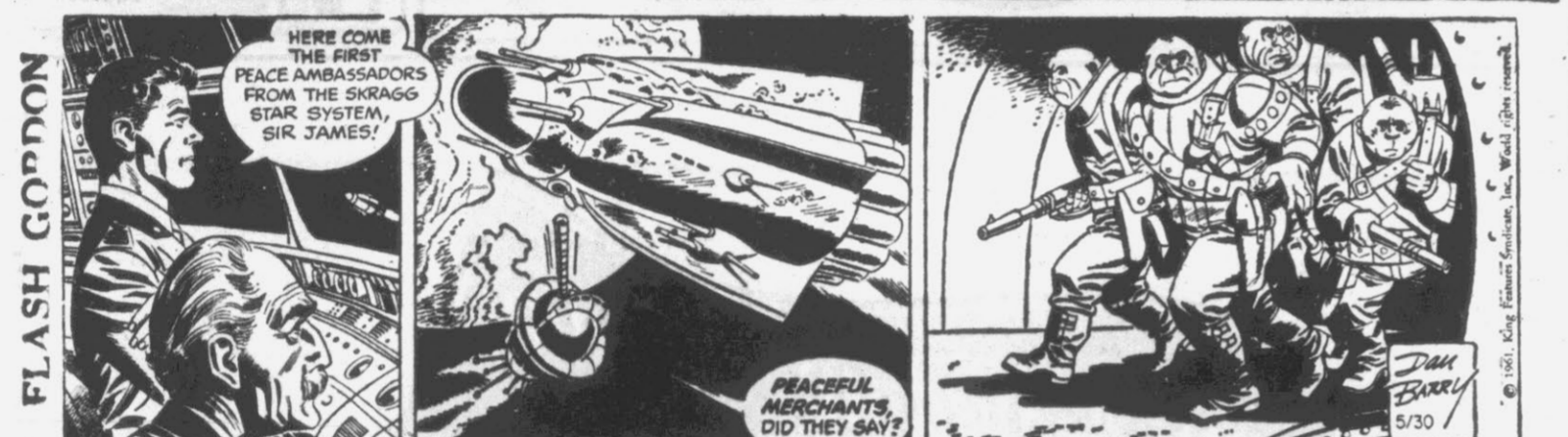

### Re-Districting Plan Faces House Hurdle

RALEIGH (AP) — A Senate-passed bill placing Republican Congressman Charles R. Jonas and Democratic Rep. Paul Kitchin in the same district "will have rough going in the House," a mountain lawmaker predicted today. Rep. Leonard Lloyd of Graham, vice chairman of the House Congressional Districts Committee, said "This thing is not settled. Whitener. There was no discussion Monday night as the Senate passed the Jonas-Kitchin proposal on third reading and sent it to the House. Ed Kemp of Guilford, chairman of the House Congressional Districts Committee, said the group would not meet today as some had expected to rush action on the measure. Instead, there will be a public hearing Wednesday or Thursday, Kemp stated. He added he had received several requests for public hearings on the measure which was introduced only last week. One of the requests, he said, came from Beverly Moore of Greensboro, Democratic chairman in Guilford County. Kemp stated he expects a request from the Davidson County Party chairman.

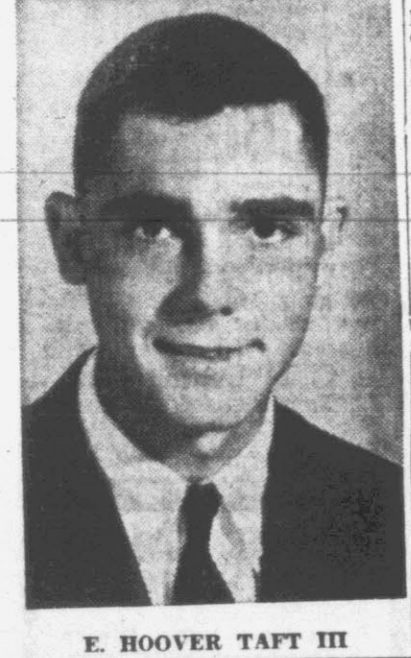
