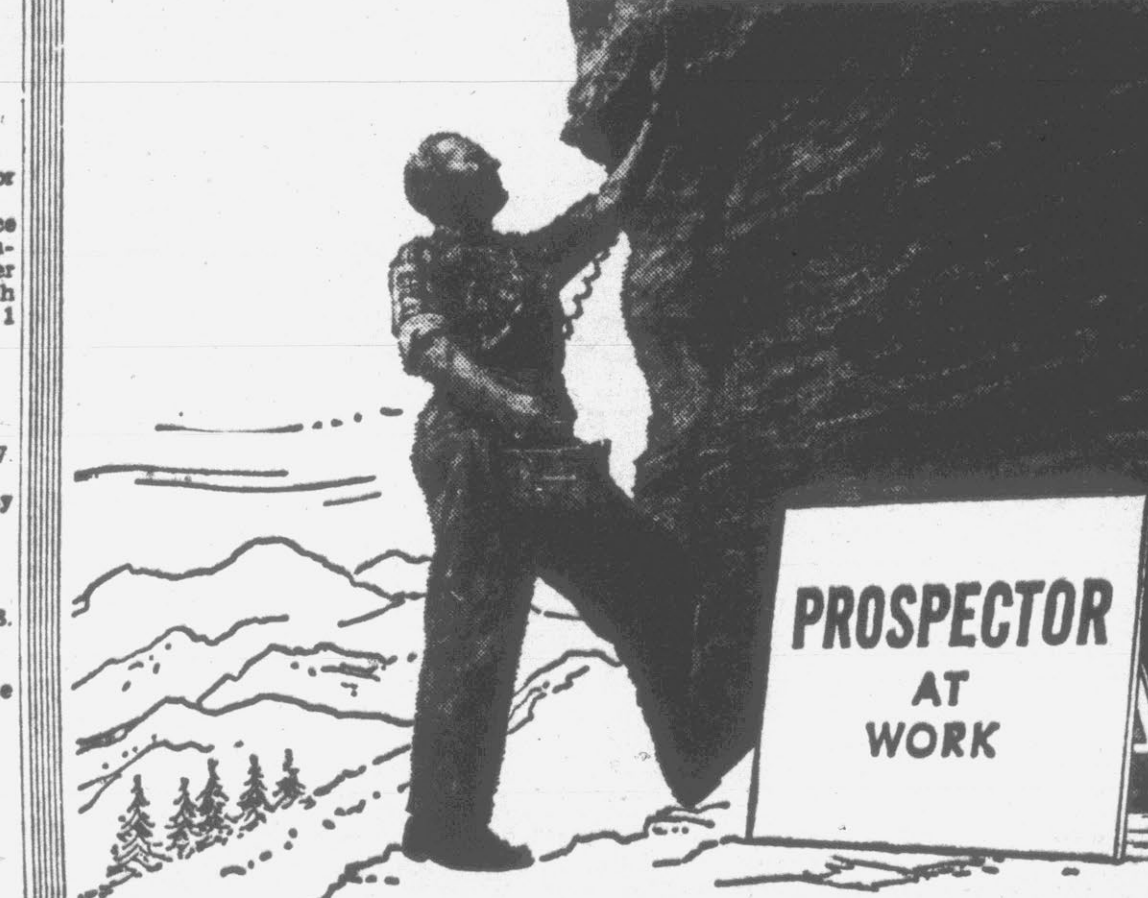

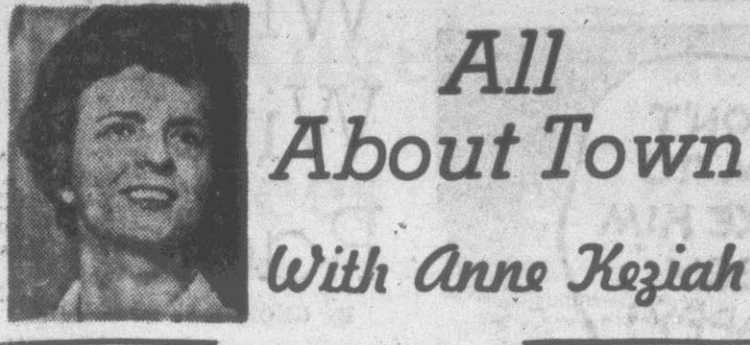

Indians Among N.C. Boosters

BOOSTERS—Among the North Carolinians who received certificates as members of the pioneer chapter of Far Heel Travelers for participation in the Ohio Valley Travel Show last March were several Cherokee Indians. These citizens have continued to boost travel by promoting the "See North Carolina" idea. Last week the Travel Council of North Carolina gave additional commendatory letters to Mrs. Annie Driver, Mrs. Lela Welch, Mr. Hayes Lossiah and Mr. John Ed Walkingstick—all Cherokees and members of the entertainment staff of Oconalofee Indian Village at Cherokee.

In furtherance of the "See North Carolina" idea the Travel Council will participate extensively in the Charlotte travel show next spring rather than go outside the state.

BAD FRONT—The Atlanta Journal complains vigorously about a situation that prevails in Georgia. Much the same complaint can be filed in Eastern North Carolina, although conditions there were never quite as bad as in Georgia and South Carolina.

The protest is about the dilapidated, unsightly and uninhabited cabins and small houses along the highways. The field hands or share croppers who used to live there have been displaced by mechanized farming. But, says the Journal, like protesters from last year's campaign, nobody thinks to take down the old shacks.

The tourist, who has been fed a diet of "Tobacco Road" and "God's Little Acre", doesn't pause to investigate and to learn that nobody has lived in the houses for years. To the contrary, as the fast moving cars sweep by, the impression gained is that this represents living in the area.

Dilapidated houses and barns, old automobile "graveyards" and service station premises cluttered with old tires and old drums present to travelers a bad road—worse than anything the billboards can suggest.

AZALEAS—The committee in charge of the 1962 North Carolina Azalea Festival at Wilmington has fixed the dates of April 5 to 8 for the event. It is necessary to set the date months ahead in order to line up entertainment, "royal" guests, and other phases of the mammoth festival. But there is hazard in advance guessing. Only two or three times in the fourteen years of the festival has the selected date hit right at the peak of the blooms. But—only two or three times has the date been so far off as not to have plenty of beautiful flowers.

MULTIPURPOSE—Nearly every time a facility primarily designed for one purpose is diverted to another use there are prob-

lems of priority. From early days of TVA there has been controversy about the main purpose of the big dams—to generate power or to control floods. Lately a new factor has been injected—recreation. Actually bills have been introduced in legislative bodies requiring(?) government flood control and private power reservoirs to maintain a specified water level for the benefit of non-investing boaters and fishers.

Most recent incident involves efforts of viral groups seeking to use public facilities for their own private pleasure. The controversy between fishermen who want to use highway bridges as private fishing piers, and water ski fans who want to use the intracoastal waterway for a private ski-rink, would be ludicrous—except that major governmental agencies have taken a part in the argument. The Legislature even passed a law about it.

Wide publicity has been given the situation at Wrightsville, where a highway bridge spans the intracoastal waterway. Doubtfully there are, or will be, other instances of conflict. The bridge was built by Federal and State money to provide for movement of water craft. That particular section of the waterway is one of the best free water ski places in the state. And the bridge affords one of the best free fishing piers. Trouble is that fishing lines and hooks sometimes dump the skiers into the water, and fishermen catch wooden slats instead of edible fish.

One solution, which apparently has not been seriously considered, might be to use the highway bridge for land vehicular traffic, and to use the waterway for its original purpose—to serve business and pleasure water commerce. The total capital investment of taxpayer money in these facilities is too much to permit diversion to pleasure use of a few dozen—or a few hundred—people at expense of the whole public.

\$19.320—The National Association of Manufacturers has completed a study which shows that it requires an average of \$19.320 capital investment in facilities to provide one person a job. The amount is less in many areas, more in some highly technical automation industries. Reduced to simplest possible terms, that means that an employee working 40 hours a week at \$2.50 an hour must work four years before his employer can hope to make any profit to be distributed as dividends to stockholders or profit-sharing arrangements with employees.

The current State budget of a billion and a half dollars—three quarters of a billion a year—distributed among the approximate 60,000 persons on the State payroll, means that the taxpayers have invested about \$12,500 in every job.

the people of this county, and likewise to people of other counties who will be served by the training center. The future growth of the institution, and the fact that it will be a permanent state-supported facility in this county must likewise be taken into consideration in determining its location.

It will be no easy task for the Board of Education and the state officials to decide which of the proposed sites will best fill the needs of the school and the people who are to be served by it. Yet, their final selection of the site must be made on this basis. As in locating any major facility for long-term use, the selection of a site for the industrial school must be on the soundest possible basis with due consideration given to every factor involved.

This is a major task for those charged with the responsibility for determining the site of the school. At the same time it is a task which could be carried out with all deliberate speed in order that work may begin on the training center as quickly as possible. Pitt and surrounding counties will receive immense benefits from the training center, but these benefits will not begin until the school is ready to accept students. It is important, therefore, to the county as a whole that the preliminary work on locating the school and preparing for its construction be completed as early as practical.

Gibbs' Resignation Is Viewed With Regret

The resignation of S. G. Gibbs as Greenville Police Chief after almost nine years as head of that important department of the city will leave a void among the city's department heads which will not be easily filled.

During the time he has been head of the Police Department, Chief Gibbs has afforded the city effective, impartial and efficient law enforcement. He has brought into the department new methods and up-to-date law-enforcement operations that have stood the city and its residents in good stead during these years.

Under Chief Gibbs' direction Greenville has developed one of the best police departments for a city of this size in North Carolina. Its record in all phases of law enforcement in recent years—in providing police protection, traffic safety, investigation and crime prevention—has been outstanding.

It is with regret that we view his resignation as Greenville's Chief of Police after rendering years of outstanding service to this community. At the same time, however, we recognize the fact that the state is acquiring the services of an excellent law enforcement officer and administrator in the new position Chief Gibbs will be accepting with the state government.

Foreign Aid Is Aided By Nikita

WASHINGTON (AP)—Premier Khrushchev has been helpful and impartial to the Republican and Democratic administrations in recent years just as they were going through the wringer to get congressional approval for their foreign aid plans.

Three years in a row he has stood up such a ruckus about something that Congress looked on foreign aid as a pretty good idea. If he had played quiet, Presidents Eisenhower and Kennedy might have had more trouble here at home.

Khrushchev did it in 1959 when Eisenhower was in the White House by threatening Berlin. He did it again in 1960 by insulting Eisenhower, wrecking the summit meeting, and being generally belligerent.

And now, just as Kennedy was having a gloomy time getting approval for his new long-range foreign aid program, Khrushchev dug up his Berlin scare again, trotted it out, and made foreign aid sound like one of the good ways to undercut him.

Thursday, for instance, Sen. J. W. Fulbright, Arkansas Democrat and chairman of the Senate Foreign Relations Committee, said menacing conditions in Berlin, Cuba and Laos have improved chances for Kennedy's foreign aid proposals.

This was after Secretary of State Dean Rusk had told the committee about the troubles communism is causing the United States around the world.

Since the war the United States has spent \$85.8 billion on foreign aid — \$60.4 billion of it for economic help and \$25.4 billion for military assistance in one form or another. This aid has gone to more than 70 nations.

Since the recovery of the European allies of the United States, who were helped back

on their feet after the war by American aid, they have joined in giving some help to more backward areas. Kennedy wants them to do more.

In the past American help was given on a year-by-year basis which brought complaints from American critics that this was the wrong way, that aid should be given long-range to let receiving nations do long-range planning with worthwhile projects.

Kennedy bought this idea and asked Congress to let him approve aid over a five-year period. This has been one of the big bottlenecks since Congress traditionally likes tighter control, such as year-by-year spending provides.

For the coming year Kennedy asked what Eisenhower had asked, about \$4 billion. But for the long-range project he asked around \$8 billion, although in practice it probably will run a lot higher.

Kennedy suggested too:

1. Putting most existing economic aid programs into a single new agency whose boss would report directly to Kennedy and Rusk.

2. Arms aid, now running about \$2 billion a year and administered through the Pentagon, would be separated from the annual foreign aid package and placed in the military budget.

3. Carefully tailored programs for each country receiving aid, based on the over-all needs and local resources rather than unrelated projects, with special favor toward those nations undertaking social and economic reforms.

It's doubtful Kennedy will get all he asked — at least in the form he asked — but Khrushchev's fist-banging is a big help in convincing Congress he had to be stopped and one of the safest ways is through some more foreign aid.

The Millions We've Given Him—

Took A Busman's Holiday

It's easy for a working man to take a busman's holiday on vacation. Most folks who enjoy their work find this out as they travel.

A postman wants to see the post office, a theatre operator the movie house, the store owner a similar establishment.

Russell Cowan and myself in Nassau were no exceptions. Russell is a druggist so shortly after arrival we walked into the nearest drug store to see how its done on the island.

The front part of the store was set up similar to ours. There were cosmetics, candies, film and various sundries on display. We explained our interest to the clerk and she directed us back to the prescription department.

There we found George Higbs busily compounding a prescription. He surprised us by explaining that pharmacists don't go to college to learn their profession in Nassau. They serve a four-year apprenticeship and then take an examination. Actually, he said, there is no pharmacy school on the island.

For higher education, there is only a small liberal arts college. However, he continued, a few lucky ones go to England for a period of study.

Much of the drug supply comes from the United States, he told us, a little over 50 percent. Alcohol is bought from England "in bond" since there is a \$20 per gallon tax on that purchased in the United States. Ethyl alcohol is not a big item in the prescription business though.

Russell told me later that the bottles of pills and medicines were distributed on the shelves similar to what would be found in the States.

The drug store out of the way, we walked about the town until we found a newspaper office. We went in and I introduced myself as a newspaperman to the man behind the counter.

He told us that this was only the circulation office of the paper. However, he'd be glad to take us to the newspaper plant on the edge of town. We readily agreed and he took us to his car parked nearby.

"I want to probe a point," he stated as we entered the vehicle. "I want to prove that this thing will still run." We could see his point. It was an English-made auto of ancient vintage.

We headed "over the hill" as the natives say, and into the residential section of Nassau.

"This is our colored quarter," our guide said. "At your home

you would call it colored town." He was Negro himself as is 85 percent of the island's population.

Soon Nassau's big new high school looked into view and a right turn brought us to the newspaper's plant. There we met the editor, who seemed a part of old England, and the mechanical superintendent, a friendly man who rode herd over printers, line-type operators and pressmen.

The mechanical superintendent recalled that a North Carolinian had recently worked in the paper's advertising department. He showed us a picture of the man from Ashoklee. He was holding a North Carolina Press Association advertising award which he won.

After we had seen the shop we boarded the old auto once again and our guide carried us directly to the dock on Bay St. and our ship. Our busman's holiday urge was satisfied. Once again we were just tourists.

There is considerable selfishness in the talk about what the public desires. It is like the advertising agency's man who objected to the use of the name of Abraham Lincoln because the Lincoln is a competing car. Such brilliance we can do without.

Each car still be very useful, particularly as so many use it in their cars. That has not yet been invaded by television. In the current congressional investigation of radio and television, much has been said on both sides which is more excitement than mature judgement.

First of all, it must be recognized that there are no private property rights in the air. When we speak of a network, we refer to a private business which syndicates acts, shows, and whatever to stations scattered over the country. It is true that the networks own some stations but most of them are not so owned. Many radio stations are owned by newspapers or by publishing syndicates which also own newspapers. Some are owned solo.

At this point it needs to be made clear that the ownership of a radio or television station does not give anyone the right to do anything about it. The air-waves are owned by the government of the United States which has exclusive authority over them. The station-owner is licensed by the government to use a government-owned air-wave. The final decision as to what may appear on the air-waves rests with an agency of the government, the Federal Communications Commission which has, on the whole, behaved itself surprisingly well. It has been moderate in its rules concerning censorship. It has not interfered too much with the conduct of stations or networks. While occasionally a network manager or an advertising agent would like to forget where the authority over radio and television rests, most of the stations obey the rules and regulations, even if their programming represents immaturity and bad taste.

Let us stop asking ourselves whether or not the Biblical record is true or mistaken. The important thing is whether or not it is true to us. Is the Bible a mere book or is it a divine message which God has written upon our hearts? If it is a divine message, then indeed God is our God and we are His people.

The fallacy of the rating systems is that they seek only to discover what the audience is watching, not what it wants to watch. The might find, if they plucked a little leeper, that the public is sick of the present fare, that it desires an improvement, and that it has some pretty definite ideas about how improvement might be achieved. The fact that the public likes a show of a certain type does not mean that it will welcome, or even watch, a hundred shows of the same type. And no finding of the rating surveys can relieve the networks of their responsibility to explore new ideas of serving and holding the audience which they now have and hope to build.

Few aspects of American entertainment deserve criticism more than the television rating systems, but in contending that the sample used by raters is too small to be dependable, comedian George Jessel is using a weak argument to advance a good point. And he is neglecting the points on which all of the tv rating systems are vulnerable.

The protest that "I don't know anyone who has ever been called by a television survey" is a common one, and it is true that the rating systems employ a very small sampling on which to base their evaluation of a program's popularity. Yet other surveys in advertising, educational, and political campaigns have proved rather conclusively that a small but scientific sampling can be as dependable as the most broadly-based poll.

The real weakness of the rating system lies in the fact that it judges the popularity of programs on the basis of the number or proportion of set-owners who are watching the program at a given time. As long as the surveys on which the ratings are based ask simply "Which program are you watching?" they will neither help improve television fare nor accurately assess any given program's popularity.

When a customer decides on a property, she asks him to sign a sales contract. This is an agreement to buy the place with one curious clause that provides the sale will take place six months and a day from date, although the buyer may take possession immediately.

The agent buys the property herself from the original owner, paying the agreed price less her commission.

What's With Radio?

When one travels on the road he might turn on the radio to listen to something. What he hears for miles and miles is Rock-n-Roll or hillbilly music, or perhaps a Polka in areas where there are Poles or the crooning of a female Calypso singer or the terrible wailing of a woman who has outwitted what is called a "sultry" voice.

Then on comes what is called news. It is the reading of short, crisp bulletins which may give some indications of what is happening. The best of news reporting has moved from radio to television. However, the news is a relief from the music and therefore is of some value.

You might ask, why listen? It grows on one. I generally turn on good music while I work. By good music, I mean taste like Mozart, Bach and so on. Sometimes intermingled with such offerings are some modern novelties which may prove interesting for the moment, or some which may last a little longer, perhaps half a century or so.

Just now, up in the woods, my radio is bleating an awful Polka that would have driven Paderewski to change his citizenship. It is a Polka written by an American with a trifle of jazz in the rhythm and perhaps a bit of hillbilly in its overtone. It is a chop suey, a goulash, a rubbish.

Radio program planners believe that they know what the public taste is. Actually, the public did not have such bad taste until they listened to these efforts at musicalizing on radio. Back in the days of Williams and Warner, the grand team of vaudeville stars used to be what were then called "coon-shouters." They were singers who produced music in what was regarded as the Negro idiom. It was good listening although not quite as exciting as the sentimentalities of Gus Edwards. Even today, we are singing "School Days," and a tear comes to the eye. We even have a barber shop quartette and the audience went wild.

The QXR theory of programming is delightful and when FM is used, it justifies the existence of radio. I am told that several stations in various parts of the country are using the QXR format and are doing well financially which only goes to show that nobody can be an absolute authority on public taste. Good music is nowadays stylish.

There is considerable selfishness in the talk about what the public desires. It is like the advertising agency's man who objected to the use of the name of Abraham Lincoln because the Lincoln is a competing car. Such brilliance we can do without.

Each car still be very useful, particularly as so many use it in their cars. That has not yet been invaded by television. In the current congressional investigation of radio and television, much has been said on both sides which is more excitement than mature judgement.

First of all, it must be recognized that there are no private property rights in the air. When we speak of a network, we refer to a private business which syndicates acts, shows, and whatever to stations scattered over the country. It is true that the networks own some stations but most of them are not so owned. Many radio stations are owned by newspapers or by publishing syndicates which also own newspapers. Some are owned solo.

At this point it needs to be made clear that the ownership of a radio or television station does not give anyone the right to do anything about it. The air-waves are owned by the government of the United States which has exclusive authority over them. The station-owner is licensed by the government to use a government-owned air-wave. The final decision as to what may appear on the air-waves rests with an agency of the government, the Federal Communications Commission which has, on the whole, behaved itself surprisingly well. It has been moderate in its rules concerning censorship. It has not interfered too much with the conduct of stations or networks. While occasionally a network manager or an advertising agent would like to forget where the authority over radio and television rests, most of the stations obey the rules and regulations, even if their programming represents immaturity and bad taste.

Let us stop asking ourselves whether or not the Biblical record is true or mistaken. The important thing is whether or not it is true to us. Is the Bible a mere book or is it a divine message which God has written upon our hearts? If it is a divine message, then indeed God is our God and we are His people.

The fallacy of the rating systems is that they seek only to discover what the audience is watching, not what it wants to watch. The might find, if they plucked a little leeper, that the public is sick of the present fare, that it desires an improvement, and that it has some pretty definite ideas about how improvement might be achieved. The fact that the public likes a show of a certain type does not mean that it will welcome, or even watch, a hundred shows of the same type. And no finding of the rating surveys can relieve the networks of their responsibility to explore new ideas of serving and holding the audience which they now have and hope to build.

Schweitzer Will Head 'Summit'

LONDON (AP) — Dr. Albert Schweitzer, famed humanitarian and Nobel Peace prize winner, has agreed to be honorary head of a proposed summit peace conference of religious leaders, it was disclosed today.

Rabbi Maurice N. Eisendrath, president of the Union of American Hebrew Congregations, announced appointments of the famed 86-year-old medical missionary at the 12th International Conference of the World Union for Progressive Judaism.

Rabbi Eisendrath told delegates of 22 nations that Premier Khrushchev, President Kennedy and other world leaders appear further apart than ever in their negotiations.

It is the duty of religion, he said, to exert moral pressure to persuade the heads of state to subordinate self interest and hasten their negotiations so an accidental push of a button may not destroy the world.

The idea of a summit conference of religious leaders was proposed in 1959 by Rabbi Eisendrath after discussions with leaders of Islamic, Buddhist, Moslem, Hindu and Shintoist faiths as well as outstanding Christian churchmen.

Rabbi Eisendrath said he hoped to form an international organizing committee and expected the conference would be held by late 1962 or early 1963. He recommended Bombay as the summit site.

Belhaven Man Inducted As Rotary District Governor

WASHINGTON, N.C. — Dr. William T. Ralph, Belhaven dentist, was officially inducted into office as governor of District 773 of Rotary International in an inter-city meeting of Washington and Belhaven-Pantego Rotary Clubs held here Thursday evening.

Dr. Ralph was elected district governor at the Rotary International convention in Tokyo, Japan, early in June, and succeeds J. Bruce Eure, attorney of Fair Bluff and Whiteville.

Retiring Governor Eure presented the governor's emblem to Dr. Ralph, and a past governor's emblem was presented to Eure by Past District Governors Charles L. McCullers of Kinston and Dr. Maynard O. Fletcher of Washington.

An address by Edmund H. Harding, highlighting Rotary experiences of the quarter of a century since he began his service as Rotary district governor, was interspersed with many humorous and anecdotal sequences. Harding was introduced by Carl Goerch of Raleigh, a former president of the Washington Rotary Club. Dr. Zeno L. Edwards, Sr., of Washington, presented Goerch, now retired publisher and editor.

Dr. Ralph said one major project of his administration will be the advancement of the Rotary Foundation program, with all 43 clubs of District 773 participating 100% in this effort.

Cites No Time Limit On Work At Library

An official of Coastal Refrigeration, Inc. said this morning his firm hopes to have the air conditioning for Sheppard Memorial Library in operation by July 15.

However, he pointed out, there is no time limit for completion of the project in the contract.

Phil Moore of Coastal Refrigeration, Inc. had this to say in commenting on the City Council's discussion of the project Thursday night. The council instructed City Manager Louis Schepers to write the firm requesting that representatives appear at a council meeting July 26.

In a statement today, Moore said: "With regard to air conditioning installation at Sheppard Memorial Library we would like to take the opportunity to advise the City Council, the new city manager and the public in general that this installation is more than a mere air conditioning installation. It is a rather complicated year round system using heat pumps.

"There is an extensive electrical contract comprising rebuilding of the entire electrical system. This contract is being handled by another reputable local firm as a subcontract. Electrical work has not been completed nor has the refrigerant work. It is anticipated that the electrical switchover will be made the first part of next week.

"We would like to advise that one of the primary delays in this installation has been the fact that the late unseasonably cold weather prevented our tearing out and removing of the old boiler and steam heating system which had to be accomplished since the old boiler room is being used as the new equipment room. The library requested our delay in removing of this boiler due to the cold weather. We hope to have the installation in operation not later than July 15."

City Manager Schepers told the council Thursday that the air conditioning project had reached the point where it should be approached through the council.

Meanwhile former City Manager Leonard Bloxam who has overseen the project for the city said in a statement this morning, "I didn't know there was a problem. Several weeks ago Phil and I met with the library board. We told them what the problem was and they seemed at that particular meeting satisfied with the solution to the problem.

"At that time he assured them that he would have someone working on the project continuously beginning that week. There were some electrical problems that had to be worked out. Our understanding was that that would be coordinated with the other work. To my knowledge there has been someone working on air conditioning wiring ever since."

Carnival Couple Mentally 'Able'

HANOVER, Va. (AP) — Carnival workers Kenneth and Irene Dudley found mentally competent by doctors, may face trial in September on murder charges growing out of the starvation death of their daughter, Carol Ann.

Dudley, 47, and his wife, 44, were indicted for murder earlier this year by a Hanover County Circuit Court jury.

Friday it was learned that physicians at Southwestern State Hospital in Marion, Va., had pronounced both the Dudleys "mentally competent and able to stand trial."

The Syracuse, N.Y., couple were arrested in February after the body of 8-year-old Carol Ann was found abandoned in woods about 100 miles south of here Feb. 9. Police said the child died the night of Feb. 1 in the Dudleys' delapidated car at a truck stop near Ashland in Hanover County.

Later, authorities said the Dudleys admitted that four others of their children died over a 2 1/2-year period as they traveled across the country in quest of employment with carnivals. Police quoted Dudley as saying he and his wife disposed of the bodies of the children dead.

One live child, Christine, 2, was with the Dudleys when they were arrested Feb. 10 in North Carolina.

Tob Growers Given Reminder

The Pitt County ASCS office Friday issued a reminder to tobacco growers awaiting an ASCS representative to witness disposition of excess acreage.

B. Livingston Roberts, office manager for the Pitt County Agricultural Stabilization and Conservation Service, reminded farmers that "they should not harvest any tobacco on any excess acreage."

Roberts said growers harvesting tobacco on excess acreage must comply with some further adjustment.

He reported that all the office's remeasurement and disposition should be completed during next week.

Roberts said 1,139 of Pitt's 2,596 tobacco farms this tobacco season planted acreage in excess of allotments. The overplanters represented 42 per cent of the county's tobacco farmers, he said.

Of the county's 1,651 cotton farms, only eight per cent, or 131 farms, were overplanted. Twenty-six per cent of Pitt's peanut farmers, 224 of 856, planted excess acreage, Roberts said.

The office manager said the ASCS staff has revisited a total of 1,604 farms for remeasurement or disposition.

Russians Taking Advantage Of Health Program

LONDON (AP)—Russian ballet dancers appear to have gone on a dental spree—at the expense of British taxpayers.

One 23-year-old ballerina has had 14 extractions, 11 fillings, two teeth crowned and two false teeth fitted.

The girl paid a London dentist one pound (\$2.80). The actual cost to Britain's National Health Service, which is financed largely out of taxation, was 39 pounds (\$109).

A spokesman for the Leningrad Kirov Ballet Company's British agents said a dozen girl dancers have been paying regular visits to London dentists to have neglected teeth fixed at a cost of 1 pound each.

Under the National Health Service Britons—and visitors—pay only 1 pound for dental treatment with the rest of the cost being met out of government funds.

'Somerset Place' Knew Gaiety, Love And Tragedy

Pettigrew State Park is located on the shores of Lake Phelps in Washington and Tyrrell Counties, nine miles south of Creswell. In the park are parts of two old plantations, "Bonarva" and "Somerset Place," home of the Pettigrews and Collins family. The park is named for Gen. James Johnston Pettigrew, who is buried a short distance outside the park area. The lake is a well known fishing place and sportsman's paradise. Many of those who enjoy the boating and fishing on the clear waters of the wide lake hardly give a thought to the history of the cream colored house on its bank, and the gaiety, love and tragedy its empty rooms once knew. Nor to the beauty of its gardens, the wide sweep of lawns, the heavy laden branches of the orchard trees, and the swift water of the mill race—sights once seen from the now bare windows and wide porches. Nor to the sweaty slaves digging the canal, and planting and harvesting crops. Nor to the work in the woods, felling and sawing trees to be cut into boards in the mills that once stood on the canal. Nor to the grinding of corn in the grist mills, and the waters that sweep past them carrying the flatboats laden with grain and lumber to the Scuppernon River. Nor to the slaves singing in their chapel on Sunday, or to the somber sunset burial of a field hand.

estate passed to Josiah Collins II. When Josiah Collins III became of age in 1829, his father gave him the operation of the plantation.

It was under the direction of this Collins that "Somerset Place" was developed into the thriving, prosperous place it became. There were about twenty buildings and an undisclosed number of slave quarters in the community on the lake shore.

Tree lined drives, a garden of four acres, a lawn of eight acres made the estate a picturesque place noted for its beauty. Lavish living and much entertaining made it sort of the society capital of the area. In fact the pace and ways of life were often commented upon by members of the more austere Pettigrew family, who lived on their plantation, "Bonarva" nearby.

At one time 327 slaves worked on the place doing the main tasks such as large place required.

The gay, carefree life of the Collins family came to an end on that sad Thursday, Feb. 2, 1843. The swift waters of the mill race in the canal at the front of the house would take time out from its work turning the mill wheels to take the lives of eight and ten year old Hugh and Edward Collins as well as two small Negro boys. They were drowned in that part of the canal at the lower end of the garden. Or as in an account of William Pettigrew: "Edward and Hugh Collins were drowned in their father's canal on Thursday, 4 1/2 p.m., Feb 2nd, 1843. They were seen by my father's servant Jim as he carried the mail over, together with two Negro boys nearly of the same age in a boat on the canal. . . midway between the dwelling and the mill. As Jim returned the bridge on his return he perceived the heads of the boys above water."

Efforts to get them out failed and later the upper and lower gates on the canal were closed. But it was too late. "They had been drowned half an hour when they were taken from the canal."

Attempts to revive them in the big house failed also, and the sad parents with kind neighbors set about the preparations of readying them for their last journey across the sound to Edenton.

"On Saturday morning soon after daylight the coffin, containing the two brothers, was placed on my father's (Pettigrew's) barouche and bound securely with cords."

At two o'clock the procession reached Mackeys Ferry. It was placed on the steamboat for Edenton.

Death came again to the Collinses of "Somerset Place" in the late 1850's. Kent Collins was thrown from his horse on the canal drive. He struck his head against an elm tree and died instantly. The aggrieved father had a chain fastened around the tree and time slowly strangled it to death. He never fully recovered from the effect of his favorite son's death.

Then the war came and it brought an end to the kind of living that those that lived at "Somerset Place" had known. Josiah Collins died at Hillsboro in 1863. And with his death, the plantation on the lake went the way of the other plantations of the south.

Efforts by Mary Collins and two of her sons to revive the place after the war failed. The Collins ownership ended in 1870 but Mary lived there until her death in 1872.

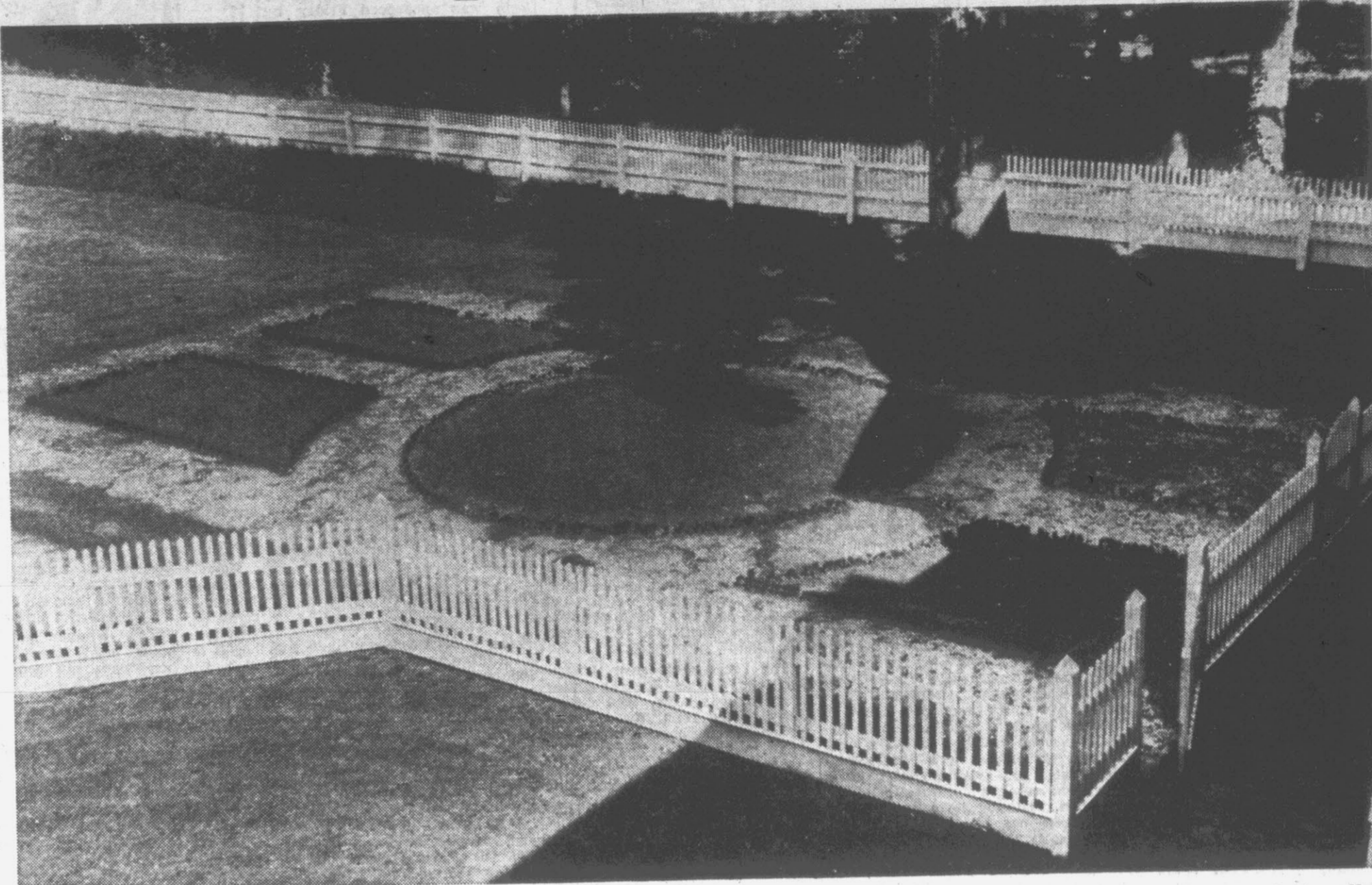
The place changed hands several times, going downhill all the time. In the 1920's it became the property of a Rocky Mount Bank. The federal government bought it, and in the 1930's the park was established.

The Park Service has done and is doing a fine job of restoring the old estate. Neat walks, a white fence around the garden area, the well kept old house and outbuildings show that much work and planning is being put into the project. Site markers, showing where different structures stood along "the street" and talks with the able and courteous Park Ranger, Mr. Tom Hampton, enable the visitor to form a better picture of "Somerset Place" and its happenings.

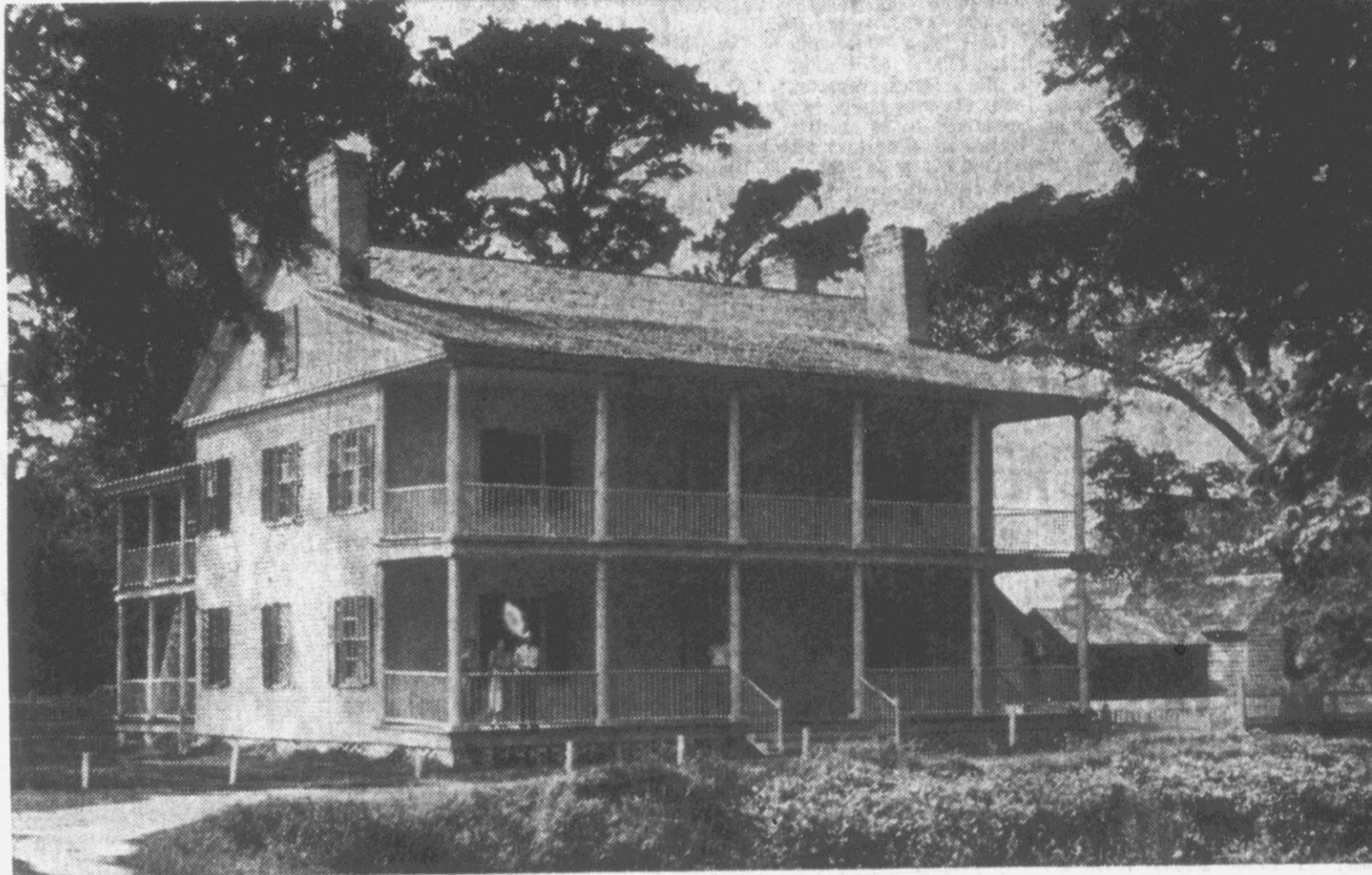
And maybe in time the visitor can step into the spacious hall of the "Mansion House" and catch a glimpse of what one writer saw in 1885.

"I shall never forget my first entrance into the stately old mansion. The wallpaper, with its pink, blue and gold floral design, hung long before the Civil War was in fairly good condition. A bright fire was burning in the fireplace. It looked cheerful and certainly was very comfortable."

But that was yesterday. The walls are bare now and the last fire in that fireplace has long been out. For "Somerset Place" does belong to the yesterdays, and if you listen closely, the wind in the cypress trees along the canal bank seems to be trying to tell you so. And the cream colored house that Josiah Collins III built over 130 years ago seems to impart that feeling that most old houses have — a feeling that it watches your every movement, like an old man sitting in the shade watches a stranger.

Supervised Playground Activity Games Are Preferred By Children

The children like to play games best.

That is, games like cards, carrom, horseshoes, checkers, reading books and coloring. Maybe softball sometimes, but mostly games.

These supervised activities take place at certain hours at the city's recreational grounds during the summer months, this year's program lasting from June 12 until July 28. Children drift in from before activities begin until things are pretty well set up.

They bring with them their bikes and dogs, and everyone pets the dogs.

You might think they would rather swing, or play on sliding boards and the chinning bars and monkey bars, but most of the children, between ages of four and 14, seem to prefer games, and especially learning

new games. They catch on fast.

Out at Third Street School playground, Annette Reynolds is the director, with something like 25 to 30 children appearing at her playground each day.

The early birds greet Annette as she drives into the yard. They escort her to the play area and jump up and down while she opens a large green container which is like Pandora's box: full of everything.

The everything includes bats, balls (for several different games), nets, checkers, cards, a carrom board, coloring books, scrapbooks, leaflets, bulletin boards and a first aid kit — among other things.

After each child settles on the first item of diversion, he takes turns. At the board games, the winner continues to play a succession of people until someone else wins. All playing is by turn.

Big and little, boy and girl, they enjoy the same games.

Jean Johnson, daughter of Mr. and Mrs. C.W. Sprouse, is one of the children who prefers to play games "best." She will tell you that Annette reads books to the children and makes pictures for them to color. "If any of use get hurt, Annette has our parents' names and phone numbers, and our doctor's name so she can call them," Jean says.

So far this summer no one has been seriously hurt. Most of the ailments are minor scratches or cuts which occur before the children reach the playground.

The recreation programs at all the city playgrounds are well planned during the summer months. Something is planned for each week, though there is time for diversion and chosen activity, and there is opportunity for a creative director to use her talents.

One of the projects this summer involved a nature study, and the children collected var-

ious leaves and insects, combining the leaves in a scrapbook. The insects were collected in bottles with holes punched in the tops, and were gathered from the playground area.

A firsthand study of termites was very much available due to the presence of the bugs in a tree on the grounds.

About the time of the fourth of July, the children learned about the liberty bell, flags and Betsy Ross. Some of the more active pastimes which occupy the children's time are volley ball and tether ball. Annette says they "love tether ball and carroms best. We don't know what we would have done without the carrom board."

Another entertaining activity has been potato sculpture. Litter bags have been another object of "study."

The playgrounds are usually inhabited by children who live in the nearby neighborhood. This summer, the Third Street Playground has proved a haven for the C.W. Sprouse children, Jean, 11; Susan, 10; Mickey, 8; Cindy, the youngest; and Judy, 13, who have just moved to Greenville and know few friends. Friends are fast made on the playgrounds, however.

The Third Street School Playground director is a graduate of East Carolina College, with a major in education. After teaching in the winter, Annette is prepared to meet the children on the playground in the summer.

And the play box is soon empty, with a playground full of children ready for games.

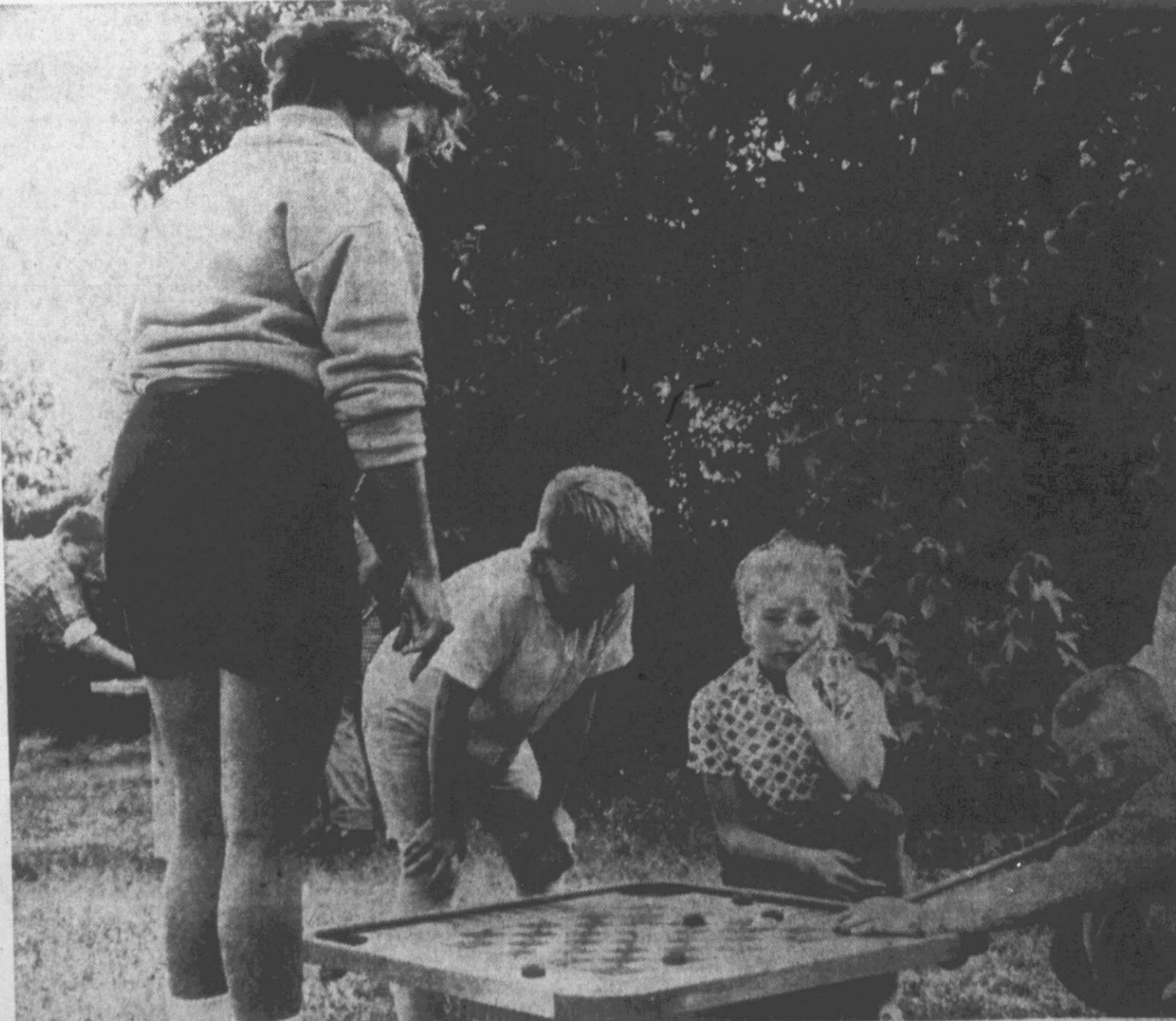
Gold For Girls In Electronics

CAROMS . . . is a favorite game of the younger set at City Recreation Commission playgrounds.

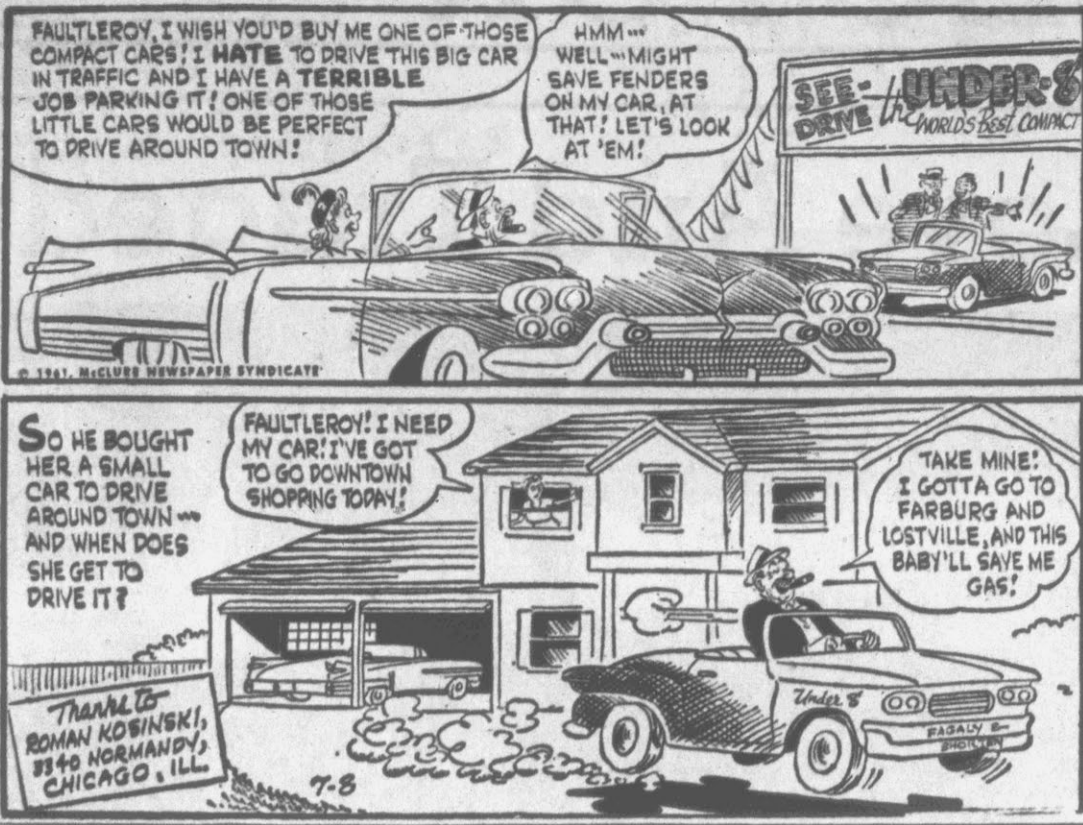


"NOW THIS IS HOW IT'S DONE" . . . says Gayle Clapp, a playground worker. (Reflector Photos by Stuart Savage)

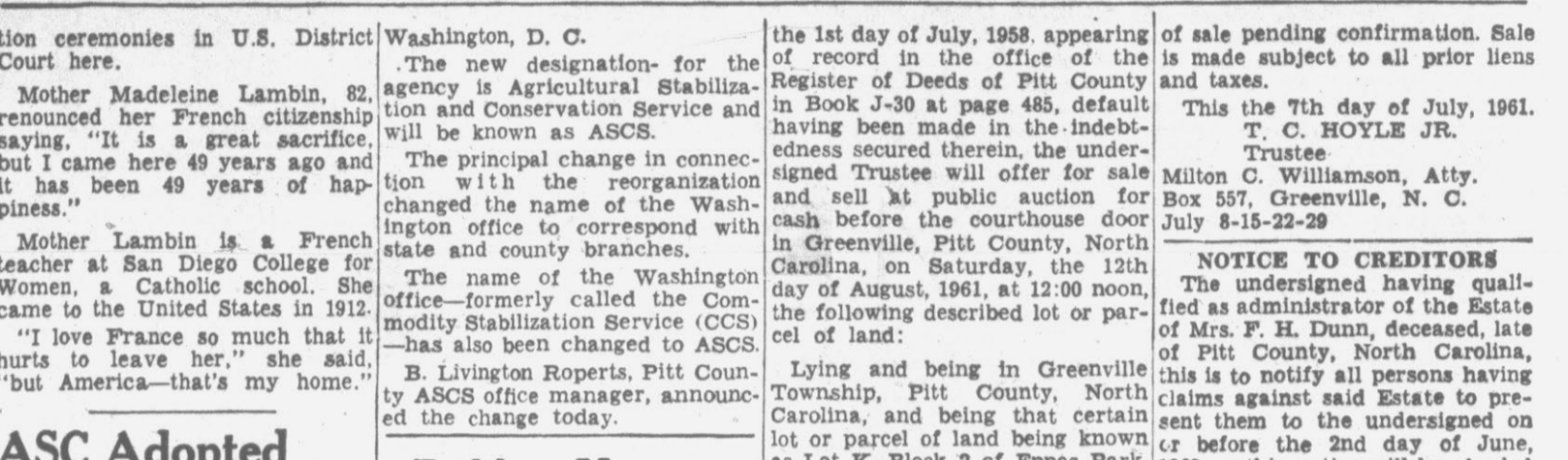

James Hoffa Re-Elected, And Advises Critics To 'Get Lost'

By NORMAN WALKER Associated Press Labor Writer MIAMI BEACH, Fla. (AP)— James R. Hoffa today advised his critics to get lost. He said he's whipped 'em and they might as well admit it.

Hoffa, 48, a one-time Detroit warehouse hand, was elected overwhelmingly Friday to a second five-year term as president of the Teamsters, the nation's largest labor union, over only token opposition.

"Seriously," Hoffa remarked later. "I think Bobby Kennedy, his brother the President, the secretary of labor, and the supposed Senate select committee ought to recognize now that the time and effort they've put in trying to destroy the Teamsters have completely failed. It was a waste of time."

Hoffa referred, of course, to President Kennedy, Atty. Gen. Robert F. Kennedy, Labor Secretary Arthur J. Goldberg, and to the Senate investigating Committee headed by Sen. John L. McClellan, D-Ark.

"From now on they ought to leave us alone," Hoffa said. "They ought to get out of our hair and let us operate as a trade union and as Americans."

Hoffa said the charges and investigations piled up against him and the Teamsters during nearly four years have been no picnic, but he said he isn't nervous about them continuing.

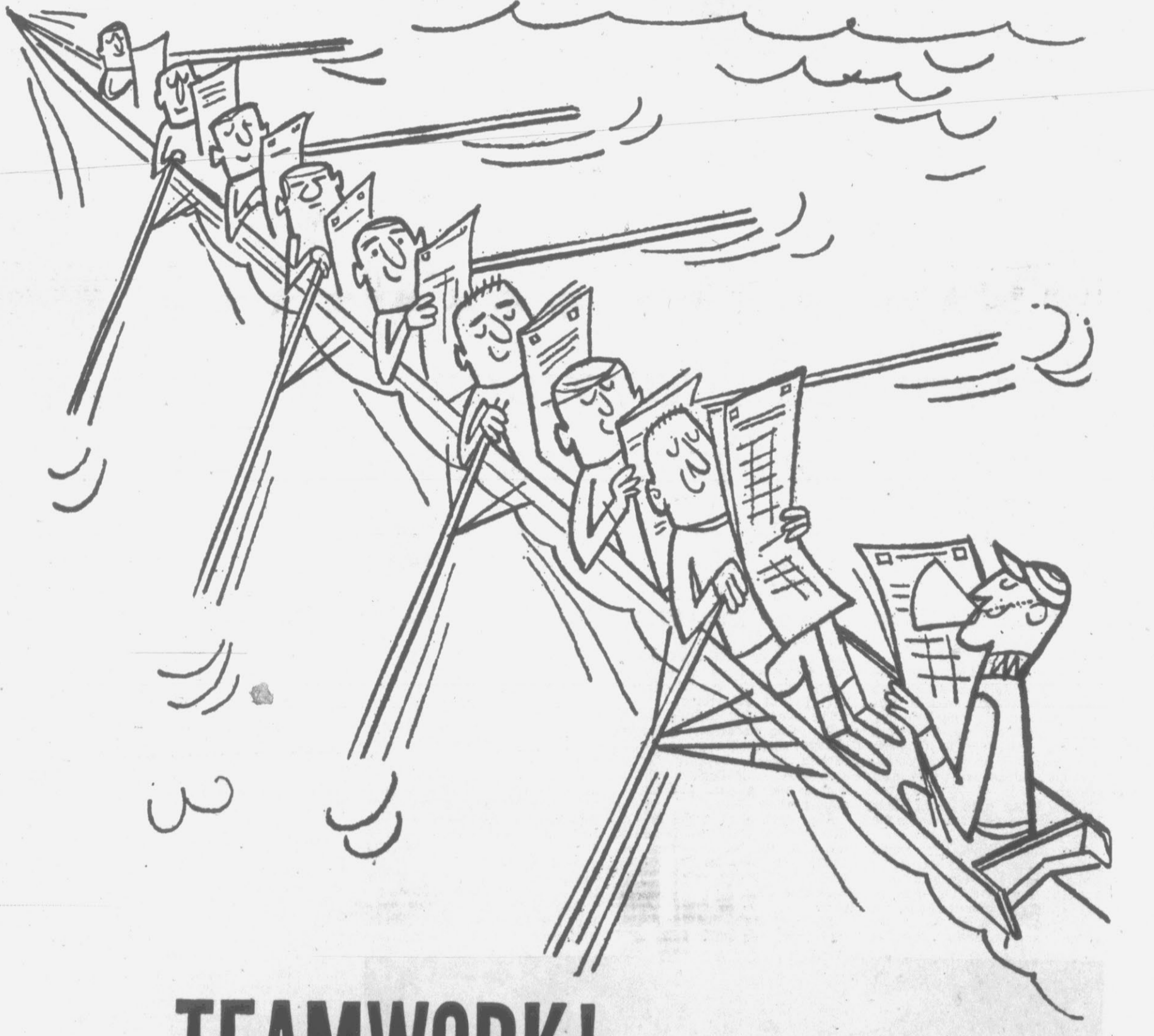

Last week we were talking about the twenty-fifth anniversary of the publication of "Gone with the Wind."

We intend to say also that as part of the observance Macmillan has come out with a handsome new edition of the work, lavishly illustrated, which sells for ten dollars.

As a come-hither device, Macmillan is offering the purchaser of this deluxe edition a 24-page illustrated booklet which will answer "countless questions that have gone with the Wind" fans have asked about the book and its famous author. That there should be this sort of interest on the part of the public is a pretty remarkable fact in itself and points to the development of a cult. What a pity that Margaret Mitchell burned the manuscript of that other novel which she considered superior to the one published.

One thing certain, in our affluent society there is no question that a ten-dollar book will sell. Witness Shirer's "Third Reich," which has broken more records than the Yankees as it pushes stoutly into its thirty-sixth week as first on the best-seller list.

National Purposes

Speaking of the affluent society reminds us of some remarks on our problem of defining our national purpose by August Heckscher in the current "American Scholar." If we follow Mr. Heckscher's argument correctly, it is that a meaningful set of goals, both for society and the individual, has become harder and harder to achieve in America as we perfect our technology and learn how to satisfy our material needs.

In this connection, Heckscher reports an interesting conversation which he had with his Russian guide at the Revolutionary Museum in Moscow last year. After seeing the mementos of the Russian Revolution, he remarked to the guide that Thomas Jefferson had suggested the desirability of a bit of revolution in each generation.

Holdup After Friendly Chat

DURHAM, N.C. (AP)—A chat-

ly, middle-aged man who made friends with a grocery store's employes Friday before robbing the place of an estimated \$3,000 was the object of police search today.

Officers said the robber, described as short and wearing a wide-brimmed straw hat and light tan raincoat, escaped in a 1953 or 1956 model Ford with a South Carolina license. The car was operated by another person, police said.

Employes said the gunman came in about a hour and a half before the robbery and began shopping. He bought about \$3 worth of groceries and explained to employes he was waiting for his wife.

The robber carried on friendly conversations with employes and even talked with the store manager, Charles Glosson, the chance of his son's getting a part-time job there. He also asked to use the pay telephone, and, unnoticed, cut the wires.
