French Army Moving To Crush Revolt By Rightists

ALGIERS (AP)—French troops took positions on the rooftops of the besieged Bab El Oued district today as the army moved to smash a revolt by French right-wingers in accordance with stern orders from President Charles de Gaulle.

Shortly before noon, French officers studying maps near command cars parked in rain-drenched streets said: "Our heavy weapons now control all streets of Bab El Oued."

Sporadic shooting broke out at several points in Bab El Oued as units of the European Secret Army Organization tried to flee encircled buildings.

Military sources said 16 French soldiers were killed and 91 wounded in the fierce five-hour street fighting Friday.

Losses among the civilian population and of secret army commandos were at least 20 killed and 80 wounded, officials said.

It was believed a handful of deserter officers who constituted the general staff of the secret army's Bab El Oued zone fled in ambulances into other parts of Algiers.

An estimated 10,000 troops backed by tanks, light and heavy armored cars and halftracks threw a cordon around Bab El

Qued. A curfew was imposed on the area while army loudspeaker trucks boomed appeals to surrender.

Rumors of preparations for a general uprising swept the city. "We have nothing to lose now. We may just as well go down fighting," one European said.

Stunned European settlers realized for the first time that the army was ready to shoot at them. Many had been confident that French troops would never fire on Frenchmen.

When French air force planes circled over Bab-el-Queid Friday strafing Secret Army Organization positions, the settlers realized the chips were down.

Authorities feared the battle might trigger a general uprising throughout Algeria's major cities by secret army men determined to risk all in a bid to attract world attention to their cause.

Officials don't believe such a revolt could succeed if the army remained loyal to De Gaulle. The settlers accuse the French

government of selling Algeria out to the Moslem nationalists. The right-wing secret army has called for all-out resistance. It has more than 30,000 modern arms and can count on the complicity of most of Algeria's one-million Europeans.

As night shrouded the city, tanks and armored cars rumbled through the streets.

Armored columns encircled Bab-el-Qued where the streets were littered with broken glass and debris of the fighting.

Steel-helmeted troops cautiously searched houses where during the day en with armbands marked with secret army insignia fired at French troops.

Shortly before midnight machine gun fire rattled in the heart of the city. An armored convoy of French gendarmes was attacked by Europeans firing from the balconies of their elegant apartments.

Molotov cocktails were hurled against armored vehicles that sprayed the houses with bullets from their heavy machine guns.

Air Service Meeting On Tuesday

Next step in the long air service fight for Wilson-Greenville?

This will be thrashed out in a meeting of the Pitt-Greenville Airport Commission Tuesday night.

Wilson-Greenville Counsel W.W. Speight revealed this morning that the Airport Commission meeting had been called by Chairman Vance Perkins.

It comes in the wake of a CAB decision Tuesday which denied service to Wilson-Greenville, but granted additional stops in Kinston and Rocky Mount. It also granted service to Goldsboro.

"We're having a meeting of the Pitt-Greenville Airport Authority Tuesday night to consider the decision and decide whether or not we actually can take any action," Speight said.

The Tuesday meeting will not be a joint meeting with Wilson representatives.

However, Speight asserted, "If any action is decided upon, Wilson will be contacted and our efforts will be joint, I'm sure."

Members of the Pitt-Greenville Airport Commission are W. T. Kizer, B. Alton Gardner, F. O. McGowan, Dr. Ralph Brimley in addition to Perkins as chairman.

Also attending the meeting along with Speight will be his associate attorney W. H. Watson.

Meanwhile officials announced that the Rowan County Airport Board would file a petition with the CAB asking reconsideration of a CAB decision to deny Piedmont Airlines service to Rowan County in which Salisbury is located.

Their application was turned down at the same time as Wilson-Greenville's.

James L. Highsmith, attorney for the Rowan County Board, said he would take advantage of a 20-day period following the CAB ruling to file the petition.

Rocky Mount is expected to extend the Olive branch to Wilson by renewing its proposal that the two cities go together in constructing a joint airport.

Rocky Mount presently has options on land at Sharpsburg between Rocky Mount and Wilson.

With funds already approved and FAA steps thought to be approved, Rocky Mount will have a convincing argument with which to approach Wilson.

It is not likely that Greenville and Kinston would construct an airport between these two cities. Kinston has plans for improving the old Stallings Air Base runways. Stallings, once operated as an air force pilot training center, is located on the northwest side of Kinston.

South Korea's President Quits

SEOUL, South Korea, (AP)—South Korea's military strongman, Gen. Chung Hee Park, 44, took over the presidency today from Yun Po-sun who resigned as the nation's last constitutionally elected official.

The ruling 28-man Supreme Council, unanimously accepted Yun's resignation in a closed-door meeting and later appointed Park acting president until elections in the summer of 1963.

Swift Pursuit Wrecked Bid To Patrol School

The hour was late, at least for some people but not the Patrol. The silver and black interceptor clipped along smoothly at 55 miles per hour headed for Greenville and home.

About three miles east on U. S. 264 the patrol vehicle met a string of six cars. The leading two were outstanding. They were speeding.

Patrolman W.L. Whitehead rounded the curve, then spun the sleek vehicle around in a drive-way. He would pursue the speedster, try to stop them before they became killers.

The silver and black car roared to life. Quickly it overtook the last two cars in the line, then a third vehicle. The fourth car turned into the Simpson road just before the interceptor sped around the curve.

The speedsters were out of

sight. The still night air was broken by the roar of the patrol car, the darkened community. They were still moving. The patrol vehicle was still moving too. It was gaining now as the law breakers slowed a little for Grimesland.

East of Grimesland the chase became hotter. The three cars rolling on.

"Five-eighty-nine to any Beaufort County car!" No answer. Again the same query and the same dead silent reply.

"Five-eighty-nine to Williams-

ton." In pursuit of two vehicles headed East on 264 East of Grimesland, traveling 90 miles per hour now and don't seem to be gaining on them, have any Beaufort County Car and Chocowinity police stand by to assist in stopping same."

Then . . . The pursued car swerved into the left-hand lane. The highway had become almost obscure with smoke.

"Five-eighty-nine to Williams-

ton. . . 10-3 (cancel or disregard last information on that traffic) . . . one of the cars just blew up and the other is slowing down . . . stopping him now."

"How will this affect my application for the Patrol? . . . I've applied for Patrol school."

Trooper Whitehead shook his head. "You might as well forget it. . . you've had it."

The boy looked worried. "I joined the National Guard and have served six months. . . have a military police MOS so I could get on the patrol."

"You should have thought of that before you pulled this stunt. . . If you were wearing this uniform and I were in your shoes what would you do now?"

"I'd do the right thing, I guess."

The trooper did the "right" thing.

President Set Own Rules In Calling On Eisenhower

PALM SPRINGS, Calif. (AP)—President Kennedy made his own rules of protocol today and scheduled a short journey from his weekend desert retreat to call on former President Dwight D. Eisenhower.

Kennedy, who wound up the formal part of his California visit Friday with a firm expression of confidence in the future of freedom and a personal look at an Atlas rocket firing, planned to see his predecessor on what was labeled a courtesy call.

The President is staying at the desert home of singer Bing Crosby, about 20 miles from the Southern California resort. Eisenhower is a few miles from him, in a cottage at the Eldorado Country Club.

Kennedy was understood to feel he should call on Eisenhower, rather than vice versa, since he is a transient in these parts and Eisenhower has made it his winter residence.

The President demonstrated his support of some of the headiest nuclear research conducted in this country when he visited the Lawrence Radiation Laboratory at the University of California.

He stopped there before addressing a record crowd at Charter Day ceremonies in the football stadium on the university's Berkeley campus. An estimated 88,000 filled the stadium seats and spread over the field—the biggest attendance yet for an on-the-spot Kennedy speech audience, and tops for the stadium, where many a big game has been played.

The possibility of cooperation with the Soviets in outer space is encouraging, Kennedy told the throng—which gave him roaring, whistling ovations.

Knowledge is the passkey to the future, he said, with learning as an eternal goal. He declared, "No one can doubt that cooperation in the pursuit of knowledge must lead to freedom of the mind and of the soul."

Americans can take new confidence in the direction history is

moving the world, Kennedy said. And he charted the direction in these words: "No one who examines the modern world can doubt that the great currents of history are carrying the world away from the monolithic idea toward the pluralist idea—away from communism and toward national independence and freedom."

Americans also must shun the idea that their country's mission "is to remake the world in the American image," he said. His point was that U.S. policies should aim at helping newly developing nations travel the road to "genuine national independence."

"Diversity and independence, far from being opposed to the American conception of the world order, represent the very essence of our view of the future of the

world," Kennedy said. From Berkeley, the President flew to Vandenberg Air Force Base, which identifies itself as "the free world's military missile center." From a bluff 1,000 yards from the launching site, he became the first chief executive to witness the firing of an intercontinental ballistic missile.

An Atlas D rocket, the kind that boosted astronaut John H. Glenn Jr. into space, sizzled flame and thundered off its pad in a high arc over the Pacific. Gen. Thomas S. Power, commander of the Strategic Air Command, reported to Kennedy after a tour of other missile complexes on the base that the Atlas missed its bullseye off Eniwetok by only eight-tenths of a mile. The flight of about 5,000 miles lasted only 26 minutes.

Peiping Attacks Aid To Viet Nam

TOKYO (AP)—Red China charged today that stepped up American military aid to South Viet Nam was a grave threat to peace in Southeast Asia and warned "no peace-loving country can remain indifferent."

Peiping's latest attack accused the United States of turning South Viet Nam into a living hell by "slaughtering patriots fighting for independence and freedom."

"The U.S. Air Force has taken a direct part in the war against the people of that region, and the United States has increased preparations for aggression in South Viet Nam and other regions of Southeast Asia," the broadcast declared.

U.S. Army helicopters with American crews have shuttled South Vietnamese troops into battle zones and U.S. pilots have accompanied South Vietnamese planes on strafing and bombing missions. U.S. officials insist, however, the American troops are non-combatants.

Communist China "will struggle to the end to check U.S. armed aggression in South Viet Nam," declared the New China News Agency in a broadcast devoted to an editorial in the People's Daily Observer of Peiping.

It was the second time in a month that Red China sharply assailed U.S. efforts to bolster the South Viet Nam government's fight against the Communist Viet Cong guerrillas. Peiping declared on Feb. 24 that U.S. aid to Presi-

dent Ngo Dinh Diem's pro-Western regime seriously affected the security of Red China and Communist North Viet Nam.

More than 4,000 U.S. troops have been sent to South Viet Nam to train and support Diem's forces. Sources in Saigon, the capital of South Viet Nam, have said the U.S. contingent soon would number 7,000 men.

"The United States can give no excuse to justify its crimes of aggression," Peiping declared.

"Washington vainly hopes to subjugate the Vietnamese in order to intimidate other peoples in Asia, Africa and Latin America. No peace-loving country can remain indifferent to this new grave situation."

Shell Explosion Wounds 2 GIs

FT. BRAGG (AP)—Two soldiers were wounded Friday when an artillery shell fired from a 155 millimeter howitzer exploded prematurely.

The accident occurred during a routine training exercise.

The Army said Cpl. Albert R. Binickel was admitted to a hospital with wounds of the back and arm. He was reported in good condition. Pfc. Robert K. Sargent was treated for shock and minor injuries and released. Both men are from Claremont, N.H.

Girl Scout Council Says Camp Hardee Won't Open

GOLDSBORO — The Girl Scout Council of Coastal Carolina announced today that it will not be able to operate Camp Hardee this summer as planned.

The Board of Directors made the decision this week based upon a report presented to them by J. W. Hanna and R. L. Mohler, specialists with the Soil Conservation Service of the United States Department of Agriculture. The council has been consulting with the service since last summer in regard to the serious soil erosion problem at the site located on the Pamlico River below Washington, North Carolina.

In his report, Hanna presented the problems involved when construction of an erosive condition is undertaken involving an embankment of over 10 feet. The problem at Camp Hardee involves a vertical embankment of some twenty feet which extends more than one-third of its boundaries.

Hanna presented to the board a thorough study including recommendations and a cost estimate.

BERLIN (AP)—Maria Beale Fletcher, Miss America of 1962, arrived in Berlin today for a three day visit with American troops.

Miss Fletcher, from Asheville, N.C., arrived by commercial plane from Frankfurt, along the southernmost of the three air corridors to Berlin.

While her plane was in the air, informed sources said, Soviet military planes were making two flights in the north corridor, which connects Berlin and Hamburg.

Congressional Reaction Awaited

Fate of the administration's new farm program appears to hinge on Congressional reaction to accepting or rejecting price supports and production controls as a package deal.

The administration, in our opinion, has taken a realistic approach to the basic problem which has faced American agriculture for the past 15 years: the problem of tremendous production and artificially high prices.

Under the proposed legislation, producers of individual categories of commodities would have the choices of government support prices along with government-regulated production controls, or no controls and no support prices.

To a great degree in recent years, the government has offered subsidies to many farm commodities without any controls on production. This has resulted in gigantic surpluses which have been costly, not only in initial pay-out to farmers, but likewise in storage fees. It has, we think, proved an unrealistic approach to the economic problems of agriculture. Certainly it has placed the government

in an unrealistic position in its attempt to help agriculture maintain its relative place in the economy of the nation.

What the administration is now proposing is a plan for most commodities similar to that which has worked so well for tobacco for more than two decades. Tobacco farmers have received guaranteed basic prices for their production, but in return they have abided by production quotas set by the Department of Agriculture. The program has been of tremendous benefit to tobacco farmers, and at the same time it has not cost the government a great deal of money. The cost has been negligible compared to the amount spent on other farm commodities operated under different programs.

Obviously there must be some control on production of farm commodities, either in the market place or by government regulation. For some commodities in recent years, neither of these has been brought to bear and the result has been a constant build-up of costly surpluses.

The program for agriculture presented by the administration has sufficient merit to warrant support by members of Congress.

Returning Home Is Best Part

HOME AGAIN—Getting back into daily routine after an absence of two weeks during which the isolation from North Carolina news was almost complete, is both difficult and pleasant. Some wise man has said that the best part of any trip is coming home.

This was our first time to cross the border into another country where the Stars and Stripes do not fly with authority. Differences in practices and living conditions were obvious immediately after going into Mexico, but there was not the sensation some travelers have said they felt of being in an alien land. That probably was because our daughter met us at Brownsville and was constantly with us for more than a thousand miles of driving and served as a guide in many of the historic places visited.

From time to time we will give you stories about the things we did and saw, and impressions gathered of customs and conditions. One thing was particularly noticeable, that while the contrast between the fabulously rich and the very poor is striking, the gap is narrowing. The ratio of literacy and of gainfully employed among the poorer classes is rising rapidly. It is the determined policy of the Mexican national government that every child shall be able to read and write and do simple sums by age twelve.

Approximately 40 percent of the Mexican Federal budget goes for education. The other 60 percent goes for national defense, public improvements—roads and utilities, and all other functions of government. That is about the ratio for education spent by North Carolina, but far more than spent by the United States government.

For the present we will get back on the job reporting North Carolina news.

CANDIDATES—Fewer contests developed by the close of filing time for participation in the primary than had been expected. Although a United States Senator, two Supreme Court Justices, and a whole flock of Superior Court judges and solicitors are to be elected this year, there will not be a single statewide contest among Democrats. Republicans will have to choose between two candidates for the United States Senate—the first time since the primary was instituted as the official method of nomination that Republicans have had it all to themselves.

There will be primary contests for many district offices—Congress and solicitor, and by time the books close for legislative, county and township filings on April 13 it is expected that there will be a contest in every county.

Republican Chairman William E. Cobb has served notice on the several county boards of

election that if there is no local Democratic primary race in any county, he will demand that all precinct election officials be named from the Republican party. Chances are slim that more than half a dozen counties will be affected, and it is doubted the rearranged organization will be changed in them. At any rate, the recommendation for precinct officials must come from the county chairman of the party not from the state chairman. And not less than three nor more than five names shall be submitted for consideration by the county board. There's another little hitch. The statute requires that recommendations for precinct officials must be made to the county board on or before the seventh Saturday before the election, but candidates may file any time before noon of the sixth Saturday before the election. For these reasons there appears little prospect of all Republican officials in any county.

STATE BOARD—The election laws give to the chairman of each political party the right to nominate members of the various county board of elections which are appointed by the State board. The laws also allow county party chairmen to nominate precinct officials appointed by the county boards. But appointment of the State Board of Elections is the sole prerogative of the Governor, and he is limited only by the restriction that not more than three of the five members shall come from the same political party. Because there are only two recognized parties in North Carolina, and Democratic Governors have been in office since the election laws were written, that means three Democrats and two Republicans on the State board. There is no requirement for the Governor to seek or honor or respect advice as to these appointments, as is the case with county and precinct appointments.

Governor Sanford made it quite clear this week that he would not consult Cobb or any other Republican—but would grant them audience if they requested a conference, without any implied obligation to accept their suggestions. He added with emphasis that he would make no deals in advance and he manifested resentment at the officiousness of Cobb and Judd in intimating they could select the board member.

Highway Promoters Can Benefit The Area

Organization of a U.S. Highway 13 Association is a move which could mean important benefits to Greenville and other cities and towns along the route of this relatively new North-South highway.

In past years other organizations of this type have proved extremely effective in promoting specific highway routes throughout the country. To a large extent much of the traffic which plies many of the major highway routes can be attributed to promotional efforts of communities located all along those highways.

Individually such communities are limited in what they can do to promote the popularity of a particular route with the motoring public. Collectively, however, these communities can accomplish a variety of things. Not the least of these are combined efforts to sell the public on the idea of using a particular route because of certain advantages it offers over other routes. Collective efforts are also much more effective in bringing about needed improvements along the highway route in order to make it more attractive to motorists.

U.S. Highway 13 will become an increasingly important North-South traffic artery in future years, and concerted efforts of communities along the route through an associated can play a major role in promoting both the use and improvement of the highway route.

Principles For GOP Solons

WASHINGTON (AP)—The Republicans in Congress are still trying to figure out where they stand and for what. They're working on a set of principles.

These are to be ready some time in June for use in this year's congressional elections, a field in which they haven't been having much luck.

They've won control of Congress only twice in the 15 elections since 1932. Their national chairman, William E. Miller, tried to pep them up by predicting victory and telling them not to be defeatist.

But, as Sen. Barry Goldwater of Arizona remarked, getting Republicans to agree on a catalog of principles won't be easy.

Then Goldwater, the highly conservative Republican who seems to be making more speeches than anyone else in his party, uttered a thought which, if it came to pass, might spread more confusion than cohesion.

"What I would like to see," he said, "would be a statement of basic principles from which individual members can go where they want."

The congressional Republicans created a 12-man committee of themselves to recommend the principles. Before the 12 do that, they'll have to agree on the principles.

Then they hope they'll get agreement from the Republican National Committee and approval from all the Republicans in Congress. Meanwhile, they are asking for recommendations from Republicans all over the country.

Their list of almost 400 people includes former President Dwight D. Eisenhower, former Vice President Richard M. Nixon, New York's Gov. Nelson A. Rockefeller and all the Republican governors.

And, for a very simple reason, this should be quite a list of recommendations:

The Republicans, like the Democrats, talk of themselves as a single political party, a condition odd enough to frenzy a non-American trying to understand how a party can call itself a party when the conservatives in both parties join forces to defeat the liberals in both parties, and vice versa.

which is what they do.

If anyone doubts it, he will have to contend with Goldwater whose idea of Republican principles is not likely to be a duplicate of Rockefeller's.

Goldwater recently told Republicans: "If it is fair to claim that the Democratic party is schizoid, torn by internal dissensions, struggling to find a middle way between the extremes of Hubert Humphrey and Harry Byrd, it is also fair to say the Republican party has failed to present to this nation a solid political organization unequivocally committed to an easily definable political philosophy."

It might also be fair to suggest Goldwater's appraisal be shortened to say: The Republicans are all mixed up.

If they sometimes seem to have an almost mystical unity in criticizing President Kennedy's programs, it doesn't by any means exhaust either their acidity or their critical enthusiasms.

Some of them haven't been too happy with themselves, as they demonstrated notably at their Lincoln Day dinners when:

Sen. Margaret Chase Smith of Maine suggested the party's presidential candidates showing faint-heartedness about running against President Kennedy in 1964.

Sen. Jacob K. Javits of New York scolded Republicans for "paying too much attention to the thunder of the right and not enough to the thunder on the cities."

And Sen. Hiram L. Fong of Hawaii said it's about time Republicans asked themselves whether they have lost touch with millions who no longer regard Republicans as their champions.

In view of all the views that would have to be reconciled to get agreement on a set of principles, the product may not be what politicians like to call a ringing decalogue. Javits said he hopes it won't be fuzzy.

Robbed Of Their Charm

NEW YORK (AP)—Would you like a job that enabled you to spend part of your working time with some of the world's most glamorous women—and paid you money for doing it?

Dining—and sometimes winging—with celebrated beauties is one of the fringe benefits of writing a daily newspaper column.

Imagine getting paid for listening to all those gorgeous dames. It's the envious remark a columnist hears most often from other men.

"I'd be glad to do it for nothing. Tell me, what are they

really like?"

Well, in the last 18 years I have met dozens of the most famous feminine stars of stage and screen—just about all except Brigitte Bardot, Elizabeth Taylor and Lasseie. They range from Natalie Wood and Joanne Woodward to Mae West and the late Ethel Barrymore.

And what were they like? Frankly most of these lady celebrities were just like ordinary women—except more so. The feeling I have most often after leaving them is one of pity for their husbands—and relief that I am not married

to them.

The merciless demands of stardom robs many of them of the softer charms of femininity. The struggle to stay on top turns them into monumental egotists, and their egos must be constantly fed with praise and lip-service admiration or they turn into raging tigresses.

Their beauty often has a surface, varnished quality that says, "Fragile—don't touch." There is also a cold and brittle air about their good looks as if they had been chipped out of ice. This repels rather than attracts, and leaves a man with a feeling of uneasiness.

Beneath this chill exterior you sometimes sense in them a strange and hidden loneliness, as if somehow along the way in their fierce struggle for the power, fame and money of stardom they had lost the capacity for simple human joy you can see shining in the face of a housewife content with her man.

Other Editors Saying A Transatlantic Call

(Richmond News Leader)

When Juan Peron put the telephone back on its cradle Sunday night, he had a right to be pleased. Listening in his Spanish refuge, the exiled dictator of Argentina heard the voice on the transatlantic wire tell him that the hand-picked Peronista candidates had won a landslide victory. There was talk of returning him from exile, and placing him in power once more.

A few hours later Arturo Frondizi, the first freely-elected president in Argentina's bleak history of dictatorship, declared a state of military emergency which would prevent the Peronistas from taking office. Frondizi's six-year term will be up in two years; he will not be eligible to seek reelection. He hopes to maintain some semblance of democratic processes until that time, but the wedge of autocratic tradition, driven alternately by Peronistas and Communists, will not have it so.

Ironically, it was the same combine that brought Frondizi to the presidency. Peron was exiled in 1955. As minister of labor in 1946 Peron won the support of the working classes with his pro-labor legislation, and soon ran successfully for President. A new constitution assured his perpetual reelection and hurried nationalization of utilities and industry. Under the pressures of inefficient nationalization and fantastic graft, the economy wavered precariously.

In 1953 government-engineered riots in Buenos Aires burned and looted the headquarters of every political party except the Communists. The free press was extinguished. Per-

on's leftward swing became so pronouncedly anti-Catholic in a Catholic country that he became the first non-Communist head of state to be excommunicated by the Vatican. Finally, in September of 1955 a military junta seized the government.

The first junta lasted but seven weeks, and still believed in Peron's social policies, if not in his personality. A second junta took power and spent two years restoring liberty under the old constitution and preparing for the general elections.

Peron began immediately to exert his enormous influence from exile. He directed his followers to vote for Frondizi, a directive joined by the Communists. Frondizi received 1.1 million votes. But when Frondizi failed to respond to the Peronista commands despite a series of nationwide strikes, Peron must turn in unmarked ballots for the congressional elections in 1960. Voting is compulsory in Argentina. Frondizi's party received 500,000 votes; 861,000 ballots were unmarked.

The growing Peronista-Communist strength explains Frondizi's hemming and having over the expulsion of Cuba from the Organization of American States at Punte del Este. The winner of the governor's race in populous Buenos Aires Province was Andre Framani, a labor leader who had never run for office, and who had campaigned on a hands-off-on-Cuba policy. The chief attack was that Frondizi had sold out to the Alliance for Progress.

With such vast power over the masses of Argentina, Peron needn't pick up his telephone immediately. There will be another day, and another call.

Many of these legendary beauties haven't had the time to develop other aspects of their nature. Their conversation is about as inspiring as that of a department store mannequin. Their chief subject: Themselves.

If you talk about anything else, you can see the interest dying in their eyes. They don't want even to talk about another lady star—unless her last film was a box-office dud.

In discussing their activities and attitudes, they lie like Bar on Munchausen. They parrot, generally, only what is popular or fashionable at the moment. The last thing on earth they want you to know is what they are really like—or how they really feel.

Seldom will one give you a frank answer, such as: "Do I like to cook? Listen, palsy, I couldn't even commit suicide in the kitchen—I wouldn't know how to turn on the gas."

Cadoc's Song Of Hate

For many years, I have attended the annual dinner of the Friendly Sons of St. Patrick, the principal Irish event of New York City. Usually, I go with Jim Farley, who still signs his name with green ink. The Society is 178 years old which takes it back to shortly after the American Revolution. The occasion is famous for old-time oratory—the kind for which the Irish are particularly famous—although there are few these days of the quality of Bourke Cockran or Joe Scott who could make any audience weep over his poor Irish mother.

The Irish believe that they are difficult to understand which always strikes one who has not a drop of Irish blood in his veins as an Irish paradox of which George Bernard Shaw would be gully, for every Irishman wears his loves and his sorrows on his sleeve. The fact is that the Irish find it easy to be political and be it remembered that the Chief Rabbi of Israel, Dr. Herzog, when he lived, was an Irishman, and his characteristic of the new whose brogue was the real thing as Mike Quill's is not. And while the Mayor of Dublin is a Jew, it is amazing how these two races of man manage to be such political partners in the amazing metropolises of this wonderful country.

It is often forgotten that the fathers of Irish freedom, Charles Parnell and Douglas Hyde, were Protestants, but the Irish prefer not to discuss such minor issues. As Senator Eugene McCarthy of Minnesota, in a brilliant oration that carried with it the perfume of the peat bog, said: "An Irishman has five great loves: love of country, of religion, of learning, of political freedom, of poetry and song."

Senator Eugene McCarthy is a Democrat of the liberal persuasion, unlike the other McCarthy, who was a Republican of conservative persuasion. But both, each in his way, could fit these categories of affection. Joe is dead but surely not forgotten by friends or foe, of whom there were and are many of both kinds; but Eugene is among us, and is characteristic of the new kind of Senator, the scholar who comes into our national legislature out of teaching in school and college. There is Mike Mansfield and Walter Judd; there is J. William Fulbright who was a college president and a Rhodes Scholar and Paul Douglas who was a professional economist. Eugene McCarthy was a school-teacher, and his oratory is polished, his scholarship delightful, his wit biting. In his Friendly Sons' speech, he quoted Cadoc the Wise (first century) an ancient Celtic monk's "Song of Hate":

"I hate the judge who loves money, and the scribe who loves war, and chiefs who do not guard their subjects, and nations without vigor."

"I hate houses without dwellers, lands untilled, fields that bear no harvest."

"Landless clans, the agents of terror, the oppressors of truth."

"I hate him who respects not father or mother, those who make strife among friends."

"A country in anarchy, lost learning, and uncertain boundaries."

"I hate journeys without safety, families without virtue, lawsuits without reason."

"Ambushes and treasons, faults in counsel and justice unhonored."

"I hate a man without a trade, a laborer without freedom, a society without teachers, a false witness before a judge, the undeserving exalted to high position."

"Fables in place of teaching, knowledge without inspiration."

"Sermons without eloquence, and a man without a conscience."

"The centuries pass but wisdom is eternal and Cadoc's words fit this day as perhaps never before, and it takes a bit of courage, even for a Minnesota Irishman, to speak out in these days when materialism stalks our land and when men talk only of the standard of living not the standards of life—and what a difference there is

Lookaheads On Business Front

Whether giants in the frozen foods and canning industry are unfairly crushing small, specialized companies will soon be subject of a Federal Trade Commission report. It may be followed by complaints against some of the giants accused of smothering competition.

And here are more look-aheads in business:

Jobs for youths: While Congress will rough up President Kennedy's program for employment aid for youths, his proposal to give on-the-job training probably will be enacted. But plans to put others to work in governmental enterprises or sending them to camps will probably be voted down because they seem so much like WPA and CCC programs. Even Kennedy's staunchest supporters don't want the Kennedy boom confused with the recession.

EVEN JUNK GOES

Boom in antiques: As predicted here, Jacqueline Kennedy's interest in historical furnishings for the White House is

increasing the sale of Early American furniture. Now the boom is spreading to take in rural heirlooms, antiques and almost-antiques. Some small antique shops are already scant of stock and having difficulty in replenishing it.

Imaginary set-back: March retail figures will, on the surface, look as if there was a sales slump. But it will all be imaginary. Easter was on April 2 last year and will be on April 22 this year. So March sales will be down, but will more than be made up for in April.

Do-it-yourself growing: The home-improvement part of this market will pull it ahead. More homeowners, confronted with rising costs of repairs and improvements, will try to do more themselves. Advertising campaigns to sell tools and materials will reach a peak between now and July.

Fresh tie-in surge: A new package deal about to be offered shoppers, will stir up competitors and imitators. A line

of detergents will offer \$5-off deals; purchase of a package will allow the buyer \$1 off a brand-name dress, \$3 off a famous kind of slacks, and \$1 off a \$5 famous-brand shirt. This, of course, is a variation of the familiar deal whereby the purchaser of a package of breakfast food is invited to send \$1 for some article said to be worth \$2. But the detergent promotion will be done with so much imagination and advertising that it will produce a minor trend.

Modest metal price rise: There is not yet any legal authority to liquidate any part of the national stockpile. Nevertheless, the huge amounts that are being turned over to the effect on nonferrous metal prices. Consumption of many metals is rising or is expected to rise, but prices are slow in following.

Lumber prices to go up: Lumber prices, softened by a tough winter that cut building, are firming and will go higher as building rises. In addition to the

normal spring rise, there will be another one, prompted by government aid to construction.

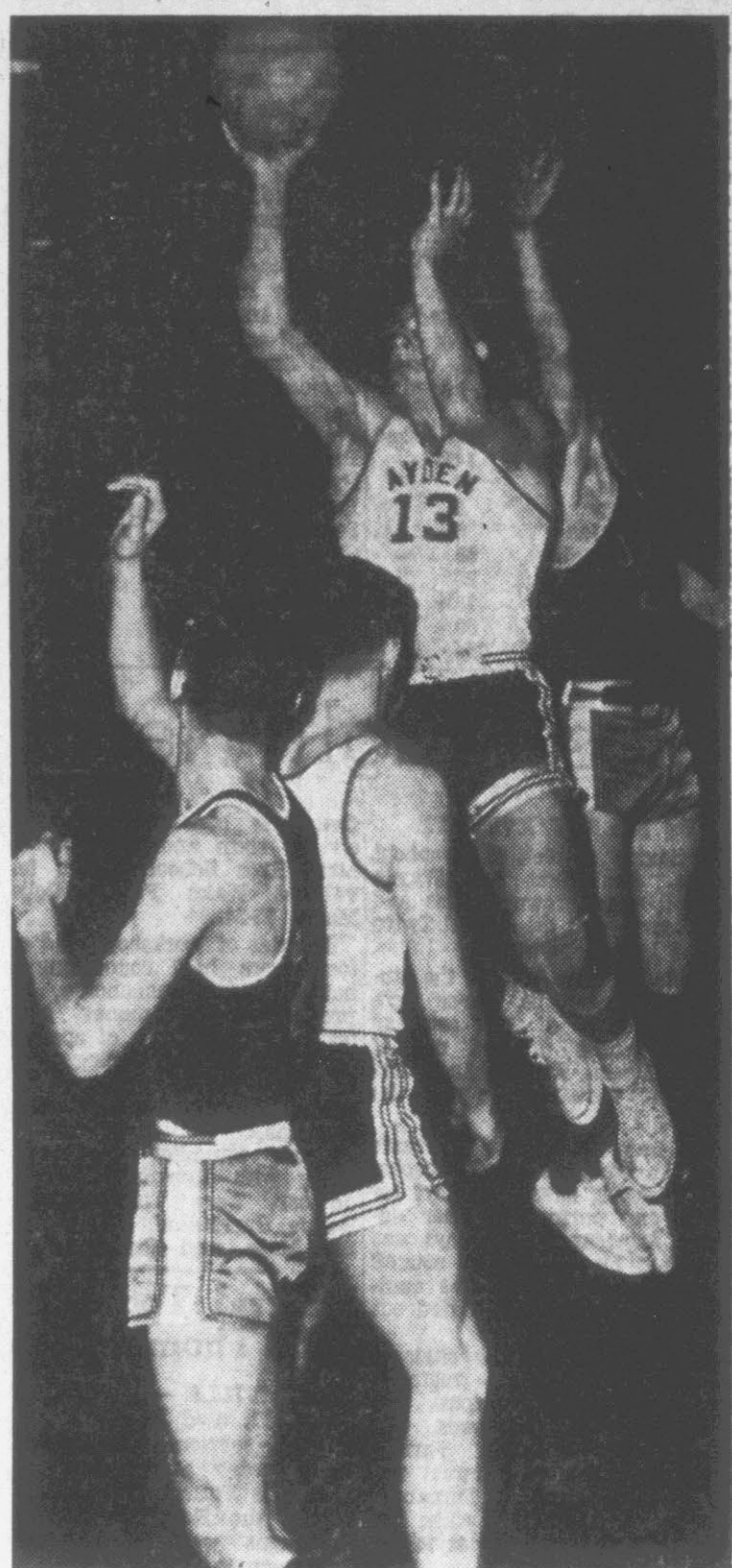

Ohio State Crushes Wake Forest; Facing Cincinnati

LOUISVILLE, Ky. (AP)—Cincinnati Coach Ed Jucker is confident his Bearcats can beat Ohio State—with or without the Buckeye's Jerry Lucas—in tonight's semifinals of the National Collegiate Basketball championships.

Lucas, a three-time All American, injured his troublesome left knee in the Bucks' 84-68 romp over Wake Forest in Friday night's semifinals but still is expected to start against Cincinnati.

Cincinnati earned its berth opposite the top-ranked Buckeyes with a 72-70 heart-throbbing triumph over UCLA on Tom Thacker's jump shot with just four seconds to play in the other semifinal match.

The championship game is scheduled for 9 p.m. EST, with the contest for third place between Wake Forest and UCLA to begin at 7 p.m.

It marks the first time in history the same two teams have met in consecutive years in the finals. Last year Cincinnati upset Ohio State 70-65 in an overtime for the championship.

Agree To Sell Cincinnati Reds

CINCINNATI (AP)—Only formalities remain before William O. DeWitt owns the Cincinnati Reds.

In a joint statement Friday DeWitt and the Crosley Foundation, holder of 90 per cent of the stock of the baseball club, announced

DeWitt had offered \$4,625,000 for the club and the foundation had agreed to sell. Pending are approval at a stockholders' meeting April 5 and approval from the other nine National League teams.

DeWitt said he would be president and sole stockholder. He admitted he had partners but declined to identify them, saying only that all money involved was "local."

The 58-year-old baseball executive repeated that he would not move the Reds from Cincinnati, birthplace of professional baseball.

The Crosley Foundation was set up by the will of Povel Crosley Jr., long-time owner of the Reds, who died a year ago.

DeWitt took over as general manager of the Reds in December 1960 and became president last December.

Former Welter Champ, Virgil Akins, Is Finished

ST. LOUIS (AP)—Virgil Akins of St. Louis—the former world welterweight boxing champion—is temporarily blind in the left eye, and permanently finished as a fighter.

Dr. Jack Hartstein said Akins is suffering from a detached retina and awaiting surgery scheduled for today at McMillan Hospital. The doctor said the operation probably will restore sight, but Akins will not be permitted to fight again.

His manager, Eddie Yawitz, said the fighter complained about his eye several days ago. He last fought Tuesday in Houston where he was beaten by Rip Randall.

An examination by the Texas Athletic Commission disclosed no injury.

Akins won the world title by knocking out Vince Martinez in St. Louis June 6, 1958, and lost the title to Don Jordan in Los Angeles six months later.

The audience seldom sees what goes on before a show goes on stage for the night's performance. They may never give a thought to the hours of preparation and the toil which go into a production.

This will probably be the case with the major portion of viewers expected to attend productions of "Guys & Dolls", a musical fable of Broadway which will run each night next week on the East Carolina College campus.

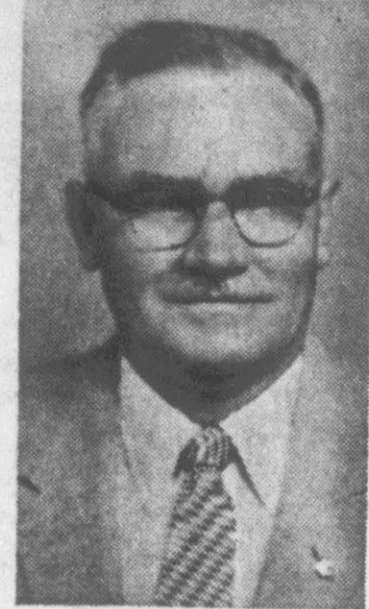

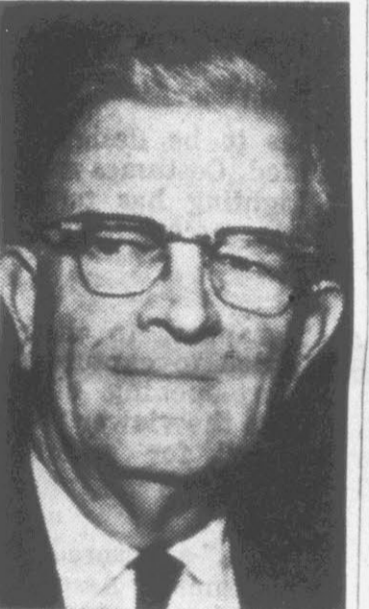

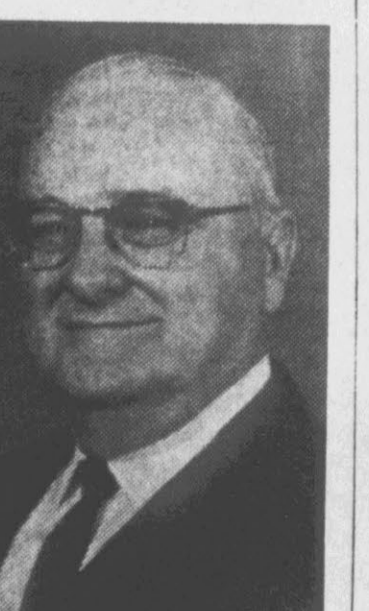

A RESOLUTION PROVIDING FOR AND ORDERING A SPECIAL ELECTION IN AND A NEW REGISTRATION OF ALL QUALIFIED VOTERS IN THE CHICOD SCHOOL DISTRICT ON THE QUESTION OF LEVYING A TAX TO PROVIDE SUPPLEMENTAL FUNDS FOR THE OPERATION OF SCHOOLS IN THE CHICOD SCHOOL DISTRICT OF A HIGHER STANDARD THAN THAT PROVIDED BY STATE SUPPORT:

WHEREAS, the Chicod School District has heretofore been established by regular proceedings and the boundary lines of said District have been defined and the said boundary lines and description of said District and the action of the Board of Education with respect thereto duly appear on the records of Pitt County; and

WHEREAS, the Chicod School District has a school population of five hundred (500) or more, as has been certified by the Board of Education of Pitt County and the said Board of Education of Pitt County has requested the Board of Commissioners of Pitt County to provide for an election in the Chicod School District upon the question of levying an additional special school tax of not more than ten cents (10c) on each One Hundred Dollars (\$100.00) of assessed valuation of all taxable property, both real and personal, within said District, in order to provide supplemental funds for the operation of schools on a higher standard than that provided by State support; and

WHEREAS, the aforesaid petition of the Chicod School District, together with the approval thereof by the Board of Education of Pitt County and the Board of Commissioners of Pitt County, has been approved by the State Board of Education;

"Yes, indeed," he said. "I spent most of my four years at Chapel Hill sitting on the front porch of the SAE house and going to the movies."

As the Chapel Hill Weekly remarked, there is little chance that teachers of creative writing or, indeed, any kinds of teachers will be seeking Mr. Percy out for testimonials, through SAE and M G M might.

Speaking of the Chapel Hill Weekly, that intangible journal, surely one of the best non-dailies in the country, has just celebrated its 39th anniversary.

The first issue is now something of a curiosity. For one thing, the Pickwick movie house was featuring "When Knighthood Was in Flower," for twenty cents admission, that March week in 1923. It was also running verse ads to recommend the late show:

Another item from Chapel Hill is that the Playmakers have been showing a play based upon Harry Golden's "Only in America." Authors of this are Jerome Lawrence and Robert Lee, who did "Inherit the Wind," the successful treatment of the Scopes Trial, several years ago.

It is difficult to see drama in the series of sentimental essays which comprise "Only in America," and at least one early critic (Neil Clark writing in the Daily Tar Heel) has complained that this stage version does lack conflict, and that much of the time "Golden stands around like a burlesque comedian and bounces quips off a series of straight men."
