UNITED NATIONS, N.Y. (AP) The United States and Britain sought Security Council support today for a demand to censure Israel for her recent attack on Syria and to warn Israel against making future revenge raids.

N.C. Democrats Hear Freeman Push Tax Reform

CHARLOTTE (AP)—Secretary of Agriculture Orville L. Freeman in a speech here accused Republicans in the U.S. House of Representatives of "bleak negativism and narrow partisanship" for their opposition to President Kennedy's tax reform bill.

Freeman said, "every single Republican voted against" this bill which would have aided business.

Freeman, three-term governor of Minnesota before his defeat in 1960, took a jibe without mentioning names at Rep. Charles R. Jones, R-N.C., who has been re-elected to the new 8th District.

W. Ivan Bissette Among Group Making Visit To White House

W. Ivan Bissette of Grifton was among a group that shook hands with President Kennedy in the White House Wednesday and heard the President declare that failure of the government to seek a farm supply-demand balance would invite economic disaster.

Bissette, who is a member of the N. C. Agricultural Stabilization and Conservation Committee, was one of 150 state ASC committeemen from throughout the nation attending a two-day meeting in Washington at the invitation of Agriculture Secretary Orville Freeman.

Freeman, in his comments to the state committeemen, continued: "But at least we are moving toward an adjustment between supply and demand which will protect the interest of the farmer and the consumer and also protect the interest of all the people expressed through their national government."

# The Ghost Of Eugene O'Neill Has Dominated Family 6 Years

NEW YORK — (WNS) — For six years Eugene O'Neill, dead, has dominated the life of a young New York couple and their two children.

The couple, Arthur and Barbara Gelb, have spent those years, most of their savings and untold shoe leather answering the question: Who was the real O'Neill? Who was the man behind the plays?

They have set down their findings in a three-pound, 970-page volume entitled, in bright yellow letters, "O'Neill."

Any one O'Neill, who is considered the greatest American playwright eludes them.

"We don't know," said Mrs. Gelb, "why he didn't allow himself to die of drink. We believe his passion for writing saved him. But we don't know what made him write."

"Many people have theories. His widow (Carlotta Monterey O'Neill, his third wife) said that in his bones he was a Catholic; he had a literal fear of the devil."

"But there is that last, final thing — the mysterious essence of genius. No one can penetrate it. I doubt that O'Neill could have explained it. You just have to say he was a genius — and let it go at that."

The Gelbs, both in their late 30's, have been under the O'Neill spell since their student days. Mrs. Gelb gave her husband a set of O'Neill plays in 1946, the year after their marriage they saw the Broadway production of "The Iceman Cometh."

In 1956 they contracted to do a partial biography for Harper's. They expected the work to take a year and a half. But the more they poked into O'Neill's life, the more engrossed they became. They decided to do a comprehensive study.

"We were passionately interested in him," said Mrs. Gelb. "We are virtually able to account for every hour of his life. We could have written almost an hour by hour description."

The Gelbs spoke with some 1,000 persons. Their search took them to waterfront bars and libraries, mental hospitals and universities. There was a sense of urgency, for many of the people who had known O'Neill were in their 70's and 80's. Two dozen have died since the Gelbs interviewed them.

Mr. Gelb is on the drama staff of The New York Times, but he started his Times tenure 18 years ago as a police reporter. He used his police reporting techniques to find people who were either lost from sight or deliberately hiding. "It was the same kind of painstaking drudgery a detective does to track down a case," Mrs. Gelb said.

One man uncovered by reporter Gelb was James Joseph ("Slim") Martin, a former sailor and steelworker and an Irishman who loved other Irishmen. O'Neill had spent much time with Slim in New York's Greenwich Village in the 20's.

"He had been in a seaman's rest home," Barbara related, "but he got fairly violent when he drank, so they sent him to a psychiatric ward."

"Slim was a fascinating-looking man — weatherbeaten face, bright blue eyes and a beak nose. He was an avid reader, with the soul of a poet."

"He told me they had taken away his glasses, and that he shouldn't be in the psycho ward. He was very happy that someone was taking an interest in him, for whatever reason."

"I spoke to his social worker, and Slim was re-examined. It was just neglect. His trouble was physical, and he was transferred to a regular ward."

Mrs. Gelb spent many hours with Slim. "I became very attached to him," she said. "He had so much to say, but he had chest trouble — he was asthmatic — and it was hard for him to talk sometimes."

"One time, he said, O'Neill asked him how to get rid of leg fetters. He was writing 'The Emperor Jones' and wanted to know if it was possible for Jones to have escaped from a chain gang. O'Neill said he was going to write to Slim to find out."

"You don't have to do that," Slim told him. "I was a member of a chain gang. You hammer them out of shape with a rock, then spring the catch. Slim had been picked up in the South for vagrancy."

Slim was in his early 70's when Mrs. Gelb knew him. He had died since.

"He was so looking forward to the book," she said. "He never saw even the manuscript."

Slim and James Quigley, who had sailed with O'Neill to London and Liverpool, helped the Gelbs understand what O'Neill's sailing

characters but he had no understanding where his children were concerned. For all he was hurt by his own parents, he did the same thing — with a vengeance — to his children."

There were times when the Gelbs almost dropped the project. "We worked on O'Neill every single day for five years," Mrs. Gelb said. "Then we read manuscript and galleys for a year."

"We lost quite a number of friends. After they were turned down a few times they didn't call again."

"Much of the time we slept very little. We spent all our savings and at several points went into friendly debt. We were convinced the book was not in any sense commercial. But we kept on spending."

"The low point was the summer of 1958. We rented a house in Larchmont, N. Y. We were exhausted, at a financial low point, and felt the children were neglected. Then I fractured my ankle, and had to keep house from a wheelchair."

"If it had been anyone but O'Neill, we probably wouldn't have finished. He had such energy, we had his example. (In the final years O'Neill had a rare nervous disease which left his brain clear but his movements uncontrollable. He could not use a typewriter, and much of the writing from that period is so cramped under a magnifying glass.)"

"We figured," Mrs. Gelb said, "that if O'Neill could work to the last gasp, we could too."

# More Than Tax On Food Involved

There are growing indications that the three per cent sales tax on food, enacted by the 1961 General Assembly, will be a major issue in the Democratic primary this spring and in the state general election this fall.

It is altogether proper, we feel, that the question of tax be an election issue. It is a matter of importance to the people of North Carolina and it has a direct effect upon every citizen of the state. It would be difficult to find an issue that would have a more direct bearing on the life of a larger percentage of the population of North Carolina.

At the same time, however, care should be taken to see that the sales tax on food is an election issue and not a political football kicked around for the sole purpose of winning votes.

Those who chose to attack this particular tax in the coming campaign, it seems to us, have an obligation to the people of the state to offer some alternate means of securing a like amount of revenue each year for the state. Or, if they feel the funds provided by the tax to enrich public education in

North Carolina should not be expended, they have the obligation to be forthright and express such feelings.

It is not enough for candidates to talk about reducing taxes without putting forth some concrete recommendations for reducing expenditures. It is not enough for them to demand repeal of a particular tax without either recommending specific reductions in state spending or proposing alternate ways of obtaining necessary revenues if expenditures are to continue at their present rate.

When it comes to affairs of government — whether it be local, state or national — tax revenues and government spending of necessity must be considered as a whole. Any adjustments made in either has a direct effect upon the others.

The citizens of the state in the 1960 gubernatorial election indicated their preference for a program of enriching public education of the state. The legislature in 1961 implemented this mandate and chose the avenue of a sales tax on food to provide the necessary revenue to carry out the school improvement program.

A campaign issue centered around the sales tax on food will automatically involve the question of whether the school improvement program will be continued, and what sources will produce the necessary revenues if the program is to continue and the sales tax on food discontinued.

If candidates are going to make a campaign issue of any segment of this overall situation, in fairness to the people of the state they should discuss more than just the tax on food. Considerably more than just the tax on food is involved.

## A Very Tough Nut For The Foes Of Change

Reorganization of established military set-ups has been often proposed and seldom accomplished. It invariably becomes entangled with politics, and in the political arena our military brass usually find themselves overmatched.

This is not always a bad thing. It is not always a good thing.

However, circumstances and a magic name in background invite speculation that if there is ever going to be a thinning out of National Guard and Army Reserve units, it will be accomplished in the near future . . . regrettable as it must appear on many home fronts.

Circumstances? (1) Addition of two new Regular Army divisions and maintaining them in a state of combat readiness;

(2) Recent experiences with unready and un-military personnel in ranks of the standby forces;

(3) Creating a ready force of six prime Guard divisions and flexible brigades, fit for quick call-up;

(4) Assumption that if the big bombs fall, the war would be fought chiefly with forces in being; and if they don't fall, there will be ample time for whatever buildup is needed;

(5) A growing feeling among many seers that the whole pattern of warfare is moving into a revolutionary era.

Oh yes . . . the "magic name" in the background: Robert McNamara. He has the capacity to convince even reluctant lawmakers that his available evidence and conclusions cannot be pushed aside.

The circumstances of the times, coupled with the McNamara logic, comprise a very tough nut for the foes of change to crack.

## Imperfect, But Filling Big Role

WASHINGTON (AP) — It was 17 years ago that the United Nations was created in San Francisco. It's been a big disappointment to a lot of people. It shouldn't have been.

It's not perfect. It could get worse. It's still the only one of its kind. None better is in sight. It might improve.

And this week the Senate, despite all the griping and complaining by some members as it debated how to help the United Nations with American money, never even remotely considered pulling out.

At the start of the San Francisco conference, just as the war in Europe was ending, there was a sense of a new world being born.

Before the conference ended anyone able to recognize reality knew it was the same old world. There were several reasons but one is enough:

The United States and Russia, allies in the war ending, were not allies in the new world coming because they didn't trust each other. They didn't then and they haven't since.

Each, to protect itself, wanted to be able to veto the other in the Security Council which, starting out, was the main U. N. organ, dominated by the big powers.

The General Assembly was secondary. There each nation had one vote and no one had a veto. In the cold war years Rus-

sia used the veto so often in the council that the veto and the council both became absurdities.

After that of this United States led the way in upgrading the assembly, enabling it to recommend action which Russia, before, could have vetoed in the council.

The idealists, who thought in terms of an orderly and cooperative United Nations, overlooked something else in 1945. This was the possibility of profound changes through the addition of new nations.

At that, with a starting U.N. membership of 51, the world seemed fairly orderly. There was a limited number of nations on earth, a number which hadn't changed much in generations.

But the big European colonial powers, through impoverishment, had to disgorge themselves of their ancient colonies, which became new nations in swarms and flocked to the United Nations. Now it has 104 members.

These new nations can vote in blocs when it suits their common interests, which may not be American interests.

This in itself has caused some American frustration and disillusionment, particularly since this country pays such a big part of the U.N. freight.

It showed up vividly this week in efforts by individual (Continued on Page 6)

## The White Collar Perils

NEW YORK (AP) — Science has done considerable research on the perils that beset the health of Hottentot and Eskimo. But apparently it has overlooked some of the health problems facing one of the true pillars of our civilization and society — the great American white collar worker.

This is too bad because, medically speaking, the average office employee has far more interesting ailments than those that afflict the happy flea- and louse-bitten sons of nature who inhabit tropical jungles or polar igloos.

Recently, I made a tentative list of strange illnesses found among the office coffee-break

set. Well, it appears I barely scratched the surface. There seems no real limit to the weird and unusual diseases that plague the U. S. white collar worker.

Office employees from all over the country write in to describe other startling or obscure occupational ailments they had noted among their fellow workers.

Here are a few: Alimentary doloroso — Symptoms: Afternoon lassitude, heavy dull feeling in stomach. Cause: Too many four-martini, three-hour luncheons. Rarely found in bookkeepers. Strikes most often among sales execu-

tives. Romeo dermatitis — Itchy feeling in fingers felt by romantically minded vice presidents whenever the pretty new girl in the stenographic pool passes by. No known cure, and victim rarely seeks one.

Inner Sanctum Knee-Knock — A vibrating weakness of the legs that afflicts any mouse-like male employee who, at his wife's urging, invades the boss' office to ask for a salary hike. Symptom usually disappears when the employee voluntarily asks to take 20 percent pay cut after the boss explains times are so bad the firm may have to go out of business.

Cranial Expansum — An insufferable, at least to others, enlargement of the head that occurs in young business trainees when the wily personnel director tells them, "Actually we regard you as junior executives."

Pedal Pallor — The numb sensation one gets from sitting so long with his feet on the desk that the blood drains out of them.

Neurosis Minor — This hits the office efficiency expert when he finds some of the girls are throwing away carbon paper after using it only once.

Neurosis Major — A condition that reduces the same guy to gibbering frustration when he discovers the office used 12 more paper clips this month than it did during the same month a year ago.

Rumpus ponderosa — Known colloquially as middle-age spread. This is commonly found among 25-year swivel chair veterans and secretaries with a fondness for sweets. The symptoms are obvious even to the untrained eye.

When you consider all the health perils that threaten the white collar worker, you can't help but wonder why he doesn't ask for extra pay for risking life and limb in a real danger zone.

## All-Out Bid For Pennies

It appears that the Treasury has gone mad in its search for more pennies. The proposal to put a withholding tax on interest on savings and on dividends may look like a scheme to soak the rich, to get after the tax-dodger. In fact, it will be a hardship on the widow and orphan, on those who have inherited small amounts and have to live on interest and dividends.

The idea that the persons will be able to get the money back at the end of the year is nonsense. What will she live on in the meantime? The rich can spend their money to Switzerland or invest in European businesses. The widow and orphan, the child who is dependent upon this kind of money to go to college, they cannot go to tax-havens. They are stuck.

The only thing to do should this law be passed is to take the money out of savings banks and buy bonds or some such equity and hide it under the mattress. This could produce a financial panic but it would be of the Treasury's making. The idea of collect first and refund later will make the tax collectors even more hateful than they are now.

It is about time that the Congress restudied the entire question of taxes. Obviously the graduated income tax makes the rich richer and the poor poorer; it destroys incentive and initiative; it impoverishes the spirit of man; it is actually lowering the living standard of our people because a lower quality of goods is substituted.

True, the government needs money in our war against Soviet Russia, but there are better ways of finding it. Money than the graduated income tax, which actually produces a flight of capital. While the poor are being impoverished by taxes and every year the Treasury seeks new ways of depriving Americans of their livelihood and while phony high wages, only part of which the worker gets, outprice our goods in world markets, no one bothers to find a more honest and more equitable way of collecting revenue.

The most satisfactory tax, used in many countries, is the transaction tax, sometimes called by other names. This is a tax on every commercial transaction that actually takes place. It has the advantage of cutting out the take-first-and-refund-later device; it has nothing to do with deductions, with all the mish-mash about expense accounts. Just as we now pay taxes all the time, so under the transaction tax, we shall be paying taxes all the time but it will be on actual transactions, not on taking the cream off the top. And it would be possible to get rid of the horde of tax investigators who fall upon the American people like locusts.

Furthermore, it is morally wrong for the Treasury to employ stool-pigeons, informers, spies to go about seeking for information. These creatures, to get their percentage, pry into private affairs of people, impersonate government agents, and it is reported, although I cannot prove it, some of them act as double agents, doing a little blackmail on the side.

The income tax on interest on savings banks accounts is particularly nasty and should be opposed actively. I, for one, will vote for no Senator or Representative who votes in favor of such an act, no matter which party he belongs to. I hope that all my readers will adopt the same attitude and will tell their Senators and Representatives so. This is something to be angry about because it strikes directly at those who do not have much money. If they want to soak the rich, why don't they go after the numbered accounts in Swiss banks? Why do we not tell Switzerland that unless they cooperate, we shall break off all relations with that country? Extreme?

Nothing is more extreme than the proposed withholding tax on interest and dividends. If those in charge of our financial affairs cannot think better than that, we must protect ourselves from them.

(Washington Daily News) If there ever was a community project around which the people of Washington and Beaufort county ought to rally, the one proposing a one-year extension college course here is it.

When we realize that East Carolina college right now has more than 3,000 applications for next September's Freshman class, and more than 4,500 are expected, we can begin to understand the educational tragedy facing us. When we have to tell our boys and girls that "we're sorry, there is no place for you," we are telling them that we are not on their side in their search for greatness.

East Carolina college proposes to establish this one-year college training course in Washington. Many boys and girls who might be turned away from ECC itself in Greenville can still get a year's college education right here at home. If they are successful with this first year, they can enter ECC the following September as full fledged sophomores.

Is not this idea the fulfillment of a dream long nurtured in the breasts of so many of us who long ago realized what is about to happen in our educational story right here at home?

Is there any reason why all our people cannot get behind this project and give it our complete and enthusiastic endorsement? We know of none.

Of course, it is going to cost a little money—very little. The people of Washington and Beaufort county must furnish classroom space, lights, water, heat, janitorial services, and needed research books for the library. We do not know what the total cost would be, but our guess is that for an amount not to ex-

ceed \$2,400 per year, this one-year college school can be ours. If we stop a moment and realize that over the years many boys and girls from our area have attended college because ECC is close at hand, then we might also realize that even the proximity of ECC has not been enough for some others to attend.

Officials at East Carolina college are fairly certain that they will have many boys and girls seeking admission to this school.

The directors of the Chamber of Commerce in Washington are so enthusiastic about the prospects for the future that they are already talking in terms of a local foundation to raise the needed money to guarantee its success.

ECC officials say that the proposed school is not in conflict with any other proposed schools for this county—including the proposed Industrial education unit now being investigated.

As we view the proposal, it becomes not a matter of "do we want it or do we not want it?" It becomes a matter simply of taking the necessary steps to insure it.

The proposed school would meet four nights each week. Qualified teachers obtained through or from East Carolina college would do the teaching. The students would pay eight dollars per quarter hour for each course taken.

This is a great opportunity for us. Let us not falter in our efforts. Let us not be indifferent to its possibilities. Let us stand together now to the end that many of our boys and girls can get a one-year college curriculum right here at home. Let us be about our work.

## Not All Unions Like Steel Deal

This year, other unions will show reluctance to go along with the settlement of the steel strike formula. Some have already indicated they want more than fringe benefits.

In years past, the United Steelworkers' pact with the steel companies have served as a pattern for other wage settlements. True, the United Autoworkers have usually tried to top the men in the mills, but the steelworkers' gains have always been a model for many other unions.

But the settlement this year: no wage rise but 10 cents an hour in fringe benefits, is not attractive to other unions. They want that rare ingredients of industrial harmony, instant money.

Almost immediately after the steel settlement, the International Association of Machinists turned down a 10-cent fringe benefit by Republic Aviation and struck its huge Long Island plant. More strife can be expected. EVERYBODY SHOPPING

Here are more look-aheads in business, based on analyses of developing trends, spiked with a little common sense:

Easter shopping surge: Sales from today to Easter will set some sort of mark. Consumers are confident, buying is increasing and late Easter stimulates sales more than early Easter. Both men's and women's fashions have enough change to bring about a wave of replacements.

Publishing boom: Congressional changes in the tax law will form fresh, new markets for publishers of tax diaries, tax notebooks, and books to guide the unwary through tax traps. Corrections are being made in countless galleys today, and they will continue until Congress finally passes the bill, at which presses will roll and the nation will be glutted with books and booklets designed to help, business, minimize taxes.

LESS FOREIGN-CAR ADS  
Smaller ads for smaller cars: Foreign car manufacturers, faced with the fact that the United States can make cars just as small, are cutting back advertising appropriations for the rest of the year.

Tourist bust: The OAS may not have kept Algeria, French but it is keeping Paris broke. Just as France has readied itself for a flood of tourist reservations, it is getting a flood of cancellations. Night life is dying, streets are deserted, gendarmes are everywhere, theatres are empty and tourists already there are fleeing to other countries.

Costlier magazines: Your favorite magazines will cost more. The recent upheaval at Curtis Publications shows that publishers are becoming less interested in total circulations and more in quality. Indications are that the most-wanted readers will pay higher prices for the magazines they like. So mags will hike prices, glad to get rid of those who won't meet the increase. Note: Prospects of higher postal rates will speed this process.

## Probation Head Obtains Results

PROBATION — Here is further testimony to truth of the old adage that "It Pays to Advise." Several weeks ago Charles Cohoon, new director of probation, had published in nearly all the big state papers a feature article on the value of the probation system, and how North Carolina was suffering great loss both in money and in human rehabilitation by inadequate use of the service. He urged judges to give more consideration to probation in dealing with first and youthful offenders. Result of the publication of that article was a boom in number of persons put on probation during March, the number reaching an all time record. Cohoon estimates it costs less than one-third as much to maintain a probationer as to keep a prisoner, and that the State saves a lot of money through use of the plan. The greatest saving, however, is in the maintenance of self-respect and self support and the rehabilitation to useful and productive citizenship of the individuals.

Norfolk, and South Carolinians have put US 17 as far north as Georgetown in first class condition, with an adequate road continuing on to Myrtle Beach. Why, argue the people in these other states, should we spend our money on roads that benefit only North Carolina, when there is such great need throughout our own state. And yet unless the bottlenecks just across the borders can be unstopped, that part of US 17 traversing North Carolina will get little benefit from the increased traffic when the bridge-tunnel route is opened late next year.

Somewhat similar but less serious problems have arisen in locating Interstate 77 north of Mount Airy and Interstate 26 south of Hendersonville.

COMPLACENCY — The city and the people of New Bern were shocked early this week by announcement that St. Luke's hospital would be closed in a very short time. Operated by an order of Catholic Sisters it is the only hospital for white people in New Bern. A city-county hospital is under construction, but will not be ready for about a year. New Bernians are taking almost frantic steps to keep St. Luke's open.

Not long ago there was much publicity about the plight of the town of Highlands up in Jackson county, faced with the epidemic and no doctor. A doctor had promised to come, but could not get clearance through the State board of examiners until June. The community appealed to Governor Sanford, who interceded with the medical board to have an exception made to the rules and give the out of state doctor an examination ahead of schedule.

Numerous communities throughout the state have been disturbed by announcements of funeral homes that they are discontinuing ambulance service. This has been a money losing proposition all along and the funeral directors got tired carrying the load. In several places where private business men undertook to carry on they found the operating loss too heavy to sustain.

These several instances are cited to illustrate how easily the American public accepts conveniences and services and quickly assume them to be rights rather than privileges for which somebody must pay. A great many people have assumed that a doctor is as close as the telephone, a hospital bed available to need and ambulance on call to transport the patient to the hospital. All this without much thought as to who was paying for these services. It may be somewhat rude, but it is wholesome, that the people are being awakened to the facts.

There are about 25 miles of US 17 between Norfolk and the North Carolina line that is of very little importance to Virginia, but which would require a good deal of money to put in desired condition for the main line. Most Virginians want to spend their tax money on roads leading from Norfolk westward into Virginia.

The same situation is found in South Carolina. The approximate 25 miles between the North Carolina line and Myrtle Beach does not serve South Carolina. Virginians have built good roads from the north to

## Palmer And Player Dominate Tournament

**AUGUSTA, Ga. (AP)**—The 1962 Masters Golf Tournament looked today like a rerun of an old movie thriller on television—Arnold Palmer vs. Gary Player, going into the final rounds.

Last year at the midway point, these two were tied for the lead at 137. This time Palmer is 136 after a sensational 66 in Friday's second round; Player at 138 after a conservative 71.

So thoroughly have Palmer and Player dominated the tournament, it is almost as though it were a match-play event with only two participants.

Their closest challengers going into the third round were U.S. Open champion Gene Littler, who rode a sterling 68 to a 139 total, and little Gardner Dickinson Jr., whose 71 gave him 141. But they were forgotten pursuers.

All the attention was on the Palmer-Player duel.

Player seemed not the least disheartened that he lost his first round lead and fell two shots behind Palmer.

The small, sinewy South African star, hoping to become the first man ever to win Masters back-to-back, said he prefers to

be two shots behind Palmer because that forces him to abandon his usual conservative style.

"You can't afford to play conservatively on this course against a man like Palmer," Player said. "He is always attacking."

Palmer, whose 66 was his best ever in the Masters, was happy with the situation, too.

"I like it just where I am," he said.

Palmer strung together four straight birdies on the back nine, closing with a 31—just one shot over the back-nine record set by Jimmy Demaret in 1940.

The only excitement on Player's round was an eagle-3 he picked up on the par-5 15th with a screaming drive, a four-iron to the green and a 30-foot putt.

Par over the 6,990-yard Augusta course is 36-36-72.

A 149 was necessary to qualify for the final 36 holes. Fifty-two players made it. Some of the major casualties were former Open champion Tommy Bolt, former Masters champion Art Wall and Billy Joe Patton, who almost won the 1954 masters, but finished third one shot behind Ben Hogan and Sam Snead.

There will be two new clubs—the Houston Colts and the New York Mets of the National League.

There will be four new managers—Casey Stengel of the Mets, back after a year's retirement, Larry Craft of the Colts, Mel McGaha of Cleveland and Billy Hatcher of Baltimore.

And there will be three new parks—four if you want to count the return to New York's Polo Grounds, unoccupied since the Giants pulled up stakes and went to San Francisco after the 1957 season.

The Dodgers (and Los Angeles) will inhabit Walter O'Malley's dream park at Chavez Ravine.

The Washington Senators have the new D.C. Stadium. And Houston has a 33,000-seat park ready to go while work continues on the domed stadium the Colts hope to have ready for 1964.

As usual, Washington and Cincinnati will get the jump on the others in their home openers.

The Senators have their presidential opener, Monday against Detroit, with Don Mossi of the Tigers scheduled to oppose the Senators' Bennie Daniels after President Kennedy completes his "first pitch" duties. The NL champion Reds also start Monday at home—with either Bob Purkey or Joey Jay scheduled to pitch against the Phils' Art Mahaffey.

Nine games are scheduled Tuesday, with Baltimore at the world champion New York Yankees, Los Angeles at Chicago, Cleveland at Boston and Minnesota at Kansas City in the American League, and Cincinnati at Los Angeles, New York at St. Louis, Chicago at Houston, Milwaukee at San Francisco and Philadelphia at Pittsburgh in the NL. All are afternoon games except the New York-St. Louis clash.

In a preseason balloting conducted by The Associated Press, members of the baseball writers association picked the Yankees to repeat easily in the American League, and the Dodgers to win a close race with San Francisco, Milwaukee, St. Louis and Cincinnati in the National League.

## Another Boxer On Critical List

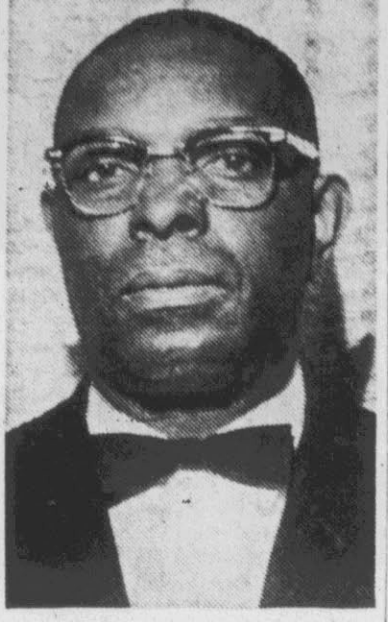

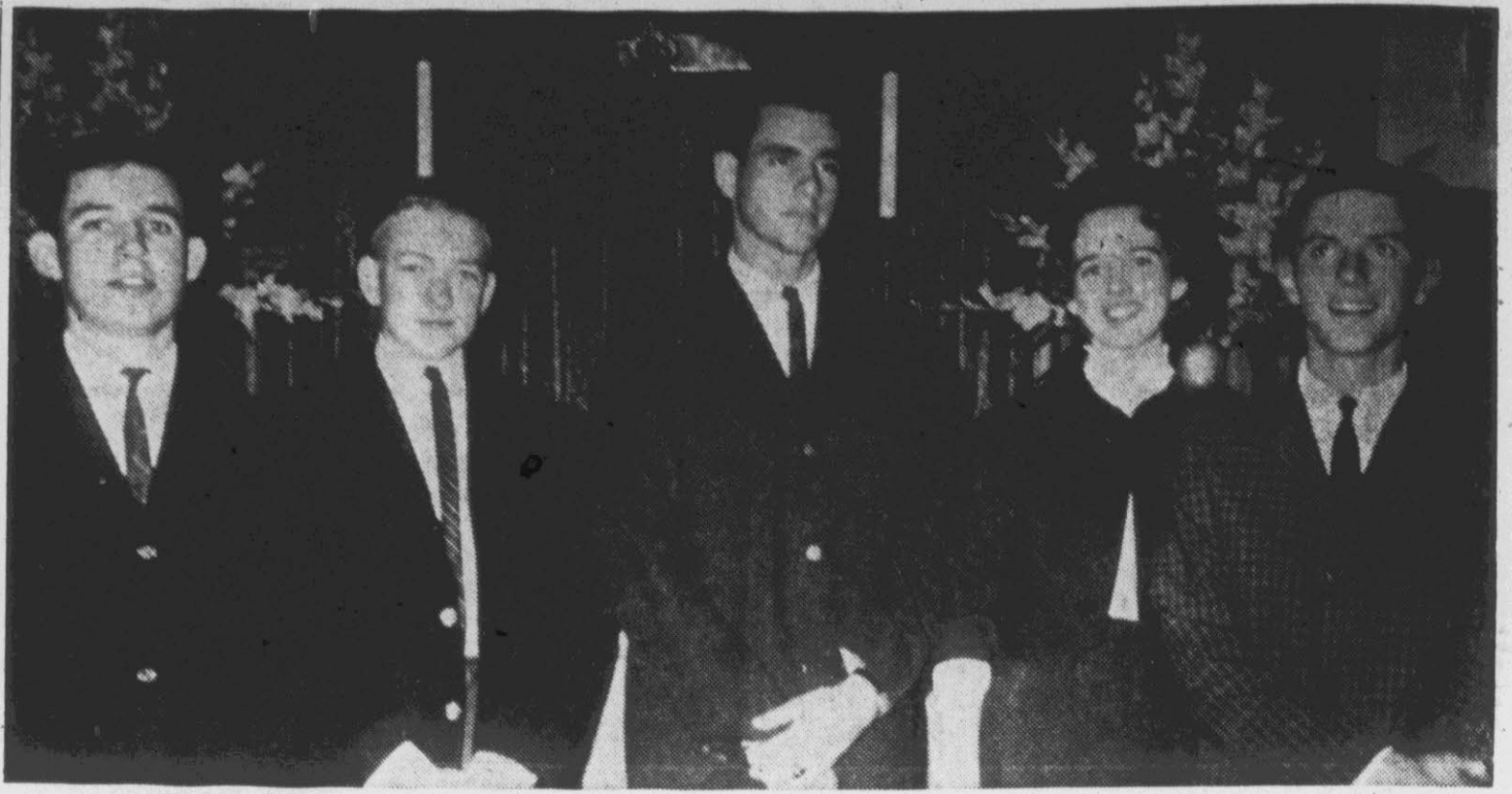

The final session will be held next Monday at Dallas, Tex. Albert S. Harrison of Virginia was the only governor here. A throat ailment prevented North Carolina Gov. Terry Sanford from attending.

Hodges said that, in addition to earning millions of dollars, the "Visit USA" program of the Travel Service "will be building international friendships as more people meet and understand one another. This is the real way to world peace and in this rests our hope for the future."

He explained that last year 1.6 million Americans traveled overseas, spending, along with visitors to Canada and Mexico, \$2.2 billion. Only 600,000 visitors from overseas came to the United States.

While the United Nations is not the ideal parliament of man, it is a little unpleasant to think of what the world might be without it if only because so long as people are calling one another names they're not fighting.

On the very biggest issues — getting the United States and Russia to trust each other more than they did in 1945, stopping nuclear tests, or achieving disarmament — the United Nations has been a flop.

But it has done and is doing many things in many ways — for example, keeping peace in the Middle East and restoring it in the Congo — and so long as it exists there can be hope it will do more.

## Local Library Launched At Book Club Meeting

(Editor's Note: National Library Week begins on Sunday, April 8. Investigation showed that Sheppard Memorial Library has had a rather unusual story and stands today where ruins once were left by fire.)

Three times fire destroyed Greenville's public library, and if that was not tempting fate, a letter bringing news that Harper D. Sheppard of Hanover, Pa., planned to give \$50,000 for a library building here was never received.

Each time fire destroyed buildings housing the library, there were enough people who liked books to find a new place for a library and enough books to fill it.

And the Robert L. Carrs of Greenville found out about the missing letter. Sheppard, in the end, gave \$50,000 for a library building and permanent equipment, as a memorial to his father, William Henry Haywood Sheppard. The benefactor was a native of Pitt County. The town gave the land — but this didn't happen until early in the 1930's.

The history of the library goes back to a June afternoon in 1904, as the End of the Century Book Club was meeting at the home of Mrs. John L. Wooten. Mrs. Sallie Southall Cotton rose and suggested to her friends that the club start a library for the town with their own books.

The books were collected, so by November of 1904 in a small

room on the third floor of the Masonic Temple, located where the George Washington monument now stands at the Pitt County Court House square, the Greenville Public Library opened. Histories of the library make scant note of the fact that the Masonic Building burned, and the library lost its home.

It was re-established in the Winslow Building, then moved to the National Bank Building where it remained one year. Then the library moved to the Evans Street School building, rent free.

The library's connection with the Evans Street School is probably the most well known. In fact, the library today sits on the site that once supported this school. Rumors have persisted to this day about the presence of the library on this site, and many have wondered whether the library was once a fine house.

At that particular time, the school needed more room and the library was forced to seek new quarters. This time it found a place at the Farmer's Bank — until a second fire burned it out.

Many of the books were reported destroyed. The library moved to the Chamber of Commerce Building, and eventually back to the Evans Street School Building.

Another Fire  
In January of 1929 fire had its way again and destroyed the entire school building, including the library facilities.

Mrs. Robert L. Carr, an im-

portant figure in the permanent library building, tells about that fire in a letter published in the Nov. 4, 1949 edition of "The Daily Reflector."

"It seemed that I can hear a telephone ringing and your voice saying, 'Elizabeth, the Evans Street School is on fire and the library is burning.' By the time that Dr. Carr, James Ficklen and I got there, we found the building ready to collapse. Robert's and Jim's length counted for much that morning, as they stood on the ground, reached through a window, and brought out something. It was the vital thing needed — the complete file of all the books and furnishings of the rooms which made collecting the insurance a routine matter."

She told in her letter that the library temporarily made a new home in a "funny little building" owned by Clifton Edwards.

That wasn't the end of the library's existence on the Evans Street property, however. Fate seemed to lure her back.

The school board then offered the library temporary use of its abandoned school site, and the Board of Aldermen of the town found funds to finance a small building, the first one the library had ever had of its own.

Through these years, book clubs and civic clubs had solicited books and gifts, supporting the library under their own steam. The End of the Century's original effort to establish a library was helped by interest and work of the Sans Souci and Round Table Book Clubs — all three among the town's

oldest book clubs, and still active.

The library was managed in its early years by a library commission composed of representatives of various organizations of the town. In 1923 the library commission felt its institution had outgrown their type of management, and they have the building to the Woman's Club, which had the support of the three book clubs so instrumental in its past. The Pythian Club, the Kiwanis, the Greenville School Board, Rotary, American Legion and others contributed to its support in various ways.

The Woman's Club retained management of the library until 1927, when they presented the town "a well organized public library." Trustees appointed included J. S. Ficklen, elected chairman; P. L. Goodson, W. H. Woolard, J. E. Winslow, Mrs. J. B. Kittrell and Mrs. R. L. Carr.

This was the same period of time when the library was housed at Evans Street School, the fire destroying the building in 1929.

### —Strange Sight—

The library's little building, which the town erected on the spot, was said to be a strange sight, with such a small building affixed to the large steps left by the fire. "It really must have looked weird, but all of us interested in the library thought it very lovely," Mrs. Carr commented. Dr. and Mrs. Carr had been

interested for some time in asking Harper D. Sheppard of Hanover, Pa., Dr. Carr's uncle, if he would be interested in giving funds for a real library building for Greenville, as a memorial to his father.

Finally the Carrs wrote the letter, telling about the efforts of clubs here and others towards establishing a permanent library. They suggested that \$20,000 would be an adequate sum for a fine library building. Six months passed, and no reply came.

The Carrs were traveling in Pennsylvania about this time, and stopped to see Sheppard, who immediately asked if they had gotten his letter, and when he learned they hadn't, he sent a messenger to his office for a carbon copy of his letter.

It was Sheppard's idea that \$20,000 would not provide the type of memorial he would like to leave in his father's name; he suggested the sum of \$50,000, upon three conditions: that the town provide a site; that he name two members of a building committee of three — he specified Dr. Carr and Haywood Dail — James Ficklen was the choice of the library board; the third condition was that all future support of the library would be assumed by citizens of Greenville.

Later, Sheppard was reported so pleased with the site selection that he offered another \$10,000, making his gift total \$60,000.

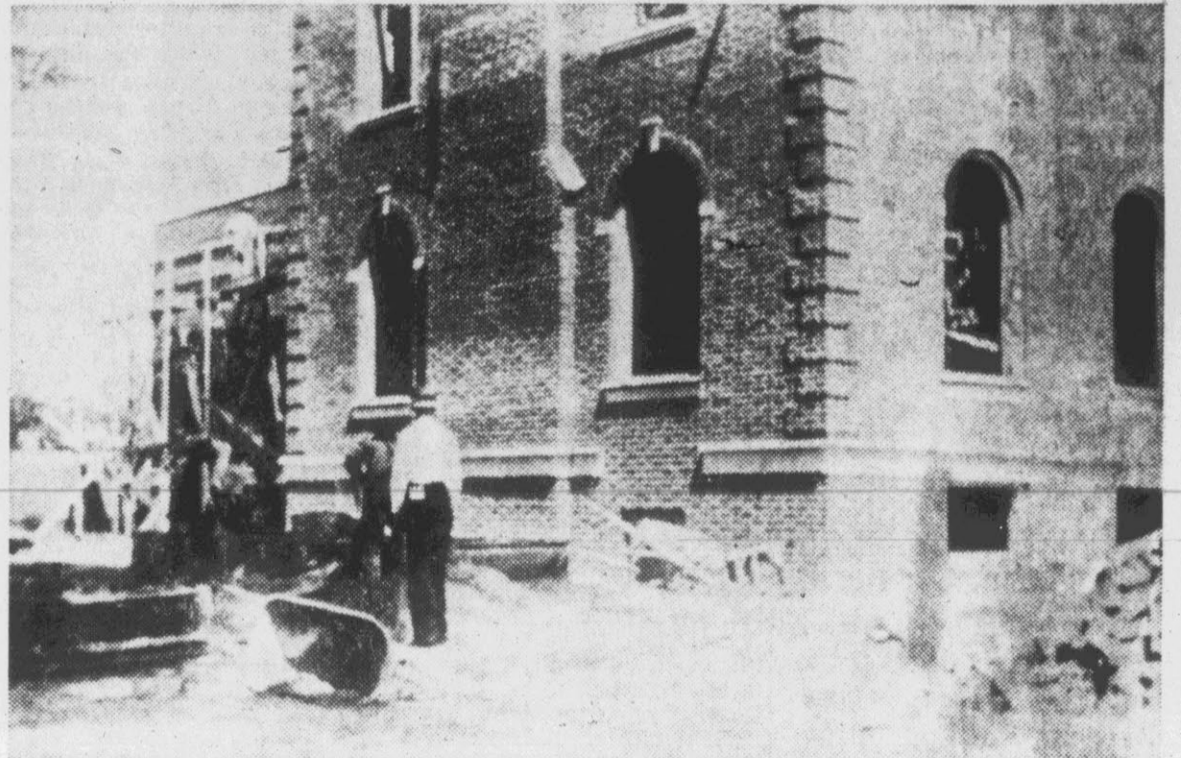
On Oct. 17, 1930, Sheppard Memorial Library was formally presented to the town.

It was a building designed to take care of the needs not only of its day, but of years to come, and it has done that well. It has been called the most beautiful library building in the state and the most complete, in furnishings, in the South.

A portrait of the benefactor, Harper Donelson Sheppard, was presented by Sans Souci Book Club by its then president, the late Mrs. W. L. Hall, to hang in the library. Mrs. C. W. Heame was the artist.

Times have changed since the early years of the 1900's when special entertainments were presented to raise funds and collect books for the library. A book reception was one of the first entertainments for the benefit of the library. "This invitation is sent to you with the best wishes we can give. Bring a book, or send one, please do. 'We'll appreciate it as long as we live. Rome wasn't built in one day, you know. It takes time for everything. We hope at some future day to show the result from books you bring.'"

The first book given was "Christ in the Camp."

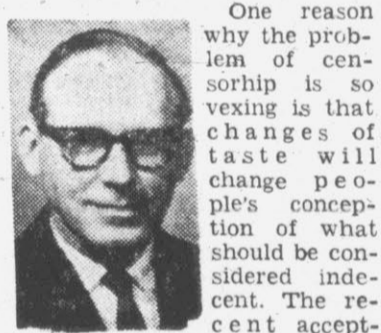


## Reviews And Reflections

The problem of censorship reached Greenville this week.

### Changes In Taste

Nobody with any insight at the meeting of the City Council last Thursday night could have failed to be sympathetic with concern of the PTA committee over lewd literature.

On the other hand, it was interesting to note that their opponents brought out all of the arguments which experience has shown make any type of censorship such a tricky business: Exactly what is to be classed as offensive? Who is willing and able to serve as the censor? If magazines are to be censored, why not other media also?

In the light of all the circumstances, we feel that the suggestion by the Council that those who object to pornography should employ the legal avenues of redress open to them and bring their complaints before a court was mature and wise.

One reason why the problem of censorship is so vexing is that changes of taste will change people's conception of what should be considered indecent. The recent acceptance of Miller's "Tropic of Cancer" after many years of its being smuggled into this country and surreptitiously peddled is a good example of this in literature.

The same sort of thing has happened in the field of art. In nineteenth century America, for example, the nude statue was widely condemned.

In his "Art and Life in America," Oliver Larkin points out that when the Boston Museum

of Fine Arts was completed, naked "Bacchante" by Frederick MacMonnies was supposed to stand in the courtyard. However, public opinion, backed by no less weight than that of President Charles Eliot of Harvard, banished this work. President Eliot called MacMonnies' work, which would not generally be considered totally inoffensive, "the shameless exaltation of wine, women, and song." A bad combination indeed to reside in one piece of marble.

### Academic Honors

A publication under academic auspices which frequently contains interesting and even lively articles is the South Atlantic Quarterly. Its sponsor is Duke University.

The current issue contains an article on honorary degrees by Forrest Kirkpatrick, a trustee of West Virginia University. Since the open season for this type of degree is near at hand, some of Kirkpatrick's findings are of interest.

According to him, the first honorary degree granted in America was conferred upon President Increase Mather of Harvard by Harvard in 1692. Not only was Mather doctored with a S. T. D., but his entire faculty of two was similarly honored. Thus Harvard undoubtedly became the first American college which could boast that its entire teaching staff had "the doctorate."

During the eighteenth century, according to Kirkpatrick, Harvard had such a notorious reputation for conferring the honorary degree that Baron Von Steuben, the Revolutionary general, considered the practice a threat to his troops. At least, he is reported to have ordered them to ride through Cambridge fast, warning them that "if they caught you, they'd make you a doctor."

Other bits of incidental lore about honorary degrees include the fact that Narbert, a Seelie Eye dog received one from a New Jersey college in the '30's, and that Bing Crosby is the last recorded recipient of an honorary Ph. D. That degree is now reserved for drudges and harmless hacks.

### How's That?

When Walker Percy received the National Book Award for his "The Moviegoers," he was asked what Southern writers have which Northern writers lack. Now we get two versions of his answer. Most of the reporters present thought he said "We got beat," but at least one took it down as "We've got the heat." Fortunately, either answer might form the basis of a whole critical theory about Southern fiction and probably will.

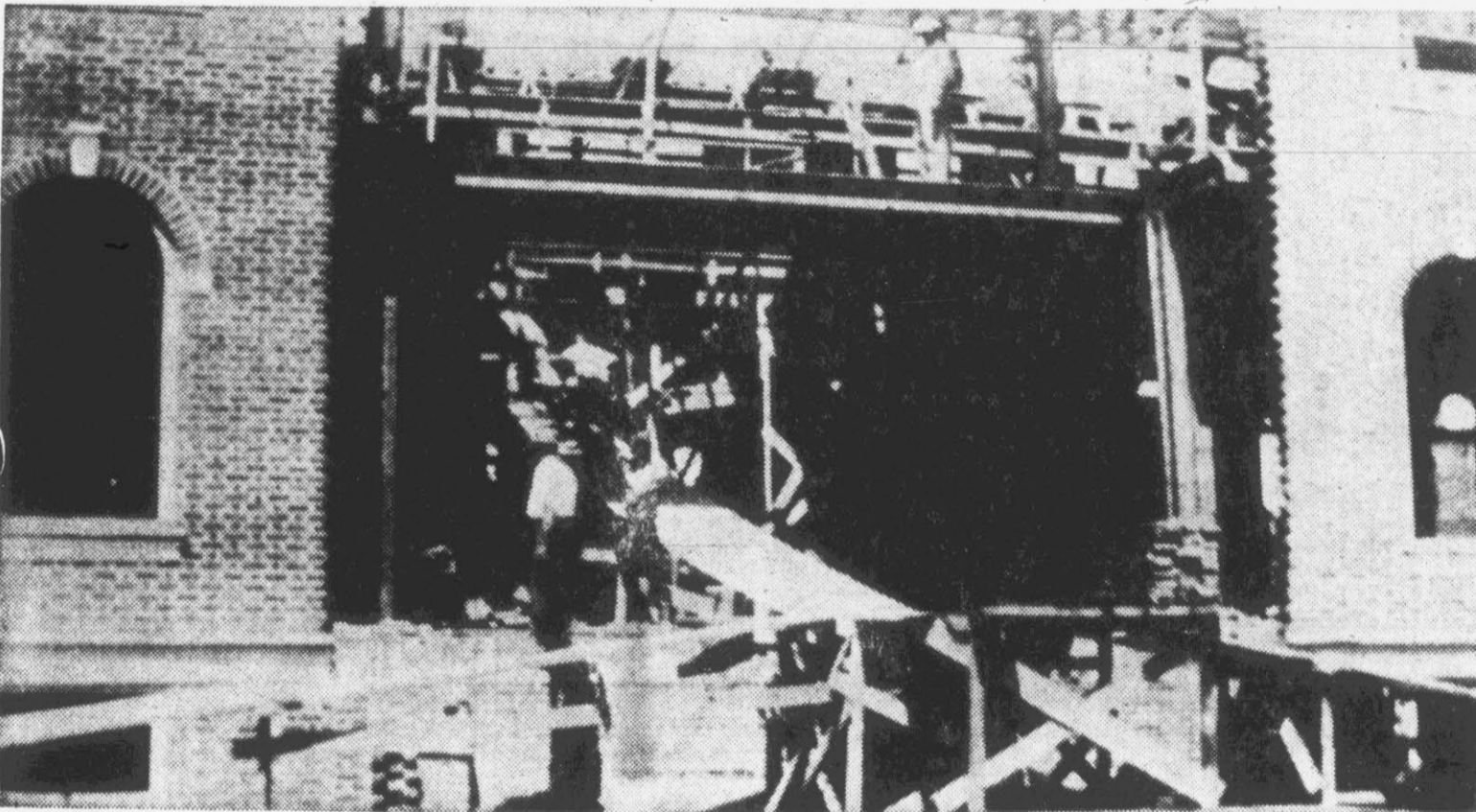

## Poultry Processing Plant To Be Expanded

ROBERSONVILLE — Austin Farms is planning an expansion within the next two weeks which will almost double the plant's daily output and will result in the hiring of an additional 50 personnel.

If you've never heard of their brand name, "Blue Ribbon Poultry", this isn't any sign that you haven't ever purchased any chickens that were processed at Austin Farms.

The company, perhaps one of the most modern chicken processing plants in North Carolina, is presently processing 25,000 birds daily. Within the next two weeks the plant's output will jump to 40,000 chickens daily.

"Because of the desperate need of more available poultry on the market," said Donnie Hardison, general manager of Austin Farms, "we are having to expand. This need for expansion is due to the additional useage of poultry by the American housewife and is also needed in the overall economy because of the depleted income from crop sources."

Austin Williams, president of Austin Farms, said, "The expansion will include an additional \$30,000 in new machinery. One of the machines on order is a cut-up machine which will enable us to sell cut-up fryers and chicken parts, both frozen and non-frozen."

Hardison added, "Besides the 50 additional workers which will be hired, we will also have to increase the number of U. S. Department of Agriculture Inspectors. We have inspectors at present, and one veterinarian, Dr. W. T. Dereaux of Greenville."

"Presently there are 115 employees at the plant, most of whom live within a 10 mile radius of Robersonville. The expansion will enlarge our payroll almost \$2,500 a week and

we will be spending from \$5,000 to \$7,000 more daily on the purchase of live poultry.

"We buy most of our live poultry in Eastern North Carolina and sell processed poultry all over the east coast, from Maine to the Gulf of Mexico. The company never buys chickens from poultry raisers in numbers less than 5,000 and they presently have five trucks which can both pick up live poultry and deliver packaged poultry."

"Approximately 50 workers will be hired as the expansion goes into effect. There is no pre-training required for these particular jobs. Approximately 70 percent of the workers in the plant are women.

During 1960-61 the poultry business suffered, Hardison said. "Business was bad because of the depressed prices in poultry. With more stable prices during the past few months, chances in increased poultry production in our immediate area seem very good."

One day last week, Austin Farms was buying chickens at 15 cents per pound, but prices are subject to change slightly from day to day.

### When Plant Built

When the processing plant was constructed in 1957, the capacity for the machinery production was 7,200 chickens per hour or 120 a minute. Gradually, Austin Farms is working up to that capacity.

Under the present production, Austin Farms is processing 50 chickens each minute and within the next two weeks will be processing 80 chickens each minute. The whole process, from unloading to packaging for shipment, takes only 54 minutes.

Reports indicated that less than one year before the construction of the poultry plant began, poultry-growing on large scale was almost non-existent in the Robersonville area.

Shortly after the plant began processing chickens, a survey

revealed that over 300,000 chickens were being grown within a five mile radius of Robersonville.

Also at that time three new feed mills were opened in the area with expansion taking place in still another feed mill. Besides the new mills came a chicken hatchery.

To what was once primarily a tobacco area, Austin Mills bought new industry and new hope to the occasionally disillusioned tobacco grower. The construction of poultry houses can now be seen along any highway or rural dirt road leading from Robersonville.

Austin Williams, president of the company, has had 20 years of experience in poultry business. He is a native of Wendell and operated a small processing plant in that area prior to his establishing a plant in Robersonville.

His experience in the poultry business is reflected in the fact

that he planned ahead for growth and expansion. Austin Farms is still not operating on full capacity, but the growth of

the demand for poultry in North Carolina and the east coast has edged the company nearer to its potential capacity.

# Mediation Efforts To End Shipping Strike Dropped

SAN FRANCISCO (AP) — Efforts to settle the West Coast maritime strike by mediation have been abandoned.

President Kennedy's three-man special mediation panel Friday night gave up efforts to settle the three-week-old strike after two days of separate talks with both sides. The panel flew to Washington to report no progress to Secretary of Labor Arthur J. Goldberg.

Goldberg and other Cabinet members will confer with the President who will then decide whether to interrupt the strike by using his power under the Taft-Hartley Act which would restore shipping for at least 90 days.

Hawaii Gov. William F. Quinn disclosed in Honolulu that an affidavit outlining effects of the strike has been mailed to the Justice Department in Washington. Quinn said the department wanted the affidavit by Monday for the President's consideration.

Willard Wirtz, chairman of the mediation panel and also under-

secretary of labor, said after the meeting here: "We find the parties too far apart to offer any settlement through mediation. We will report to the secretary (Goldberg) there is no foreseeable prospect of our settling this dispute."

Wirtz told newsmen the difference was substantial and the only issue was money.

He said total cost of union demands was far above the \$5.5 million in wages and benefits the employers offered in a three-year contract.

Officials of the striking unions—Sailors Union of the Pacific, the Marine Firemen and the Marine Cooks and Stewards—said, "Mr. Wirtz' statement is accurate" and would make no further comment.

Presidents of 12 struck ship lines in the Pacific Maritime Association issued a statement saying, "There are limits beyond which the maritime industry cannot go."

The strike had idled some 60 ships on the West Coast and in Hawaii. East Coast-based and foreign vessels are not involved.

## Red Guerrillas Attack Outpost

SAIGON, South Viet Nam (AP) — Communist guerrillas in battalion strength attacked the government outpost of Tra Bong in central Viet Nam and were beaten off in fierce fighting.

Government sources said at least 37 rebels, including two artillery company commanders, were killed and many wounded.

Reports reaching here said the battle flared at Tra Bong, about 330 miles from Saigon, late Thursday night with the Communists making repeated attacks on the outpost defended by a company of army troops. The defenders reportedly suffered three dead and five wounded.

### NOT AT CONGRESS

TOKYO (AP) — North Korean Premier Kim Il Sung apparently is not attending the Supreme Peoples Congress that opened April 5 in Pyongyang, the New Asian news agency reported today. He was not mentioned among the dignitaries attending the opening of the parliament.

### Indonesia Will Pay 4 Wounded

WASHINGTON (AP) — Indonesia has told the United States that appropriate compensation will be given to four Okinawan fishermen wounded by an Indonesian patrol plane.
