Kennedy Assumes New Influence In Crushing Defeat Of Big Steel

WASHINGTON (AP)—President Kennedy's price-crushing victory over the mighty steel industry left him clothed today with vastly new influence to shape the American economy. The steel giants bowed one by one Friday to a massive, three-day government drive forcing them to cancel \$6-a-ton price increases announced late Tuesday. The surrender under furious Kennedy attack was a public spectacle unlikely to be soon forgotten by industry or labor leaders considering a try at breaching the administration rules for wage-price stability. The President, after denouncing the price boosts touched off by the U.S. Steel Corp., unleashed the full brunt of government retaliatory power to force the roll-

back. "The people of the United States are most gratified," Kennedy said on learning that major steel producers had reversed their decisions. He was just starting an inspection of Atlantic Fleet maneuvers. The President's brother, Atty. Gen. Robert F. Kennedy, though also elated at the administration victory, charted full speed ahead on the New York federal grand jury investigation he had ordered into the price increases. He said the price rollback would not have any effect on continuing the probe. Similarly, two congressional committees said they would carry out plans for investigations. Chairman Emanuel Celler, D-N.Y., said however, the House Judiciary Committee would engage in more of a study than an investigation, with the purpose of determining whether the antitrust laws need strengthening. The president shall not be punished, Celler said at Miami Beach Fla. "A Senate Antimonopoly subcom-

mittee headed by Sen. Estes Kefauver, D-Tenn., also will go ahead. A spokesman said, "We're interested in the monopoly situation of all those price increases one after another. This hasn't changed now that there has been an equally quick reversal." The surrender parade was signaled by Inland Steel's decision not to raise prices. Then Bethlehem Steel, No. 2 in the industry and heavily involved in government ship-building, canceled its previously announced increase. From then on it was a rout, with U.S. Steel tossing in the towel. Big Steel said it couldn't stand alone and wanted to "re-move a serious obstacle to proper relations between government and business." Only 24 hours before, U.S. Steel Board Chairman Roger M. Blough said at a televised news conference in New York that his firm would stick to its higher prices.

Secretary of Labor Arthur J. Goldberg—one of the chief Kennedy lieutenants in bringing the steel industry around—went secretly to New York to talk to Blough. A high administration source said that no deal was made, however, to bring the steel companies around. The arsenal of weapons the President wheeled into his all-out economic foray against the big business leaders was an awesome display of coldly determined political and economic power seldom employed by the government. Every major governmental department got into the act. The President himself got on the phone to people of influence. Steel moguls were flooded with grand jury and congressional committee subpoenas. Steps were taken to channel government orders to steel firms holding the price line. These holdouts were encouraged.

Secretary of Defense Robert S. McNamara said, for instance, that steel buying for defense contracts would be shifted to firms that did not raise prices. It was clear when the fight ended Kennedy had only begun. This is what may have impressed the industry. With Congress seemingly in Kennedy's corner, he had new antitrust legislation ready to recommend for immediate enactment. Secretary of the Treasury Douglas Dillon was called off a Florida vacation to level another barrage. Dillon called off the new conference after the price cancellations. Other moves were being considered. One was to remove concessions to business contained in the pending tax bill. A second was to require producers of foreign aid items to use only the lower-priced steel. Also, the President's economic advisers were ready to trot out a white paper challenging industry's arguments justifying a price increase. The view here is that the steel companies might have gotten away with hoisting prices gradually later on—some time after the newly negotiated steel labor contract had gone into effect July 1.

\$926 In Fees

Filing fees totaling \$926.48, paid by candidates for the upcoming Democratic primary, will be turned over to County Auditor Reginald Gray by Board of Elections Chairman D. S. Spain, Jr. Spain said this morning the amount represented fees paid by 58 candidates who filed prior to yesterday's noon deadline. The lowest fee was \$5 paid by candidates for a county board of education seat. Highest was the \$79.50 paid by Clerk of Court D. T. House who is running unopposed. For salaried offices the filing fee is one percent of the annual salary. For justices of the peace and constables who work on a commission basis there is a minimum fee of \$10 or one percent of the previous year's income if it is over \$1,000.

Candidate For District Solicitor Faces Tax Suits

Cecil D. May, the unopposed candidate for solicitor of the Fifth District with filing fraudulent State income tax returns, said this morning, "This thing came as a complete surprise to me."

The New Bern candidate, running for the office presently held by Robert Rouse of Farmville, commented, "They gave me a notice of assessment of taxes and at the same time they served me with the other papers (warrants)." May is free under \$1,000 bond pending trial.

May said the entire matter "came out of a clear blue sky" and that he knew nothing of the action until Friday afternoon.

The warrants, drawn up in Raleigh by Assistant Attorney General Lucius Pullen and Raleigh City Court Solicitor Carl Churchill, charged May with making and subscribing to incorrect income tax returns for the year 1959 in that he reported a gross income for that year of \$9,110, when in fact his income for the year was \$20,973.51.

Attempting to evade payment of income tax by failing to report income for 1959 in that he reported \$9,110, and paid an income tax of \$23.80 when he actually made a gross income of \$20,973 and owed as income tax about \$602.

Making and subscribing to incorrect income tax returns for the year 1960 by reporting a gross income for that year of \$10,974.64 when his gross income was \$19,783.67.

Attempting to evade income tax by failing to report income tax in that he reported \$10,974 as his gross income and paid only \$45.50 when his gross income for that year was \$19,783, on which he should have paid \$482.25.

The candidate for solicitor was assured of the Democratic nomination in the fifth district after Rouse announced that he would not be a candidate for re-election—and he was tied.

J. H. Harrell, a Greenville attorney and chairman of the Pitt Democratic Party Executive Committee, said that the charges against May would not disqualify him because he is innocent until proven guilty. However, Harrell noted that should May withdraw from the primary it would be up to the

District Committee to select his successor as Democratic nominee. The Fifth District is made up of Carteret, Craven, Greene, Jones, Pamlico and Pitt counties. The committee was selected at the last State Democratic

Convention consisting of two members from each county. Pitt County's representatives are Kenneth Hite and M. K. Porter. The committee would have to make the selection because the final date for filing was March 16 for State offices.

Friday's Final Filing Date Finds 58 Entries In Pitt Demo Primary

Friday's final filing filing for candidates in the May 26 Democratic Primary left a total of 58 official entries with four county-wide and six township contests.

Headlining the races that developed were contests for Pitt's remaining seat in the House, the sheriff's office and the Fifth District seat on the Board of County Commissioners. A three-way contest developed for the two seats on the county Board of Education up for election this year.

Robert D. Wheeler of Grifton, who challenged Sen. Robert L. Humber in 1960, and W. A. (Red) Forbes of Winterville have involved incumbent Rep. Frank M. Wooten of Greenville in a three-way primary battle.

Ruel W. Tyson along with veteran deputy A. M. (Duke) Andrews, Sheriff Tyson declined to seek re-election to a fifth straight four-year term. He was appointed to fill an unexpired term in November, 1943 and was re-elected in 1946, 1950, 1954 and 1958.

Sen. Humber gained his party's nomination unopposed when no other candidate filed for the office. Humber, assured of a third straight two-year term, may be serving the last tenure for an exclusive Pitt County senator.

Following the recent U. S. Supreme Court ruling on voter representation, Gov. Sanford urged the 1963 General Assembly to reappoint the State's Senate seats. Pitt, a single Senatorial district, is a sure bet to fall under the lawmakers' reshuffling program.

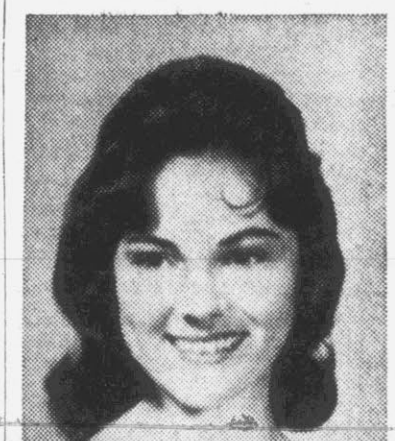

In addition to the 17 Democrats seeking or securing major county office nominations, 17 more filed for justice-of-the-peace positions and 16 of that who filed for constable posts created six township races.

Six Races For Constable In Pitt County Townships

Friday-the-14th-filing-dust-lifted from the official register for May 26 Democratic Primary candidates with races for constable nominations launched in six Pitt County townships. A total of 24 Democrats, including 11 incumbents, had filed for constable jobs in 12 of the county's 15 townships when Chairman D. S. Spain of the county Board of Elections closed the filing period at noon Friday. Seventeen men, including 10 incumbents, had filed for township justice-of-the-peace offices. Perhaps the liveliest race developed in Grifton Township where four candidates are seeking to unseat incumbent constable Walter R. Joyner. John H. Bates, Marion Knowles Jr., Willie P. Faulkner and H. H. Adams are seeking to end Joyner's tenure at Grifton constable. In 1960, Joyner was nominated without opposition and elected in November.

Four men are vying for the Winterville Township constable office to be vacated by W. Randolph Harris who is a May 26 nomination candidate for Pitt's sheriff office, also sought by deputy A. M. (Duke) Andrews. Candidates in Winterville include Marvin R. Gaskins, Lyman Ray Letchworth, W. J. McLawhorn and Hennis A. Shivers. Assured of election since no

opposition filed are these incumbents: constables: Charles Ray Stocks, Arthur Pennell Burnett, Farmville; William H. Crandall, Carolina; Joseph E. Joyner Jr., Greenville; Clarence W. Dixon, Chicod; and J. L. Owens, Fountain. No candidates for constable jobs in Bethel, Belvoir and Swift Creek Townships entered the primary. Of the 17 nominees for local jaypee jobs, nine are from Greenville, two are from Winterville and Ayden Townships, and one each from Grifton, Belvoir, Fountain and Farmville Townships. Greenville jaypees: incumbents Walter E. Lee, Luther D. Moore, A. C. Jackson and Frank Harrington and new magistrates Fountain, Harrington, Johnny Brown, W. O. Flynn, W. A. Dunn and West Shields Jr., the only Negro entered in this year's primary. Winterville jaypees: incumbent C. F. Little and newcomer George W. Harris Jr. Ayden jaypees: incumbent Lee M. Nance and C. G. Kenneth McKell's unusual cereal mosaic of a house scene. These and several hundred more pictures and art objects by children are currently on exhibit at the Greenville Art Center, which is featuring art by students of the Greenville public schools, under supervision of Mrs. Norma Gray.

At least 31 different media and combinations—from straws and cereal to oils and collages—are used by these students in their exhibition. Many of their parents may be unaware of student talent in the family. Some other notable designs and displays are by Mrs. Louise Spear's fifth grade at Agnes Fullilove School; a colonial scene executed in watercolor. After painting the water and sky background, the students mounted trees and figures from cut construction paper, and carried out a three-dimensional effect by making cabins and attaching them to the panel. Fifth grader from Elmhurst School, Charles King, using chalk, designed a picture of colored leaves in a skillful manner; Henry Kidd, fourth grader at Elmhurst, used rubber cement and watercolor in his country scene of a home. His dominating colors were green, brown and white, with a lavender background.

Arthur Fahrner, third grade student at Wahl-Coates School, used crayon etching to present a colorful and purposeful design featuring interplay of a multitude of colors on a black background. Katrina Wilson, fourth grader from Elmhurst, executed a crayon etching of subdued trees by use of dark, dramatic colors.

Young Winslow's ink and wash of tall buildings much resembles a painting by a professional artist which has been exhibited at the center before. His metropolitan buildings were topped realistically with leaning TV towers.

The McKell cereal mosaic used cereal roof over the house, corn flakes for trees and another cereal for flower blossoms.

The vast-media consisted of crayons, scrap collage, colored ink, charcoal, cut paper, chalk,

tempera paint, India ink and watercolor, watercolor, montage, round paper sculpture, blown ink, potato prints, colored pencil, straw sculpture, basketry, wire and plaster, finger puppets, rubber cement and watercolor, dry brush and ink, dripped wax, craypas, finger printing, lineoleum block print, coat hangers, monoprint, cereal mosaic, puppets, sand and plaster, and weaving.

There are probably more. Assisting Mrs. Gray in her instruction of these students were the following student teachers from East Carolina College: Patricia Haywood, Robert Butler, Wayne Frick, Joanne Lackey, Mrs. Barbara Tucker and Gale Hammond.

# Emphasizing Presidential Powers

President Kennedy's complete victory over the major steel companies that announced price increases this week emphasizes the power the administration can wield even upon the biggest business in a bare-knuckle fight.

The rolling back of steel prices late yesterday was a smashing triumph for the administration in its effort to hold the line against inflation. Collapse of big steel attempts to make the higher price level stick came as almost as much a surprise to the public as did the earlier announcement of major companies that they were hiking their prices by \$6 per ton.

Net effect of the rapid developments in the price battle between the government and the big steel companies will be to indicate to the public, to management and to organized labor in basic industries that the Kennedy administration will do more than just talk when it comes to maintaining a stable level of prices and wages. Certainly the impact of rolling back steel prices will have its effect upon every other basic industry in the country and will be reflected in a slowdown of inflationary influences which might otherwise move into the foreground.

The steps taken by the administration in recent days against the steel price increase are the most far-reaching by any recent administration to control the level of prices and wages in the national economy. If the administration steps short of actual

# New Titles For Two Officials

**NEW TITLES** — Changes announced this week by Governor Sanford in the organizational structure of the Department of Administration give new titles to two officials but without seriously affecting their duties as heretofore performed. Hugh Cannon, who has been director of administration for several months, becomes also the State chief budget officer. William A. White, director of purchase and contract for the past year, has added title of assistant director of administration. This adjustment makes it unnecessary to fill the \$13,000 job vacated by Charles Holloman, who is resigning as budget officer to enter private business. No immediate raise in salaries for Cannon and White is proposed.

In practice ever since the Department of Administration was created in 1957 the director has had the final say on all budgetary matters as well as many other governmental activities. A high salaried budget officer has been sort of fifth wheel in the mechanism. The division of purchase and contract is an important part of the overall department in which the top man also had the final word. Making the chief of the purchase division assistant director of administration brings the operation closer together and should eliminate some lost motion.

So far as the persons are concerned, this adjustment makes Hugh Cannon without question the most powerful figure in State government next to the Governor. Never before has one man had so much authority. Last year when Bill White was brought to purchase and contract Governor Sanford indicated he wanted him to "straighten out" that agency and then would use him as a trouble shooter in other departments. Apparently he is set for permanent tenure where he is.

C. & D. — Important personnel changes are being made in the Department of Conservation and Development. William R. Henderson has resigned as chief of the commerce-industry division to go into private business. He has bought controlling interest in Bennett Advertising Company with home offices in High Point, the agency which has handled the State advertising account for several years. As the chief industry hunter for the State, Henderson drew one of the highest salaries on the State board — \$14,928, just six

dollars a month less than the director of C&D. Admittedly his place will be hard to fill at that salary. Before announcement was made of his leaving but after the top officials knew about it several prospects were contacted. In every instance the men contacted were making more where they are.

**BOWLES** — Rumors have been current for months that Hargrove Bowles, C&D director, would leave the State job for private business. He and a group of associates had been tentatively awarded rights to a television channel at High Point and it was expected he would take over personal management of that enterprise. This week the FCC reversed decision of its hearing officer and awarded the channel rights to a Winston-Salem group. This development may mean that "Skipper" Bowles will continue in his State post for some time.

All that raises further interesting question is whether he may personally take over direction of the industry hunting phase of his department's far flung activities. The pattern for such operation was set by development in the Department of Administration earlier this week when the director of the department took over also the portfolio of the chief State budget officer.

**SAFER HIGHWAYS** — "Modern expressways with full control of access are about three times as safe for the motorist as the old conventional highways," according to James S. Burch and James R. Zook of the Planning Department of the N. C. State Highway Commission.

This fact is based on both accident and injury rates from scattered studies across the nation over the past 20 years. Studies made in North Carolina revealed that the expressways with full control of access had 34 per cent fewer accidents than those with no control of access — and 57 per cent fewer accidents than on the average primary highway in the state.

The U. S. Bureau of Public Roads summarizing many pertinent research projects in the nation, reported last fall that the ultimate completion of 41,000 miles of full access Interstate Highways in the nation would be expected to save 5,000 lives a year, even though their length will represent only 1.2 per cent of the nation's total road and street mileage.

wage-price dictation were successful with one of the largest industries in the country, there can be little doubt that the administration can use similar influence with other segments of the industrial complex.

There looms now the question of whether the administration will attempt to call all the shots so far as wages and prices are concerned. Have we moved in recent days into a new era in which, for all practical purposes, there will be wage and price controls by the federal government? Have we come to the beginning of an era in which government economists rather than top leaders in industry and labor organizations will decide what is to be done with wages and prices?

Certainly the administration by its action in the steel situation has nipped in the bud any inflationary spiral which may have threatened at this time. The effects of the outcome of the steel price dispute will be felt throughout the nation's economy and will have long-range effects upon wages, prices, and the stability of dollar purchasing power.

# Accustomed To Lack Of Year 'Round Jobs

Although North Carolina for the most part has not considered itself one of those states hard-hit by unemployment, it is apparent from the March report of the Employment Security Commission that this state has a severe unemployment problem.

The report covering the month of March showed that an average of 47,700 checks a week were written for jobless workers in this state eligible to collect unemployment insurance in any given week there are other jobless workers who for one reason or another are not eligible for such payments. The figure of 47,700 would represent only a portion of North Carolina's unemployed.

During the month the ratio of unemployment to the total number of workers covered by unemployment insurance was 5.3 per cent. While this ratio is not favorable, there has been no great to-do in the state about unemployment in recent months.

Perhaps one contributing factor to the seeming lack of public concern over the matter is that North Carolina has become accustomed to high unemployment at some seasons of the year. Because of seasonal employment which is so much a part of the economic picture in specific sections of the state, there are also high and low levels of unemployment.

The situation reflected in the unemployment figures for March constitutes one of the major economic problems North Carolina faces. The need for more year-round jobs is acute in many communities. Although the unemployment figures for the state may not fluctuate sharply from one year to the next in any given month, they do change sharply from one season of the year to the next.

North Carolina will never realize its economic potential until it finds a way to eliminate much of the seasonal unemployment which now plagues many areas of the state.

# Where Is The Competition?

**WASHINGTON (AP)** — If you and your neighbors were selling eggs and you raised your prices, you wouldn't stay in business long unless you cut your prices back to their level.

That seems simple enough. It would be in keeping with the ancient spirit — often observed more in talk than in practice — of free, competitive enterprise.

But that isn't the way the steel industry plays it. This week when the U. S. Steel Corp. boosted prices its competitors might have cleaned up by not raising prices. To the contrary, most of them followed U. S. Steel like sheep. Within three days eight companies had put in raises.

This was asking for a fight with President Kennedy who, because of the special circumstances surrounding this situation, couldn't take it lying down. And he didn't.

His brother, Atty. Gen. Robert F. Kennedy, is going after the steel industry. A federal grand jury will now investigate this round of price increases. Kennedy said his department is checking into two questions:

1. Did the steel companies get together to raise prices? If they did, he said, it would be a violation of law.
2. Should the U. S. Steel Corp. be broken up because it's too big? Kennedy said it should if it's so big it controls industry prices.

Big Steel walked into this fight with its eyes open. It well knows the Kennedy administration has been taking action against price-fixing and monopoly in many directions.

Only last year one of the biggest scandals in American industry was exposed.

**HATRED PUNISHES ITSELF**  
Hatred is not only an evil — it is a hurtful and devastating evil. Singularly enough it damages the person who entertains the hate more than it does the object of that hatred. The human beings who set out to hate another human being end up by gathering to themselves a tremendous amount of misery. No matter if their hatred results in "success," the price they have to pay for the fulfillment of their desire has been too great. They have injured themselves more than they can possibly have injured anyone else.

What is true in the case of individuals is likewise true internationally. One of the most inspiring circumstances in world affairs is that there is neither a gun, a fortress, nor a

distrial history rolled to a sordid end.

After government prosecution for price-fixing and bid-rigging 29 giant electric equipment companies were fined, seven of their executives were jailed, and 45 others were fined. This was initiated during the Eisenhower administration.

The President, who wanted the industry and the Steelworkers' Union to sign a noninflationary contract, thought that's what had been done. So did the rest of the country because there was no hint or suggestion from the steel industry it had a price increase in mind.

But at least U. S. Steel must have been preparing for it. The union reminded by a contract which provided some benefits but no pay raise. Within five days U. S. Steel boosted prices. By Thursday night, so had seven other companies. But not all did.

This explains why the President attacked the steel industry with so much anger Wednesday.

Thursday Roger Blough, chairman of the board of U. S. Steel, was reminded by reporters that two large steel companies have not yet raised prices.

He was asked how long his company could stick to its price increase if these two kept their price where it was. He said: "It would certainly affect us. And I don't know how long we can maintain our position."

Which raises a question the federal grand jury will probably want an answer to: If all the other steel companies had refused to go along with U. S. Steel in raising prices, how long, in view of what Blough said, would the giant of the industry dared to have kept its new price?

How many streets would be happier if the people who lived along those streets could learn the lesson that hate defeats its own ends, that it has a terrific kick-back, that it damages the hater worse than his victim.

I do consider my philosophy a Christian one and would cite the parable of the fig tree in which Christ chastized man for his unfruitfulness. In a democratic society we must be willing to face the fact that not all fruit is good, but who is to say what is and what is not. If these pious critics were as creative as the people whom they seek to silence, then pornography would perish.

If our people were to be taught to think creatively and philosophically, in our schools, then discretion would deal the death blow to trash. Let us take the mote from our own eyes before we remove the beam from our neighbor, and let me congratulate the city council on its wise and fair decision. Let the twist be replaced by ballet; rock and roll, by Beethoven symphonies; and prejudice by academic honesty.

With appropriate fanfare, hoopla and celebrations by bearded and costumed townsfolk at six stops en route—the General will puff and puff back to Chattanooga—the city which was its home in retirement for many years.

The story of the General is the story of the Andrews raid.

It was on April 12, 1862, that 21 members of the Ohio Volunteer Infantry — led by professional spy James Andrews — stole the General at Big Shanty, Va., just north of Marietta.

Their mission was to burn all railroad bridges and cut all telegraph lines in their wake, to isolate Atlanta.

The plan was foiled by William A. Fuller, young conductor for the Georgia-owned Western & Atlantic Railroad. He led his crewmen in pursuit of the stolen General—first on foot, then by handcar and, finally, in a relay of three other locomotives.

The Confederates overtook the General, out of wood, water and oil, near Ringgold, Ga., just south of Chattanooga. Its crewmen, who didn't have time to burn a bridge, fled into the woods and soon were rounded up. Eight of them, including Andrews himself, were hanged and now lie buried in Chattanooga's National Cemetery.

Nineteen of the raiders were awarded the nation's first Medals of Honor. Had their plan succeeded, some experts say, they would have shortened the war by three years.

The General won't burn wood this trip. It will generate its steam from fuel oil. And it will have brakes, a convenience the General didn't have 100 years ago.

# Dealing With Reality

Politics are amusing but economics deal with realities. Most persons do not care whether the economics are mercantilistic or capitalist or socialist so long as they have work to do, food to eat, clothes to wear and a place to sleep.

When four or five million people are out of jobs, it does not really matter to them too much whether Republicans or Democrats are in power or whether the President is good-looking and well-spoken or silent like Coolidge and homely like Lincoln. They want their chow.

And this is the most pressing issue before the country today. It explains, to a degree, the sudden emergence of unpopularity for the U. N. It explains the opposition to the give-away programs when Western Europe is relatively more prosperous than we are. It explains the large number of dissenting political sects which are arising throughout the country, many of which are based on gibberish but who seek, nevertheless, to express their discontent.

This needs to be studied and analyzed before it becomes so keen a problem as to be extremely difficult to handle. Were the dissent only expressed by illiterate crackpots, it would perhaps not matter so much. But the circulars and letters that come to me are often from professionally-trained persons, from lawyers, doctors, editors and businessmen whose objections ought not to be ignored either by the White House or by Congress. Whereas, General Edwin Walker did not make a favorable impression by his testimony, the kinds of words and ideas which he spoke are constantly being repeated all over the country.

I wish to make this further point: the dissidents are not all anti-Catholics or anti-Semites. Among my correspondents are many Catholics who speak the same language of discontent. The New Orleans experience is not novel; it is only more articulate.

What are the principal causes of dissent?

Of course, I omit the anti-Catholic issue which is likely to exist in an essentially Protestant country. Nevertheless, it cannot be ignored. I recently wrote an article about the POAO, the Protestant organization which takes the same position as President Kennedy on using tax-money for parochial schools. The response to my article was quite different from the stated policy of POAO. It was a 18th Century attack on Catholicism with out-of-context quotations from the Bible to prove a point.

But the discontent is principally economic and while President Kennedy remains popular, the attack is "on the men around him," who are accused of being too young, too inexperienced, too many from Harvard "who do not know the rest of the country," too many Keynesian economists, etc., etc. The President's Cabinet does not give him political strength, although it should.

For instance, the President's transportation plan is rational and important. The idea goes way back to when Herbert Hoover was Secretary of Commerce. The duplication in railroading, a product of 19th Century concept of competition, was already beginning to show the signs of social and economic corrosion. The plan to unify railroads went through the House of Representatives but was killed by liberal Republicans in the Senate.

Subsequently, the railroads themselves attempted to solve the problem of waste trackage and the competition not only with each other but with good roads, motor lorries, airplanes and motor buses, and private automobiles. It became a question of cost accounting. The roads became wider, the lorries and buses became larger, the jet planes became smaller—the transportation system of the United States, from an economic standpoint, is fairly crazy. This was pointed out by the Hoover Commission's task force dealing with this subject (Continued on page six)

# Lookaheads In Business Trends

By ELMER ROESSNER  
Here are more look-aheads in business, based on analyses of developing trends:

**Surge in industrial spending:** The new tax bill providing a tax deduction equal to 7 percent of spending for new equipment (but not buildings) is already stimulating spending for industrial sinews. However, the big surge will come after the bill is passed. (It was planned that way). The tax benefit (it will later be called a loophole) can completely offset a tax liability up to \$25,000, one tax service estimates. And the total pudding can be worth \$2 billion to business.

**Tobacco repercussions:** American tobacco stocks and prices of leaf tobacco are under heavy pressure because of the British anti-cigarette campaign. British consumption of tobacco is sliding and—what's worse to American growers and stockholders—the cancer scare may spread to the continent.

**PUBLIC POWER FIGHT TO TOUGHEN**  
A louder outcry against public power is coming. The rea-

son is this: many power projects are operating on 50-year Federal licenses, which begin to expire in 1968, and so will give the government an opportunity to take over. In anticipation, private power companies will step up their fight against government power. A publicity windfall has dropped into the private-power companies' lap: The Bonneville (Ore.) Power Administration has just shown up with its fourth annual deficit—\$15.3 million.

**More male style consciousness:** Dun & Bradstreet, Esquire and other authorities see a rising male interest in fashions. Easter is giving the trend a shove, and so has John F. Kennedy's ability to wear clothes well. Retailers expect greater style discrimination (and consequent higher turnover) to be a long-term trend in the men's market.

**PATENTED PATENT ISSUING**  
Automatic patents: Not many inventors know that the Patent Office is trying to go automa-

ic. When this is done, the claims for an invention will be coded and fed into an electronic machine that will tell IN SECONDS whether the invention infringes on others. This will eliminate months of file-by-file comparisons. The plans are ready, machines are in the making and President Kennedy will soon ask Congress to speed appropriation of necessary funds.

**Alligatorweed relief:** Alligatorweed is one of the most troublesome pests of Southern waterways. Now the U. S. Department of Agriculture thinks it has found some South American insects that devour the weed and is experimenting. If things work out, the insects will wipe out the weed and then die themselves because there is no more food left.

**Watch state, local spending:** Federal spending is rising. But state and local spending is going up faster. If seeking contracts for goods or services, don't ignore these close-to-home opportunities. In many cases, local conventions (that's

graft, son) will have to be met, so if you are squeamish or honest, forget about it.

**OLD PROMOTER PROPOSES SOLUTION TO URBAN JAMS**  
There was a gleam in the Old Promoter's eye when he dropped in today.

"I have solved the problem of downtown traffic congestion!" he announced. "Bravo!" I said, "Tell!"

"I proposed running electric conveyances down the middle of the streets from outlying settlements to the heart of town. These will carry ten times as many people as private cars can, and twice as many as the buses can. We can eliminate all of the autos and most of the buses and still get people to work and home again faster than they can tool through traffic jams today."

"Sounds fine!" I said. "And what are you going to call these mass transportation, high speed vehicles?"

"Street cars," he said.

The jet plane is a pleasant advantage, but it is uneconomical. The supersonic airplane will be beyond economic possibility.

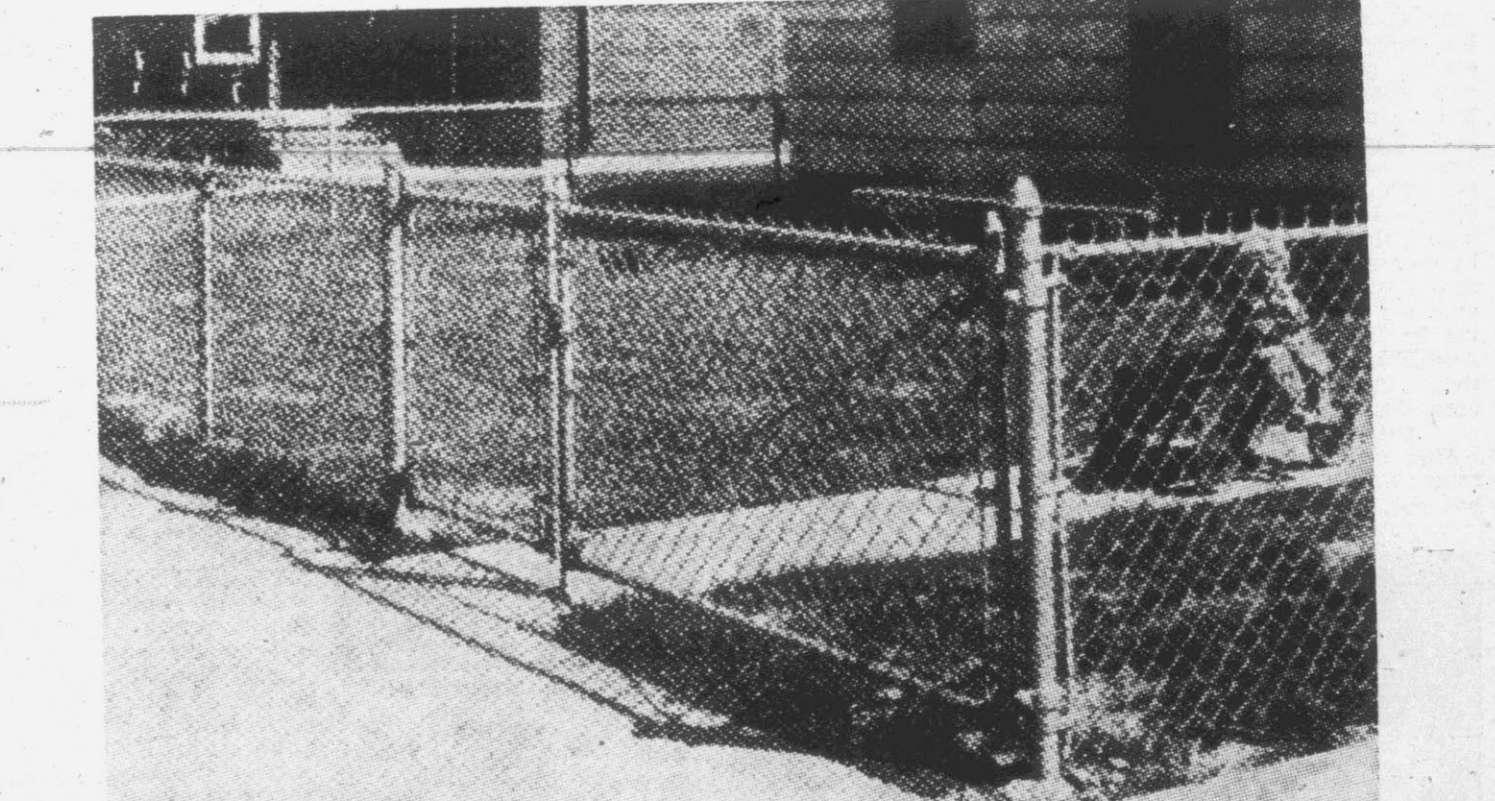

# Reviews And Reflections

By JIM POINDEXTER

It has been interesting to note the reviews of Reynolds Price's "A Long and Happy Life" which have appeared in this country and in England.

One who has read the book might wonder at Oxford dons and Fleet Street pundits make of the dialect and country humor of this North Carolina writer. Well, they eat it up, especially the starchy Times Literary Supplement of London, which has high praise for the "richly funny moments" in the story. More than that, its reviewer is reminded by the heroine, Rosalind, of a plain country girl of Miranda in Shakespeare's "Tempest."

By contrast, the New Yorker has savagely flayed what it considers Price's arty overwriting and imitativeness of Faulkner's convoluted style. One familiar with the book can only be puzzled by the latter accusation. Price's talent is genuine, his style is his own, and he has written one of the best novels to come out of North Carolina.

**Critical Blindness**  
Of course, each critic has a right to his opinion, no matter how blind. And even the best can be blind sometimes. For example, Roscoe Drummond is a seasoned critic of political affairs and books. Yet he surely had an off day when he recently said the following about Dick Nixon's "Six Crises": "Mr. Nixon has a lot of things to say and he says them cogently."

If one can judge from the excerpts from this work which have appeared in Life, Mr. Nixon does indeed have a lot of things to say. Unfortunately, too many of them seem to be rather plaintive attempts at self-justification and ego-building, giving the work a tone like that of the memoirs of a slipping matinee idol. If Mr. Nixon were in a position of authority, one would be frightened by his manifest lack of inner security. As it is, a reader can only be embarrassed for him.

**Last Mention**  
Somewhat, a reference to Walker Percy's "The Moviegoer" seems to creep in here every week. This is the last one, and it is merely to say that this novel, which we have finally gotten hold of, is beautifully executed, although it must be among the most pessimistic works in American fiction. It is definitely for readers who admire good writing and definitely not for those who are looking for a bit of inspiration and uplift in the stories which they read. It is also not for those who demand the message plain, since Percy develops his meaning in the most subtle—even baffling—fashion.

**Art and Life**  
As Oscar Wilde once said, life tends to imitate art. According to Atlas magazine, a case illustrating this epigram has recently come up in England. There, the extremely solemn group, as well they should be, who are agitating for nuclear disarmament have suggested that wives whose husbands are politically influential should withhold their affections until the husbands start working for the cause. The plot of Aristophanes' "Lysistrata" in the 5th Century B. C. was based upon this stratagem. It failed.

**Original Scholarship**  
After many years of original research, W. S. Baring-Gould has published "Sherlock Hol-

mes of Baker Street," probably the definitive biography of the great detective.

It is Baring-Gould's theory that Holmes was so deeply influenced by Lewis Carroll, author of "Alice in Wonderland," and a college mate, that he decided to pull a great hoax and appear before the world as a fictional character. With this purpose, he had his friend, Dr. John Watson, write up his cases which were sold to publishers by A. Conan Doyle, his literary agent.

Baring-Gould unravels many mysteries about Holmes which have baffled scholars, including his lost years in the Far East and an obscure love affair which produced a son, now living in New York. Here is biography that reads like fiction. That undoubtedly would please Holmes, were he still alive.

# Speight Art Show Attracts Many Visitors

Francis Speight's paintings, now on exhibition at East Carolina College, are attracting visitors from many parts of the state to the Hallway Gallery, Rawl building, on the campus here. The art show, open to the public through April 14, is presented by the college Department of Art as a major event in its cultural program for the year.

A North Carolinian and an internationally famous painter, now artist-in-residence at East Carolina College, Speight returned to his native state after a long absence, when he joined the faculty of the college last September. As a distinguished professor of art for thirty years at the noted Pennsylvania Academy of Fine Arts and as a painter whose works are displayed in more than four hundred galleries and museums in the United States and Canada and in a number of private collections throughout the country, he has received a warm welcome here from "home folks" and from students and art lovers.

Interest in the current exhibition of his work is evidenced by visitors to the Hallway Gallery from his native North Carolina, representatives of the State Museum of Art in Raleigh; members of the Greenville Art Center; students and faculty members at the college, and other admirers of his work.

The exhibition at East Carolina College affords an opportunity of seeing the works of the North Carolina artist to those who missed the "Francis Speight Retrospective Exhibition" at the N. C. State Museum in Raleigh, Feb. 15-March 25, 1961. This loan show, including works by Speight from museums and private collections, attracted national attention and was viewed by people from a wide area in the United States.

Speight Homestead, Bertie County, and "Canal Street" represent his early work as an artist. "Beside the Road, Roxboro," and "View at San Souci Ferry, Bertie County" were painted since Speight joined the East Carolina faculty last fall.

Included also in the exhibition, in addition to the oil paintings which are most characteristic of Speight's work, are several watercolors and drawings. Among these is a drawing, an appealing study of his wife, Sara Blakeslee Speight, who is also an accomplished artist.

"Straw for the City's Horses," a large canvas, is among the paintings included in the exhibition at the college. This work was awarded in 1940 the Jennie Sessan Medal for Landscape by the Pennsylvania Academy of Fine Arts.

Other paintings included in the exhibition are evidence of the artist's residence in Pennsylvania and of his interest in his native state. Among these are "Sans Souci Ferry" (1960) and "Along the Tracks, Statesville, N. C." (1928); and "Schuykill River at Manayunk" (1956); "Autumn, Applebachville, Pa." (1938); and "11th Street, Philadelphia" (1937).

Since coming to Greenville last fall, Speight has spent a large part of his time painting in various parts of North Carolina. Almost any fine day, especially when the cloud effects in which he is particularly interested are there to be painted, Mr. and Mrs. Speight take off from their home on the corner of Fifth and Greene streets, Greenville, and travel here, there, and yonder to work. He has been particularly interested in scenes in his native Bertie County and has spent many days there with brush and palette in hand.

Speight paints with his eye on the object. One cold, damp day between winter and spring, for example, a large group congregated at the corner of Cotanche and Fifth Street, Greenville, with Speight as center of interest. Shivering, with the collar of his overcoat upturned, he was painting a city scene, while a group of curious citizens and college students, unaccustomed to such artistic activity, gaped at the artist. Speight has been a little way off of downtown work since then.

Shortly ago, he appeared on the East Carolina College TV program "Let's Go to College," discussed the impetus to paint this city street intersection, and demonstrated his methods of work. Speight is a representational painter. He has respect for, and is interested in, the modern abstract, and other approaches. But most of his work has shown a mastery of design, color, and technique in paintings combining realism with imagination. Many of his works are based on scenes in which the lines and angles of buildings—witness his "The Old Mill" in the East Carolina Exhibition—provide the design and a masterful use of color and contrast in light and shade are chief characteristics.

An artist who is described as having "rare genius" and as "unexcelled among native North Carolina artists," Speight has won recognition through a number of outstanding awards and prizes. In 1960, the Pennsylvania Academy of Fine Arts granted him its highest award, the Academy Gold Medal of Honor. Among prizes presented to him in national exhibitions of painting, in addition to the Sessan medal, are the First Altman Prize, the First Hallgarten Prize, the Kohnstamm Prize, and the Oberg Prize.

His work is included in the permanent collections of the Metropolitan Museum, New York; the Boston Museum; the Toronto, Canada, Art Gallery; the Norton Gallery of Art, Palm Beach, Florida; the Montpelier, Vermont, Museum of Art; and elsewhere. Speight has been a member of the National Academy of Design since 1940. In 1960 the select National Institute of Arts and Letters elected him to membership. He is listed in Who's Who in America and in the Encyclopedia Britannica, in which one of his works is reproduced.
