Humber To Head Area Commission Elected Chairman Of Six-County Development Ass'n Here Last Night

Greenville's Robert L. Humber, one of three Pitt County members of the Coastal Plain Planning and Development Commission, was elected chairman of the six-county development association at a meeting here Thursday night.

Named to serve with Humber as officers of the organization were Vice Chairman Sherwood L. Roberson, mayor of Robersonville and a member of Martin County's representation trio; and Mrs. McDonald Gautier Jr. of Washington, secretary. Mrs. Gautier is among Beaufort County's delegation.

In addition to electing officers, forming a nominating committee and attending to other organizational matters, the 18-member board heard brief addresses from two state officials.

John Crawford of N. C. State College in Raleigh and George M. Stephens Jr., also of Raleigh, spoke to the group. Crawford is a leader in the development of area organizations similar to CPP&DC.

Nash County Sen. Dallas Alford of Rocky Mount, chairman of the steering committee which shaped the organization, presided at the meeting until Humber was elected.

Scheduled to meet in Greenville next Wednesday is the

nominating committee appointed last night and composed of the chairman of the six counties' board of commissioners.

They include B. Alton Gardner of near Ayden, Pitt County; Sam T. Moore of Washington, Beaufort County; R. M. Fountain of Tarboro, Edgecombe County; John Henry Edwards Sr. of Williamston, Martin County; Henry M. Milgrom of Battleboro, Nash County; and Thomas Daniel of Wilson, Wilson County.

Duties of the nominating committee include proposing membership from the six-county area's citizenry for the commission's eight basic committees: agricultural, industrial, education and culture, youth, community development, recreation and travel and finance.

In accepting his chairmanship, Humber told the meeting: "The paramount obligation of us all is to unite our energies, cooperate and create complete harmony in our endeavors."

In commenting further on the mission of CPP&DC today, Humber said: "The potential service that this commission can render to Eastern North Carolina is tremendous in every field of human interest. It deserves, and I am sure that it will receive, the personal support of the citizens of the entire area."

"The program envisions a wide scope of development and the commission solicits suggestions from all citizens as to programs that should be examined and implemented by the commission."

Gov't Bureau Endorses Plea To CAB On Area Air Service

Greenville has received support of the federal government's Bureau of Economic Regulation in its fight to have the Civil Aeronautics Board reconsider area air service for Eastern North Carolina.

Counsel W. W. Speight said the Bureau of Economic Regulation has filed a reply with the CAB upholding Greenville's position.

The reply did not support the Greenville petition asking a stay of air service awarded Eastern Carolina cities. However, it did ask that the board award the service only on condition that the CAB conduct an investigation to determine whether or not all service shouldn't be rendered from one central airport to serve an area in Eastern North Carolina within a 50 mile radius.

Speight said he was informed of this new development in the long and spirited air service fight by his associate counsel in Washington, D. C. this morning.

The bureau reply followed a joint statement filed by Goldsboro, Rocky Mount and Kinston which accused Greenville of trying to deprive them "for an indefinite period" of air service granted in a Piedmont area decision.

Their statement came after Greenville filed its petition asking that the CAB stay awards of service to the three cities, or condition them on their cooperation in the establishment of an area airport in Eastern North Carolina.

Wilson-Greenville had jointly requested air service in the CAB's Piedmont Local Service Area investigation and service

was recommended by the CAB hearing examiner. However, when the CAB's decision was handed down recently Wilson-Greenville was denied service. Piedmont Air Line stops were awarded to Rocky Mount, Goldsboro and Kinston in this area.

Subsequently, Wilson announced that it was accepting the CAB decision and thus that city was not a party to Greenville's petition for reconsideration.

Rocky Mount has approached Wilson with a plan for constructing a joint airport between those two cities.

Meanwhile Greenville was continuing plans to move ahead with its request for reconsideration.

"We plan to go forward with our petition and motion before the CAB and request that the hearing examiners' decision be upheld," Speight said.

"It is understandable why the cities which have been awarded service don't wish that service to be delayed. However, our interest here is in obtaining service not only for Greenville but for a real area airport that will serve all of Eastern North Carolina.

"We are convinced that our position is in accordance with the announced policy of the CAB and FAA and endorsed by the President of the United States in his message to Congress of April 5. In this message he commended the area airport concept.

"We plan to go all the way and we feel that in the end our position will be shown to be sound and in accordance with policies laid down by these two boards.

"We are very fortunate in having as our ally in this fight down to the wire, the aid, assistance and support of Congressman Herbert C. Bonner."

Speight cited statements made by Rep. Bonner in the April 17 edition of the "Congressional Record."

In it Bonner pointed to the Eastern Carolina air service situation as being in conflict with the area airport concept advocated by the President.

Bonner pointed out that the Eastern Carolina cities are so situated that a centrally located airport "would make possible a much greater facility of service than is possible at any individual community."

"So far," he said, "neither the Administrator nor the Civil Aeronautics Board, to my knowledge, has given any active consideration to ordering a regional airport for the area.

"I sincerely hope that this government will not spend its money unwisely in building an airport for one city to the exclusion of usefulness to others, particularly where under our Government's announced policy the airport could be constructed as a model area airport."

Ing winds up to 40 miles an hour, swept eastward along the mountains Thursday. Will Walk Out

GENEVA (AP)—Soviet Deputy Foreign Minister Valerian A. Zorin threatened today to walk out of the 17-nation general disarmament conference if the United States conducts atmospheric nuclear weapons tests in the Pacific in the next week or so.

He made the comment to newsmen after a Good Friday session of the disarmament conference.

In the conference room itself Zorin said the American tests would bring about an extremely tense international atmosphere.

U.S. Ambassador Arthur H. Dean made it clear the United States tests undoubtedly will be held because of what he called the unyielding Soviet attitude. Dean said the Soviet Union appears to have killed any chance for a quick agreement on an internationally enforced nuclear weapons tests ban.

Both Dean and British Minister of State Joseph B. Gorder refused a Russian call for an unpoliced moratorium on tests. The Russians remained adamant against international inspection and control.

The United States, Dean said, "has learned its lesson with regard to a voluntary, unpoliced moratorium which can be broken at will by the Soviet Union on any pretext it wishes to dream up."

The Big Three hagled again about the testing question. Then, though Zorin had indicated Thursday he might try to force continued sessions over the weekend, the conference recessed for the Easter holidays. It will reconvene Tuesday.

Zorin told the session the projected American tests would collapse the conference and nobody would forgive the United States and Britain if this happened.

Later, speaking to newsmen, Zorin said the tests "would inflict an irreparable blow to the negotiations." Asked to explain what he meant by irreparable, Zorin said: "There will be no negotiations, that is all."

Foresters Control Vast Fire, But It Will Be Days Before Extinguished

RUTHERFORDTON, N. C. (AP)—A raging forest fire was brought under control early today by firemen, but foresters said it would be another three days before the mountain blaze could be extinguished.

Three bulldozers today cut a two-lane fire breaker around the fire, which has burned an estimated 200-300 acres of woodland. About 100 firemen were still at the scene today battling the fire.

The fire, which burned through a wide stretch in Rutherford and Cleveland counties, destroyed several vacant homes and took the life of a logger. Clinton Herman Hamby, 57, of Rt. 3, Lawndale, was trapped when he went back for his lunch box after the fire, starting from burning sawmill waste, gained headway on Huckleberry Mountain. A companion escaped. The origin of the fire was placed at a point 18 miles southeast of here in the South Mountain range.

Robert Freeman, operator of a forest fire tower in Rutherford County, "I'd say this is a 'Class 5' fire day," he added Thursday.

At one point late Thursday night authorities said pointedly, "We need workers, but no more spectators."

This was one of several fires Thursday in the western part of the state. There were six in Buncombe County, which touches a Western corner of Rutherford County, and one in Lincoln County, which borders on Cleveland County.

Buncombe County fires were reported at Little Mountain near Leicester, in the Cedar Creek section, at Aversy Creek, North Turkey Creek, Mills Gap and Black Mountain.

Five fires were reported in Madison County, one each in Madison and Polk counties. The Lincoln County fire burned an estimated 100 to 125 acres, mostly woodland, between Gastonia and Dallas.

Gen. Salan Captured

ALGIERS (AP) — Fugitive ex-Gen. Raoul Salan, leader of the terrorist Secret Army Organization, was arrested today in the heart of Algiers, French officials announced.

Salan, a 62-year-old army veteran who has served service in virtually all corners of the world was sentenced to death in absentia for the putsch as was his colleague, ex-Gen. Edmond Jouhaud.

When reports spread that Salan was captured, heavy troop reinforcements were concentrated around Reghaia, an air base near Rocher Noir headquarters.

Salan already was aboard a plane bound for Paris when the announcement was made, the spokesman said.

A government official said Salan was taken when riot troops and police sealed off a small section in downtown Algiers and launched a search of cars, buildings and passersby.

Recommend No Action In Death

A coroner's jury last night recommended no criminal action be taken in the death of Herman Lawrence Briley, killed March 16 in the crash of a car near Bethel.

Briley, 18, of Riverview Court, Tarboro, and a second person, 20-year-old Leroy Beach Jr., of Robersonville, were occupants of the vehicle at the time of the crash. Both were thrown clear of the wrecked auto, Briley suffering fatal head injuries and Beach suffering hip and head injuries.

Driver of the car at the time of the fatal crash was not definitely established. Officers testified that Beach told them he drove the car away from the Briley's Tarboro home but "didn't know about who was driving at the time of the collision."

The car was registered in the name of a Tarboro man but was bought by Briley. Briley had no operator's license, Lawmen noted.

In returning their decision the jury stated that they found Briley had died of injuries received in the wreck and recommended "no criminal action be taken against Leroy Beach."

Death Climaxes Racial Disorder

AUGUSTA, Ga. (AP)—Police clamped a tight security lid on this east Georgia city today after the fatal shooting of one white teen-ager and the wounding of another in a predominantly Negro section.

Seventeen persons, including 14 teen-agers, both white and Negro, were arrested. Extra-duty policemen, seeking to stem a four-day tide of racial disorder, rounded up carloads of youths carrying knives, clubs and iron pipe.

The slaying victim was Leslie Lee Luttes, 16. He was killed Thursday night by a pistol bullet under the left eye and was peppered in the back of the head by a shotgun charge.

Luttes was sitting beside George Lewis, 15, driver of a car in which three youths were riding. Lewis was wounded by the shotgun fire. Eddie Gay, 16, on the back seat, escaped injury.

Police said they found an air rifle and a sack of rocks in the car, owned by Gay's father. Gay said he and his companions were going to a miniature golf course and lost their way. The shots came without warning, he said, and the other two boys slumped in the seat.

Gay drove to a funeral home

where an ambulance took the wounded boys to a hospital. Luttes already was dead. Detective E. F. Beasley said Lewis suffered shotgun wounds of the face, neck and hands.

Shortly after the shooting, Mayor Millard Beckum made a television appeal for calmness and pledged full police resources to maintain order.

There were numerous arrests during the night, but Police Lt. M. C. Watkins said none were in connection with the shooting. Among those arrested were two Negro men and a Negro woman who were in a car which contained a shotgun. They were booked on a charge of late hours and having a weapon, Watkins said.

Seven white youths and five Negroes were arrested during the night and earlier in the day on various charges, mostly loitering and carrying weapons.

Some of the white youths had been cruising through Negro areas where there had been reports of windows broken by rocks and dented automobile fenders, Watkins said.

Pilot Trapped In 'Warmup' X-15 Flight

EDWARDS AIR FORCE BASE, Calif. (AP)—Test pilot Joe Walker took the X15 on what was described as a warmup flight to 150,000 feet and 3,920 miles an hour and returned safely—to find himself trapped.

After the black rocket ship skidded to a landing on a dry lake bed here Thursday, Walker radioed: "I can't get the lid open!" His cockpit canopy was stuck. Technicians pried it open with a tool predated the space age—a screwdriver.

The flight was a preliminary to planned X15 trips to nearly 50 miles in space. It was made to test a new emergency control system scientists think may be needed at extreme altitudes.

Walker termed the test 100 per cent successful. Officials said the flight means the X15 will be able to try for a new altitude record, 250,000 feet, within the next two weeks.

Republicans Blast JFK Action On Steel Prices

WASHINGTON (AP)—Republican congressional leaders have unloaded some of their sharpest criticism of President Kennedy since he took office, claiming he used police state methods to "blackjack" steel companies into rescinding a price increase.

In a formal statement released Thursday, they charged Kennedy with ordering or supporting nine actions last week that "imperiled basic American rights, went far beyond the law, and were more characteristic of a police state than a free government."

These "punitive, heavy handed and frightening" actions amounted to "a display of naked political power never before seen in this nation," said the statement issued on behalf of Senate Republican Leader Everett M. Dirksen of Illinois, House GOP Leader Charles A. Halleck of Indiana and other GOP leaders in Congress.

uncanny ability to get on the wrong side of major issues. "Eight companies announced \$6-a-ton price increases last week but later backed down in the face of strong opposition from the President, who said such increases were not in the public interest.

"We condone nothing in the actions of the steel companies' except their right to make an economic judgement without massive retaliation by the federal government."

"Temporarily President Kennedy may have won a political victory, but at the cost of doing violence to the fundamental precepts of a free society. "This nation must realize that we have passed within the shadow of police state methods."

Old Civil Action Is Finally Removed From Docket

Court officials reflected on a half-century of Pitt County judicial history this week as Judge Joseph W. Parker ordered a 49-year-old civil action off the civil issue docket.

les J. O'Hagan Sr. and Adelaide Johnson, was brought in behalf of the late Mr. O'Hagan in 1913 by a 30-year-old Greenville attorney, Albion Dunn, and a former first district congressman, Col. Harry Skinner.

Judge Dunn, now 79, was on hand as the half-century-old action was finally laid to rest.

O'Hagan was accorded use of the land during his lifetime. At his death, it was to pass along to his heir, if any. It would be divided among certain "contingent remaindermen" if O'Hagan had no heir.

The action was instituted to determine whether it would be legal to sell the land and treat the receipts according to the will's provisions. Superior Court Judge Oliver Allen of Kinston

who died about 10 years later, ordered the property sold.

To add authority to the deeds for the purchase land, the defense attorney, the late U. S. District Judge Don Gilliam, appealed to the Supreme Court. On page 197 of Book 163, Supreme Court Justice Allen, who wrote the opinion, affirmed the lower court's ruling.

Judge Allen recalls the property sold for about \$18,000, which was deposited under the trusteeship of the Greenville Banking and Trust Co. (later Guaranty, then Wachovia). O'Hagan was paid interest on the funds throughout his life.

His sole heir, Charles J. O'Hagan Jr., signed a receipt for the money in 1943, following his father's death. The case remained officially unsettled on the civil issue docket because the trustee was required to file annual reports in the court.

South Carolina Electrocutes 2

COLUMBIA, S. C. (AP) — A rapist and a murderer, both from Greenville County, died in South Carolina's electric chair early today.

Executed on Good Friday were Douglas Clee Thorne, 26-year-old white man convicted of rape, and Ray Landy Young, 30-year-old Negro convicted of killing a Greenville liquor store operator.

Thorne was the first to be executed and Young followed him to the chair.

In addition to the O'Hagan case, 22 more civil actions which had been previously settled were ordered off the docket by Judge Parker.

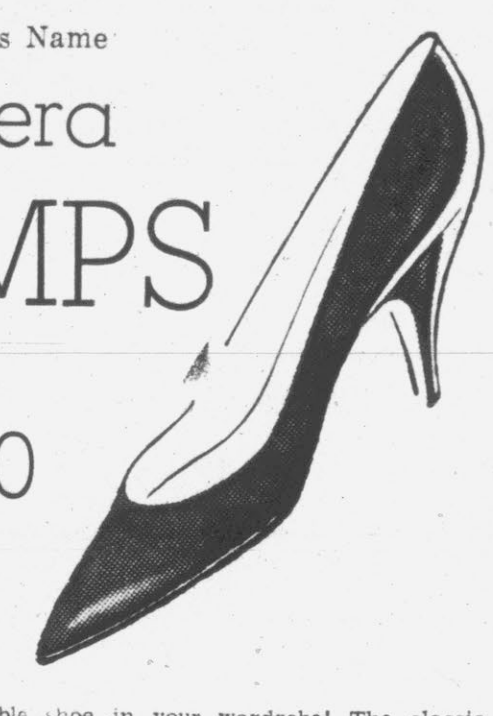

Serve A Dish Guests Don't Expect

WHAT MAKES a good hostess? Want to enter the ranks of this particular Elysian Field? Then no matter how much earnest labor you put into the preparation of a company meal, serve it with a light heart and a warm welcome.

Our next suggestion: offer at least one combination of food your guests are NOT expecting. There's nothing like the element of surprise, if it's interesting and inviting, to give a fillip to a party.

Take good old baked ham. Its usual accompaniment is candied sweet or scalloped regular potatoes. Once in a while depart from this theme. Offer a new-for-your-house goalong, then when that becomes tried, true and familiar, go on to some other combination.

Some time ago we discovered that Noodles Romanoff was a dish that made a spectacular success when we served it with ham at supper buffets. This is a baked dish of cooked fine noodles, cottage cheese, and sour cream that is seasoned with Worcestershire sauce and onion.

is that combination of cheddar cheese, bread, egg and milk that goes under several names—fondue, strata, puff. Although this is often served by itself as a main dish for lunch or supper, we find its flavors are excellent with ham. Our contribution to this standard recipe is, t. layer pimiento in the fondue and it adds a delectable and interesting note.

Fresh asparagus is great on this menu. Serve it hot if you like; or marinate the cooked spears in a savory French dressing and arrange them on salad greens.

PIMIENTO CHEESE FONDUE
8 slices bread
1 1/2 cups packed-down coarsely grated cheddar cheese
1 can (4 ounces) pimiento drained and cut fine
3 large eggs
1/4 teaspoon salt
1/4 teaspoon white pepper
1/2 teaspoon paprika
2 cups milk
Trim crusts from bread; place 4 slices in the bottom of a baking dish (about 8 by 8 by 2 inches). Sprinkle with cheese and pimiento. Arrange remaining 4 slices bread over top. Beat eggs until foamy; add salt, pepper, paprika and milk; beat to combine; pour over bread, pimiento

and cheese. Bake in a moderate (350 degrees) oven until golden brown—about 45 minutes. Serve at once. Sides of fondue should be crusty, inside custardy. Makes 6 to 8 servings as a meat accompaniment, 4 large servings if offered as a main dish. For a large group, double the recipe but bake in two dishes.

Small Apartment Can Mean Easier Life For Oldster

NEW YORK — (WNS) — An oldster moving from larger quarters to a one-room apartment may find the storage problem difficult. However, with planning, the move can usher in a new and easier way of life.

Though possessions may date from years back, decisions must be made: what to keep, what to dispose of, how to find places for what remains.

Widowed sisters took apartments in the same building. The older disposed of the minimum of furnishings and possessions. She took as much with her as she could possibly squeeze in.

"I know I can't keep it all. But I have to live with it before I know what I can live without," she explained.

Care Of Gloves Before Storage

Before packing winter gloves away, give them an especially thorough washing. Launder lined leather gloves like "plain" leather—on your hands, using plenty of lukewarm soap or detergent suds. When the leather "shell" is clean, turn the gloves inside out and squeeze the suds through the fabric lining.

Rinse both sides thoroughly, blot in a towel, and gently massage the leather between your fingers while it is still somewhat damp to restore its suppleness.

MUNICH, Germany—(WNS)—There is nothing like falling in love to cure anemia and liver complaint, according to Dr. Ernst Selzner. He has demonstrated to university students here that kissing, when sincere, can enrich the blood, accelerate the heart, and tune up the system.

However, kissing should be avoided immediately after heavy meals because it is bad for the digestion, he said. It can provoke spasms in the stomach and encourage a temporary diminution of gastric juices.

He stressed the necessity of knowing how to read labels, in order to get the best value for the purpose for which the food was to be used.

Mr. Ratcliffe advised that the best way to save money, was to plan meals ahead, so that in the store, items would not be chosen at random from the shelves, but chosen with the knowledge of what each would be used for. It is not always necessary to have the top brand in order to have the same food values. The choice depends upon the dish in which the food is to be used. For instance, one would not need the top quality merchandise for use in a casserole dish, while, if a salad were planned, appearance would be an important consideration, and firm, well colored fruit or vegetables would be more acceptable.

He explained that certain items like Dried Milk had an expiration date, and one should read the label to be informed about this.

Mr. Ratcliffe had a large display of goods on hand. Many of the cans were opened to show at first hand, the difference in the value of the various grades and brands.

These opened goods were later given as door prizes, with pies, bread also; These consisted of fruits and vegetables.

In many cases the differences in canned fruit, depended not only upon the color and appearance, but on the syrup in which it was packed—either heavy or light.

He displayed pineapple, pears, peaches, fruit cocktail, asparagus, tomatoes, baked beans, vienna sausage, dried milk, and talked about all the other items in his display, explaining the value of each.

He advised about items for summer cooking and showed how each grade had its own place in the menu. Mr. Ratcliffe's final advice was—read the label before you buy in order to save cents by having Sense.

Area Goal Backed By The Record

Attorneys for the cities of Kinston, Goldsboro and Rocky Mount have pointed the accusing finger at Greenville with the assertion that " . . . Greenville alone, under the pretense of area needs as opposed to civic pride, seeks to delay vital air service to her sister communities."

The statement refers, of course, to the action of Greenville in asking reconsideration of the recent CAB decision in the Piedmont Airlines case in which air service was denied a joint Wilson-Greenville request.

Contrary to what the statement of these three other cities implies, there is nothing vindictive in action which Greenville has taken, and certainly there can be no justified criticism for the action of asking reconsideration of the decision. Otherwise why would the CAB regulations provide for such a course following announcement of its decisions? It is obvious, we think, that had the shoe been on the other foot one or more of the cities that now so piously rap Greenville's action would have asked for reconsideration.

The statement of Kinston, Goldsboro and Rocky Mount also asserts that the joint effort by Wilson

and Greenville was undertaken "seeking service only for their own communities" rather than for the avowed purpose of acquiring an area air facility for this section of the state.

Such a statement is, in our opinion, wholly without foundation.

Greenville, in the past decade, has participated in every effort in this area of the state pointed toward an area airport. It should not be necessary to remind the outspoken attorneys of the three cities that at one time or another each of the communities they represent has given consideration to a joint air facility only to pull out of the effort to adopt a go-it-alone attitude. The decision not to cooperate in seeking to bring a joint air facility to reality was theirs, not Greenville's or Wilson's.

Greenville in the past has not undertaken any effort for area air service under false pretense, and it is not doing so now.

Pitt Products Could Well Get Emphasis

The state-wide promotion by the C & D to attract attention to North Carolina products is an undertaking in which most communities of the state could profitably participate.

During the week set aside for the event, stores, restaurants and other business places are being asked to give the red carpet treatment to items produced in North Carolina. It affords an opportunity for each community and county to emphasize at the same time products which are produced in its immediate area.

The program is pointed toward making Tar Heels more aware of the items produced in their own state with the idea that the greater the volume of sales items, the more the economy of the state will be strengthened. It follows also, that the greater the volume of sales of an item produced in a community or a county, the greater the economy of that smaller area is also strengthened.

Pitt County should exert every possible effort to generate participation of local business concerns in the state-wide project. In doing so it would be only natural to give proper emphasis to items produced in this county.

The broad array of items which would bear the "made in Pitt County" label would probably surprise many people who consider themselves thoroughly familiar with the economy of the county and what is produced here. It may take considerable effort on the part of many citizens to arrange a number of creditable displays of items produced in Pitt, but it would be a worthwhile undertaking.

We are confident the Pitt Development Commission would find the development groups of individual communities as well as manufacturers and producers most cooperative in arranging such displays.

So Much Tied To Cold War

WASHINGTON (AP) — Day to day living in America seems as broad as American life and yet one event after another demonstrates how much this life is shaped by forces far beyond America.

One example was President Kennedy's news conference Wednesday when so many wide-ranging questions seemed unrelated—steel, business, disarmament, labor, prices, profits, Berlin, nuclear tests, campaign costs.

Yet, almost all were interlocked and hinged on the cold war with communism even when there seemed no connection and communism wasn't mentioned.

The same holds true in one after another of these meetings between the President and the press.

He started off Wednesday's session by saying a new American disarmament plan had just been outlined to the Russians at Geneva. Here the cold war connection was direct and obvious.

He followed this with a statement on his conflict with the steel industry—a conflict he won when steel backed down on his price increase—and how he has no ill-will toward the men responsible for the short-lived price boost.

He acknowledged the need of American business to make profits and said, "There can be no room on either side in this country at this time for any feelings of hostility or vindictiveness."

But his reasons for not wanting a price spiral to start at this time, when he's trying to keep the economy on an even keel, are rooted in the cold war. The United States is up to its neck in spending on armaments.

A general increase in living costs, meaning also increased defense costs, would jeopardize the economy and boost govern-

ment expenses, at a time when the United States must stay financially sound to cope with communism and meet its commitments around the world.

Further, higher prices would cripple this country's ability to sell abroad, particularly to its allies or in competition with them elsewhere, at the very moment it wants closer trade ties with them.

Greater Western prosperity, particularly American prosperity, is vital in discouraging the ambitions of communism and in stiff-arming it in Asia, Africa and Latin America.

This is an endless chain. There was, of course, a direct cold war link when Kennedy said this country now seems to have no alternative to nuclear testing since Russia wouldn't agree to an effective test ban treaty. The implications here were more grim than his simple statement showed.

Because there is no agreement to test there is no reason to think both sides won't just go on testing and talking about not testing.

France came into the questioning but here, too, it was cold war stuff: How did he feel about sharing nuclear weapons with France? He indicated he was still against it.

West Germany also got into the questioning. This, too, involved the cold war. It was on the problem of reaching a settlement with the Russians on Berlin.

Even Kennedy's announcement of forgiveness for a couple of Army reservists who were critical of his calling them to active duty had a connection with Russia.

It was after talking with Premier Khrushchev, and listening to his warnings about Berlin, that Kennedy called up Reservists to show the Russian this country didn't intend to buckle under.

And for all this he was to be not exalted, accepted, praised, crowned. Instead he was to have a crown of thorns pulled down upon his brow in derision of his kingly claims. He was to be struck over the head by soldiers who bowed before his alleged royalty in mockery. He was to be crucified on a hill outside the city

No wonder he experienced what has come to be called the Agony of Gethsemane. He was human enough to want to avoid this suffering and shame if it could be done consistently with the will of God. But his final words were, "Nevertheless not my will but 'hine be done.'" No wonder there appeared unto him an angel from heaven strengthening him. When people meet life in that spirit God always sends the supporting angels.

We do not know just how the shedding of Christ's blood brings about the forgiveness of our sins, but the assurance of the gospel is that it does just this.

Crucifixion is a divine pattern to which God Himself conformed and to which we must conform if we enter into the fullness of His love.

Hero Of An Anniversary

The postmark confirms all this . . . an occasion of historical significance to the multitude sharing in the production, selling, processing, transporting, and consumption of tobacco, is brought to our attention from New York.

Not Virginia, Not North Carolina, Not South Carolina; and not Georgia.

Still and all, the presentation is good and a reader is bound to find something of particular interest.

Commemorative ceremonies are scheduled in May, at

Jamestown, Va.

You might, and might not, know that John Rolfe is the hero; and he must have been quite a guy.

English colonization efforts failed at Roanoke Island, Newfoundland, Elizabeth's Island in present Massachusetts, and at the mouth of the Kennebec River in Maine.

Jamestown marked the turning of the tide; and Jamestown survived only because John Rolfe developed tobacco as a marketable product.

John is best known for marrying Pocahontas the Indian maid, but his first shipment of tobacco to England in 1612 spelled the difference between a dying colony and one that would last.

That first shipment consisted of only a few hundred

pounds but six years later the colony shipped more than 40,000 pounds. Historians say cleared land was so scarce the people were growing tobacco in Jamestown's muddy streets.

About Rolfe himself, no one knows what he looked like. There are no sketches or illustrations.

Something about his life, aside from his tobacco and Indian interests, are known. Rolfe and his wife sailed from England in 1609 when he was 24 years old. They were shipwrecked at Bermuda, where a daughter was born and died; and reached Jamestown in May 1610 where Mrs. Rolfe soon afterward died.

John asked permission to wed Pocahontas in 1614, and two years later they went to London where Lady Rebecca (as she was known) died in 1617 as she was about to return to Virginia.

A son, Thomas, later followed his father to Virginia and married there. Through him many Americans can trace their ancestry to Pocahontas, including such well-known names as the Bollings and Randolphs.

John Rolfe is believed to have died in an Indian massacre in 1622.

His accomplishments and the subsequent role of tobacco in American history are logical subjects for a big party in Jamestown.

A program is planned, including re-enactment of the planting, packing and loading of the first tobacco crop, sailing a replica of the Susan Constant (one of the original Jamestown ships), unveiling a life-size statue of Queen Elizabeth I, and sundry other affairs.

It sounds tame as contrasted with the high drama of Rolfe's times.

Office Adds To Powers

In retrospect, the only real significance of the case of Kennedy vs Steel is that by a single act the President has expanded the power of his office without legislation. This was attempted by Franklin D. Roosevelt throughout his regime, but no matter where else Roosevelt succeeded, he never actually gained complete control of the economy. The National Recovery Act was an attempt in that direction but the NRA was declared unconstitutional in the *Sick Chicken Case*. It was beyond question a fascistic measure and it is interesting to note that its true nature was not generally recognized until it reached the Supreme Court.

President Kennedy has been able to gain control of the economy because the government is the principal customer of manufactured goods. Roosevelt sought to establish a similar control by creating "yardstick" businesses; that is, companies engaged in manufacturing heavy goods in competition with existing companies. At first it was contemplated that the government would own such companies, but wiser counsel prevailed and loans were made through the Reconstruction Finance Corporation and other agencies to accomplish the same end. The various Kaiser enterprises started that way.

President Kennedy has developed a different concept. The government will neither own nor operate these enterprises, but it will control prices. The United States Steel Corporation precipitated this by its inept and inopportune announcement that it would raise prices. Good public relations indicated that such an announcement would only have been sound after the new wage agreement had been in operation some time and the evidence was clear that the price was insufficient to maintain efficient plant and equipment. The President was able to ignore this question because the industry failed to make it clear to the people. Businessmen usually do not grasp the essence of public relations and therefore failed to prove their point or to have any sense of timing.

The President was able to mobilize his entire Cabinet, particularly the Departments of Justice and Defense to fight this battle which soon enough involved the questions of inflation, of trusts, or cartels to control prices, of defense contracts. It was on the rock of defense contracts that the steel industry split, for if some companies did not receive defense contracts, their production would be trivial. After all, the steel industry was hardest hit during the Depression and was rescued by government contracts and by war.

government contract is rarely beneficial for any business, what with shifting specifications, whimsical controls, and re-negotiations long after the goods have been delivered. Nevertheless, when it is the best business available, it becomes prime. Today, the American steel industry exports about as much steel as is imported. The peril is that we shall import so much steel as to endanger our home industry. This the Department of Defense can hold over the head of the industry. Therefore, companies largely or wholly dependent on government must function on the principle that the customer is always right.

The President has won a victory in the expansion of Presidential powers and has established the fact that his hold on his Cabinet and on Congress is complete, but he has frightened privately-owned enterprise and the private investor beyond anything that had heretofore been experienced. This is a by-product of the President's press conference and his implied attack on profits which did not go over well.

The President does not have Roosevelt's gift of sarcasm. When Roosevelt employed this rhetorical device, it was like a piercing rapier. President Kennedy can display anger but no nastiness. Therefore, his reference to profits only frightened.

Bitter Fight Ahead Over FTC

One of the most bitter fights in Congress will be over President Kennedy's renewed insistence that a law be passed giving the Federal Trade Commission power to issue "cease and desist" orders against suspect business practices pending hearings and final decision.

The bitterness will be deepened by President Kennedy's action in forcing a rollback of steel prices. Opponents of President Kennedy will charge that the FTC proposal is part of an Administration program to straitjacket business. In addition, Congressmen will be under intense pressure from business interests in their own areas who fear the FTC will abuse added powers.

And the coming scrap will not be softened by the fact that there are convincing arguments on both sides of the question.

Under the present law the FTC can bring action against a company or individual suspected of unfair trade practices; for making false claims or granting illegal discounts, for restraining trade and so on.

The accused is given a hearing and eventually is ordered to abandon the questioned practice, or the complaint is dismissed. Decisions may be appealed to Federal courts.

Under the Kennedy proposal, when the FTC makes a complaint it would be allowed to order the accused to cease the practices pending decision.

The arguments against this is that it makes the FTC prosecutor, judge and jury; that it applies penalties even before guilt is established, and that it gives dictatorial powers to the commission.

The loudest argument will be that the proposal would give the Kennedy Administration tremendously more power to shove business around.

It will be pointed out in Congress that if the proposal were broad enough and if it were in effect last week, the FTC could have ordered the steel companies to desist from raising prices until after it had ruled on their legality, which might take a year or two.

WHAT OF LOSSES? It will also be argued that innocent companies could be penalized into bankruptcy by use of this power. A company might be ordered to cease a certain advertising claim. Months later the FTC might dismiss the complaint or the courts might set it aside. By that time the company might have lost incalculable sales and profits.

And there is no recourse. If a business loses a million dollars in consequence of an incorrect FTC complaint it would have only an income tax deduction at best.

On the other hand, the arguments for cease and desist powers are equally strong. At present, many businesses go right ahead with questionable practices, knowing that it will take the FTC a year or two to halt them. By that time the practice will have gained its end, or the company will be ready with a variation.

PUBLIC FOOLED A case in point is that television commercial in which sand appeared to be shaved from sandpaper after being lathered with a certain soap. After months of investigation and hearings, the FTC ordered the commercials be stopped because it was not sandpaper, but a plastic film, that has been "shaved." But by the time the FTC order was issued, the campaign was at an end.

There are scores of other cases, many of which will probably be cited in Congress. Claims for toothpastes, liver pills, other medicines, home accessories and various services have ranged from extravagant to downright dishonest. But by the time the FTC could force stoppage, the campaigns were over, the sales made, the profits banked.

In fact, if an old promoter has a slick way of fooling the public about his product today, there is only conscience to prevent him from launching a tricky advertising campaign and get rich. By the time the FTC gets a complaint, investigates it, holds hearings, reaches a decision and sustain an appeal to the courts, two years will have passed. And in two years, almost any old promoter can think up a new slick idea.

FOR THIS Easter Sunday after His resurrection, there was no witness to the resurrection itself. As R. C. H. Lenski points out (quoted in "Peloubet's Select Notes," p. 143), "Those paintings which portray the glorious Saviour coming out of the opened door of the tomb while the guard flees and falls in dismay at sight of Him, are not in accord with the facts of the case"; the Lord had risen before the removal of the stone. It is significant that Christ tells the women He will see His disciples in Galilee. All His disciples and most of His other followers were Galileans; Christ Himself was brought up there. The Galileans, being a mixed race, were probably more receptive to new ideas than many.

Christ's greetings to the women, translated usually "Hail!", was the common Greek salutation of the time.

In Christ's time, as now, the seventh day of the week was counted as Saturday; the word for seventh was Sabbath or Sabbath, the weekly day of rest. The Sabbath, travel and carrying burdens were forbidden; so it was early Sunday, "the first day," before they returned to the burial scene. Since that time the Christian church has met on the first day in celebration of the resurrection.

When Christ presented Himself to His disciples at Galilee, they fell down and worshipped Him; only after His resurrection did they adore Him in this manner, signifying recognition of His deity.

His message to His disciples holds for us today: "Tarry ye... until ye be endued with power from on high" (Luke 24:49), then go forth and preach the Word.

In the portion assigned from the letter to the Hebrews, written by an unknown author about 65 A.D., the emphasis is on the pre-eminence of Christ over the angels, the superior beings of the Old Testament. Christ's life on earth is referred to as a "purification of sins," after which He "sat down on the right hand of the Majesty on High" (Hebrews 1:3)—a resurrection in the deepest sense.

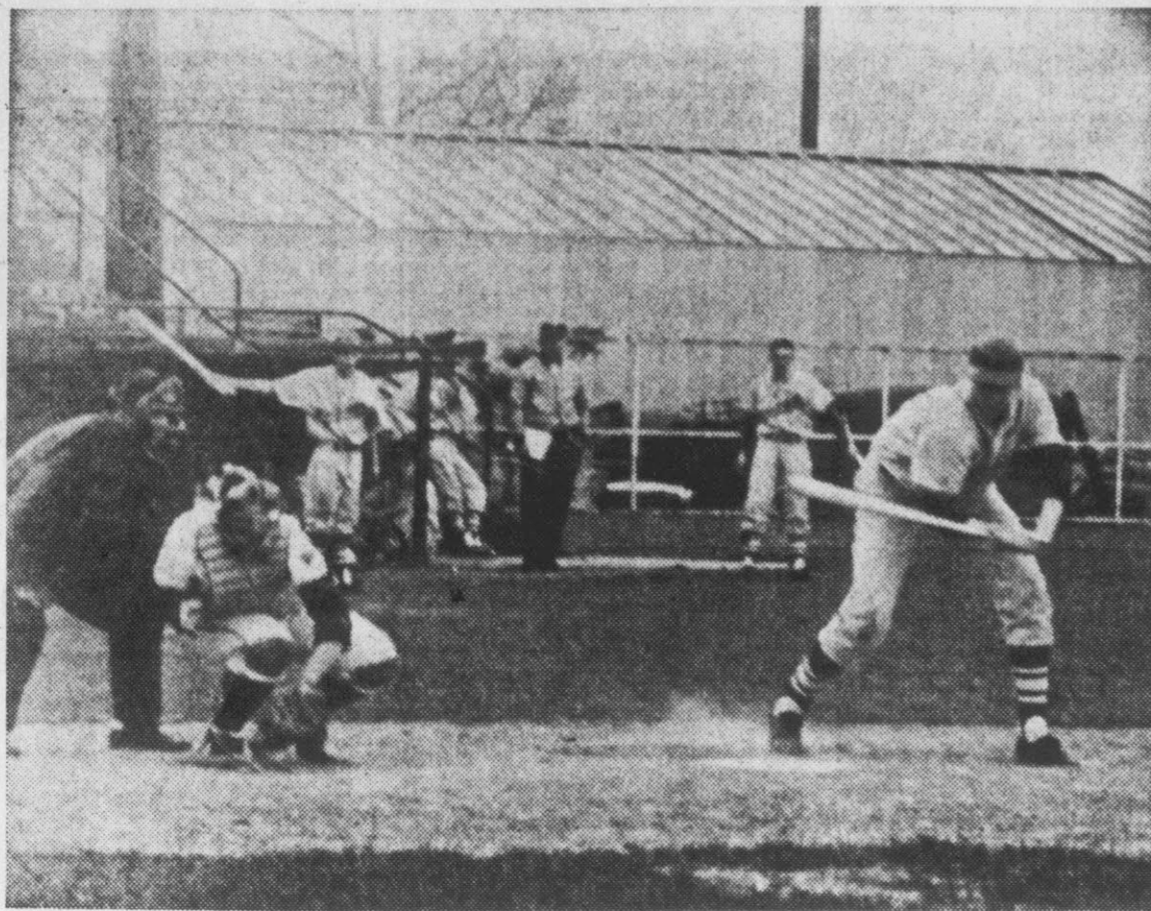

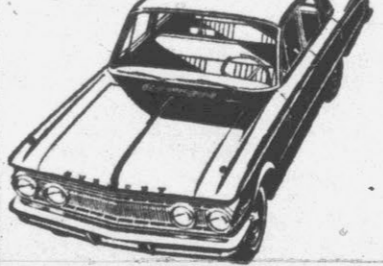

Handicapper's Own Advice: Stay Home

LEXINGTON, Ky. (AP) — In the man's world of handicapping horse races, Jobie Arnold is about as welcome as a swarm of bees at a picnic.

Her success at picking winners pleases the bettors but she has a feeling that her male compatriots would like to give her a one-way ticket to Timbuctoo.

Jobie believes she is the only woman handicapper in the country. For two years, she has picked results for newspaper readers on racing in Kentucky, Ohio and Florida. In 17 of 21 race meetings, she has been ahead of the men in number of winners.

On opening day of Keeneland Race Course April 7, she had a rare triumph. She picked winners of the first seven races and her horse in the eighth race was a close second.

It's only academic for Jobie, however, since she never bets her own selections.

"It only upsets you and you don't watch all the horses in a

race," she said.

How does she explain her success? "For one thing, she has grown up with horses. Her grandfather, William Kenney, owned the farm now owned by George Widener. She has trained and shown hunters and jumpers all over the country."

A second factor is that she places great emphasis on getting out to the track as early as 7:30 a.m. and seeing the horses work out. She talks to jockeys, trainers and agents.

What factors enter her picking? "There's no one thing. She watches the horse's past few races, its allowed weight, the jockey, claiming price "which can show many things," breeding, and stables.

There are definite stables which win at certain tracks," she says.

What is her considered advice to faithful bettors on the races? "Stay home."

Finn Is Top Candidate In Tokyo Olympic Marathon

BOSTON (AP)—Eino Oksanen at 31 must be ranked a top candidate for the 1964 Olympic marathon in Tokyo, until proved otherwise.

The police detective from Helsinki, Finland, captured his third Boston A. A. Marathon classic Thursday in 2:23:48.

"If possible, I'd like to win here again next year," he said. "I know Oksanen does not care to look as far ahead as the Olympics, this smooth-striding machine with the thatch of bobbing reddish hair proved himself more than a match for the field of 181 starters.

Over the last 10 miles, Oksanen's only serious rival was countryman Paavo Pystynen, 30, a career army man. He shot away from him some five miles from the finish and beat him by 350 yards, a revenge victory. Oksanen, rated the top marathoner in Finland, was leading the national

championship race last year when a cramp slowed him down and Pystynen came home ahead of him.

Oksanen now would like an opportunity to redeem himself for a 24th place in the 1960 Rome Olympics.

Oksanen again proved he is out with his races, not set records. In his earlier victories in 1959 and '61 (he did not compete here two years ago), Oksanen dogged the heels of America's Johnny Kelley until the last three quarters of a mile before calling on a powerful reserve burst to win going away.

U.S. Marine Lt. Alex Breckenridge finished third, Kelley—only American to win in the past 17 years—came home fourth—followed by Ted Atkins of Toronto, Richard Haines of Washington, D. C., and Larry Damon, two-time Olympic skier, from St. Johnsbury, Vt.

Miss Finerman took the lead early and held it against the challenge of Robyn Johnson of Arlington, Va., who earlier had smashed a meet mark with a winning 55.5 seconds in the 100-yard freestyle.

Miss Johnson's performance erased the meet record of :55.8 by Chris Von Saltza and also tied the American standard.

Baltimore Adds Hansen To Rolls

BALTIMORE (AP)—Shortstop Ron Hansen was added to the playing roster of the Baltimore Orioles today after he was granted an additional 30-day leave by the Army.

ORDINANCE NO. — AN ORDINANCE AMENDING THE ZONING ORDINANCE OF THE TOWN OF WINTERVILLE, NORTH CAROLINA, BY ESTABLISHING ZONING REGULATIONS APPLYING TO TRAILERS AND TRAILER CAMPS

THE BOARD OF ALDERMEN OF THE TOWN OF WINTERVILLE, NORTH CAROLINA, DO ORDAIN:

Section 1. DEFINITIONS. The following terms whenever used

or referred to in this ordinance shall have the following respective meanings unless a different meaning clearly appears from the context:

(a). **TRAILER.** Any vehicle, housecar, camp car or any portable or movable vehicle on wheels, skids, rollers or blocks, either self-propelled or propelled by any other means, which is used or designed to be used for residential living, sleeping, commercial or utility purposes, but not including those vehicles primarily designed for the transportation of goods.

(b). **TRAILER CAMP.** Any park, trailer park, trailer court, court, camp, site, lot, or parcel or tract of land designed, maintained or intended for the purpose of supplying a location or accommodations for any trailer, trailer coach, or trailer coaches, upon which any trailer, trailer coach or trailer coaches are parked, whether a charge is made for the use of the trailer, camp and its facilities or not. "Trailer Camp" shall not include automobile or trailer sales lots on which unoccupied trailers are parked for the purpose of inspection and sale.

Section 2. It shall be unlawful for any person, firm or corporation to place or maintain any trailer used for human habitation, or to use any trailer for living, sleeping or business purposes on any lot or premises located within the "Residence District" or within the "Business District" of the Town of Winterville, North Carolina.

Section 3. No trailer camp shall be constructed or maintained within the "Residence District" or within the "Business District" of the Town of Winterville but, subject to the following regulations, trailers may be placed and trailer camps constructed and maintained in the "Industrial District" of the Town.

(a). The minimum land area used or occupied by any one trailer unit in a trailer camp shall be 25 feet by 50 feet and the same shall be defined by a marker at each corner; and provided, further, that the minimum width of walkways serving such trailer plot shall be 10 feet.

(b) No trailer shall be placed nearer than 5 feet to its individual side lot line nor nearer than 7 feet to its back lot line nor within 20 feet of any street or exterior boundary line of the trailer camp.

(c) One off-street automobile parking space shall be provided on the site for each trailer unit in such trailer camp. The off-street parking spaces shall be set aside in a location convenient to the occupants of the trailer units and shall have ingress and egress by means of a public way. Where parking areas are provided adjacent to a public street, ingress and egress thereto shall be made accessible through driveways or openings not exceeding 25 feet in width in the curb line of said street.

(d) Each trailer camp shall be provided with at least one refuse collection station provided with water and fly type containers for each 12 trailer units conveniently located to serve the occupants of the trailer units and such station shall be conveniently located for the collection by the Town forces.

(e) No trailer shall be used as living or sleeping quarters unless and until connections have been made with the town sewer system for sewage disposal.

Section 4. All ordinances and parts of ordinances in conflict with this ordinance are hereby repealed.

Section 5. This ordinance shall be in full force and effect from and after the date of its adoption.

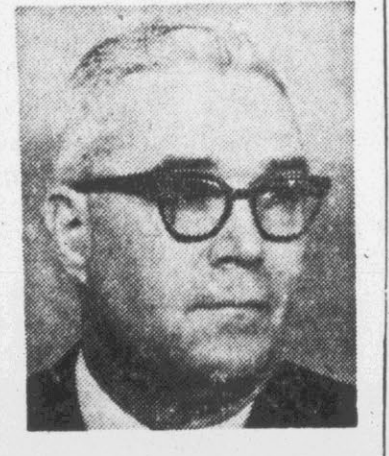

Holy City Is Jammed With Worshippers

JERUSALEM, Jordan Sector (AP) — Arab Christians and pilgrims from around the globe bowed before the traditional site of Calvary at dawn this Good Friday inside the walled city.

Church bells rang out across the hills of Jerusalem. Skies were overcast and drizzling. A few hundred yards from the worshippers in the Church of the Holy Sepulchre—built on the ground where Christians believe Christ was buried—Jordanian desert troops peered from sandbagged medieval walls across no man's land to the Israeli sector of Jerusalem. But the frontier was peaceful for the day.

Thousands of devout pilgrims were expected to follow Christ's last walk later in the day, bent under the weight of full size crosses along the twisting, stone-flagged Via Dolorosa that marks the Way of the Cross.

Jerusalem's hotels and private houses in the old walled quarter were jammed with visitors for Easter week, which this year stretches to April 29, when Eastern churches celebrate the resurrection. The Tourist Bureau estimated about 6,000 pilgrims were here already.

Covered alleyways and bazaars—barely wide enough for burdened donkeys to pass—were thronged with Americans and Europeans in newly bought Arab headresses, nuns and monks in robes from far-away lands, dark-faced Ethiopians, Copts from Egypt, and Armenians from Lebanon.

At the foot of the Mount of Olives Thursday night believers knelt in darkness around the huge rock where tradition says Jesus underwent his agony after Judas betrayed Him.

Anglicans and Arab evangelists held devotions in the same hillside garden. Lutheran sons walked from their church through the gate in the city wall to services in the onion-domed Russian church at the foot of the mountain. Other worshippers gathered in churches throughout the city.

More than 100 Christian sects are represented in the city.

Roman Catholics worshiped in the massive Church of the Holy Sepulchre, so weakened by age that the whole structure threatens to collapse.
