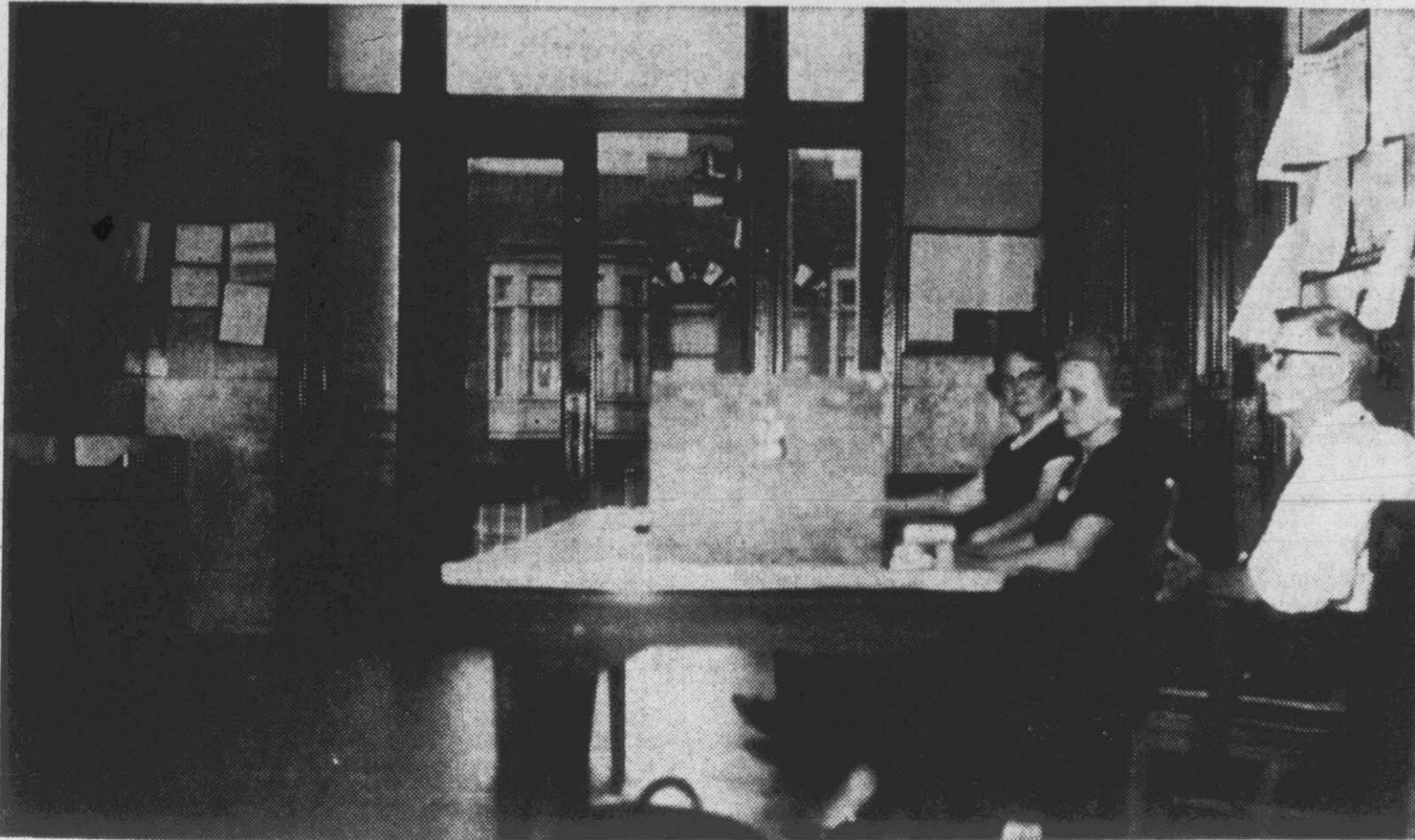


Partly cloudy, continued warm through Sunday with widely scattered thundershowers.

Balloting Runs Close To A Third Of First Primary

Voting in today's Democratic nomination primary for Pitt's House seat apparently included little more than one-third the ballots cast in the May 26 first primary.

A 12-precinct survey, including the county's most populous vote districts, indicated voting today will total about 38 per cent of the first primary's 8,000-vote total.

The pattern of voting was similar with regard to the various precincts surveyed with the exception of Winterville. That precinct, ranked third in the May 26 morning survey, was leading the county at 11:12 a.m. today.

Ike Asks Substantial Cuts In U.S. Defense Spending

WASHINGTON (AP) — Gen. Dwight D. Eisenhower stunned Republicans as well as Democrats Friday night with a call for substantial cuts in the nation's \$51.6-billion defense budget.

The former president's unexpected assertion that current military spending reflects "unjustified fears, plus a reluctance in some quarters to relinquish outmoded concepts" caught Republican congressional leaders short.

Eisenhower did not elaborate. He did not say where he would cut the defense spending which has been regarded by both parties as sacrosanct and above the debate over balancing the budget.

Flight Engineers Plan Strike At Two Airlines

NEW YORK (AP)—The Flight Engineers International Association, AFL-CIO, said it would strike Eastern Air Lines and Pan American World Airways at 1 p.m. EST today despite a National Mediation Board offer to step in as peacemaker.

The tentative TWA agreement, reached with the aid of Secretary of Labor Arthur J. Goldberg, is subject to approval by union members employed by the line. It would resolve a two-year dispute over manning of jet cockpits.

WASHINGTON (AP) — A compromise has emerged in the House from the ashes of the administration farm bill.

Orderly Approach To Airport Issue

Decisions this week by the Civil Aeronautics Board and the Federal Aviation Agency will not satisfy all parties concerned in the matter of air service for Eastern North Carolina, but those decisions do provide a logical and orderly approach to determining whether an area airport for the area will best serve the interest of the area.

At the same time, the decisions will not further delay institution of air service to several locations approved several months ago by the CAB.

The CAB said in effect it would not delay institution of service by Piedmont to Rocky Mount, Kinston and Goldsboro until a study of regional airport possibilities had been made. It did intimate, however, that such a study would be made in order that the question of a regional airport might be resolved. Also of significance is the FAA announcement that allotment of funds for airport construction in this section of North Carolina would be delayed until the CAB area airport study had been completed.

The CAB should set about immediately to begin its study of the regional airport possibilities in this section of the state and the effect it could have on the caliber of air service available in the section. There should be a full and careful investigation

of the question, but there should be no long delay either in initiating or completing the investigation.

The Reflector for a number of years has looked upon establishment of a regional airport as the best method to assure now and in the future adequate commercial air service to this section of North Carolina. We are still of the opinion that this is the most logical approach to the situation and the solution which in the long run will serve the best interest of all the section and its citizens.

By withholding funds for airport construction in the area until the study has been completed, the FAA will be avoiding the possibility of an unnecessary waste of both federal and local funds construction of local airports that might well be superceded by a regional facility.

The decisions announced this week by these major federal agencies which regulate air service and federal funds for airport construction are in the best interest of this area and its people. The CAB suggestion for the regional airport investigation should be implemented at the earliest possible moment by beginning such an investigation.

Swinging Back To Hyde County

RANGE — The pendulum apparently is swinging back toward Hyde County and its marshes and wetlands in the search for a suitable site for the Air Force to conduct practice bombing runs.

There is at least a feeling prevalent in Raleigh that in the end it may be that the first choice of the Air Force for a range site in Hyde County may be its flat, final choice and, in fact, the only choice.

Then, in face of the strong opposition, the question would resolve itself on whether the Air Force is to have the Hyde County site or not, and what is at stake.

STAKE — What is being considered, with no little effect, is that approximately seven-thousand jobs in Eastern North Carolina, most of them in the Goldsboro area, may depend on the Air Force obtaining a suitable practice bombing range.

More than 3,000 Air Force personnel at Seymour Johnson Air Force base at Goldsboro would be transferred if the Tactical Air Command should move its fighter-bomber wings. Twice that many dependents would be moved. And the effect on the area economy directly or indirectly would total several thousand other jobs—from the ports terminals at Morehead City which handle the high aviation fuel, to the railroad which delivers it in tank cars to Seymour Johnson, and the service industries which depend on the Air Force base.

All told, this is a considerable segment of the economy in Eastern North Carolina and more than enough to cause concern.

SITE — The Hyde County site, in uninhabited wilderness area north and east of Lake Mattamuskeet, has not been ruled out.

This is true even though the 30,000 acres of land needed has changed hands since the time the Air Force announced it wanted the Hyde County site and opposition to it arose.

The opposition in Hyde County and from sportsmen elsewhere has been hot and heavy—and with sufficient support and weight to make it necessary to look elsewhere, at least for a while.

In the interim, the land was sold to a new owner, Wayne Rollins of Delaware, Pa. Rollins says it would be premature at this point to comment on what he would do if the Air Force should make an offer to lease the lands. Rollins said his original plans were to develop the acreage for farming—although at present it is a virtual wilderness, populated by

deer, bear and in a season by ducks and geese.

HYDE — Historic Hyde, sparsely settled—with a population density of only 20 persons per square mile—has three principal occupations—farming, fishing and hunting.

Its ducks and geese are one of its richest resources and the dollars of sportsmen are a welcome windfall since the hunting season does not conflict either with the farming or fishing seasons.

Opposition to locating a practice bombing range in Hyde is based on the fear that it would have an adverse effect on the waterfowl and wildlife, that the roar of low-flying fighters and bombers would be ruinous to the hunting and thus destroy the reputation of Lake Mattamuskeet as the finest duck and goose country in the Eastern United States. Further, opponents claim it would be detrimental to the wildlife refuges at Mattamuskeet and in nearby areas such as Pea Island in Dare County.

DISPUTE — These points are open to debate. Gov. Terry Sanford has asked the Wildlife Resources Commission to make further studies into the matter. The Air Force contends that on the basis of experience elsewhere the "dud" charges used on the practice range would have no more effect than the blasting of the shotguns from Mattamuskeet's blind during duck season.

Furthermore, the Air Force has indicated that it would consider restricting use of the range so as to have minimum effect on the waterfowl and the hunting season. Nevertheless, the opposition to a practice range in Hyde County is formidable both from Hyde County itself and from sportsmen and conservationists elsewhere. This posed the dilemma.

SEARCH — The search goes on. Other possible sites in what the governor referred to generally as several coastal counties are being investigated.

These several counties are principally Hyde, Tyrrell, Washington and Dare. But except for the vast swampland north of Mattamuskeet, almost all other areas in this contiguous four-county area between the Pamlico and Albemarle Sounds have been ruled out for one reason or another.

It is possible, but not considered likely that the new investigation will turn up sites which would suit the Air Force as well. But it is the second time around in the searching and the Air Force did a pretty good job of looking the first time.

Losing Sight Of The Job They're To Do

Members of the House and Senate Appropriations Committees appear to us so engrossed in inflating their own egos and saving their own faces that they have lost sight of the welfare of the government and the governed in their dispute over how money matters will be handled.

The childish hassel is holding up appropriations bills in Congress and unless the deadlock is broken, the fiscal year may end with the two Appropriations Committees still fighting each other over procedure rather than carrying out the legislative work for which they were elected by the voters of the nation. They appear to have become so concerned over individual prestige and the prestige of the respective bodies they represent in the two houses of Congress that they have subordinated the nation's welfare to their own desires in what has become a struggle for legislative power.

In our opinion, the members of the two committees are staging a spectacle which is unbecomingly supposed to be mature and experienced leaders dedicated to public service. They appear to us at this point bent on serving their own desires rather than the best interests of the government or the people of the nation.

If they are to serve the Congress and the people they should resolve their silly differences and get back to work on legislative matters before them.

Silence Won't Stop Recession

WASHINGTON (AP) — Question: Can you avert an economic slump by keeping mum about the possibility there may be one?

Answer: Not likely. The question arises because of a rap-on-the-knuckles administered this week by the Kennedy administration to Ewan Clague, an official who sometimes speaks out of turn.

Clague, the commissioner of labor statistics, in a talk in Atlantic City was quoted as saying charts indicate a recession in 1963. "The only question being exactly when it is coming."

Clague's chief, Secretary of Labor Arthur J. Goldberg, quickly said in a statement "economic facts do not bear out such an assumption."

Then the Labor Department got in touch with Clague by phone, and put out a statement quoting him as saying his remarks were not a prediction. He said he was only analyzing historic trends which, if projected, "indicated an economic peak might be reached sometime in 1963 which might be followed by a business downturn."

Actually, of course, neither President Kennedy nor Secretary Goldberg has the foggiest notion whether 1963 will bring a slump. Nor is Clague's crystal ball much clearer for all his wizardry with charts.

For economists is not an exact science, like astronomy for example. An astronomer who incorrectly predicted an eclipse might have to turn in his card in the astronomer's union. But economists and politicians who flub economic forecasts just hope everybody will forget. They go on predicting.

Back in 1931, newsman Edward Anely got out a book entitled "Oh Yeah?" It would have been hilarious if anybody had felt like laughing that year.

It was simply a compilation of optimistic statements made by economists, business men, politicians and others before

and during the great depression that began with the stock market crash of October, 1929.

A few examples: Irving Fisher, economist, Sept. 5, 1929: "There may be a recession in stock prices, but not anything in the nature of a crash."

Charles E. Mitchell, chairman, National City Bank, Sept. 20, 1929: "There is nothing to worry about in the financial situation in the United States."

President Herbert Hoover, Oct. 25, 1929: "The fundamental business of the country is on a sound and prosperous basis."

Henry Ford, Oct. 3, 1930: "The crash was a good thing. You watch!"

Arthur Brisbane, columnist, Nov. 26, 1929: "All the really important millionaires are planning to continue prosperity."

Robert P. Lamont, secretary of commerce, March 3, 1930: "As weather conditions moderate we are likely to find the country as a whole enjoying its wonted state of prosperity. Business will be normal in two months."

The argument still continues as to what caused the big depression. Democrats-blamed the Republican policies, assailing President Hoover. Hoover accused the Democrats of sowing panic, and said Franklin D. Roosevelt's New Deal retarded recovery.

One thing seems clear. Rosy statements accentuating the positive and soft-pedaling the negative appear to have little effect on economic trends. For example, all Roosevelt's blithe pronouncements, plus his blimping, could not get the country going full blast again. It took World War II to do it. But this is not a recommended way to attain full employment.

Most experts say nowadays there cannot be another great depression: There are so many built-in economic cushions and the government has vast new powers.

This is one prediction everybody had better believe: The alternative is too inauspicious to contemplate.

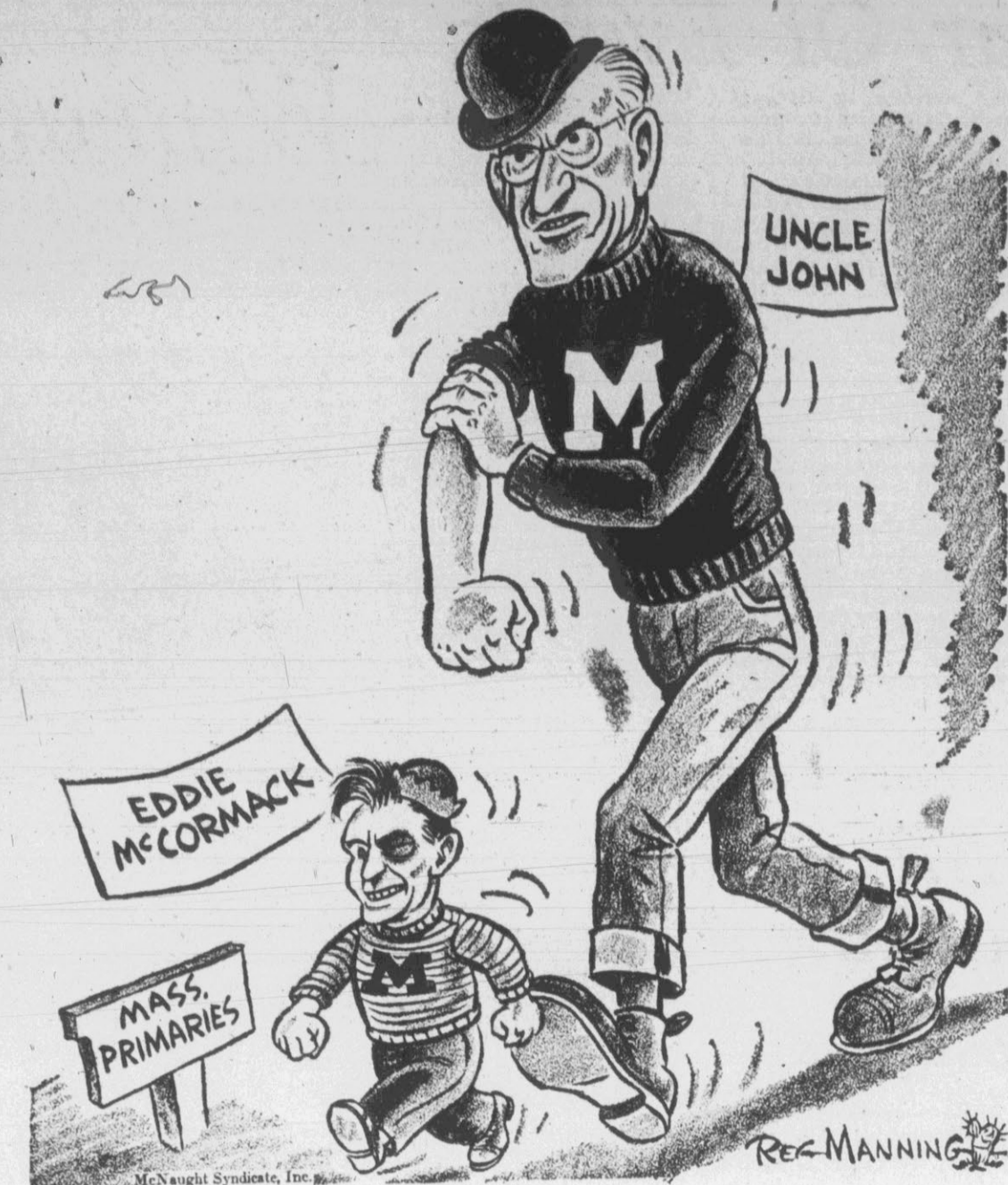

Mexico's Irish Blood

MEXICO CITY — There was a time when the Irish were riding plush seats of everybody's gravy train down in this direction.

Such names as O'Higgins, O'Brien, O'Donohoe and so on have gone down in Latin American history. While the citizens with names like Sanchez Perez and Abney are lucky to get in the telephone directory.

It is claimed in reliable champagne parlors and bars here that more monuments around here are dedicated to the Irish than to Latin. Mexico once had a viceroy named John O'Donohoe. Briefly.

He came from the Fatherland, which in those days was Spain, and his name was spelled Juan O'Dononju. Possibly a holdover from the days when the Spanish Fleet got itself wrecked on the coast of Ireland. And man, what a fiesta!

Anyhow, Mr. O'Dononju (Spanish spelling for the way the Irish pronounce it) landed in Veracruz to restore order in the colony and get things going. He was met by a group of revolutionary gentlemen.

It was a cozy little nook swarming with atmosphere. On the menu, a Shillelagh Delight turned out to be a banana split. And soup was Dublin Stew. They also set fire to everything on the platter and served you in a blaze of glory.

And when we asked for dessert, the solemn waiter wheeled up a cart with a collection of ice creamish structures such as the proletariat seldom beholds. Then left.

This, children, was an edifying event. Because the strawberry and pistachio construction was very tasty looking but could not be dented with a spoon.

Your faithful correspondent went to work on it with a knife at which point, the shocked waiter slithered up to inform us that it was merely a model. Plaster of Paris. You pick your type from the models and it is then hand-tailored in the galley. Senor O'Connor's idea of elegance.

Needless to say, we paid the bill and hid us hence for a bag of legitimate chocolates at the corner. From a gentleman named Henandez who did not operate with models.

For there is only one way to stop crime and that is to have "hanging judges" on hand to get rid of messy human beings. Every year, the age of criminals grows younger. Why? Because as the kids say, "You can't do nothing to me, I ain't 21 yet." 21, my eyes!

Fear In Cities' Parks

"No Chicagoan in his right mind would dream of strolling at night through Grant Park, along the downtown lakefront. And the New Yorker who used to sleep on the grass in Central Park on hot nights would as soon take a cosy nap on an East Berlin sidewalk with an American flag in his hand."

The fact is that crime in this country is growing so rapidly that we are one of the most lawless people on Earth. If, when a policeman wants to make an arrest, a neighborhood mob intervenes, all who can be caught should be arrested and punished severely. A few exhibitions of police strength, unimpeded by politically-minded judges, would be a splendid lesson. A decent citizen would help the policeman.

Grafton quotes Cleveland's chief of police, Frank W. Story:

"Not long ago a crowd of 50 to 60 people calmly watched one of our motorcycle men, a good officer, being beaten by a couple of thugs. No one called the police."

Lawlessness and danger often makes for corruption among the police. Disgusted by the ridiculous attitude of judges, annoyed at police rules which often are disadvantageous to the policeman, tempted by large and small bribes, policemen do go wrong. When a cop risks his life to bring in a mugger, a thief or a rapist and then finds a soft-minded judge, assisted by a social worker, letting the criminal off because he has not yet reached the magic age of 21, the cop naturally throws up his hands in disgust.

For there is only one way to stop crime and that is to have "hanging judges" on hand to get rid of messy human beings. Every year, the age of criminals grows younger. Why? Because as the kids say, "You can't do nothing to me, I ain't 21 yet." 21, my eyes!

Bring out the cat and throw the kid over the knee of a strong cop, let down his pants, and give him an old-fashioned hiding and he won't forget it.

Attorney General Robert F. Kennedy says:

"The only lasting solution will come when people everywhere realize their own responsibilities to abide by the law."

I fear that some virtues have to be pounded into some people. They learn better through the rear-end than by eyes and ears. What they hear goes in one ear and comes out through the other. What they see is the bunk. But what they feel leaves with them a lasting, even an everlasting, impression. The worst thing about city life is that the old-woodshed is gone and when a kid screams, the neighbors hear the noise and telephone in their complaints.

The parent who has good children is truly blessed. When I was a youngster, we always knew the cop on the beat. We usually liked him. If we were bad, he gave us a warning. If we were very bad, he would tell our parents who would probably whack us to maintain family self-respect. There were no juvenile courts in those days. Some kids were pickpockets and petty thieves. So they were locked up. Those who were locked up were likely to become permanent criminals. But the crime rate

Proposals Would Slow Business

Two Kennedy proposals to boom business this year will do nothing of the sort. In fact, they will tend to slow down business for the rest of the year.

President Kennedy, presumably with the finest brains that can be hired on the New Frontier, has put forth two projects with the youthful enthusiasm intended to help dissolve sluggishness in business. Yet each proposal threatens to retard expansion.

The plan to allow business to deduct percentages of investments in new equipment in calculating income taxes.

This was originally an 8 per cent allowance; it has been cut to 7 per cent and, before Congress gets through with it, may be even less or washed out entirely.

UNCERTAINTIES COMPOUNDED
Suppose you were an executive of a corporation planning a \$1 million expansion. Would you dare launch the plan now, not knowing what tax considerations would be available? Would you go ahead now knowing what tax reductions are in store?

Chances are you would freeze on the point; you'd wait and see what Congress will do about the current tax allowance and what Mr. Kennedy and the Congress will do about the tax cut in 1963.

Thus, instead of speeding up business, these two proposals tend to slow it down. No further comment.

Sal Gero Says He Was Fired

East Carolina College Assistant Football Coach Sal Gero said today, "I want it understood that I was fired."
The statement by Gero came after he returned from a trip to Pennsylvania where he had been working and looking for a job.
Gero was not available last Saturday for comment when Dr. N. M. Jorgensen, director of athletics at the college, announced that the assistant coach would not be on the college staff this coming season.
Jorgensen's remarks were, "Gero was hired on a one-year basis and his contract was not renewed."

Gero told the Daily Reflector today that "they (college officials) have not given me any reason for the firing and it came about after I was given a promise by President Leo Jenkins and Dr. Jorgensen that all the assistants would be back next year."
The assistant coach, whose contract is not up until Sept. 1, also stated, "I still have not been given a reason for the firing and this has hurt me in my quest for another job."
Gero explained that he has been unable to give prospective employers the reason for his firing which has hindered him in obtaining another position.
When former Head Coach Jack Boone was re-assigned last November and the fact that a new head coach would be hired was made public, Dr.

Jorgensen noted that Boone's assistants would remain in their present positions.
Gero began his duties at East Carolina last fall under Coach Boone and worked with the 1961 Buc team. Prior to joining the East Carolina staff, he coached at Asheboro High School.
In commenting on Gero's remarks today, President Jenkins said, "It is my responsibility to the people of North Carolina to do all in my power to obtain the services of the most capable people possible."
"All faculty members and coaches are hired with the understanding they are to work on a probationary period. If at any time during this period we feel that the performances of such new staff members are not up to our expectations or do not fit satisfactorily into the program being carried on here, we naturally do not continue their employment."
"This is common practice in all colleges and departments within such colleges and I see no reason for East Carolina to depart from it."
In the middle of May the college announced that Robert Gant had been hired as an addition to the football coaching staff and as an instructor.
Gant is scheduled to take over the backfield coaching duties for Pirat Head Coach Clarence Stasayich.
The new coach has been coaching at Albemarle for six years, three years as an assistant coach and three as head coach.

The River And Stan The Man Keep Rolling Along

St. Louis, located on the banks of the Mississippi River, has been made famous by two old men. One is The River. The other is Stan The Man. Both just keep rolling along.
Stan (The Man) Musial, 41-year-old Cardinal great, established another in his long list of records Friday night, lashing a home run and three singles to surpass Ty Cobb's major league record of 5,863 career total bases.
It was the fourth major career standard established by the personable Cardinal outfielder this season. He previously topped the National League records held by

the late Honus Wagner for hits (3,430) and games (2,785) and by Mel Ott for runs (1,859).
Musial's four hits in St. Louis' split of a doubleheader with Philadelphia raised his batting average to .345, best in the league. His total base count now stands at 5,866. Babe Ruth is third on the all time list with 5,793.
Musial's second inning homer, his eighth of the season, triggered a six-run inning that brought the Cardinals a 7-3 victory in the opener, but the Phils came back for an 11-3 verdict in the nightcap.
In the others, New York and Houston split a pair, Met lefty Al Jackson throwing a one-hit 2-0

shutout in the opener and the Colts romping 16-3 in the second. Cincinnati fought off a Los Angeles ninth-inning rally and beat the Dodgers 4-3. The Dodgers remained 2½ games in front of San Francisco, however, which was the victim of a ninth-inning Milwaukee rally that brought the Braves an 11-9 decision. Pittsburgh beat Chicago 7-5.
In the American League, Minnesota reclaimed second place with a sweep over Los Angeles, 3-2 and 8-3; Cleveland, stopped Washington 6-2; New York, with Mickey Mantle starting for the first time in a month, fell before Detroit 7-5; Boston and Baltimore split a pair, the Red Sox taking the first 2-1 in 10 innings, and the Orioles the second 4-3; and Chicago beat Kansas City 5-1.
The Mets' Jackson, a lefty who makes his home in Houston, allowed only a single to Joe Amalfitano and a walk in the first inning before settling down to his near-perfect performance. He retired 22 in order before walking the lead-off man in the ninth. Jackson (4-8) struck out nine in the first complete game one-hitter of the season.
Jim Golden (5-4) tossed a seven hitter, contributed two triples and got the benefit of a 17-hit attack in leading the Colts second game rout.
Cincinnati's Bob Purkey (13-1) shut out Los Angeles on four hits before he had to leave the game with a muscle spasm in his back in the eighth. The Dodgers promptly hopped on three relief men for a three-run rally in the ninth, but Ted Willis finally saved it for the Reds.
Milwaukee rallied for three runs in the ninth, the last two on Lee Maye's single, to outlast the Giants in a see-saw battle that lasted four hours and two minutes.
Dick Groat drove in two runs with a single and double and scored two more as the Pirates overcame a 4-3 deficit against the Cubs. Bob Skinner had a two-run homer for the Pirates.

Longest 9 Inning Game In History

SAN FRANCISCO (AP)—Milwaukee and San Francisco played the longest nine-inning game in major league history Friday night and early today but the Braves' 11-9 victory still isn't a certainty.
The 4-hour, 2-minute parade of pitchers and cheap hits could pick up in the fifth inning as this future date if National League President Warren Giles upholds an official Giants' protest of an interference play near first base.
Stu Miller, the center of the protest drama, and the four umpires offered different versions of the play in post-game comments. This much was certain:
With Giants on first and third, Miller pushed a squeeze bunt between the mound and first base. Braves' pitcher Ron Piche fielded the ball and threw toward first but hit Miller in the left shoulder.

Miller was called out for interference.
Later first base arbiter Al Forman said Stu had run outside the three-foot restraining lane near the base.
Said Miller: "Forman admitted I was on the line but according to him you can't be on the line. He's making up his own rules."
Section 7.09 (1) says the runner is out if "He runs outside the three-foot line or inside the four line and, in the umpire's judgment, interferes with the fielder taking the throw at first base." But it doesn't specifically mention running on the line.
After trailing 5-0 in the second, the Giants moved ahead 6-5, were tied at 6-6, rallied for an 8-6 lead and were tied again, went ahead 9-8 with a run in the seventh and finally lost 11-9 when Milwaukee scored three times in the ninth.
Man of the 26 hits—16 of them by the Giants—were little pop flys that fell just beyond panting infielders. Six others didn't even get out of the infield.
The longest previous nine-inning game was a 31-run horror between Detroit and Kansas City July 23, 1961, that last 3 hours 54 minutes. The old night game nine-inning mark was 3:52 set by the New York Yankees and Boston Red Sox.

Purkey Suffers Pain In Back

LOS ANGELES (AP)—Bob Purkey, the biggest mystery of the year to National League hitters, was mystified himself today—and a little concerned—about a stabbing pain in his back.
The Cincinnati right-hander scored his 13th victory Friday night as the Reds muddled through a three-run Los Angeles rally in the ninth inning and beat the first-place Dodgers 4-3 before 48,260.
But the back pain became so severe it began to take Purkey's breath away and he had to leave the game after shutting out the Dodgers for seven innings and hitting a rally-starting double in the eighth.
"I felt this little catch in my back before the game," Purkey said, "but the trainer relieved it. Then, about the second or third inning, it started again. My back seemed to tighten up a little more every inning."
"When I got to second base in the eighth, I couldn't breathe. It felt like someone was sticking a knife in my back—between the spine and the base of the right shoulder blade."
In the dressing room after the game, Purkey said the back was still sore. "I can't take a deep breath," he said, "or move my shoulders either way without it grabbing hold of me."
"I'll see how it feels tomorrow, and if it's still sore I'll see a doctor. The trainer says it doesn't look like a (muscle) tear and I'm happy to hear that."

BERLIN (AP)—Germany's Gustav "Bubi" Scholz challenges Harold Johnson for the American world light heavyweight title at outdoor Olympic Stadium tonight.
The 15-round fight, first title match ever in Germany, is scheduled for 3 p.m. EST.
Some 50,000 fans are expected to pour into the giant stadium to watch the clash between the 33-year-old champ from Philadelphia and Scholz, a 32-year-old Berliner. The odds favor Johnson. He's the 4-1 favorite.
A professional since 1946, Johnson's record shows 69 victories, 32 by knockouts in 76 fights. The champ has been knocked out four times in his early career. He is unbeaten since 1955.

Vopos Search Berlin Subway

BERLIN (AP)—East German police stopped a West Berlin subway train twice during the night, searched it at length and arrested a man, West police reported today.

The train ran on one of two lines crossing East Berlin. Since Aug. 13, when the Communists closed the border in Berlin, subway trains which formerly connected the two halves of the country have not been allowed to stop in East Berlin.

West police said it was the first time since the Reds closed the border that a subway train was halted and searched.

The train connects the district of Neukölln in the American sector with the borough of Wedding in the French sector.

The train was first stopped shortly before midnight by a group of East German police—at Alexanderplatz station.

After a half-hour search, the Communists let the train continue its run. The train was stopped again 10 minutes later, shortly before reaching Bernauer Strasse station, still in East Berlin.

A platoon of Red police again searched the train. An unidentified man was taken off the train. Apparently he had no identification papers.

Police said the search appeared to have been aimed at finding somebody the Communists wanted.

Cooperate With A Nesting Bird

DETROIT (AP)—Roughhewn construction workers and foremen have joined a mother killer in her efforts to hatch a brook in the midst of excavation work on a new building in suburban Southfield.

Workers guide huge earthmovers and bulldozers around a 10-foot high mound of earth in the middle of the excavation.

The killer's nest sits atop the mound.

Thus far the bird has stayed on her nest despite the noise and vibration from the bulldozers.

Construction workers say the mound of earth will be left intact until the young birds are ready to fly or until the mother bird abandons the nest.

Soviet Union Kills Bid To Talk Over Dispute

UNITED NATIONS, N.Y. (AP)—The Soviet Union cast its 100th Security Council veto Friday night, killing off a move to bring India and Pakistan together for new talks on their 15-year-old Kashmir dispute.

The 11-nation council adjourned after U.S. Delegate Adlai E. Stevenson denounced the veto—which automatically defeated a resolution introduced by Ireland—as a willful abuse of the United Nations.

"What of the future?" Stevenson asked. "The council is a vital and purposeful organization of the United Nations in spite of the veto. It provides vital and purposeful direction and leadership. As for the veto itself, we hope that long before the Soviet Union approaches its 200th veto, it will realize that its own interests lie not in national obstruction but in willful vetoes for narrow ends but in willing assents for the broad and common good for which the U.N. stands."

Platon D. Morozov, the Soviet delegate, assailed the resolution introduced by Ireland as "inspired and prepared by the United States." He said it had "a foul odor to it."

The Soviet Union and Romania cast the no votes, while Ghana and the United Arab Republic abstained. The other seven members voted yes, but the Soviet "no" constituted a big power veto that doomed the resolution.

Thus the council, which started the current series of meetings at the request of Pakistan last Feb.

SEATTLE (AP)—Although it's a long way from Seattle, North Carolina was well represented at the World's Fair honors the Tar Heel State today.

A delegation of 175 business and civic leaders will be on hand as the North Carolina flag is raised to its place of prominence in the Plaza of the States as the bands play and the speeches flow.

The group—which has been touring Washington State since Wednesday—is the Agrusiness Caravan. It is sponsored by North Carolina State College, the state's agriculture department and the Wachovia Bank and Trust Co.

Dr. John Caldwell, chancellor of the college, will represent North Carolina's Gov. Terry Sanford.

Caldwell and Washington Gov. Albert Rosellini will kindle the font of unity in the plaza and fair President Joseph Gandy will extend greetings to the Tar Heel State.

North Carolina is the 23rd state to be honored by a day of its own at the fair.

The delegation is to fly back to North Carolina Sunday.

Nehru Hopeful Testing Will End

NEW DELHI, India (AP)—Prime Minister Nehru expressed belief today that nuclear weapons testing probably will stop for a long time after "these series of tests by the United States and the Soviet Union."

Nehru told Parliament that experts have informed him that the scientific and technical knowledge achieved by the United States and Russia will remove the need for further testing for a long time.

He said he does not know whether the Soviets will carry out their threat of a new test series following the American test series.

"It is a move in the right direction and will have the approval of the overwhelming majority of farmers. What we need is less government in agriculture and more freedom for farmers."

Benson said he felt the 1958 act, in which farmers voted 71 per cent to eliminate controls on corn, was sound.

"What we need is similar action on other commodities, similar to the action provided on corn in the '58 act," he said.

Union Officials Claim Railroads Seeking Strike

CHICAGO (AP)—Angry union officials representing 200,000 trainmen have accused operators of the nation's railroads of trying to provoke a nation wide rail strike.

The accusations came after management representatives walked out of a negotiation meeting with union officials Friday. It was the second time railroad operators had walked out of a bargaining session with the trainmen. The last walkout occurred May 17.

The break in bargaining arose over work rules the carriers consider featherbedding—calling for unnecessary jobs. The unions maintain the rules are a requisite for safe and efficient transportation.

J. E. Wolfe, chief industry spokesman, handed a statement to Leverett Edwards, chairman of the National Mediation Board, and to the union chiefs, saying: "It is obvious that no progress can be made by prolonging the present endeavors."

Collect Blood Here June 27

The Red Cross bloodmobile will visit Greenville next Wednesday for its last stop this fiscal year.

The bloodmobile will be stationed at the Greenville Moose Temple from 10 a.m. until 4 p.m. The preceding day, Tuesday, the bloodmobile will be stationed in Farmville at the National Guard Armory from 12 noon until 6 p.m.

Quota for the two-day visit is 250 pints of blood, but blood program officials hope they will be able to collect 257 pints of blood in order to clear the deficit in the blood bank for the fiscal year ending June 30, Kenneth Whichard, blood program chairman for Pitt County, said.

Civil organizations and others who have been participating in the program by sending donors have been asked by Whichard to be represented in the blood collection. Whichard also urged those who have used blood to try to replace it as a "moral obligation," even though there is no requirement that they do so.

Blood collected by the bloodmobile is distributed for use by member hospitals, including Pitt Memorial Hospital, at no cost to the patient. The only cost is a laboratory and processing fee charged by the hospital.

Rusk And Italy's President Talk

ROME (AP)—Secretary of State Dean Rusk had his first meeting with Italy's new president today and reviewed NATO and Common-Market problems.

Rusk, who came to Rome from Bonn on the third leg of his 10-day European tour, conferred with President Antonio Segni at the presidential palace within hours after his arrival. Premier Amintore Fanfani and Foreign Minister Attilio Piccioni joined Segni for the talks.

Despite a full schedule, Rusk's 26-hour stopover here appeared almost a respite after his earlier talks on nuclear problems with President Charles de Gaulle in Paris and on the Berlin crisis with Chancellor Konrad Adenauer in Bonn. There are no such major problems in Italian-American relations.

In an airport statement in Rome, Rusk hailed the Atlantic alliance as "firm, solid and strong."

The meeting was Segni's first personal contact with a top American policymaker since his election by Parliament last month. But Segni and Rusk are well acquainted. Until his election, Segni was Rusk's Italian counterpart as foreign minister.

Rusk, headed for Italy after apparently reaching agreement with Chancellor Konrad Adenauer to leave the next move to the Berlin issue up to the Russians.

The U.S. secretary told West German Foreign Minister Gerhard Schröder, who saw him off, that "we go away greatly encouraged. I am looking forward to our next meeting, which I am sure will take place in the next few months."

Schröder said the talks had produced "extraordinary unity on all decisive questions."

Union Officials Claim Railroads Seeking Strike

The unions retaliated, charging: "The break is a deliberate, irresponsible, determined effort to force a transportation crisis."

The unions, representing engineers, conductors, trainmen, firemen and switchmen, added: "Since the start of the present conferences, carrier representatives have sought unilateral application of the presidential commission's report and adamantly refused to negotiate issues."

At Colorado Springs, Colo., Louis J. Wagner, president of the Conductors and Brakemen's Union, said his union "generally is placed in a crucial situation as a result of the rupture of negotiations."

H. E. Gilbert, president of the Brotherhood of Locomotive Firemen and Engineers, said the collapse could lead to a national rail strike.

"Clearly the railroads have conducted a deliberate, determined program to push the nation toward a transportation crisis," said Gilbert, in Houston, Tex., for his union's convention.

After the carriers walked away from the bargaining table, Wolfe told a news conference that the railroads would put into effect all recommendations of the special commission as soon as they are legally free to do so.

The unions have threatened a strike if any recommendations are acted upon without an agreement.

The presidential commission recommended last February that 40,000 firemen on diesel locomotives be eliminated over a period of years. The total membership of the firemen's union is around 60,000.

It also called for a revision of the wage and hour system, suggesting pay increases for most of the men who man the trains. The carriers agreed to the commission report. The unions did not.

Wolfe said the industry would be agreeable to arbitration by the mediation board provided the issues were within the framework of the commission report. If arbitration is rejected by either party, Wolfe said, the next step would be for the mediation board to inform President Kennedy that an emergency exists.

Oran Terrorist's Bomb Sets Spectacular Blaze

ORAN, Algeria (AP)—A bomb touched off a raging fire in a gas storage reservoir today and sent panic through a nearby residential quarter.

Firemen wearing gas masks attacked the flames with chemical extinguishers. Inhabitants of nearby apartments were ordered to leave.

Gendarmes and troops surrounded the area as flame and smoke billowed up from the blazing reservoir.

The fire was put out after about an hour, but gas continued to escape from the damaged tank. Electric current in the area was cut to avoid danger of explosions.

The spectacular new terrorist action followed a Secret Army Organization broadcast Friday night calling for a final stand against Algeria's imminent independence.

Fugitive former Gen. Paul Gardy issued the order to his outlawed followers in Oran after stating that contacts with representatives of Moslem nationalists have failed to yield positive results.

A blaze, started by a bomb, gutted the Oran townhall less than an hour after his clandestine broadcast.

In Bone, eastern Algeria, two plastic bomb explosions reminded the population that the local Secret Army command was not accepting the peace negotiated in Algiers.

Algiers alone held on to the precarious peace accord announced Sunday by Moslem nationalist representative Dr. Cheikh Mostefa and Secret Army leader Jean-Jacques Susnil.

But the accord had little legal or binding value since it consisted only of two broadcast announcements.

One week before Algeria votes on its future, a new dangerous note has crept in.

Machegun fire Friday seriously wounded two Moslem officials in Algiers in a daring attack by men described as Moslems.

The attack was seen as an outgrowth of an internal struggle within the Moslem Front of National Liberation (FLN).

European settlers saw the incident as another sign of future insecurity and turbulence under Moslem rule.

Fascinated With Collecting Coins

By MARTI MARTIN Reflector Staff Writer ROBERSONVILLE — Perhaps the byword of a nine-member group of Martin County numismatologists is the old warning, "Don't take any wooden nickels" . . . amended slightly to include: " . . . unless, of course, they're valuable."

L. G. Hardison of Robersonville, president of the club, instigated organization through contacting eight more coin enthusiasts in the county to schedule the first meeting May 10. At the inaugural session, the club immediately adopted a resolution calling for coin auctions at each meeting. Under the proviso, members are allowed to place two coins for sale by auction once a month, on regular meeting nights.

trade coins at wholesale prices among ourselves. We are also able to discover some of the interesting aspects of another person's collection or methods of collecting and filing coins." In addition to Hardison, current club officers include Vice President David Hughes of Williamston and Secretary-Treasurer Mrs. Mamie Smith of Robersonville. Members include James H. Gray III, Robert M. Beach and Robert A. Gray, all of Robersonville; Bill Jackson of Wash-

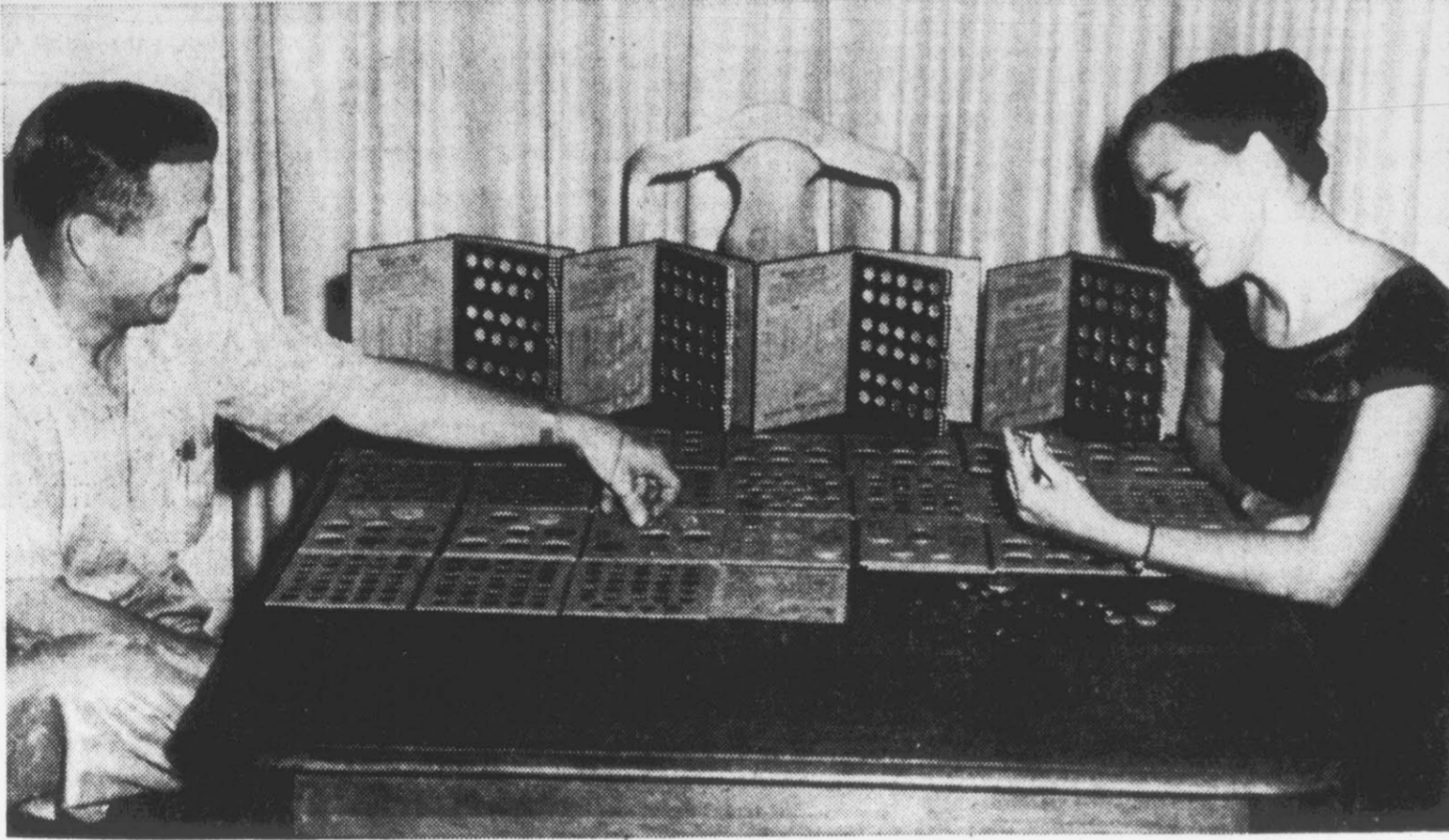
ington; Spencer Ayers of Hasell; and Eddie Poe Everett of Hamilton. All members are interested in collecting U. S. coins. Hardison estimates the total value of the nine members' collections at \$15,000 or more. The nine members represent what is perhaps a typical cross-section of Martin County's citizenry. One is a high school junior, two are college students, another is a housewife, others are salesmen and farmers. But in spite of widely-varying daily interests, the nine collectors, in true collector fashion,

experience a degree of extra excitement with each meeting when the group avails itself of another opportunity to talk shop, numismatics. Numismatologists are not unlike collectors of other items ranging from stamps to flower seed, they're all quite fond of encountering other collectors of similar breed. Coin enthusiasts make a valid point: "What could better cause excitement than money?" They follow with a list of assets linked with such a hobby. Primary among inducements attracting the average numismatologist, perhaps, is the assurance of liberal sprinkling of mystery, adventure and history through a search for rare numismatics.

For example, Hardison's collection includes a popular U.S. coin dating to 1738, his oldest collector's item. But, as Hardison points out, age is not always the prime determinant of value: "Beauty goes a long way in determining the value of a coin. One of the prettiest coins I have is an 1827 half-dollar, worth between \$15 and \$30 retail." His collection also includes a complete Lincoln penny set, 1941-51, and an impressive list of single-coin prizes such as an 1857 "Flying Eagle" Indian-head penny, an 1878 "Liberty Head" silver dollar, an 1830 "Liberty Head" nickel, an 1899 "Liberty Head" dime and a 1915-D buffalo nickel. Other items that contribute to Hardison's personal numismatics include a half-dime, measuring nine-sixteenths of an inch in diameter. The collector also boasts complete 1927 sets of half-dime, dime, quarter and half-dollar.

Reviews And Reflections

William Faulkner has done it again with "The Reivers." This latest masterpiece is in the comic vein. It deals with events in Jefferson, Mississippi and Memphis in 1905, and is narrated in the last retrospect of 1961 by Lucius Priest, who, a page 11, with Boon Hoggenbeck, stole Jefferson's solitary automobile, belonging to Lucius' grandfather, for a week-end in Memphis. In a manner characteristic of Faulkner's unique imagination, the story develops amazing and ridiculous complications before it ends happily for everyone. Along the way the reader meets a variety of reputable and disreputable characters, with it a good book, practical, even all of whom are eminently believable. Faulkner's treatment of this gallery is a tribute to his inense humanity, for he not only evokes the chuckle but the tear, as he sympathetically exposes some of the pregnant aspects of life along with the absurdities. This is a truly remarkable work, crowned by the author's brilliant style and his exciting narrative technique, whereby he is always inviting his readers to plunge ahead to understand the meaning of the mysterious clues which his characters are continually dropping.

Confederate Arithmetic Dick Walsler's "North Carolina Miscellany," the anthology of odds and ends about the State, is being well received. Walsler's range of choice is wide. He quotes some problems, for example, from the 1864 edition of L. Johnson's "Confederate Arithmetic." "A Confederate soldier captures 8 Yankees each day for nine successive days. How many does he capture in all?" "If one Confederate can whip 7 Yankees, how many soldiers can whip 49 Yankees?" Byrd censures Walsler also quotes William Byrd's famous description of North Carolina in the early 18th Century: "One thing that may be said for the inhabitants of that Province, that they are not troubled with any Religious Fumes, and have the least Superstition of any People living. They do not know Sunday from any other day. But they keep so many Sabbaths every week that their disregard for the Seventh Day has no manner of cruelty in it. "To speak the Truth, tis a thorough aversion to Labor that makes people file off to North Carolina, where Plenty and a Warm Sun confirm them in their Disposition to Laziness for their Whole Lives." What Rights? Recent indications that the American people no longer actually believe in the principles of the Bill of Rights have evoked various comments. Chief Justice Warren doubts that the Bill (Continued on Page 8)

Student Supplies Are Big Business

By HENRY HOWARD Reflector Staff Writer Supply and demand, classical and traditional economic terms, are applied with expert adeptness and yield abundant fruit in operation of East Carolina College's student supply store system. While the term "supply," when applied to book store-soda shop operations, means at first glance simply retail commodities, closer inspection of ECC's system provides a greatly broadened and enhanced version of "supply." By definition, it's obvious the two soda shops, the book store and the general supply shop provide convenient retail outlets for various categories of student-needed commodities. That closer look, however, shows the scope of the student supply system reaches to more urgent student needs. It affords nearly 100 part-time jobs for students in financial straits. Its annual profits are turned over to the administration for conversion into \$50 to \$100 scholarships available to students in financial need. It provides a built-in training program that boasts living evidence of worth in ECC graduates who have made careers for themselves in retail management professions. The system's manager, Harry G. Rainey — himself a product of the supply stores — says the students employed in the four stores and the system's food-vending machine service form a community within the near-6,000-student ECC college population. "We enjoy having them work with us. They are grateful for

an opportunity to work. In many cases, the money they earn working two to three hours a day accounts for all their food and spending money," Rainey says in describing the student-employment program. Records show the student payroll in the store system closed the fiscal year ending May 31 at about \$36,000. These funds were apportioned among an average part-time force of about 95 deserving students in monthly paychecks ranging between \$25 and \$70. Self-help jobs for students pay 75 cents an hour. Profits of the student stores in fiscal 1960-61 went into scholarships for approximately 225 students last school term. Based on the store system's history, fiscal 1961-62 profits will provide more scholarships for deserving students during the academic year beginning this summer. Students qualify for the grants by exhibiting need for financial help and by maintaining a "C" average in their scholastic work at the college. Self-help jobs are made available only to students who need them to help with college expenses. "We conduct personal interviews with each student who applies," Rainey says, "and the first consideration is need." From the interviewees, the store system fills the gaps in its shop personnel through a typical day on the basis of class schedules of the students. Shifts are constantly changing as the student workers hustle to meet classes while their replacements hurry to man the stores. Personnel for the system is not one of its problems, Rainey points out. "When school opens this fall," he predicts, "we'll have 50 to 75 qualified applicants in excess of the jobs we have." Students who have held the self-help jobs in past years are always given preference, Rainey says. He estimates 60 to 70 per cent of the system's student employees remain on the payroll during their East Carolina careers. Some of the applicants on the waiting list can be used during the system's rush seasons. In addition to the 65 who maintain clerk jobs in the four stores and the 35 who staff the vending machine service as many as 30 students are employed temporarily at the beginning of each quarter when student textbooks and other supplies are in heavy demand and during athletic contests when the system operates additional concession stores. Proof of the value of training provided for the self-help employees while on duty is personified in the manager, Rainey, a 1956 ECC graduate, went to work as assistant manager of the system immediately following his college days. Two years ago, he was promoted to his present post as manager when then-manager Mahlon Coles resigned. Another example is a February graduate of East Carolina who, after self-help employment in the supply store system

throughout his college career, accepted a position as manager of the student supply store at Campbell College, a Baptist school of about 1,600 students near Raleigh. Rainey proudly notes campus leaders are often among his student-employee ranks. "Right now, the summer school student body president is an employee . . . and the students' president for next school year is a former employee," he says. The ever-growing family of self-help students has evolved into an informal type of association. A highlight of the each school year is the student employees' Christmas party when one of their members is chosen for "Student Employee of the Year" honors. ECC President Leo W. Jenkins was on hand to present the trophy last Christmas. Growth and improvement in the supply store system is ample evidence that Rainey sports an acute awareness that, aside from the admirable by-product supplies, the stores must meet the text-book and commodity needs of the growing and bustling East Carolina student body. With that, his prime duty, in mind, Rainey suggests a thought with which it's difficult to argue: "It's a pleasant situation that a necessary element in the daily life of the college can be of service to the students in these various ways." Indeed it is.

Grifton Clothing Co., which settled in Grifton late in 1959, veteran Pitt industry Lutz & Schramm pickles in Ayden; Greenville's branch of Fieldcrest Mills, Inc.; and G&W Boats, Inc., of Greenville, have undertaken considerable expansion programs. A survey, based on the past six months, conducted by the Pitt County Development Commission, revealed some figures to measure the growth. Executive Director C. Keeping Two Sets Of Books Is Secret Of French Budget Work

NEW YORK (AP)—You can live within your means while going further into debt to build up your economic muscle. At least, some European countries, notably France, appear to be doing it. The secret is keeping two sets of books.

President Kennedy suggests the deficit-plagued U.S. Treasury might study this for pointers.

Some of his advisers urge that old-fashioned ideas like balancing the formal budget be tossed in the ashcan as meaningless in the new economic age they glimpse. Financial leaders, business executives, and many run-of-the-mill taxpayers are sure to brand this as heresy, as a step toward fiscal disaster.

The President says the important thing isn't achieving a balance every year in the formal budget, which he terms misleading in its present form, but assuring economic growth for full employment.

His budget director, David E. Bell, suggests one method, which he admits may be too far out for adoption: "Making budget decisions not in terms of the actual revenue outlook for the next year, but instead in terms of what the budget will look like in a year of full employment."

Both the President and the budget head take note of the European practice of having two budgets. One balances current operating expenses with tax collections to the apparent satisfaction of European legislatures. The other meets the costs of government loans, subsidies and public works by borrowing, without the naughty word deficit ever being so much as breathed.

If France kept its books as the U.S. Treasury does its administrative budget, France would have shown a deficit in each of the last 10 years.

Admirers of the European system point to the faster economic growth there than here without the question of Treasury deficits sparking monetary inflation ever being raised.

This is the difference in the U.S. and French systems:

The U.S. Treasury usually borrows from the banks to meet its deficits, and this creates a bigger supply of money and credit, with the danger of inflation. France and other European nations normally do their borrowing by selling securities to the public, and thus take away spending money.

rather than increasing credit. Critics of the French double budgetary standard charge that the apparent absence of a deficit tends to weaken the resistance of legislatures to more and more spending schemes—and some add that American legislative resistance is low enough as it is.

As for the United States, Bell contends that the belief common 30 years ago that balancing the budget is the only proper standard has been generally abandoned. More, he contends that today's dogma of balancing the budget over a business cycle—that is, deficits in recessions to boost business, and surpluses during recoveries to curb inflation—doesn't work under present circumstances.

Bell holds that in recent years business recoveries have not brought full employment or full use of industrial capacity. He says the government must step in with deficit spending to assure these goals, with resultant prosperity balancing future budgets.

Most businessmen and many congressmen are pretty sure to line up against this deficit spending theory.

Scientist Found Guilty Of Bomb Hoax 'Joke'

SAN FRANCISCO (AP)—Dr. Oleivig Von Roos, a California Tech rocket scientist, was convicted Friday of falsely reporting a bomb was in his luggage aboard a plane.

Von Roos, 37, made his "joking" remark to Miss Janice Evanson, 24, Seattle, stewardess aboard a Seattle to Los Angeles plane March 18.

U.S. Dist. Judge Michael J. Roche, who heard the case without a jury, found Von Roos guilty after the German-born scientist's attorney argued that it was "a crummy joke" but there was no intent to harm anybody.

Assistant U.S. Atty. David R. Urdan argued that the law doesn't absolve the defendant from guilt even though it was a joke.

Judge Roche set July 2 for sentencing. The maximum penalty for conviction on the charge, a misdemeanor, is one year in jail and \$1,000 fine.

Kay Starr Plans Marry Again

HOLLYWOOD (AP)—Singer Kay Starr says she will marry auto sales executive Earl Callcut of Reno, Nev. next November.

Miss Starr, married four times previously, said Friday they met last summer while she was appearing at a Lake Tahoe night spot.

"Since Earl's work is in Reno," she said, "and mine is here, we'll maintain two homes. I'll have to live like a gypsy but as an entertainer I'm used to that."

Miss Starr's name recently had been linked romantically with comedian Don Rickles.

Co-defendant in the suit was S. Robert Tralins, who wrote the book for Madame Sherry, identified as Ruth Barnes.

The book claims Farouk visited her Rancho Lido in 1952, the same year he lost his throne.

The suit, filed by a West Palm Beach law firm, said the dust jacket of the book contained the statement that "she (Madame Sherry) boasts that she was the only madam in all America to formally receive visiting royalty. She describes the receiving line of her girls who greeted King Farouk and the antics that ensued."

Farouk claims he has never been in America.

A Clarksville motor company which had been called to pick up an identical truck got Loooper's by mistake.

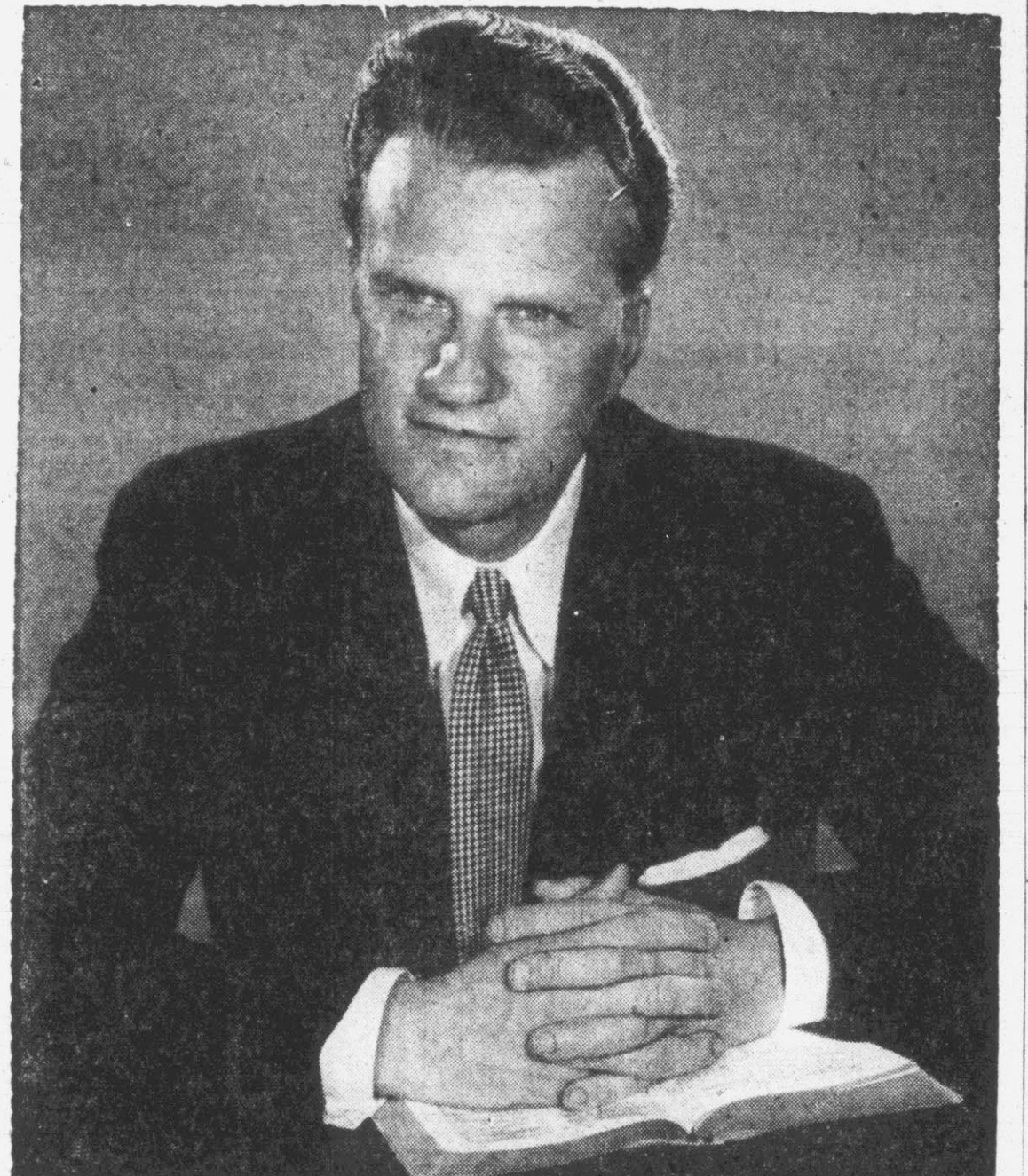
