U.S. Growing Impatient Over Hanoi Replies

WASHINGTON (AP) — The United States, indicating growing impatience with the impasse over where to make initial peace contacts with North Vietnam, is looking to Hanoi for a speedy reply to the latest American proposal listing 10 new potential sites.

called late Thursday on Hanoi to give a "serious and responsible answer" to the U.S. proposals for preliminary talks on peace negotiations. Rusk warned Hanoi that U.S. restraint in restricting the bombing of North Vietnam on March 31 was meant to inspire discussions on ending the war and not be an excuse for what he called propaganda warfare while the battle went on.

These diplomats, including some from nations allied with the United States in the war, reasoned that since neither Washington nor Hanoi has mentioned Paris as a possible site its compromise selection would result in neither side losing face. Premier Alexei N. Kosygin indicated how important such a face-saving compromise might be to Hanoi when he said Thursday in Rawalpindi, Pakistan, that North Vietnam will conduct peace talks "as a nation that has not been vanquished, that has not been defeated."

Noting the United States had already proposed Laos, Burma, Indonesia and India, Rusk added six more Asian locations—Ceylon, Japan, Afghanistan, Pakistan, Nepal and Malaysia. In Europe, he named the capitals of Italy, Belgium, Finland, and Austria in addition to the previously discussed Geneva, Switzerland. North Vietnam is said to dislike Geneva because Hanoi believes it was treated unfairly when the 1954 decision was made there to divide Indochina into North and South Vietnam with the 17th parallel as the dividing line.

Central Business Plans Reviewed

Plans for the central business district project for Greenville were presented to the Greenville Chamber of Commerce and Merchants Association at its board meeting Tuesday night. The presentation was made by Bob Anderson, planner with City Planning and Architectural Associates, Chapel Hill, and John Messick and Col. A. E. Dubber of the Greenville Redevelopment Commission. Members of the board asked questions and made suggestions concerning the business district project. Harold Creech gave a report on the industrial committee of the chamber and indicated the committee was successful in obtaining options on industrial sites. Creech said the industrial committee has been working with a number of industrial prospects, was planning the erection of a shell building and was planning a number of surveys and brochures to aid in attracting industry to the Greenville area. Mitchell Wooten, assistant manager, reported that plans have been completed for the

publishing of a visitor's services and accommodation guide in which all motels, service stations and restaurants, who are members of the chamber, will be listed. The guide will be distributed throughout North Carolina to promote Greenville as an excellent place to visit or hold a business meeting or convention. The board members passed a resolution to request that the North Carolina State Highway Commission improve and widen N.C. 903 from the intersection of N.C. 125 and N.C. 903 to the intersection of N.C. 903 and N.C. 33. The members also voted to send a resolution to President Lyndon Johnson and members of the Congress urging that legislation be enacted to cut spending and attempt to achieve a better national fiscal policy.

Needed To Help Fund Current Expense Budget

City School Board Sets Tuition For Out-Of-District Students

Greenville school board members last night set a tuition charge of \$60 per year for out-of-district students attending city system schools in order to boost income to help fund a \$579,182 proposed current expense budget approved at the special session. The city school budget will be presented to the Pitt County commissioners. The city school system is financed, in part, by county-wide avallorem taxes. About one-third of all the taxes levied county-wide for education go to the Green-

ville school system. The exact ratio is based on the ratio of students in county schools as compared with students in the city system. The \$60 tuition charge is expected to bring in about \$12,000. Some 200 students from outside the Greenville school district attend school in the city. A \$1 per pupil fee was dropped by the board last year in the interest of making "free public education" a reality. The budget as approved last night is \$25,625 less than a \$604,807 figure reviewed at the group's regular meeting Monday. Last year's current expense budget totaled more than \$560,000.

Major reductions include \$6,000 for two part-time high school teachers, \$1,000 each for building repairs and supervisors salaries, \$1,500 for an elementary teacher aid and \$2,000 for repairs to equipment. In addition to the current expense budget, school board members approved a tentative capital outlay expenditure schedule totaling \$248,000. Major expenditures in the current expense list include \$27,500 for administration; \$306,762 for instructional services (including teachers salaries); \$91,100 for opera-

tion and maintenance of plant (including janitors, maids, fuel and utilities and repairs to buildings and grounds), \$50,870 for fixed charges such as social security, insurance and auxiliary agencies (with bus operation costs, libraries, driver training, lunchrooms and other items included). Capital outlay expenditures would include \$165,000 for new buildings and grounds (including \$50,000 each for new buildings and furnishings, and \$71,000 for sites and new site improvements); \$80,500 for old buildings and grounds (with \$10,000 for improvement to existing sites, \$15,000 for

heating systems and \$21,500 for furnishings); and \$32,500 for auxiliary agencies (new buses, driver education cars, and other items). Board members, in approving the tuition charged, expressed regret at the move but indicated it is necessary in order to raise additional funds needed to carry on the total school program. Parents of out of district students do not pay Greenville school tax and this, the board agreed, would tend to tax those persons outside the district who use Greenville school facilities.

Local Phone Users Still Unaffected

A nationwide strike of AFL-CIO Communications Workers of America is not expected to affect service to local Carolina Telephone and Telegraph Company customers. Carolina Telephone's Greenville manager, Linwood Langley, said "presently the strike is not affecting us," he added the strike might affect some customer service in long distance eventually.

He said the walkout by the communications workers would affect incoming calls that are operator handled. Direct dial calls should not be affected immediately, he explained. Long distance calls placed from Greenville, Pitt County and other areas serviced by Carolina Telephone should not be hampered. Langley added, however, the five Western Electric employees, installing equipment in the new addition to the telephone building, walked off their jobs due to the strike. He noted that the installation of equipment is in such a condition that the local company can manage with the Carolina Telephone employees. The strike is primarily affecting the American Telephone and Telegraph Company, parent firm of the Bell System. Western Electric is a subsidiary of Bell.

Post Office Contract Awarded

Congressman Walter B. Jones announced today the award of a contract for construction of the new Greenville Post Office.

He said the Norfolk builder-investor Fine and Salzberg, apparent low bidder on the project in Greensboro last February, has received the contract and will complete the building within one year. Estimated construction cost is \$360,130. The Post Office Department will rent the building for about \$35,500 a year under a basic 20-year lease with six 5-year renewal options. A spokesman for Fine and Salzberg said today, "We are very happy to receive this contract and look forward to beginning construction within the next 30 to 60 days."

"We are thankful for this opportunity to have a part in the rapid development of the Greenville area." He added that the Norfolk firm may handle the construction job itself, or it might use a Greenville area contractor. The new facility is to be built on a block bounded by Greene, Pitt, First and Second streets. The site is located one block south of the Tar River, in the west end of the city's Shore Drive Urban Renewal Project. Inside floor space of the new post office will be nearly 23,000 square feet. It will have a 28,000 square-foot loading platform and will have parking and maneuvering area of more than 48,000 square feet.

Wallace was reelected for a one-year term. Noah G. Raynor of Greenville was reelected vice president and Mrs. Alice Hudson secretary of the Greenville Tobacco Board of Trade, was named secretary-treasurer. W.E. Cobb Jr. of Rocky Mount was elected to the newly created post of assistant vice president. Four persons were named to serve with Wallace, Raynor and Cobb as Eastern Belt representatives on the Bright Belt Warehouse Association Board of Governors. They are W. A. Tripp of Greenville, J.R. Rogers of Williamston, Bennie Bell of Farmville and Harold Veazey of Hoki.

Rates Hiked By Federal Reserve

WASHINGTON (AP) — Americans face the prospect of harder-to-get loans at higher interest rates following the second increase in little more than a month in the Federal Reserve System's discount rate. In what it termed an attempt to beat back accelerating inflation, the Federal Reserve Board stepped harder on the economic brakes in approving effective today a discount rate of 5.5 per cent for 3 of its 12 banks—New York, Philadelphia and Minneapolis. It had been 5 per cent. The other nine banks are expected to follow in a move virtually sure to trigger higher interest rates on loans throughout the economy. A nationwide AP survey showed meanwhile that interest rates on home mortgages are nearing 8 per cent already in some sections and the cost of a average home has climbed about \$2,500 since 1966. The new rate is the highest since just before the 1929 stock market crash when it went to 6 per cent. One government source said the boost from 5 per cent was not unexpected in view of congressional inaction on President Johnson's request for the 10 per cent income tax surcharge, pushed by the administration as an anti-inflation weapon.

Plants Idled At Prison After Uproar

RALEIGH (AP) — The industrial plants at Central Prison will remain idle the rest of this week in the aftermath of a bloody uprising early Wednesday that left six prisoners dead and 77 injured. Crews were busy Thursday cleaning up the debris in the prison yard where more than 400 inmates staged a sit-down strike that boiled over into a riot. "The trash has been cleaned up in the yard, but inside the building it's still a mess," said Central Prison administrator David Henry. "Plumbing had been ripped out."

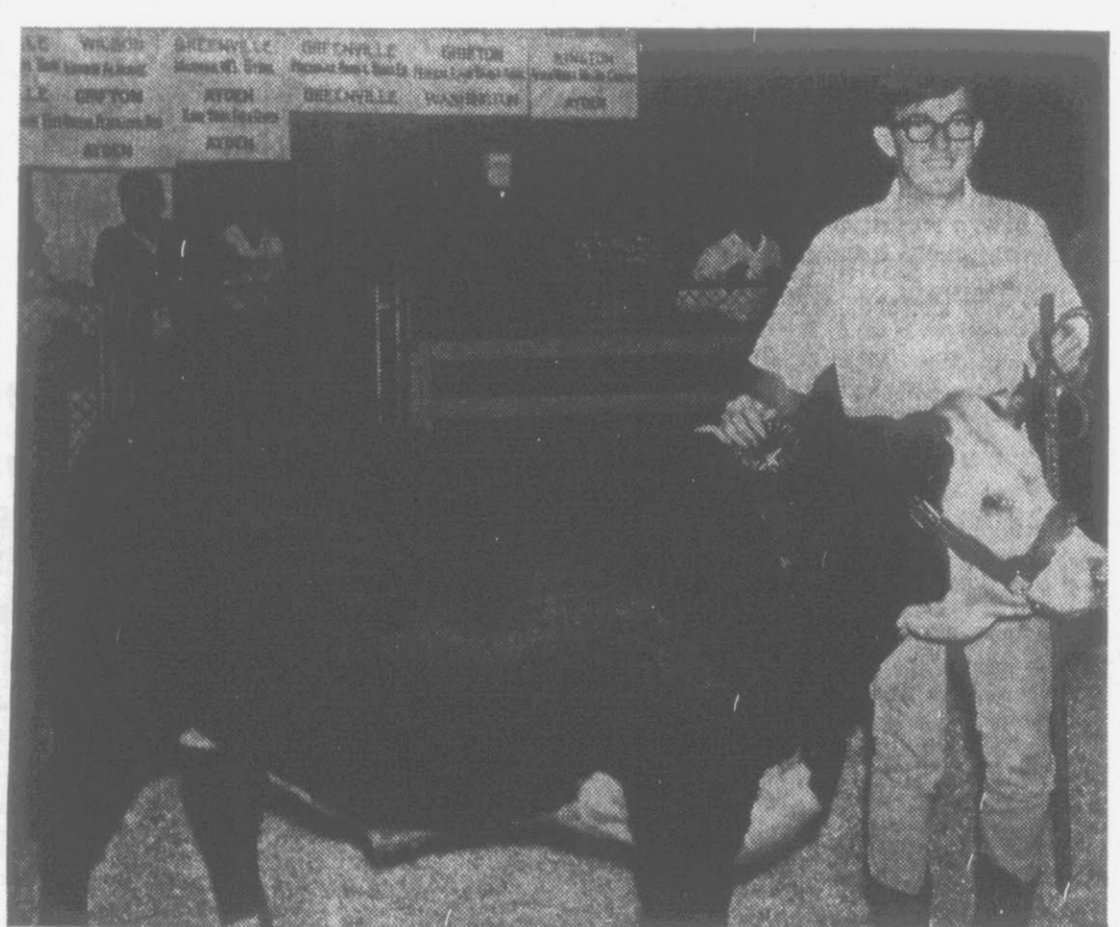
Less Congestion On 1968 Market

SMITHFIELD, N.C. (AP) — The president of the Eastern Carolina Warehouse Association says indications are that there will be considerably less congestion on flue-cured tobacco markets this year than in 1967. Lawrence H. Wallace of Smithfield told the organization's annual meeting Thursday that congestion will be reduced or alleviated by season-long sale of both tied and untied with price supports. In past years, untied sales with price supports were allowed only part of the season. He said the outlook for a substantially smaller tobacco crop also will help improve the marketing situation.

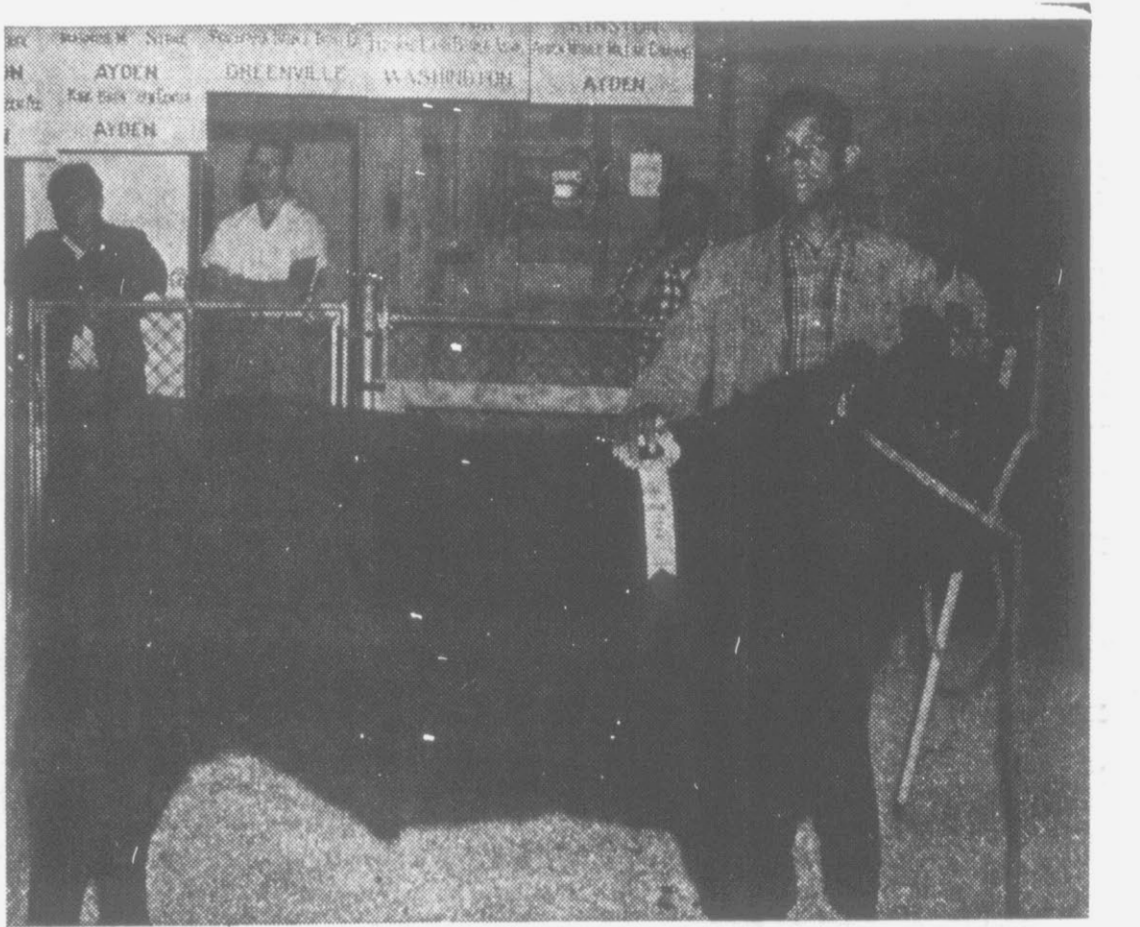
No Truth In Ky Story, Says Embassy

SAIGON (AP) — Both the U.S. Embassy and Vice President Nguyen Cao Ky today denied a report being investigated by a Senate subcommittee that the CIA fired Ky for smuggling opium in 1963. The report, made to the Senate Foreign Expenditures subcommittee, said Ky commanded air crews in a secret CIA operation flying saboteurs to North Vietnam and took advantage of the setup to fly opium from Laos to Saigon. The U.S. Embassy said there was "no truth in the story that Ky was removed from any position by any element of the U.S. government for opium smuggling or for any other reason."

# Thousands Of Voters Unregistered

There is only one day remaining in the voter registration period for Pitt County voters.

Those citizens whose names have not been placed on the new voter registration books by the time the registration period ends at 6:30 p.m. tomorrow will not be eligible to vote in the May primaries. No matter how many times a voter has registered prior to this registration period, or how long he has lived and voted in this county, he is not eligible to vote unless he has registered during the current registration period that began March 30.

Through Thursday there were approximately 16,500 people who had registered to vote in Pitt County. That represents approximately half the number of names on the old voting books that were formerly used. It means there are literally thousands of otherwise eligible voters in Pitt who have not

gotten their names on the new registration books.

We strongly urge each citizen who has not registered during this new registration period to do so tomorrow. After that, it will be too late.

It is important to the individual citizen that he register in order that he will be eligible to vote. If he does not register, he forfeits his most precious democratic right . . . the right of voting in a free election. It is also important to the county as a whole that the individual citizen register and vote. Pitt is a large county from a population standpoint and it has traditionally cast one of the larger county votes in this section of the state. More important still, the county is denied the benefit of the ballot box expression of those citizens who fail to get their names on the registration books.

Unless several thousand additional Pitt citizens register tomorrow, they will deny themselves the right to vote in the forthcoming elections. They will also deny the county benefit of their participation in the election of local and state officials.

# Politics Builds Into High Gear

RALEIGH — This Spring's political campaigns have been unusually quiet and subdued and conducted in a sometimes mystifying low key up to the final few weeks.

Now, however, there are signs of a building crescendo—strenuous efforts by campaign organizations to move into high gear before election day, May 4. Also, surprisingly, a great deal of confidence about the outcome can be found in any of the campaign headquarters. Apparently this has been generated by the recent build-up of campaign tempo.

Some of the candidates also have planned extensive newspaper advertising campaigns for the primary wind-up. Some already have begun buying full page ads. But television commitments are expected to prove even more expensive. No exact figures are available but sources close to the campaign headquarters admit that the buying of television time during the two weeks prior to primary election day accounted for a major part of the candidates' projected budget.

"We felt we had to do it," says one of the campaign managers. He added that all media were included in campaign planning—newspapers, radio, television and billboards. Other possibilities were considered as well. Several political candidates also have spent many thousands of dollars on professional type polls which purport to indicate preferences and outline issues which might be exploited.

**Fair Treatment**

The state's broadcast media, represented by the N. C. Association of Broadcasters, has pledged "fair treatment" to all political candidates insofar as purchase of time is concerned.

The pledge is by NCAB president Paul B. Marion of Charlotte who says any report that a single candidate has or will be able to buy so much television time that other candidates are turned away "is completely false and unfounded." He says neither federal regulations nor ethics of the industry would permit such a situation which a political candidate could "corner the market on political advertising."

**Number of Races**

Marion added that because of the number of political races in the state, some stations have set limitations on the amount of time to be made available for political advertising. But in every case, he said, opposing candidates will be assured of "equal treatment."

# Coincidence, Or Not; Investigation In Order

It may be mere coincidence that at least three major warehouse fires have occurred in the eastern section of North Carolina in the past week. Coincidence or not, a good many people would feel a great deal better if there were a thorough investigation of the fires by state fire officials and other investigative bodies.

On Saturday night a loss estimated in \$100,000 resulted from a warehouse fire in Robersonville. Early Wednesday morning fire was discovered in a tobacco warehouse at Fuquay-Varina. It quickly burned the structure to the ground resulting in a loss estimated at \$234,000. During the day Wednesday fire struck in the Rocky Mount tobacco warehouse district causing the city's worst blaze in 40 years and resulting in damages that are expected to run several hundred thousand dollars.

The similarity of the fires and the rapid succession in which they occurred arouses suspicion that arson may be involved. These factors likewise raise the question of whether there may be some connection with the fires in these three separate communities.

# Moving Toward Direct Action

WASHINGTON (AP) — The killing of thousands of pigs by farmers demanding higher prices for them dramatizes a rising interest among farmers in direct action rather than continued reliance on the complex and elaborate federal programs designed to help them.

The direct approach is also evident in Congress, where farm legislation of an entirely new kind is being considered, based on the collective bargaining procedures guaranteed to labor and industry 30 years ago.

During those three decades, the government, in an effort to hold down farm production and stabilize prices, has erected a dizzying edifice of farm law.

It takes 108,000 people to run the Department of Agriculture and it was only half-jokingly that an amendment was offered a few years ago prohibiting the department from acquiring more employees than there were farmers.

Yet despite costly, often confusing legislation the problems it is supposed to solve continue. Farm prices still fluctuate sharply, production increases yearly and farm income last year was lower than it was 20 years ago.

For the small farmer—the so-called "family farmer" Congress talks the most about helping—the situation grows steadily worse. Unable to take any of his small acreage out of production to qualify for price supports, he gets almost no benefit from the programs. Squeezed by higher costs for everything he needs, he is being forced off the land.

In the last 15 years, 15 million people have moved from the farms and rural areas into the cities, compounding the urban problems now tormenting the nation.

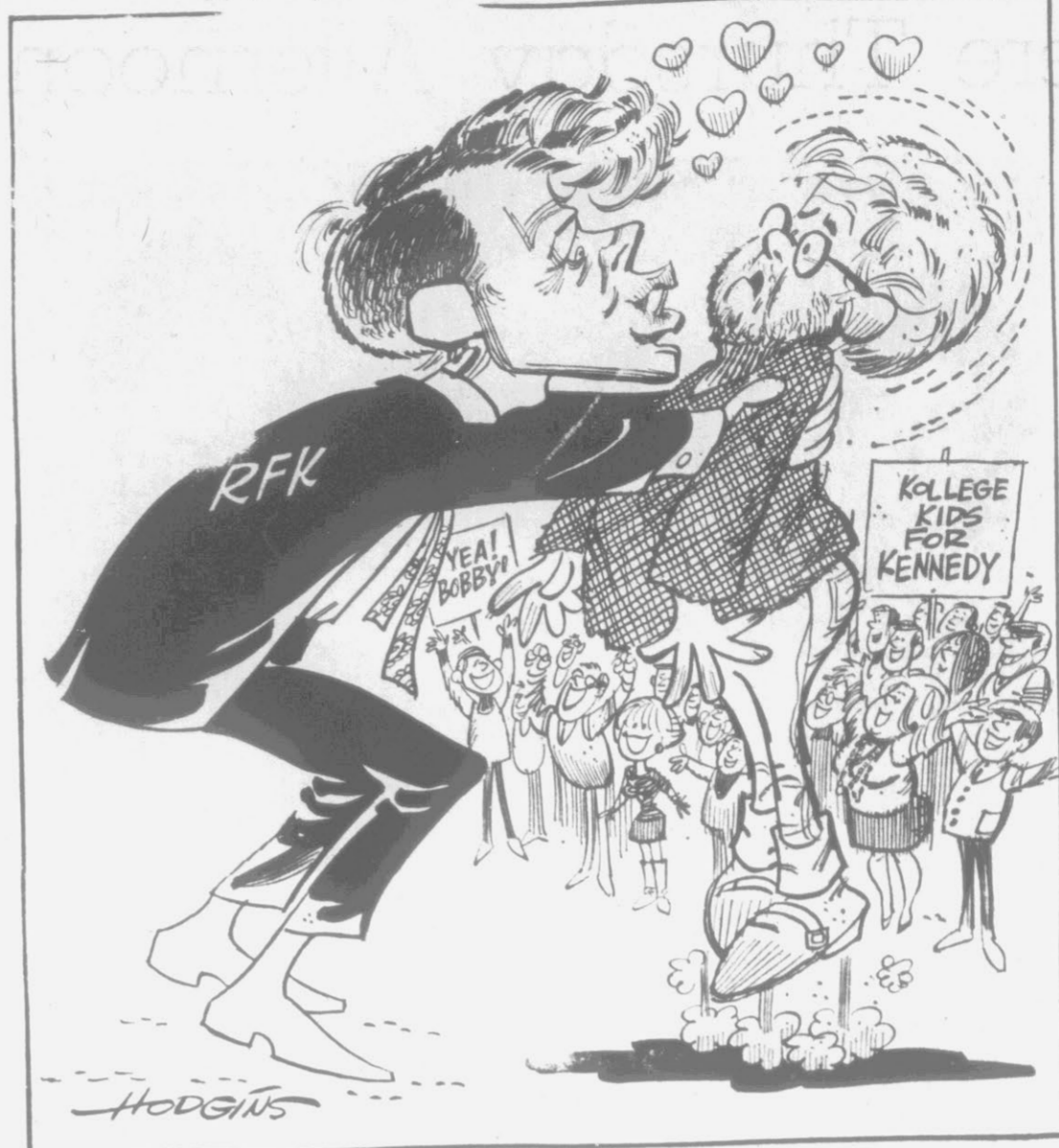
The words of an unknown author were put in my hands recently and I pass them on to my readers with the conviction that they will be helpful.

# Visit To Rumor Factory

WASHINGTON — While many businesses suffered during the recent disturbances in our American cities, there was one that thrived—and that was rumor-making. The rumor factories in Washington were going full steam during the crisis and still they couldn't keep up with the demand.

I visited a rumor factory in the nation's Capital the other day and was given a tour by the foreman, a jolly, round-faced man named Clarence, who has been manufacturing rumors for 30 years.

"We've been going 24 hours a day for the last two weeks, and we've yet to fill all our orders," Clarence said, as we walked around the large air-conditioned building.

"I know this is a silly question," I said, "but how do you make a rumor?"

"It's not hard once you get the formula," Clarence told me. "Over here we have the raw facts. Now you mix them with gossip and fantasy, put them through this machine, and they come out a solid rumor. The process doesn't take long, a matter of minutes; but in order for a rumor to have any substance, it has to be kept hot. That's what those burners over there are for. They can heat up a rumor in seconds."

"Where do you get your raw materials?" I asked him.

"Mostly from bars and hairdressers. We have a staff that does nothing but collect bits and pieces of rumor material which they bring in at the end of the day. The ones we don't use right away, we bale and store in a warehouse for later use."

"For example, right now, because of public demand, we've been working on racial rumors, so we've been storing the political tidbits for later on in the year, just before the conventions."

"Racial rumors, we had a big run on Vietnam rumors, but that's died down for the moment."

"How do you distribute your rumors?"

"Distribution is no problem. A lot of them are distributed through taxi drivers; others are dropped off at the press club; some are left on street corners, and, of course, there's always the telephone. During a racial crisis our rumors hardly get out the door before they're grabbed up and spread all over town."

"We walked into another room where several women were inspecting the rumors as they came off the line."

"This is our quality control division. Every rumor that leaves our factory is carefully inspected for holes in it."

"Then you do reject rumors?" I asked.

"We certainly do. A rumor has to withstand tremendous pressure in order to work. If it doesn't hold up, it's not going to be circulated, and pretty soon people will be going to other places to buy their rumors. We've even called in rumors because of a flaw we've discovered in them after they've left the factory."

We walked to another part of the factory and the foreman said: "This is our research and development division. We're constantly trying to find new methods of making rumors. We had a big breakthrough not long ago. We found out a way of taking old rumors and using them again."

"One of our lab assistants discovered that by taking a rumor circulated in Chicago and doctoring it slightly and fixing it up, it would look like a brand-new rumor for Washington. We're franchising the process for other cities. They'll buy our old racial rumors and in exchange we'll buy their old rumors. This source of supply will go on forever."

"What happens when you put out a rumor and it turns out to be true?"

mer. The process doesn't take long, a matter of minutes; but in order for a rumor to have any substance, it has to be kept hot. That's what those burners over there are for. They can heat up a rumor in seconds."

"Where do you get your raw materials?" I asked him.

"Mostly from bars and hairdressers. We have a staff that does nothing but collect bits and pieces of rumor material which they bring in at the end of the day. The ones we don't use right away, we bale and store in a warehouse for later use."

"For example, right now, because of public demand, we've been working on racial rumors, so we've been storing the political tidbits for later on in the year, just before the conventions."

"Racial rumors, we had a big run on Vietnam rumors, but that's died down for the moment."

# Bobby Likes A Gamble

INDIANAPOLIS — Just before the March 28 filing deadline for the Indiana Presidential primary, Sen. Edward M. (Ted) Kennedy and other agents of his brother placed call after call to friends in the Indiana Democratic organization and got this same answer each time: Don't come in!

The Kennedy men were told that Gov. Roger Branigin and the regular organization would out Sen. Robert F. Kennedy to pieces. Besides, they said, Branigin would defeat Sen. Eugene McCarthy so badly in a two-man race here that the Kennedys could forget about McCarthy. In effect, they told Teddy Kennedy: We'll take care of McCarthy for you if you bypass Indiana.

Despite this advice, the decision to enter Indiana was concurred in by all key Kennedy advisors. A private poll by John Kraft did show Kennedy only a short distance behind Branigin, but this was not the reason for disregarding the counsel of their Hoosier friends.

Rather, the Indiana gamble typifies the audacity with which the Kennedys have always played politics and exactly duplicates the gamble taken by John F. Kennedy in West Virginia in 1960. By running in a state where the cards seem all stacked against him, Bobby Kennedy risks disaster in search of a win that might start the bandwagon moving.

Transforming Branigin from stand-in for President Johnson to favorite son candidate has made no essential change in this strategy. Rather, Kennedy men claim that Branigin as favorite son is more formidable than as LBJ stand-in (an unprovable contention which some Hoosier politicians believe exactly contrary to the facts.)

The psychological warfare campaign began the first week of April when Kennedy operative Pierre Salinger on a visit told local newsmen how difficult it would be for Kennedy to beat Branigin. Ted Sorensen, a member of the Kennedy high command, went a step further last week by telling Indiana reporters that Kennedy's real goal was only to come in second here ahead of McCarthy, so formidable is Branigin. In private, of course, Kennedy advisors concede that they must win here to be nominated.

This exaggeration of the difficulties Kennedy faces in Indiana are, unwittingly, reinforced by pro-Branigin politicians accustomed to the organization getting what it wants. They simply cannot conceive of a Kennedy win. With one of the last statewide patronage systems giving an incumbent governor iron control over the state party, all but five of 92 county chairmen (many of them state employees) have announced for Branigin.

Besides this, State Chairman Gordon St. Angelo is one of the nation's rising young political technicians and has introduced computer techniques to Hoosier politics. Branigin's campaign will not be the slapdash, jerry-built effort put on for President Johnson in Wisconsin.

But neither technical proficiency nor Kennedy's unpopularity in rural areas of this conservative state justifies the underdoggy spread by Salinger and Sorensen. Many

# Gold Speculation May Return

Gold speculation may return to the United States. Now that the Treasury no longer buys or sells gold, leaving that to licensed dealers, there is only one reason that buying and selling gold should not be as free as the sale of AT&T or IBM stock.

But that's an important reason: a free market in gold might set off a wave of speculation that would increase the gold drain.

Here's why: There is not much gold available for buying and selling in the United States. Heavy speculation would result in sending large amounts of dollars to London, Paris, Zurich and the other free markets for transfer of gold here and, once overseas, it could be exchanged through central banks for U. S. Treasury gold.

Even a law prohibiting the

import of gold on private accounts would not top the gold drain, because American speculators would be tempted to buy certificates of gold deposit, which would require the shipment of dollars abroad.

either in foreign deposits or smuggled imports.

Meanwhile, in anticipation that gold trading may be allowed in the U. S., a number of banks and other institutions have filed applications for licenses to deal in gold. Licenses can sell only to other licensees at present, but that would be changed if Americans were legally allowed to speculate in gold.

In addition, the New York Commodity Exchange is preparing to deal in gold when legally permitted. A committee is already at work on a proposed futures contract and preparing rules for trading, the degree of refinement, and delivery points.

The principal licensed dealer in gold today is Engelhard Minerals and Chemicals Corp., of Linden, N. J., which sells only to other licensees, principally in jewelry and den-

istry. They are also more than 225 other licensed sellers, mostly refiners, and 800 licensed buyers.

**What May Happen Here**

What can happen here is illustrated by a report from one of my spies, who was in Toronto when gold trading was resumed. He stood in line at the "gold window" at a bank with a half a dozen others. "All looked seedy and shabby as if they didn't have the price of a cup of coffee," he said. But when their turn came, they pulled currency out of pockets and hats. Some had suitcases for carrying their gold away.

"I was treated with utmost courtesy," he reported. "They asked me if I wanted to trade through London, Paris or Zurich."

He asked to see some gold and was ushered into a vault.

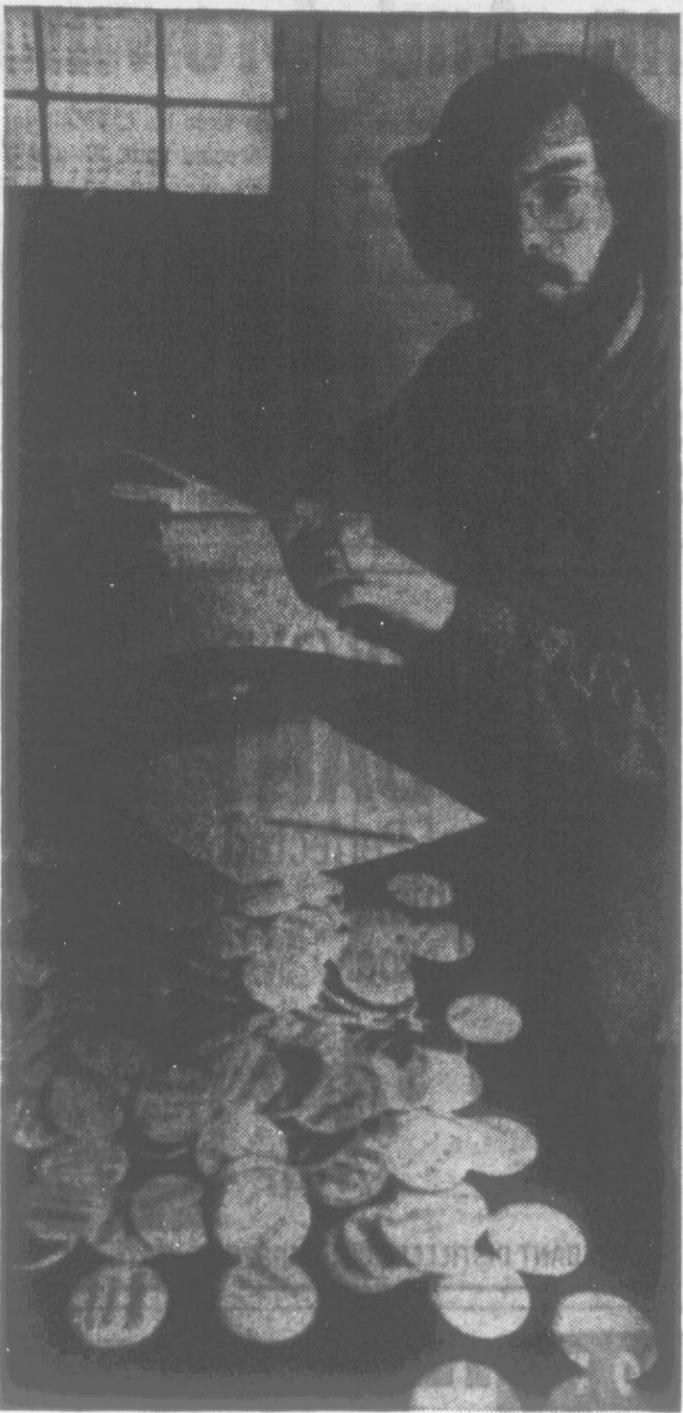

(Continued From Page 4) The gold bars were one kilo, worth about \$1,400. He said he wanted only a few ounces. The bank had no small bars, but a kindly clerk explained that service charges and cablegrams would wipe out any possible profits on such a small amount.

It was not until he had stood in line at a fourth bank that he found a 10-ounce bar for immediate delivery, which cost \$373.50 in U. S. dollars, or 8.75 per cent more in Canadian currency. The bar was stamped, "Engelhard Gold Makers of Newark, N. J.," along with figures indicating it was 9.960 fine.

Having a touch of arthritis, he tied the bar to his shoulder that night. In the morning, the pain was gone, he said. But the morning paper headline said: "Gold Price Declines." He called the bank and was told the price was \$36.96 an ounce. He dashed over there, the price had dropped a cent to \$36.95, and there was a 92 cent commission for turning in his bar. He net loss was \$6.40, not counting the phone call.

Moreover, St. Angelo promises he will not tap the huge war chest (raised partly by 2 percent salary checkoffs from state employees) reserved for electing a Democratic Governor in November.

Besides, Kennedy is now building an organization here from the bottom up under the direction of Lawrence F. O'Brien, with paid non-Hoosier coordinators in each Congressional district. Nobody but Kennedy has both the money and expertise to put this together so quickly.

Finally, Branigan, a witty and toughly independent man who gives Hoosiers the conservative - style government they want, may not be fitted for Presidential politics. His charming distaste for mass media was shown last week when, incredibly, he turned down repeated requests by CBS for a TV interview. More important, he must counter Kennedy's charges that he is not a real candidate for President by making the point his victory would give Indiana bargaining power at Chicago.

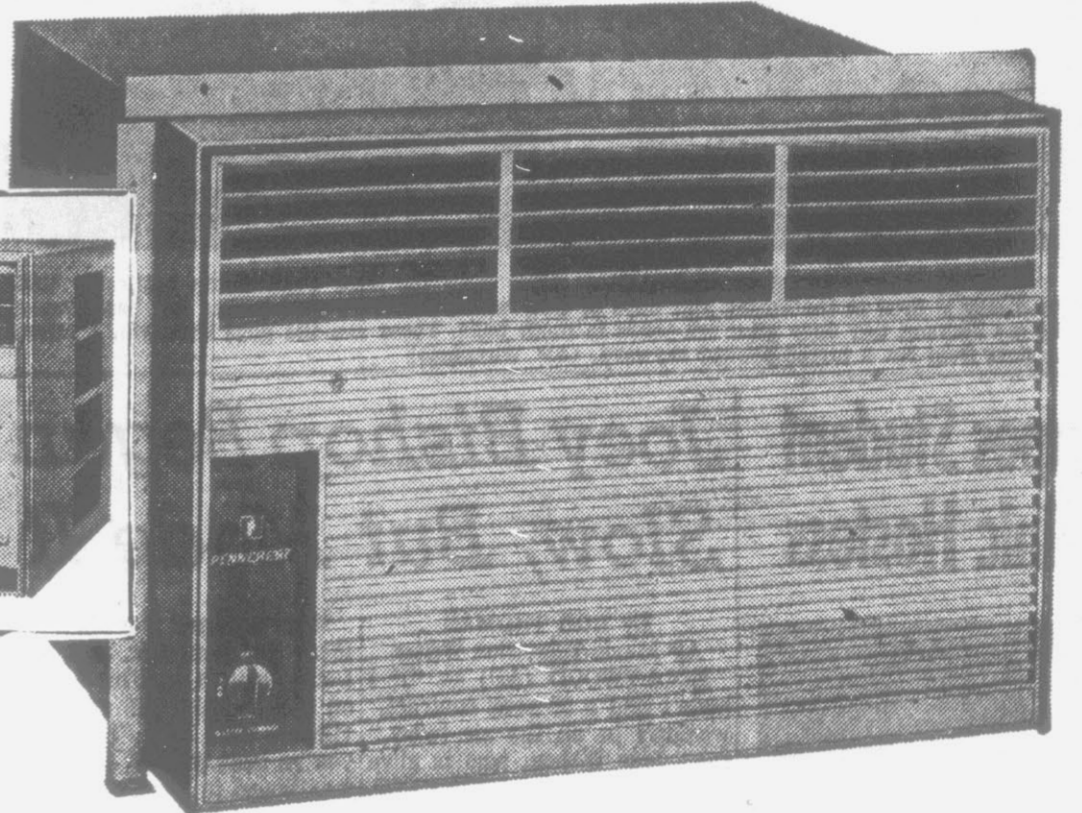
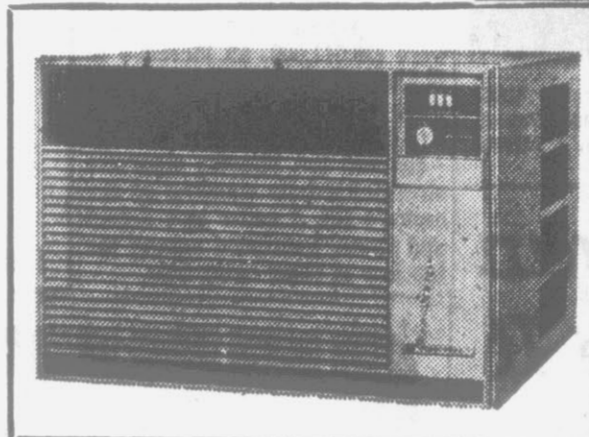

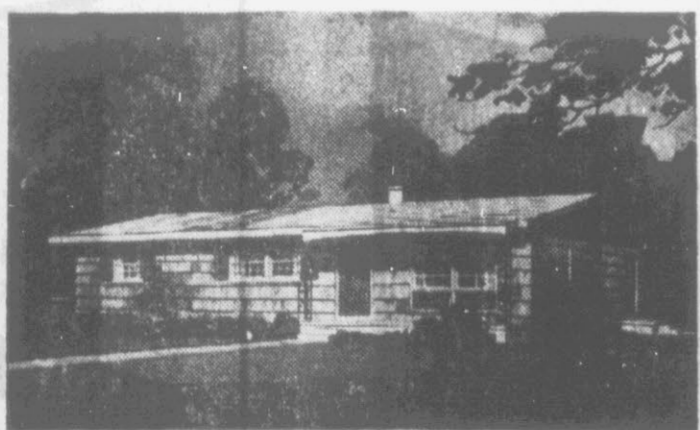

# 'Hospitality Business' Evolving And Growing

NEW YORK (AP) — The definition of hospitality remains the same in any man's language, but the business of hospitality, which includes motels, is evolving and growing like few other businesses in America today.

Taking to the road this summer, vacationers in the 48 contiguous states and the District of Columbia will find at least 5,825 motels of 50 units or more offering a total of 581,388 rooms. Count Alaska and Hawaii, and add in the thousands of rooms in motels of fewer than 50 rooms, and the figure swells. There will be at least 65,500 more motel rooms than a year ago.

The latest count by Helmsley-Spear, a real estate firm whose

motel census is widely accepted, shows California in first place with 63,211 rooms in 653 motels. Florida is next with 590 and 57,600, and Texas, New York and Illinois follow.

Now consider that this business barely existed 30 years ago and you can visualize the evolution and growth. Motel's today are big business.

"A husband and wife still can operate a 20- to 40-room motel successfully," says Stephen Brener, Helmsley-Spear motel consultant, "but beyond that size they get into something that demands professional assistance."

The reason is that guests today are looking for more than overnight accommodations. They want convention rooms, lobbies, showrooms, restaurants, bars, swimming pools and even bellhops, which for a while were left behind at the hotels. Do-it-yourself, once a trademark of motels, may be going

out of style. All this demands big investments. A 100-room motel with a restaurant and most facilities now costs about \$1.5 million, Brener says.

He provides these per room costs: Basic construction \$6,000 to \$8,000; restaurant, parking lot, swimming pool and other facilities \$4,000; furnishings, fixtures, equipment \$1,500; and \$1,000 to \$2,500.

These are averages. A room alone doesn't cost \$12,500 to \$16,000. But per room costs, prorated for the expenses of installing and operating the restaurant and other facilities, do come to this seemingly high figure.

What is often considered the beginning of the motel industry was Askin's Cottage Camp, erected back in 1901 at Douglas, Territory of Arizona.

Askin's charged 50 cents a night, plus 25 cents for coal to fuel the heating-cooking stove in the room. The facilities which

the traveler now takes for granted were in the backyard. Brener believes the word motel was first used in 1925 at San Luis Obispo, Calif., when an enterprising businessman opened a "Mo-Tel."

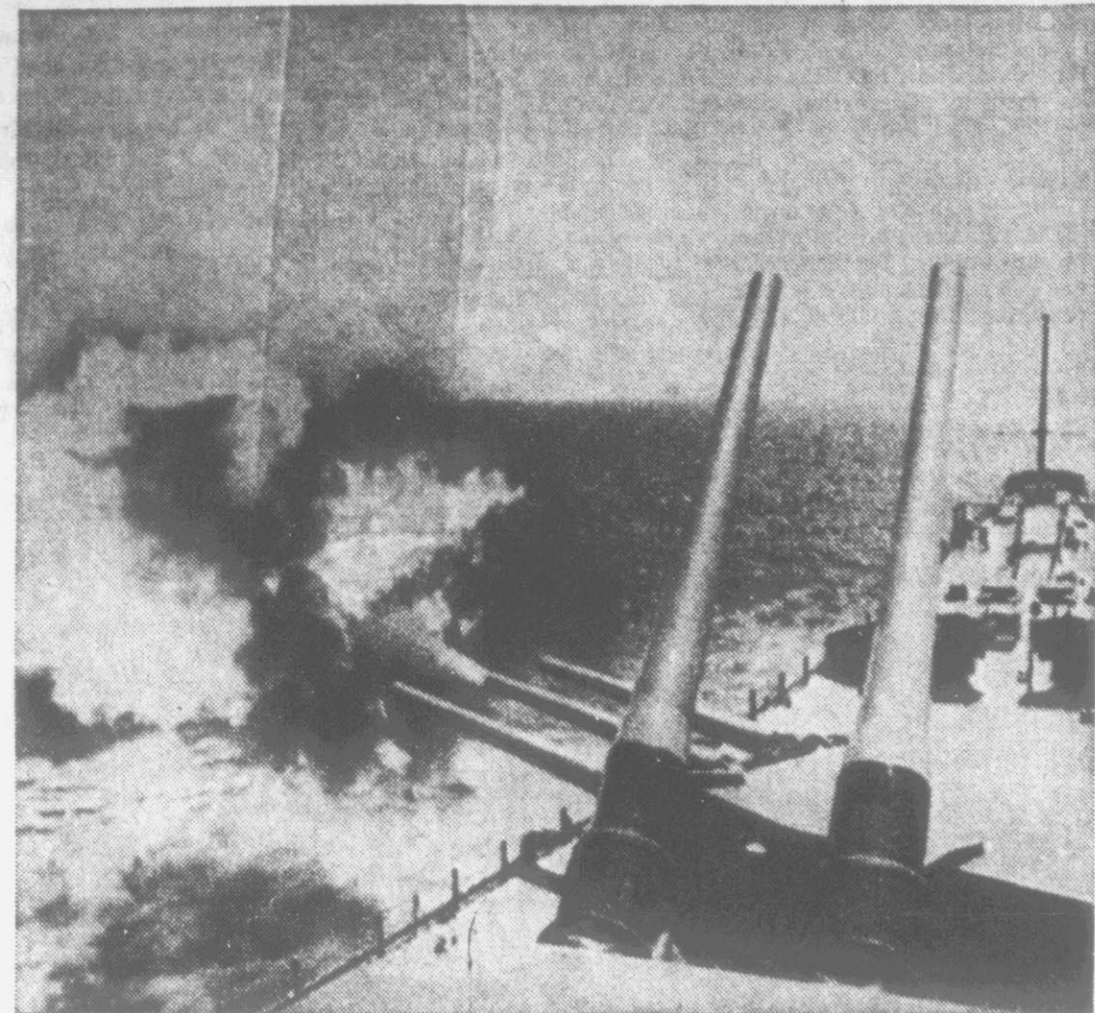
The real spurt in the business came after World War II when there was still a shortage of rooms for transients. Hotels, which had been bankrupt during the 1930s, were operating at nearly total capacity.

To meet the need, and as

roads were built, small developers erected their 10- and 20-unit motels.

Twenty years ago a 25-room motel was considered large, says Brener. Ten years ago the figure had risen to 50, five years ago to 100, and now to 500 and even 600.

Several of the big hotel chains now are in the business as well as franchisers. Recent construction has been largely by these professional operators rather than an individual businessman.

But with me! For six months there had been talk about what I was going to do. Finally I went on the air, and the critics and viewers were told: 'This is what you've been waiting for!' There was bound to be some hostility.

"I was against selling the show; I thought it was a mistake to come on too strong. I said, 'Let's go on quietly and have the show start to build.' But it wasn't done that way, and I got clobbered."

Bishop refused to panic when ratings thumped into the cellar. He continued working hard on preparation, spending long days at his Vine Street headquarters. His campaign to build an audience wasn't aided by a network strike which kept his show off the air for three weeks; the rating dropped while re-runs played.

But then the show started to climb. The Johnny Carson show on NBC continues to top the ratings, but ABC officials are eminently satisfied with Joey's performance, as evidenced by this week's renewal. Bishop obviously enjoys his work.

"Without being too hammy about it, I would say that the greatest satisfaction with the show is in being able to do some good for humanity," he remarked. "Like when an orphanage notified us that tickets to its benefit were selling poorly. We mentioned it on the show and sales jumped from \$4,000 to \$27,000. That sort of thing gives you a kick."

HOLLYWOOD (AP) — "If I hadn't had a 39-week contract, wouldn't be on the air today," says Joey Bishop, who is alive and thriving on late-night ABC.

This week marks the first anniversary of Bishop's brave foray into Carson country, and he received a handsome anniversary present from the network: a 39-week extension of his contract, putting his show into the fall of 1969.

Between celebrations, the sad-faced comic paused to reflect on the events of his year of entertaining the insomniacs. A veteran of four rugged years with a weekly series, he takes a realistic view of the television rate-race.

"If I had only a 26-week contract with ABC, I'm sure the network would have dropped me," he reasoned. "When you're set for only 26 weeks, that means that the executives will be making their decisions during the first 13 weeks. That could have been fatal for me."

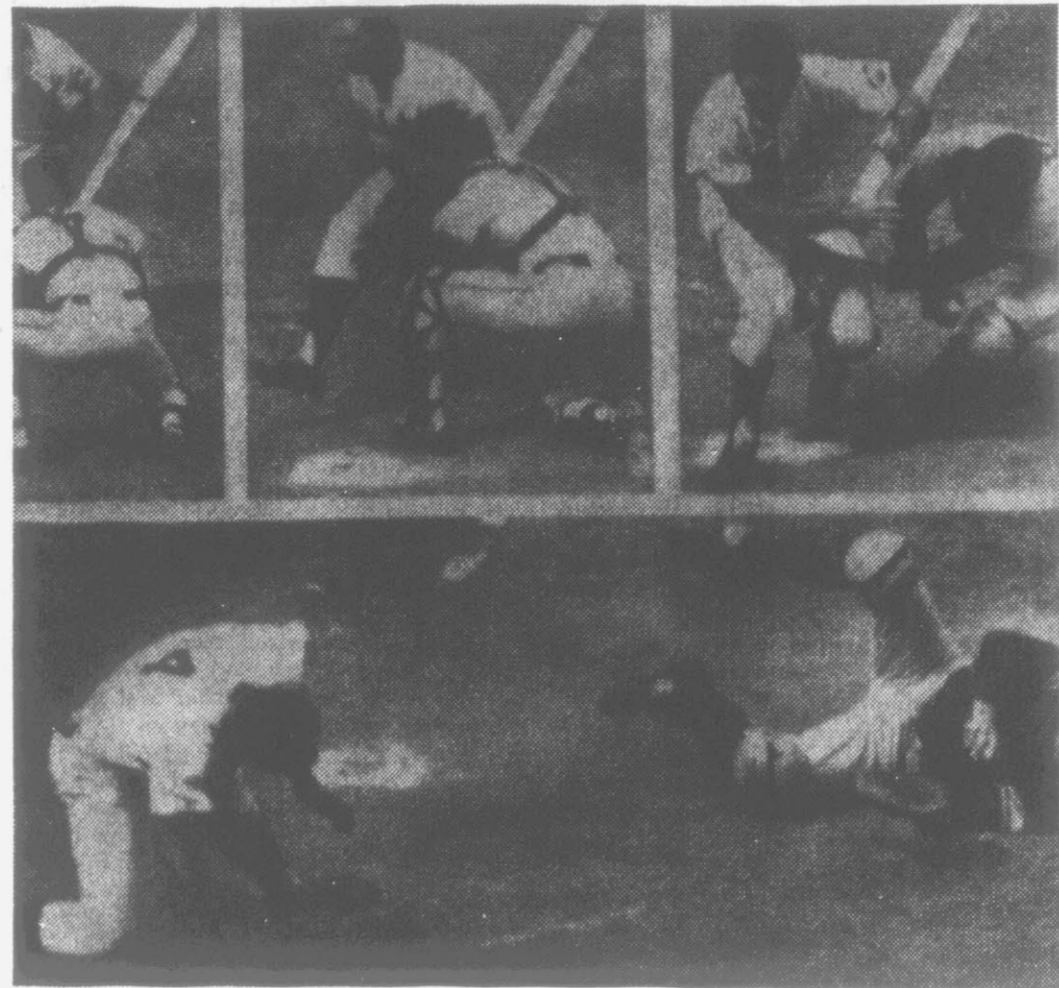

Ted Williams is looming right up ahead, but Mickey Mantle has his sights set on Jimmy Foxx.

The home-run countdown season began in earnest Thursday night when the Yankee slugger hit his first one of the season in New York's 6-1 victory over California.

It was Mantle's 519th career home run, just two short of Williams' total, which is now the fourth best ever compiled. Foxx' total is 534 and Mantle is trying for a crack at it this year.

"I don't set goals," Mantle said after the game, "but I would be nice to pass Foxx this year."

Ahead of Foxx are Babe Ruth with 714 and Willie Mays, who has 565 and is probably good for

[a few more yet.

"What I want to do is finish third," said Mantle, not wanting to appear greedy.

In other American League games, Oakland beat Baltimore 4-3 in 13 innings, Boston beat Chicago 3-0, Detroit topped Cleveland 5-0 and Washington edged Minnesota 7-6.

In the National League, Cincinnati took St. Louis 4-3 in 12 innings, Atlanta beat Chicago 5-3 and San Francisco beat the New York Mets 5-3.

Mantle's homer came in the fourth inning with Bill Monbouquette on base and Roy White hit another two-run homer in the same inning. Monbouquette turned in a sparkling performance on the mound, allowing just five Angel hits, one a homer by Roger Repoz.

John Donaldson drove in the winning run for the Athletics with a sacrifice fly in the 13th for Oakland's first victory in its new stadium. The key play in the inning came when Brooks Robinson tried to force a runner at second on a bunt and failed. Had he gone to first, Donaldson's fly would have been the third out of the inning.

Jose Santiago pitched a two-hitter against the White Sox who are still looking for their first victory of the season. Santiago held the White Sox hitless for five innings.

Al Kaline, playing his 2,000th major-league game, hit a home run for the Tigers and so did Dick McAuliffe and Willie Horton. Joe Spina held the Indians to seven hits. Kaline's homer was his 305th, putting him one behind Hank Greenberg, who holds the all-time Detroit record.

Rod Carew was tagged out in a run-down with two out and the bases loaded in the ninth and the Twins' six-game unbeaten streak ended. The Senators scored six times in the fifth inning. Ted Uhlaender and Bob Allison homered for the Twins.

# Decision May Come Soon On Future Of Olympics

LAUSANNE, Switzerland (AP) — Nine powerful men assemble this weekend to decide the fate of the Mexico City Olympic Games.

But the rug could be pulled from under their feet by the most powerful of them all—Avery Brundage, the 80-year-old Chicago millionaire who for 16 years has ruled the International Olympic Committee (IOC) with an iron hand.

The Executive Board of the IOC has to decide whether or not to accept the postal vote which admitted South Africa to the Mexico Olympics.

Over 40 nations have threatened to boycott the games if South Africa takes part. There is a strong possibility that they will be joined by the Soviet Union and the rest of the East European bloc, thus making the Olympics a farce.

A sudden decision by IOC

President Brundage to fly to South Africa this week touched off speculation that he may be trying to settle the issue alone.

Rule 15 of the IOC says: "The president alone may take action or make a decision where circumstances do not permit it to be taken by the International Olympic Committee or its Executive Board. Such action or decision is subject to ratification by the committee at its next meeting."

In other words, Brundage could simply announce in Johannesburg at his scheduled press conference today: "South Africa is in" or "South Africa is out."

The next meeting of the IOC committee is scheduled to coincide with the games in Mexico City and would be much too late to change his decision. For an emergency meeting to be called, at least 25 of the IOC's 71 members must make a written application.

# Expansion Day For National?

CHICAGO (AP) — The National League may follow the American League and expand to 12 teams for the 1969 baseball season at a meeting of club owners here today.

Warren Giles, NL president, met Thursday with the league's Expansion Committee of Walter O'Malley of Los Angeles, John Galbreath, Pittsburgh, and Roy Hofmeier, Houston.

Among recommendations expected to be presented at today's session is the adding of two new franchises next year.

"It will be up to the league owners to decide what year we will expand," said Giles. "That could be Friday, or maybe later."

Giles admitted that representatives of San Diego, Buffalo, Dallas-Fort Worth, Montreal and Milwaukee were in Chicago.

So far, the only definite stand the NL has taken on expansion was to vote to do so not later than 1971.

The American League got the expansion jump with new teams in Seattle and Kansas City for a 12-team operation next year.

The junior circuit will meet in Chicago next Thursday and may form a two-division playoff plan for 1969.

Delayed NL expansion also would mean that the enlarged AL would corral more players in the draft.

Bob Lee has found a chink in the St. Louis Cardinal armor. The world champions show a definite weakness around the 12th inning.

Lee, Cincinnati's veteran reliever, picked up his second straight 12th inning victory over the Cards Thursday night and the score both times was 4-3.

In the only other National League game scheduled, Atlanta rode Felipe Alou's second home run of the game to a 5-3 ninth inning victory over Chicago, and Willie Mays' bases-loaded double drove in three runs as San Francisco rallied for a 5-3 victory over the New York Mets.

In the American League, Boston shut out Chicago 3-0, Washington tripped Minnesota 7-6, Detroit blanked Cleveland 5-0, New York topped California 6-1 and Oakland beat Baltimore 4-3 in 13 innings.

Lee worked out of a 12th inning jam and picked up Wednesday's victory when Pete Rose doubled and came in on Lee May's single. On Thursday, the big left-hander had to work a bit harder for the victory, going three innings before another Rose double broke it up.

Rose, who homered tying the game in the eighth, doubled Leo Cardenas across with the winning run in the 12th. Cardenas, who opened with a single, move to second on Chico Ruiz' hit before Rose delivered.

John Edwards, traded to St. Louis by Cincinnati during the winter, drove in two runs with a double giving the Cards the lead they held until Rose's home run tied the game.

Atlanta was down to its last out, trailing Chicago 3-2 in the ninth. But Sandy Valdespino singled and pinch hitter Mike Lum tripped him home. Pete Mikkelsen relieved for the Cubs and Alou lined his second homer of the game to win it for the Braves.

"It wasn't a bad pitch," said Mikkelsen. "He just hit the heck out of it."

Alou and Clete Boyer had accounted for Atlanta's first two

runs with solo homers—Boyer's run batted in was the 500th of his major league career.

Adolfo Phillips had a two-run shot for the Cubs.

It may have been a costly victory for the Braves. Slugger Joe Torre was struck in the side of the head by a pitch in the eighth inning and left the field bleeding from the nose. He was taken to a hospital for X rays.

"The preliminary examination on Torre looks good," said Atlanta Manager Luman Harris.

Mays stroked two doubles against the Mets—the second one clearing the bases in the seventh inning. That wiped out a 3-2 New York lead built mostly on pitcher Don Cardwell's two-run homer.

The Giants had loaded the bases with two out against Cardwell on two singles and a walk. Danny Frisella relieved and Mays sliced a two-strike pitch to right field for the winning hit.

The two doubles gave Mays 1,116 extra base hits in his career, tying him with Ted Williams for seventh place on the alltime list.

Gaylord Perry, who had relief in the last inning, was credited with the victory. It was his first of the season, against one loss for the Williamston, N.C., native.

# Another La Follette Eyes Future

MILWAUKEE, Wis. (AP) — The red brick house high on Maple Bluff looks across the blue waters of Lake Mendota to the shining dome of Wisconsin's Capitol.

So does it occupant. The square old mansion has a bronze plaque beside the door identifying it as a "registered national historic landmark."

The occupant sometimes feels as though he ought to wear the same sort of identification.

But Bronson C. La Follette, heir to the glittering name of Wisconsin's greatest political dynasty, has his mind on the future even though he is surrounded by the historic past.

La Follette is a candidate for governor Wisconsin this year, a post in which members of his family already have served 12 years in this century.

For the first of them, his grandfather Robert Marion La Follette, three terms as governor were only a starting point toward the Senate career that made him an immortal of American dissent.

Bronson's father, Robert M. La Follette Jr., began—and ended—his political career in the Senate, extending the family tenure there to 40 years. There is no reason to believe that Bronson himself will not eventually seek to reclaim that seat.

La Follette now is 32, and says ruefully, "I'm a little slower than the other members of the family."

"Fighting Bob" La Follette was elected to the House of Representatives when he was 29; "Young Bob" was named to succeed his father in the U.S. Senate at 30—youngest senator since Henry Clay.

But Bronson's record is not all that delayed—he first was elected attorney general of Wisconsin at 28, and was the only Democratic constitutional officer to withstand a Republican sweep two years ago when he won reelection.

On the other hand, his uncle, Phillip Fox La Follette, also a three-time governor, retired from politics at 41, when the National Progressive party he founded waned in the rising nationalism before World War II.

"But it had been more than 20 years now since the La Follettes passed from the national scene, and in a sense they have become defied.

"I have to keep reminding people that I am just a plain human being. I make mistakes.

"What I have to do to live with myself is put the past behind me and look to the future. Otherwise, I couldn't cut it."

But the past, as expressed by the previous visionaries of his name and lineage, does not seem so far away when this latest La Follette talks political philosophy.

His grandfather thundered against the railroads and unregulated utilities and sweatshop labor and political bossism; his father for the rights of unions and civil liberties and education; his uncle, on the state level, for tax reform and government efficiency.

Bronson, whose winning slogan as attorney general identified him as "the people's advocate," talks of consumer protection, the responsibility of the state in meeting the urban crises, upgrading of law enforcement training and personnel, property tax reform.

"I suppose you could call it the New Progressivism," he

says candidly. "In some respects my thinking picks up where the La Follette Progressives left off. What it means, basically, is the re-establishment of state's rights in areas of responsibility to the people's needs.

His grandfather, of course, broke from the Republican Party and ran as the Progressive candidate for president in 1924; his father was elected both as a Progressive and as a Republi-

can, and finally was defeated in 1946 when he returned to the Republican primary against a young judge named Joseph R. McCarthy.

The last Progressive elected governor of Wisconsin was in 1942, and although there was considerable sentiment to take the party's fading powers into the Democratic party two decades ago, Bronson is the first La Follette to win office as a Democrat.

He now has strong ties to the Democratic party, or at least to one of its wings. He is a friend of New York Sen. Robert F. Kennedy, who, as U.S. attorney general, gave Bronson his first political office six years ago, as an assistant U.S. attorney.

But he made the turn to the Democratic party largely because the evolution of the traditional La Follette views on social reforms—the "Wisconsin Idea"—found more support

there. These included many advances that later won national enactment: the corrupt practices act, workmen's compensation, a child labor law, state civil service, the first eight-hour labor law, compulsory education—at these began here, and withstood constitutional challenge.

At the moment, La Follette is largely keeping his own counsel in the mansion above the lake where he lives with his wife,

Lynn, their 8-year-old son—Robert M. LaFollette IV—and 6-year-old daughter Deborah.

He has not yet said it, and this grandson of the first woman graduate of the University of Wisconsin Law School may never need to echo his father's statement of 1925, when he announced he would seek his dead father's vacant Senate seat.

"I am well aware that the relationship in itself does not entitle my candidacy to considera-

tion," young Bob said. "But it does not disqualify me for high the same time, that relationship political office."

SAN DIEGO, Calif. (AP) — U.S. Navy frogmen solved the case of the "mystery box" to the tune of Mexican bands. Bathers below the border at Tijuana reported discovery of a big box covered with sand and Mexican newspapers voiced concern over possible radio activity from what they called the "mystery box." But authorities couldn't find any such object.

After two days of searching, the frogmen found a five-foot gasoline storage tank and as they searched "at least 1,000 Mexicans gathered on the bluff above the beach. They even brought bands," a Navy spokesman said.

## Gun Sales Soar In Cities Struck By Recent Rioting

WASHINGTON (AP) — Gun sales have soared in predominantly white suburbs of Washington, Baltimore and Kansas City since looting and violence erupted in the Negro neighborhoods of those cities this month. Rioting that followed the murder of Dr. Martin Luther King Jr. on April 4 marked the first major racial disorders in any of the three cities in recent years.

In contrast, there was little if any increase in gun sales in the suburbs of two cities which experienced rioting in previous years as well as this month. Only one dealer in two-suburbs adjacent to Chicago's West Side, scene of a 1966 riot, reported an increase in sales. And there was no evidence of an increase in Detroit's suburbs, where gun sales went up sharply during the 1967 riot.

When trouble broke out in Washington, gun sales were banned in the city and in its Maryland suburbs. Sales were permitted in suburban Virginia, however, and in Alexandria long lines of suburbanites formed outside gun shops.

Alexandria police said in the first two weeks in April they received 400 applications for permits to possess handguns—more than they had during the entire month of March. Although purchases were barred in the Maryland suburbs of both Washington and Baltimore during the disorders, many dealers forwarded applications for handgun permits to police for processing. The ban was lifted last Sunday.

Karl Zinkhan, deputy chief of the Baltimore County police, said the number of requests was the highest his department has received since 1966 when the law requiring permits was passed.

"We don't like to see so many handguns going out," Zinkhan said, "but, we're reasonably sure they are going into the hands of responsible citizens."

Gun dealers in Overland Park, Kan., a suburb of Kansas City, reported a spurt in sales as soon as a ban on them was lifted.

In Independence, Mo., another Kansas City suburb, 40 people were lined up at one gun shop when the ban went into effect.

Edward Breit, owner of a gun shop in Oak Park, Ill., a town adjacent to Chicago's West Side, said his business was up substantially.

"Mostly handguns. Not rifles or shotguns," he said. However, police in Oak Park and neighboring Cicero said applications for handgun permits were running about normal.

In the Detroit suburb of Dearborn, Police Chief John B. O'Reilly said, "Last fall the amount of handgun registrations probably tripled. This pace has been constant. I don't think there has been any change as a result of Dr. King's death."

## See No Need To Restrain Press

NEW YORK (AP) — Newspaper editors whose cities were hit by summer riots feel strongly that there is no need for a code of voluntary restraint in their news coverage.

This was the primary conclusion in a survey taken by William M. Ware, Cleveland Plain Dealer executive editor, for the Freedom of Information Committee of The Associated Press Managing Editors.

"Guidelines are impractical, and possibly even irresponsible," one editor responded. "I certainly do not think they do infringe on freedom of information," said another.

Ware polled editors in cities struck by riots in the past three summers and said he delayed writing his report until the President's National Advisory Commission on Civil Disorders had released its findings and recommendations. He also consulted the Justice Department's Community Relations Service.

The survey conclusions reported by Ware: "1. Emphatically no need for a code of voluntary restraint. In fact, a positive determination to have no part of one."

"2. No real threat at the moment to FOI (freedom of information). But, in view of the trend of the times, a serious warning to keep the guard up."

"3. Agreement on news executives' responsibility to: (a) make plans for coverage of any eventuality; (b) obtain and publish all the news; (c) exercise sound judgment and justifiable restraint in timing, story play, headline treatment; (d) protect the staff (e) take the initiative in projects beneficial to the community, such as prior news presentation of basic causes of unrest and riots and advocacy and support of total community cooperation in seeking solutions."

"4. Support for the belief newspapers met their responsibility for riot coverage moderately well, and disbelief of charges that newspapers fomented or contributed to the spread of riots."

## Russian Doctor's Day Has Heavy Load Of Paperwork

MOSCOW (AP) — Up to half a doctor's day in this bureaucratic society must be devoted to filling out forms and other paperwork.

This is disclosed in a detailed report of a Soviet doctor's life, given in the newspaper Komsomolskaya Pravda.

Dr. Svetlana Parkhomenko makes 105 rubles or \$116.67 a month, so she is about as well off as a typical teacher.

Dr. Parkhomenko works at a polyclinic, as do about two-thirds of this country's doctors. The polyclinics are like outpatient centers at Western hospitals.

Treatment is free, though the patients have to buy some of their own medicine.

Dr. Parkhomenko is expected to handle five cases an hour at the clinic, No. 32 in the Zhdanov district of Leningrad.

House calls to bedridden patients, which take more time because of the distances involved, average 30 minutes each.

Dr. Parkhomenko, 30, received the normal six years of medical education after being graduated from high school. She married an army officer, Stanislav, and they have a 7-year-old son who is looked after at his school. After her day at the clinic the doctor has to shop, prepare the family dinner and do housework.

The couple has moved around a lot because of the husband's military career. Their apartment is filled with secondhand furniture picked up along the way.

Dr. Parkhomenko hopes eventually to do postgraduate study and become a specialist, which would mean better pay and less routine.

A woman going into medicine is no rarity in the Soviet Union. It boasts 26 doctors per 10,000 people, against 1 per 10,000 in the United States, and three-quarters of these are women.

On her vacations, to get away from it all, she never reveals that she is a doctor. But she confesses that her professional training is often too much for her and she finds she has not really escaped. "I catch myself thinking—this person over there has kidney trouble, that one

shows all the symptoms of diabetes..."

## Court Ordered Leg Amputation

MEMPHIS, Tenn. (AP) — A court ordered leg amputation has been performed in an effort to save the life of a 66-year-old Goldsboro, N.C., woman.

After the operation Thursday, Mrs. Agnes Jeffries, who had declined to permit the surgery, said she had been in a highly emotional state and "not in complete control" of her faculties when she had refused to allow the operation.

He condition was good. The court order was carried out by doctors at the Naval Hospital in Millington, near Memphis.

Navy doctors said Mrs. Jeffries had a severe case of gangrene in her right leg and in their opinion would die unless the leg was amputated. The doctors said they feared a suit if they operated and one if they didn't.

Legal officers at the Naval base turned to Bart Durham, assistant U.S. attorney at Memphis, for guidance.

Durham found two somewhat similar cases recorded in law books in which federal judges had authorized doctors at federal hospitals to administer blood transfusion to patients who objected on religious grounds.

Federal officials contacted the woman's son, Sgt. Thomas M. Phillips, with the Air Force in North Carolina, and he agreed to the surgery.

U.S. District Judge Bailey Brown and Durham talked with doctors and Mrs. Jeffries at the hospital Wednesday. They obtained written statements from doctors familiar with the case. The judge then issued his order.

Mrs. Jeffries was transferred to Millington from the Blytheville, Ark., Air Force Base.

NEW YORK (AP) — Methodists, getting set for the country's biggest church merger yet, are worrying over whether the new united denomination should stick to a long-time rule against drinking alcoholic beverages.

A change from required abstinence to a voluntary approach to it is being recommended to the constituting convention of the United Methodist Church, starting this Sunday in Dallas, Texas.

The present policy is "inconsistent and inaccurate" and is "producing hypocrisy and a loss of integrity in the corporate life of the Church and in the lives of many ministers and laymen,"

says the Church's board of social concerns.

But controversy surrounds the proposed change to a more open position, encouraging abstinence, but not demanding it.

The revision also would allow ministers to smoke. They now must promise to refrain from it, although laymen may use tobacco—a situation often called a "double standard" in the Church's discipline.

These matters of personal practice were among numerous issues before the meeting, which will unite the 10.3-million-member Methodist Church with the 747,000-member Evangelical United Brethren Church into one body of 11 million.

Urging adherence to the firm rule against liquor, Methodist

Bishop Everett W. Palmer, of Seattle, Wash., says "alcoholism is a trap" and that to accept even moderate drinking is a "bait for the trap."

"Moderation is the first step toward immoderation," he writes in the denominational weekly, Christian Advocate. "Every heavy and immoderate drinker was once a moderate drinker. Every alcoholic was once a heavy drinker who imagined he could 'take it or leave it.'"

On the other hand, some Church leaders argue that the rigid stand against drinking has become unrealistic, and that it cripples the Church in ministering to persons most in need of help.

Methodism's "one-track abstinence policy" is blocking effective pastoral care to those with alcoholic problems, says the Rev. Dr. Howard J. Clinebell Jr., of the Church's Claremont, Calif., School of Theology.

Noting that recent studies indicate 61 per cent of adult Methodists occasionally drink, he

says the present policy "leads to widespread sham . . . and nonenforcement" and undermines "authenticity and the growth of a healing community."

Under the present Methodist discipline, ministers and lay officials of congregations must pledge to abstain from alcohol, and general members may be tried and expelled for buying, selling or "persisting in the use of intoxicating liquor." Such cases, however, have become virtually unheard of.

The proposed change would encourage abstinence as a "sound and wise witness" to God's concern for mankind in a "society where drinking is so uncritically accepted and practiced" and where it does so much harm.

But the new standard also would openly accept those who do drink, saying: "Persons who practice abstinence should avoid attitudes of self-righteousness which break fellowship with those who do not abstain. Persons who drink should learn

to recognize and avoid dangerous patterns of drinking as well as un-Christian attitudes toward persons who abstain."

The proposed shift from a prohibitive to a flexible stance is in line with that taken by some other testant bodies in recent years, as well as by national interdenominational organizations working to reduce alcoholism.

"The moral taboo on drinking is breaking down among Protestant churches," says the Rev.

Jon L. Regier, a departmental official of the National Council of Churches. "At the same time, however, the churches are reaching a new awareness of the grave problems posed by irresponsible use of alcohol—and are seeking enlightened ways of dealing with these problems."

Some Protestant bodies, such as Southern Baptist Convention and numerous smaller evangelical groups, still firmly condemn any use of intoxicants.

Recent studies indicate that 77 per cent of Protestants sometimes drink, while 90 per cent of Catholics and 94 per cent of Jews do so, with Jews having the smallest incidence of alcoholics.

A "bring a guest" supper is planned for 6:30 on Wednesday of the week of services. Members and guests will gather for a meal and a brief message prior to the evening service.

On Friday night the high school young people will lead in a special youth night planned by the High School Youth Council. Each night there will be a personal word of witness shared by individual members of the congregation.

CAMP LEJEUNE, N.C. (AP) — Navy Lt. Richard M. Lyons, a Roman Catholic chaplain and Vietnam veteran, will receive the Silver Star next Tuesday at Camp Lejeune.

The Jesuit priest, 37, has been cited for his bravery last Jan. 31 during the siege of Hue. He continued to aid the wounded and give his church's last rites although wounded in the arm and leg himself.

He is the first Navy chaplain to receive the Silver Star for Vietnam action. His parents live in New Brunswick, N. J.

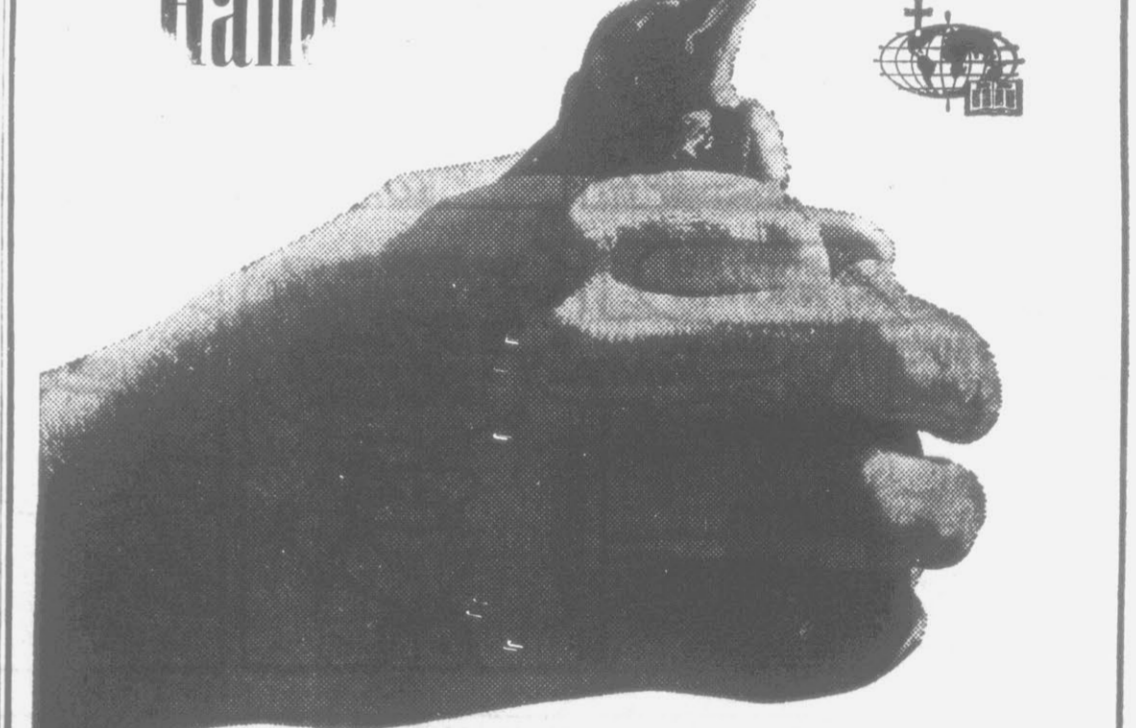

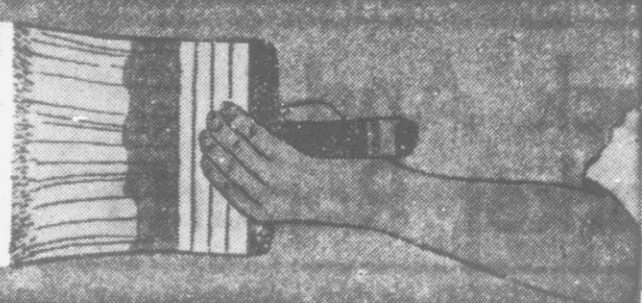

**NEW YORK (AP)**—The stock market weathered a sharp early decline on news of higher interest rates and cut its losses considerably in quieter trading this afternoon.

The Dow Jones industrial average at noon was off 5.95 at 903.26.

In the first wave of selling, the Dow was down 11.44 points.

Losses still outnumbered gains by 4 or 5 to 1, improving the early ratio of 8 to 1 for losses over gains.

The market reacted to surprise news that the Federal Reserve Board had raised the discount rate to 5½ from 5 per cent in an antiinflationary move taken because of the failure of Congress to increase taxes. The rate hike was followed quickly by a boost in the prime rate—the basic rate the largest banks charge to their biggest and best credit risks—to 6½ per cent from 6 per cent.

The interest rate increases fanned out to commercial credit and other interest rates.

The Associated Press average of 60 stocks fell 2.7 to 324.5 with industrials off 4.9, rails off .5 and utilities off 1.3.

The ticker tape was five minutes late in the first rush to sell. Gulf & Western Industries rose 1 to 45 on a block of 35,000 shares and expanded the gain almost to 2 points. Johns-Manville was down 2 as

was Xerox. IBM was off about 1½.

Losses of a point or so were taken by Raytheon, Commonwealth Edison, Public Service Electric & Gas, American Smelting, International Nickel, Du Pont, M-G-M, Polaroid, Texaco and United Air Lines.

Control Data moved into plus territory, showing a net gain exceeding a point.

Armsted, which topped 17 points Thursday on news that plans for a merger with U.S. Gypsum had been terminated, edged higher. U.S. Gypsum dropped more than a point.

Prices on the American Stock Exchange recovered selectively from a sharp early decline.

# Cables Cut In Scattered Sabotage

**NEW YORK (AP)**—Telephone service in scattered parts of the country was disrupted this morning because of cut cables, American Telephone & Telegraph Co. officials said as a nationwide telephone strike moved into the second day.

About 30 feet of an AT&T cable was cut and removed about 15 miles east of Toledo, Ohio, a company spokesman said.

That cable runs to Bogart, Ohio, and affected service from Chicago east, an Ohio Bell Telephone spokesman said. Phone calls were rerouted through other cables and service was quickly restored to the Federal Aviation Administration Control Center at Oberlin, Ohio, he said.

The FBI has entered the investigation of the incident, the spokesman said.

An AT&T spokesman in New York said he could not pinpoint when the cable was cut or how many private and business customers were affected.

Another cable in the Toledo area was cut by a shotgun blast about 10:30 p.m. Thursday, he said. Service was restored about two hours later, he said.

# Orders Caging Of Gentle Tiger

**MIAMI, Fla. (AP)**—Tammy is a 110-pound Bengal tiger and a gentle host at children's pajama parties.

But the Dade County sheriff's office says William Seefeldt, the owner, will have to cage his 10-month-old pet. The cage is necessary to qualify for the permit to keep her.

"She is house broken with seven generations of captivity behind her," Seefeldt said Thursday. "If they put her in a cage away from people she would go wild."

Tammy was born in a litter of five tiny tigers at the county's Crandon Park Zoo. The zoo traded the excess cubs to an animal dealer and Seefeldt bought Tammy from the dealer. He didn't reveal the price but Dr. Gordon Hubbell, superintendent of the zoo, said tiger prices range from about \$600 to \$1,200.

Seefeldt said he bought Tammy as a follow-up to other unusual pets—a bear, falcon, fox and skunk.

Seefeldt has had Tammy six months and she's a plaything for the neighborhood children. This week 25 of them held a pa-

jama party with Tammy as guest of honor. She even visited Hialeah High School.

"The adult neighbors are afraid," said Hubbell.

Thursday, the sheriff's deputies pointed to the statute requiring permits for carnivorous animals including tigers. They said Seefeldt would get the permit when Tammy got a cage.

Seefeldt said he would take his case to court. Dr. Hubbell, who recommended that Tammy be caged, said he had never testified against a tiger but felt the ruling would support the sheriff.
