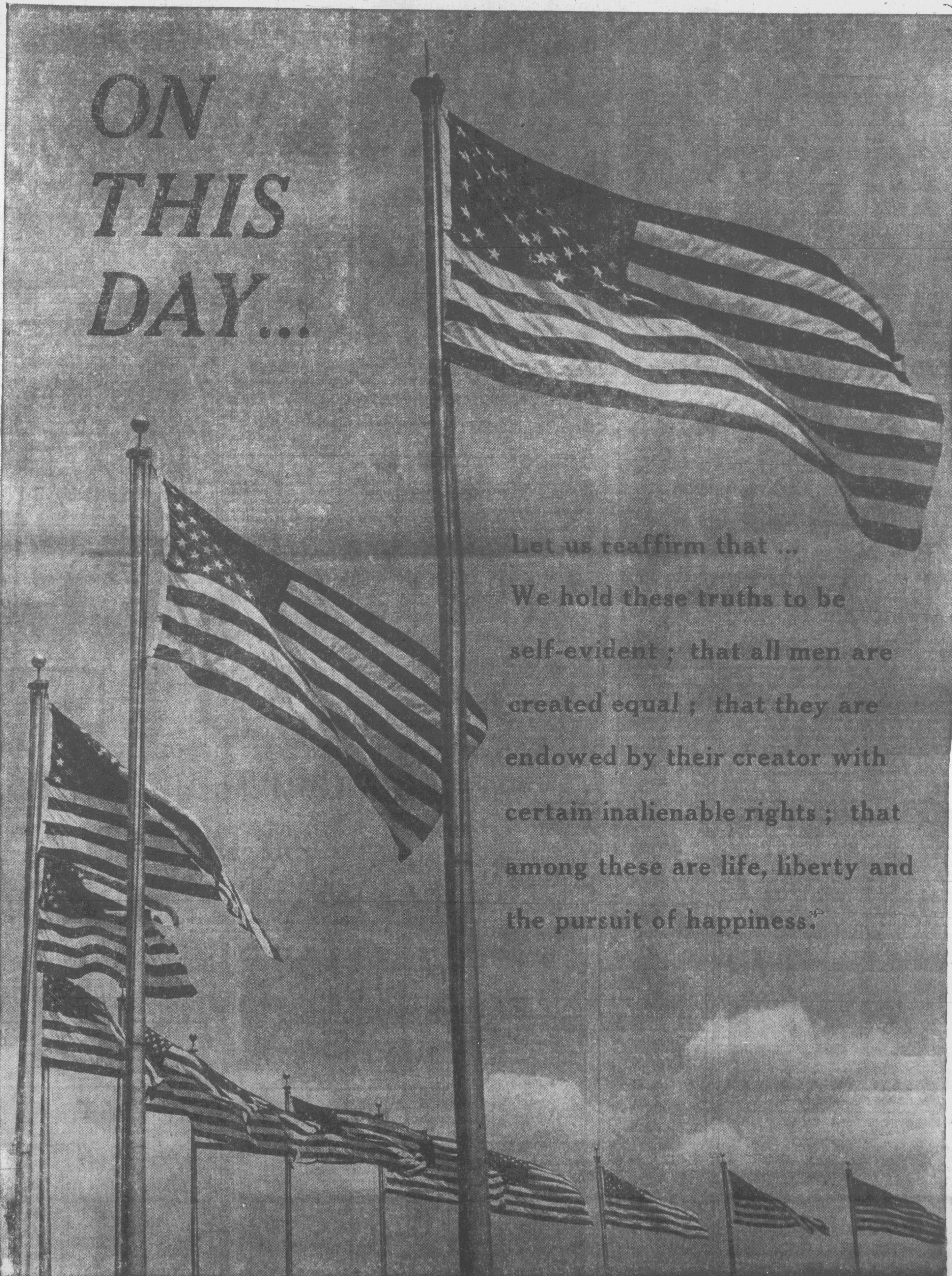

Tentative Budget Of \$62,000 For Bethel

BETHEL—The Bethel Board of Commissioners Tuesday approved a tentative budget for the 1968-69 fiscal year of \$62,000.

The \$62,000 figure represents an increase of \$5,000 over last year's budget of \$57,000. The tax rate will remain the same as last year at \$1.10 per \$100 of valuation.

The commissioners learned that the federal government has approved one-third participation in the \$80,000 seven and one-half acre sewer disposal lagoon to be built south of Bethel.

Bonds have been issued in the amount of \$40,000 to help pay part of the remaining sum. Construction is expected to start in two weeks, according to Mayor J. M. Butter-

worth.

A delegation complaining about the numerous dogs that reportedly roam the streets inside the town limits, appeared before the commissioners and asked for action. In response, the commissioners voted to enforce the town ordinance which requires that dogs allowed to run loose be picked up by the Pitt County Dog Warden.

Delton Perry's re-election to Fire Chief by the Fire Department was approved by the commissioners unanimously.

A delegation protesting the unpaved section of Nelson Street was told that the three blocks in question would be paved in the next two weeks.

Commissioner R. J. Whitehurst was absent.

WILLIAMSTON—The Martin County Board of Education voted to sell at public auction the school property at Parmele and Salisbury in their monthly meeting Monday.

The two schools both closed at the end of this year.

The title of Assistant Superintendent was changed to Associate Superintendent in accordance with state regulations.

The school board voted to approved Walker Insurance Agency in Charlotte, as the representative for the school student accident policy.

Jones Calls On FTC To Reconsider Its Request

WASHINGTON — Congressman Walter B. Jones, D-NC, First District, Wednesday appealed to the Federal Trade Commission to reconsider its request of Congress to ban cigarette advertising on radio and television.

In a telegram, Jones asked FTC Chairman Paul Rand Dixon to give more thought to the matter because "it is unfair

to single out the tobacco industry for punishment.

Jones said to Dixon: "I do not believe that medical science is unanimous in your conclusion (that broadcast advertising should be banned). I submit it is unfair to single out the tobacco industry so long as over 50,000 people per year are killed in automobile accidents and in all probability hundreds

of thousands either die or suffer complete failure of health as the result of excessive use of alcoholic beverages, yet no punitive action has been suggested in these areas."

Jones also presented a statement to the House in which he charged the FTC with using its recommendation to Congress for headline hunting. He added that the FTC was speculating, using incomplete information to prove a point, applying a "peculiar logic" to the matter and disregarding the importance of "magnificent" research facilities in North Carolina which are working on tobacco studies.

The congressman pointed out that 650,000 farm families in 26 states produce tobacco for 425 factories in 35 states employing over 75,000 persons at annual wages totaling \$352-million. He added that annual tobacco taxes total about \$4-billion and farm income some \$1.5-billion.

Big ECU Grant Means Equipment, Research

A \$160,000 federal grant for enrichment of ECU's science program will mean new equipment and further research over the next three years.

Congressman Walter Jones announced the grant yesterday.

The funds will be used to purchase a \$45,000 electron spin resonance spectrometer and a \$45,000 electron microscope. Some \$64,000 will be used to support student-faculty research projects.

The funds came through the College Science Improvement Project program of the National Science Foundation. It is the first major non-state funds to be received for enriching the science program.

The university is presently spending \$158,000 in state

funds to upgrade science equipment and faculty. Also underway is a construction program costing nearly \$5 million for a new physics-biology building and renovation of the chemistry building.

The federal grant covers a three-year period with \$69,300 coming now, \$69,200 next year and \$24,500 on July 1, 1970. The funds benefit the basic science departments of biology, chemistry and physics. Dr. J. William Byrd, physics chairman, coordinated preparation of the great proposal.

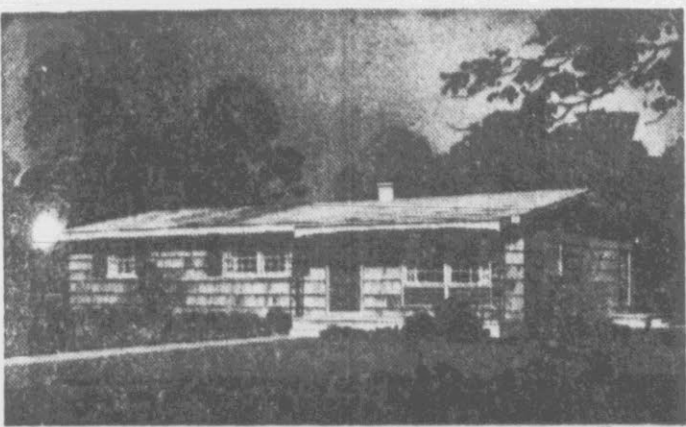

One Gunman Had Nazis' Pictures

Sniping Incident Spur Gun Pleas

NEW YORK (AP) — The slain Central Park sniper who killed a young woman and wounded three men lived in a sparsely furnished tenement apartment decorated with photographs of Nazi leaders.

Detectives found pictures of Adolf Hitler, Field Marshal Hermann Goering and Joseph Goebbels, the Nazi propaganda minister, hung in the gunman's apartment.

They also found a mystery as to his name. A bankbook found in his pocket after he was felled by police bullets Wednesday carried the name Angel Angelof but police said after their search it was "only a part of his real name."

The gunman, using a long-barrelled .45-caliber revolver, brought an hour of terror to a normally quiet corner of the park in the neighborhood of 85th Street and Fifth Avenue, three blocks north of the Metropolitan Museum.

Firing from the roof of a public lavatory, he sent nursemaids with toddlers fleeing from an adjoining playground. Passers-by halted Fifth Avenue traffic and bus passengers drove for cover.

The gun duel added fuel to the national controversy over gun controls which began anew following the assassination of Sen. Robert F. Kennedy last month.

In Washington, President

Johnson expressed horror at the shooting and renewed his plea for gun control laws "to protect the American people against insane and reckless murder by gunfire."

New York Gov. Nelson A. Rockefeller, campaigning for the Republican presidential nomination in Oregon, said in a statement: "The shocking burst of violence by gunfire in the heart of New York City shouts its message to Congress: Give us sensible control over guns."

Less than 12 hours after the Central Park incident, another sniper opened fire in Harlem, wounding Patrolman John Muuss, 28, in the leg. He was treated at Harlem Hospital.

The victim of the Central Park killing was Lilah Kistler, 24, daughter of a Kingston, Pa., physician, who earned her living by walking dogs for apartment dwellers.

The gunman also shot Charles Bach, 80, twice in the back, as he sat on a park bench, and wounded patrolmen Philip Sheridan, 28, and Jesse Hubbard, 35, in the right leg and left hand respectively.

Miss Kistler was shot through the back of the head when she went into the lavatory after trying the leash of a shaggy gray terrier to an outside railing.

Maurice Johnson, 56, a park attendant in charge of the lavatory, heard a noise, apparently the shot, and went from his office through the men's section to open a locked door to the women's section.

"I saw a man climbing above the stalls, breaking open the skylight to the roof," he said. "He had his head through, so I couldn't see his face. I yelled to him something like 'Hey, what are you doing in there?'"

"Then I saw the revolver in his belt. He reached for it with his right hand, and I realized we were dealing with a crazy man. So I closed the door quickly and locked it, making sure to take the key."

He summoned police who exchanged sporadic fire with the gunman until two emergency service officers arrived and lobbed tear gas grenades onto the roof.

As the gas enveloped the sniper, Patrolman Albert Salan, 26, pulled himself into a leafy maple tree across the street. Braced against the trunk he aimed his revolver with both hands.

"His back was to me and he was firing down from the roof on the guys out front," Salan recounted. "He sensed me behind him and started to turn. I put two shots into him."

WASHINGTON (AP) — The Internal Revenue Service says it has recommended prosecution of almost 1,600 alleged violations of existing federal gun control laws in a two-year drive to step up enforcement.

For the first 11 months of the fiscal year that ended June 30, IRS officials say they recommended to the Justice Department prosecution in 851 cases, while 721 charges were pushed in the previous fiscal period.

This compared with recommended prosecutions in just 465 cases for fiscal 1966.

There are two major areas of federal law controlling the sale, use and registration of guns on the books now.

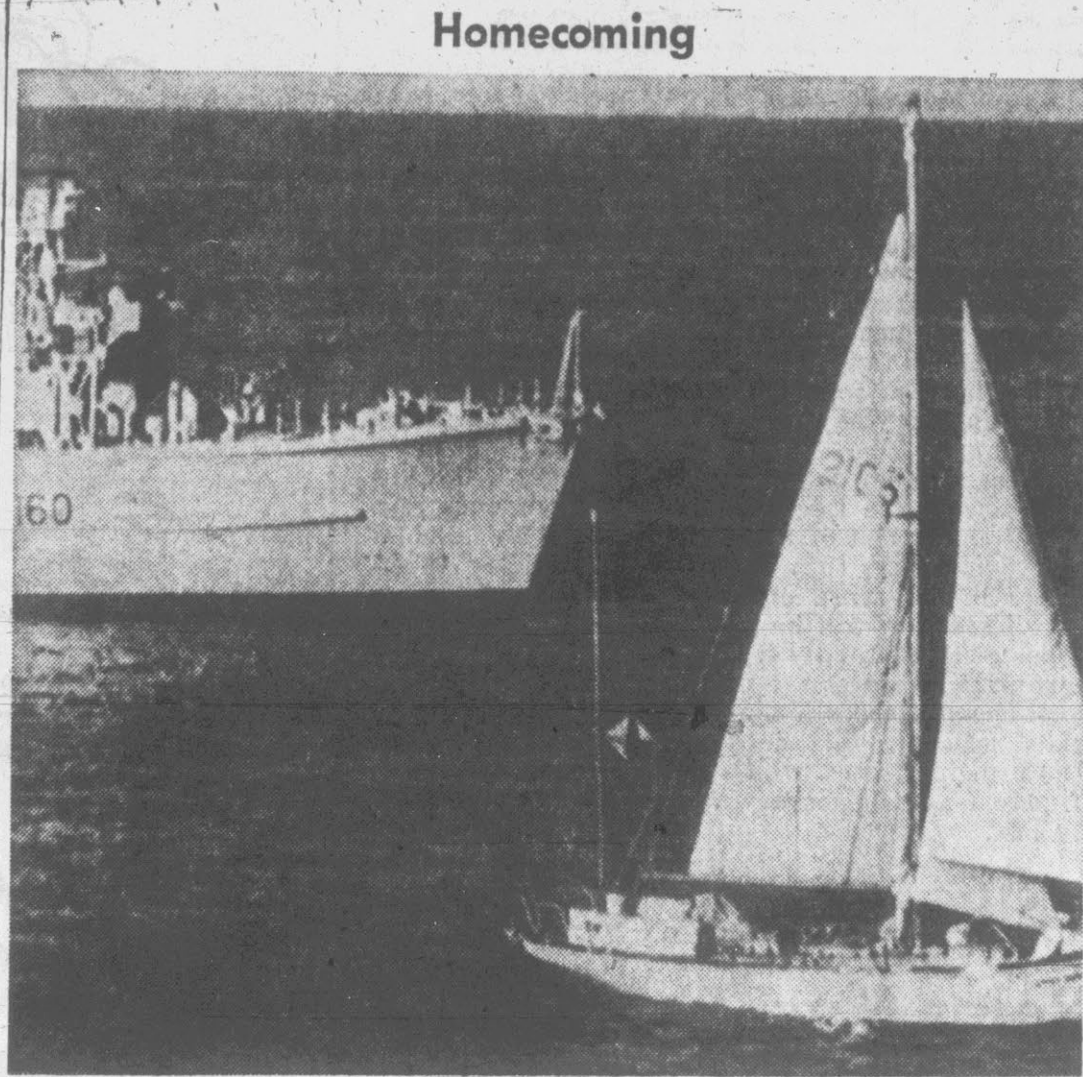
The National Firearms Act bans the public possession of gangster-type weapons such as sawed-off shotguns and various kinds of machine guns.

The Federal Firearms Act contains licensing and registration provisions for dealers and restricts the interstate transportation of guns by ex-felons and persons on criminal indictment.

These laws do not require the registration of all guns, nor the licensing of all persons owning or possessing weapons, rather they apply these factors only to gun dealers.

These provisions have been held up in Congress, as have been other bills providing for stricter laws governing the mail-order sale of rifles and shotguns.

Solo Sailor Ends Global Voyage

PORTSMOUTH, England (AP) — Vegetable man Alec Rose sailed his 36-foot yacht into his home port today to the cheers of thousands saluting completion of his 28,500-mile solo voyage around the world.

Hundreds of sailing craft escorted the 59-year-old Portsmouth man and his Lively Lady the last few miles into the harbor.

Rose waved to the crowd as his 20-year-old secondhand ketch crossed the finish line. The hundreds of yachts and boats in the harbor blew sirens and let off signal rockets, and shouts of "We want Alec!" could be heard above the roar of low-flying planes and helicopters.

As the little yacht reached the last buoy, Rose's wife Dorothy and his daughter Jane went aboard.

Rose set out from Portsmouth last July 16 and spent 320 days alone at sea, stopping in Australia.

Sir Francis Chichester, who sailed alone around the world in 1967 in a bigger, faster boat, took only 226 days, but Rose was not trying to set any records.

"He is following a lifelong dream—to sail around the world alone," said Mrs. Rose who has been running the family fruit and vegetable shop alone.

Rose returned to Portsmouth nine days before his 60th birthday.

Opine Hanoi Doubts U.S. Intentions

PARIS (AP) — The United States is making a persistent effort in the Paris peace talks to convince North Vietnam that American forces will be withdrawn from South Vietnam as rapidly as possible after a peace settlement.

U.S. negotiators think that North Vietnamese disbelief in American military intentions is probably a major obstacle to progress in peacemaking. At the same time they are trying to draw North Vietnam into a discussion of whether it will remove its own troops from the South.

Indications of North Vietnamese views which Ambassador W. Averell Harriman and other officials have received from diplomatic sources leads them to conclude that the policymakers in Hanoi cannot conceive of the United States giving up its massive investment in South Vietnam.

Another Rocket Cache Is Found Near Saigon

SAIGON (AP) — U.S. troops found another rocket cache only six miles east of Saigon today while other American forces repelled a Fourth of July ground attack on their camp 40 miles northwest of South Vietnam's capital.

Patrolling infantrymen from the U.S. 1st Division came on five rockets ready for firing and 33 rocket fuses only 500 yards from the site where a larger cache was turned up Wednesday.

Since the firing pins were in place, there was speculation that the Viet Cong had planned a Fourth of July bombardment of Saigon.

A U.S. spokesman said American troops have captured 551 enemy rockets within a 16-mile radius of Saigon since March 1.

Nine raids Wednesday and today on enemy artillery sites, bunkers and storage areas brought the number of B52 raids in the area to 28 since Monday. Each mission involves 3 to 12 bombers, each carrying up to 60,000 pounds of explosives.

A U.S. spokesman said the raids have triggered 87 secondary explosions, indicating direct hits on ammunition or fuel.

American fighter-bombers

ranged on up North Vietnam's panhandle in 135 missions Wednesday, and pilots reported destroying or damaging four anti-aircraft missiles and their transporters moving into position to menace the B52s.

The fliers also reported destroying or damaging 21 trucks, seven supply boats and 13 anti-aircraft sites and touching off numerous fires and at least four secondary explosions at storage areas near Dong Hoi, the Mu Gia Pass and Vinh.

Over South Vietnam, enemy ground fire brought down an Air Force F4 Phantom fighter-bomber on a combat mission nine miles southwest of the coastal city of Nha Trang. The two crewmen bailed out and were rescued uninjured. It was the 276th U.S. warplane reported downed in combat over the South.

Warns Of Separated Schools Plan

DALLAS, Tex. (AP) — Executive Secretary Sam Lambert of the National Education Association said Wednesday that "Black Power advocates are demanding black schools for black children—a new kind of segregation, still separate and still unequal."

He told delegates at the NEA's annual convention, "We must move to halt the tragic momentum moving our nation toward two societies—one black, one white, still separate and even more unequal."

Lambert expressed a view that improved public schools were "perhaps our only hope for a new and better society."

He said, "We must move to tackle in the schools the tragedy of crime in the streets, riots and the dry rot of our big cities. We must find a way to use teacher power to do something about attitudes and feelings as an essential investment in the next generation."

About 7,000 delegates are attending the NEA convention. The association represents one-million members.

Minneapolis Wallace Rally Survives Melee

MINNEAPOLIS, Minn. (AP) — A rally for George C. Wallace was interrupted Wednesday night by a confrontation between police and demonstrators that included some fist fights.

Wallace was stumping in the home state of Vice President Hubert H. Humphrey and Sen. Eugene J. McCarthy, rivals for the Democratic presidential nomination, in an attempt to get on the Minnesota ballot as a third-party candidate for president.

Several hundred of the demonstrators—about half of them whites and half Negroes—swept into the Wallace public meeting in Minneapolis Convention Hall. Most remained to heckle the former Alabama governor with chants and boos after some 50 of their ranks were cleared out of the hall by police using night sticks and Mace.

Police intervened when a dozen fist fights erupted on the hall floor in front of a platform

stage. One of the demonstrators' leaders, a young Negro man, attempted to mount the platform to use the microphone to address the crowd. He was pushed off by a Wallace aide, igniting the round of fights and scuffles.

Some 30 policemen quickly swarmed onto the floor, surrounded the throng and pushed it toward an exit ramp with night sticks extended horizontally in front of them. Witnesses said the officers did not use the sticks to strike anyone.

Six persons were treated for minor injuries at General Hospital. Craig Bork, a photographer for the Minneapolis Star who received a cut, said he was struck by a Negro. An injured Negro, Dallas Young, 20, said he was hit on the head by a pistol.

Police said five persons were arrested, one Negro man, two white men, one white woman and one white juvenile. All were

charged with breach of the peace.

The melee lasted about 15 minutes, but restoring calm delayed Wallace's appearance at the rally for an hour and 37 minutes. It was another eight minutes before he could speak to the demonstrators and Wallace supporters, who made up perhaps 80 per cent of the crowd of 6,000 cheered for him.

"You better keep yelling, because after November we're going to quiet you down," Wallace told the demonstrators as he tried to speak. "I think this is a good lesson to you people and to people in other states who have listened to this free speech and academic freedom talk."

"These are the folks that always talk about free speech but they don't want you to say anything. This November, the people of this country are going to put their stamp of disapproval on anarchists in this country."

Woman Had \$4 Million In Heroin

BOSTON (AP) — A French woman was arrested today at Logan International Airport after customs agents said they found \$4 million in uncut heroin hidden behind secret partitions in her luggage.

Police identified the woman as Erika Krigers, about 45, of Paris, who had just alighted from a Pan American World Airways plane from London.

Customs officers were conducting a routine inspection of passengers' luggage when they said they spotted something peculiar about Mrs. Krigers' suitcases.

They dumped out her clothing and other personal articles, thumped the bottoms of the suitcases, then ripped them open.

Inside the agents found 13 pounds of heroin, neatly wrapped in several individual packages.

Mrs. Krigers was taken before a U.S. commissioner who ordered her held in \$50,000 bail on a charge of unlawful importation of a harmful drug. Conviction carries a maximum penalty of 20 years in prison.

WRONG BAG PITTSBURGH (AP) — Two men grabbed a canvas bag a messenger was taking to a bank Wednesday, jumped in a car and sped away. The bag contained valuable canceled checks and deposit slips.

MVD Will Ask 6 Helicopters, 300 Troopers

RALEIGH (AP) — The North Carolina Motor Vehicles Department plans to ask the 1969 General Assembly for six helicopters and about 300 more troopers to bolster the State Highway Patrol.

Deputy commissioner Joe Garrett unveiled the proposals Wednesday at preliminary hearings before the Advisory Budget Commission.

Garrett said the helicopters are needed to evacuate accident victims from isolated areas and also may be used for riot control, apprehension of criminals and traffic control at football games.

He said the department has not made a final decision on the specific personnel needs of the patrol, but a major increase in the current authorized strength of 900 men is anticipated.

A new training academy also will be needed, Garrett said, because the Institute of Government has "run out of dormitory space" for rookie troopers. He told the commission land near the institute in Chapel Hill will be available for a new academy.

Increased operating funds for several divisions within the Motor Vehicles Department also will be requested for the next biennium, Garrett said.

State Highway Commission officials also appeared before the budget panel Wednesday to argue their case for new revenues.

Highway Commission Chairman Joe Hunt said highway fund revenue sources have remained static since 1949, but "the cost of doing things has doubled—tripled in some cases."

Hunt cited rising costs of maintenance, overhead and retirement contributions and said, "We actually have less money to spend for actual construction today than we had in 1949."

The "heart of the problem," he added, is the fixed nature of the gasoline and auto registration taxes which feed the high-

way fund because such revenue sources "do not reflect inflationary trends."

Highway Commissioner John F. McNair of Laurinburg, who heads a special subcommittee on revenue needs, told the Budget Commission his group already has concluded "new sources of revenue are imperative."

He said the panel's findings and recommendations will be made public by next Jan. 1.

Hunt, commenting on the \$300 million bond issue approved for road-building in 1965, said the state will "only have scratched the surface" of its highways needs when the funds have been exhausted.

As of June 30, Hunt said, more than two-thirds of the \$300 million dollar issue had been obligated for engineering, rights of way or construction.

Wallace Party To Meet July 20

CHARLOTTE (AP) — The North Carolina convention of George Wallace's American Independent Party will be held July 20 in Raleigh.

Reid Stubbs, North Carolina campaign manager for the former Alabama governor, made the announcement Wednesday night in Charlotte after meeting with Dick Smith, a Wallace national aide.

"Wallace is expected to make appearances late this month in Winston-Salem and Burlington," Stubbs said. "We'd like to coordinate the three events as closely as possible."

The convention will be only a formality, as Wallace will be the only candidate offered to the 85 delegates for consideration.

Bright Belt Warehouse Meet Mon.

WRIGHTSVILLE BEACH, N.C. (AP)—The Bright Belt Warehouse Association, governing body for flue-cured tobacco auction sales in five southeastern states, opens its annual convention Monday amid new efforts to restrict cigarette advertising and pressures to reduce tobacco surpluses.

Fred Royster of Henderson, managing director of the association, said speakers during the four-day convention at Wrightsville Beach would discuss all of the current problems besetting the billion-dollar tobacco industry.

He said special emphasis would be placed on domestic sales, the world market, taxes, the health issue, and restrictive legislation before Congress.

Sales potential of flue-cured tobacco to central and eastern Europe will be outlined by John D. Palmer of Wilson, president of Tobacco Associates, Inc. Palmer returned this week from Europe after serving on a special agriculture mission appointed by Secretary of Agriculture Orville Freeman.

Proposed federal legislation to clamp down on tobacco advertising will be discussed by Frank B. Snodgrass of Bowling Green, Ky., managing director of the Burley and Dark Leaf Tobacco Export Association.

Other speakers include William A. O'Flaherty, Richmond, Va., executive director of the Tobacco Tax Council; Bill Anderson, Raleigh, secretary-treasurer of Tobacco Growers' Information Committee; and several representatives of the U.S. Agriculture Department.

Policemen Completed Institute On Traffic

Two Greenville police officers have completed a three-week traffic school conducted by the Northwestern University Traffic Institute under the sponsorship of the Governor's Highway Safety Program.

Among the 45 law enforcement officers attending the Police Traffic Supervision program were Lt. R. B. Elks and Sgt. M. H. Boyd.

Included in the course were classes in pursuit driving, accident investigation, traffic supervision, supervision of traffic department personnel, uniform traffic laws and public relations.

The three-week program held in Raleigh was the first of two such schools scheduled to be held in the state by Northwestern University this year, under the sponsorship of the Governor's highway safety program. The second traffic institute program is scheduled to begin in High Point August 5.

The Raleigh Police Department acted as host for the school, which met at the Raleigh Police Department training facilities. Registration fee, room and meals were provided at no cost to the city.

Making Up For Change In Plans

RALEIGH — The governor and Mrs. Dan K. Moore are off on a flying July holiday visit to sunny Italy.

Their plans are to visit the summer session of the North Carolina School of the Arts which is conducted in Siena under an arrangement with the Italian government, former foreign minister Aldo Fanfani and a Siena bank which contributes \$50,000 a year for the program.

King in Memphis, Tenn., touched off rioting and racial violence and disorder almost at the same time the governor had he gone — would have been flying to Tokyo. Instead, he remained in Raleigh and curfews were ordered and the National Guard was called out to maintain order.

Moore himself stayed in constant touch with the situation across the state on an around-the-clock basis. With firm action, the situation became calm within a few days and many believe Moore's prompt action prevented a much worse turmoil.

Would Have Come
One factor directly involved in the governor's premonition of the possible trouble was that Dr. King's itinerary would have brought him to North Carolina the next day after he was shot.

He had planned to visit Charlotte and perhaps other cities in connection with his plans for a "Poor People's March" on Washington. It appears that Moore and some other state officials were apprehensive.

Other Factors Involved
The story of the governor's premonition — a nagging worry about possible tragedy and violence — is true. It has been confirmed by the highest sources.

At the time, however, speculation centered on possible political activity as the reason for the governor's decision not to go to Japan.

The only possible connection with politics apparently is that the trip was scheduled in the midst of the Spring primary campaign and that Moore perhaps felt that leaving the state in the hands of the election-embattled lieutenant governor, Robert (Bob) Scott, in troublesome times might neither be wise nor fair, either to Scott or his primary opponents, J. Melville Broughton Jr. and Dr. Reginald Hawkins. Had Scott not been actively engaged in a political campaign at the time, Moore might have gone to Japan despite the premonition of trouble and stress.

But he pondered whether it would be right — from anyone's standpoint — to leave the power of the governor's office in the hands of a candidate busy campaigning for that office. In any case, from Moore's judicial point of view, there was question and doubt. He decided against it.

And perhaps the trip, relaxation and change of scenery in Italy will make up for sudden cancellation of plans by the state's first family to visit another part of the world earlier this year. The Moores had been scheduled to accompany a North Carolina Trade Mission to Japan in the Spring but didn't go.

A Premonition
The little-known story behind cancelling of that trip is that almost on the eve of departure three months ago, in early April, the governor had a premonition.

It was a premonition that something might happen to Dr. Martin Luther King Jr., and that the governor would be needed in Raleigh.

"I just can't go," the governor told his wife, Jeanette Moore, one morning. "I am going to stay here." He urged her to go on the trip to Tokyo without him.

Stayed At Home
She was disappointed but refused to go if her husband did not.

"I was disappointed," Mrs. Moore has told friends. "But now I'm glad I didn't go. I am glad that I was here to be with him, my husband, the governor, during those dark days and long nights."

"It would have been terrible to have been far away in Japan when he was needed and felt he should have been here to do what he thought needed to be done."

Strength For Today

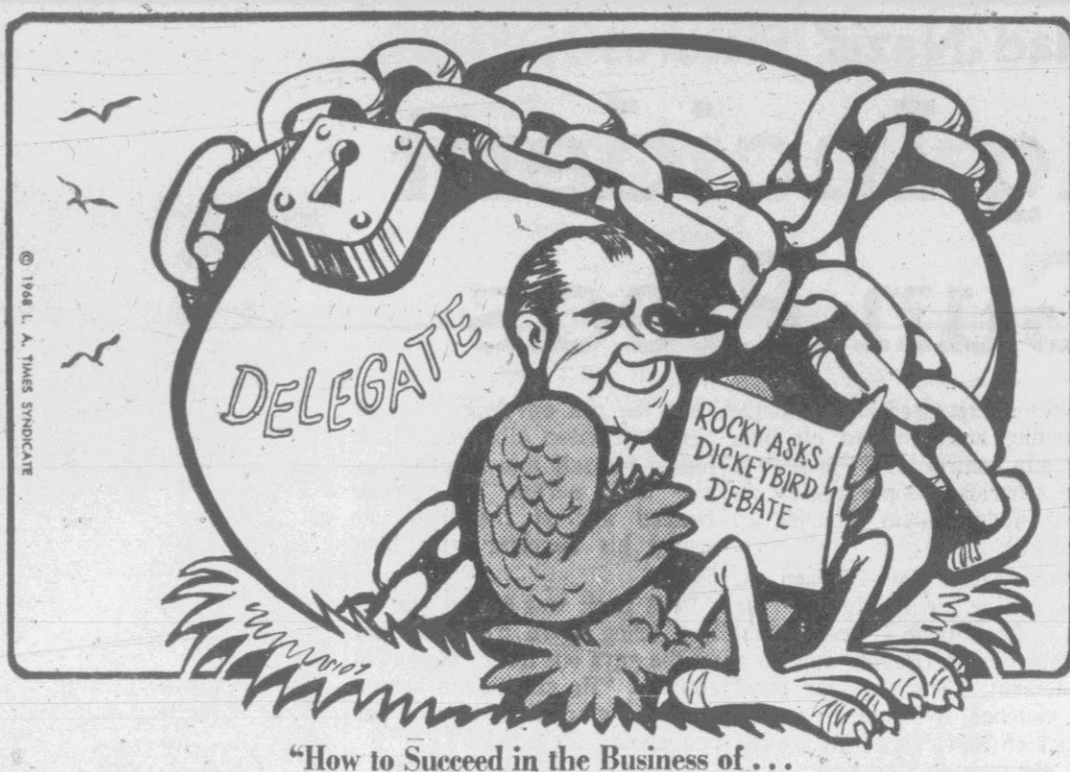

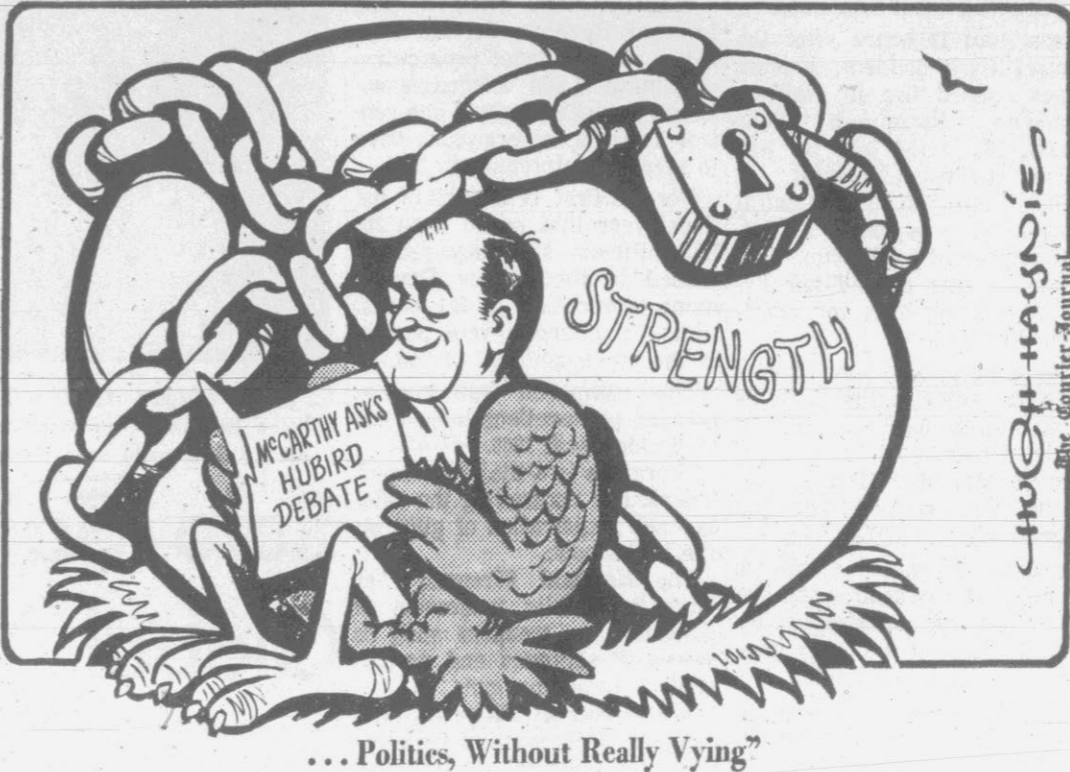

Electoral College Issue

A handful of lawyers and spectators gathered in a Federal court room in this historic old city one day last week. Three judges were on the bench. The question before the court had to do with the system by which the American people elect their Presidents. The judges had been asked to order the system

changed. It was a hazy morning, hot and drowsy, and the proceedings some how seemed a dream. The court room clock rolled backwards through the years. Thomas Jefferson was there, and John Marshall, and the diminutive James Madison. The lawyers and the judges were talking much of the

time of what was said one summer—the summer of 1787. No one seemed quite certain why the Founding Fathers settled upon the compromise that is known as the electoral college.

This much was clear: The system, coupled with the rule of winner-take-all, has its inequitable aspects. On the surface, it is patently unfair that presidential electors from, say, Alaska, Virginia and New York, should be chosen as they are. But the question at law is not whether the system is unfair; the question is whether the system violates the Constitution.

The suit involves Virginia only. Like every other State, Virginia chooses her electors by the general ticket plan. That is to say, the party that carries the State as a whole wins all 12 electoral votes. Minority votes count for nothing.

Early in the nation's history, Jefferson thought the plan unfair. John Marshall felt the inequity so keenly that for years he refused to vote in presidential contests. If presidential electors were intended to correspond to Congressmen and Senators, why, then, are they not chosen in the same way—two from a State at large, the rest from individual districts?

This was the point of the suit last week. The plaintiffs, led by J. Harvie Williams of the American Good Government Society, wanted the three-judge court to enter an order holding Virginia's general ticket system to be in violation of the Constitution. The most natural relief, if the court agreed, would be to put into effect the district system instead.

Now, the odds are—what? —10,000 to one that the three-judge court will refuse to go (Continued On Page 5)

Other Editors Saying Only The Beginning

(Henderson Dispatch)

Certainly no one enjoys an increase in the cost of life's necessities, but this is a day of mounting prices for nearly everything the individual purchases. It is not surprising, therefore, that the Carolina Power & Light Company is seeking a modest increase in rates to offset the ten percent surtax it will be required to pay along with other business concerns.

The power company's request from the State Utilities Commission is only the beginning. Countless other companies will claim the necessity for this type of relief in the wake of the Federal government's tax increase. It may be more the rule than the exception.

It has been argued that the new surtax will arrest the inflationary trend in this country. Perhaps so, but it will also reflect in higher living costs as the levy is passed along to consumers, as it will act on their own initiative and as they deem essential for their own survival as going concerns.

These developments could trigger a recession if the public resents the imposition generally by ceasing to spend. The power company says it will reduce its rates to pre-

sent levels when and if the surtax is removed. It is being imposed only until June 30, 1969. But that is a weak reed to lean upon. Temporary taxes have a way of becoming permanent. It's a good bet that the surtax increase will be extended by Congress beyond the expiration date fixed in the act. That means higher rates now being asked will, if granted, likewise stretch out farther.

CP&L says it must have this revenue if it is to maintain its position of attracting investment capital to continue its plans for broad expansion to meet the needs of booming business, and if it is to continue to pay its shareholders the promised return on their money. The argument makes sense and is quite understandable.

The tax bite has not yet been felt by the consuming public so that the actual effect is not predictable in advance. If it fails to meet objectives envisioned by the administration and Congress, a problem may arise that is even more serious than the one for which the remedy is sought. Only time can provide the complete answer. The move is made on a theory. It remains to be seen whether or not it works.

Chasm In N.Y. Ranks

NEW YORK — Gov. Nelson Rockefeller's declaration that Mayor John V. Lindsay would have to ask to be named to the Senate, far from surprising Republican insiders here, was merely the logical conclusion to the tortuous course followed by the Governor since the assassination of Sen. Robert F. Kennedy.

Fearful that Lindsay might humiliate him by turning down a Senate offer, Rockefeller for weeks has sought private assurances from the Mayor that his answer would be yes. Lindsay's refusal to say yes or no prior to a hard offer has produced a rash of hot-eyed suitors for the vacancy, festooning a serious business with comic opera trapings.

The unseemly story once again reveals the chasm of suspicion between Governor and Mayor created by their battle in last winter's city garbage strike. But it also is a classic example of the Byzantine style of politics often pursued by Rockefeller to his own detriment.

It is this style more than any considerations of ideology that has alienated Rockefeller from the party rank-and-file nationally and has made fellow Republican liberals, such as Lindsay himself, less than ardent in supporting his Presidential bid.

The trouble began immediately after Kennedy's murder when Rockefeller, instead of quickly naming a successor, began to war game the situation with his advisors. Suspicious of Lindsay ever since the garbage affair, Rockefeller's chief lieutenants feared the Mayor would reject an offer of the Senate seat with a public pronouncement that he could not, in good conscience, turn the city over to Democrat Frank O'Connor (president of the City Council). Lindsay would then seem the selfless party man.

To smoke out Lindsay's intentions, Rockefeller let politicians and press know that he definitely had decided to offer him the seat.

But Lindsay didn't bite. His aides were just as suspicious as Rockefeller's, fearing that an advance acceptance by Lindsay might find Rockefeller changing his mind, to the Mayor's acute embarrassment. What Lindsay actually would have said to a bona fide offer is anybody's guess, but some close associates told him he could do more for New York City in the Senate than in City Hall.

The mutual suspicion was underlined during the only prolonged conversation between them since the assassination. Rockefeller began by asking Lindsay to document the reasons why he ought to be appointed—a curiously insensitive way of testing Lindsay's intentions. Lindsay did not respond.

Rockefeller then abruptly changed his line, suggesting to Lindsay that he was really his first choice. Again, Lindsay did not respond. The two fenced for the balance of the unrewarding conversation.

They have had no effective communication since. Sen. Jacob Javits, who maintains cordial if not warm relations with both, has volunteered to serve as an intermediary carrying messages to make sure (Continued On Page 5)

The Search For New Giveaways

It's a sure bet that the oil companies, their ad agencies and gimmick supply companies are frantically searching for new promotions to replace the giveaway games they have been using for two years.

The House Small Business Committee has been conducting hearings on evidence that the games can be fixed and that the cost to dealers is so high that many have increased gasoline prices to pay for them.

The Federal Trade Commission has been rumbling and grumbling about the games. Maryland has prohibited the games by law. And many motorists are getting the feeling that they have been played for suckers.

The Small Business Committee, under Representative John D. Dingel, D-Mich., watched Mrs. Mildred Trotsie, vice president of the Mary-

land Association of Petroleum Retailers, open several boxes of one kind of cards and pick winners at will. She explained that the edges of the cards were marked in different positions and winners could be spotted readily.

Helped Bring Legislation
Presumably a dealer in the know could give winning cards to favorite customers or slip winner to his brother-in-law. A similar demonstration before a Maryland legislative committee helped bring about passage of the law prohibiting games in that state.

Gregg Potvin, a committee counsel, presented evidence that 12 companies, responding to committee questionnaires, said they had received \$32 million from dealers for game materials in 1966 and 1967, and that \$24 million was paid in prizes and \$18 million was paid to companies that produce the games.

In addition, the 12 companies paid \$44 million to advertise the games. The total will be higher when two other large companies answer their questionnaires.

Rep. Dingell said the committee will invite oil companies to answer the testimony. This column, as always, will give equal space to replies.

that dealers who maintain such games "reduce their profits and in the end cost their customers money through the necessity of having to charge higher prices to pay for such promotions."

"While some of the complaining dealers admitted to pump more gas because of the prize cards they hand out to their customers, it is a fact that some have to pay approximately \$15 for each box of 1,000 cards.

"Some of the complaining dealers are inquiring as to who receives credit for the unredeemed winning cards. This is a question which dealers have repeatedly asked but one which the oil companies and the game promoters have left unanswered."

That also leaves another question unanswered: If the Federal Trade Commission was aware of this last April, why hasn't it done something about it?

The Constitution, after all, seems clear enough on its face: "Each State shall appoint, in such manner as the legislature thereof may direct, a number of electors equal to the whole number of Senators and Representatives to which the State may be entitled in the Congress."

The provision appears to give each State legislature carte blanche. Besides, Federal judges are notoriously unwilling to march into political thickets. A court order, limited to Virginia only, could not be made of general application prior to the November elections. The precedents, such as they are, suggest that the suit will be tossed out.

Even so, the arguments are fun to play with. It is evident, as members of the court observed from the bench last week, that the constitutional provision is not to be taken literally. If the Virginia General Assembly were to refuse to let Virginians vote at all, and were to appoint one partisan set of 12 lily-white conservative Democrats only, surely the courts would enjoin the action. If this is so, then the question is a justiciable question. The unfairness, so to speak, becomes a matter of decree.

During these summer months, many homemakers think of preserving the family food supply. Just a work of caution — be sure to process low-acid foods in the pressure canner at 240 degrees. Most vegetables are low in acid. They require a processing temperature higher than can be reached in the boiling water bath. The pressure canner is used to be sure of killing bacteria that cause dangerous spoilage. This temperature is obtained when the pressure gauge registers ten pounds pressure for a definite length of time. The pressure canner is used for all vegetables except tomatoes and pickled vegetables.

Acid foods which are fruits, tomatoes, pickled vegetables, and rhubarb are processed in a boiling water bath (212 degrees F).

There are several points to look for in properly canned foods — color that is natural fruit or vegetables. Clearness — syrup or liquid clear, free from seeds, spices, etc. Texture — tender, yet not over-cooked; only young tender vegetables should be canned. Flavor — The natural flavor preserved as much as possible. Ripeness — well-ripened but not defective or over ripe. Appropriate size — uniform in shape and size. Pack — arrangement with reference to symmetry and best use of space in jar and completely free of air bubbles. Container — should be standard glass pint or quart jars and practical in size and shape.

Please keep these points in mind when canning your fruits and vegetables this summer. Then be sure to bring your samples to the County Fair for exhibit.

PRESERVE THE QUEEN OF FRUITS

Peach season is here so eat all the fresh you can, and then freeze, can, and preserve some for the rest of the year. Peaches are a favorite fruit with almost everyone, and I have just received a brand new make-ahead Fresh Peach Salad recipe which you might like to try.

FROZEN FRESH PEACH SALAD

- 3 cups crushed Fresh Peaches
 - 2 cups miniature marshmallows
 - 1/2 cup drained crushed pineapple
 - 1/2 cup (3 oz.) slivered almonds
 - 1/4 cup (4 oz. jar) quartered maraschino cherries
 - 1/8 teaspoon almond extract
 - 1/8 teaspoon salt
 - 2 cups sour cream
 - Few drops red food coloring
- Mix all ingredients in 2-quart bowl. Pour into 3-inch square pan or 12 muffin cups lined with paper baking cups. Cover with foil and freeze. 15 minutes before serving, cut into squares or peel off paper cups. Makes 12 servings.

Two Workmen Die Of Gas From Canton Sewer

CANTON, N. C. (AP) — Still unknown today was the identity of a deadly gas that escaped in a sewer Wednesday, killing two workmen and injuring four others, in the second serious gas leak in North Carolina in as many days.

Haywood County Coroner George W. Brown said he had named "industrial noxious gases" as the cause of death for Charles Frederick Ledbetter, 34, and Michael Earl Miller, 20, both of Canton.

Brown said Ledbetter, Miller and four other men were cleaning a sewer on the grounds of the U.S. Plywood-Champion Papers Inc. mill. He said it was thought Ledbetter and Miller were inside the 42-inch pipes which empty into the sewer when the gas seeped through them.

The coroner said it was first thought the gas was chloride, "but we're almost completely positive now that it was not." He said Dr. Ernie Goodman, the Champion plant physician, and a team of engineers had begun gas analysis tests to determine the nature of the deadly gas.

Only one day earlier, four persons suffered gas inhalation and about 1,700 were evacuated from a wide area when chlorine gas escaped from a water filtration plant at Pope Air Force Base near Fayetteville.

Three men were hospitalized Wednesday suffering from the gas inhalation accident at Canton. They were identified as Edward Parker Judy, James Jackson Rogers and Ronald Dover Fie. The fourth man — Harland Lee Herron — was injured in the rescue effort.

Brown said Judy was in "serious condition, but improving steadily," and Herron was in good condition and would probably be released today.

Fie and Rogers were taken to the plant dispensary, where their conditions were described as good.

Ledbetter was dead on arrival at Haywood County Hospital. Miller died at the hospital a few hours later.

Minor Injuries In 2 Accidents

Two wrecks during rains on Pitt County roads last night resulted in minor injuries.

State Trooper Howard Winslow reported that a car operated by Willard Garris, 22, of Rt. 1, Box 38, Ayden skidded on a curve about a mile south of Ayden on the Gum Swamp Road at 7:05 p.m.

Alma Hunter, 15, of Rt. 1, Box 37, Ayden was treated and released at Pitt Memorial Hospital. Damage to the car was set at \$350. Garris was charged with failing to see a movement could be made in safety.

At 8:15 last night a car traveling west on N. C. 30 skidded, knocked down a SCL railroad signal light and went into a ditch.

Trooper Winslow identified the driver as Bernetta Gladys Austin, 20, of 800 W. Fourth St., Greenville. She and four children in the car were treated at Pitt Memorial Hospital and released.

The driver was charged with having an expired operators license, expired inspection sticker and exceeding a safe speed. Damage to the car was set at \$300.

Opened Parcel, Meets 7 Snakes

LOS ANGELES (AP) — As postal clerk Jewell Lyons opened an unmarked parcel Wednesday, out slid six racer snakes and a gopher snake.

"I didn't even scream," said Mrs. Lyons. "I didn't have time. I scrambled on top of a desk and then I shouted for help."

One of her coworkers at the terminal annex office gathered the snakes after determining they were harmless. The reptiles were turned over to a city animal control officer, who set them free.

Today In Washington

By THE ASSOCIATED PRESS WASHINGTON (AP) — The program for development of an American supersonic transport plane, the SST, has been denied additional money by the House but plans for the aircraft remain alive.

In approving a \$1.35 billion appropriation bill Wednesday, which contained no additional funds for the SST, the House re-

fused an attempt to kill the program all together.

Although no new money was provided, the SST program still has \$186 million in previously appropriated funds for use during the current fiscal year.

WASHINGTON (AP) — A central academy for training all federal law enforcement officials except FBI agents is in the

planning stage, sources say.

The academy, which would be ready for operation in about three years if plans work out, would train about 1,400 persons a year to handle such positions as Secret Service and Internal Revenue Service agents, U.S. marshals and other jobs requiring arrest and gun-carrying duties.

Lloyd Ruby Captures Paul Revere Race At Daytona During Night

DAYTONA BEACH, Fla. (AP) — Veteran Lloyd Ruby of Wichita Falls, Tex., drove in front virtually all the way through early morning darkness today and easily won the second annual Paul Revere 250-mile road race.

It was such a breeze for Ruby, driving a 1967 Cougar, that he finished more than 15 miles ahead of runner-up John McComb of Hutchinson, Kan., and still failed to break the 105.033 miles an hour record Parnelli Jones set last year.

Ruby's winning speed was 103.152 m.p.h. and he won \$3,675.

Indianapolis 500 champion Bobby Unser of Albuquerque, N.M., leaped from his fifth starting position into the lead before half a lap was run. But an electrical fire under the hood sidelines his 1968 Camaro before he could get credit for leading a full lap.

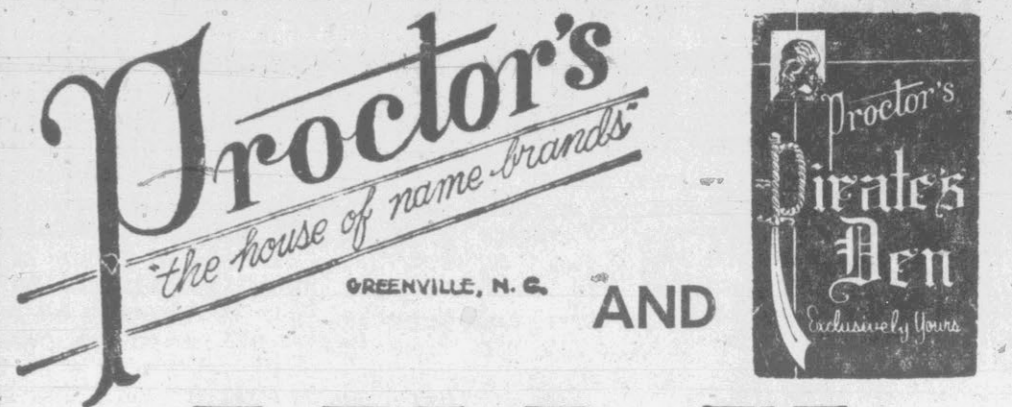

Tiant Fans 19 In Cleveland Effort

The question today for Cleveland's Luis Tiant is, obviously, what happened to the other 34 pitches?

Tiant threw 135 pitches against Minnesota Wednesday night and 101 were strikes. The other 34? "I don't have good control like I usually have," explained Tiant, whose 19 strikeouts helped him break one major league record and tie another in the Indians' 1-0 10-inning victory over the Twins.

It was the best pitching performance in the American League where Baltimore swept a doubleheader from Chicago, 3-1 and 1-0, New York dropped Washington 4-1, Detroit defeated California 5-2 and Boston edged Oakland 4-3 in 11 innings.

In the National League, Atlanta blanked San Francisco 2-0, Pittsburgh pounded New York 8-1, Philadelphia nipped Chicago 3-2, Cincinnati outlasted Houston 9-7 and St. Louis shaded Los Angeles 2-1.

Tiant's 19 strikeouts gave him a two-game total of 32, breaking the record held by Sandy Koufax and a three-game total of 41, tying the mark set by Koufax in 1959.

Tiant's three-game total was one better than the 40 strikeouts teammate Sam McDowell accumulated for the American League record earlier this season. His 10-inning total of 19 was two short of Tom Cheney's extra-inning record of 21 set in 1962 for Washington.

Tiant struck out the side three times—the last one in the 10th when the Twins got runners at first and third with none out. The shutout was his seventh this season and lowered his earned run average to 1.11—best in the

American League.

The Indians got the game's only run in the 10th when Lou Johnson beat out an infield hit and took second on Cesae Torvar's wild throw. Joe Azcue followed with a single to right, scoring Johnson. That was enough to beat Jim Merritt, who allowed just two hits until the 10th.

Boog Powell rapped three hits including his 13th home run helping the Orioles to their first game victory over the White Sox. Jim Hardin hurled a three-hitter for his ninth victory.

In the nightcap, Tom Phoebus completed the sweep with a five-hitter and Curt Motion's second inning homer gave him the only run he needed.

Phoebus, like Tiant, had his strikeout pitch working. He fanned 12.

Norm Cash, Willie Horton and Dick Tracewski whacked home runs, leading the high-flying Tigers past California. Cash's two-run shot broke a 1-1 tie in the sixth inning after he was roundly booed for a fielding lapse that helped the Angels score in the top half of the inning.

Denny McLain won his 15th game—top in the American League.

Mike Andrews singled in Boston's winning run in the 11th inning as the Red Sox squeezed past the Athletics.

Jim Gosger tripled two runs home for the A's, giving Oakland the early lead.

Mel Stottlemyre won his 10th for New York—beating Washington with a four-hitter. Bobby Cox tagged a tie-breaking homer in the seventh inning and the Yankees added a pair of insurance runs in the eighth on singles by Tom Tresh and Jake Gibbs.

Pappas Hurls Braves To Third Win

Milt Pappas, who wanted all the Cincinnati Reds to travel first class, is pitching just that way for the Atlanta Braves.

Pappas, the Reds' player representative until he was traded three weeks ago, turned in another sparkling performance for the Braves Wednesday as they defeated San Francisco 2-0.

Life in Atlanta—a 3-0 record and 0.58 earned run average—certainly has been a lot more pleasant for Pappas than life in Cincinnati.

The 29-year-old right-hander was a marked man from the start of his 2½-year tenure with the Reds. He was the key player the Reds received for Frank Robinson in their trade with Baltimore.

And as player representative, he encountered various problems with management, including his fight for first-class seats on airplanes for all the players.

"It was a big relief for me when I was traded," he said after halting the Giants. "I hated every minute in Cincinnati. People here expected too much of me. There was a great mental strain and there was too much heat from the front office because I was traded for a big hitter."

Pappas, of course, never won a pennant for Cincinnati the way Robinson did for the Orioles in 1966. After two unimpressive seasons, he compiled a 2-5 record with a 5.57 ERA before being traded last month.

Pappas expected the trade, especially after he raised a major fuss over the Reds' refusal to take a day off out of respect for the memory of Sen. Robert Kennedy. He resigned as player rep as a result.

That was only the culmination of a series of problems. The travel feud stemmed from the Reds' policy of handing first class airplane seats to front office personnel, the manager, coaches, press, radio and television people before allocating them to the players. Those players who don't make it into the first-class section go tourist.

The Braves are happy this particular tourist stopped off in Atlanta. Elsewhere in the National League Wednesday, St. Louis

edged Los Angeles 2-1, Pittsburgh walloped New York 8-1, Philadelphia edged Chicago 3-2 and Cincinnati trimmed Houston 9-7.

Pappas allowed just six hits before retiring for a pinch runner after opening the eighth inning with a single. His seven shutout innings raised his total of consecutive scoreless innings to 21 2-3. Pappas received support from Felipe Alou's homer and Hank Aaron's sacrifice fly. The Cardinals downed the Dodgers for the third straight

time, Orlando Cepeda scoring the winning run in the eighth inning on John Edwards' sacrifice fly. Cepeda walked and went to third as Mike Shannon doubled. Nelson Briles scattered seven hits.

Home runs by Willie Stargell and Donn Clendenon powered a four-run uprising in the fourth inning that carried Pittsburgh past New York. Carl Taylor and Gene Alley added two-run singles in the sixth.

Mike Ryan's run-scoring single in the fourth turned out to be the decisive hit for Philadelphia. Larry Jackson had a 3-0 lead going into the ninth but ran into trouble and needed relief help from Chris Short. Glenn Beckert singled home the Cub runs.

Cincinnati rallied for three runs with two out in the ninth

Folks Smarter In Car Racing

DAYTONA BEACH, Fla. (AP) — The fastest qualifier for the first race at Daytona International Speedway back in 1959 Coton Owens of Spartanburg, S.C., owns the car on the pole in today's Firecracker 400.

What has happened in stock car racing in the nine-year interval, as Owens sees it, besides raising the speed from his 143.198 miles an hour to this year's 187.049?

"Mainly, the people in racing got smarter," says the Sandy-haired 43-year-old Owens who quit driving five years ago when his eyesight weakened from an old accident injury.

"When we wet flat out on this track the first year, our cars almost lifted off the ground coming off the corner," he recalled. "These guys racing today tell me it is real comfortable running 180 or so."

"We didn't know enough about aerodynamics nine years ago," Owens said. "We've learned how to keep the cars on the ground."

Prize money is bigger now, too, especially for first and second places, but Owens would like to see it spread out a little more.

"The difference from first to seventh place is too wide," he said. "Our car finished fourth in The Dayton 500 last February and we were challenging the leader. But the winner got \$40,000 and fourth place paid \$5,200."

Owens' biggest purse as a driver was between \$9,000 and \$10,000 as best as he recalls. But he said he never wrote down the exact figure for his biggest purse, how much he made in a season or in a career.

He couldn't even estimate it. Owens is by no means unhappy with stock car racing.

"I still love it as I always did," he said.

He lives it through his driver currently Charlie Glotzbach of Georgetown, Ind. Owens picked Glotzbach, who is 30 but never a full-time driver, over some better known names. His reward came rapidly when Glotzbach put their 1968 Dodge Charger on the pole with a 185.156 m.p.h. first day qualifying speed.

Even though Lee Roy Yarber

ough later beat it with his record run, Glotzbach couldn't be bumped off the pole.

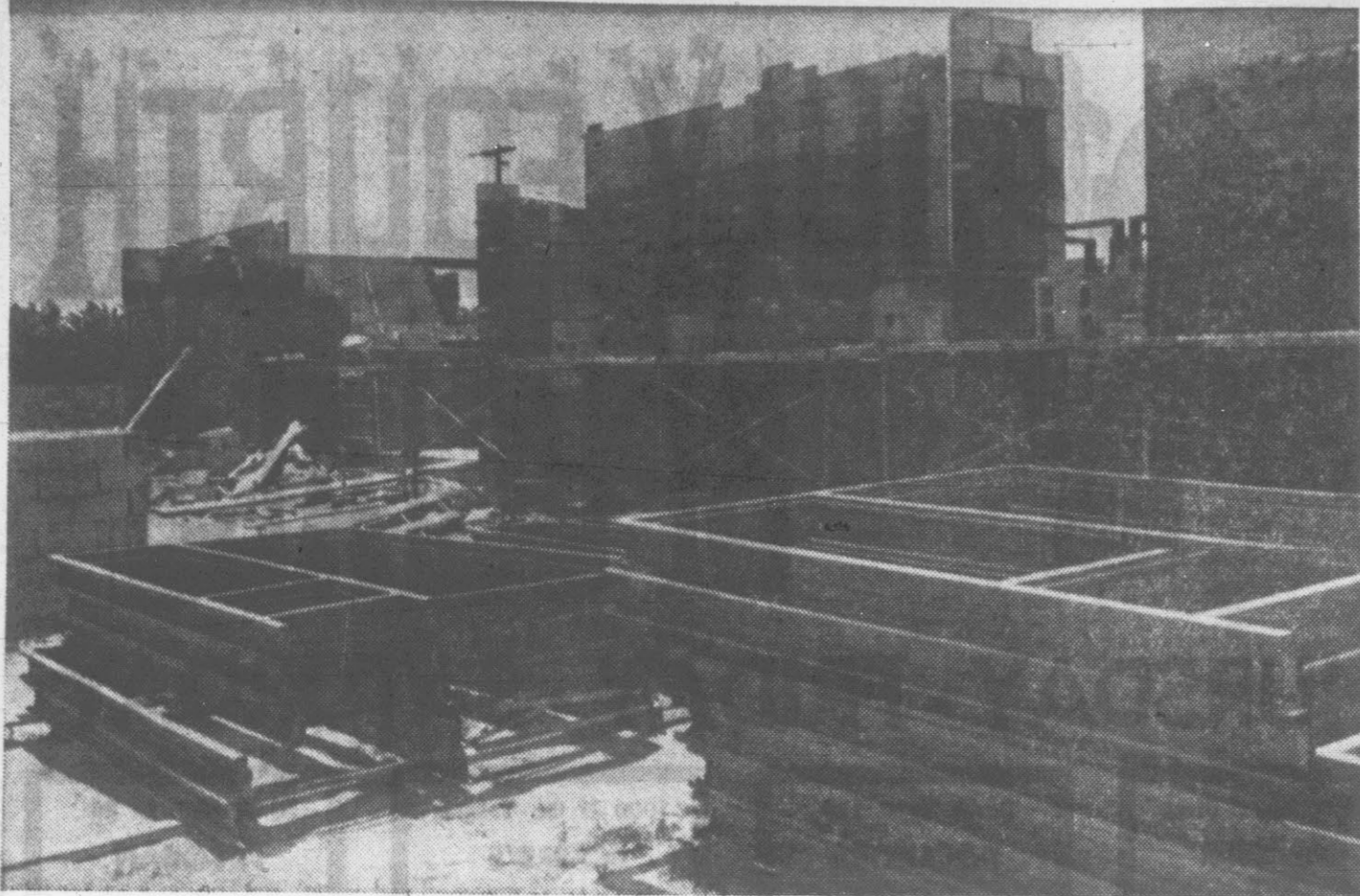

A Romantic Name Given Western N.C. Region Writer Loved So Well

RALEIGH (AP) — Friday marks the birthday of the author of the novel, "Land of the Sky." Her name was Frances Christine Fisher and she was born in Salisbury in 1846. She wrote under the pen name Christian Reid.

When she was only 15 her father, Col. Charles Frederic Fisher, was killed at the first battle of Manassas, 1861. It was for him that Fort Fisher, Confederate bastion near the mouth of the Cape Fear River, was named.

Frances' mother was a Roman Catholic, and the girl followed her into that faith. Later she was to have the Catholic Church of the Sacred Heart built on a part of her family land.

For years she lived in the old family home, where she was educated. She made frequent visits to Asheville, but otherwise there were few breaks in her routine quiet home life.

She published her first book, "Valerie Aylmer," in 1870, when she was only 24 years of

age. Thereafter she continued to write for the rest of her life, issuing altogether nearly 50 novels.

By far her best known work is "Land of the Sky" (1876), the scene of which is laid in the mountains of western North Carolina. The title of her book was adopted as the name of that region.

In 1887 Frances Fisher married James Marquis Tiernan of Maryland, a mine developer, and went with him to Mexico where she lived until his death 11 years later. Many of her

novels of this period have Mexican background and characters. Among the titles are "The Land of the Sun" and "Fairy Gold."

Returning to Salisbury she continued to write. Her drama, "Under the Southern Cross," proves her strong devotion to the Southern Confederacy and her belief in the right of seces-

sion.

Later works include "The Light of the Vision" and "A Far-Away Princess." In 1909 she was awarded a medal by Notre Dame University.

She died at Salisbury in 1920, in her 74th year. On U.S. Rt. 29 in Salisbury, at the entrance to the cemetery, is a historical marker which bears this inscription:

Many Motorists Saw Victim After Impact

WASHINGTON (UPI) — The motorist feels a thud and another pedestrian is dead.

"But I didn't see him," the driver says.

According to an Indiana study by the U.S. Public Health Service, one-fourth of the motorists who struck and killed pedestrians at night said they didn't see their victim until after the impact.

But the PHS says such incidents can be prevented if pedestrians wear one of the new retro-reflective devices now on the market.

Retro-reflective devices, like traffic signs, "spotlight" themselves in light.

Most objects are diffuse reflectors—they reflect the light that strikes them in a random fashion. Consequently, the illumination they create is dull and hard to see at night.

Retro-reflective devices bounce the light which strikes them directly back to its source regardless of the angle from which the light comes. A total of 90,000 tiny glass beads per square inch of material are responsible for the "condensed" light. Thus a pedestrian wearing the material becomes highly visible in the headlights of an automobile.

ReflectORIZED clothing can be detected soon enough for drivers to take evasive action at speeds up to 70 miles per hour, PHS research shows.

Retro-reflective material is made in various forms—fabrics, press-on-tapes, arm bands, or "dangle-tags."

Several national retailing and mail order firms are now offering children's jackets with reflective material.

The PHS is planning a nationwide program of demonstrations and seminars to promote the use of the reflective devices by pedestrians.

Learn The Lessons Of The Streets

RIVER FOREST, Ill. (AP) — Sixteen white teachers—11 of them nuns and two seminarians—sat in the cool white marble hall of Rosary College and learned a lesson of the streets. Their teachers: three Negro men—a self-described former hustler and pimp, a member of a South Side Chicago street gang called the East Side Disciples and a civil rights leader who is a sociologist. Part of the lesson went like this:

Harold, 22: "I grew up in the streets. Everything I know I learned on the street—hustling and pimping."

Nun: "What do you mean—hustling?"

Harold: "Well, like the handkerchief game. Say, a white man would come down to the street looking for something—"

Michael Lawson, a sociologist and civil rights leader involved in rehabilitation programs: "Looking for what, Harold?"

Harold: "Looking for black women. I'd tell him I could get some fine black women for both of us, I'd have two handkerchiefs, see, one filled with paper and the other with money. I'd tell the man to put his money in with mine and hold the handkerchief while I went for the women. All the time I'd be switching the handkerchiefs around. And I'd leave him holding the one filled with paper while I ran off with the one with the money."

The Negro men and white teachers were participants in a traveling workshop in human relations, run by five nuns, which is starting its fourth cross-country tour to combat what it calls white racism.

Its method: Conducting seminars to educate white teachers, civic leaders and clergy about Negroes, about racial prejudice and about themselves.

This particular lesson was mostly about Negroes. Jessie, 19, a street gang member, told of his life on the streets.

"I been in a gang since I was real young," he said. "That's the way it is if you live in my neighborhood. Like, a friend of mine's got a \$10 bounty on his head. That means if some member of another gang kills him, he gets \$10."

The traveling workshop is sponsored by the Chicago-based National Catholic Conference for Interracial Justice. Participants last year included 3,200 lay teachers and public servants, 100 clergymen of all faiths, 9,540 nuns, 60 brothers and 1,100 minority group members.

Sister Mary Peter Traxler, director of the workshop and of educational services for the National Catholic Conference for Interracial Justice, recounted some of its results.

—A realtor in Youngstown, Ohio, told the audience, "Never again will anyone in my presence call Negroes lazy. How can they have any hope at all if, as we've heard, a Negro college graduate can expect lifetime earnings equivalent to a white man who has only an eighth-grade education?"

—A deputy warden said, "I didn't really realize before that Negroes suffered, too."

Sister Mary Peter said the effect of the workshop on its participants has been measured.

"We went back to test," she said. "The only real measurement of attitudinal change is the extent to which actions change, so we drew up 21 possible actions that a person might have undertaken after participating."

The actions included such things as joining a human relations group or participating in a civil rights demonstration.

"We found that 93 per cent of the participants had undertaken at least two of these," said Sister Mary Peter. "This is clear-cut evidence of our effect."

Beautiful Mrs. Wins Miss Title

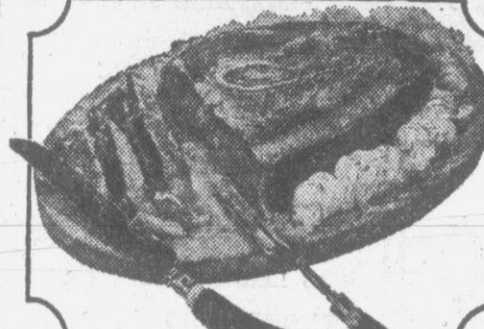

Americans' Concern Is For Selves

EDITOR'S NOTE—What's on America's mind? America. That's the conclusion of the third nationwide soundings by members of The Associated Press Managing Editors Association who were asked to say what their readers are talking about.

This report was compiled by Tom Fesperman, managing editor of the Charlotte Observer, and Ian Menzies, managing editor of the Boston Globe. Their first reports forced the basis for a series of stories earlier this year.

The Americans are turning in upon themselves. They're worried about the guns they own, and they're not quite sure how to control them. They're worried about violence in the country—not so much just racial violence, but crime and generally violent behavior—and they're talking to each other about it in Boston, in Council Bluffs, in Amarillo, in Saginaw, in Moline, in Newark, all over.

It's not quite the same as it was in February, when managing editors over the United States last reported on "what the people are talking about" in our Editor-to-People Survey No. 2.

In February, our predicament in Vietnam seemed to be the main topic of conversation in little towns and big cities across the country. In February, we wondered mainly about our behavior toward the Vietnamese.

In July—now that there's talk of peace around a big table in Paris—we're talking about ourselves, and about our behavior toward each other. In July, the memory of Bobby Kennedy's death in a kitchen corridor is still sharp.

Newspapermen listening in on conversations on street corners and at club meetings and in offices and factories hear not so many specific mentions of Bobby as they do of the need to put our own violence under tighter controls.

They're caught, it seems, in a constitutional dilemma: Should they shackle their own rights to own guns in order to control the irresponsible and violent ones?

But guns are not all they're talking about in July. They still speak of the war, if not as much as they did a few months ago. They speak, not very excitedly, of the presidential campaign. They talk of taxes—the taxes that seem to be going up and up, locally as well as nationally. They talk of civil rights, still, but now they seem to be talking more of local action programs to give the Negro more his due.

They talk of the Poor People, and in some places they talk of bussing school children to other neighborhoods, and in Texas they talk of maybe getting liquor by the drink.

"Eavesdrop" reports from more than 40 cities in the United States are full of the problems, the prices, the crime, the taxes, the mystery of youth, the rebellions.

And the reports are largely cheerless.

The Americans are not talking about any great achievements in early July, or about any big victories, or about any major progress, or about rainbows for they thought even the May-June weather was pretty lousy.

We reported in February that the Americans were generally unhappy, and we must tell you in July they're still evidently bent with care.

But sprinkled here and there through this big salad of conversations were some small crumbs: Some people, of course, are talking about their summer vacations.

It seemed, after all, a bright thing to talk about.

Cabbie Driving For Two Goals

LANSING, Mich. (AP) — As he drives a cab through the city streets, Edward Pierce is also driving toward two goals—a master's degree and the gold life master card that is the symbol of achievement in bridge.

The candidate for a Master's degree in psychology at Michigan State University finds that, though his study of this subject is a help in card playing, a good bidding system will help even more. So between fares in his cab he studies a new system of bidding—a combination of the Karlan-Sheinwald and the Italian systems.

Bridge has been the student's favorite pastime since he was 8 years old and found a deck of cards and a bridge book. "It all seemed fascinating to me," he recalls. "I read the book and started to play and have been playing bridge ever since."

Many Disabled Workers Could Get Social Security

"There are many disabled workers in this area who could receive Social Security payments by filing an application," states Jack Tatem, manager of the Social Security District Office in Greenville.

Tatem pointed out that many disabled workers still put off filing a social security claim for months, and sometimes years, after they become disabled. In a few cases the disabled person loses some payments because of this delay. "Back payments" cannot be made for more than 12 months before the claim is filed, even though he may have been disabled for two or three years before this.

To receive disability benefits under the Social Security Law two requirements must be met. First, the disability must be severe enough that it prevents the person from doing any substantial gainful work. The condition must be expected to last for at least 12 months or to result in death. Secondly, the disabled person must have worked and paid into social security for at least five years in the ten year period before he became disabled. For persons 31 or younger, less work is required.

Tax Return On Household Employees Due July 31

GREENSBORO—If you have a household employee now, you may be required to file Form 942, Employer's Quarterly Tax Return for Household Employees by July 31.

According to J. E. Wall, District Director of Internal Revenue for North Carolina, social security taxes are due when \$50 or more in cash wages is paid to any employee in a calendar quarter for services of a household nature.

This includes services performed by cooks, butlers, housekeepers, governesses, maids, cleaning women, valets, babysitters, janitors, laundresses, furnacemen, caretakers, handy-men, gardeners, grooms and chauffeurs.

No taxes will be required on amounts paid to persons who are not employees. Carpenters, painters, plumbers, repairmen and others who do work for you as independent contractors are not considered as employees.

The employer tax and the employee tax are each 4.4 per cent, or a total of 8.8 per cent of the total cash wages if \$50 or more was paid during a calendar quarter.

The tax applies only to the first \$7,800 of taxable cash wages paid to an employee in an entire calendar year.

The bidding: Queen of ♣ South correctly diagnosed that an end play was required to assure the success of his slam venture; however, he projected his campaign in the wrong direction and his efforts went for naught.

A contract of six hearts was reached with dispatch and West opened fire with the queen of clubs. South was in with the ace, drew trumps in two rounds and cashed the ace of diamonds, on which West discarded a club.

When the declarer realized that he was confronted with a diamond loser, it appeared to him that the success of his contract hinged on picking up the queen of spades. He proceeded to ruff out the dummy's remaining club of cash the king and queen of

diamonds and then throw East in with the fourth round of that suit.

In order to avoid presenting South with a ruff and discard, East exited with the eight of spades. This was covered in turn by the nine, West's ten and the trick was taken by North's ace. On the return, South finessed the jack in his hand; West, however, produced the queen of spades for the setting trick.

Declarer's technique was faulty. The contract did in fact hinge on an endplay—South, however, had his attention centered on the wrong suit. If he strips out the spades—rather than the diamonds—he cannot fail.

After the ace of diamonds reveals the bad news in that suit, it is suggested that declarer ruff out the eight of clubs and then play A-K-J of spades. He is now in position to claim the rest of the tricks.

If West wins the third spade, he must, on the return, present declarer with a ruff and discard—since West is known to have nothing left but spades and clubs.

If East has the queen of spades, he will be confronted with an equally unpleasant prospect. Since the lead of either black suit is fatal, he must return a diamond. If he comes back with the jack of diamonds, however, South can win the trick with dummy's queen and, on the return, he finesses successfully against East's ten to clinch the contract.

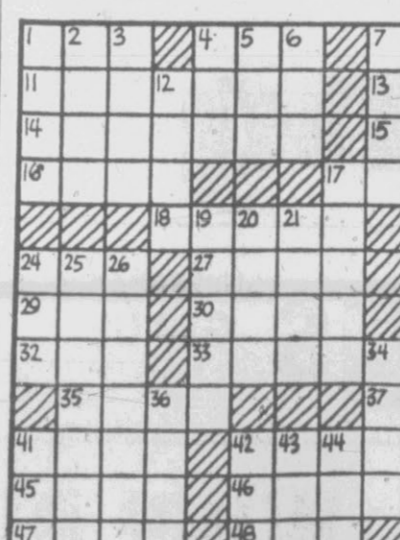

Demonstration Plans In Disarray

CHICAGO (AP) — President Johnson's decision to withdraw from the political scene appears to have lessened somewhat threats of demonstrations at the Democratic National Convention next month.

Shortly after Chicago had been named site of the Democratic conclave, antiwar, civil rights and hippie leaders chorused that if opposition to the President's policies was to be meaningful, it would have to involve the convention at the sprawling International Amphitheatre.

But now the protest movement is hazy, in some cases in disarray.

The National Mobilization Committee, organizer of the march on the Pentagon Oct. 21 and the largest vehicle for war protest, has had two turn-arounds in recent weeks.

Shortly after Chicago was announced as the site for the convention, Rennie Davis of the committee's Chicago office announced a massive demonstration at the International Amphitheatre, a program Davis touted as "the largest in American history."

Two weeks ago, Davis announced the plans had been canceled. "Those plans were shaped largely around the as-

sumption that Johnson would be running," he said at the time.

On June 28, Davis announced that the committee would, indeed, demonstrate at the Democratic convention, and added: "The movement will be climaxed by a major antiwar mobilization outside the International Amphitheatre the day the Democrats select their candidate for president."

Davis said the committee decided to demonstrate after the assassinations of Dr. Martin Luther King Jr. and Sen. Robert F. Kennedy, the continuation of the Vietnam war and the emergence on Vice President Hubert H. Humphrey as the possible Democratic presidential nominee.

Whether to demonstrate is being debated in other groups.

Lowell Rheinheimer, 20, reflects the growing uncertainty when he discusses the Chicago Area Draft Resisters, CADRE, a chapter of a national resistance organization which had plans for demonstrating the week of Aug. 25.

"After Johnson's announcement," he said, "the youths in CADRE had a tendency to relax, to breathe a sigh of relief. And they felt they could withdraw themselves from the movement."

If the peace movement plans appear loose and tentative, those of the civil rights movement are even less structured.

James Farmer, former direc-

tor of the Congress of Racial Equality, said CORE will not demonstrate at the convention and added: "I hope the convention comes off, and I plan to attend."

The Rev. Ralph David Abernathy, president of the Southern Christian Leadership Conference, has never officially adopted the promise of his predecessor, the late Rev. Dr. Martin Luther King Jr., to demonstrate at the convention, although he, too, has mentioned the possibility of a "presence" there.

When eyes first focused on the convention site in early January, Negro comedian and civil rights activist Dick Gregory angrily denounced the Democrats' choice of Chicago, proclaiming the convention would be held only "over my dead body" and that he would spearhead a demonstration of 5,000 persons.

Three months later Gregory called everything off.

He said he feared the planned marches would erupt into violence.

As the civil rights and antiwar threats have softened, so have those of the flower people.

The Youth International Party—or Yippies—has re-evaluated its plans to stage a festival of joy in Chicago during the convention of 50,000 to 500,000 head-spangled youths.

"Yes, we had a program to come to Chicago," said Jerry Reuben of New York, a leader of the Yippies. "And officially

it's still on. But the question of what to do is all up in the air."

It is so up in the air that many Yippie leaders are openly discouraging the Chicago invasion. "The drama was taken out of the situation by Johnson's decision," Reuben said.

The Yippies contend they are regularly abused by police in daily situations, and were especially forcefully dispersed during an antiwar march in April.

But city officials deny such allegations, as do officials of the Democratic party.

"Mayor (Richard J.) Daley has frequently stated that anyone who wants to can come to Chicago to carry out his right as an American to petition and demonstrate as long as he doesn't violate any laws," one city official said.

Demonstrations are highly restricted in Chicago. A city ordinance allows only one march a day, limits the size of the march to the discretion of the police superintendent. It requires that police be notified at least 24 hours in advance of the route, its points of inception and termination, and the names of the leaders.

The ordinance restricts marching to daylight hours, but prohibits marches during the peak traffic hours of 7:30 a.m. to 9 a.m. and 5:30 p.m. to 6 p.m.

With the threats of demonstrations fading, another possible obstacle has been thrown up—the statewide strike by a tele-

phone-union.

Officials of the 11,800-man Brotherhood of Electrical Workers contend that a continuance of the strike could mean delay of installation of the complex communications network required for the convention.

Linemen, installers and repairmen have been on strike since May 8 in a dispute over wages. Negotiations have been broken off.

But Illinois Bell Telephone Co. officials insist that adequate manpower and technology is available for installation of the sophisticated equipment.

Convention coordinator John M. Meek seems unconcerned about the strike and says merely, "We'll cross that bridge when we come to it."

And in the backdrop of all this, Democratic party and Chi-

cago city officials continue to rebuff rumors that the convention will be moved to another city—possibly Miami Beach, where the Republicans will meet earlier in August.

Meek has assured the news media almost weekly: "We never ever discussed moving the convention, or talked about it, or thought about it. We came out here have the convention. We knew there would probably be demonstrations. There were demonstrations at the 1964 convention. Nobody was any the worse for it."

Chance Devised Ice Cream Cone

NEW YORK (AP) — The ice cream cone, the traditional American summer treat that has become an international year-round favorite originated by chance at the St. Louis World's Fair in 1904.

Researchers at the National Biscuit Co., a leading cone producer, discovered that the first known merger of cone and cream occurred when an unidentified concessionaire at the Fair experienced a lull in business for the flat, sweet griddle cakes he was selling. He tried rolling a still-warm cake into a cornucopia shape and, pleased with the result, coaxed an ice cream vendor in an adjacent booth into putting a scoop of ice cream into the open end of his creation.

It's not known if that first scoop was vanilla, chocolate or strawberry, but neither the cake vendor nor the ice cream salesman recognized the potential of their discovery. However, two other Fair employees were more farsighted. Shortly after the exposition closed, these two men, whose names also are lost to history, began the commercial production of handmade cones in Cincinnati and they soon were joined by competitors in other cities.

The first machines to produce cones were developed in 1910 and were able to turn out 3,000 cones an hour. Now cone-making machines can produce six million a day in a variety of shapes, including the standard conical type, double-top cones to handle two scoops of ice cream, flat-bottom cups, and cones for home use.
