Resolution Submitted In Both Houses
Use Of Computers To Assist In N.C. Redistricting Is Proposed

RALEIGH (AP) — The North Carolina General Assembly received legislation today authorizing the use of computers to assist in congressional and legislative redistricting. Sen. Hargrove Bowles, D-Guilford, sent up the resolution in the Senate and Rep. Norwood Bryan, D-Cumberland, sponsored it in the House. The legislation authorizes and instructs the Legislative Services Commission to employ computer resources to assist in the redistricting. "This resolution," Bryan said, "will save a lot of time because it will do our arithmetic for us. There are a vast number of combinations of counties that will satisfy the judicial requirements for redistricting. It will give us all the combinations and we can pick the one we want." He added, "It costs in excess of \$2,500 a day to run the legislature and this would save us many days." Bryan noted that the cost of using the computer could be "far less than the time we would save." Bowles said in a prepared statement, "Computers can possibly simplify the process of redistricting. Data consisting of population figures and any other standards may be input and the computer will produce all possible plans which meet the prescribed standards. When the computer starts repeating itself, it has exhausted all possibilities." Bowles went on to say, "If it becomes necessary to break down county lines, the number of possible districts becomes very great indeed. The computer would in this event save a great deal of manual calculation." The Guilford senator noted that "Nothing short of the closest possible equality" in redistricting "can reasonably assure us that the courts will not upset the plan."

Raid Guerrilla Base
Israeli Strike Deep In Lebanon

By MARTIN ZUCKER Associated Press Writer TEL AVIV (AP) — Israeli commandos penetrated 28 miles into Lebanon during the night, killing 10 Arabs at a Palestine guerrilla base on the coast and wounding many more, Israel's military command said today. It was the deepest Israeli incursion into Lebanon since the attack on the Beirut airport Dec. 28, 1968. The Lebanese government reported two guerrillas killed and seven wounded. It said helicopters and ships landed the raiders at Sarafand, on the Mediterranean coast, under cover of naval bombardment. An Israeli spokesman said six Israelis were wounded. He reported that the raiders blew up two houses, a number of caves and underground buildings used for housing and storage, and a rocket launcher mounted on a raft. Officials in South Lebanon said Sarafand was a "secret little harbor used by the guerrillas for embarking on the occupied Gaza Strip." AP Correspondent Elias Antar reported from Sarafand that an estimated 120 Israeli commandos made the raid in four helicopters. He said they blew up two guerrilla strongpoints on the shore, but the guerrillas and the Lebanese army claimed they fought off the raiders before they reached the main guerrilla base. The Lebanese army said the Israelis made two assaults. The Israelis said they learned of the base from five Palestinian frogmen who landed Jan. 2 on the northern Israeli coast "to kidnap an Israeli citizen." An Israeli spokesman said the raid was in retaliation for a number of Arab guerrilla raids on Israeli settlements along the Lebanese border. The last previous retaliatory raid into Lebanon occurred on Dec. 27, when several Arabs and one Israeli were reported killed in an attack on a village six miles across the border. At U.N. headquarters in New York, mediator Gunnar V. Jarring awaited the reaction from Egypt and Jordan to proposals which Israeli leaders communicated to him last weekend when he visited Jerusalem.

Allowing Governor To Succeed Himself Is Favorably Received

By NOEL YANCEY Associated Press Writer RALEIGH (AP) — Gov. Scott's proposal that future governors be allowed to succeed themselves received a generally favorable reaction from the North Carolina General Assembly Thursday. "I have always felt that a governor should be allowed to succeed himself as many times as the people were willing to re-elect him," said Rep. Perry Martin, D-Northampton. Rep. Ike Andrews, D-Chat-ham, who was named chairman of the House Rules Committee by Speaker Phil Godwin said he had in the past opposed the idea of letting a governor serve two terms in succession, but said now "I am willing to admit the time is here or near when it must be done." Godwin said he could "see some virtue in the idea" of a governor serving more than one term, and Rep. Jim Houshouser, R-Watauga, state Republican chairman, said he thought the governor's proposal was "pretty sound" and he felt the General Assembly might go along with the idea of letting the people decide the issue. But Rep. Dwight Quinn, D-Cabarrus, said that letting a governor succeed himself "is one of the things that I don't know whether I agree with or not." Only minutes after the governor had urged the General Assembly to boost North Carolina's minimum wage from \$1.25 to \$1.60 an hour Rep. E. Lawrence Davis, D-Forsyth, introduced a bill to do just that. "Inflation has substantially increased the cost of living," said Scott in proposing the increase. Davis, a freshman legislator, said he had prepared his bill before he knew it was part of the governor's program. He said he sponsored the bill because "a person cannot live and support a family on \$1.25 an hour." "I think chances are excellent that the minimum wage will be increased and I think there is a fair chance it will be increased to \$1.60," Davis added. There were some rumblings among the lawmakers that the governor had not recommended enough for the public schools in the proposed budget. "If he has any substantial problem it will be in respect to public schools," said Sen. W. W. Staton, D-Lee. Rep. Dan Lilley, D-Lenoir, and about 15 other house members sponsored a bill to permit youths over 18 to donate blood without the written consent of their parents or guardians.

Incumbent Is Unseated By Election Bd. Honor King

WHITEVILLE, N. C. (AP) — The North Carolina Board of Elections wound up a three-day hearing Thursday by declaring Republican Thomas Harrelson of Southport the winner of a disputed race for the state House of Representatives. Official final returns earlier had left the race in a tie at 5,452 votes each between Harrelson and the incumbent, Democratic Rep. Arthur Williamson of Columbus county. The board ruling in favor of Harrelson climaxed a hearing into alleged fraud and forgery in the Nov. 3 general election in the South Lees precinct of Columbus County. Evidence was brought out at the hearing to show that poll books issued by the state elections board each contained 64 pages while the South Lees book contained only 62 pages. It also was brought out that the South Lees poll book had 38 names but Republicans said only 31 persons voted, and of the remaining seven, five testified that they did vote. A handwriting expert from the State Bureau of Investigation testified that the signatures of Republican and Democratic election judges were forgeries. The board ordered that its records be turned over to the attorney general and district solicitor for possible prosecution. Just before the board ruled Thursday, Williamson's attorney said the legislator would not return to Raleigh even if he were named the winner, because of the "cloud" over him. Hunt Fire-Bomber Into The Gulf

RIO DE JANEIRO (AP) — Police and newsmen kept watch through heavy rains today for Swiss Ambassador Giovanni Bucher, but there was no indication when his kidnapers would release him. Hundreds of police patrolled the streets around the envoy's hillside residence with instructions to "arrest the kidnapers." But it was considered likely he would be turned loose at some remote point to make his way home. Leftist guerrillas had promised to release Bucher after 70 prisoners were freed by the Brazilian government and flown to Chile, as ransom. A Chilean Foreign Ministry official said Bucher would be set free as soon as news agency photographs of the prisoners arriving in Santiago got back to Brazil. The prisoners reached Chile before dawn this morning. Bucher was abducted Dec. 7 by a group called the Popular Revolutionary Vanguard. He was the fourth diplomat kidnaped in Brazil in 15 months. NEW ORLEANS (AP) — An undetermined amount of oil gushed into the Gulf of Mexico today from one of a cluster of Shell Oil Co. wells at a platform which has been burning out of control since Dec. 1. A Shell spokesman said the well had "looped over into the water because of the terrific heat." The company prepared a 125-foot boom through which sand and water will be pumped at high pressure to blast the steel casing until the oil escapes and catches fire again, thus halting the water pollution. Shell has put out two burning wells on its platform 10 miles off the Louisiana coast and 60 miles south of New Orleans. Five or six wells continue to burn. Shell estimated at least one more would be brought under control by Tuesday. An aerial survey Thursday disclosed oil ashore and in the surf between Belle Pass and the resort of Grand Isle.

Murder Trial Is Nearing Jury

LOS ANGELES (AP) — The Sharon Tate murder trial is near the crucial moment when the jury will be asked for a verdict, and the prosecutor has launched a last dramatic appeal for conviction of hippie-type clan leader Charles Manson. "Charlie is a phony and a con-man," Deputy Dist. Atty. Vincent Bugliosi said at the end of his second day of summation Thursday. "He's a vicious, cold-blooded murderer." Bugliosi said he would end his arguments sometime today. The jury then will receive the judge's instructions and could begin deliberations late today or early Saturday. The trial began seven months ago.

NCNB Reduces Its Prime Rate

CHARLOTTE (AP) — North Carolina National Bank dropped its prime interest rate today to 6 1/4 per cent from 6 1/2 per cent. Ken Clark, a vice president of NCNB, said the bank, second largest in North Carolina, was following the lead of the First National City Bank of New York, which made an identical cut today of its prime interest rate.

School Closed

WARRENTON, N. C. (AP) — John Graham High School in Warrenton has been closed "at least until Monday" by the Warren County Board of Education following a request by its faculty. The school was closed for seven days in November after racial disorders and, since it reopened, there have been 24 small fires in the school buildings and on the grounds, Principal Fred Bartholomew said. Faculty members cited the "unbearable strain" and asked the board to close the school "until order and discipline can be restored." The teachers told the board that constant disruptions have endangered lives of pupils and faculty. The board considered the request Thursday morning and closed the school early Thursday afternoon. The school has about 650 pupils, about 150 of them white.

Court Martial Clears My Lai Accused

By WILLIAM L. CHAZE, Associated Press Writer FT. McPHERSON, Ga. (AP) — Sgt. Charles Hutto, who drove a truck and chopped cotton before joining the Army, has been acquitted of assault with intent to murder My Lai villagers during an infantry operation in 1968.

officers who deliberated a little more than two hours.

Hutto was the second soldier to be tried and acquitted on charges arising from the attack on My Lai. Sgt. David Mitchell of Ft. Francisville, La., was found innocent Nov. 20 at Ft. Hood, Tex., of assault with intent to kill.

Hutto, 22, of Tallulah, La., an eighth grade dropout, stood at attention in the cramped, paneled courtroom at 3rd Army headquarters at Col. Donald Laffoon, president of the court-martial, announced the verdict.

All of the jurors were Vietnam veterans.

Glancing at a piece of paper in his hands and then staring straight at Hutto, Laffoon, a bespectacled, mustached officer

from Highland, Ind., said: "Not guilty, your honor."

Hutto, deadpanned but blinking, took a deep breath and exhaled. The soldier, whose wife, Brenda, was weeping among the spectators, then turned and embraced his lawyers.

The soldier joined his pretty, blonde wife and the two walked out of the old, red-brick building into a misting rain.

Still blinking back tears, Mrs. Hutto told newsmen that she had done "a lot of praying" and "figured it would be all right."

"I have faith in the Army," she said.

Hutto, smiling and holding his wife's arm, declined to comment when asked whether testimony at his trial had produced

an accurate picture of what happened at the Vietnamese village.

"I'm not going to answer any question about My 'Lai,'" he said. "That's all I've got to say about it."

"That's all behind me now. That's in the past."

He said he expected to leave the Army by next week, take a job as the manager of an Atlanta ice cream shop and return to school. The soldier has been held in the Army a year past his scheduled separation date. He enlisted in 1967 for three years.

Edward Magill of Miami, Fla., Hutto's civilian lawyer, called the case "an important one—for Charlie Hutto and the Army."

Magill, a lieutenant colonel in the Army Reserves, said in his closing statement Thursday the Army's entire system of discipline was on trial with Hutto.

"Think about what you would have if every time a private got an order he stopped to question it," said Magill. "Think about the other Charlie Huttos in the Army."

The defense contended that Hutto entered the tiny hamlet of My Lai intent not on murdering civilians but on following orders he had received from Capt. Ernest Medina, the commander of Charley company, and other officers.

Witnesses testified during the trial that Medina ordered his soldiers to "kill every living thing in the village."

Col. Kenneth Howard of At-

lanta, the military judge, said the testimony left little doubt that Medina gave an illegal order. The question the jury must answer, he said, was whether Hutto knew it was illegal when he fired on the villagers.

Hutto admitted in a sworn statement that he shot at civilians during the operation but said he only did so because he thought he was following orders.

Magill held that neither Hutto nor the other Charley Company troops had ever been told of illegal orders or how to react to them.

He said it never occurred to Hutto, described by a psychologist as incapable of forming the intent to kill or of disobeying orders, that an illegal order would be passed down the chain of command.

Charged With Impersonation Of CIA Agent

RICHMOND, Va. (AP) — A federal grand jury has indicted Philip L. Twiddy, 37, of Hampton, on a charge of impersonating an officer of the Central Intelligence Agency.

An FBI affidavit said Twiddy and Roger Allan Merricks were arrested by police in Wilmington, N. C., last Dec. 22 on a local charge and that Merricks was wearing a military uniform at the time.

The affidavit quoted Merricks as saying that Twiddy had asked him if he had a military uniform and if he would become Twiddy's aide for a trip to Wilmington.

The federal complaint charged that on Dec. 21 in Emporia Twiddy represented himself as a colonel in the CIA and said he needed someone to drive him to North Carolina on a "secret mission."

By TOM SEPPY, Associated Press Writer WASHINGTON (AP) — President Nixon's proposal to consolidate most federal volunteer programs into a new agency will affect five government bureaus and 10 programs.

In a speech at Nebraska University Thursday, Nixon said he will send a special message to the next Congress asking that the Peace Corps, Volunteers in Service to America (VISTA) and a number of other agencies now scattered throughout the federal government be brought together into a new agency—a new Volunteer Service Corps.

Nixon did not name the other programs but it was understood they were:

The National Teacher Corps, Retired Senior Volunteer program, Foster Grandparents and National Health Service Volunteer Corps, all from the Department of Health, Education and Welfare.

The Senior Corps of Retired Executives from the Small Business Administration, the Office of Voluntary Action in the Department of Housing and Urban Development, the International Executive Volunteer Service from the Agency for International Development, State Department; and the National Student Volunteer Program in the Office of Economic Opportunity.

It was unclear how many volunteers would be included in the new agency, but there are more than 16,000 people in the three largest prospective agencies.

Nixon said the new Volunteer Service Corps "will give young Americans an expanded opportunity for the service they want to give—and that will give them what is not now offered, a chance to transfer between service abroad and service at home."

He said he would place current Peace Corps director Joseph Blatchford in charge "to make it an agency through which those willing to give their

time and their energy can work at cleaning up the environment, at combating illiteracy and malnutrition, and suffering and blight, either abroad or here in America.

"To the extent that young people respond to this opportunity, I will recommend that it be expanded to new fields and new endeavors."

The proposed new federal agency is expected to work closely with the National Center for Voluntary Action, a program announced by Nixon in his inaugural address to help solve the nation's social problems by "enlisting those millions of Americans who stand ready to serve and to help."

Will Count On Informal Talks

CAMBRIDGE, Mass. (AP) — Derek C. Bok, who will become president of Harvard University July 1, says he hopes to establish close communication with the students.

"I've got to find ways to have very informal meetings with small groups," Bok told a news conference Thursday. "The informality is very important. Mass meetings just lend themselves to rhetoric."

How To Buy Home Furnishings

Young married people try to stretch their pennies when they set up housekeeping, but some home furnishings are overpriced, poorly made and in bad taste.

The taste of an individual is a personal matter, and it may take years for a young person to educate herself to a better look in her home. But she can do something about getting her money's worth when she makes purchases for the home.

One giant step is being taken by some members of the home furnishings industry. More companies are endeavoring to explain what goes into their product in an attempt to educate dealers and salesmen.

At a recent home furnishings show at High Point, N.C., a sofa manufacturer had a sofa cut in half so that dealers and retailers could see what goes into the product and, hopefully, pass the information on to the consumer.

During the upcoming winter home furnishings show at the Merchandise Mart in Chicago, one company will show how their carpet is manufactured and a sewing machine manufacturer will display a profile of their machine showing how their needles tuft the carpet. It is all in the interest of showing the workmanship of the product.

Good companies are willing to tell what is in their product. But inferior merchandise often results from the manufacturer's efforts to market something inexpensive.

For example, a young girl saved money earned at an after-school job to buy a chest

for her newly redecorated room. She had seen some campaign-style chests, but they were expensive. When she saw one advertised for \$89, she bought it. But when it was delivered she noticed that the white lacquered side piece had a gash in it. The gash was a break in the thin surface and underneath was a saw dust like material.

Fortunately, she had purchased the piece from a reliable furniture store, and they were grateful to learn what the chest was made of. The store said it

hadn't known, and the girl hadn't asked. She had been more interested in the color, size, hardware and price. She had assumed it was wood, she said.

In choosing a piece of furniture, buyers should be sure to learn all about it before they make a purchase. If the salesman is not specific he should be made to clarify his statements. Many people are intimidated by store personnel. They shouldn't be. They should keep in mind that they are spending their own money not the salesman's.

Big, But No New Tax Measure

The Governor's and the Advisory Budget Commission's \$4.3 million proposed state budget is big, but it also reflects the fact that no new taxes are expected to be imposed this year, and the softness of the economy of the past couple of years.

Generally the budget provides pay increases of approximately ten percent for state employees and teachers during the next biennium and it is doubtful that this is going to be entirely satisfactory to the people involved.

The pay increases will allow a teacher salary range of from \$6,352 to \$9,616 the first year and from \$6,655 to \$10,074 the second year. The present range is \$6,050 to \$9,158. This is far below what teachers were asking and still will not bring the state up to national averages.

Much of what was recommended for 1971-73 involves aid to county and municipal governments. There is a \$25 million recommendation for takeover from the counties of the entire non-federal share of Medicaid and work incentive programs. Powell Bill funds would be doubled for cities, under the Scott proposals. These funds are used by municipalities for non-state system street improvements and maintenance.

The budget proposals do not go as far as the State Board of Education had requested in expanding the kindergarten program, although this program would be trebled with a \$3.3 million appropriation.

There are funds in the budget for increasing by 100 the number of men on the Highway Patrol in the never ending war on highway disasters.

Funds were recommended for increases in academic salaries at the state's universities on an average of ten per cent, although individual raises would be at the discretion of the administrators.

Some \$115,697,393 was recommended for capital improvements at all state institutions with much of this allocated to colleges and universities. In addition to this recommended appropriation an additional \$34,077,487 would be spent in self liquidating, federal and other funds. Together they

make a record.

Even with amount, however, many badly needed construction projects were left behind.

The proposed budget is not spectacular; however there are other proposals to be made both by the governor and by the Legislature itself. The Advisory Budget Commission recommended, for instance that the Legislature settle the question of urban school busing. It also suggested that "the scope and extent of the school of medicine at East Carolina University is a matter for consideration and decision by the General Assembly."

The chances that this and a number of other projects not presently included in the budget, will be approved are still good. A number of additional appropriations are always approved by the Legislature. There is the likelihood that the projected revenues for the biennium will improve it the economy strengthens during the next few months.

The governor's recommended budget has many strengths within the funds which are available. We expect that there will be further recommendations which will make it satisfactory for our growing state.

Moscow Holds Key To Peace

WASHINGTON — Behind President Nixon's sober conviction that Moscow holds the key to peace in the Middle East lies a calculated conclusion by the Administration that Egypt will not dare start shooting across the Suez Canal without explicit Soviet approval.

This means that if the cease-fire is not extended by Cairo when it expires on Feb. 5 as President Anwar Sadat now threatens, only Moscow could prevent a terribly dangerous outbreak of war along the canal.

That shows the lamentable lack of influence available to President Nixon in the implacable showdown period that started with resumption of peace talks by United Nations negotiator Gunnar Jarring.

The talks themselves, which took Jarring to Israel this past weekend, cannot possibly satisfy Egypt's public demand for progress in the brief period between now and Feb. 5. Sadat wants proof that Israel by then will have signalled its willingness to withdraw from conquered Arab lands, particularly Egypt's Sinai Peninsula.

No such concession is possible. Before even discussing withdrawals from Arab-occupied territory, Israel will insist on absolute guarantees, such as unrestricted passage through the Straits of Tiran and into the Gulf of Aquaba, on insoluble problems.

Just how insoluble these problems are can be seen from backstage American maneuvers to extract ticklish compromises from the hard-line Israelis. Taking the Gulf of Aquaba as an example, Mr. Nixon's Mideast experts are quietly pushing an ingenious plan that would give Israel a physical presence on the heights of Sinai's Sharm El-Sheik, overlooking the Straits of Tiran. This would deny Israel its land-bridge — a new road now being built from southern Israel to Sharm El-Sheik down the Egyptian Sinai.

Conceivably, Israel might some day accept this unpublicized U. S. plan, which would add a small Israeli-Egyptian "liaison team" (protecting Israel's right of passage) to the international inspection force posted at Sharm El-Sheik. Some day, maybe, but not now.

Besides, just one Israeli posted on Egyptian territory will almost certainly be one too many for Cairo. And without some physical presence at Sharm El-Sheik Israel will never start talking withdrawal. The result: deadlock.

Deadlock over Sharm El-Sheik is only one of dozens of Arab-Israeli deadlocks which, despite private indications here that Israel may now be prepared to make certain concessions, show no sign of being resolved. Until they are, discussions of a withdrawal timetable will not begin.

That is where the Soviet Union comes in. As the President sees it, months of brutally hard bargaining will be necessary before these deadlocks begin yielding to compromise — if ever they do. But whether diplomacy enjoys so long a time to work its way depends on Moscow.

Thus, if Sadat — under heavy pressure from militant, patriotic younger officers to expel Israel from the Sinai — decides he cannot extend the cease-fire, an Egyptian attempt to cross the canal is predictable (SET ITAL) unless (END ITAL) the Russians say nyet. Without solid assurance of Soviet backing in any such hazardous military operation against the Israelis, Egypt would not strike in force.

Moreover, Sadat's diplomatic hole-card is the threat of renewed shooting that could well involve not only Egypt and Israel but the U. S. and the Soviet Union. So long as a cease-fire continues, he knows that pressures will mount on Israel from the United States (and on the U. S. from virtually every U. S. ally in Europe) to force Israeli withdrawal. Sadat can play that hole-card of renewed hot war only once.

The key to Sadat's decision of Feb. 5, and to the broader question of a Middle East political solution, lies not in Cairo but Moscow. The Russians will undoubtedly refuse to countenance any new Suez war until then, the cease-fire, acknowledged or tacit, seems assured.

That merely delays the flash point to some time in April. If, as now seems safely predictable, the dispute is still deadlocked then, Moscow will have to make its choice: opt for restraint by Cairo or risk a war engulfing itself and the U. S.

Now, Socrates had a wife, Xanthippe, who was known to all men as a shrew, a nag, and a scold. Her sole pleasure in life, it was said, lay in making the philosopher groan. Yet the venerable sage once turned this very situation to the uses of his teaching.

This occurred one morning when a pupil encountered Socrates on the street, and passed to inquire of his health. "And how," added the pupil politely, "is Xanthippe?"

"Compared," asked the philosopher, "to what?"

A suggestion is in order, it seems to me, that my Republican friends of both left and right, in the midst of their anguish with Richard Nixon, retire to the privacy of

their chambers and put to themselves the Socratic question. For it is not really enough to ask: How do you like Mr. Nixon? The philosopher's riposte must be considered as well.

We must suppose that Socrates was examining not merely the alternative to Xanthippe — the other women he might have taken to wife — but that he was deliberating upon Xanthippe yesterday and Xanthippe tomorrow: what the lady had been, what she might yet become.

Politics, as Bismarck remarked, is the art of the possible. When John Lindsay once proposed to begin a speech with that hoary aphorism, his ghost-in-chief begged His Honor piteously to

try again. At the very least, it was urged, let us think up a new cliché. But this is how clichés acquire their patina: They are cast at bottom of solid bronze truth. Bismarck's truth is a trugh the President's critics tend to forget.

The most virulent attacks upon Mr. Nixon, I am sorry to say, are stemming these days from that bastion of the right, the American Conservative Union. The ACU's publication, Battle Line, is becoming an anti-Nixon screed. A number of Southerners, whose principal interest lies in preserving a peaceful and productive system of public schools, are stepping up a supporting barrage. They believe Mr. Nixon led to them on matters of desegregation, and they are not soothed by talk of Haynsworth and Carswell. What has he done for us lately?

Let me talk sense with these unhappy friends. The plain truth is that at Miami, there WAS no possible alternative to Mr. Nixon of Bull Durham. Yet suppose it had been otherwise. Would my friends have preferred Rockefeller? Romney? Hatfield? Stassen? No, but they would have preferred Ronald Reagan. Yet this was impossible; and politics, to repeat, is the art of et cetera.

Came the election of 1968; and when they called the roll up yonder, leaving George Wallace out of it, the tally showed 31,784,000 and 301 electoral votes for Nixon, to 31,272,000 and 191 for Humphrey. How is Xanthippe today? Compared to what? Compared, my brothers, to Hubert Humphrey. Would my friends be happier tonight if HHH had won? Let us doubt it exceedingly.

Very well. What of Xanthippe tomorrow? My compatriots would love to dump Mr. Nixon and revive Mr. Reagan. The prospect has a certain vintage appeal; but alas, it is vintage '64. From this remote distance, it

Now, Socrates had a wife, Xanthippe, who was known to all men as a shrew, a nag, and a scold. Her sole pleasure in life, it was said, lay in making the philosopher groan. Yet the venerable sage once turned this very situation to the uses of his teaching.

This occurred one morning when a pupil encountered Socrates on the street, and passed to inquire of his health. "And how," added the pupil politely, "is Xanthippe?"

"Compared," asked the philosopher, "to what?"

A suggestion is in order, it seems to me, that my Republican friends of both left and right, in the midst of their anguish with Richard Nixon, retire to the privacy of

their chambers and put to themselves the Socratic question. For it is not really enough to ask: How do you like Mr. Nixon? The philosopher's riposte must be considered as well.

Twain Meet In Mills' Offices

RALEIGH — The Governor is executive. The General Assembly is legislative. Their separation is as fixed as east and west.

The twain meet where Fred M. Mills, Jr., holds forth in an office off a first floor court of the Legislative Building where a serve-yourself coffee bar is always open.

The meeting is amiable with an absence of pressure. "Arm-twisting? I don't believe it can be done. I'm not big enough to do it," said Mills, a Wadesboro businessman — farmer acquainted with the legislative process through two teams each in Senate and House.

Furthermore, he went on, the reservoir of good will and support among legislators for Governor Bob Scott and his program would make strong-arm strategy unnecessary as well as unseemly.

Factors In His Favor

Mills knows legislative procedures and the thought patterns which guide lawmakers' decisions because he's been there. He's on a nick-name basis (Fritz) with most returning members. He counts as close personal friends the presiding officers for the '71 session, House Speaker Phil Godwin and Lieutenant-Governor H. P. (Pat) Taylor, Jr.

Governor Scott undoubtedly had these factors in mind when he selected Mills for his liaison with the final General Assembly of his term.

"Lame duck" is the appellation given to the chief executive when he deals with the legislature with the close of his administration in sight.

That recognizes the political reality that his power, apologetic and otherwise, is on the wane and that attention already is shifting to the future and his successor.

Scott has disclaimed the "lame duck" label and put before the session a far-reaching program, centered on reorganizing the structure of state government and extending to protection of the environment and charting goals for the future. Except for the tax boosts successfully engineered two

years ago, the Governor's mid-term program is quite as ambitious as his initial presentation to the General Assembly.

Protecting those revenue sources gained in 1969 — taxes on soft drinks and cigarettes, a two-cent per gallon hike in the gasoline tax — may turn out to be the major undertaking for Mills and administration forces.

Granted that there's no bag of appointments to dangle, Mills said he sees no reason why support for the Governor's program should lag this time.

"I've served under two Governors — Sanford and Moore — in their second sessions, and I didn't notice their power was greatly diminished," he said. "After all, he's still Governor. His friends aren't going to desert him simply because he only

Installations Being Given South Vietnam

SAIGON (AP) — The U.S. Command says 150 more installations, ranging from major base camps to small pumping stations, will be turned over to the South Vietnamese as part of the Vietnamization program.

"So far more than 100 installations have been transferred to Republic of Vietnam armed forces," a spokesman said. "These are facilities and installations of all sizes."

The original cost of the 250 installations and facilities was roughly \$60 million, he said, adding:

"Most of these installations were constructed to an austere standard with an estimated life of less than five years. Most of those turned over already were army unit base camps and small cantonment facilities, small troop housing facilities. We haven't really turned over any high-cost facilities."

The command isn't saying exactly what installations will be turned over in the future, but many likely will be Army camps and Navy, Marine and Air Force facilities as American troops are withdrawn.

The entire U.S. 3rd Marine Amphibious Force and 1st Marine Division at Da Nang are being withdrawn from Vietnam by next June, and their headquarters camps and other facilities likely will be turned over to the South Vietnamese.

When U.S. installations or facilities are declared surplus the command conducts a study to determine the best usage. The spokesman says the following possibilities are considered in order of priority:

- Use by another U.S. military unit in Vietnam.
- Transfer to the South Vietnamese armed forces.
- Transfer to another allied force in Vietnam.
- Use by a U.S. military unit outside Vietnam, if the facility can be moved economically.
- Use by another U.S. government agency in Vietnam.

"When a facility is transferred to the South Vietnamese they adapt it to meet their requirements," he said. "For example, they may use part of it for housing the families of soldiers. Part of the barracks area may be converted to dependent housing."

OAKLAND, Calif. (AP) — A member of a motorcycle club has been acquitted of murdering a youth at a rock music festival while movie cameras rolled and an estimated 300,000 persons listened to the Rolling Stones. The slaying appears in a sequence of the movie "Gimme Shelter."

Alan David Passaro, 22, of San Jose, Calif., a member of the Hells Angels, whooped a joyful "Yow!" and his blonde wife Celeste burst into tears when a court clerk read the verdict Thursday.

But Passaro is back today in the same 10th floor Alameda County jail cell he occupied when his trial started a month ago to await return to Soledad State Prison to complete a 2-to-10-year sentence for parole violation. Originally he was sentenced from Santa Clara County for theft of a motorbike and marijuana possession.

Passaro's defense was that two knife wounds he admitted

inflicting on Meredith Hunter, 18, of Berkeley, were not the fatal ones and that he acted out of fear for his life because Hunter had been brandishing a pistol. The Berkeley youth had five stab wounds.

The eight men and four women jurors, who recessed overnight during their nearly 15 hours of deliberation, declined to comment on their decision.

Judge William J. Hayes of Alameda County Superior Court had listed four possible verdicts besides acquittal in his charge — first- or second-degree murder or voluntary or involuntary manslaughter.

Defense attorney George Walker said he felt movie films taken near a stage at the Alameda County fairgrounds, Dec. 6, 1969, when Hunter was slain, showed his client innocent.

He said the pictures, seen several times by the jury, established a theory that Hunter had already been stabbed before the crowd in front of the stage separated and Passaro rushed in to make an overhand knife thrust.

Passaro was arrested in a car with three other Hells Angels on a San Jose street three days after the killing as a result of detectives' study of the motion picture film.

On the witness stand he testified he hadn't meant to kill the Berkeley man when he jumped on his back, but was trying to get Hunter's gun away from him.

A bus, provided by Virginia Electric Power Company, will be a Tri-County Feed Mills in Bethel at 9:30 a.m. to pick up interested Pitt County farmers. The bus will pick up farmers on a first come first serve basis and the number of passengers is limited. There will be no charge for the bus ride.

Scott visited a Blood Mobile unit in downtown Raleigh Thursday to donate a pint and proclaim January Blood Donor month in North Carolina.

Scott rolled up his left sleeve, stuck out his arm and asked the nurse, "Is this the right one?"

"No, sorry," said Dorothy Payne as she attached a blood pressure machine to Scott's right arm.

Mrs. Payne applied her stethoscope and listened intently. "I can't hear your heart beat for my own," she quipped.

As the governor lay on the donor table, his wife Jessie Rae stepped up to chide him for upstaging her. Mrs. Scott, a Red Cross Volunteer, was giving out pins to donors.

After the pint was drawn, Scott was taken to the recovery area for the best part of the experience—soft drink and cookies.

"Now we've got to the part I understand," said Scott, who is well-known for his off-and-on diets.

Scott ate the cookies as Mrs. Scott gave him his donor pin.

has two years left to go." Elections Gave Strength

Scott goes into his second session from a point of strength. He put his record on the line in last fall's general elections, campaigned vigorously against Republican charges that tax increases were unnecessary and that state government operation was wasteful.

Election results cut GOP strength by 11, in the face of anticipated gains. The surprising Democratic tide rebounded to Scott's credit, as party chief and administration leader.

Aspiring candidates to succeed Scott in his Capitol office will be much a part of the '71 legislative drama.

Chief among them, on the Democratic side, are Lt. Gov. Taylor and Senator Hargrove (Skipper) Bowles of Greensboro. Rep. James Holshouser of Watauga, the state GOP chairman, is regarded as a prospect to carry his party's banner in the 1972 gubernatorial race.

Politics No Problem

Mills doesn't see the jockeying which might accompany the developing campaign for governor as a problem for him. "I don't believe it would be wise for anyone who wants to be governor to have on the record an attempt to wreck another governor's program," he surmised.

"Unless it would be Holshouser," he amended. "There's a certain amount of partisanship we'll have to look for."

While he is on friendly terms with both Taylor and Bowles, obviously Mills has closer ties with Taylor. They're both from Wadesboro, and have been friends and fellow legislators a long time.

Does that stake him out to support Taylor for Governor next year?

He feigned surprise. "I didn't know Pat was running," he said.

Bunche In A N.Y. Hospital

NEW YORK (AP) — Ralph J. Bunche, 66-year-old U.N. under-secretary general, is said to be in satisfactory condition at a hospital where he has been under treatment since Jan. 2.

Bunche entered New York Hospital with what a U.N. spokesman described as a heavy cold. A hospital spokesman said he developed bronchitis, which seemed to be clearing up.

seems incredible that the Republican Party could repudiate its own President and field a different nominee without incurring certain defeat — without insuring the election, that is to say, of the Democratic nominee. It was the people of Athens, who failed to stand by a good man when they had one.

Quotes Colonel As Ordering 'Wipe Them Out For Good'

FT. BENNING, Ga. (AP) — The rookie chief of the 11th Infantry Brigade gathered his company commanders for a pep talk on the eve of the My Lai attack, a court-martial witness says, and told them they hadn't been aggressive enough with the Viet Cong.

"Wipe them out for good," S.

Sgt. Dennis R. Vasquez quoted the colonel as saying.

The next day, Capt. Ernest Medina's Charley Company swept into the village expecting to meet a fierce Viet Cong unit. Instead, the government claims, the Americans slaughtered uncounted numbers of defenseless Vietnamese civilians, including women and children.

The pep talk was related Thursday to the jury trying Lt. William L. Calley Jr. on charges of murdering 102 "Orignal human beings" in the village nearly three years ago. Calley led the 1st Platoon in Medina's company.

The testimony of Vasquez was offered to bolster the defense contention that officers far superior to Calley were responsible for the alleged civilian killings.

Vasquez, then a captain, was artillery liaison officer for the task force, a unit of the 11th Infantry.

The day before the March 16, 1968 assault, Vasquez testified, he was at a briefing conducted by Col. Oran Henderson who had taken command of the brigade the day before.

Vasquez, now stationed in Germany, holds a lower rank now than he did in 1968 because he left the service for a while, then rejoined.

Lt. Col. Frank A. Barker, the task force commander, was in that meeting, Vasquez said. So was Medina, Calley's immediate superior.

Barker died three months later in a helicopter crash.

Medina emerged from that briefing and gave one of his own to Charley Company, gathered around him in a circle at the Landing Zone Dottie staging area.

"Someone asked if we were

supposed to kill women and children and everything," Medina's radio operator, James Errol Flynn, 22, testified.

"What was Capt. Medina's response to that question?"

"He replied, to kill everything that moved," said Flynn, who now works as a pipe fitter in Rochester, Minn.

Judge Reid Kennedy permitted the release of some heretofore confidential documents that had been shown to the six-officer jury while the courtroom was clear of spectators.

One of the documents is an order from Col. Nels A. Parson Jr., chief of staff of the parent American Division, issued nearly a month after the My Lai operation.

It forbids further use of the term "search and destroy" in the command on the grounds that the term "has occasionally been used to foster the impression that military operations wantonly create, without regard to human suffering, large numbers of refugees."

A number of witnesses have testified that Medina, in their briefing, classed their mission at My Lai as search and destroy.

SAIGON (AP) — A South Vietnamese task force trying to reopen Phnom Penh's highway to the sea battled North Vietnamese forces today around a key mountain pass 95 miles southwest of the Cambodian capital.

The U.S. Command announced that an American plane was shot down in another sector of Cambodia.

South Vietnamese military headquarters said the task force smashed into more than 200 North Vietnamese at Stung Chhay, one of two key mountain passes controlled by the enemy

on Highway 4. Fighting raged until dusk Thursday as South Vietnamese fighter-bombers and artillery pummeled the North Vietnamese positions on the heights overlooking the road. Reports from the area said the fighting resumed today.

A South Vietnamese spokesman said 41 North Vietnamese and five government troops had been killed and 28 South Vietnamese wounded.

"It is not clear who controls the area," the spokesman said. While the southern task force tried to push north, the Saigon government said, a force of South Vietnamese marines was moving south toward the Pich

Nil pass, the other enemy stronghold on the highway, about 60 miles southwest of Phnom Penh.

"The marines have not arrived there yet," the spokesman said. He added that he did not know how far the marines were from the pass. However, the Cambodian commander in the area said Thursday that his troops were advancing on Pich Nil and would retake it from the North Vietnamese and that he was keeping the South Vietnamese marines in reserve.

A total force of 5,300 South Vietnamese and 8,000 Cambodian soldiers launched the two-ended drive Wednesday to reopen Highway 4, which has been closed by North Vietnamese troops since Nov. 21. Phnom Penh has been cut off from its seaport, Kompong Som, creating shortages of oil, gas and other imports in the capital.

The U.S. plane shot down in Cambodia was an Army spotter craft that crashed in Kratie Province, in the northeastern part of the country. The crewmen were rescued.

Sources said the plane apparently was on a reconnaissance mission spotting North Vietnamese positions for U.S. artillery on the South Vietnamese side of the border.

It was the first American aircraft reported lost in Cambodia since Dec. 12 and the 52nd reported lost there since last May.

The only significant battlefield action reported in South Vietnam was a clash between about 50 North Vietnamese and

American forces from the 5th Mechanized Infantry Division less than two miles south of the demilitarized zone. U.S. headquarters said seven North Vietnamese were killed, and there were no American casualties.

Headquarters said one American was killed and seven were wounded in mine and booby trap incidents. A second American was killed and seven others wounded in the accidental firing of a mortar round, the U.S. Command said.

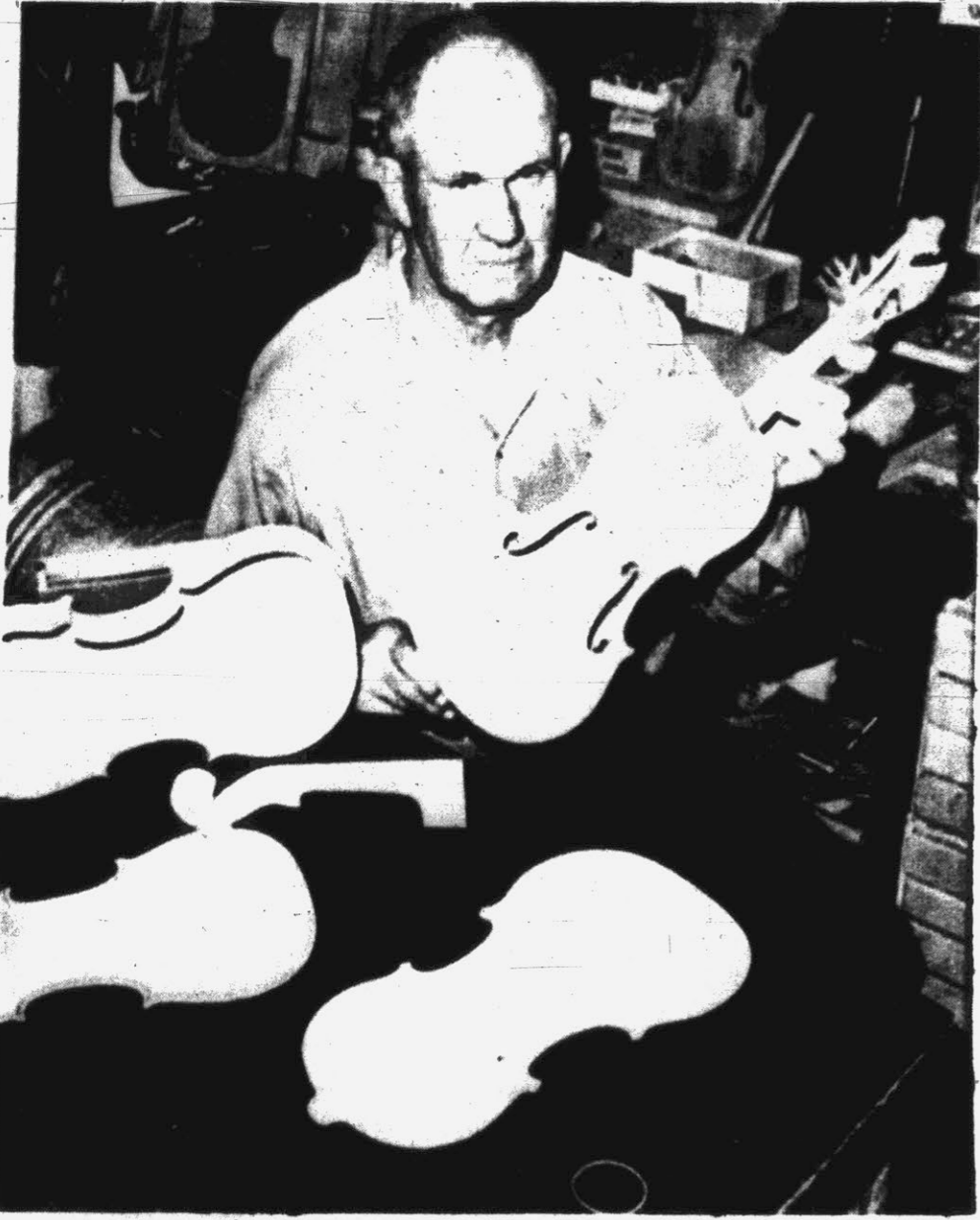
No Governor For Brief Period

OKLAHOMA CITY (AP) — Oklahoma will be without a governor for 2½ days next week unless the United States is attacked by a foreign power.

The Oklahoma Constitution provides for acting governors when the governor is outside the state.

But Gov. David Hall and the top three men in the line of succession—the lieutenant governor, the president pro tempore of the Senate and the House speaker—all will be in Washington for the inauguration of Rep. Carl Albert, D-Okla., as speaker of the U.S. House of Representatives.

And there is no constitutional provision for successors beyond that except in an emergency provision. It names a host of state officials as next in a line of succession if the United States comes under attack.

Poll Indicates Priests Under Severe Strain

One of every four Roman Catholic priests is considering quitting the ministry because of severe emotional stress, a study indicates. Among Protestants, the problem is only half as acute, with one of every eight Protestant ministers considering resignation.

The comparative findings were drawn by a University of Notre Dame sociologist, Dr. John P. Koval, from an analysis of data from 1,500 Catholic priests and 5,000 ministers of 21 Protestant denominations.

"Over-all, we find not only that Catholics have a relatively higher incidence of severe stress than the Protestant clergy (25 per cent vs. 12 per cent) but their high stress incidence is also accompanied by a greater proportion of multiple stresses," Koval says.

The main problems reported bothering Catholic clergymen include conflicts with superiors, loneliness, lack of support from colleagues, claims of inadequate leadership, a desire to marry, and disappointment with Church stands on moral issues.

For Protestants, the main difficulties were found to center on job factors such as inadequate pay and a sense of "futility and ineffectiveness of the church's work," rather than on the personal dimension.

However, neither Protestant nor Catholic clergy—no matter how distressed—indicated any loss of conviction about their faith.

The study found a pervasive "generation gap" among clergy, with about twice as many younger priests under age 45, citing dissatisfaction as those over that age.

Says Exception In Deep South

LOS ANGELES (AP)—Dr. Carlfred B. Broderick, professor of sociology at Pennsylvania State University, says premarital sexual intercourse is increasing in this country and that women are participating more freely.

The exception, he said, is the Deep South where "the traditional double standard of sexual morality is more influential."

Broderick, a guest lecturer at the University of Southern California Wednesday, said his studies indicate that in conservative sections of the nation, the number of women who take part in sexual intercourse before marriage has increased from about 10 per cent to 30 per cent in recent years. In the more liberal areas, he said, the number has risen from 30 per cent to 50 per cent.

The material was taken from a Protestant clergy support study and a national study of celibacy sponsored by the National Federation of Priests' Councils.

In regard to feelings among Protestant clergy that they're underpaid, another study by the Episcopal Church Foundation found that laymen think ministers' salaries may nearly double by 1975, and that they should go even higher.

The nationwide survey among lay men and women, seeking to determine what kind of clergymen can best serve parishes in the future, found that a solid grounding in theology was considered the first requirement.

The ideal clergymen also should be "an interesting and relevant preacher," have a lively interest in young people and "skill in family counseling," the study found. But few laymen expect the minister to be an expert fund-raiser or administrator. About half favor ordaining women.

Daily Papers Hiked Prices

NEW YORK (AP)—The American Newspaper Publishers Association reports that 126 newspapers increased their daily price to 15 cents during 1970.

That brings to 146 the number of daily newspapers selling for 15 cents, according to a survey by the ANPA.

An overwhelming number, 1,606, still charge 10 cents a copy, but a year ago the number was 1,680. Only 51 dailies still charge 5 cents a copy or less, the ANPA said.

The ANPA said only four daily newspapers were selling for 15 cents a copy in 1967.

The state with the most daily newspapers at 15 cents is New York, with 34. Massachusetts has 22, Pennsylvania and Indiana 11 each, Wisconsin 9, and California, Maine and Michigan six each.

Even though New York has 34 papers selling at 15 cents, 39 dailies sell for 10 cents and three for 5 cents.

Canada has five dailies that charge 15 cents and 95 that charge 10 cents. The Bahamas' two papers charge 15 cents each. Puerto Rico and the Virgin Islands have no papers charging 15 cents.

Only two papers, both in Oklahoma, sell Sunday editions for five cents. The most common price around the country is 25 cents, with 161 in that category. Another 140 papers charge 20 cents, 115 charge 15 cents and 89 charge 10 cents.

Thirty newspapers charge 30 cents for Sunday editions, 35 charge 35 cents, three charge 40 cents and four charge 50 cents, the ANPA said.



Heath Warns Critics In Commonwealth

SINGAPORE (AP) — Prime Minister Edward Heath today told Commonwealth critics of his plan to sell arms to South Africa that the 31-nation association could be wrecked by attempts to limit the rights of member states to pursue their own national policies and interests.

In a keynote address at this year's Commonwealth conference, the British prime minister sidestepped direct reference to his Conservative government's plan to provide arms to the

white-supremacist government of South Africa. But he plainly had that in mind when he said any tampering with the sovereign rights of Commonwealth nations would be "playing into the hands of those who would gladly see the Commonwealth destroyed."

Heath said the Commonwealth "is not a court of appeal with a prescriptive right to sit in final judgment of the policies and the actions of its members. It's a body of friends free to come and go as they wish."

Heath dwelt at length on the "aims and realities" of Soviet power, asserting that the Kremlin's rules are out to push the frontiers of their influence to every part of the world, and particularly into the Indian Ocean.

His government wants to sell limited supplies of maritime weapons to South Africa for the defense of the sea lanes off

southern Africa. African members of the Commonwealth are opposed, contending that the arms will be used against South Africa's black majority, and some of the African nations are threatening economic retaliation against Britain or withdrawal from the Commonwealth.

Earlier today in the second conference session, Tun Abdul Razak, prime minister of Malaysia, expressed grave concern at the encouragement, blatant or implied, given to racist regimes in South Africa, Rhodesia and Portugal's African territories.

In a rebuke to Heath, Razak complained that the sale of arms to south Africa would have "the effect of boosting the morale of the racists in the pursuance of their apartheid and colonialist policies."

Razak also served notice that Malaysia will seek a new and friendly relationship with Communist China if Peking stops

trying to subvert its neighbors in Southeast Asia. He said Malaysia stands for the neutralization of the entire region.

The Malaysian leader said his government favors seating Red China in the United Nations,

Hog Cholera Reappears In County

DETROIT (AP) — Two Detroit police officers were shot and killed late Thursday night in the downtown area.

Police information officer Richard Boutin said the two officers were in plainclothes and in a private car when they came upon a street altercation.

Boutin said the officers stopped to try to break up the argument and they were shot, apparently before they were able to leave their car.

Police reported two persons taken into custody, one allegedly with a wound by a light automatic weapon.

A new outbreak of hog cholera has developed in Pitt County in the Ham's Cross Roads area, according to Henry C. Riddick, assistant county agricultural extension agent.

Farmers in this area should use extreme caution to prevent the spread of the disease, especially when visiting hog lots in that area, Riddick explained.

"If a visit is absolutely necessary, clothing and footwear should be changed before another hog lot is visited," Riddick noted.

The new quarantine area starts at McGowan's Cross Roads, runs down rural road 1700 to the intersection of U.S. 264 to Chicod Creek to Tar River and extends to the county line. The quarantined area then proceeds south along the county line to rural road 1800; then westerly on 1800 to rural road 1786 to Black Jack, and from Black Jack along rural road 1774 to McGowan's Cross Roads.

"Farmers are reminded that all hogs in the quarantine area are restricted in movement except to market," Riddick said. "The premises must be inspected for market hog movement by qualified personnel and a certificate of movement instead."

At present, this is the only area under quarantine in the county. The Belvoir quarantine was lifted on Jan. 12.

All hog farmers should remember that to move feeder pigs, market hogs, or breeding stock, their premises must be inspected.

Speaking about the various approaches to the campaign, Major Fielman noted, "Our mail appeals will be making their traditional appearance in homes here this month."

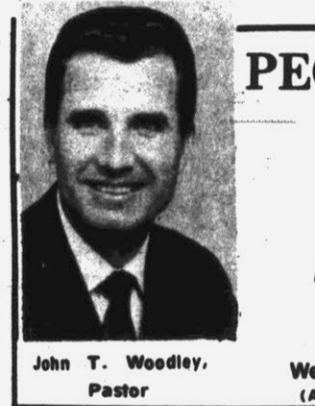
He added, "Every person who sits down and writes a check for this cause should realize that his check can help create a whole new life for one of the nearly 250,000 children born with birth defects every year."

East Carolina University's Pirates return to Southern Conference action Saturday night, but have to travel again for it. They go to Greenville, S.C., to meet the Furman Paladins, who moved into a share of first place last night.

Both Furman and Davidson post 3-1 Southern records, while East Carolina rests in third with a 2-1 mark. Furman bested Richmond last night, 101-77, on the Paladin home court to gain the first place tie.

The Pirates will be out to start a new winning streak after losing Wednesday night, 90-82 to strong small college power Old Dominion.

"We look for a much improved team as compared to last year's," East Carolina's Tom Quinn said of Furman. "This will be one of our more difficult conference games, and we expect it to be an extremely hard game."

"Even though Furman lost to The Citadel (90-80) last week, they have a good home record, and they present a number of problems," Quinn said. Furman has posted a 6-1 mark at home, but has yet to win on the road in three away contests. One of their home victories was an 84-75 victory over Davidson. The lone home loss came in the Poinsettia Classic to Mississippi State, 84-74.

"They are a good shooting team," Quinn pointed out. "And they will match us in height. They are very strong in their backcourt play and we'll be going against their 1-3-1 offense which we haven't seen this year so far. This type of offense weighs heavy on individual play on defense, and it's hard to help out against it."

According to the latest Southern Conference statistics, one game out of date for each team, Furman is the leading offensive team in the conference, five full points ahead of the Bucs at 84.8 points per game. However, the Pirates are allowing only 75.5 points per contest, one less than Furman. The two teams are almost even in field goal percentage, but Furman's free throws are a good bit ahead of the Bucs. Furman is hitting 71.9 per cent of their charity shots, while the Bucs are converting only 65.5.

The Bucs are doing a better job on the boards, however, pulling in 52.1 per cent of the loose balls, as compared to 41.3 per cent for Furman.

Russ Hunt is the leading scorer for the Paladins, pushing through 18 per game. Lisco Thomas is getting 16.9, followed by Bernard Collier with 12.3, Don Jackson at 9.3 and Jerry Martin at 8.3.

Hunt is the only rebounder in

double figures with 10.3, while Thomas is next at 7.6.

Hunt, 6-8, is a sophomore, while Thomas, 6-7, is a senior. They play a double-post position. Collier and Martin are on the wings with Jackson at the point.

"We look for quite a bit of pressure from them, along with some zone defenses," Quinn said.

The Pirates, meanwhile, don't expect to do anything different. "We'll just work on some things

to get ready. We've been a little slow in picking some things up, but our players are in good spirits. They don't like to lose, and I feel they are going to be all right," the coach said.

"I still think we have a good team, but whether we have a championship team will depend on how well we eliminate the little errors that good teams don't make."

Following Saturday's contest, the Bucs return home on Tuesday, meeting Davidson.

Super Bowl Silently Ready

MIAMI (AP) — The countdown to Super Bowl V accelerated today for the Baltimore Colts and Dallas Cowboys, but the big buildup inherent in previous summit scraps remained conspicuous by its absence.

In contrast to the brubaha that preceded each of the four AFL-NFL confrontations, the main conversation piece as the Colts and Cowboys began final preparation for Sunday's championship showdown was the physical status of Walt Garrison, No. 2 wheel in Dallas' dynamic running game.

Through no fault of their own,

the Super Bowl foes have the look of a pair of Crusaders with no Holy War to fight.

The Colts, led by incomparable Johnny Unitas, will be out to atone for their upset loss to the New York Jets in Super Bowl III two years ago.

The Cowboys will be out to prove, once and for all, that they are capable of winning the Big Game. And both teams will be out to claim the winner's shares of \$15,000 per player.

But the open hostilities of the AFL-NFL battles have been missing. Baltimore and Dallas were allies, under the NFL banner, until merger and realignment put them in opposing camps last season. Neither has

an axe to grind in the name of league prestige.

"No, I don't want to win it for the old AFC," said Billy Rae Smith, 35-year-old war horse of the Colts' defensive unit. "I'd like to win it for old B. R. and the Colts."

The Colts' hopes will be riding on the 37-year-old arm of Unitas, whose charisma has been dominant during the week building up to the game.

Dallas will counter Unitas' passing with the league's most potent ground attack, a ball control force led by super rookie Duane Thomas and Garrison, if he's healthy. The Cowboys' stocky fullback came out of the NFC title game against San

Francisco two weeks ago with a sprained ankle and chipped collarbone.

"I would think Garrison will start," Cowboys' Coach Tom Landry said Thursday. "He's been running with Thomas in our first unit."

"We would have been in bad shape if we only had one week to prepare for Baltimore. We had six players who might not have been able to play."

Both clubs tapered off Thursday after working out for three days in balmy, 80-degree weather. The forecast for Sunday calls for partly-cloudy skies, temperatures in the 70s and northerly winds up to 15 miles per hour.

The Cowboys, who developed a fun-in-football approach for the first time in their checkered history while reeling off seven straight victories to nail the NFC title, have been training at a leisurely pace in Ft. Lauderdale.

"We've been working out in an atmosphere of vacation," Landry said, "but you wouldn't know it by the players."

The Colts, who shifted to the AFC in last year's realignment and captured the conference title on the heels of a six-game winning streak, have been strictly business all week at their Miami Lakes hideaway. They blame their 16-7 Super Bowl loss to the Jets in part to the "carnival atmosphere" of their 1969 training base.

There is no question in my mind that we'll be physically and mentally ready to play Sunday," said veteran offensive tackle Bob Vogel.

In line with the low-key attitude each team has taken toward the upcoming collision, there have been no "guarantees" of victory such as the one Jet ace Joe Namath made good against the Colts.

"No predictions," said Dallas quarterback Craig Morton, who has recovered from an elbow injury and a laryngitis attack under the hot Florida sun. "We're not a talking team."

"If I had a crystal ball," said Baltimore middle linebacker Mike Curtis, "I'd go out and bet the horses."

Marquette String To Go On Line Saturday

Danger signals were flying today for Marquette's 24-game winning streak, currently the longest in college basketball.

The New Mexico State Aggies who play the unbeaten nationally second-ranked Warriors at Milwaukee Saturday, were upset by West Texas State 72-67 at Amarillo Thursday night.

That forbodes trouble for Marquette since the Amazing Aggie will be on the rebound against the Warriors. The Aggies gained their nickname in the NCAA championship tournament last March by beating St. Bonaventure for third place.

"Our mental mistakes killed us," commented coach Lou Henson of the Aggies. "Anytime you get outbounded this bad, 56-37, you'll lose."

Maybe the Aggies, now 10-3, this season to Marquette's 12-0, were looking past West Texas to Marquette. At any rate the Buffaloes overcame a three-point deficit in the second half to go

ahead for good at 50-58 with 7:41 left to play.

Ralph Houston scored 18 points and grabbed 18 rebounds to pace the Buffaloes. Chito Reyes was high for the Aggies with 19.

Notre Dame, beaten by Marquette 71-66 earlier in the week, bounced back to beat Detroit at South Bend 93-79 as Austin Carr threw in 47 points.

The Irish trailed by 13 points at halftime 44-31, but came from behind in the second half as Carr scored 38 points in the last 20 minutes. A free throw by Carr put the ninth-ranked Irish ahead for good at 62-61. Jim Jackson led Detroit with 29.

McClendon Went From Tragedy To Big Thrill

HOUSTON (AP) — A season that ran the gamut from tragedy to ecstasy to heartbreak climaxed in the thrill of a lifetime Thursday night for Louisiana State's Charlie McClendon when he won coach of the year honors from his fellow football coaches.

Actually, the popular Cholly Mac shared the American Football Coaches Association's coach of the year honor in the university division with Darrell Royal of Texas, who became the first ever to win the major college award twice.

Bennie Ellender of Arkansas State's small college national champions captured the college division award. Ellender has since taken over as head coach

at Tulane.

The awards dinner capped the AFCA's 49th annual convention. "We had to come from below the floor to rise to the heights we did," said McClendon, who guided LSU to a 9-2 regular season record before a bitter 17-12 loss to national champion Nebraska in the Orange Bowl.

LSU's season hit the depths two weeks before it even started with the shocking death of quarterback Butch Duhe from a floating cyst on the brain.

"I'll never forget it," said McClendon. "He had been suffering from headaches and they became so excruciating that I wouldn't let him practice. I laid him down in the training room. They took him to the hospital and an hour later they told me

I better get over there. By the time I got there he had expired. Breaking the news to his parents was the toughest thing I've ever had to do."

A stunned LSU team then dropped a 20-18 last-minute decision in its opening game against Texas A&M. Next came seven consecutive triumphs, several of which were unimpressive against weak opposition before a 17-9 victory over powerful Auburn—a game that put LSU in the Southeastern Conference driver's seat.

The winning streak finally was snapped 3-0 by Notre Dame, a team that cost the Tigers a bowl bid a year ago by suddenly reappearing in the post-season picture. Ironically, that 3-0 setback in Notre Dame Stadium did almost as much for LSU as a victory would have.

Two weeks later the Bengals blasted Mississippi 61-17 for the SEC crown and a berth in the Orange Bowl. Archie Manning, Mississippi's great quarterback, played with a protective covering on his broken left arm and the LSU players went out of their way to avoid hitting the arm.

So much so that more than one coach here told McClendon how impressed they were with the performance. He even got a letter from Manning's mother.

"She complimented our players for true sportsmanship," McClendon said.

Royal's Texas Longhorns finished the regular season with a 10-4 record and were ranked first in the Associated Press poll. But their 30-game winning streak was shattered 24-11 by Notre Dame in the Cotton Bowl.

Ellender directed Arkansas State to a perfect season, including a Pecan Bowl victory over Central Missouri.

More than 1,700 members of the AFCA cast their ballots at the end of the regular season.

Shaw Hopes To Turn It Around

PEBBLE BEACH, Calif. (AP) — Tom Shaw compared himself to Arnold Palmer as he discussed his winless 1970 season on the professional golf tour.

"I kept thinking I'd win a tournament. But, just like Arnold, I ran out of tournaments," said the 28-year-old blond from Oregon after shooting a four-under-par 68 Thursday to share the first round lead with Bobby Nichols and Terry Dill in the \$135,000 Bing Crosby National Pro-Am Championship.

Palmer, the game's all-time leading money winner, also went without a tournament victory in 1970. But with \$128,000 in prize money, the year was no disaster.

Shaw won the Doral Open and Avco Classic in 1969 and totaled \$83,332 in winnings. But a reversal in his fairway fortunes last year made him one of the tour's second class citizens — a non exempt player. He was 68th on the money list, with \$34,004 in 1970.

"There was no big change in my game. My scores were just too high," he said Thursday after his sub-par round at the 6,464-yard Cypress Point course.

Nichols, who made his 1970 season with a \$60,000 first-place check in the Dow Jones Open, also played his opening round at Cypress, the shortest of the three courses used in the Crosby. Dill's 68 was at the four-year old Spyglass Hill course and was the best round ever at the 6,972-yard course in Crosby competition.

Shaw, Nichols and Dill were one stroke ahead of veteran Howie Johnson. At 70 were Gene Littler, Rik Massengale, Lefty Gene Ferrell and Argentina's Roberto de Vicenzo.

Jack Nicklaus, who passed up last week's season-opening tournament in Los Angeles, started 1971 with a 72 at Cypress.

The Ohioan, whose five 1970 titles included the British Open, was bunched with Palmer, Masters champion Billy Casper and several others at even par.

Shaw and Nichols had early

tee times Thursday and played most of their rounds when the weather was warm and calm on the ocean side courses. Blustery winds moved in later in the day.

Shaw made two big birdie putts, from 25 and 30 feet. Nichols outdid him, however, with putts of 40 and 45 feet for two of his six birds.

"A putter can make a racehorse out of a mule," said Nichols, whose chances of holding the lead alone were killed when he put a three-iron shot into the Pacific on no. 17 and took a double bogey six.

Dill played most of his round in the afternoon but Spyglass is the least windy of the three Crosby courses. The Texan, who has never won a tournament in nine years on the tour, ignored the wind on the 14th hole by holing out with a nine-iron from 112 yards for an eagle three.

Shaw, trying hard not to run out of tournaments this year, also was a first round leader last week at Los Angeles. He finished the tourney with a 282, and by going 72 holes he spared himself the agony of going out with the "rabbits" this Monday to qualify for a spot in the Crosby.

Devine Takes Packer Post

GREEN BAY, Wis. (AP) — Dan Devine wasn't here Thursday to hear perhaps the most important announcement of his life, but even in absentia he made one thing perfectly clear.

At 46—the same age Vince Lombardi was when he took charge of the Green Bay Packers 12 years ago—Devine isn't too old to tackle a new challenge.

One of the most successful college football coaches in the nation, Devine is willing to give up his coaching job and athletic directorship at the University of Missouri—where tenure gave him total security—to try to fill the National Football League footsteps of the legendary Lombardi.

Devine was given a five-year contract at undisclosed terms as head coach and general manager of the Packers. His mission is clear: to restore the pioneer NFL club to somewhere near the heights it ascended in the 1960s under Lombardi.

The mantle was passed to Devine, the seventh head coach in Packer history, after three disappointing seasons under Phil Bengtson.

Bengtson was handpicked by Lombardi as his successor in 1968, when the Packers were riding a crest of three consecutive NFL and two straight Super Bowl titles. But his three-year record was only 20-21-1, in-

cluding 6-8 in 1970. He quit under fire Dec. 22.

Dominic Olejniczak, Packer president, announced the signing of Devine at a hastily called news conference Thursday.

George Allen was believed to have been Green Bay's first choice when he was fired by the Los Angeles Rams. But then Allen was hired by the Washington Redskins, and the Packers turned to the college ranks.

Devine, who was in Kansas City Thursday, telephoned Pat Peppeler, Green Bay player personnel director, later in the day to discuss the NFL draft which starts Jan. 28.

Devine, a native of Augusta, Wis., said he would be "less than honest if I didn't say that reaching this decision to leave the University of Missouri was the most trying experience of my life."

Devine played quarterback at the University of Minnesota-Duluth.

He entered coaching in 1948 at East Jordan, Minn., High School, where he had two undefeated teams in two seasons.

After five years at Michigan State and two at Arizona State, he went to Missouri to succeed Frank Broyles as head coach.

In the next 13 years, second longest coaching reign in Missouri history, he compiled a record of 93 victories, 37 losses and seven ties. His teams played in six bowl games, winning four.

NOTICE TO LIST TAXES

Every person, firm or corporation owning property January 1, 1971, whether real or personal, is required by the laws of North Carolina to list such taxes during the month of January. Property must be listed in the township in which it is located.

Critics' Case Against Space

WASHINGTON (AP) — The recent successes of two unmanned Russian moon probes have sharpened the arguments of critics of America's manned space flight program.

The critics proclaim that America, too, should rely more on automatic payloads, and they urge additional cutbacks in manned projects. Congressional opponents of man in space already have sliced deeply into

the space agency budget since the Apollo 11 moon landing in July 1969.

They have been aided by several factors: the need to spend money on more earthly problems like pollution, poverty and Vietnam; the abortive Apollo 13 mission which demonstrated the risk to astronauts, and the fact that most Americans believe the Soviet Union no longer is a threat to U.S. superiority in space.

The congressional action,

which has trimmed NASA's budget from a peak of \$5.9 billion in 1966 to \$3.2 billion this year, has resulted in elimination of three Apollo moon landings, a stretchout in other missions and cancellations of some unmanned programs.

That leaves just four more Apollo shots, starting with Apollo 14's scheduled Jan. 31 launching.

In the same period, the number of persons employed in the space program in the United States has dropped from 420,000 to 145,000.

Yet, a Senate attempt in December to delete \$110 million from the budget for NASA's next major manned vehicle, the space shuttle, was defeated.

The feeling of the Congressional majority now seems to be: space cuts have been deep enough. Let's ease up for the time being.

However, the \$110 million will allow NASA only to move into a study phase on the shuttle, a reusable vehicle intended to ferry men and supplies between earth and a large orbiting space station. Space officials foresee future budget battles similar to those being waged by congressional opponents of the SST, the supersonic transport. They say it will be a fight against the SSS or shuttle space station.

Congress has cut enough funds in the past two years to delay the launching of the shuttle space station from 1975 until 1977 or 1978, perhaps later.

The only other plan for sending man into space before that calls for a small three-man station named Skylab to orbit the earth in 1973. That could mean a gap of four or more years in manned space flight.

Manned flight proponents fear this will enable the Russians, who have declared they will orbit the first large station, to overtake the U.S. lead in space.

Most opponents of manned flights feel this argument is flag-waving and propaganda intended to influence Congress to loosen the purse strings. They feel the United States can maintain an on-going space program

and a lead over Russia with an annual budget around \$3 billion.

Scientists generally have decried the cuts in the space program. However, congressional opponents of the shuttle have enlisted two eminent scientists for their cause.

They are Dr. James A. Van Allen of the University of Iowa, whose instrument aboard America's first satellite discovered the Van Allen radiation belts, and Dr. Thomas Gold of Cornell University, who also heads President Nixon's space science panel.

"The manned space program, it seems to me, has had its day," Gold said.

Van Allen said: "I am totally unpersuaded that men in a spacecraft are important or even useful in any way that is commensurate with the effort required to maintain them there. It increases the cost of a given mission and risks human life unnecessarily."

The Iowa physicist said future space flights "should be launched for purely scientific objectives" and recommended two central objectives for the space program of the 1970s.

"First," he said, "the fullest economically feasible exploitation of our space capabilities for useful applications in rapid and efficient communications, in aviation, and in the analysis and forecast of the dynamics of the world's weather and in terrestrial reconnaissance and survey in the broadest sense."

"Second, the enlargement and extension of scientific knowl-

edge and human perception of the larger physical universe."

The presence of a fifth trump should not have influenced him into taking drastic action, inasmuch as his holding contains no marked distributional advantages. With eight high card points, and two doubletons, North has a sound free raise to two spades.

West opened the king of clubs, the dummy played the ace and East signaled mild encouragement with the five. A spade was led to the

queen and West was in with the ace.

West was dubious of the prospects of cashing a club trick in view of South's reluctance to defend against five clubs. It appeared that East might welcome a play at this point, but there was some question in West's mind regarding which suit to attack inasmuch as he did not know where partner's strength was concentrated.

After considerable soul searching, West shifted to the ten of diamonds. Declarer was in. He drew trump and proceeded to run the diamonds, discarding three hearts from dummy. He cheerfully conceded one heart trick to his opponents and claimed his contract.

Inasmuch as East is most anxious to obtain a heart shift if West regains the lead, he should endeavor to convey a message to partner at trick one, by dropping the ten of clubs under the ace. Inasmuch as the ten is an unnecessarily high card, it is hoped that partner will interpret this play as a suit preference signal to indicate strength in the higher ranking of the two remaining suits — hearts and diamonds.

We are aware that, in the normal course of play, a high card is a come-on and requests a continuation of the suit led. If it were East's desire to get more clubs, however, he could play the eight. The ten is an unnecessarily dramatic signal, and by common sense should be construed as a suit preference play requesting a heart lead.

Yet, a Senate attempt in December to delete \$110 million from the budget for NASA's next major manned vehicle, the space shuttle, was defeated.

The feeling of the Congressional majority now seems to be: space cuts have been deep enough. Let's ease up for the time being.

However, the \$110 million will allow NASA only to move into a study phase on the shuttle, a reusable vehicle intended to ferry men and supplies between earth and a large orbiting space station. Space officials foresee future budget battles similar to those being waged by congressional opponents of the SST, the supersonic transport. They say it will be a fight against the SSS or shuttle space station.

Congress has cut enough funds in the past two years to delay the launching of the shuttle space station from 1975 until 1977 or 1978, perhaps later.

The only other plan for sending man into space before that calls for a small three-man station named Skylab to orbit the earth in 1973. That could mean a gap of four or more years in manned space flight.

Manned flight proponents fear this will enable the Russians, who have declared they will orbit the first large station, to overtake the U.S. lead in space.

Most opponents of manned flights feel this argument is flag-waving and propaganda intended to influence Congress to loosen the purse strings. They feel the United States can maintain an on-going space program

edge and human perception of the larger physical universe."

"If one or more men in the spacecraft is the cost-effective technique for conducting any one of these missions, let it be done in that mode," Van Allen said.

"But if, as I anticipate, this is not the case, let us not grieve nor devote ourselves to the invention of specious and inane reasons to the contrary. Rather let us get on with our two basic objectives in the most sensible and rational framework that we can devise."

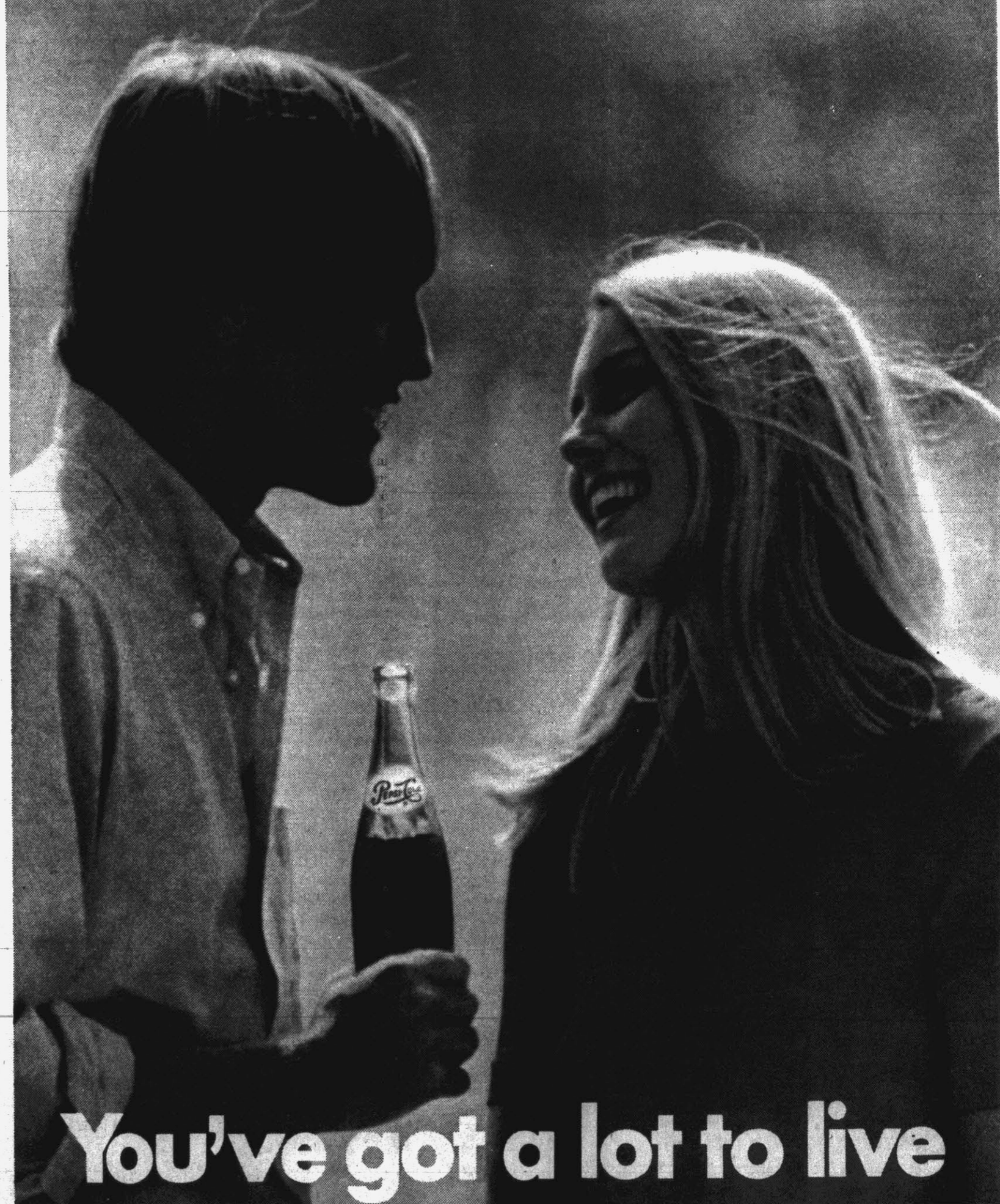

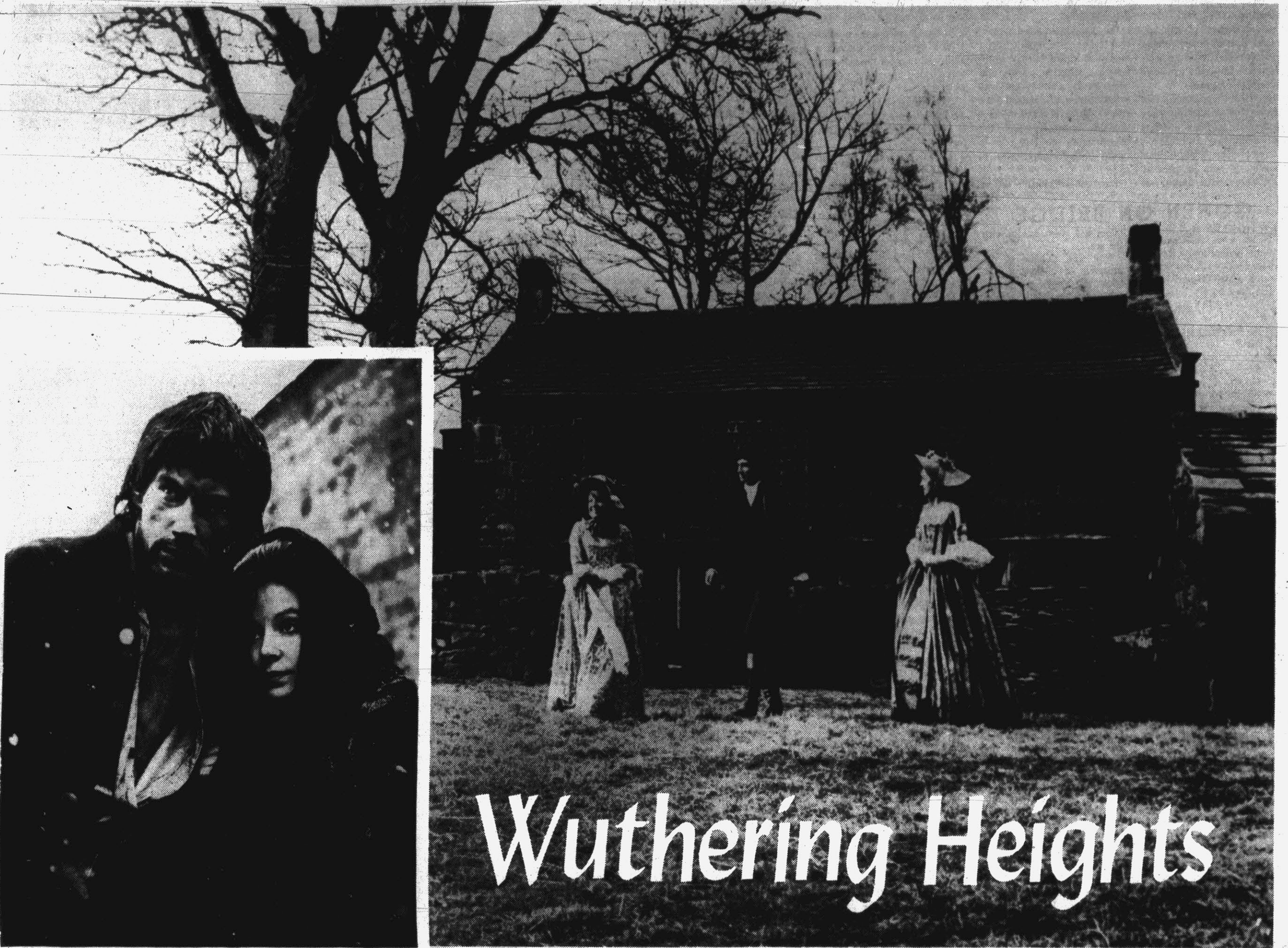

“Heathcliff!”—Catherine’s desolate cry from the heart still echoes over the Yorkshire moors. A new film based on Emily Bronte’s classic, “Wuthering Heights,” has been made in Yorkshire in the authentic setting of the 19th century novel, and it brings up interesting points of comparison with the original Hollywood version made in 1939.

The earlier film was made on Joel McCrea’s Los Angeles ranch. Laurence Olivier and Merle Oberon played Heathcliff and Catherine—dramatic roles which made them into international stars.

These much-coveted roles have now again been taken by two young, gifted “unknowns,” Timothy Dalton and Anna Calder-Marshall. Dalton, 23 years old, has a look of the young Sir Laurence. But he avoided seeing the earlier film so that his own interpretation would not be influenced by Sir Laurence’s. He’s already had three screen roles, in “The Lion in Winter,” “Cromwell” and “The Voyeur.” Miss Calder-Marshall, at age 22, had previously scored a great success on television in “Male of the Species”—her acting in that won her an Emmy award.

Director Robert Fuest says his film is almost as much about the moors as about the young lovers. The wild landscapes are used as a complement, and a magnificent, brooding accompaniment, to the passionate and tragic story of Heathcliff and Cathy. Although there’s an emphasis on the youth and rebelliousness of the young lovers, however, Fuest feels that “the central situation of the book is so basic and universal that it should have some appeal for everyone, even the ones who remember the Olivier version.”

The cast, director and crew of the new version are all English. But it did have American financial backing (American International Pictures) in common with the earlier film. Emily Bronte’s novel was adapted by Patrick Tilley.

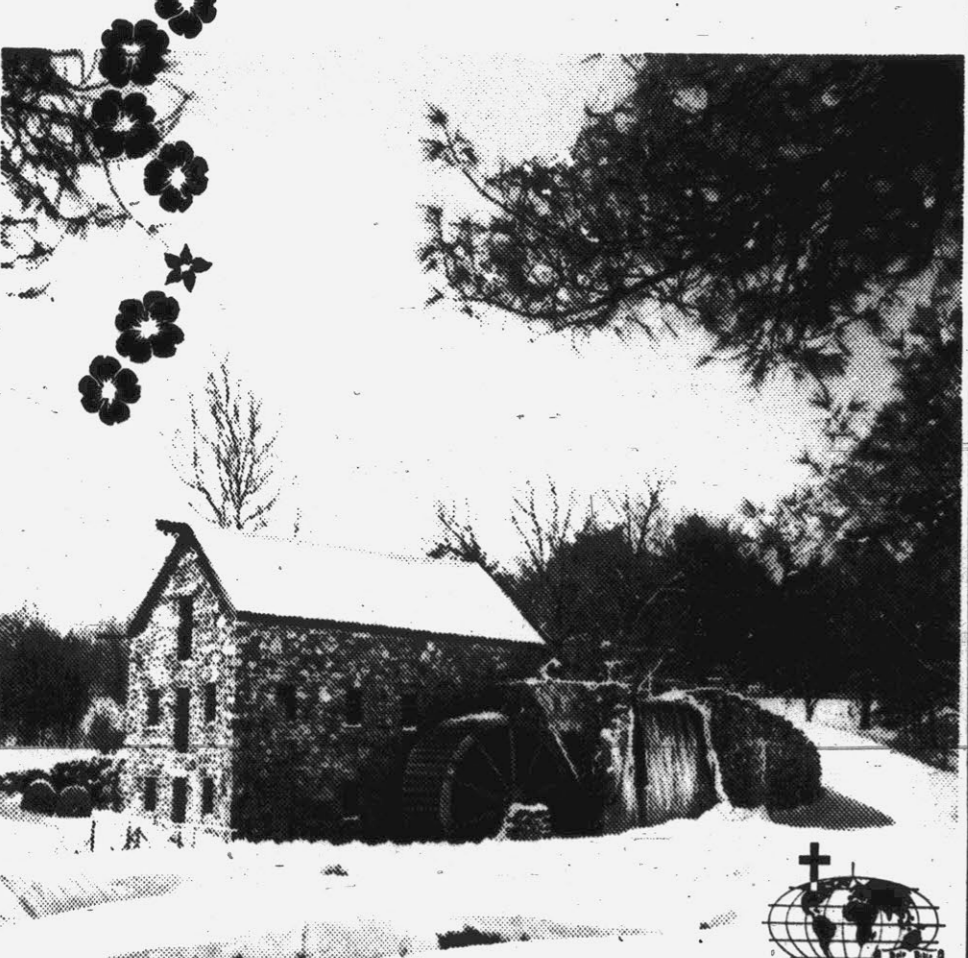
