## Kissinger And Thieu Hold Talks

SAIGON (AP) — Henry A. Kissinger and President Nguyen Van Thieu conferred for more than two hours today on secret peace talks that the presidential adviser held with the North Vietnamese, in Paris. They scheduled a second meeting for Friday. It had been expected that Kissinger and Thieu would confer only once. The scheduling of a second meeting fanned speculation that the subject was highly significant and possibly involved a major proposal put forth by the Americans.

U.S. Sources confirmed that the talks between Kissinger and North Vietnam's chief negotiator, Le Duc Tho, figured in the meeting. They gave no hint as to the tenor of the discussion or whether there had been disagreement.

"I really won't talk — there is no sense in asking me questions," President Nixon's chief adviser on foreign policy told newsmen when they asked if he was delivering any new peace proposals to Thieu.

Kissinger, who arrived Wednesday night from Paris

and Switzerland, met with Thieu after a session Wednesday evening with U.S. Ambassador Ellsworth Bunker and a meeting of nearly three hours today with Bunker, Gen. Frederick C. Weyand, the commander of U.S. forces in Vietnam, and Weyand's Air Force commander, Gen. John W. Vogt.

Kissinger said his conference with the other Americans dealt with "the general political and military situation." This echoed the White House's earlier announcement that he was going to Saigon for a "general review of all aspects of the Vietnam problem including the negotiations in Paris."

Kissinger came to Saigon after a secret meeting in Paris Monday with Le Duc Tho of the North Vietnamese Politburo, and while the American was traveling to South Vietnam, Tho was en route back to Hanoi.

This combination of events, coupled with the boost that a peace agreement would give President Nixon's candidacy for re-election, touched off speculation around the world that Kissinger and Tho had made a deal and that Kissinger had come to Saigon to tell Thieu he would have to resign and make way for a coalition government.

## \$30.5-Billion HEW Bill Vetoed, Killed

WASHINGTON (AP) — President Nixon and his congressional supporters have killed a \$30.5-billion spending bill for health, education and welfare. The action provoked harsh attacks from administration critics. Nixon vetoed the bill Wednesday and pressed Congress to take out the \$1.8 billion added to his original request. He called the measure "reckless federal spending."

The House hours later failed to muster the two-thirds majority necessary to upset the veto. The vote was 203 to 171 in favor

of overriding, 47 short of the number needed. No Senate vote on overriding will be taken.

Here is how North Carolina congressmen voted. To sustain the veto, Republicans Broyhill, Jonas, Mizell and Ruth and Democrat Fountain. To override, Democrats Galifianakis, Henderson, Jones Preyer and Taylor. Rep. Lennon, a Democrat, was listed as not voting.

Although Democrats led the attack on Nixon, the party split ranks in the House and 42 Democrats voted with 129 Republicans against overturning the veto.

Democratic presidential candidate George McGovern de-

nounced the veto and declared it a campaign issue.

"Mr. Nixon has a confused set of values when he said it is reckless to spend \$1.8 billion more to meet the health, education and human needs of this country, but contends it is desirable to spend over \$4 billion more on the Pentagon next year," McGovern said in a statement issued in Springfield, Ill., where he was campaigning.

Sen. Edward M. Kennedy, D-Mass., asserted, "The President's veto once again has demonstrated his insensitivity to the nation's priorities in health, education and programs affecting the elderly."

But in the House, some ranking Democrats disagreed with their leaders' denunciation of the veto.

"The bill is higher than can be justified under the conditions prevailing in this country," said Texas Democrat George H. Mahon, chairman of the Appropriations Committee.

In his veto message, Nixon said the government cannot afford to spend the \$30.5 billion appropriated for the Labor and

Health, Education and Welfare departments.

The spending "just cannot be done without more taxes or more inflation, both of which I am determined to avoid," he said.

The bill carried funds for the fiscal year which began last July 1, and its demise leaves the two departments operating at last year's level of spending.

The vetoed measure contained about \$800 million more than the President asked for education, including special allotments for poverty-area schools.

The health allotments exceeded his budget by about \$900 million. Included were extra funds for research at the National Institutes of Health, for mental health care, and for hospital construction grants.

Nixon also vetoed the HEW-Labor spending bill in 1969 and was upheld by the House.

## Banks Robbed

Two banks were robbed in North Carolina this morning. Police say a branch of Wachovia Bank and Trust Co. near Greensboro was held up and an office of the North Carolina National Bank at Charlotte was robbed less than an hour later. They were the 26th and 27th bank holdups of the year in the state.

The Charlotte bank is at the intersection of Beatties Ford Road and Lasalle Street in the northern part of the city. Officers said a young man, armed with a small caliber pistol, took an undetermined amount of money. Police said the robber may have joined two accomplices and fled in a car.

Further details were not immediately available.

The amount of money taken in Greensboro was not immediately determined.

## Greenville Mart Up Wednesday; Had \$86.64 Day

The average on the Greenville tobacco market was higher yesterday than on the two previous sales days this week.

Yesterday's average of \$86.64 per hundred pounds was 10-cents per hundred pounds higher than Monday's average of \$86.54 and nine cents higher than Tuesday's average of \$86.55.

The Greenville market yesterday sold 515,825 pounds for \$446,903. Greenville led the other six markets operating in the Eastern Belt in the number of pounds of tobacco sold yesterday.

Wilson received an average of \$86.85 when 515,432 pounds of leaf went for \$447,631. The lowest average on the Eastern Belt was received on the Kinston market. That market averaged \$86.27 per hundred pounds.

The Farmville market averaged \$86.69 after selling 249,686 pounds of tobacco for \$216,459. The Smithfield market also averaged \$86.69 when 248,961 pounds of leaf was sold for \$215,827.

The volume of sales on the

Farmville market continued heavy for the limited opening, according to Louis Williams, sales supervisor of the Farmville market.

"Offerings consisted mostly of primings and lugs and the volume of nondescript grades showed a sharp gain on all floors," Williams said. "Tobacco carried over from last year accounted for a large percentage of sales yesterday."

Clean grades of lugs and cutters accounted for top price paid on the Farmville market and these grades continued to bring 87 cents per pound.

According to the Federal-State Market News Service, stabilization did not receive any tobacco from yesterday's sales on the Eastern Belt.

The seven markets sold a total of 2,763,249 pounds of tobacco yesterday for \$2,392,263, giving an average of \$86.57 per hundred pounds.

Season totals for the Eastern Belt include 16,501,127 pounds of leaf being sold for \$14,267,643, for a season average of \$86.46.

## VC Echoing Peace Claim

PARIS (AP) — The Viet Cong's chief delegate asserted today that President Nixon "missed one of the most favorable opportunities to end the war" when he arrived in the White House in January 1969.

U.S. Ambassador William J. Porter did not reply to the assertion by Mrs. Nguyen Thi Binh, which echoed Democratic statements in the U.S. presidential campaign, but again urged a cease-fire.

"With the killing stopped," Porter said, "you could devote your attention and resources to the needs you have neglected during wartime, such as the dikes. Vietnamese could hold discussions on South Vietnam's future political institutions."

His reference to dikes was an answer to a renewed charge by the North Vietnamese at the 155th session of the peace talks that the United States was deliberately bombing the dikes.

Mrs. Binh declared the U.S. government in 1969 was not seeking "a correct negotiated solution, based on the fundamental rights of the Vietnam-

ese people and of the right of self-determination for the people of South Vietnam."

"On the contrary, it sought a solution which would permit it to perpetuate the yoke of neocolonialism on South Vietnam," she charged.

In a sharp reaction to Communist protests about American bombardments of North Vietnam, Porter said: "Another example of the complications you place in the path of negotiations concerns your protests against United States air and naval actions against military targets in North Vietnam."

"By making such protests, while passing over in silence your invasion of South Vietnam, you attempt to reject the consequences of what you yourselves have caused. This is unconvincing. The arsonist obtains no sympathy for his scorched fingers."

Porter said the North Vietnamese have never mentioned "the 12 divisions of regular North Vietnamese armed forces you sent south in hopes of imposing a military solution there."

## Executive Director Of Boys Club Is Announced

Graham Gutting, a teacher last year in the Pitt County Schools and a former Air Force captain, was introduced Wednesday afternoon to the Boys' Club of Greenville-Pitt County as the new executive director of the club.

Gutting replaces the late David Wilcox, who died in a boating accident at Whichard's Beach near Washington, N.C. on June 17. Raymond Williams, a counselor in the Greenville City Schools and long-time Program Director for the club, served as interim director until the appointment of Gutting this week.

Austin Britt, president of the Board of Directors of the Boys Club, welcomed Gutting aboard and presented him to members present at the late afternoon meeting.

A native of Shelbyville, Indiana, the young red-haired new executive director worked in Pitt County Schools last year as a teacher of boys in the seventh and eighth grade level in remedial programs.

The son of a career naval man, Gutting graduated from high school in Annapolis, Maryland and later served three years in

the Air Force, being discharged as a captain. Eighteen months of his service tour was spent based in the Phillipine Island, with duty stints in Korea, Thailand and Hawaii. While in the service, he was active in Boy Scout work, serving as Boy Scout Project Officer.

A graduate of Clemson University with a major in geology, Gutting engaged in archeology field work in efforts

to uncover foundations of Ft. Prince George near Clemson before the area was submerged as the result of a nuclear power plant constructed by the Duke Power Company.

He is married to the former Dinah Silvey of Texarkana, Arkansas. Gutting is an active Baptist, and takes part in Sunday School and choir activities.

"I think the Boys' Club has great potential for Greenville," Gutting remarked. "I hope it will be possible to expand the present program to serve an even larger number of boys who need this club."

Selection of Gutting to fill the vacancy was made by a Special Committee appointed to study applications for the position. The committee consisted of Dr. William Monroe, Larry Graham and Doyle Hayes.

Britt said he was grateful that someone of Gutting's qualifications and capability had been found by the committee to be the new director of the Boys Club. Britt also expressed appreciation on behalf of the boys and the board of directors to Raymond Williams for an outstanding job of filling in as interim director.

## Regional Conference Opened Door To Planning

RALEIGH (AP) — A series of regional conferences this month has opened the door for greater emphasis on planning and cooperation in North Carolina between local governments and the state.

The conferences, arranged by Gov. Bob Scott and the new Council on State Goals and Policy, were the first of their kind in North Carolina and afforded some 1,500 persons an opportunity to express their views on how the state should develop.

Scott, who called for long range development last year in promoting creation of the council, said the regional discussions "generated an enthusiasm for planning and, hopefully, a better understanding of what planning is all about and the need for it."

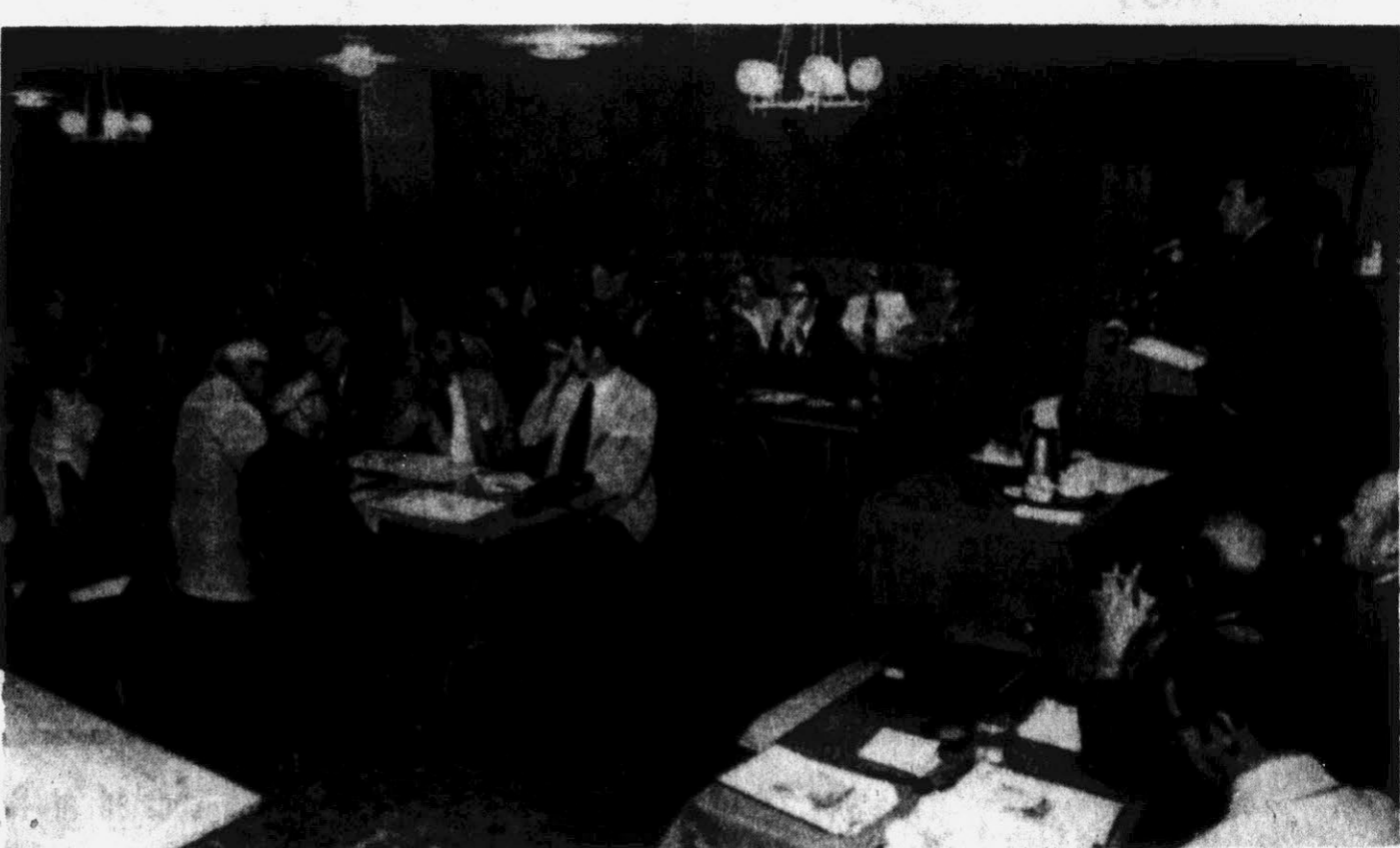
Scott has made coordinated planning a major theme of the final months of his administration. In April, he told the L. Q. C.

Lamar Society the states' "concern should not rest solely on a desire to head off urban problems, but rather on a positive commitment to provide every individual an opportunity to enjoy the fruits of an open and free society without being forced to migrate into a strange and hostile environment."

"I am convinced that the most realistic approach to rural development rests on programs to prepare people for new jobs and programs to provide job opportunities within rural areas where people are now living," Scott told the society at a meeting in Birmingham.

Interest in his theory was evident at the regional meetings in early August in Mooresville, Hendersonville, Williamston, Burlington and Warsaw.

Repeatedly local participants referred to the need for coordinated efforts to improve highways, to provide

1 teaspoon vanilla or 1 table-spoon brandy  
4 egg whites

In a small mixing bowl, combine marmalade and vanilla stirring until marmalade is softened.

In a medium mixing bowl, beat egg whites until soft peaks form. Add sugar gradually, beating until stiff peaks form. Fold in orange marmalade; spoon mixture into top of double boiler.

Cook over gently boiling water (water in bottom part should just touch top part of double boiler) 1 hour without lifting cover. At end of cooking time, lift top part of double boiler from bottom; remove cover and let stand about 10 minutes. Souffle will fall about 1 inch. Turn out of double-boiler top into serving dish. Surround with some of the Custard Sauce. At table, spoon into dessert dishes; pass extra sauce.

To serve cold: Make souffle ahead (may be made the night before). Turn warm souffle into serving dish. Cover and chill. Before serving, surround with some of the chilled Custard Sauce; pass extra sauce.

**CUSTARD SAUCE**

4 egg yolks

1/2 cup sugar  
1 1/2 teaspoons flour  
2 1/2 cups milk  
1 teaspoon vanilla

In a small mixing bowl beat together egg yolks and sugar until well mixed; stir in flour.

In a heavy 2-quart saucepan heat milk until bubbles appear around edge. Stirring vigorously, slowly add about 1/2 cup of the hot milk to the egg-yolk mixture, then stir warmed egg mixture into remaining milk.

Cook over very low heat, stirring constantly, until mixture

thickens enough to coat the back of a metal spoon. Remove from heat; stir in vanilla. Turn into a bowl; cover and chill.

Makes 2 1/2 cups. Note: Any leftover sauce may be served with baked apples, fresh orange sections and other desserts.

2 tablespoons butter  
½ cup chopped onion  
¼ teaspoon minced garlic  
1 pound ground lean beef  
3 tablespoons flour  
2 cups diced peeled tomatoes  
½ teaspoon sugar  
2 teaspoons salt  
2 teaspoons chili powder  
½ teaspoon pepper  
6 slices buttered white bread  
Cut kernels off corn cobs—makes about 2 cups. In a med-

dium saucepan melt butter; add onion and garlic and cook gently until softened. Add meat and crumble with a fork until it loses its red color. Stir in flour. Add corn, tomatoes and seasonings; stir and cook for 5 minutes. Turn into a buttered glass baking dish (10 by 6 by 2 inches). Top with overlapping slices of bread, buttered side up. Bake in a preheated 350-degree oven until bread is golden—25 minutes. Makes 4 to 5 servings.

It is remarkable, however; that in the course of the Democratic National Convention and in its aftermath, a rare (almost minuscule) minority surveys the scene with anything approaching an opinion that victory is possible in November if a large number of additional "ifs" work out in their assays.

# Changes Loom In Leadership

RALEIGH, N.C. — A leadership change of significant proportions seems to be brewing for the House in the 1973 General Assembly. The word in legislative circles is that Rep. Jim Ramsey of Person, identified with insurgents in recent sessions, is wrapping up the race for speaker. Ramsey supporters are saying that a canvass of Democratic nominees for the House gives him the edge over Rep. Dwight Quinn of Cabarrus for the post as presiding officer. The selection of Ramsey as speaker would bring to the

fore a group of younger lawmakers, restive with old ways of doing things and receptive to change in the legislative system. The 40-year-old Roxboro lawyer, running for his sixth House term, is confident but cautious in making claims. He's contacted Democratic candidates, including the 38 who didn't serve in '71, and he's encouraged by the response. "It looks real good at the present time," he said. If he wins, little Person County will have the top two leaders chosen by the legislature itself. Sen. Gordon Allen is in line as President Pro Tempore in the Senate. Ramsey already is making plans predicated on victory. He wants an early Democratic caucus, promptly after the general election, to initiate organization. He has in mind a session that will go about its business in an open and orderly fashion. Among innovations Ramsey aims to implement if he becomes speaker is open decision-making on money matters. In the past, who gets what in the state budget has been worked out behind the closed doors of an appropriations subcommittee. "The time has come for us, as trustees and stewards of the state's money, to let the public see what goes on at each stage of the process," he argued. That will assure greater public confidence in the final result and put an end to pork barrel legislation, he said. Secrecy has cloaked the rationale for spending decisions and permitted vote trading for pet projects. Open doors will let the public

participate in the debate. Ramsey suggested, and guide legislators towards a sound budget. Money Big Issue Money will be the big issue in '73. Ramsey predicted. Both candidates for governor have taken a stand against new taxes. Requests will far exceed available revenue from the present tax structure. Money will be tight, and the fight keen for a share of it. Hard scrutiny should be given the "A" budget for continuation of present state programs, Ramsey advocated. It may be funds can be found for new purposes through reductions in established programs, he said. Democratic House candidates will get a preview of problems they will grapple with at a Sept. 22-23 briefing in Raleigh. Key state officials will sum up pending issues as they affect their agencies. Undoubtedly, the gathering also will be an occasion for politicking and nose-counting in the speakership race. November Caucus Advocated Ramsey favors a departure from custom for an early decision in the contest. The Democratic caucus to organize the House has been held on the eve of convening the legislature. He wants it moved up to Nov. 17, ten days after the general election. Traditionally, the caucus is called by the senior Democratic House member. That would give the ball to Quinn, a veteran seeking his 12th term. There's nothing sacred about the tradition, Ramsey observed. If a majority of the Democratic members came together, that would be the caucus. Ramsey said committee appointments, if he is speaker, will be ready the first week of the session. Who will get plum chairmanships, he added, isn't known even to himself at this point. He plans a calendar committee, charged with setting priorities for floor action. That will space out major bills and give order to the flow of legislation, he explained. Implementing change depends on the will of the House, Ramsey noted. "These are my personal ideas. It will take the support of the majority to adopt them," he said. Standing committees, continuity in the speakership, and annual sessions are further changes in the legislative structure in time, Ramsey said. While he looks with favor on them as future prospects, he said, they must come through an evolving process.

We wonder if these surveyors have projected their views to the GOP National Convention. If they did, it must be pretty dismaying, too. For one thing, there is almost nothing in sight to promise an entertaining evening before a television screen; and only humdrum headlines in the newspapers. There is no contest between factions or candidates. There is no suspense. There is a prospect of speeches echoing the same themes of the past two years. What has the GOP convention (and all of watching and waiting America) got to look forward to? Not one blessed thing. It promises to be one of the duller political shows in memory of the living and some of the dead. There will be another gathering in Miami Beach, however, that may help fill those long hours...possibly occupying more headlines and television time than the Republican convention. That would be the promised simultaneous gathering of Yuppies, Zippies and demonstrators of all shades and persuasions. That just might save the day. If they live up to their unspoken promises, surviving Republican veterans will look back in years to come...greeting one another with cries of "Remember Miami Beach in '72". It just could be the salvation of August's Dream in Dullsville.

# Walker-Hunt Guerrilla War

RALEIGH — The race for lieutenant governor, which didn't look like much of an affair two months ago, is beginning to shape up as a guerrilla war. Johnny Walker, the Republican from North Wilkesboro, is the reason for the different picture. By turning down Jim Hunt's proposal to limit campaign spending to \$50,000, Walker has let it be known that he plans to wage a time-consuming, costly campaign. Walker says the Democratic Party has been entrenched in North Carolina for about 70 or 80 years and he needs to spend more money than Hunt just to come out even. "I don't think that makes any sense," Hunt said, when asked to comment on Walker's refusal to accept the \$50,000 spending limit. "I have no natural advantage just because I'm a Democrat. People don't vote for a candidate merely because he's a Democrat or Republican or American Party candidate. They have too much sense for that. They're going to vote for the candidate who can do the best job." Hunt says that \$50,000 for lieutenant governor race is enough for the candidates to get their message across. Hunt says he feels the candidates should have to go out and talk to the people and see what they're saying. It's not enough, he contends, for the candidates to send their message via the costly medium of television. "If I'm the presiding of-

ficer of the Senate in the 1973 legislature," Hunt said, "I'm going to push for reasonable spending limits for campaigns." Walker isn't exactly torn to pieces by Hunt's statement. He's going out to meet the people—"the factory workers, the filling station operator"—on this week's walking tour of North Carolina. And he says because of the disadvantage the Republicans face in North Carolina in voter registration and other things, it might be fair for Hunt to spend \$50,000 during the campaign while Walker spends in the neighborhood of \$250,000. To my untrained eye, it would appear that Walker is the first candidate in North Carolina to start using television for the fall campaign. He has used a commercial trying to link Hunt with Democratic presidential nominee George McGovern and McGovern's platform. "The people aren't going to go for that," Hunt replies. "I'm not running for President. I'm running for lieutenant governor. I'm talking about state issues. I'm staying out of the national picture and will run my own campaign." If you'll recall, Walker cozied up to Jim Gardner during the Republican primary last spring. He said a poll of his indicated that the strongest Republican ticket in the fall would consist of President Nixon, Jim Gardner, and Johnny Walker. Well, Nixon and Walker

# The Key To Watergate?

SCRABBLE, Va. — We had as our guest one night last week a gentleman, now retired, who had spent his life in intelligence work. The after-dinner conversation turned to the Watergate Caper. Our guest had a few speculations to offer. I pass them along. By way of background:

This bizarre affair broke into the news in the early hours of June 17, when five men were caught red-handed in the offices of the Democratic National Committee, located in the plush Watergate apartment complex in Washington. Their mission, by every indication, was political espionage.

Four of the five men had backgrounds in Miami, where they were identified with the Free Cuba, anti-Castro movement. The fifth was a former CIA employee, James W. McCord Jr., now a private consultant on security procedures. When it transpired that McCord numbered among his clients both the Committee for the Re-election of the President and the Republican National Committee, the affair became the talk of our town. And much later, when the story broke that a \$25,000 cashier's check, payable to the Nixon committee, had found its way to the bank account of one of the four Miami suspects, the Watergate Caper turned into a political time bomb. "I am out of the game," said our guest. "I know nothing more than I have read in the papers. My own assignments never involved Cuba, but my guess, all the same, is that the key to the Watergate incident is not in Miami or in Washington, but in Havana."

We were sitting out on the deck, listening to the night noises — an owl, a whippoorwill, a pack of hounds on the trail of a fox. A soft breeze rippled the smoke of our guest's cigar. "Suppose," he said, "just to be supposing, that the Castro government is keenly interested in normalizing relations with the United States. It would make sense to suppose that if the United States could reverse its policy toward China, the U.S. could reverse its policy toward Cuba. "But not under Nixon. The President, if I am not mistaken, remains absolutely frosty toward Castro. He has made not the slightest gesture toward a Cuban rapprochement, but Havana might well suppose that the Democrats, if they could put

# Changes In America's Business

NEW YORK (AP) — When a store is being altered and is framed in scaffolding, it isn't uncommon to see a brightly painted sign announcing "Business as usual."

Business can't go on as usual of course, but no enterprising businessman admits that. He believes that a growing business accepts the challenges and turns them to advantage. It adjusts.

On an immensely larger scale, it may be said that something of the same is occurring in the American business environment today. It is being altered. The rules are changing. The scaffolding is up—but so is the sign. The most obvious change is in the rules for pricing. Not long ago this was largely a private matter, a decision the company made in its own interests, for its own good. No longer. As has been demonstrated by an unacceptably high rate of inflation, price is public.

Today's huge corporations, if left to follow the old rule, are fully capable of challenging a governmental anti-inflation program. Recognition of this has been made official through various government bodies, particularly the Price Commission. But the change is even greater. Presidential power also is being used to intervene directly. Pricing therefore has become political too, as General Motors, Chrysler, Ford and American Motors understand fully. If the President doesn't want a price increase you must consider the consequences of challenging him.

If you sit on the board of directors you feel a few splinters. You might, in fact, find it so uncomfortable as to quit, but if you don't you at least study the issues before you sign anything. And you have a big liability insurance policy too, because the stockholders might sue you. As a director, and therefore as an insider, you may find yourself in a dilemma when it

comes to trading the company's stock. Once it was easier to look after your interests; at the hint of bad news you dumped your shares.

You have to watch that sort of thing today. Investigations into the trading activities of the Penn Central before its collapse have put the heat on the use of inside information for personal financial advantage.

In Wall Street, the clamp-down on some of the more bizarre, scandalous, free-wheeling practices has thrown a lot of brokerage houses out of business, and those that remain now must run their affairs like businesses instead of games. In manufacturing, some companies still haven't adjusted to the notion that they are responsible for the safety of their products, but this concept is firmly part of the new environment, as the automakers are learning. Business knows also that a company's obligation isn't solely to make money for its stockholders. In the new

environment, it must avoid polluting, promote race and sex equality, be a good citizen.

All this, it is said, is for the public good. And while some companies insist it is anything but that, others have embraced the public good thesis in circumstances that differ from any of those mentioned before.

These companies, accustomed to taking not only product orders but instructions from Washington, seem increasingly to feel that they should also rely on Washington to bail them out financially. For the sake of national security, jobs, investors—for the public good, that is.

Most companies, however, appear to be adjusting nicely, if you can judge from the financial statements being issued and, in general, you can, notwithstanding loose accounting practices soon to be tightened. There's scaffolding all around, yes, but that sign is hanging too.

Chief of Police Glenn Cannon said today that local police officers will continue to enforce a Greenville City Code prohibiting crowds or assemblages of persons blocking streets or sidewalks in the city.

Local officers, whom Cannon said attempt to enforce all city

and state laws in an impartial manner, were criticized by local citizens at the City Council meeting last week for arresting a number of persons in the downtown area over the past several weeks.

Cannon emphasized that persons found violating that ordinance or any other law might fall prey to local officers who are charged with enforcing laws made by the Greenville City Council and the North Carolina General Assembly.

Citing the law under which several persons have been charged recently the chief said the code provides that "all crowds or assemblages of persons who shall congregate on the streets or sidewalks of the city, obstructing traffic to the inconvenience of vehicle drivers or pedestrians, shall be dispersed by Police. their man in the White House, would take a more flexible view.

"So let us suppose, to be supposing, that a decision is made in Havana, at the highest levels of the Castro government, secretly to feel out the Democrats on this score. This is maybe early March. The idea is to send an emissary to the Democratic National Committee, rather than to any one of the candidates, with a nice proposition: If the party would take a sympathetic view toward normalizing relations with Cuba, well, Cuba would take a sympathetic view of the Democrats' urgent need for campaign contributions. The proposition might not be put so bluntly, but the offer would be unmistakable: Money. Big money."

He paused for a moment, intent on the hounds giving chase.

"Now suppose, he went on, "to be supposing, that the Free Cuba people in Miami get wind of the thing. We have to assume they maintain an excellent intelligence apparatus in Havana. Eventually they find out who the emissary will be—probably a Washington or New York lawyer who could visit the committee offices without raising the least alarm. In time they learn when he's coming—say, on June 19. But early on, they begin to think in terms of a deal of their own."

A talks to B, and B talks to C, and C is captivated. He sees glorious visions of a headline in The Evening Star: 'Communist Dollars Back Democratic Campaign.' Then C sends a cryptic note up the line through the Nixon committee. For \$25,000, he hints, we might buy something worth a million. Trust me, he says. The top people—John Mitchell and Maurice Stans—never are told anything. The romantics down below are kept almost as much in the dark. But the money changes hands in last April and the waiting time begins. It ends on June 17."

By obtaining a count of his opponents' distribution, South was able to set up the profitable end position which assured the success of his slam contract.

South opened the bidding with one spade, West overcalled with two clubs and North jumped to three spades since he held the required 13 points in support. East competed by bidding four clubs and now South made a mild slam try by showing the ace of diamonds. When North cooperated by indicating possession of the heart ace, South cue bid in clubs and North's call of five diamonds showed second round control of that suit. This was all South needed to hear and he proceeded without further ado to six spades.

West opened the king of clubs which declarer ruffed with the deuce of spades. The ace of spades was played; then the five was led to dummy's ten as West fol-

lowed suit for the second time and East showed out, discarding a club. The king of diamonds was cashed, followed by a small diamond to the ace and a third round was ruffed in dummy, on which East's queen appeared.

The closed hand was reentered by ruffing out dummy's remaining club and the jack of diamonds was led. West followed with the ten and the three of hearts was discarded by North as East stuffed a club. South now had a count of West's hand. The latter was presumed to have a six card suit for his vulnerable overcall. He was known to have started with four diamonds and two spades. This would leave him with, at most, only one heart. This meant that declarer could safely lead that suit and duck it into either defender's hand with the assurance of a profitable return.

The deuce of hearts was led and when West followed suit with the jack, the eight was played from dummy. East could not overtake the jack without establishing North's queen, so he allowed his partner to hold the trick. West was obliged to return a club on which dummy discarded the queen of hearts as South ruffed with the king of spades. North's hand, consisting of trumps and the ace of hearts, was now high. Declarer lost only one heart trick on the deal.

If West had played a small heart when that suit was led, dummy would still have played the eight, for if East overtakes with a spot card, he has a choice of either leading into the ace-queen of hearts, or else presenting South with the same ruff and discard that his partner was forced to give.

# Soil Samplings Taken At Site Of Proposed Institute Building

Soil samplings on property located at the southeast quadrant of First and Reade Streets were taken this week. This drilling for soil samples marks one more step in plans to construct a building on the site for East Carolina University's Regional Development Institute.

Thomas W. Willis, director of the institute, said that it would be at least seven to eight months before possible construction on the building would get underway.

Tom Grogg of Raleigh and Albert Strawbridge of Columbus, both with the Law Engineering Testing Company of Raleigh, were on the site Tuesday with drilling equipment to set soil samples.

"We're taken four samples from the area where the main building will be located and two from the site of the parking lot," Grogg stated.

Strawbridge pointed out that to procure samples "we drill 30 feet down with drills that cut a seven and one-half inch hole."

The two men were carefully removing compact rolls of yellowish clay streaked with traces of red from the core of the drills, cutting them into sections which they then placed in jars and labelled with information to be used by soil analysts.

"Law is the third largest engineer testing company in the country," Grogg commented. He noted he had been in this work for a number of years. "I worked in North Africa for six years from 1961 to 1967," he commented, "mostly in Tunisia and Liberia." He agreed that the heat and humidity in Liberia was even higher than that of Greenville.

Strawbridge has been with the firm for the past year.

# N.Y. Mayor Says Mobs Are To Be 'Chased Out'

NEW YORK (AP) — Amid the lingering echo of misaimed gangland guns that killed two innocent bystanders by mistake, New York's 30,000-member police force was under mandate from Mayor John V. Lindsay today to "run the mobsters out of town."

"Get out and stay out!" was the message the mayor ordered police brass to relay to the city's five shadowy Cosa Nostra families, ranging in size up to

possibly 1,000 members.

The "hit" parade that began 14 months ago with the shooting of crime chieftain Joseph Colombo had already claimed 15 lives within the underworld, before it spilled into the city's mainstream last Friday with misdirected bullets fired in a little East Side restaurant.

"The recent murder of innocent citizens, allegedly the result of mistaken identity by gangland executioners, is an outrage which demands that the mob must be stopped and the gangsters run out of town," Lindsay declared in a statement Wednesday.

Manhattan Dist. Atty. Frank S. Hogan already has an-

nounced a wholesale subpoenaing of members of New York's five crime families, for a grand jury convening next week to look into the mistake slaying of two businessmen at the Neapolitan Noodle restaurant.

Lindsay gave no details on how he expected the police to chase the mob out of the city.

The present gang warfare has been attributed to various factors — a showdown over territory or rackets, pressure for or against the mob's re-entry into the lucrative field of narcotics, an influx of hot-blooded young buttonmen who are tired of waiting for the elderly dons of the Mafia to die or step

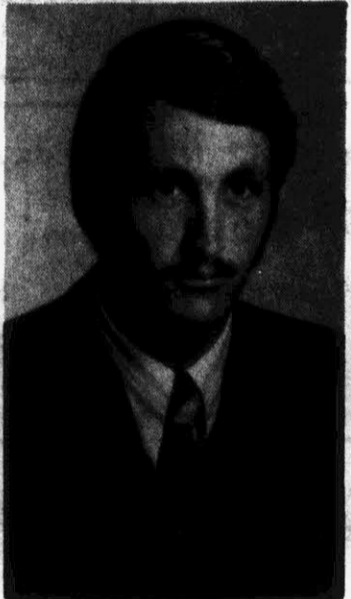

## Stargell Erases Damage By Davis

For 26 innings, the Los Angeles Dodgers were giving people the willies. They got some of their own medicine back Wednesday night. Willie Stargell erased earlier damage done by Los Angeles Willie Davis with a two-run homer in the ninth inning to give the Pittsburgh Pirates a dramatic 3-2 victory.

Davis, who had won two previous games with homers, put the Dodgers into a 2-0 lead with a two-run double in the second inning. It lasted until the final frame, when the Pirates scored three times to beat Don Sutton. Stargell's wallop followed a run-scoring single by Al Oliver and marked the 18th time this season that the Pirates have won games in the ninth inning. The National League's East leaders, who boosted their lead to 10 games over the New York Mets, have also come from behind to win 33 times this year.

In the other National League games, the Cincinnati Reds ripped the Philadelphia Phillies 8-2; the Houston Astros trimmed the Montreal Expos 5-0; the San Francisco Giants smashed the Chicago Cubs 14-9; the Atlanta Braves topped the New York Mets 3-1 and the St. Louis Cardinals beat the San Diego Padres 6-4.

American League scores: Chicago 8, Milwaukee 6; Kansas City 3, New York 2; Oakland 4, Baltimore 3; California 2, Cleveland 1 and Texas 9, Boston 8 in 10 innings. Rain postponed Minnesota at Detroit. Sutton was pitching a four-hitter for Los Angeles through eight innings before Pittsburgh rallied in the ninth. Dave Cash led off with a double, took third on a balk by Sutton, and scored on Oliver's single. Stargell then produced.

Tony Perez knocked in four runs, two with a homer, to pace a 13-hit attack that powered

Cincinnati past hapless Philadelphia. The loser was Ken Reynolds, who dropped his 10th game without a victory this year.

"I think he lost his composure," said Philadelphia Manager Paul Owens of Reynolds, who failed to last the first inning. "I don't know what else you'd call it. He was throwing all over the place."

Bob Watson and John Edwards each drove in two runs and Don Wilson spun a five-hit leadoff homer over Montreal. The Astros took the lead with two runs in the fourth on a single by Watson and Edwards' sacrifice fly.

Houston scored three more times in the sixth, helped by three Montreal errors. Watson drove in one run with a squeeze bunt, his third hit of the game. Edwards drove in another with a base hit and Doug Rader singled home the final run of the inning.

San Francisco crushed Chicago with a 20-hit offense, including four by Ken Henderson and three by Tito Fuentes and Dave Rader. Henderson drove in five runs with his hits, one of them a three-run homer, and Fuentes knocked in four.

The Cubs had 15 hits, including a homer by Jose Cardenal in the seventh when they scored five runs.

Dusty Baker singled home the tie-breaking run in a two-run sixth inning and Hank Aaron blasted the 664th home run of his career to help Atlanta defeat New York. The home run put Aaron an even 50 in back of Babe Ruth's career record 714. Luis Melendez hit a two-run homer in the second inning and Ted Sizemore singled home what proved to be the winning run in the sixth that gave Bob Gibson and St. Louis a triumph over San Diego.

Nate Colbert belted his 33rd home run—tops in the majors this year—for the losers.

## Wood Shakily Captures 21st

"I'm not looking at records," says Chicago's amazing Wilbur Wood. "I'm still a relief pitcher at heart, pitching one batter, rather than one game, at a time."

That's the approach to the game of baseball—or rather the artistry of pitching—by the 30-year-old knuckleballer, a refugee from the bullpen, the winningest hurler in the major leagues this season.

Wednesday's performance was hardly one of his more successful efforts of the year. He was clipped for 10 hits and five runs by Milwaukee and departed after only 6 1-3 innings.

But he'd hung around long enough to record his 21st victory—and that was good enough for Chicago Manager Chuck Tanner, who said: "I got no complaints. Woody won the game."

The White Sox' 8-6 triumph over the Brewers, coupled with Oakland's 4-3 victory over Baltimore Wednesday night, enabled the White Sox to remain within a game of the front-running A's in the American League's tight West Division race.

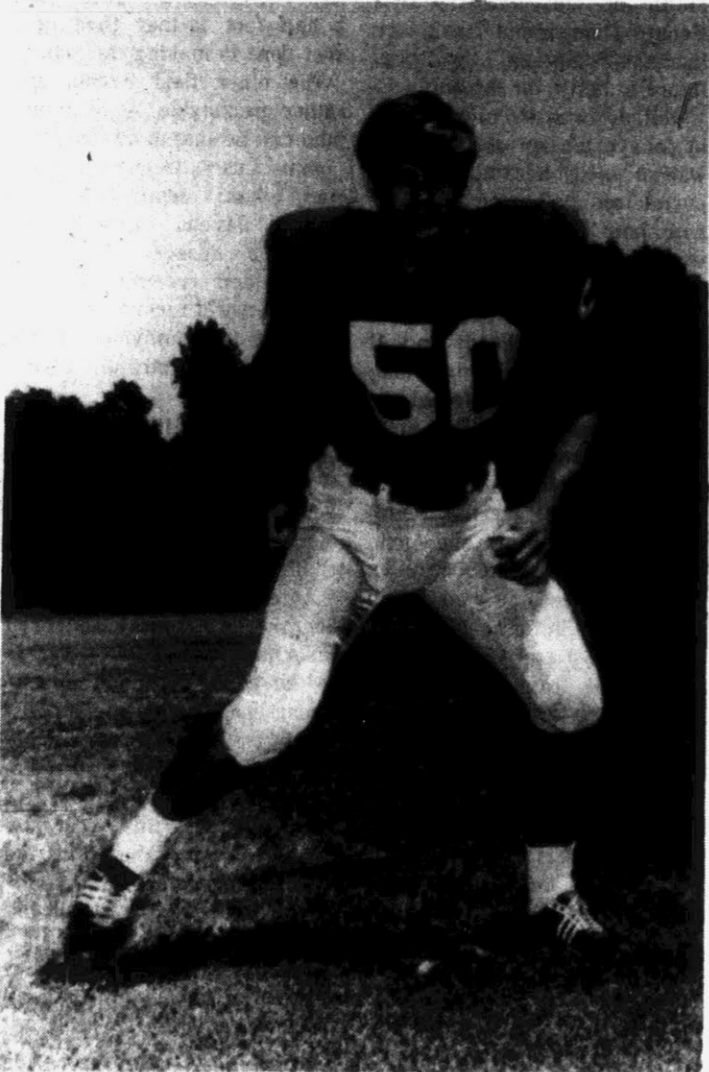
Elsewhere in the American League, Kansas City defeated the New York Yankees 3-2, California edged Cleveland 2-1 and Texas topped Boston 9-8 in 10 innings. Minnesota's game at Detroit was rained out.

In the National League, San Francisco outlasted the Chicago Cubs 14-9, Cincinnati clubbed Philadelphia 8-2, Houston blanked Montreal 5-0, Atlanta turned back the New York Mets 3-1, St. Louis beat San Diego 6-4 and Pittsburgh clipped Los Angeles 3-2.

## Davidson's Dave Fagg Doesn't Like To Lose; Wildcats Are Thin

Dave Fagg of Davidson tags himself as the "World's Worst Loser." He hates it, but at Davidson, he's trying to get used to it.

"We're trying to play with the big guys," he said. "This business of winning is about to kill me. The problems of money and other factors put a lot of pressure on us. We keep trying to figure out ways of winning short of cheating."

This year, the Wildcats, coming off a 1-9 season, will try to relieve some of Fagg's frustrations.

"We're going to have to be tough on defense," he said. "We have to make the big play of defense and we have to do a better job of turning over the ball to our offense. And we have to win with our toe. Nearly every game we lost last year, it was because of our kicking game, one way or the other. And we've got to have a little bit of luck."

Fagg says that Davidson must approach the game with a plan to spread out its offense, and therefore spread out its opponents' defenses. "We need to take an 11-on-11 situation and make it a 1-on-1. If we can do this, we'll be able to create a lot of scoring for us. We'll be able to make things happen. But we can't

gang up for a real battle."

On defense, Fagg wants to keep his opponents in front of him. "We want to keep them from getting off the big play. If their biggest play is only 15 yards, they can't hurt us too much," he said.

In the kicking game, Fagg wants more kickoff and punt returns carried back by his Wildcats for scores. "We've got to block some punts too, and cover our kicks better," he added.

Among the 48 players Fagg expects to have on hand when practice begins, there will be just 10 seniors. "We're not rebuilding," he said. "We're just looking to September 9 for our first game. We're trying to win this year, but we are thin and we have some young guys playing. We have 10 or 11 starters back with some 23 lettermen."

The coach feels that he has some good experience and some fine talent, but that it doesn't run very deep. "We've got some people who've been under the gun for three years now. We have some skill and some fine athletes. If we can put the 22 guys on the field we want on the field, I think we can make it an interesting game. We can't afford to get people hurt during the preseason drills."

Scotty Shipp, Davidson's quarterback, could be

All-Conference, according to Fagg. "He's a fine T quarterback. But he's got to complete more passes. We're shooting for a 68 percentage. He could also be our punter."

Fagg feels the receivers, Andy David, Walt Walker and Mike Harding could be outstanding.

"Our backs are not big, but they're fairly quick," Fagg said. He lists Dave Ingold and John Webel as the top tailback candidates, with Alton McCallum as the fullback.

Defensively, Woody Montgomery at linebacker and Mike Sikes at end provide experience.

Hardison, from Williamston is listed by Fagg as a dream player. "He's one of our tremendous athletes," the coach said. "He has to rank with some of Davidson's all time great defensive players. Playing at linebacker and defensive end has been a real test of his ability, but he loves to play and he fights you hard. He's played with a couple of injuries, too. He's also a serious student—the type player you really dream about—a super guy."

Some of the newer personnel who bear watching on

the Davidson team are George Weicker, a linebacker; Eddie Womack, a defensive halfback; David Harper, a quarterback; Bill Smith, an offensive tackle, and Gary Pomeroy, a flanker.

Fagg also looks to the incoming freshman class to provide him with additional depth. "We've got to have it or else we've got to all right."

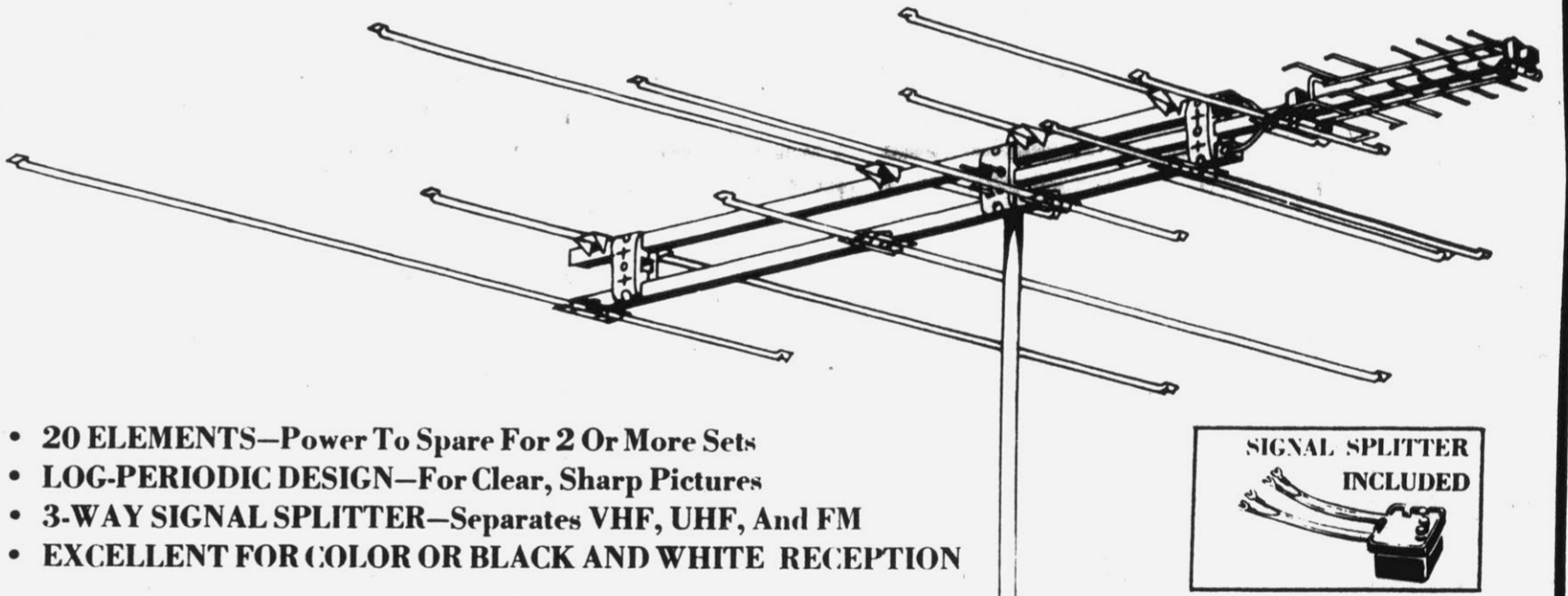

# Brundage Not Backing Down

MUNICH, Germany (AP) — Avery Brundage preparing to step down as president of the International Olympic Committee, acted like a man who welcomed the chance to bow out fighting.

Still athletic looking at 84 years of age, Brundage was in a jovial mood as he talked to a small group of reporters Wednesday about what will likely be his final—and one of the toughest—fights of his 20 years in office.

His opponent this time is not professionalism or commercialism, but politics—in the form of a burgeoning black African movement to boycott the Munich Olympic Games because of participation by athletes from the breakaway British colony of Rhodesia.

"We cannot tolerate political interference," Brundage said after putting the boycotters on notice that their national Olympic committees stand to be dropped from the IOC and their athletic teams disqualified from future Olympic competition.

"This is one of the most serious issues yet," he said. "Naturally, the people who furnish the money want to take charge. But we can and will resist this with the help of local people. We've done it before successfully."

He admitted that he was "worried and concerned who my successor will be. We are at a crucial point of the Olympic movement. Just look at this political interference."

Ten days before the start of the Games, seven African states had served notice that their teams would not participate if the Rhodesians did.

Brundage insists the Rhodesians will remain since they are adhering to conditions the Africans themselves prescribed last year. These included marching under the old colonial flag with the Union Jack, accepting the designation of southern Rhodesia and observing "God Save the Queen" as Rhodesia's national anthem.

Brundage's successor is expected to be elected during the pre-Olympics IOC meeting here. The plenary session opens on Aug. 21.

Two leading prospects for the post are IOC Vice Presidents Lord Killanin of Ireland and Count Jean De Beaumont of France.

Looking back on his 20-year reign, Brundage said, "I don't

regret having taken the job, exhausting as it sometimes was. I don't regret it at all. I do believe that the Olympic movement is the greatest social force in the world. I had a lot of work, some grief but also much happiness. The Olympics are something worth working—and living—for."

# Young Players Have To Mature For Browns

CLEVELAND (AP) — Nick Skorich talks about his Cleveland Browns making a run at the Super Bowl, but—on paper—it appears the team is on the brink of disaster.

For Skorich to succeed, he'll have to have young players solve major problems at quarterback, on the lines, in line-backing and the secondary.

Skorich has avoided the quarterback problem the past two years because Bill Nelsen and his crippling knees have survived. Even if Nelsen can complete another campaign, it is doubtful he can lead the team to a repeat title in the Central Division of the American Football Conference (AFC).

Nelsen's unquestionable game knowledge is equalized by the facts he cannot run more than a few feet and cannot throw long passes consistently.

Pressure on Nelsen was increased last year by failure of the offensive line to block well enough to establish a good running game, despite the presence of still-brilliant halfback Leroy Kelly and fullback Bo Scott.

Skorich wants Mike Phipps, the former Purdue University star, to take over as field general, but Phipps failed to win the job last year and may not prove ready this season.

Phipps could change the entire offensive image if he could win the job because he could deliver the long passes to such receivers as Fair Hooker and Frank Pitts and could run from rushing defenders. He has good pass-catching tight ends in Mill Morin and Chip Glass.

Even if Phipps can do the job, that leaves the problem of line blocking, which Skorich blamed last year on new formations and two new tackles.

Rookie Doug Dieken started at one tackle and second-year

MUNICH, Germany (AP) — Bob Seagren, who won't be able to use the pole with which he vaulted to a world record, and shot putter Brian Oldfield, who smokes to relieve tension, underscore a mixture of youth and experience for the United States in the Olympic field events.

Seagren's Cata-Pole, with which he set a world record of 18 feet, 5½ inches a month ago, has been banned from the summer Games because it wasn't available to the rest of the world long enough. Olympic officials say Seagren would have an unfair advantage.

Even so, using the older poles made by the same firm, the former University of Southern California star had shared the

world mark at 18-4¼ with Kjell Isaksson of Sweden. These two, along with Americans Steve Smith and Jan Johnson, Italy's Renato Dionisi and East Germany's Wolfgang Nordwing, figure to battle for the gold.

Oldfield, who says he smokes to relieve tension on the field, warms up by heaving the 16-pound iron ball over his head with both hands. He also admits he drinks when the day is done.

The other two U.S. shot putters are George Woods and Al Feuerbach. World record holder Randy Matson failed to make the team.

Art Walker, the first of America's great international triple jumpers, joins teammates Dave Smith and John Craft to give this country its first top threesome ever at an Olympics. Smith's American mark of 56-0 and Craft's wind-aided 56-2 make them top threats for the gold.

But Walker, 31, is still around and many feels his international experience puts him a mental step ahead of the other two. His best is 55-1.

The world long jump record of 29 feet 2¼ inches may not be approached in quite some time, but the three Americans here have shown they are ready to take on the world's best.

Arnie Robinson has done 26-8¼, young Randy Williams 27-4¼, with an aiding wind and newcomer Preston Carrington

26-4. Carrington, the Wichita State kid who surprised the experts by beating out favored Henry Hines for the team, went a half foot farther than he's ever done in making the team.

The other field events are rather predictable. At least one man can be said to be favored.

Janis Lusis, 33-year-old Russian, has dominated the World's Javelin throwers for nearly a decade. He's still around and recently became the new world record holder at 307-9. He is the obvious choice to win a second straight Olympic gold medal.

Hungary's Miklos Nemeth and West Germany's Klaus Wolfermann, as well as Finland's 1-2 punch of Jorma Kinunen and Hannu Sitonen, could challenge.

America's trio of Bill Schmidt, Milt Sponsky and Fred Luke have made rapid progress in the event but don't appear strong enough for a medal.

Jay Silvester, America's world record holder in the discus, had his global standard of 224-5 equalled this year by Ricky Bruch, the massive Swede who might be the favorite to win the gold medal in the event this year.

Bruch has beaten Silvester in a series of pre-Olympic tuneup meets to gain the mental advantage.

America's Tim Vollmer may be ready to catch the two napping and old-time Ludvik Dan-

ek of Czechoslovakia, the former world record holder, has shown good form, too.

Anatoly Bondarchuk of Russia is the dominant force in the hammer throw this year with his mark of 248-6½, about two feet off the world record held by West Germany's Walter Schmidt. The psychological and hometown advantage go to Schmidt.

Tom Gage, Al Schoterman and George Frenn compete for the United States. Frenn and Schoterman have surpassed 231 feet but no farther.

Young Dwight Stones, the youngest men's Olympic track competitor, says he can win the high jump. He's in the best shape of his life and the flopper from UCLA has improved his lifetime best five times this year to 7-3.

His teammates, Ron Jourdan and Chris Dunn, have also achieved 7-3 but may find that mark not enough at Munich.

Russia's Juri Tarmak, 7-4¼, and Russia's Kestutis Sapka, 7-4¼, are favored with Stefan Junge, 7-3¼, of East Germany making the competition formidable. It might take 7-1 just to qualify for the finals.

Jeff Bannister and Jeff Bennett, the tall and the short of the U.S. hopes in the decathlon, face Russia's Nikolay Avilov and Joachim Kirst of East Germany as well as a half dozen other men in the two-day test.

Bannister, 6-3, and Bennett, 5-8, have surpassed 8,000 points this year and both run the final event—the 1,500-meter run—very well, meaning that if they are close with one event left, anything can happen.

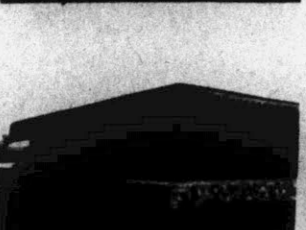
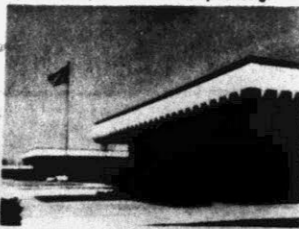

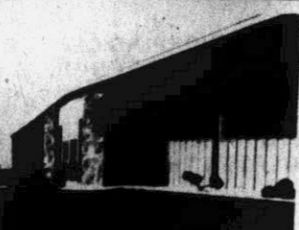

## Specialists In Anatomy Join ECU Med School

Two new faculty members have been appointed to the East Carolina University School of Medicine's anatomy department.

Dr. Evelyn McNeill, a native of Sanford, and Dr. Jack E. Brinn, a native of Hertford, joined the medical school faculty in July. Both will hold the rank of assistant professor, according to Dr. Michael Schweisthal, chairman of anatomy at ECU.

Dr. McNeill, who will also be associate professor of physical therapy in the ECU School of Allied Health and Social Professions, has degrees from UNC-Chapel Hill, Duke University and the Medical College of Virginia. She was certified in physical therapy by the Medical Field Service School, Fort Sam Houston, Texas.

Her doctoral study in the

human nervous system was supported by a traineeship from the American Physical Therapy Association. She is also the recipient of the Osterud Award in Anatomy, given by the Medical College of Virginia to medical, dental or graduate students for outstanding work in anatomy.

Dr. Brinn, who holds degrees from ECU and the University of Wyoming, recently completed a two-year postdoctoral study in mechanisms of hormone action at Pennsylvania State University's Hershey Medical Center.

His research in the relation of mechanisms of hormone action to the endocrine function of the pancreas was supported by the National Institutes of Health and has been reported by various national journals.

During his years of study, Dr.

Brinn was the recipient of a number of traineeships and teaching and research assistantships.

## GOP Policymakers See Possible Minority Report Over Platform

MIAMI BEACH, Fla. (AP) — Republican policymakers started drafting a platform today, and the possibility emerged of at least a minority report urging the legalization of abortion.

Such a position is contrary to the expressed views of President Nixon, and his positions are expected to prevail on abortion as well as other issues at the Republican National Convention opening Monday. But the abortion question could reach the convention floor.

The Platform Committee scheduled a final round of witnesses before going later in the day into closed drafting sessions that will last through the weekend.

The proposed GOP abortion plank is similar to one rejected in a long fight at the Democratic party's national convention here last month. It says in effect that decisions on abortion should be left to each woman's conscience.

Few had expected an abortion proposal to make headway at GOP platform hearings. But a platform subcommittee of 11 women and 4 men listened attentively and discussed with ap-

parent sympathy late Wednesday a plea by Jill Ruckelshaus, the wife of a top Nixon appointee.

Speaking for the National Women's Political Caucus, Mrs. Ruckelshaus appealed for "a strong and sensitive women's plank." She is the wife of William D. Ruckelshaus, administrator of the Environmental Protection Agency.

A male member of the subcommittee, who asked not to be quoted by name, said he would not be surprised if the subcommittee did not turn out at least a minority report endorsing the women's plank.

It would call for the outlawing of discrimination against women in obtaining credit, mortgages, loans, leases and in starting businesses. It also would ask for a broad child care program for working mothers, ratification of the Equal Rights Amendment to the Constitution, and "repeal of the laws that restrict the right of every woman to determine her own reproductive life."

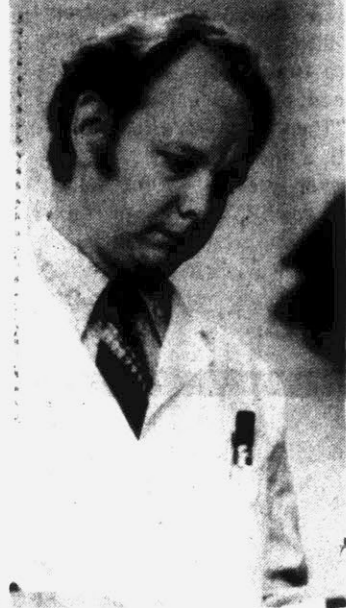
Rep. John J. Rhodes of Arizona, chairman of the convention's 108-member Platform Committee, said he hoped to

have a first section of the draft platform, covering military and foreign affairs, ready for release Monday and the rest of the document issued in two installments Saturday and Sunday.

One group which got a minority report to the floor at the Democratic convention, the Na-

tional Coalition of Gay Organizations, seemed unlikely to get as far with the Republicans.

A spokesman testified Wednesday in support of the repeal of laws and discriminatory regulations based on sexual orientation. The identical plank was turned down finally by the Democratic convention.

## Tobacco Loan Plan Seen By Holshouser

WASHINGTON (AP) — An announcement of a low-interest loan program for flue-cured tobacco is expected from the U.S. Department of Agriculture shortly, says Jim Holshouser, Republican candidate for governor of North Carolina.

In Burlington council member Samuel DuBois Cook said, that, "Obviously, each governor is going to have his own narrow interest. But the long range affairs of state can be guided to some degree by a council's recommendations."

Cook said that, during the conference, "sensed a current, a tone, a feeling of individual responsibility for helping to bring about the good life for every citizen of North Carolina."

Cook is a professor of political science at Duke University.

The council will make its first recommendations in November, two months prior to the start of the 1973 General Assembly.

A tentative statewide plan was developed earlier by the council and the Planning Division of the state Department of Administration. Details of that plan, which was explained at each of the regional conferences, will be altered as required to include suggestions produced by the August meetings.

Scott said that "everyone attending the conferences felt like the planning effort must be something more than that

which was done by the State Planning Division and that which would be done by the Council on State Goals and Policy."

"There must be involvement on the local and regional planning level, to create a local state partnership," he said.

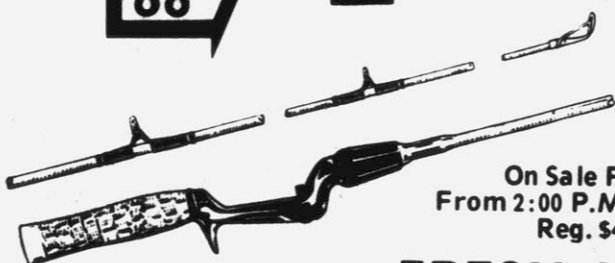

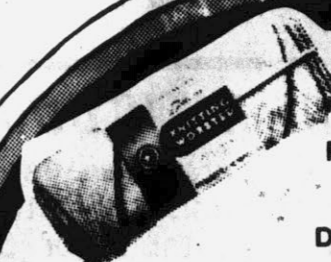

## Doubts Claim Russians Lied

WASHINGTON (AP) — Sen. J.W. Fulbright, chairman of the Senate Foreign Relations Committee, says there is no reason to believe that Russian leaders lied to President Nixon about the number of missile-firing submarines they had under construction.

The Arkansas Democrat said Wednesday it was clear from a CIA briefing that the disagreement stems from different interpretations of what constitutes a submarine under construction.

However, Sen. Henry M. Jackson, D-Wash., stuck to his charge that the Soviets did lie when they said they had 48 missile-firing subs under construction, rather than 41 to 43.

As a result, he has offered an amendment to require numerical equality in future U.S.-Soviet arms limitation agreements.

The controversy has stalled Senate action on the five-year U.S.-Soviet offensive missile freeze for more than a week. Expected House approval could come tonight. Both chambers must approve the interim agreement.

The offensive agreement freezes Soviet subs at a top of 62 with no more than 950 missiles, and U.S. submarines at 44 with up to 710 missiles. ## Learn Kidnaper Parole Violator

WALNUT COVE, N.C. (AP) — A probation officer says a young farm laborer charged in North Carolina with kidnaping a 9-year-old girl was in violation of parole in his native Alabama.

The girl was found unharmed Tuesday on a road about 10 miles from her home in Walnut Cove, Stokes County, 24 hours after her mother and a man were slashed to death in the woman's home.

Sheriff Clyde Duggins of Stokes County said other warrants would be filed in the case of William Otis Robertson, 20, jailed Tuesday night at Winston-Salem in neighboring Forsyth County.

The bodies of Mrs. Betty Greene Mabe, 38, a widow, and William L. Ernst, 49, a fellow worker in a Winston-Salem tobacco plant, were found Monday morning at the woman's home near Walnut Cove, a rural community 17 miles north of Winston-Salem.

The child, Brenda Lea Mabe, was found Tuesday after a massive search launched following discovery of the two bodies.

Robertson surrendered to officers Tuesday night after bloodhounds led officers to a tobacco barn on a farm near Walnut Cove.

Meanwhile, a federal probation officer at Birmingham, Ala., identified the farm laborer as William Otis Stewart of Mobile, a three-time escapee from a Tuscaloosa, Ala., school for mentally retarded who once was adjudged insane in a court action following the first escape in 1970.

The probation officer, W. Foster Jordan, said the youth was sent to the Partlow State School at Tuscaloosa after receiving a suspended five-year sentence for forcibly breaking into a Forkland, Ala., post office.

Jordan said the last escape came last April, but the following month the youth was given permission to visit a sister in Connecticut. The officer said Robertson, or Stewart, had violated parole by not making progress reports since then.

Jordan said the boy's stepfather, Jim Robertson, and his mother, had died in the late 1950s.

# McGovern Admits His Agent On 'Peace Mission'

SPRINGFIELD, Ill. (AP) — Democratic presidential nominee George McGovern first denied, then confirmed, that Pierre Salinger had acted as his agent in secret Paris talks with North Vietnamese peace negotiators about U. S. prisoners of war.

Then he denied any flimflamery.

Here is what happened Wednesday:

Early in the day a news agency reported from Paris that anonymous friends of McGovern said Salinger, who was President John F. Kennedy's press spokesman, had given Hanoi negotiators a message from McGovern saying they should conclude a peace with President Nixon without waiting for the November election.

The story proved to be at least partially true, but in early afternoon McGovern denied it flatly. He even went further,

leaving the clear impression that anything Salinger might have done was strictly at his own initiative.

A newsman's tape recorder caught this exchange as McGovern stepped down from a speaker's platform at the Illinois State Fair:

"Pierre Salinger had no instructions whatsoever from me," McGovern said. "He told me he's going to Paris and he said while he was there he might try to make some determination of what was going on in the negotiations. But there wasn't the slightest instruction on my part to him."

"Did you discuss this with him at any length?" he was asked.

"No. I haven't seen him for several weeks."

Barely two hours later, McGovern's press secretary,

Richard Dougherty, casually distributed a three paragraph printed statement from McGovern to newsmen in a temporary press room at McGovern's hotel. It said:

"I have just conferred by phone with Pierre Salinger in reference to his recent visit to Paris. Mr. Salinger had planned to return to Paris following the Democratic National Convention and at my request, he met with members of the North Vietnamese delegation in Paris.

"The only purpose of the discussion was to determine if any change had occurred which would permit the return of the prisoners prior to the end of hostilities.

"Mr. Salinger found no change in the publicly stated positions of Hanoi. Mr. Salinger also made clear that I have re-

peatedly stated my conviction that the end of the war should not be delayed by a single day because of the American election campaign."

What McGovern was saying is that he had, in fact, instructed Salinger and that Salinger had, in fact, raised the issue of a pre-election peace.

Why the discrepancy? News-men questioned McGovern an hour later as he emerged from an elevator to enter a reception for Illinois Democrats.

"There's no discrepancy at all," McGovern insisted.

"I was asked if I had instructed Pierre Salinger to inform the North Vietnamese delegation that I wanted them to go ahead and negotiate a peaceful settlement now. I said I had never even discussed that matter with Mr. Salinger, and I didn't even know that he had

brought up the issue. I didn't even know that he was in the United States until he called me some two hours after I talked with you."

Then Dougherty cut off questioning, insisting McGovern was behind schedule.

Left unanswered was why McGovern had said he'd given Salinger "no instructions what-

soever" when in fact he'd asked Salinger to act as his emissary.

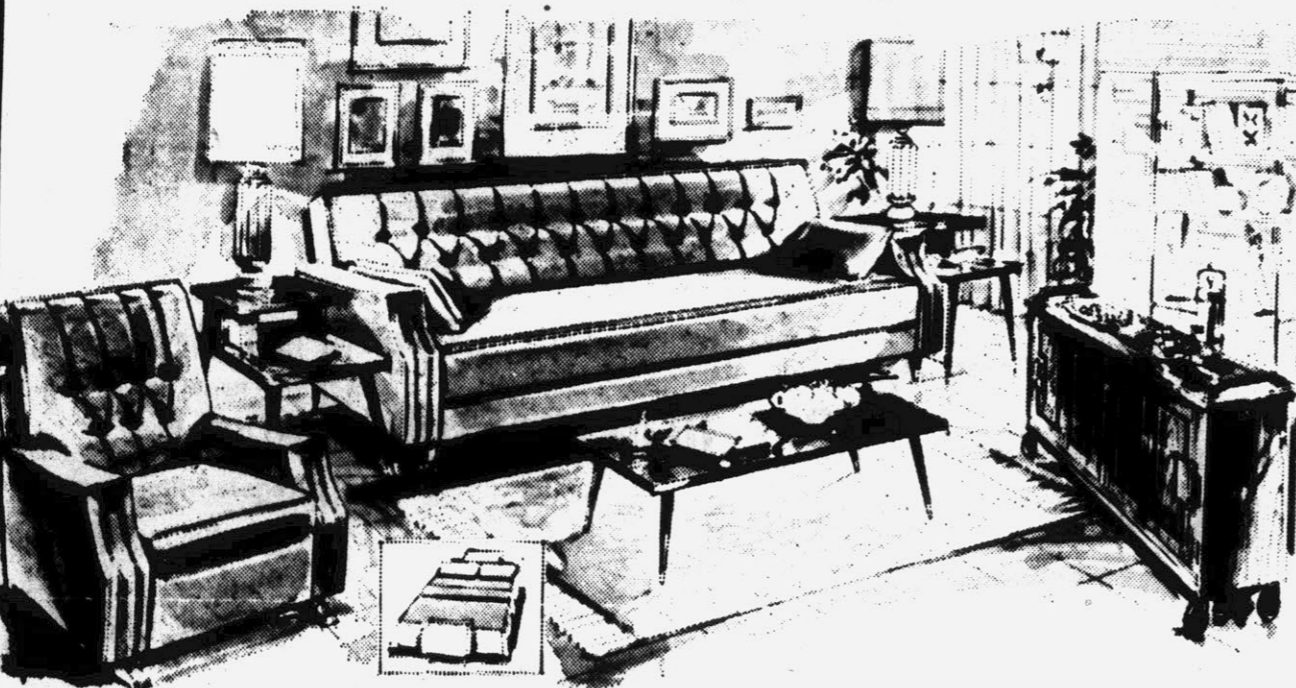
