OPPOSITION TO COMMUNISM IN RANKS OF CIO

A.F. of L. Leader Predicts Union Will Purge Itself

WAGE-HOUR MAN TAKES UP DUTIES

Plans to Concentrate on Textile, Tobacco and Cotton Garment Industries First

Washington, Aug. 16. (AP)—John Frey, American Federation of Labor leader, predicted today that the CIO soon would purge itself of communistic elements.

Frey told the House committee studying un-American activities that the labor organization of John Lewis already had started a campaign to rid itself of Communist members in four west coast unions and the United Automobile Workers.

"I've believed," he said, "that the great majority of members of the CIO are as much opposed to Communists who obtained positions in their organizations as the A. F. of L."

"I've believed that if sufficient evidence was presented to the membership, the CIO would take upon itself the task of ridding the organization of the Communists who have gained control."

Frey said communism had made little progress in American labor up until the time Lewis took an A. F. of L. union into his new organization three years ago.

Other developments: Elmer Andrews, Federal wage-hour administrator, said he was concentrating on the textile, tobacco and cotton garments industries first in setting up machinery for operating the new labor standards law.

Andrews discussed plans for handling his new job immediately after he was sworn in.

Meeting reporters a few minutes later, he said he expected to announce a labor standards committee for the textile industry within a week.

Senator Murray (D-Mont.) pledged his support to President Roosevelt if the latter seeks a third term, while two other Democratic Senators, McKellar of Tennessee and Minton of Indiana, expressed doubt that the chief executive would run again.

Record High Temperature Threatened For Part of East

RELIEF HOWEVER SEEN FOR AREA

Yesterday's High Of 93.4 in Manhattan Set Record for Year and Top for Aug. 15

(By The Associated Press) Virtually the entire country sweltered today in a heat wave with a record high temperature for the year threatened in parts of the east.

Increasing humidity made the mounting heat more oppressive. In the east a little relief was in sight, with a forecast of scattered thundershowers.

The mercury soared in the north and middle Atlantic states, the middle section of the Gulf states, on the north Pacific slope and in Montana.

Weather a little cooler prevailed in the Great Lakes region, the Ohio valley, Kansas, Oklahoma and Iowa, with heavy rains dispelling the heat in some sections.

In Illinois the Galena river, swollen near flood proportions, started to recede. Water stood two feet deep in the business section of Galena after yesterday's rainfall. Rivers still were rising in southern Wisconsin.

Discouraged New Yorkers went to work with the mercury out-climbing yesterday's hour by hour.

Yesterday's high, 93.4 in Manhattan, set a record for the year and broke the August 15 record.

Georgia Mart Average 21.31

Atlanta, Aug. 16.—(AP)—Georgia tobacco sales for the first 12 days of the current season sold over an average of 21.31.

Special figures for the first 12 days, or at the end of the third week, last Friday were announced by S. A. Martin, statistician for the Georgia department of agriculture.

The third week's sales totaled 22,858.779 pounds sold for an average of 16.74 cents a pound. This compared with a third week last year in which the 15 market centers sold 25,739,126 pounds for an average of 15.71 cents.

At the end of the third week last year growers had sold in Georgia warehouses 69,744,664 pounds for an average of 21.37 cents.

Nashville, Tenn., Aug. 16.—(AP)—Tobacco experts reported today that burley growers in many Tennessee localities faced the prospect of a "trusty escape" to Wilson.

State Due For Big Boom As Result New Building

Raleigh, Aug. 16.—North Carolina is in for a big boom as the result of the building program given so much impetus by last week's session of the General Assembly, in the opinion of state officials and building material men.

"We're going to see the state right square in the middle of a \$25,000,000 building program within the next three months," said Thad Eure, Secretary of State whose office force has been working overtime since Saturday morning's adjournment of the legislature. "If that won't make for prosperity, I don't know what will."

The Eure office ("your office" as he explains to every citizen of North Carolina with whom he talks) has enrolled all the bills enacted last week and the Secretary of State said Monday about noon that certified copies of all the acts "is already on the desk" of the PWA administrator in Washington, the regional director in Atlanta, and

all others interested in the new laws. "That will not finish our work, though," said Eure, "before long we'll be rushed by bond attorneys wanting certified copies of Journal entries and legislative minutes."

Confirming the Eure prediction of a building boom was R. M. Kermon, executive Secretary of the North Carolina association of Plumb and Heating Contractors. "I've been all over the state recently," said Mr. Kermon, "and I have found everywhere preparations for bigger and better building in the immediate future."

"That's going to bring prosperity to workers in the building trades as well as to contractors," he added. With every effort being directed at speed in getting ready to start on the building authorized last week, hammers and saws ought to be going strong in the very near future.

Electric Railroad In Grip of Strike

Waukegan, Ill.—(AP)—Twenty thousand commuters, deprived of customary transportation to Chicago by an electric railroad strike, scurried for other passenger service today.

A drizzling rain added to inconvenience of these residents of a dozen suburbs along the Lake Michigan shore who ordinarily use the Chicago North Shore and Milwaukee railroad.

Its service was suspended after union employees voted to cease work in protest against a 15 percent wage cut order.

The Chicago and Northwestern and the Chicago, Milwaukee, St. Paul and Pacific steam road suddenly acquired a large share of the North shore line passengers.

Greyhound bus lines also prepared to establish extra service to handle North Shore line customers. All street car and bus service in Waukegan and street cars in North Chicago operated by the North Shore line were at a standstill. Waukegan is of 35,000 population and North Chicago 1,000.

Officials estimated the electric line carried 24,000 passengers daily and that about 20,000 are regular commuters to Chicago.

NEW BUILDING FOR PITT FAIR

Directors Make Plans For Exposition At Meeting Here

Directors and other officials of the Pitt County Fair Association in session last night definitely agreed to go ahead with proposal to erect buildings on the present fair ground site a few hundred yards from the city limits on the Falkland highway.

Estimated cost for the work is \$1,500. J. Hicks Corey, secretary-treasurer of the association pointed out that the frame buildings would be used for agricultural displays, exhibits, and for stock and poultry.

More concrete plans for the Pitt County Fair, which will be held the week of October 1, also were mapped. The Pitt fair is sponsored jointly by Greenville and Pitt County parts of the American Legion, and Tuesday of "fair week" will be known as Farmville Day.

The officials designated Thursday of the fair festival to be known as Farmers Reunion Day. Events tentatively scheduled for this feature include an old-time "hog calling" contests. A prize will be awarded to the farm man and woman having the largest family. It was also announced that the wife of a farmer who could call her husband with the loudest tone of voice would be awarded a prize. Other plans for this day will be announced at a later date.

Students in the Greenville city schools will be guests of the fair on Wednesday of fair week. This has been a regular feature of previous Greenville fairs.

A colorful display of fireworks will be used each night of the fair, and efforts are now being made to obtain a well-blended variety of free acts.

Half Holidays Over

Tomorrow will mark the last Wednesday half-holiday for three clerks and others this summer, the Merchants Association having decided recently to discontinue the practice after Wednesday, August 17th.

The Daily Reflector, which has been going to press earlier on Saturdays, hereafter will observe its regular schedule, last Saturday having been the final half holiday for this summer.

Two Confess Abduction Of Couple After Arrest On Farm In Minnesota

Otis Jones Meredith and John Couch are Taken in Custody

MEREDITH SHOT SEEKING ESCAPE

Both Men Admit Kidnaping St. Louis Socialite and National Park Service Man

St. Paul, Minn., Aug. 16.—(AP)—The Federal Bureau of Investigation announced today the arrest of Otis Jones Meredith and John Couch near Effie, Minn., for the kidnaping of Miss Peggie Gross and Daniel Cox Fahey, Jr., of St. Louis.

The two were located last night by special agents of the FBI at a farm home nine miles east of Effie.

Police Chief Miller at Big Fork, Minn., said he and a deputy sheriff went to the farm home of Meredith's 19th-in-law, Charles Root, with two Federal men last night and surprised Meredith and Couch in the yard.

Meredith ran toward the woods, Miller said, and was shot twice in the back, but Couch stood motionless while the Federal men clapped handcuffs on him. At the Itasca county hospital attendants said Meredith was in a critical condition.

Fahey's automobile, stolen by the pair after they dumped Miss Gross, 23, St. Louis socialite and Fahey, National Park Service architect, out near Minneapolis was recovered at the Roots farm, the Federal agents said.

They were identified as the kidnapers, Robert Hendon, chief of the St. Paul office of the FBI said, from photographs. Identification was made by Miss Gross and Fahey.

Both men readily admitting kidnaping Miss Gross and Fahey, Hendon said, he also asserted they admitted a number of other crimes in the mid-west and south-west.

DISASTER HITS NAVAL PLANES

Five Fliers Left Dead and Four Injured in Mishaps

San Diego, Calif.—Aug. 16.—(AP) Disaster struck twice among the navy's war planes in "routine" maneuvers, leaving five fliers dead and four injured today.

After attempting a landing after dark last night, a PBY patrol bomber smashed nose first into San Diego bay, carrying two of a crew of six to their deaths.

The four survivors, all injured, were pulled from the water as the wreckage sank.

Ten hours earlier a speedy torpedo plane plunged earthward from an altitude of 3,000 feet over Camp Kearney Mesa. Its three crewmen perished in the crash.

Death, however, spared six men in another patrol bomber which was damaged in a forced landing on the bay last night. The fliers emerged unhurt.

Navy authorities said one of the bomber's dead was H. Bockmann, about 23, but identification of the second victim was lacking until later today.

ACL Trouble Is Blamed On Lack Of Co-Operation

SPANISH FOES WAGE VICIOUS BATTLE BY AIR

First Claim of Aerial Victory Made By Government

22-DAY BATTLE CONTINUES RAGE

Each Side Claims the Other Faction Lost Many Planes; Minimize Own Losses

Hendaye, France, Aug. 16.—(AP)—Spanish Government and insurgent war planes battled viciously today for the upper hand in the 22-day battle in the blistering Ebro river valley of southern Catalonia.

Three apparently re-organized Government air squadrons not only met insurgent planes on equal terms, but adopted the insurgent tactics of bombing and machine-gunning troops on the ground. In two days of battle with an insurgent fleet of 42 German and Italian made craft at least 34 planes on both sides were reported shot down.

Official dispatches from each faction reported the other had lost many planes while minimizing its own losses. In one battle in which the Government maintained 21 insurgent machines were downed and none of its own wrecked. Insurgents said 13 Government planes were lost against two of their own.

It was noted, however, the Government reports were the first claims of aerial victories to be made by the Government in many weeks.

FARMERS PLAN TO MEET HERE

Outstanding Agricultural Leaders to Be On Program

Farmers throughout the county and elsewhere in the state were making plans today to attend the annual Farm Bureau meeting to be held here tomorrow, at which time three of the nation's most outstanding men in the agricultural field will speak.

Farmers are reported to be especially anxious to hear what J. B. Hutson, AAA official will have to say regarding tobacco quotas. Court orders have been resorted to in Georgia and Florida to prevent the government from collecting a penalty tax on tobacco sold in excess of the quotas. No organized move has been revealed in this state, however, to test the constitutionality of the new marketing act, which was put into effect only a referendum of the growers.

In addition to Mr. Hutson, farmers will have the opportunity of hearing Edward A. O'Neal, president of the Farm Bureau Federation, F. R. Wilcox, director of the marketing adjustment section and John W. Goodman, assistant director of the extension service.

It has been estimated that 3,000 farmers will be here for the meeting, to be followed by a barbecue dinner at the Star warehouse. Admission to the picnic dinner will be by Farm Bureau membership cards.

The speaking is scheduled to get under way at 10 o'clock in the Campus building of East Carolina Teachers college.

ABC Enforcement Officers Get Still

J. M. Ward and J. L. Taylor, law enforcement officers of the Pitt County Alcoholic Beverage Control Board, assisted by officer E. G. McMullan, yesterday afternoon located and destroyed a 100-gallon illicit liquor distillery in Swift Creek township near Quinerly Cross Roads.

The officers revealed that 3,000 gallons of beer were found near the plant which, officers believed, had been in operation as late as last Saturday. Sixteen sticks of dynamite was required to destroy the plant.

According to officers, this was one of the first stills located in Swift Creek township. "The still was of unusual type," declared one of the officers, "having a 50-gallon steam drum connected by a pipe line to a copper kettle."

53 FATALITIES DURING MONTH

Deaths From Highway Accidents Fewer During June

Raleigh.—Deaths from automobile accidents in North Carolina during July totaled 53, as compared with 75 the corresponding month of 1937. Dr. R. T. Stimpson, director of the Bureau of Vital Statistics, State Board of Health, reports. The total number of deaths as a result of the month was 107, as compared with 121 for July, last year, including three resulting from collisions between automobiles and railroad trains and two airplane casualties. Nineteen persons were burned to death and 21 were drowned.

Suicides were up again, the total number for last month having been 23, against 18 the corresponding month of 1937.

Births continued to decline, the July total being 6,270, as compared with 6,270 a year ago. Deaths increased, the total for last month having been 2,656, while the total for July, 1937, was 2,592.

Infant deaths under one year of age dropped from 520 last July, to 506 for July, 1938, while maternal deaths dropped from 36 to 32. There was also a decline in the number of deaths among children under two years of age from diarrhea and enteritis, the July, 1938 total being 178, against 194 the previous July. Cancer deaths were up 10; tuberculosis deaths jumped from 120 to 137, and syphilis fatalities were up nine. There were 23 deaths from measles and 41 from whooping cough. Dr. Stimpson's report showed. One death from typhus fever occurred in Cumberland county, while the total number of deaths from typhoid and paratyphoid was 12, as compared with 14 the same month a year ago. One death resulted from poliomyelitis, and one was reported a year ago. There were seven deaths from mifeanus, as compared with one in July, 1937, and one from rabies, as compared with none last July.

How's Your Health? Edited for the New York Academy of Medicine. By Iago Seldin, M.D.

It has been said that "he who rides a hobby horse takes corrective exercises for his soul" and it is with this objective in mind that one should select and cultivate one's hobbies.

Individuals used to an active life who are forced into idleness by illness fare better when their tedium is relieved by some form of busy-ness, not beyond the limits of their restricted powers.

It may be amusing to see a man, who in full health manages affairs of large responsibility, sitting propped up on a hospital bed and weaving on a miniature loom or working with small carving tools on a linoleum block.

At first, such "a temporarily shelved executive" may frown upon the child's work proposed by the diplomatic occupational therapist, but if he has the good sense to be persuaded, he is soon likely to develop an enthusiasm for his task.

But one neither needs nor should seek until he is hospitalized before developing a hobby. It is better to cultivate the hobby for itself rather than as a refuge.

Certain desiderata in hobbies are self-evident. For the man occupied in physical labor during his regular work, a laborious hobby would surely be like the proverbial postman's holiday walk. Such an individual might fare better with a hobby which does not involve much physical effort.

On the other hand, the person whose occupation involves little physical activity would do well to cultivate a garden or develop such sports or holiday occupations as involve the expenditure of physical energy.

But one's hobby should not be looked upon as a holiday occupation. The hobby is rather a tribute to one's self and to one's intimate interests as against the numerous obligations which one must fulfill as a member of the family and of the community.

In general the creative hobby is to be preferred. Games to be followed as hobbies must be selected with great discrimination. A highly competitive game is likely to be too much like everyday life, a continuous fight for attainment and accomplishment. The desired psychological effects on one's hobbies are satisfaction, mental peace, change in occupation and in mental absorption.

Over \$6,000,000 Is Paid Unemployed. Raleigh, Aug. 16.—Approximately \$6,000,000 had been paid out to completely or partially unemployed workers in North Carolina through last week and since the first check was issued on January 27, records in the State Unemployment Compensation Commission show.

Through Thursday of last week the actual payments, made in the \$21,531 checks issued, amounted to \$6,136,322.63. Through that date, August 11, the commission had collected in contributions from employers \$14,818,885.72, and had been credited with \$28,994.58 on the balance on deposit with the U. S. Treasury, except for a small amount of interest collected on returned checks. With collections of \$15,057,870.30 and benefit payments of \$4,136,322.63, the commission had a balance in the benefit fund of \$8,921,547.67 on August 11. When the first payment was made on January 29, the fund was slightly more than \$10,000,000. This reserve has been reduced a little more than \$1,000,000 as the difference between collections and benefit payments since the payments started.

Washington Daybook

Washington-Notable dates: 1918-Armistice. 1928-Kellogg pact outlawing war. 1938-War outlawed; nations just fight it out.

Perhaps it is the surroundings, or the tradition, but whatever it is, the faces of recent Secretaries of State all look curiously alike, at least when done in oils. In Secretary Hull's reception room, where he meets the press, are paintings of five recent Secretaries of State. Some have mustaches, and some not, but all have a certain restrained nobility-of-purpose look about their faces as if the artists had wanted to give them a dash of George Washington at Valley Forge.

Secretaries Lansing (under President Wilson), Cully (under Wilson), Stimson (Hoover), Hughes, (Harding and Coolidge), all wore mustaches, with Hughes supplementing his with the same style of beard he now wears as Chief Justice. Kellogg (under Coolidge), was smooth shaven, and so is Secretary Hull.

Strangest of all is that Secretary Hull already has the look of a Secretary of State done in oil for posterity—and his portrait has not yet been hung in the chamber.

But Is It Loaded?

It doesn't mean anything in particular, but the State Department has a five-inch naval gun trained right on the President's office. If it were discharged it would send a hundred-pound slug through the private door into which Brain-Truster Tommy Corcoran supposedly dodges without so much as a by-your-leave from the guard.

From there the projectile would zig across the top of Greater Pat McKenna's desk in the main lobby of the executive offices, sail under Secretary Marvin McIntyre's nose and into the President's office. He probably would be glad to see it come. He hasn't added a naval souvenir to his desk collection in many months.

This government can't be accused of falling to emphasize its good neighborliness toward the Central and South American republics these days, even though the dispute with Mexico over seized oil and farm lands makes a nasty situation. (This government has to be pretty stern about that else there might be a whole wave of expropriations throughout the Spanish and Portuguese-speaking republics).

Telegrams To Presidents But outside of that, no effort is spared to do the good neighbor act. Within the last three months or so the President has sent brief telegrams of good wishes to every Latin-American president who has had a birthday. Some have received telegrams of congratulation on national anniversaries.

At the 400th anniversary celebration of the founding of Bogota, the chief city of Columbia, a plane crashed into the crowd, killing 50 persons. President Roosevelt promptly sent messages expressing his gladness at the escape of Alfonso Lopez, outgoing president, and Dr. Eduardo Santos, incoming.

Incidentally, the State Department has stopped calling them "Latin-American" republics. Now they are called simply American Republics. If it is necessary to be more specific, they are called Central American Republics, or South American Republics.

Reflector Bureau. Raleigh, Aug. 16.—On a hot, blue and news-scarce Monday practically any newspaper correspondent or columnist ought to be thankful for anything approaching usable material.

From Bill Sharpe, in charge of the News Office, Department of Conservation and Development, comes a sheet titled "Well, Of All Things!" and here are some of them:

Banker ponies, habituated to the Outer Banks of North Carolina, sometimes flee their owners when taken to the mainland and swim back to the sandbar. Recently a pony bought in the 1938 round-up swam seven channels to return, fagged but happy, to his due far at sea.

Noah Maryland Vess, 63, and totally blind, operates a grist water mill near Old Fort.

Little Japan Entered Circle Of World Powers By Handing Big Russia A Terrific Shellacking

Russia and Japan have declared a truce. If it clicks, there won't be another big-scale Russo-Japanese war—not right now, anyway. But there still is plenty of chance for trouble. This story tells what happened in the first war.

By ALEXANDER R. GEORGE (AP Feature Service Writer) Washington—The world was flabbergasted one cold February morning in horse-and-buggy 1904 by the news from far-off Manchuria. Tiny Japan had suddenly opened war on gigantic Russia!

It seemed incredible that "the cute little brown men"—nobody thought then of Japan as a militaristic nation with Asia-dominating ambitions—dared to tangle with the mighty Muscovite bear. Even more surprising was the news a few days later that the Japanese were walloping the Russians on land and sea.

The big bear, in quest of Asiatic honey, had prowled too deep into Far Eastern territory for little Japan's comfort. Russia's Gibraltar of the East, at Port Arthur in Chinese Manchuria, and the Czar's warships there had become "claws stretching toward the throat of Nippon."

Britain, which then had a "protect China" alliance with Japan, also frowned on Russian military penetration. Russia refused to withdraw her troops from Manchuria and before the Czarist government realized what was going on, the Japanese had destroyed part of the Russian fleet at Port Arthur and had won a series of land battles.

Out Of The Blue There were no preliminary border clashes like those of the last seven years between Soviet and Japanese troops. All of a sudden Japan launched a war to the finish, mustering all of its forces to drive the Russians from Manchuria.

The Russians rallied later with reinforcements from home and put up a stout but usually losing struggle. The Japanese dealt them three staggering blows: Impregnable Port Arthur was captured after a terrific seven-months' siege, the Japanese won a decisive battle at Mukden and a tremendous naval victory in the Sea of Japan.

Admiral Togo's "mosquito" flotilla annihilated the proud Baltic fleet, which had steamed half way round the world to avenge earlier Russian naval reverses. U. S. sympathies swung toward Japan as the "little fellow" in the war, spoke of the diminutive Togo as a second Admiral Dewey.

Togo, Marshal Oyama and General Nogri were heroes in this country, sharing the headlines with President Teddy Roosevelt taking jiu-jitsu lessons and Auto Speed-King Barney Oldfield doing a mile a minute in his Green Dragon. The Japanese soldiers' smiling disdain of death stirred Yankee admiration, while tales of Siberian dungeon cruelties to political exiles had made autocratic Russia unpopular with many Americans.

Japan Goes Big League The war dragged on, the Russians steadily losing ground, until President Roosevelt induced the two governments to start peace negotiations in August, 1905. Under the treaty signed in September, Russia abandoned her claims to Manchuria. China resumed control of that country and Japan took over the lease of strategic Port Arthur.

The world didn't realize it then, but Japan had become a big league nation.

The poorly-trained Russian soldiers displayed great courage but most of them didn't know what it was all about and wanted to go home to their wives and children. Typical was the question put to an English correspondent at the front by a gigantic mujik: "Tell me, little father, what made Three-Headed Angel"—a cotton

planter, a recognized authority on Negro dialects.

"Come on in the house—it's too damned hot out here," Roark says, leading the way into cool dim rooms which are a confusion of cushioned chairs, books, and phonograph records.

The last I saw of him he was standing in his courtyard, surrounded by rooms that were built in 1781, saying to his son: "Richard, go get your old daddy a match, and hurry now." And Richard hurried.

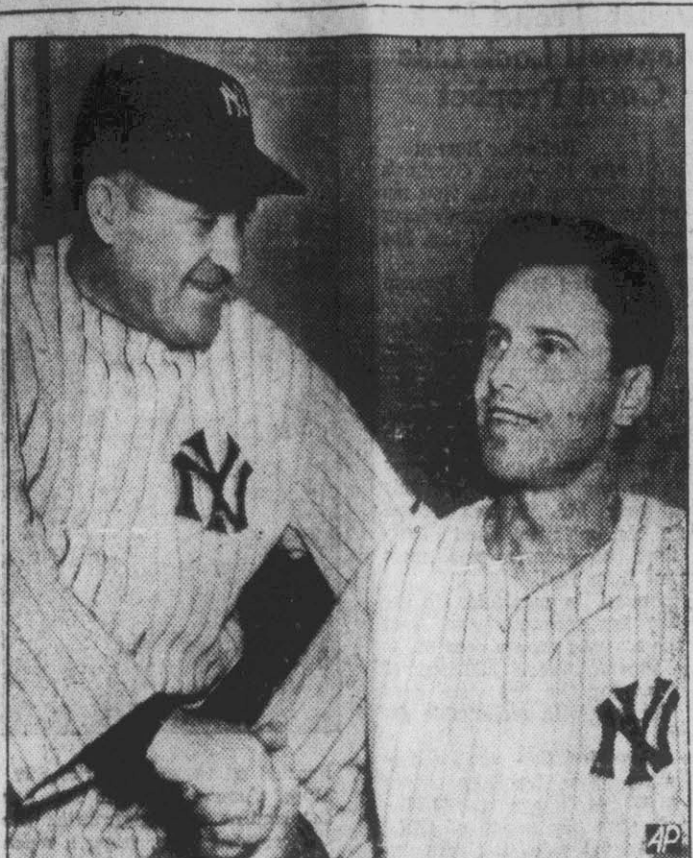

N. C. REVENUE SHOWING GAIN

August Trend Makes Maxwell Look Like Good Prophet

Reflector Bureau Raleigh Aug. 16.—North Carolina's revenue collections for the first ten days of August make Commissioner of Revenue A. J. Maxwell look like a very good prophet.

For the period Revenue Division receipts have jumped nearly half a million dollars over receipts for the corresponding period of 1937, with the figures \$2,079,338.82 to \$1,556,321.70.

At the end of July when figures for the first month of the new fiscal year showed such a drastic decline in tax receipts from July of last year, Mr. Maxwell refused to lose his optimism and flatly said that the decrease was more apparent than real.

He pointed, in particular, to the franchise tax revenues and said that these would show a decided increase during August. Report of collections for the first ten days bear him out with remarkable accuracy.

For the period this year's collections from the franchise levies were \$1,795,541.77, against \$1,281,947.04 for the like period of 1937.

Early August sales tax revenues were slightly above those for the first ten days of last August, \$110,790.46 to \$102,658.34, but bulk of revenue from this source never begins to come in until after the 15th of any month and so little is indicated by these returns.

On the Highway Division side of the tax collection ledger there were not sufficient data for the first ten days to make any real estimates or comparisons. Gasoline taxes, always biggest single item in either revenue or highway divisions, total revenue or highway divisions, total less than \$10,000 for the first ten days of August but this meant nothing at all except that the oil companies will pay them later in the month.

The bonds will be sold to get funds to match PWA grants which would enable a building program of \$8,240,510 if the state gets all the funds requested.

(Continued from page one) of seeing much of their leaf rot in barns. R. Milton, University of Tennessee specialist, said the problems was caused by recent excessive moisture.

He said many growers were experimenting with artificial heat, coke and charcoal fires on their barns, even though burley is cured by air and not by smoking as is dark fired.

Milton said despite the rot, he anticipates a larger crop of burley than last year "when we had the largest crop ever harvested, but quality will be considerably lower."

PAUL LEONARD PUSHES FIGHT

Foe of State Sales Tax Persistent in Opposition

Reflector Bureau Raleigh, Aug. 15.—J. Paul Leonard of Statesville is a most persistent man. Whereas most opponents of the state's Sales Tax have long since resigned themselves to what they consider the inevitable, Mr. Leonard still goes about the state roaring loud his protests.

In between times he writes letters to "North Carolina Fair Tax Association Members and Others Addressed" calling on them to help him "kill the snake" and especially, urging them that they should "be glad to help finance a court fight."

Mr. Leonard is Executive Secretary and Treasurer of the NCFTA and his opponents intimate that he's primarily interested in collecting funds with which to pay his salary, rather than the fight against the tax. His friends and supporters present him as a noble crusader for a great cause.

But be that as it may, and be Mr. Leonard what he may, there's no getting around the fact that he does campaign actively and vigorously against the Sales Tax and that he has probably done more than any other one man to keep the issue alive for all these years.

His latest blast to come to this bureau's attention is a letter to his members in which he tore into the Department of Revenue's field auditors as conducting a "get-what-you-can-out-of-the-merchant racket."

In his letter he also points out that his test of the Sales Tax constitutionality is on its way into the courts and calls on anti-taxers to write communications for the open forum sections of the newspapers.

He also expresses the opinion that his organization is stronger today than at any time since "it started on its noble task," and feels it an "honor to be your active leader."

He said, in part: "To you who ask that I incorporate your views in newspaper articles and speeches, may I suggest, and urge, that you write communications for the open forum sections of the newspapers yourselves."

"Now that our case is on its way into the courts, I have more time for field work. The store is being closed."

"Complaints from various sections indicate the State is pursuing its 'get-what-you-can-out-of-the-merchant racket' through its field auditors with vigor. The high-handed tactics used by the State thru its representatives are not calculated to create a patriotic spirit among law-abiding tax-paying merchants. Certainly it is time for all of you to help us 'kill the snake.' We who have, and are, making sacrifices to carry on a fight in the interest of all retailers and the customers, are excusable if we sometimes use language so strong that it may appear rude. This fight cannot be carried on with mere pats on the back, advice as to what we should do or not do and good wishes—all of which are appreciated, but none of which pay expenses and attorneys fees. Hundreds of you who have said you would be glad to help finance a court fight should now send checks and pledges, or never open your mouths in complaint again."

"We are delighted with the cooperation some of you are giving. That's a million. Our Association is stronger today than at any time since it started on its noble task. I feel it an honor to be your active leader."

Mr. Leonard, it seems, has closed up his variety store in Winston-Salem, but has not abandoned his efforts to get his case into court. His attorneys have prepared an eleven-point petition by which they would have the assessment made by the Revenue Department against the Variety Store quashed.

New talent like this makes you wonder what the factories are yelling about.

Scarcity of leading men? There's a good bet named Bruce Lester in "Boy Meets Girl." There's another in "Garden of the Moon." John Payne's the name. It's not a new one, but it hasn't clicked before.

Do they want a sure thing in the comedy sweepstakes? Let 'em look twice at Marie Wilson.

And a potential child wonder? Let 'em listen to the mamas and grandmas' clucking over Donnie Dunagan of "Mother Carey's Chickens."

"Boy Meets Girl" takes Hollywood for a dizzy ride on a mile-a-minute track of dialogue. It's fast, furious, funny, and it tops the stage version. You know the story—or where have you been? Cagney and Pat O'Brien are the honey film writers. Merle Wilson's the waitress who spruces the prodigious infant Happy, Bruce Lester's the girl friend—after the fact, nicely glossed over for the censors. Ralph Bellamy's the producer, and Frank McHugh the agent. Dick Foran's the cowboy. Lloyd Bacon mixed the ingredients with accent on speed and the laughs spill over the sides of the dish. In Hollywood, anyway.

Director Busby Berkeley took these principals, a host of supporting players, some good tunes and smart showmanship values, and whipped up what looks like a sure-fire click. Important in the story is Jimmie Fidler, movie commentator, playing himself.

If you like simple, appealing, human stuff you'll go for "Mother Carey's Chickens." Not much of a plot. It relies on romantic, amusing, heart-warming incident for its major strength. Family stuff, and good.

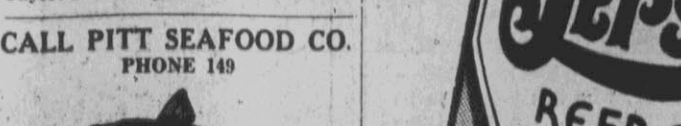
