HITLER HALTS MOBILIZATION; CALLS CONFERENCE

NOTE IS SENT TO MUSSOLINI BY ROOSEVELT

Dispatched with Hope Preserving World Peace

TEXT OF CABLE IS KEPT SECRET

White House Attaches Hail Conference Announcement As 'Very Encouraging'

Washington, Sept. 28. (AP) — White House attaches announced today that President Roosevelt had sent a personal message to Premier Mussolini "in the interest of preserving world peace."

The announcement was made in response to inquiries by Stephen Early, presidential secretary, who said the message was dispatched yesterday.

Early asserted that because the communication was personal, it would not be made public textually.

He added, however, that the note dealt with preserving world peace. White House attaches hailed as "very encouraging" the summoning by Adolf Hitler of representatives of England, France and Italy to a conference in Munich tomorrow.

Early told this to news men, advising them simultaneously that President Roosevelt's cable to the German chancellor last night probably would be the chief executive's final word in the European crisis.

The President urged Hitler to avoid plunging Europe into war.

Other developments: A three-man board selected by President Roosevelt will begin an effort Friday to avert the threatened nation-wide railroad strike.

The three commissioners and representatives of the employees and carriers have agreed, it was announced today, to begin presentation of testimony at 10 a. m. Friday.

Officials said the hearings should last about three weeks.

Senator Russell (D-Ga.) predicted the Agriculture Department would face difficulties in obtaining cotton growers' approval of 1939 marketing quotas because of widespread dissatisfaction with 1938 allotments.

"I know that the cotton farmers in my state are dissatisfied and I doubt if they will vote in favor of quotas on the 1939 crop," Russell declared. "With the cotton price what it is, the growers are faced with the situation of having about 40 per cent less than the normal amount of cotton to sell and they are not getting anything for it."

Local Negro Held On Hit and Run Charges

Patrolman C. R. Williams declared today that Frank Dupree, Negro mechanic of Greenville, had admitted that he was the driver of an automobile which was involved in a hit-and-run wreck Sunday night.

Dupree is charged with careless and reckless driving and with hit-and-run as a result of the wreck on the Greenville-Farmville highway about two miles from Greenville.

David Langley, Jr., was the driver of the other car involved. No one was injured, the patrolman said, but both cars were badly damaged.

Dupree is free under \$100 bond pending trial of the case in County court.

Guthrie, Ill.—(AP)—A bolt of lightning struck the windshield of the automobile in which Mr. and Mrs. Joe Werner were riding from Chicago.

A second car passing them at the time had all of its tires destroyed by the same charge. Occupants of neither car were injured, although they did suffer jitters.

No Hitler Reply

Berlin, Sept. 28.—(AP)—A foreign office spokesman, commenting on President Roosevelt's latest appeal for peace to Hitler, said today that the time for exchanging friendly messages is past and it is unlikely any reply would be sent to the United States' President.

"Our Fuehrer," said the spokesman, "took cognizance of the American President's reply to his yesterday's telegram, but no answer is likely to be forthcoming, else there will be no end to the messaging back and forth."

"Our Fuehrer, now as before, is doing all he can to avert war and safeguard the interests of peace, but it is up to the others to do likewise."

COUNTY BOARD MEMBERS OUT

Davidson Democrats Removed From Office by State Board

Raleigh, Sept. 28.—(AP)—The State Board of Elections ordered removal today of the two Democratic county election board members in Davidson county as it resumed its consideration of the Deane-Burgin contest for the 8th District Democratic Congressional nomination.

The board also rejected "final" returns sent to it this morning over the signatures of the two men removed, J. David Sink and Ford Myers.

Chairman W. A. Lucas said he did not know when a new Davidson county board would be appointed.

At Lexington the Davidson county election board forwarded to the State Board at Raleigh a certified return from the run-off Democratic primary of July 2, crediting W. O. Burgin with 6,917 votes and Deane with 961 in their contest for the 8th District Congressional nomination.

The board ruled that only 24 absentee ballots had been legally challenged and that of these 21 for Burgin, Lexington lawyer, and one for Deane, Rockingham lawyer, were voided.

Its members contended that the State Board's order to eliminate 146 votes was not made in accord with provisions of the rule.

The certified return was signed by Chairman Sink and Secretary Myers. S. A. Delapp, the Republican member, who was recently named by the State board, refrained from signing.

Sink said the board held a formal meeting last night to act upon the returns, anticipating that the State board would direct such a meeting because of the Supreme court's recent action in remanding the Deane-Burgin contest to the board for legal certification.

Let Contracts On Chicod Projects

Contracts were let for general construction and heating and plumbing projects at the Chicod school yesterday afternoon, but contracts for Farmville projects were rejected.

Plans on the Farmville projects will be revised and bids called for again.

The Herman Sipe Company of Conover, was awarded the general construction contract, including class rooms, etc., while the heating contract was awarded to C. L. Russ of Greenville, and the plumbing to W. M. Wiggins of Wilson. The general construction work was contracted for \$31,300; heating for \$2,972; and plumbing for \$12,039.

PWA grants have been made for both the Chicod and Farmville projects.

Daladier Says:

Paris, Sept. 28. (AP)—Premier Daladier told his countrymen tonight he would continue in Munich tomorrow his efforts to save peace and safeguard the vital interests of France, "with the backing of the whole nation."

In a two-minute radio address he said, among other things: "You will understand that on the eve of such an important negotiation it is my duty to postpone the explanation which it was my intention to give you."

TRAINING FOR GROUP IS SET

Anti-Aircraft Observers to Receive Instructions

J. H. Rose, district commander for the joint anti-aircraft and air corps exercises revealed today that officers from Fort Bragg would come here Friday to school post observers in the use of the telephone in warning of "enemy" planes.

The regular army units, temporarily stationed at Wilson, district headquarters, and are working out of that place.

Under the set-up, upon sighting an "enemy" airplane post observers will pick up their telephone and call "flash" and be connected directly to district headquarters in Wilson, from which place the message will be relayed to Fort Bragg.

Mr. Rose said that a "dry run" would be made some time prior to the date of the actual maneuvers for the purpose of testing the efficiency of the warning net.

The exercises are divided into two phases, a preliminary phase from October 3 to October 7, inclusive, and a principal phase from October 10 to October 15, inclusive.

During the preliminary phase the warning net will not operate, but during the principal phase the warning net will operate to give the defense commander, stationed at Fort Bragg, warning of the approach of hostile planes.

The Defense Commander, Brigadier General Fulton C. Gardner, stated today that telephone subscribers on party lines could materially aid by naming up their receivers at once when one of the official observers called "Flash". This procedure is necessary because of the fact that the observer cannot ring "Central" when any one of the receivers on the line are off the hook.

In issuing his statement, General Gardner expressed his appreciation of the splendid cooperation he has received from the people of Eastern Carolina in the organization of the Warning Net. He requests that they will continue to cooperate to the extent that only official observers will notify Defense Headquarters of the approach of airplanes in the Area.

NEW PROJECTS ARE DISCUSSED

Considered at Special Meeting of Board of Aldermen

The Greenville Board of Aldermen, in a called meeting last night discussed several projects, including the extension of the top over the municipal stadium, widening of streets, and a drainage program.

City Engineer H. L. Rivers reported that work on the stadium was progressing "slow, but sure." Members of the board and others attending the meeting expressed the opinion the "umbrella" roof would prove inadequate and a committee was appointed to investigate the possibility of extending the present covering four feet.

Mayor M. K. Blount reported on the purchase of property on Fifth street upon which to place the city hall and central post station and the board officially set on record as sanctioning the purchase for \$30,000.

The mayor then brought up the question of widening Greene street from the river bridge to Dickinson avenue. He explained that the State Highway and Public Works Commission had agreed to widen the highway north from the bridge to the intersection of the Stokes road and said he believed the commission would extend the project to include widening of Greene street.

He also said that it was probable the commission would widen Fifth street from Greene to Washington, three feet on each side. A resolution was passed petitioning the highway body to include Greene and Fifth streets in its program.

NOTE SENT TO CHAMBERLAIN

Says Decision to Occupy Sudetenland Intended Solely As Safety Measure To Insure Order During Final Settlement By Plebiscite

Berlin, Sept. 28.—(AP)—An authoritative source said today Adolf Hitler had sent a letter to Prime Minister Chamberlain guaranteeing that Czechoslovakia's political and economic independence would not be endangered by German occupation of Sudetenland.

The letter, sent yesterday after Chamberlain's broadcast to the British empire, was reported to have said, however, that occupation of the Sudeten territory was "indispensable" in view of conditions which Germany could no longer endure.

Hitler told the British Prime Minister Germany's decision to occupy Sudetenland by October 1 was intended solely as a measure of safety to insure order during final settlement of the problem by a plebiscite.

Germany is even ready to be co-guarantor with Poland and Hungary of the revised Czech state's independence, Hitler was said to have written.

He also was reported to have asked Chamberlain why Britain was mobilizing her fleet and why France was preparing for a state of war, if Chamberlain realized, as he said in his broadcast, that Europe ought not to be plunged into a war on account of the German-Czech conflict.

There is no nation in existence anywhere that desires to dominate the whole world by force, he was said to have told Chamberlain, and Germany demands nothing more than a right solemnly conceded to it.

White Man Arrested On Charge of Forgery

George Smith, about 21, of the Cox's Mill section, was lodged in city jail today on a charge of forgery.

Chief George Clark reported the young man was caught attempting to pass a \$3.50 forged check at Reid's store here. The chief of police said Smith had signed the name of his uncle, Major Smith, to the check.

He also said the young man some time ago attempted to cash a check forged on his uncle, but the bank noted the forgery.

County Jail Inmates Number Twenty-Five

The county jail population was reported by W. G. Leggett, jailer, today at 25, of which number eight are white persons.

Of the 25 in the lock-up, all except four are awaiting trial, most of them sent up pending appeals from lower courts to Superior court. Four are serving terms.

FRANCE HEARS OF NEW EFFORT TO SAVE PEACE

News Comes as Daladier Prepares To State Position

HAD SUGGESTION FOR SETTLEMENT

Revealed Ambassador to Berlin Authorized to Make Last-Minute Efforts

Paris, Sept. 28.—(AP)—Parliamentary sources reported today Prime Minister Chamberlain of Britain, Premier Daladier of France and Premier Mussolini of Italy would meet tomorrow at Munich, Germany, in last-minute efforts to avert a European war.

Earlier France offered Germany another suggestion for peaceful settlement of the German-Czech crisis, as Premier Daladier prepared to place France's case before the world in a broadcast.

Andre Poncet, French ambassador to Berlin, had an hour's conference with Reichsfuehrer Hitler and it was learned here that he carried proposals for a last-minute settlement of Germany's demands on Czechoslovakia.

The Premier's office announced Daladier would address an important message to his own country and to the world at 7 p. m. tonight (1 p. m. EST).

Daladier, following Hitler and British Prime Minister Chamberlain in a world-wide broadcast, will speak from the solitude of his study in the war ministry.

Official circles refused to comment on Poncet's visit to the German leader.

However, one suggestion known to have been received favorably by Daladier called for an immediate conference between representatives of Germany, France, Britain and Italy.

Freshmen were registering in large numbers at East Carolina Teachers College here this morning as the college formally opened its doors for the fall session.

Though their actual registration did not begin until today, Wednesday, Freshmen came pouring in on Monday and Tuesday, as they had been urged to come then for preliminaries intended to orient them and make them feel at home before the arrival of the upperclassmen, who will register on Thursday.

Officers of the student government and the Y. W. C. A. were back early to help welcome the freshmen. The newcomers spent the day Tuesday learning the campus, having the general set-up explained, meeting each other and the student officers, and learning college songs.

From all indications there will be a still larger student body at E. C. T. C. than there was last year, when over eleven hundred were enrolled. All available dormitory space is already taken and students are still requesting admission.

France, Britain, Italy Invited By Chancellor To Consider Situation

Chamberlain Says:

London, Sept. 28.—(AP)—Highlights from the speech of Prime Minister Chamberlain at Commons:

I will go (to Munich) to see what I can do as a last effort. I bitterly reproached the chancellor (Hitler) for his failure to respond in any way to the efforts which I had made to secure peace.

If article 19 of the League covenant providing for revision of treaties by agreement had been put into operation... the crisis might have been avoided.

That Lord Runciman did not succeed (in obtaining a settlement in Prague) was no fault of his.

Hitler on September 12... for the first time raised the issue of self-determination.

If they (the Sudeten Germans) could not achieve this (self-determination) by their own efforts, he (Hitler) would assist them to do so. Rather than wait he would be prepared to risk a world war.

TESTIFY AS TO LIQUOR TRADE

Beaufort Men Alleged to Have Used 900-Gallon Trucks

Durham, Sept. 28.—(AP)—Liquor shipments in automobiles of 150-gallon capacity and sometimes in trucks holding up to 900 gallons were routine incidents in the liquor traffic between Beaufort and Durham counties, defendants who have turned state's evidence in the "million dollar" tax evasion conspiracy testified in Federal court here today.

Mrs. Mack Rigsbee, Durham woman, now serving a sentence in a Federal reformatory for heading a local ring, and Aubrey Goss, one of the Durham defendants, gave testimony against six of the nine Beaufort bootleg conspiracy defendants. Goss appeared in prison garb, since he, too, is serving time. He was brought from the Federal reformatory at Chillicothe, Ohio.

Mrs. Rigsbee told the jury that she purchased several loads of liquor from Guy Lewis in 1933. Goss testified he had bought whiskey from Jasper Mills, Guy Mills, Clifton Mills, Lewis Cayton and Mack Shackelford over a period of two and a half years.

Other witnesses who served Goss as drivers corroborated his testimony.

Conference Be Held At Munich, Germany, Thursday

MUSSOLINI WILL ACT AS MEDIATOR

News of Hitler's Action Reaches Prime Minister Chamberlain During Speech

London, Sept. 28.—(AP)—Prime Minister Chamberlain announced the postponement of German mobilization to the House of Commons today and showed Parliament and the world a possibility of averting a world war.

He said he, Premier Daladier of France and Premier Mussolini had been invited to meet Chancellor Hitler at Munich tomorrow.

While he was speaking news came from Rome that Mussolini had telephoned Hitler and the Fuehrer had accepted him as mediator in the Czechoslovakia crisis which threatened to involve Great Britain, France and Russia and might ultimately drag in other powers.

The invitation from Hitler for the Munich meeting came even as Chamberlain was telling a tense parliament of his apparently hopeless efforts to avert war.

He revealed that the Fuehrer's invitation followed his own appeal to Mussolini to restrain the German leader and Il Duce's telephoned communication to Berlin.

Chamberlain said that Hitler had agreed to postpone mobilization of the German army for 24 hours to permit the fateful Munich conference of the Premiers to be held.

While he talked, the British fleet was mobilizing, millions of men were under arms in Britain, Germany, France, Italy and Czechoslovakia.

Just as Chamberlain concluded an hour and a half talk he was handed a penciled note by Sir John Simon, the home minister.

He read it, lifted his eyes from the paper and announced the invitation for him, Daladier and Mussolini to meet Hitler tomorrow.

The Premier said "I need not say what my answer will be. I will go to see what I can do as a last effort."

The house immediately adjourned until Monday as Chamberlain, making his momentous disclosure, ending speaking at 4:20 p. m. (10:20 a. m. EST).

The whole house and galleries stood and cheered madly.

"No member of the house will not feel his heart leap that the crisis is once more postponed," said Chamberlain as he concluded.

In a few lightning moments after Simon handed him the scrap of paper he painted the changed aspect of world affairs.

Then he disclosed the 24-hour postponement of German mobilization on and the fact that Mussolini had sent his Berlin Ambassador, Foreign Minister Von Ribbentrop to ask Hitler to defer his use of force against the Czechs.

There was no indication that Czechoslovakia would be directly represented at Munich.

Earlier Chamberlain had told Parliament that Hitler informed him as Berchtesgaden that "rather than wait" to help the Sudeten Germans achieve self-determination, "he would be prepared to risk a world war."

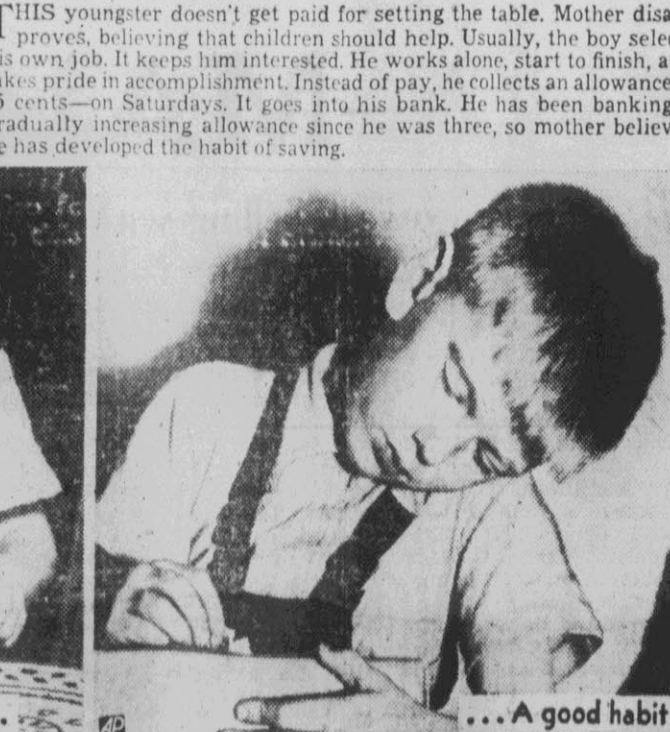

HINTS TO HOUSEWIVES

Combinations of fish produce some interesting flavors. For instance tuna timbales are delicious served with crab sauce and lobster soufflé goes perfectly with crab cream sauce. Shrimp sauce makes a delicious topping for a salmon loaf. Crab shrimp and lobster all combined with a highly seasoned salad dressing and diced celery make an excellent salad or sandwich blend.

Always soak dishes used for dough, pastry, egg and milk mixtures for five minutes in cold water before washing them in warm water and soap suds. Soak greasy and sugary pans and dishes in hot water before washing them in the regular way.

Marshmallow treat for youngsters: Make cuts in marshmallows. Insert bits of jelly and butter. Arrange the marshmallows on crackers and broil or bake them until they're puffy and browned.

One bushel of pears or peaches, cut in halves, yields about sixteen quarts of mixture when put up in medium syrup. One bushel of tomatoes will yield about twenty-four quarts when canned.

Pickled beets, chopped, mixed with chopped cooked meats and smoked ham make a tasty filling for hot toasted sandwiches.

Cheese puffs make a hit with soups of any kind. Mix one-half a cup of pimiento cheese one egg, a speck of salt and a little minced onion, parsley and a few grains of celery salt. Spread on buttered toast fingers or crackers and bake well puffed and a delicious brown color.

Something new in the canape line is a cheese tart. Spread baked pastry dough generously with one cup of grated cheese melted with three tablespoons of milk. Season with salt, paprika, minced onion and parsley. Broil until browned and sprinkle with paprika. Serve in inch strips.

To give crunchiness as well as added flavor to meringues for pies, add one-fourth cup shredded nut meats to each two egg whites. Then sprinkle the nuts over the top or add them to the meringue just before it is spread.

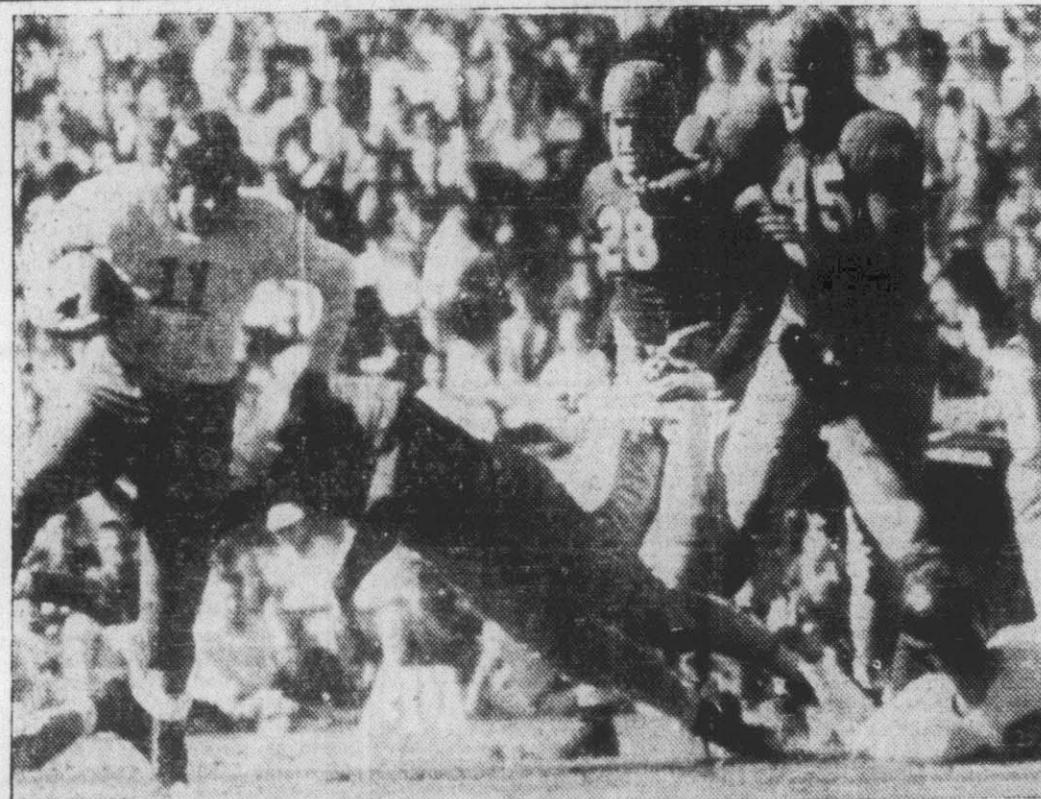

But if it wasn't the successful termination of Cooper's fight for new bus terminals in Wilmington should now thoroughly convince any and all doubters of the Cooper constancy.

The terminal fight began nearly two years ago—was actually begun even before Tom went into office in the city hall down by the sea.

Now it seems over with Wilmington to get a brand new \$35,000 terminal in one of the best locations in the city.

But in between takeoff and landing there were times when even the stoutest will might have wavered. The companies hemmed and hawed. They quibbled and evaded. Real estate owners and agents in Wilmington fought each other bitterly in effort to reap financial rewards. rival hotels battled fiercely to get the terminal as a next-door neighbor.

But Tom continued to persuade, argue, bully, threaten, plead and compromise. Now he's getting the stations.

SHORT SHOTS

Raleigh, Sept. 28.—Your correspondent, like everybody else in this vicinity, wants to attend Saturday's football fracas involving Carolina's Tar Heels and State's Wolfpack. Accordingly he grabbed a telephone yesterday with the unoriginal idea of wangling complimentary tickets out of Wade Ison, State's athletic publicity director. The connection was made and the following conversation took place:

Y.C.—Hello, Wade, how're you coming on?
Mr. I.—Fine, but we need to work on pass defense.
Y.C.—Well, you'd better get busy, I'm on the pass offensive right now—I want some to Saturday's game.

Libby Ward, one of the three avowed candidates for Speaker of the 1939 House, isn't at all dismayed by claims of Victor Bryant's supporters that the Durham man has as many as 50 votes pledged in the Democratic House caucus. Mr. Ward gives no numbers in counting up his own strength, but puts the "definitely committed to Bryant" strength at no more than 22.

State Senator John D. Larkins, heading the campaign for four-year terms for sheriffs, faces the task of reversing an 87,500 adverse majority on the same question in 1932.

Still it's doubtful if he'd trade jobs with another State Senator (Stokes S. Gilmer Sparger) who is trying to line up 60 per cent of the membership of each house in order to submit an anti-diversion amendment to the people for ratification or rejection.

Which silhouettes the real difficulties of getting a Constitutional amendment before the folks, much less adopted after it gets there.

To submit an amendment there must be a favorable vote of at least 60 per cent of the membership (not members present at the time of voting) of both House and Senate, and this favorable margin must be obtained on each of three separate readings in each chamber.

In short, one must get 72 Representatives and 30 Senators who not only are in favor of the amendment but who will be present and voting on three separate occasions.

Those Drinks At Deauville
The senator likes a good noggin of whiskey now and again, so we asked him about the liquor supply in Europe.

"There isn't a good drink of whiskey in Europe," he snorted.

He later modified this slightly. At the Deauville home of his friend Ralph B. Strassburger, owner of the Norristown, Pa., Times, he got a drink of the "Best Scotch I ever tasted in my life."

He moved on to St. Jean de Luce to visit Claude Bowers, American ambassador to Spain, who is compelled to live in this French city just across the border instead of in Madrid. Together they went to the border and looked across into embattled Spain. They did not hear the guns, as the fighting was far away.

He planned a few days in Switzerland but heard that Frank Kent, Washington writer, had been made into a new man at Vichy. He met Kent, who confirmed it. Guffey wasn't run down but he could endure to be run up a little before swinging into the Pennsylvania campaign this fall. "Wonderful" is his verdict about Vichy. He took the cure, drank the water and took the baths and the rubbing and the diet, with some modifications, and he, too, felt like a new man.

By then it was time to move on to The Hague for the Interparliamentary union. Hedged about by war and rumors of war, the union didn't take any very aggressive action. He visited art museums in The Hague and at Amsterdam and took a trip out into the country.

"But a cow," says the senator, philosophically, "looks just like a cow, wherever you see one."

Representative Oscar Barker of Durham, who will not be back in 1939 as a result of electing to try for Congress in the Sixth, was in town Tuesday with a delegation of hunters seeking to convince the Game Commissioner that the season on birds and on coons and "possums" should be opened and closed some fifteen days earlier than is now provided.


He opined that the Department of Conservation and Development is showing a much more conciliatory spirit in such matters than has been the case, on occasion. This change, he added, is likely to forestall some lively fighting in the next General Assembly.

It has been freely predicted that the game laws are quite likely to become subject of bitter wrangling in the 1939 session.

On the subject of the House Speakership, Mr. Barker said the only thing that makes Victor Bryant's selection uncertain is the fact that Durham is neither flesh, nor fowl nor good red herring in the matter of geography. The county, he said, is neither where the west begins nor where the east ends—but is sort of a hybrid.

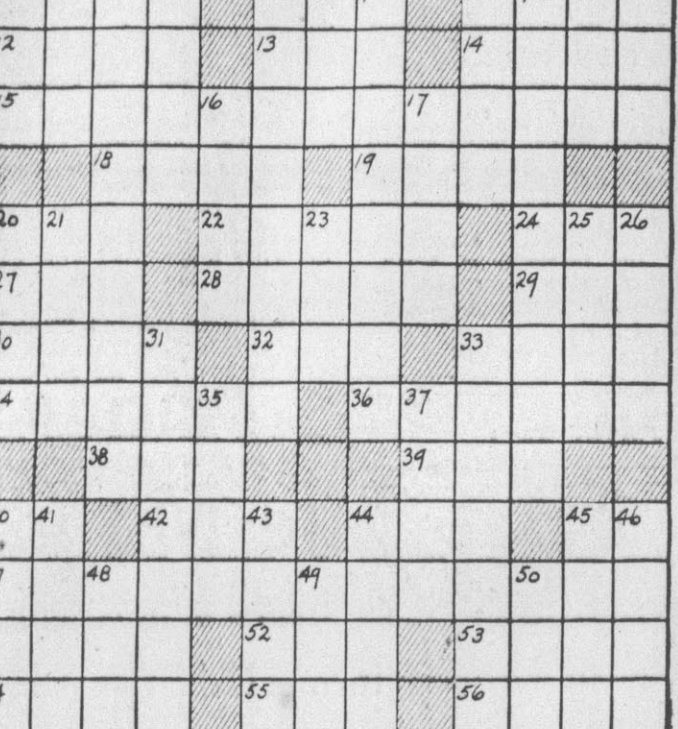

"Big Shots" Are Behind 4-Year Sheriffs' Term

Reflector Bureau
Raleigh, Sept. 27.—State Senator John D. Larkins, Jr., active head of the campaign for a Constitutional amendment extending Sheriffs' terms to four-years, seems to be lining up practically all the big shots of the political world in support of the movement.

Governor Clyde R. Hoey, Lieutenant Governor Wilkins P. Horton, Attorney General Harry McMullan, Congressman R. L. Doughton, Frank Hancock, Harold D. Cooley and Zebulon Weaver, Superior Court Judges A. Hall Johnston, J. Paul Frizzelle, Vernon Comper and N. A. Sinclair; and many others have endorsed the proposition and have recommended to the good will of the voters who will accept or reject it at the polls in November.

Despite this array of strength and talent on his side, however, the Jones county law maker is aware that he is battling several very ponderable factors and is letting no grass grow under his feet.

The same amendment was submitted to the voters in 1932 and at that time it won a majority vote in only seventeen of the state's one hundred counties. Of course, that year it didn't get the organized effort and advance work that is being put in for it this time. It failed, critics generally agree, as much the passivity of its opponents as the activity of its proponents.

"I realize that North Carolina voters, as a rule, are prone to vote 'No' to any Constitutional amendment unless it is made entirely clear to them that it ought to be adopted," said Senator Larkins. "And so that what we aim to do this time—let the voters know that conditions nowadays make it only just and right that the sheriffs of North Carolina shall serve four year, rather than two-year terms."

Aside from general indifference and a sort of inertia which tends to defeat any proposed amendment, the only active opposition to the proposal comes from "ward heelers" Senator Larkins said.

"There are in every county of the state, small fry politicians who virtually make a living out of politics. Of course they don't want to see elections for sheriff only held in four years. That would deprive them of almost half their livelihood," he commented. "We face the fact that there will be strong—and formidable—opposition from this source."

Under the amendment as it will be submitted this Fall, elections for county sheriffs, now mandatory every two years under the state Constitution, would be held in the "off" political years—that is, they would not be held in presidential and gubernatorial election year, but in 1942, 1946 and so on.

Senator Larkins believes that this spacing of the four-year terms answers the argument that the sheriff elections are needed in order to get out the vote—something that they undoubtedly do. He points to the fact that the races for President and Governor will always bring out the electorate in the years when these officers are chosen.

Support for the four-year term comes not only from counties either strongly Democratic or overwhelmingly Republican, but from the close counties as well, Senator Larkins declares.

"It doesn't seem to make any difference about the political complexion of the various counties," said Senator Larkins, "the thinking

people and politicians are to support the longer term."

The 17 counties carried for the 4-year term in 1932 were Clay, Jackson, Henderson, McDowell, Catawba, Gaston, Mecklenburg, Cabarrus, Rowan, Forsyth, Guilford, Alamance, New Hanover, Dare, Green, Edgecombe and Hertford.

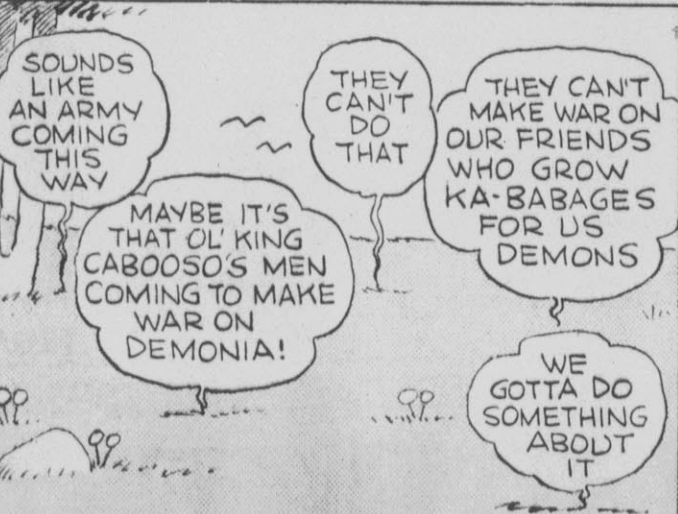

WHAT IT MEANS: Hitler's Claim to Sudetenland

Washington—Adolf Hitler used up an hour and a quarter and thousands of words at Nuremberg to keep the world on an uneasy seat, but to the statesmen of the great powers he spoke 26 subtle and special words.

"We would be sorry," he said toward the end of his address, "if our relations with other European states would become clouded or suffer from this demand for self-determination of Germans in Czechoslovakia."

"The German Brotherhood As one interpreter explained the German case, it's like this:

Everybody, everywhere must understand that the Germans are asking no more than justice for their Sudeten brothers. The Sudetens are Germans and have the right, even in the democratic tradition, to join the Fatherland.

And if they should rise up and demand that right, and should be subdued by Czech troops or police, the Fatherland would have to rescue them. But that would not be an act of aggression against a neighboring state. German soldiers would be risking their lives to protect their brother Germans.

That, said my analyst friend, would be violating the boundaries of an alien state, and it should never be done without provocation.

He went on to explain that Austria is wholly Germanic in historical boundaries, with few minority elements. It was a complete unit of the old German Empire in itself, and was intact, except for the Italian administered Tyrol. In taking it over, Hitler was simply wiping out a synthetic boundary.

World Opinion At Stake But Czechoslovakia is something else again. However synthetic its boundaries may be, it contains racial and historical elements that were never German in the remotest sense of the word. Therefore, once a nation "violates" a Czech boundary, the Czechs can claim before world opinion that their national integrity has been violated. They would be in a position of martyrs before world opinion.

"No," said my analyst friend, "Germany probably won't take the Sudeten territory of Czechoslovakia that way. If she is to act, Germany must be provoked into protecting the Sudetens against the Czechs. Before that provocation comes, Germany might even see her way clear to accept a Sudeten settlement."

"Violent protest would naturally arise within the Sudeten area. The Czechs could be accused of persecuting Sudetens and violating a sacred agreement. Germany then could act and explain to the world that she was provoked into action—as well as she might be from a strictly German point of view."

After Hitler's Nuremberg speech, I began to wonder if my analyst friend had not been reading Herr Hitler's mind all these months.

For certainly the Fuhrer spent most of his hour and a quarter under the glare of a world spotlight insisting that Germany had no desire to threaten the peace of the world unless provoked.

He went on to explain that Germany had forewarned revenge against France by giving up Alsace-Lorraine ones and for all

But, when it comes to Germanic people in Czechoslovakia—

"It is a matter of the Czechoslovak government's tarrance affairs with authorized representatives of the

Sudeten Germans and come to an understanding, one way or the other.

"However, it is my affairs, and yours, fellow citizens, to see to it that right not be turned into injustice... Germans in Czechoslovakia are neither defenseless nor left in the lurch. Let them note that."

As interpreters here see it, Hitler knows as well as anybody else that the world's great powers are not eager to sacrifice the lives of millions of their citizens in a war to keep 3,500,000 Germans in Czechoslovakia from joining 75,000,000 other Germans in Germany.

From the Hitler point of view, they ask, who knows what chance of violence may come along—perhaps something like the shooting of the two Sudetens after the

Hitler speech the other night? Would such an act provide an opportunity to bring the Sudetens into the German family in such a way that neither Great Britain nor France would feel required to fight.

In that event, German mastery over Central Europe would be within reach without the risk of a far second world war. That, as my analyst friend explains, it is what Hitler can afford to bide his time a while longer.

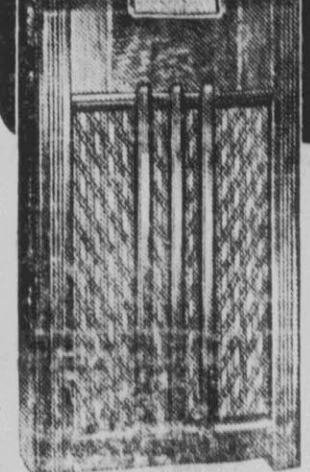
