PRESIDENT TO TALK TONIGHT ON NEW DEAL

To Discuss Legislation Passed in Last Five Years

SOCIAL SECURITY AMONG SUBJECTS

N. C. Tobacco Stemmers in Capital For Conference With Labor Dept. Officials

Hyde Park, Nov. 4.—(AP) President Roosevelt disclosed today he would discuss in his campaign speech tonight at 7:30 o'clock, EST, all New Deal legislation passed in the last five years.

He said it would cover the Wagner Labor Relations and Social Security acts, care of crippled and destitute children and other laws.

Asked if he was ready to discuss possible revision of the Wagner act in the light of expressed opposition to revision by the Labor Relations board, the President said every law needs improvement and always will.

In response to other questions, he said, while the federal administration could not be held responsible for coercion of WPA workers by either Democratic or Republican local politicians, it was making every effort to keep such coercion to a minimum.

All possible steps, he added, were being taken to keep local politicians and others from being mixed up in WPA.

At Washington, meanwhile, House investigators received testimony that an Ohio communist in "absolutely charge" of 1937 activities at Warren, Ohio, during the 1937 steel strike, appealed to John L. Lewis to have troops sent in to prevent dispersal of pickets.

Edgar Herzog, who said he joined the Communist party to learn "what it was all about," told the House committee investigating un-American activities that Gus Hall, also known as Arva Halberg, was "top man" at the Warren headquarters of the Steel Workers Organizing Committee.

Other Washington developments: The Senate Campaign Expenditures committee approved the action of Senator Van Nuys (D-Cal.), in turning over to the Indiana state committee \$2,492.15 contributed to his re-election campaign by 34 federal employees.

New York and Pennsylvania have led all states in obtaining outright gifts of 1938 PWA funds, applications for which close today. North Carolina ranks 13th, with an October recapitulation showing 160 projects, estimated cost \$28,817,430; PWA grants, \$12,966,649; and PWA loans, \$1,326,500.

North Carolina tobacco stemmers had an appointment with Labor Department officials to discuss the application of the fair labor standards act to the stemming industry employees.

Elmer Andrews, wage-hour administrator, said the appointment was made by James I. Miller, president of the James I. Miller Tobacco Company of Wilson, N. C.

Industry leaders are seeking exemption of tobacco stemmers from the fair labor standards act under a section exempting workers engaged in preparing agricultural commodities for the market.

Ayden Negro Farmer Grows Big Potatoes

H. F. Fleming, colored farmer of Ayden, route two, is quite proud of his record as a sweet potato grower, and has a right to be.

He brought one of his largest, weighing four pounds and 12 ounces, to Greenville today. The farmer said that his entire crop, of the Porto Rican brand, was large.

Fire Station

Mayor M. K. Blount revealed today that bids had been called for construction of the new central fire station to be located at the intersection of Fifth and Greens streets and proposals will be opened November 15.

Plans and specifications have been completed and approved for the building, to be erected with money approved at a bond election, supplemented by a PWA grant of 45 per cent of the total cost.

Mayor Blount stated that bids would be called for on the new City Hall as soon as plans and specifications are put in final shape and approved.

COOLEY TALKS HERE TONIGHT

Congressman To Address Democratic Rally at 8 P.M.

The general public and especially members of the Democratic party are invited to attend the rally at the court house tonight, at which time Congressman Harold Cooley of Nashville, will deliver the principal address.

Rep. Cooley is well-known in Greenville, having spoken here before and is regarded in this section as one of the state's most popular congressmen.

The meeting is being arranged by Dr. Paul E. Jones of Farmville, chairman of the Pitt County Democratic Executive Committee.

Rep. Cooley will be introduced by S. B. Underwood, Jr., president of the Young Democratic Club of the county, which organization is taking an active part in local and statewide politics.

Although Pitt county is overwhelmingly Democratic, Dr. Jones and other party leaders are urging a good attendance at tonight's rally. Members of the executive committee and county candidates were entertained by Dr. Jones at a dinner earlier in the week when plans for the rally and general campaign plans were discussed.

Withdraw Cut

Chicago, Nov. 4.—(AP)—J. J. Pelley, president of the Association of American Railroads, announced today the major roads of the nation would withdraw their proposal of a 15 per cent wage cut for nearly 1,000,000 workers.

Estimated \$3,000 Reported To Date

Assistant New York District Atty. Rosenbaum announces Admission of Three Suspects Following All-Night Questioning by Officials

New York, Nov. 4.—(AP)—An assistant district attorney announced today that four men, after being questioned all night, had confessed to two kidnappings and the kidnap-cremation of Arthur Fried, White Plains, N. Y., business man.

The assistant prosecutor, Joseph Rosenblum said the confession had been obtained from Stephen Saccoda a Sing Sing convict, D. Gula, 30, William Jacknis 27 and John Virsa, 34.

Rosenblum said they confessed to kidnaping Norman Miller 19; Benjamin Farber, Brooklyn business man, and Fried, who disappeared last December 4.

Rosenblum said the men confessed they killed Fried four days after kidnaping him and burned the body in the furnace of an east side social hall.

New York, Nov. 4.—(AP)—The district attorney's office today announced murder charges would be pressed against four alleged members of a "kidnap syndicate" accused of slaying Arthur Fried, White Plains business man, and kidnaping two Brooklyn residents who were released after ransom payments.

At the same time officials announced that part of a human jawbone with several teeth still intact had been found by police digging in the basement of Ukrainian hall, an East Side social establishment where one of the kidnapers said Fried's body was cremated in the furnace.

A quantity of bones unearthed yesterday were found to be those of animals.

Today's discovery started the police on an investigation of the possibility that an additional victim may have fallen prey to the gang.

Thirteen Cases In Recorder's Court

Thirteen cases were tried by Recorder L. C. Skinner in Municipal court this morning, defendants in eight being white persons and in five cases colored.

Colored defendants tried were Robert Harrington, drunk, cost or 30 days; Sue Moore, assault with a deadly weapon with intent to kill, bound over to Superior court under bond of \$200; William H. Ward, Zack Parker and Roberta Jenkins, engaging in riotous and disorderly conduct and assault; Parker and Jenkins acquitted, Ward convicted and ordered to pay \$100 in costs of court; Clifton Mills, assault and larceny from the person, not guilty of larceny, guilty as to assault and given 30 days or costs of court; Frank Johnston, engaging in disorderly conduct and assault, cost or 30 days.

Graham Register was acquitted of a vagrancy charge; S. T. Hicks was convicted of drunkenness and ordered to pay the costs or serve 30 days; Charles Landen was convicted of a similar charge and a similar judgment was meted out; B. E. McLawhorn was taxed with the costs upon conviction of being drunk and disorderly; Stonewall Mills was convicted of drunkenness and ordered to pay the costs or serve 30 days; A. A. Thompson was convicted of driving drunk and was fined \$50, taxed with costs and had months; Ester Clark and Pauline Griffin were acquitted of prostitution charges.

BRITAIN'S KING PRAISES MOVE OF ROOSEVELT

Monarch Terminates Session of Parliament with Speech

EXPRESSES HOPE FOR PEACE ERA

King George Warm in Praise for Roosevelt for Timely Action to Avert War

London, Nov. 4.—(AP)—King George, VI, terminated the present session of Parliament today with a prayerful hope that "a new era may have opened up for Europe" and warm praise for President Roosevelt's "timely action" to avert war in the time of crisis.

In a speech read in his absence during the closing moments of the first session of his reign, the monarch reviewed the grave events of September and declared:

"The cause of peace was powerfully aided by the timely action of the president of the United States of America.

"The desire of all peoples not to be drawn into a war with one another is manifest and significant and everywhere men and women share with me, I am convinced, the feeling of deep thankfulness that imminent peril was thus averted.

"I pray that with the passing of this peril a new era may have opened up for Europe.

The time-honored phrase "my relations with foreign powers continue to be friendly" took on new significance in the light of the four-power Munich accord partitioning Czechoslovakia.

The King described his "deep anxiety" during the Czech-German crisis. He spoke of Premier Mussolini's "valuable support" for Prime Minister Chamberlain's proposal to Chancellor Hitler for the conference of Italian, British, French and German statesmen.

The new parliament session opened Tuesday.

NO VERDICT IN MURDER TRIAL

Jury Still Deliberating Case at 3:30 This Afternoon

A Pitt county jury at 3:30 o'clock this afternoon still was deliberating the fate of two Negroes, Tommie Morgan and Henry Edwards charged with the slaying of another Negro, Macon Jordan, in the Fountain community.

The jury was given the case at the close of court yesterday afternoon, after Tuesday afternoon, Wednesday and Thursday had been devoted to the trial. The jurors started deliberations at 9:30 o'clock this morning.

Shortly after the luncheon recess this afternoon the foreman advised Judge J. Paul Frizzelle that the jury was unable to reach a verdict, but the jurist sent them back and told them to continue their deliberations.

The tribunal was expected to adjourn late this afternoon following a busy day.

Johnnie Jackson, Bill Aris, Sally Greene and Dick May were acquitted of a larceny charge. George Coward, indicted jointly with other defendants, pleaded guilty as charged and was given an eight-month road sentence.

Sylvester Newsom pleaded guilty to larceny and was placed under probation.

Funeral services for W. B. Quinerly 74, who died at his home in Ayden yesterday afternoon, were conducted at 3 o'clock this afternoon by Rev. Harry Jackson, Ayden Episcopal minister. Burial followed in the Ayden cemetery.

Active pallbearers were Jack Tucker, Herbert Quinerly, Jesse Quinerly, William Quinerly, Jack Chapman and W. B. Tyson.

Mr. Quinerly, who spent practically his entire life in Ayden, is survived by his wife, Mrs. Mary Elizabeth Tucker Quinerly; a son, Jack Quinerly of Ayden, a daughter, Mrs. William Alwyn Darden, of Greenville and a granddaughter, Miss Mary Darden Quinerly of Ayden.

Dozen Or More States Fighting Forest Fires

Hundreds of Fires Sweep Across Valuable Timberland

Hundreds of fires swept across drought-seared timber and prairie lands of more than a dozen states today.

The fire area extended from the Ohio river to the Gulf and from the Atlantic seaboard to sections west of the Mississippi.

On the fire lines were forest rangers, convicts, farmers CCC and WPA workers and volunteers. Some crews in Kentucky and West Virginia withdrew hurriedly last night to avoid being trapped by flames.

Rains checked the flames in some parts of the far-flung fire area, but in others stubborn blazes spread despite efforts by weary firefighters.

Fires dotted an area of 1,000 square miles in southern West Virginia, burning thousands of acres of timber, destroying valuable hay crops and sending up a blanket of smoke 9,000 feet in places. The fire epidemic was described as the worst in eight years. A call was issued for 2,000 men to assist 1,600 who have been at work two weeks.

In Kentucky numerous fires swept through 6,000 acres of timber in the Black Mountain region and threatened 8,000 more. A forecast of rain cheered fire wardens.

A forest fire which burned over 5,000 acres in Virginia advanced to within a quarter of a mile of St. Charles. Timber was damaged by fires near Chattanooga and Nashville, Tenn., and State Forester J. O. Hazard said the "whole Cumberland Mountain area was in a condition to burn."

To Crack Down on Parking Violators

Chief of Police George Clark declared today that all local police officers had been instructed to enforce the ordinance prohibiting parking in excess of one hour within the restricted zone.

His action followed that of the Board of Aldermen last night in authorizing the local police to enforce the law.

The restricted zone includes Evans street from Third to Five Points and Fifth street from Five Points to Read.

Chief Clark also said there were a number of local automobile owners who had not purchased city tags and added his men had been instructed to be on the alert for such cases.

Number of Proposals Taken up at Regular Monthly Meet

A Boy Scout patrol at schools, a library for colored citizens, the municipal stadium, renting the Hardee farm Bingo, auction sales, drainage, peddlers' license, paving curb and gutter and a city manager were among the topics discussed at last night's regular monthly meeting of the Greenville Board of Aldermen.

The board rescinded its order previously passed to erect a traffic blinker at the East Fifth street school and voted to appropriate \$100 for the purchase of uniforms for Boy Scout patrols.

Elizabeth Kearney appeared before the board to ask that consideration be given to the erection of a colored library here. Mrs. J.H.B. Moore and Mrs. E. W. Harvey also appeared in behalf of the project.

Representatives of the Virginia Steel company and the Peasden Steel company, contractors for the municipal stadium, discussed the making of the structure waterproof underneath and the extension of the wire in front of the stadium. The board also received a bid from the firms to extend the roof so as to protect spectators from possible rain. Passenger Liner Falls in Field of Channel Island Just After Taking Off for Port of Southampton; 9 Men, 4 Women, One Child Killed

St. Helier, Island of Jersey, Nov. 4.—(AP)—Fourteen persons were killed today in one of Britain's worst airplane disasters when a fully-loaded passenger airliner crashed in a field just after taking-off for Southampton, England.

The victims were nine men, four women and one child and included the pilot, Captain A. G. M. Cary, the wireless operator, 11 passengers and a man working in a field where the plane crashed.

The plane was on a regular run between Jersey, in the English channel, and Southampton.

The crash occurred at 10:52 a. m. (5:52 a. m. EST) shortly after the take-off from Jersey airport, which is several miles from St. Helier. The plane was seen to circle several times in the channel island in fog before falling into the field about 600 yards from the take-off.

It was a four motored plane named St. Catherine's Bay.

The only recent comparable disaster in Britain was the crash of a Netherlands airliner at Croydon airport December 9, 1936, when 14 persons were killed.

JAPANESE MAY SCRAP TREATY SIGNED BY U. S.

Spokesman for Foreign Office Says Action Considered

PACT REVEALED IN WASHINGTON

Hitherto Unannounced Memorandum Is Published by State Department

Tokyo, Nov. 4.—(AP)—The Japanese foreign office spokesman today announced that Japan was considering denunciation of the 1922 nine-power treaty, by which the United States, Japan and seven other powers pledged respect for China's independence and territorial integrity and promised efforts to maintain equal commercial opportunities in China.

Japan, he said, considers obsolete the agreement to which the United States is a signatory, and is examining a tri-power pact among Japan, Japanese-supported Manchoukuo and a new Chinese regime envisioning displacement of the Chiang Kai-Shek government. Japan believes negotiations with individual powers over interests in China are possible, however.

"Japan considers the nine-power pact obsolete," the spokesman said. "Whether we will denounce it or withdraw has not yet been decided. The government is examining the advantages of a tri-power pact."

Such a treaty ostensibly would guarantee Chinese territorial integrity upon completion of the present Chinese-Japanese war.

The Washington State Department published last night a hitherto unannounced memorandum saying results of a nine-power conference in Brussels last year was "the expressed serving of notice that the settlement of the Chinese-Japanese conflict ultimately arrived at must be consistent with the principles of the nine-power treaty and satisfactory to the conference powers."

Developments concerning foreign commercial interests in China furnish the background to the nine-power treaty problem.

She is survived by her husband; two daughters, Mrs. Ernest W. Hunt and Mrs. W. Roderic Harris; two sons, R. A. Fountain, Jr., and J. N. Fountain; and two brothers, Walter Newton and John Newton.

# ... ETIQUETTE ...

You're likely to get a very cold shoulder if you don't watch your cold weather manners.

The easiest way to nominate yourself for most-disliked member of a group is to go for fresh air in a great big way when nobody else in the house—or office—backs you up in your idiosyncrasy. And the quickest means of putting yourself in the worst graces of your favorite hostess is to tramp over her best rug in your galoshes or throw a snow-laden coat over her favorite chair.

Let's forget, when the mercury takes a sudden drop, here are a few cold-weather reminders:

Be careful to close doors behind you. One door left ajar carelessly can send room temperature to a low level in a few minutes. That goes for outside doors, storm doors and doors between rooms.

Don't insist on maintaining unusual temperatures. In rooms you share with others. Remember that 68 to 72 degrees is considered a comfortable temperature for most living quarters. If you go in for ice-weather take it where you can find it—out of doors. If you are susceptible to chills wear warmer clothing; don't try to keep a room so warm that everyone else sweats.

Keep sneezes to yourself. If you develop a bad cold stay away from others as much as possible. When you feel a sneeze coming on, prepare to catch it in your handkerchief.

Don't count on borrowing galoshes, raincoats or other wet weather accessories. Lay in your own supply—and distribute it between your office and your home so you won't be caught in an emergency. If you do have to borrow when a sudden storm comes up, return the borrowed property as soon as possible.

Hints to the weather-bound hostess:

Leave a broom outside the front door—so visitors can brush the snow off their feet.

four to five years on the roads.

Henry Hathaway tendered a plea of guilty to resisting arrest and was given a 12-months road sentence, with the court announcing that it would recommend a parole at the expiration of six months provided the defendant agree to abstain from the use of alcoholic beverages and otherwise show good behavior for five years.

Raleigh, Nov. 4—If memory serves it was Ethan Allen who made the historic remark when he was asked by what right he demanded the surrender of Fort Mifflin—"In the name of the Great Jehovah and the Continental Congress."

Now comes Chairman Will A. Lucas, of the State Board of Elections with an even terser declaration of authority, Republicans of the Sixth District wrote vigorously to demand why and how come the Democratic Congressional committee could name a candidate while the Republican ditto couldn't.

The incumbent and two former Federal District Attorneys are all appearing in the defalcation cases against E. B. Graham, of Dunn, and Enoch W. Wilson, Sampson county's Democratic Representative. Wilmington's J. O. Carr, currently the D. A., is prosecuting Irvin B. Tucker, defending Graham, and W. H. Fisher, appearing for Wilson, are both former District Attorneys during the Republican regimes of Coolidge and Hoover.

Robert Grady Johnson, penal division head was reported "in the east" Oscar Pitts was said to be "in the west" and Highway Chairman Frank Dunlap's whereabouts were unascertainable when news men wanted to ask questions about thefts from the Central Prison print shop.

It recalled the Mother Goose rhyme, "One flew east, one flew west, and one flew over the cuckoo's nest," though maybe the Messrs. Johnson, Pitts and Dunlap are not "geese."

North Carolina ranked fourth in the nation in number of total placements made by the State Employment Service in the month of August, according to the latest issue of the N. C. S. E. S. News.

Only Texas, California, Illinois and New York exceeded North Carolina in number of private placements made.

The figures: Total placements—Texas 34,903, California 21,023; Illinois 12,761; North Carolina 12,290, and Pennsylvania 10,665.

Private placements—Texas 27,662, California 16,956, Illinois 10,825, New York 10,692, North Carolina 9,501.

State Senator John D. Larkins, directing the campaign to increase Sheriff terms to four years by adoption of a Constitutional amendment next Tuesday, wasn't at all disturbed by the attack made on his plan at the Eighth District rally, when the Richmond county chairman bobbed up to say he thought the subject should not be made a party issue and should not take up time at Democratic rallies.

"I've been preaching all along that the amendment is not a partisan matter at all," said Senator Larkins. "It is getting as much support, proportionately, from Republicans as from Democrats. I have no desire to waste good Democratic time; but leaders of the party have been free in offering to let me speak at their rallies and I am very much obliged to them for the privilege."

A meeting of the North Carolina Council of Youth-Serving Agencies will be held at the Sir Walter Hotel here on November 10, it has been announced.

Chief Justice Walter P. Stacy will vote in the election next Tuesday by absentee ballot, cast in New Hanover his old home county.

# FARM'S LABOR - SAVING MACHINERY IN SIX PRETTY FARMING SISTERS

 Maxwell, Ia. (AP)—Of course it has pigs, and chickens, and cows, and 2 1/2 acres of good Iowa dirt, but the Pritchard farm here is mostly famous for its "seven pretty farming sisters."

Six daughters—the seventh has married and left home—provide the twelve hands that do all the chores and enable Flavius G. Pritchard to operate his big farm.

There's Billy, too—the son—but he's only 10. "They're good girls," Dad Pritchard says. "They're not alike, but they're all mighty fine girls."

The girls do all the housework, sewing, cooking, bed-making, the milking, chicken-raising and some of the plowing and field work.

Their grandfather came from his native Wales to settle in a log cabin on this very farm 62 years ago. Their mother died in 1935 of appendicitis.

That, says Dad Pritchard, was when the girls took over the work. They like it, too. Joan, 24, for instance, took business college work after she got out of high school and took a job in Des Moines. But she soon returned to the life she loves best—the farm.

Besides Joan and Billy, are Katherine, 16; Ila Mae, 14; Virginia, 22; Lois, 8, and Rosetta, 19. The married daughter is Bernice, 26.

It's not all work on the Pritchard farm. All the girls dance and they have a car at their disposal. Those of high school age all play on the girls' basketball team. They belong to a Methodist church, and Rosetta, too, is attending business college but living at the farm.

Dad Pritchard points proudly to the 352 chickens his girls raised from 356 baby chicks last spring. He has a lot of machinery, but he won't let the girls use it in the field for fear they might get hurt. They use horses to plow the corn. The big Pritchard farm is free of debt, now, although Dad Pritchard claims he "lost \$30,000" in the depression.

# SOCIAL and LOCAL

Writes Number of Articles.

Members of the college faculty have been interested to note recently an article by Dr. Denver E. Baughan in the September issue of "ELI" or "English Literary History." Dr. Baughan's article "Swift's Source of Houyhnhnms Reconsidered," examines the generally accepted foreign sources for the picture of the society of horses which Swift made such a bitter satire on human society, and rejects them in favor of an English source Sidney's "Defense of Poesie."

Other scholarly articles in the issue were written by men from Johns Hopkins, the University of Iowa, the University of Maine, and other universities.

Another article by Dr. Baughan, "Sir Philip Sidney and the Match-makers," is to be found in a fall number of the "Modern Language Review," a publication of the University of London.

Even in the short time since Dr. Baughan came to the East Carolina Teachers College faculty in 1936, he has done a considerable amount of writing. Last year's weekly book reviews to the Sunday "News and Observer," he completed and saw in print "Creative Writers, Inc.," which appeared in the Boston publication "Education," and "Shakespeare's Probable Confusion of the Two Romanos," published in the Journal of English and German Philology of the University of Illinois.

Dr. Baughan is a member of the English department at the college.

"The figures just compiled by the Forest Service show that while North Carolina has more acres of forest lands under protection than any of the ten southeastern and Gulf states the state also had a smaller number of acres burned over than any of these last year—something of which the state can rightly be proud," said McCormick.

## How's Your Health?

When Old Age Comes Mankind is prone to cover its want of knowledge with well-sounding phrases, not a few of which however do contain partial truths.

The Latin used to say Senectus ipsa morbus, old age is itself a disease. The moderns speak of men being as old as his arteries.

Old age is the normal effect of long life and cannot be construed as a disease save when senility develops prematurely, and, as far as the arteries are concerned, man does not live by them alone. There are other vital organs and structures, notably the brain and nervous system, that have a great influence upon the agelessness of the individual.

We do not as yet know what basically is the cause of old age, or to phrase it otherwise, what sets the limits of the body's growth, development and repair.

The old idea that the body contains just so much of vital energy which is expended during the years (anciently symbolized by the hourglass with its trickling sand) no longer is held valid. Strenuous living does not ordinarily lead to an early death. On the contrary, it appears as if "strenuous living generates the energy for life."

Perhaps some better insight into the problem of old age could be gained by using other criteria than the physical state of the body, or of any of its parts. The efficacy of the individual's life, the sustained integrity of his personality of his zest for living, could serve as a better index of the agelessness of the individual.

On the biological side, it is interesting, as Professor Ludwig Aschoff has pointed out, that natural death seldom if ever is observed. Death, in the opinion of Aschoff, is invariably the result of some morbid process.

The accumulated "assaults" which an individual suffers during his life appear to wear down some portion of his physical mechanism at one or more points of lowered resistance, and the ultimate disintegration of the mechanism is the result of a "break" at these sites.

Present day science however is not so much concerned with death as with that period of slow disintegration which is called senility. It is to the study of this problem that science is beginning to devote much of its energy.

# Carolina Leads South In Forest Fire Protection

Reflector Bureau, Raleigh, Nov. 2.—Following closely on heels of a forest fire which menaced Blowing Rock, comes announcement from the Department of Conservation and Development that last year North Carolina led all the southeastern and Gulf states in the matter of forest-fire reduction.

The state had the smallest acreage of forest fires of any of these states except Virginia and West Virginia, according to figures just compiled by the U. S. Forest Service. Assistant State Forester W. C. McCormick pointed out.

This record is considered even more remarkable when it is considered that North Carolina has 13,630,000 acres of forest land under organized state protection at a cost of only three-tenths cent per acre. Other states, with the exception of Alabama and Mississippi have been spending much more than this. McCormick said. North Carolina has about twice as many acres of forest lands under fire protection as Texas and Oklahoma, which have \$7,970,000 and 7,206,000 acres, respectively.

Only 181,090 acres of forest lands were burned over by forest fires in North Carolina during 1937, according to the Forest Service figures.

# BUDGET GROUP CONSERVATIVE

### Commission Members Studying Various Requests

Reflector Bureau.  
Raleigh, Nov. 4.—Nothing definite will be known for some time of decisions made by the advisory Budget Commission now studying requests for some \$95,000,000 in appropriations for the next biennium; but it is already as certain as anything human can be that these decisions will be conservative—perhaps ultra-conservative.

This conclusion is demanded by even a casual study of the commission's makeup. There isn't a "spender" on it. Each and every one of the half dozen budgeteers has already made a record which anyone who runs may read, and everyone of these records fairly reek of "economy" if not stinginess.

Arch pinchpenny of them all is Mecklenburg's Senator James A. Bell, only member of the Senate to vote against North Carolina's participation in the Social Security program. As chairman of Appropriations in 1937 he set a record of opposing practically every proposal to increase any sort of expenditure.

Not far behind him are Representatives D. L. Ward and Victor S. Bryant, who headed Appropriations and Finance, respectively, in the last House. Both strove with might and main to keep down state spending and as both are candidates for Speaker in 1939 they'll doubtless run more than ever toward the tightwad side.

Senators Jack Joyner and J. H. Clark of Bladen, likewise were listed among the "let's go slow" boys in 1937. They certainly haven't changed. The sole lay member—as opposed to legislative—is A. S. Brower, who is reputedly tarred with the same "economy" stick as the others. Senators Bell and Clark will not be back in the 1939 Assembly and so do not even have to bother about suiting the folks back home.

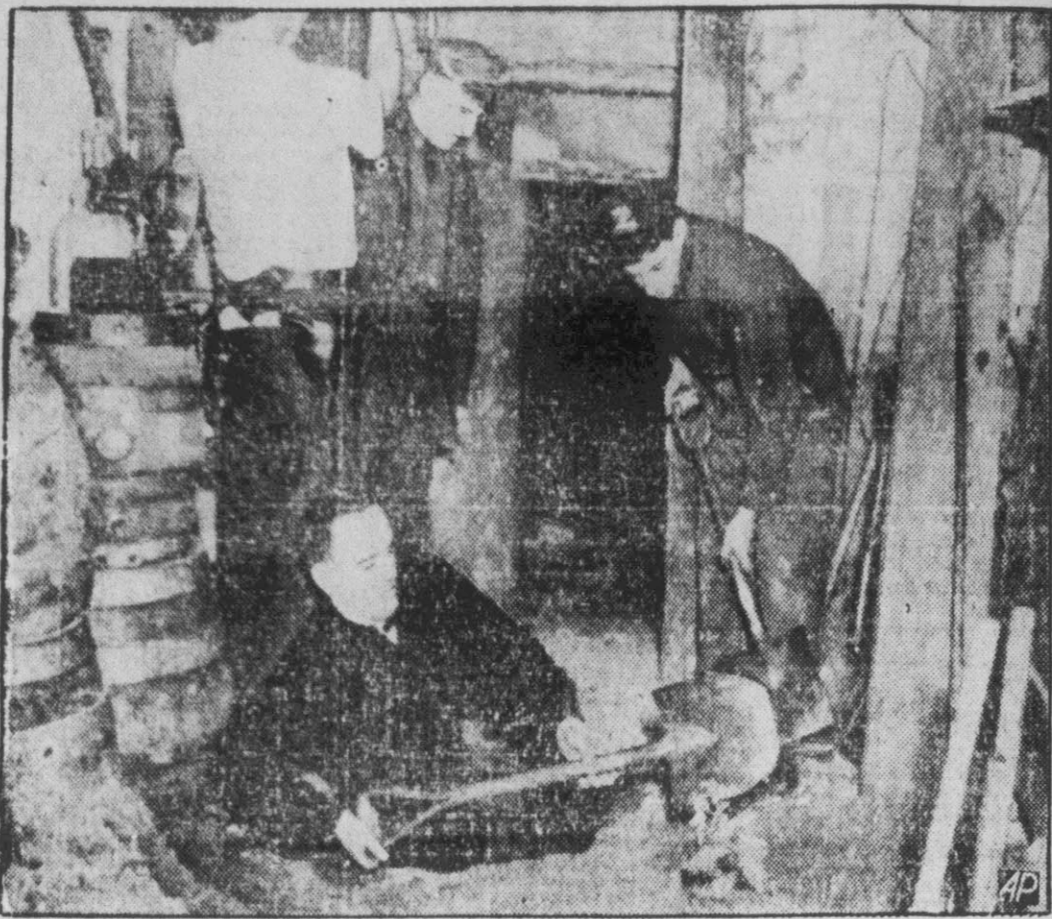
### SUGGESTS SUCKERS FOR NOISY MUSIC-AOVERS

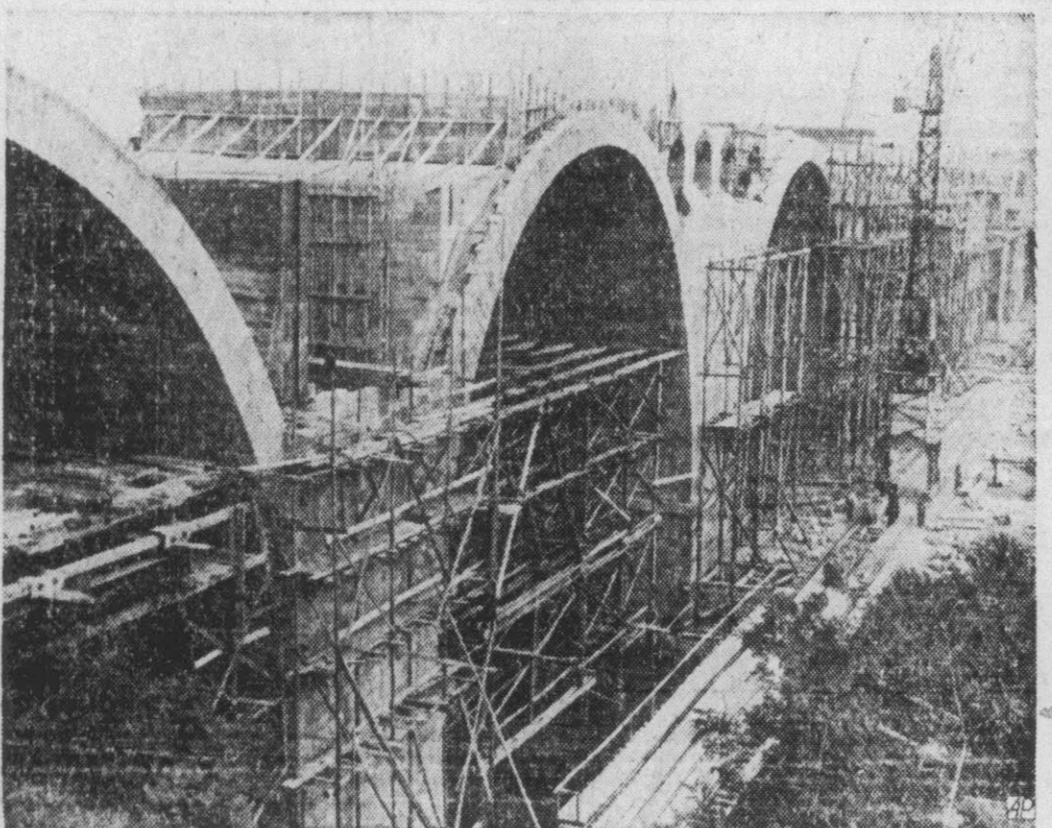

## HOCUTT PRODS SAFETY DRIVE

### Appeals for Efforts to "Keep Fifth Man Alive"

Reflector Bureau  
Raleigh, Nov. 4.—"Keep the fifth man alive." Ronald Hocutt, Director of the Highway Safety Division today appealed to motorists of North Carolina in an effort to pull down the usually super-heavy November and December traffic toll.

So far this year North Carolina has slightly bettered the national average of a twenty per cent fatality decrease and a uniform drop of that size means, Mr. Hocutt pointed out, that one out of every five persons doomed to die in traffic this year will be spared.

The goal is to keep pace with an unbroken reduction in traffic deaths that prevailed during the first three quarters of the year, with a resultant saving in the nation of 5-820 lives. North Carolina's share of these spared lives is slightly greater than proportionate to its population.

Mr. Hocutt issued his current appeal because of the fact that November and December are annually bugaboo months for traffic safety. Last year November traffic deaths in North Carolina totalled 112, in the nation, 3,750. In December 124 were killed in the state and 3,730 in the nation.

Over a five-year period the November toll was 29 per cent greater and the December 30 per cent greater. Reasons for this, Mr. Hocutt said, are bad weather, more hours of darkness and the Christmas holiday rush.

"This year, for the first time," he said, we have a fine chance of effecting really substantial reductions in traffic fatalities. Everything depends on this final two-month period—the period when we normally pile up huge death totals. Too many of us have felt that a steady increase in traffic toll was inevitable. We are now proving that it isn't.

Washington Daybook

Washington — On a quiet Friday afternoon when the capital was drifting into its week-end doldrums, Justice Brandeis leaned

across the high court bench and opened a line of questioning and argument that brought broad smiles to New Dealers in the court chambers and well nigh sent the conservative and mid-way elements of the court into convulsions.

This was the situation: In 1933 the department of agriculture held that livestock commissioners in the Kansas City stockyards were charging excessive

The commissioners won a decision—the supreme court holding that the secretary of agriculture had erred in his method of arriving at the lower schedule of rates. The court found that the commissioners had not been given a fair hearing so the new schedule was held invalid. If that ruling held, the commissioners would get the impounded half million. But the department argued that the money should be returned to the farmers who had paid the fees in the first place. So, it came to the Supreme court again with a new appeal. This time the department argued that it should be allowed to correct the error. Why not hold hearings at which the commissioners could present their case? That would give the department an opportunity to legalize its schedule of rates.

Frederick H. Wood, of New York, attorney for the commissioners, denounced such a procedure. The department made a mistake in fixing the rates, didn't it? The commissioners should be entitled to the impounded moneys, shouldn't they?

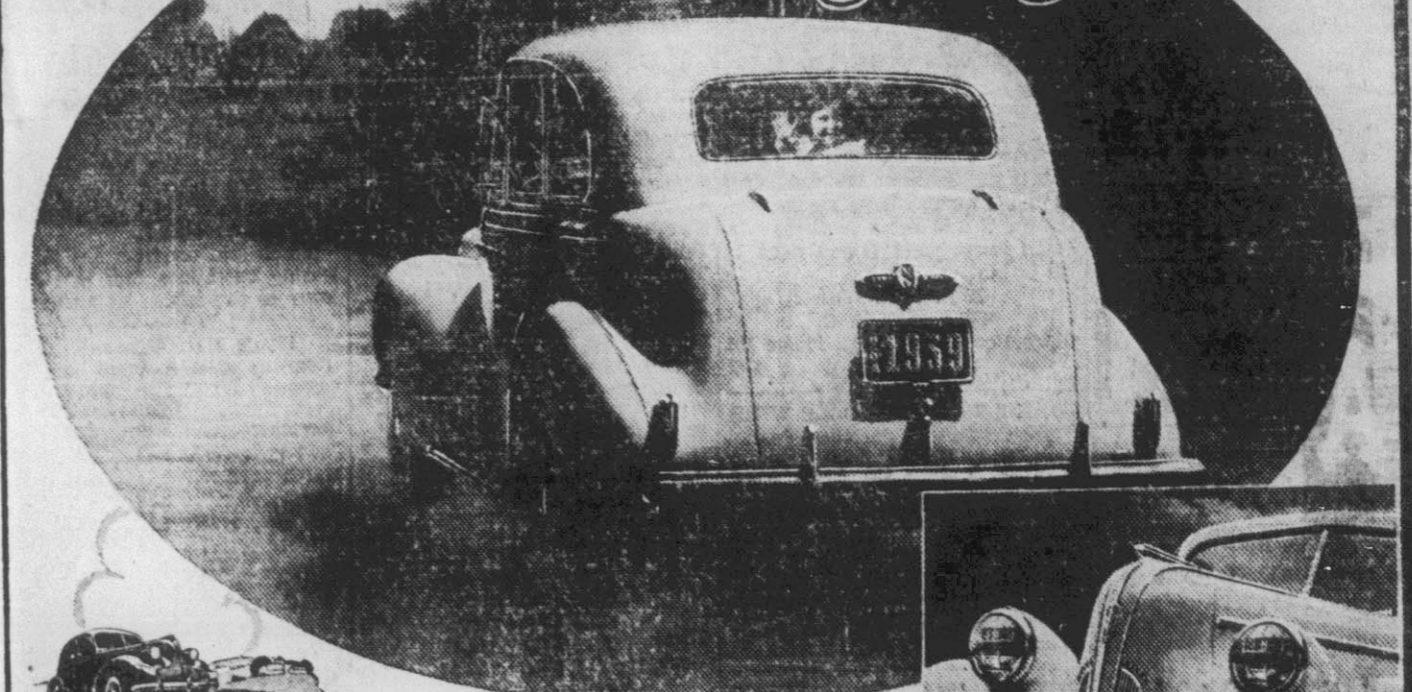

## COONS PICKS "CITADEL" AS BEST; CALLS DONAT STAR-OF-THE-MONTH

Hollywood—This is probably all wrong. It's practically a rule in this town that a movie that's colossal automatically is a movie that's best. A movie that's a spectacle is a cinch for first place.  
But somehow this department, despite two "colossals" ("Men With Wings" and "Suez") is going overboard for "The Citadel."  
I like it first because it has a story to tell—and a significant story. A. J. Cronin's authorship is practically a guarantee.  
I like it for its acting. Robert Donat's performance is different from—and tops—his work as "The Count of Monte Cristo." There's a splendid and sympathetic role for Rosalind Russell who is due for new attention because of it.  
**Had Expert Directing**  
And I like it for its direction by King Vidor, who incorporated a wealth of telling and touching inci- dents, who lost no opportunity for dramatic effects in a (neces- sarily) rather talky film.  
Its title, "The Citadel," refers to the unseen goal toward which

medical men, as the hero sees it, should be working.  
When Andrew (Donat) goes to the mining center of Blaenelly to serve as a medical assistant, he soon bumps into the prevailing system which makes the doctor dependent upon a miners' individ- ual whims for his fees.  
**Meets Obstacles**  
Half-starved and fuming at his helplessness to improve conditions. He moves to another post. Before he goes, however, he blows up—with the help of practical hard- drinking Denny (Richardson)—a leaking sewer which has caused a typhoid epidemic.  
At the new post, he meets prac- tically the same obstacles. The position called for a benedict, and the scenes of Andrew's quick courtship of Christine (Miss Rus- sell) are most amusing. With his new wife he undertakes serious research on the miners' coughing spells. But here, too, because the miners are boss and do not toler- ate such goings-on, he is frustra- ted and resigns in disgust.  
**Drops Principles**  
After hopefully hanging out his

sign in London, he and Christine starve until events lead him into the charmed circle of "society doc- tors." They show him the way to easy money and plenty of it.  
Little by little Andrew—galled by past failures—joins these money sucking parasites. Loyal Christine looks on in dismay. In the end, he returns to his high principles, flays the sycomophants, fights for his own right to practice and calls for a professional "house cleaning."
