WIDE INTEREST EVIDENCED IN OFF-YEAR VOTE

Candidates Throughout Nation Press Toward Climax

PREDICT RECORD VOTING TUESDAY

Roosevelt Heard Last Night; Hoover And Hamilton to Broadcast Tonight

(By The Associated Press) Candidates throughout the nation pressed today toward a thunderous climax to the most intense and vote-rousing off-year election campaign in national history.

The great popular interest reflected in predictions of an unprecedented ballot total Tuesday, spurred Republican and Democratic leaders in their efforts to turn the tides of victories in scores of apparently tight races.

President Roosevelt brought the national campaign of the Democrats to its peak last night by broadcasting an appeal for continued "liberal government."

Former President Hoover and National Chairman John Hamilton will speak for the Republicans tonight. Hoover's broadcast to a Spokane, Wash., Republican rally will be broadcast from 9 until 10 p. m. EST, over the Mutual network. Hamilton will speak over the Red network of NBC from 10 until 10:30 p. m. EST.

Mr. Roosevelt spoke from his Hyde Park, N. Y., home and as a citizen of his native state. He endorsed the Democratic candidacies of Governor Lehman and Senator Wagner, both seeking re-election, and Rep. Senate vacancy created by the death of Senator Royal Copeland.

Only once did he discuss specific candidates outside of New York State. Then he spoke warm words of praise for the way Gov. Frank Murphy of Michigan handled the Michigan automobile strikes in 1937. Murphy is opposed for re-election by Frank Fitzgerald, Republican nominee.

New York, Nov. 5.—(AP)—President Roosevelt's address last night in support of the New York State Democratic ticket was described as "devastating" to Republican chances today by National and State Chairmen James Farley.

"I believe it was the best speech I ever heard the President deliver," Farley said. And so far as Mr. Dewey and the Republicans are concerned it was devastating.

One Auto Stolen; Another Is Burned

Mrs. N. O. VanNortwick's automobile was pushed from the garage and stolen last night, and that of J. Hicks Corey, who lives only two doors from the VanNortwicks, was damaged by fire.

The belief was expressed that the same persons were responsible for both acts.

Mr. Corey was advised by his cook upon her arrival about 7 o'clock that his car was on fire. The upholstery of both the front and back seats was smoldering. Mr. Corey and firemen were at a loss to explain how the fire started unless a cigarette possibly tossed in the vehicle by a passer-by last night had smoldered in the upholstery all night.

When it was discovered that Mrs. VanNortwick's car was stolen, however, the theory was advanced that an effort had been made to steal Mr. Corey's car, but the ignition switch also locks the steering wheel and the would-be robbers were unable to make any headway. Mr. Corey lives at 305 Library street.

Mrs. VanNortwick's car had not been recovered this afternoon.

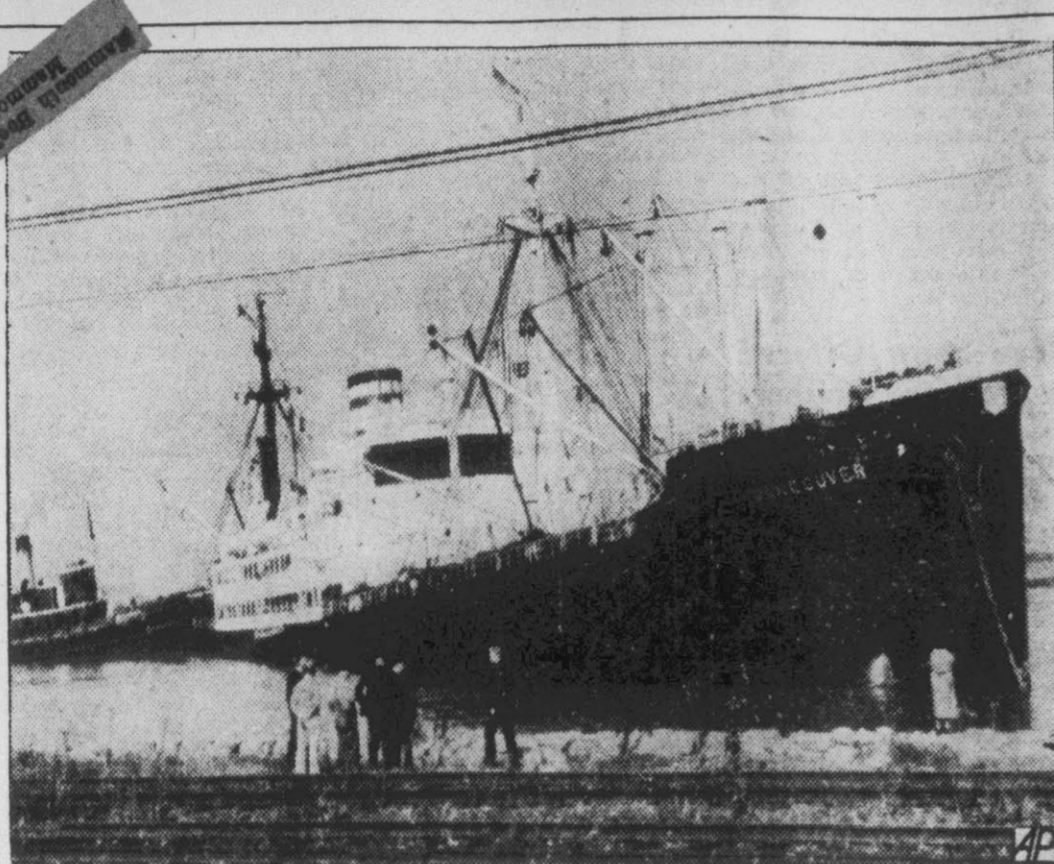
Freighter Taken

Emden, Germany, Nov. 5.—(AP)—Authoritative sources said today a Spanish government freighter had been captured in the North Sea by the Spanish insurgent auxiliary cruiser Cinday de Alicante.

The crew of the merchant ship was said to have been imprisoned and the seized ship brought to port here with an insurgent crew.

(This is the second attack within a week by a Spanish insurgent man-of-war on a Spanish government merchant vessel in the North Sea. The freighter Cartabaria, under charter to British operators, was bombarded and sunk by an insurgent armed auxiliary cruiser Wednesday within sight of England's east coast.)

MYSTERIOUS BLAST SINKS GERMAN SHIP

ANTI-CONTROL GROUP IN MEET

Talmadge assails Administration's Farm, Relief Policies

Raleigh, Nov. 5.—(AP)—Eugene Talmadge, former Governor of Georgia, brought a pastboard box of commodities to Raleigh today to show a farmer audience that while the United States was curtailing its products, the nation was importing large quantities from abroad.

Holding aloft a can of roast beef a rug and various textile products, all he said, made abroad, Talmadge asserted that "while our own laws forced our women into sewing rooms we American people buy products of the hands of women in Japan."

Talmadge assailed the administration's relief and farm policies in a speech at a meeting of the state anti-compulsory crop control association, attended by about 500 farmers.

Later the farmers adopted a resolution asking that the Secretary of Agriculture be asked to refrain from calling a referendum on crop control and expressing opposition to "any further compulsory crop control or any further compulsory legislation."

Miniature Chair On Display Here

A miniature hand-made, high-back straight chair, made by Greene Letchworth approximately 60 years ago for his first grandchild, Thomas Letchworth, was brought to the city today by Mrs. Charles McArthur of Bell Arthur, and left at the offices of The Daily Reflector to be placed on display.

Mr. Letchworth is known to have made at least five of these toy chairs, one for the first-born of each of his sons and daughters.

The chairs are hand carved and only wooden pegs are used. A regular split-bottom, common in that day, was used.

Cells Suggested For Prison Camp

The Pata County Grand Jury, in its report at the close of this week's session of Criminal court yesterday took notice of the recent escapes at the prison camp and recommended that the present type of buildings be re-built into cells on the inside, instead of the present dormitory style, which permits the too free intercourse between the prisoners.

The Grand Jury, of which J. Hicks Corey is foreman, reported that it had visited the county offices and "so far as we could determine" found them in first class condition. The books and records of the auditor's office were especially commended as a "fine example of capable and efficient work."

Flat 50 Per Cent Exemption Refused by Administrator

Washington, Nov. 5.—(AP)—The wage-hour administration said today it was preparing a basis for determining exemptions for tobacco stemmers from provisions of the fair labor standards act.

Wage-Hour Administrator Elmer Andrews has refused to a flat 50 per cent exemption sought by tobacco dealers and has held that each exemption "as a handicap workers must be justified on its own merits."

The administration said M. D. Vincent, chief of the hearings and exemptions section, was drawing up a report on what tobacco men would have to show in the way of physical or other handicaps in order to obtain temporary exemptions.

The report will cover leaf tobacco dealers, packers and re-dryers in Virginia, North Carolina and Kentucky.

The administration said that during its discussions with tobacco dealers "it became apparent that the 15,000 stemmers laid off coincidental with the effective date of the wage and hour act would have been laid off anyhow, because the peak of the stemming period for flue-cured tobacco had been passed."

No Final Figures In Drive Available

Due to any number of malterials reasons a final Community Chest 1938 Campaign report is not ready it was learned today. Certain "follow up" work is being done in the mean time.

Concentrating all the solicitations into four days finds those having done the soliciting waiting until the four days are over to make their reports and some others were too busy through the days of the campaign to do their soliciting, so will do it in the near future. But all this makes a final 1938 drive report impossible.

The Federal Surplus Commodities Corporation has been authorized to purchase an additional 33,000,000 pounds of butter during the fiscal year.

END CRIMINAL SESSION HERE

Large Number Cases Removed from Calendar This Week

This week's session of Superior court was completed late yesterday afternoon after a large number of cases had been removed from the docket despite the fact practically all of two and a half days were devoted to a murder trial in which the jury was unable to reach a verdict and the usual procedure of withdrawing a juror was ordered and a mistrial declared.

The two defendants in the murder case were Tommy Morgan and Henry Edwards. The trial started Tuesday afternoon and was not given the jury until Thursday at the close of court. A few submissions were heard meantime.

The pair was accused of slaying Macon Jordan. The two contended the shot in self defense.

A. J. Jones, 19 and Paul Hill, Jr., 15—pleaded guilty to breaking, entering and larceny and were placed on probation. J. Sam Fleming and C. R. Fleming were freed of receiving stolen property knowing it to be stolen by a directed verdict.

After pleading guilty to irregularities in his funds at the State Bank and Trust company, J. R. Gaskins ordered to pay the costs of court and prayer for judgment was continued and the defendant placed on probation. Several of Greenville's most prominent citizens declared the defendant had a good reputation.

John Moore withdrew an appeal in an assault charge and the case was settled in Farmville court.

Richard Ross and Jarvis Tyson, Farmville Negroes, pleaded guilty to charges of mutual assault with a deadly weapon and each was given a 12 months sentence, suspended upon payment of costs and on further condition they remain of good behavior.

John "Geech" Wesson, local Negro, conducted his own case on a charge of larceny from the person and was acquitted by a jury.

Johnnie Gray pleaded guilty to breaking, entering, etc., and was given a two-year road sentence. (Continued on page five)

TO CONFER ON ANOTHER PLAN AID RAILROADS

Labor and Management to Consider Proposals

CHIEF EXECUTIVE TO GIVE SUPPORT

Heads of Major Lines Decide to Drop Proposal for 15 Per Cent Cut in Wages

Washington, Nov. 5.—(AP)—Railroad labor and management, their wage quarrel composed and a strike threat dispelled, will confer here Monday on proposals for legislation to rehabilitate the carriers.

President Roosevelt gave assurance of his support for an effort to "put through a constructive program of legislation at the next session of Congress."

Executives of the major roads decided yesterday at Chicago to drop their proposal for a 15 per cent wage cut. Nearly one million workers had voted to strike rather than accept it.

J. J. Pelley, president of the Association of American Railroads, notified Mr. Roosevelt that the action was taken because rail management officials "recognize the gravity of this situation and because they hope that out of it will come, through cooperation of all concerned, a sounder and more equitable policy."

Other developments included: The administration's decision to re-open the New Orleans navy yard, inoperative since 1921, gave fresh indications that the "temporary" Atlantic squadron created last September might become a permanent sea force.

Massachusetts went to the front in the race of four tax-hungry states which claim Col. Edward Green as their own when he died and left a \$36,000,000 estate.

A special master recommended to the Supreme Court that Massachusetts be decreed as Green's legal domicile, giving it the right to collect a \$4,947,008 levy if the court concurs.

Next Criminal Court Is Set For January

With the completion of a criminal term of Pitt Superior court here late yesterday afternoon, that tribunal wound up its criminal hearings for the year. The next session of criminal is scheduled for January.

A civil term, however, is scheduled for the week of November 21.

Judge Dink James has announced that the regular session of county court scheduled for Tuesday would be held on Wednesday since Tuesday is election day.

Sum of Money Stolen From Sheriff's Clerk

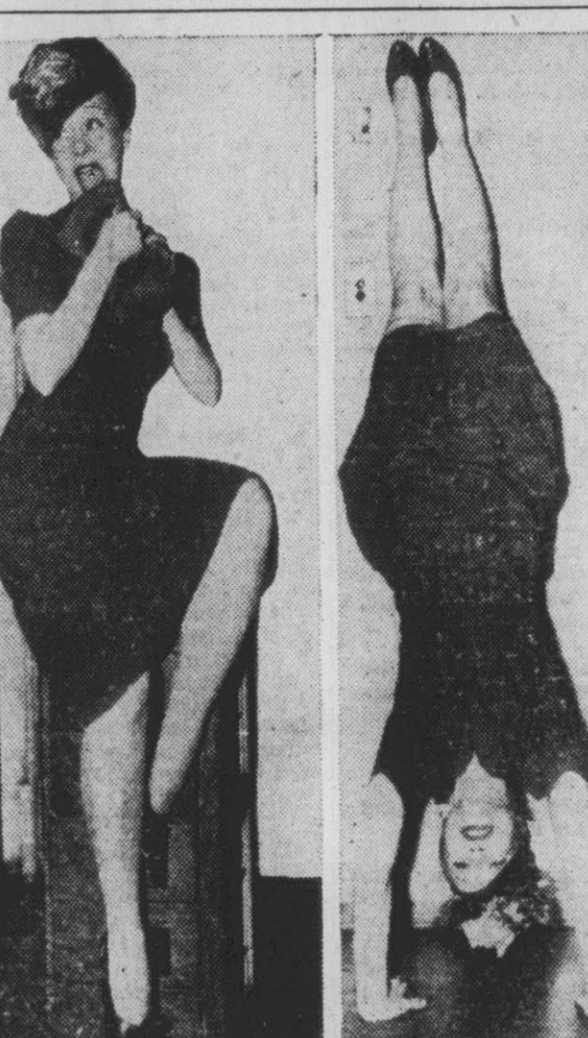
Sheriff J. Knott Proctor and his deputies had no further to go than to their own offices to investigate a robbery.

Rep. Cooley Addresses Pitt Democratic Rally

Congressman And Other Speakers Call For Big Vote

Congressman Harold D. Cooley, addressing a comparatively small crowd of Democrats at a party rally at the court house here last night urged every member of the party to go to the polls next Tuesday and cast his or her ballot.

Rep. Cooley declared that every Democrat should take pride in exercising his privilege of voting and added that "you owe it to yourselves, your family, your children and to your fine public servants" to get up early and go to the polls.

The speaker remarked at the start of his address that someone had apologized for the small crowd, but declared that did not bother him. "I like to talk to Democrats, regardless of the number," he declared, saying that he started his oratorical career before a one-man audience—a justice of the peace.

The Congressman brought his speech to a climax with a general discussion of farm program. "I do not know how you stand on control, but I have never asked a farmer to vote for control, but I have no apologies to make for helping write the 1938 farm program."

Declaring that we hear so much about surplus, the speaker declared that we had no surplus crops—only an abundance. "I feel certain that there is someone, somewhere who needs ever loaf of bread that our wheat crop can produce and the warmth of every garment that can be made from our cotton crop."

He added that until this abundance can be distributed we must make some effort to let the farmer control his own business.

The Congressman said he did not think the bill was perfect, "nor would I say the Democratic record is perfect," but, he continued, something had been done to try to help the farmer. He assured his listeners that any suggestions would be given consideration. He said the farm control act was not administered as he thought it would be, but (Continued on page five)

ELECTION LAW IS EXPLAINED

Election Board Chairman Harrell Reveals Letter

J. H. Harrell, chairman of the Pitt County Board of Elections, today issued an interpretation of the election law as outlined in a letter from the Attorney General to Raymond C. Maxwell, executive secretary of the State board.

Chairman Harrell called attention to the hours of voting in next Tuesday's general elections. The polls will be open from sunrise to sunset. The new act providing for the polls to close at 7 o'clock, if sunset follows that hour applies only to primaries, he explained.

The registration books closed last Saturday, after only a comparatively few new registrations:

1. On the official ballot, if the voter desires to vote a straight ticket, or, in other words, for each and every candidate of one party for whatever office nominated, the voter can do this by marking in the circle below the name of the party at the head of the ticket.

2. If a voter desires to vote a mixed ticket, or, in other words, for candidates of different parties, the voter is required to make a cross mark in the voting square opposite the name of each candidate for whom he wishes to vote, on whatever ticket he may be. If a voter makes a cross mark in the voting square opposite the name of any one candidate, he must proceed to mark in the voting square opposite the name of every other candidate for whom he wishes to vote.

3. If a voter makes a cross mark opposite the name of any candidate on the Democratic ticket or on the Republican ticket, the mark in the party circle at the top of the ballot (Continued on Page Two)

HUNGARY GETS ANOTHER SLICE OF TERRITORY

Troops Cross Danube At Exact Scheduled Moment

ACTION CHEERED BY HUNGARIANS

Territory Awarded to Hungary by German and Italian Mediators last Wednesday

Budapest, Nov. 5.—(AP)—Hungarian troops crossed the Danube river on pontoon bridges exactly on the scheduled second today to start occupying another slice of dismembered Czechoslovakia.

While the rest of Hungary, which has awaited this movement since she lost the territory after the World War, called the day her "national resurrection." The soldiers entered the ceded area totaling some 4,875 square miles, at 10 a. m. (4 a. m. EST, north of Altenburg, Hungary. The first step was occupation of the town of Little Schuetz, near the former Czech community of Doborogas.

Hungarian residents of the region came to cheer the regiment of infantry which was first to cross the improvised bridge. The infantrymen were followed closely by cavalry and artillery units, while overhead a dozen Hungarian airplanes circled.

The territory was awarded Hungary by German and Italian mediators last Wednesday. The four-power peace of Munich September 29 and subsequent minorities concessions cost Czechoslovakia about 16,165 square miles, or which 10,885 square miles went to Germany, 405 to Poland and 4,875 to Hungary.

Revival Closes At Free Will Baptist

The fifteen-day series of revival services at the Free Will Baptist church came to a close last night with continued capacity audience. Rev. Chester Pelt, the evangelist and new pastor, spoke on "The Reality of Hell."

Rev. Mr. Pelt declared that "Men do not go to Hell simply because they are bad. Neither do they go to Heaven because they were good. Men go to Heaven because they receive Christ as their personal saviour, and they that go to Hell go because they reject Christ as their personal saviour. Christ himself said 'I am the way, the truth, and the life: no man cometh unto the Father but by me.'"—John 14:6.

The evangelist took his message from Luke 16; 19-31. Special music was given by Mrs. J. C. Moyer of Snow Hill, and by the local quartet composed of E. D. Griffin, W. F. Owens, Chester Pelt, and S. M. Walters.

Thirteen additions to the church were made during the revival. Leaders of the church last night said they believe much good had been accomplished in the community. Appreciation was expressed for the co-operation shown by other congregations.

Schools To Have Student Patrols

The School Safety Patrol, composed of students at the various schools in the city, was organized here yesterday afternoon by F. E. Fox, safety engineer for the Carolina Motor Club, assisted by Corporal L. L. Jackson of the State Highway Patrol, City Motorcycle Patrolman H. E. Wooten, Superintendent of Schools J. H. Rose and members of the high school faculty.

Sixty-four boys were enrolled in the patrol, for which captains and lieutenants were chosen for each of the four white schools in the city. The 64 youths make up six complete patrols with half enough boys for an additional unit.

Mr. Fox said it was hoped the patrol would be extended to include the Negro schools at a later date. The School Safety Patrol had its inception at Chicago in 1921 with

the announced purpose of protecting schoolmates at the curb, permitting them to cross only at intersections, and only during a lull in traffic. Patrol members are taught to direct pedestrian, not vehicular traffic.

The patrol was brought to North Carolina in 1922 by the Carolina Motor Club and now units are organized in most of the large cities of the state, and in many of the smaller communities. It is operating in 3,000 cities in the United States, with approximately 275,000 boys and girls enlisted for service. An estimated 10,000,000 children are protected every school day by patrol members.

Pioneering Big Election Factor Babson Says "Ham and Eggs" Proposal a Menace to National Security

Babson Park, Mass., Nov. 4.—Next Tuesday a new force in American politics will elect and defeat many candidates. From Maine to California the old age pension supporters will swing the balance in many a tight contest. Graft, dolos, and unneeded relief are a bad enough burden for the nation to carry. But the political exploiting of these fantastic pension schemes is a real menace to the nation's security. Every one of the ideas—from the original Townsend scheme to the current Ham-and-Eggs-for-California version—could give us a period of wild inflation and end up by bankrupting the nation.

Quoted Without Consent Armed, however, with quotations from prominent economists, the managers of these pension schemes build up a terrific following. I find, for instance, that I am quoted

on the subject of increasing the velocity of money in the "Bible" describing "Life Begins at Fifty for Californians." So right here let me say that I have been quoted without my knowledge or consent and that I am 100 per cent opposed to the "Ham and Eggs" and similar pension schemes.

All voters have to do is look at Alberta and Colorado. Alberta was elected three years ago in Alberta and gives everyone \$25 a month. The plan was a "bust" and the Province has been in trouble ever since. After a year's experience Colorado is now ready to quit. Revenues which should be going to schools, highways, hospitals, jails, and to the really needy among the aged are being paid to everyone over 65 whether needy or not. The (Continued on page five)

will not be counted but the voter must thereupon indicate by a cross mark opposite the name of every other candidate of his choice in the election.

4. If a voter desires to vote for a person whose name does not appear on the ticket, he can substitute a name by writing it in with a pencil or pen in the blank space provided therefor. If the name is written in under the name of the candidate whose name was printed on the ballot, and the voter desires to substitute the name of the candidate written in for the name of the candidate printed thereon, the voter should strike out the printed name. If the voter desires then to vote for the straight ticket of the party, including the name of the candidate substituted, the voter may do so by making a cross mark in the circle at the top of the ticket of the party of the candidate for whose name the substitution was made. It is not necessary that the voter make a cross mark in the voting square opposite the name of the candidate whose name is written in, if the voter desires to vote the straight ticket of that party and makes a cross mark in the circle at the head of the ticket. If the voter, however, makes a mark opposite the name of the candidate so written in on the ballot, he should proceed to make a mark in the voting square opposite the names of all other candidates for whom he wishes to vote.

5. In substituting the name of a candidate by writing in the name on the ballot, no stickers can be used and the name cannot be substituted by a rubber stamp or any other way except by writing it in with pen and ink or pencil at the proper place on the ballot.

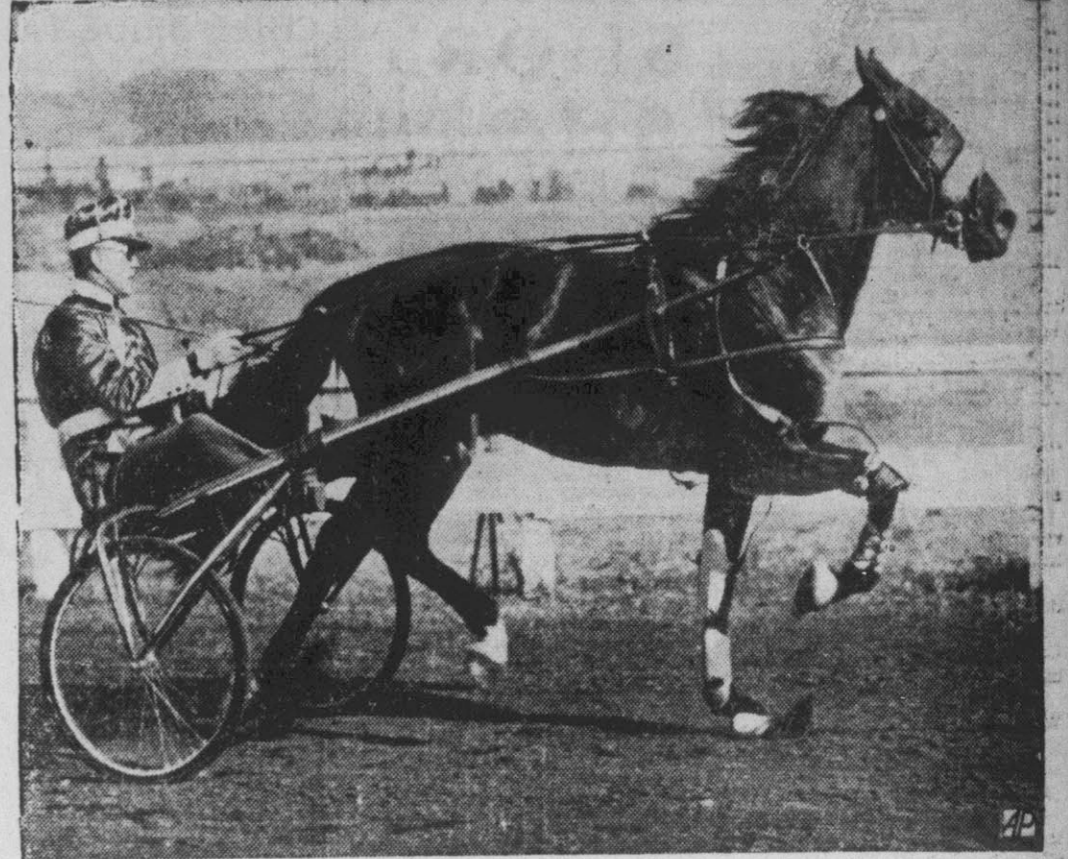

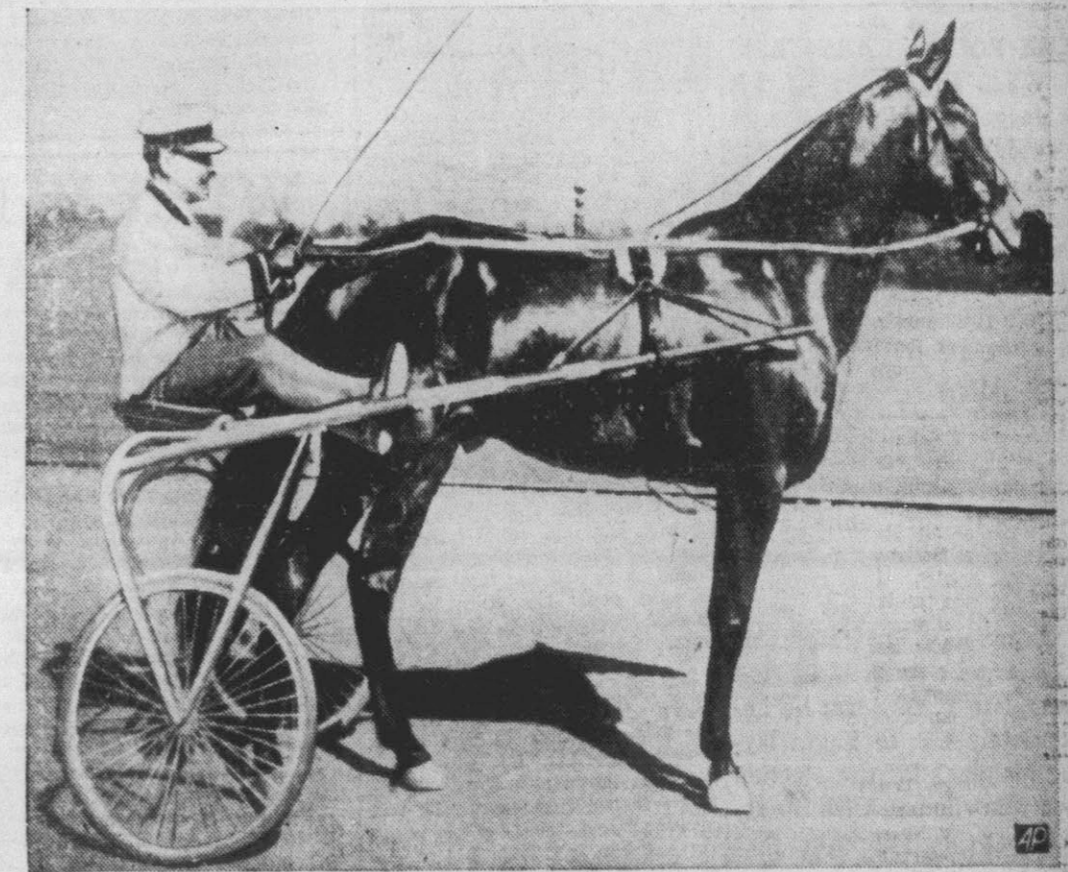

THE FOUR YEARS TERM

When the voters of this state go to the polls next Tuesday they will have the opportunity to vote for or against the constitutional amendment that would give sheriffs and coroners in this state a four years term of office instead of a two-year term. Already several of the constitutional officers are for the four years instead of the two years term, and it is our opinion that it would be far better if all the offices were for four years.

Experience has taught us that when a man is elected for a two years term he immediately has to begin laying his plans for the election two years hence, with the result that time and effort that should be used in the carrying out of the duties of office are necessarily devoted to the political angle of holding on to the office. The longer term, we believe, would result in more efficient service in office.

What is true of the county offices we believe likewise to be true in the case of state and federal offices. We believe that we would be far better off if all our officials including legislators and congressmen were elected for a term of four years, eliminating altogether the present system of off-year elections. Such a step naturally might work a hardship on the petty politicians who thrive on the biennial opportunity to suck the candidate for every nickel they can get out of them, but in the end we believe that more efficiency in office would be the result.

No doubt the change in the present legislative term is a far off dream but at least our people have the opportunity now to vote to extend the terms of sheriff and coroner to conform to the four year terms of the other constitutional officers.

SHORT SHOTS

Raleigh, Nov. 5—Revocation of 97 driver's licenses this week brought to 19,300 the total taken away in North Carolina under the revocation act.

An unusual feature of the week's record: Two licenses were revoked for manslaughter. The licenses of only two women were revoked, the women and the manslaughter revocations went together. That is to say, the only two women whose permits to drive were taken away were the only two drivers of any sex found to have committed manslaughter.

Driving drunk fell just slightly short of its usual tremendous percentage of all revocation causes, but still managed to do right well with 89 out of the total of 97, or something over 91 per cent.

There were four cases of hit-and-run driving hits, one each of reckless driving, second offense, and of obtaining license by false and untrue statements.

The women whose permits were revoked for manslaughter were lost as Lucille Parrish of Raleigh and Mamie Eley of Asheville.

What It Means: RAILWAY PEACE

By MORGAN M. BEATTY (AP Feature Service Writer)

Washington—If you would understand the power of public opinion in the United States, have a look at this year's railroad strike that has not happened.

The reason it has not happened is that public opinion is against it. In stopping the threatened strike, public opinion also has stopped a threatened wage cut.

Public opinion means you, and you, and you.

This peaceful state of affairs has been the rule in the railroad industry ever since Congress passed the little understood Railway Labor Act of 1926.

The Bar of Public Opinion. That law is so constructed that the American public is the final judge and jury in every labor dispute threatening to interrupt the services of the railroads. This year's strike that hasn't happened is a perfect example of how the public does its work.

Here's how the act works in general: It makes it a criminal offense to interfere with the organization of employees into unions, or brotherhoods. That assures representation before the bar of public opinion for employees, and management.

Every dispute goes through a painstaking series of conferences or hearings, or both, lasting 90 days or longer, before either the employees or the railroads can tie up the nation's basic transportation systems. At first glance, this rigamarole may seem a bit on the balmy side, but it's been found a practical way to give John Citizen every shred of available evidence in a railroad labor dispute.

For these conferences and hearings mean newspaper headlines and create discussion. John Citizen soon gets to know what's going on. And the idea back of the law was that if the public knew all the facts, it would decide the winner of a strike or lockout—and that therefore each side won't be very sure of public opinion before tying up transportation.

Began Six Months Ago Here's what happened this year:

Again, automatically, the law provides another 30 days, ending on November 28, during which final period no strike or wage cut can mar the smooth performance of railroad service.

It's Worked So Far

The railway labor law has been forged through 40 years of trial and error by railway management and men. It was jointly proposed to congress by the roads and the workers themselves. From the start, it worked like a charm on every kind of railway labor dispute, save one—the kind hinging on the unionization of railway employees.

So, in 1934, before the now famous Wagner act was passed, the Railway act of 1926 was amended to afford protection for bargaining railway employees, just as the Wagner act affords protection for employees in all other interstate industries.

Not only does the law assure collective bargaining and elections for worker representatives, under supervision of the mediation board, but anybody who interferes with the process is risking \$1,000 to \$20,000 fine and at least six months in jail.

Much credit was given Congressman Lindsay C. Warren, representative from this district, for the tobacco section of the farm program. Declaring that the vast majority of the public is dependent upon the farm, Representative Cooley declared this was the first time in history that anyone in Washington ever had done anything to help the man on the farm. "The farmer now has the best friend in the White House" in our history stated the speaker, and the words brought forth applause from the crowd.

The Republican party, declared the speaker, has only a program of criticism. "They have no remedy and deal only in generalities. 'We Democrats probably have only scratched the surface, but we will keep on trying," he continued, and added that if another farm bill ever is written "it will be Democrats who will write it."

The speaker opened his address by stressing the privilege accorded the American people in the right to select their own leaders. He referred to situations "across the ocean" and said he had no fear "anyone will ever seize the reins of this country," but warned that we must "do more than hate war and love peace, we must solve our own problems" in a Democratic manner to protect the happiness and welfare of our people.

He referred to the talk of "dictatorship" heard in this nation, dismissing it with the statement that "it is all tommy-rot and an insult to the intelligence of the American people." He added he had no fear of Fascism, Nazism, or Communism, ever gaining a strong foothold in America.

The speaker recalled the first days of the Roosevelt administration. The only act by which the President could be guilty of assuming dictatorial powers, he said, was the closing of the banks, and he added "has he ever been criticized for this, 'I wish I could forget the name of Hoover' said the speaker, and quoted Senator Alben Barkley of Kentucky as saying, "we can't forget him, he won't let us." He stated that when the Democratic party took over the reins of this government the country "had been led to the very brink of revolution."

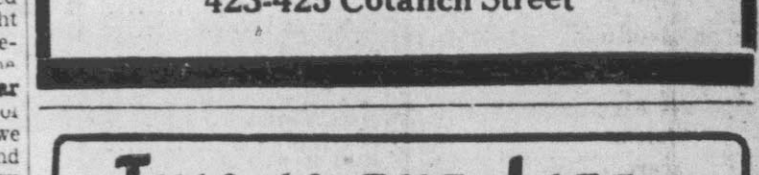

state is so poor now that the pensions have been cut to \$7 and may shortly be stopped altogether.

Paradise for 'Pols'

Politicians are asking furiously for details of these "pension" plans. The reason for such interest is obvious. The old-age pension racket is made to order for the politicians. The one great worry of the big-shot ward boss is how to "take care" of his faithful workers. He cannot afford to let any of his "boys" around one desk. He cannot be too open about patronage. So here is the perfect setup. He can put any number of friends and relatives on the public payroll, via old age assistance, without anyone knowing about it. They do not ever need

to go through the inconvenience of calling at the office for their pay—it's mailed to them! This is paradise for the politicians!

These pension plans are political dynamite. Three conservative Main Republicans endorsed the Townsend Plan and were swept into office. The G. O. P. in New Hampshire is supporting the plan. Successful primary candidates in Texas, Oklahoma, Florida, and Idaho are hammering away on old age assistance. A battle royal is on in California over the "Ham and Eggs" scheme. Even Everett Saltonstall, conservative, economically sound Republican candidate for Governor of Massachusetts—is flirting with the Townsendsites. The political power of this new pressure group is already stronger than the American Legion and Labor factions combined. Watch its power continue to

grow!

"Gray-Hair" Line Rising

Why? Because the rate of increase of the population of the United States is declining. This means that the percentage of oldsters is mounting and will continue to mount from now on. In 1900 only 1 per cent of the population was older than 65. In 1920 this figure reached 49 per cent and in the last 18 years it has jumped to 8.5 per cent. This percentage will continue to mount very rapidly from now on. Furthermore, in respect to a percentage of voters—rather than population—the proportion of "people over 65 is much greater." Moreover, under the new Wage and Hour Law it may be increasingly difficult for old people to secure jobs.

In addition to the vicious economic aspects of the problem, there is a deeper implication. "Honorable Father and Thy Mother" is one

of the Ten Commandments. Dumping parents on the state is fundamentally undermining to our national character. There is no question that old folks should be taken care of. I think that the Federal Old Age Pension program is alright. Those who contribute toward their own old age assistance are entitled to such help. The idea of pension for reward of service is splendid, but certainly not as reward for indifference or waste.

An ultimatum to Washington: In respect of this, one thing is fundamental: If the additional burden of old age assistance is to be placed on industry, then industry must be helped to bear it. It is no more possible to get around certain fundamental economic principles than it is to get around the Multiplication Table. If the ox is to be given an additional load he must be given additional food. If more efficiency is to be expected from

pearance of the jail and inmates unquestionably show that those in charge of such matters are doing their work in a very able and efficient manner.

The County Home was visited and found in good condition, and excellently supervised. The inmates are well cared for, both as to food and treatment. The corn, hay and

en place recently, we wish to recommend to those in authority, that the present type of prison camp buildings, be re-built into cells on the inside, instead of the present dormitory style, which permits the too free intercourse between the prisoners.

As stated in our September 1938 report, that the lack of time precluded investigation and inspection of schools and school buses, but would be deferred to a later term, we now offer the following: The Grand Jury was divided into six committees of three members each, and prior to the sitting of this Term of Superior court, these committees made a thorough and complete inspection of every school, both white and Negro, with reference to condition of repair, water supply, sanitation, and further needs. These Committees also inspected every school bus in the county school system. We are filing with Mr. D. H. Conley, the county superintendent of public instruction with copy thereof to the Board of County Commissioners, Board of Health and Board of Education, a detailed statement of such condition of repair, water supply, sanitation, and further needs. We particularly recommend the purchase of additional necessary lands or grounds for the use of the white school in Grifton. A detailed statement of this recommendation is being furnished to the County Board of Education. We find a most excellent administration of the schools of Pitt County. Especially noticeable was the courtesy and efficiency of the officials and teachers in the system.

We visited and inspected all of the ABC stores, offices, warehouses and records, and find them to be excellently conducted and kept.

We made some suggestions and recommendation in our September report, which are again reiterated.

In submitting this report, we wish to express our appreciation to His Honor J. Paul Frizzelle, Judge presiding and the Hon. D. M. Clark Solicitor, and all Court officers for the assistance rendered, and the courtesies extended to us during this term of court.

for soil conservation, bounties to compensate farmers against the protective tariff, loans for the relief of debtors upon their homesteads and seed and crop loans.

The meeting voted to appoint a committee of three men for each polling place in referenda "to see that we get an honest election."

Calling for both court action and votes against the crop program in the coming referenda, Talmadge predicted that "if constitutional law is put up to that court in Washington (the Supreme court) they'll declare that law (the crop control measure) unconstitutional."

Tobacco Firm On New Bright Belt

Raleigh, Nov. 5.—(AP)—Tobacco prices this week were firm on the New Bright belt, steady on the Old belt, and about the same as last week on the Middle belt, the Federal-State Departments of Agriculture reported today.

For Eastern North Carolina New bright markets a strong demand was shown for common qualities, with offerings principally common to fair quality leaf and smoking leaf. Offerings had a good volume of lugs and sales volume decreased sharply from the week before.

No season figures were given. Old belt tobacco markets had common to fair quality leaf and fair to good quality lugs as principal offerings, leaf continuing to predominate. Choice and fine quality grades had less volume.

Sales in the Old belt to October 29 were reported at 73,492,912 pounds at \$24.24 per hundred pounds.

Leaf grades were in good demand and the majority of such grades increased on Middle belt markets. Smoking leaf, cutters and lugs

showed practically no change from the previous week. Primings were steady.

Low to good quality leaf and fair to fine quality, lugs made up the bulk of offerings with leaf predominating. Sales dropped somewhat in volume. AAA reports said sales thru October 29 totalled 56,754,048 pounds at \$22.85 a hundredweight average.

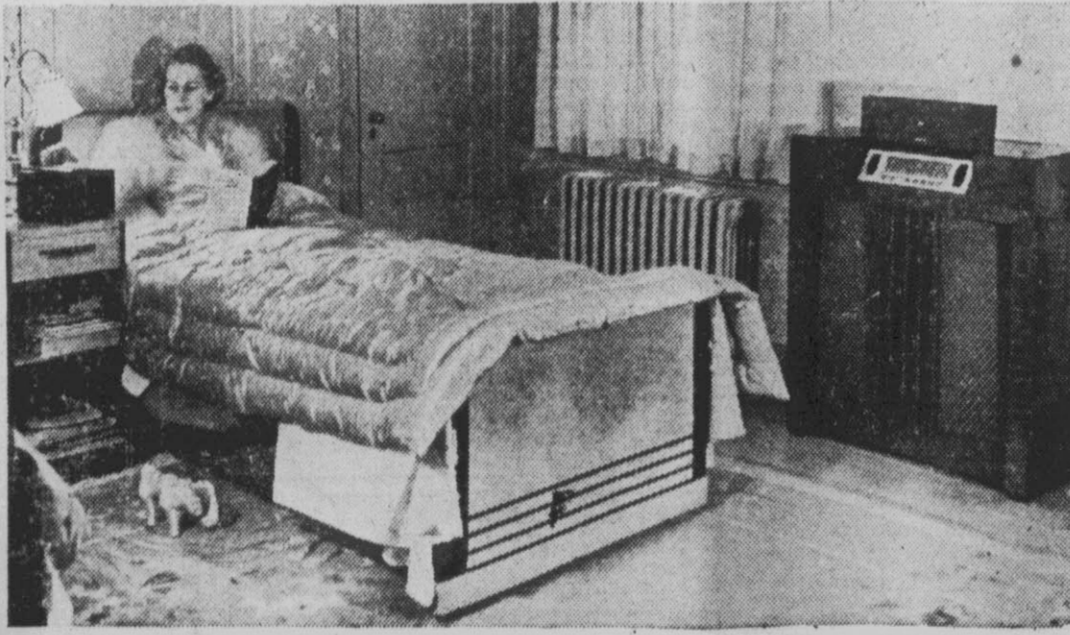
