The Next Senate.

It is said that the next United States Senate—that is, the one commencing on the 4th of March next, will consist of forty-two Republicans, thirty-nine Democrats, six Populists and one vacancy. The question of the constitutionality of the election of a successor to Senator Higgins, of Delaware, is a highly interesting one; but the Senate will, no doubt more deliberately, in the matter. The Boston Post says of this subject:

"The Republicans have a plurality, but not a majority; therefore they will be unable to organize unless they can effect a coalition with the Populists. They can hardly afford to combine with the Populists just on the eve of a national election. But they want the patronage which is controlled by the majority, and some of the hungry ones would willingly take long chances in order to secure it."

"If the six Populists decide to act as a unit upon all political matters that arise, they will practically be in control of the Senate. By casting their votes with either party they can always make a majority. Nobody knows just what policy they will pursue, but it is quite plain that they will hold the key to the situation. They can make their own terms. No bill can go through without their approval. No appointments of clerks or other officers of the Senate can be made unless they agree. They will be in a position to dictate the policy of the upper chamber. The outlook is not very cheering for the Republicans. They have an enormous majority in the lower house, but they will be utterly helpless in the Senate. They will be at the mercy of Mr. Peffer and the two senators from Nevada, who can make speeches as long and as tiresome as the ebullitions of the late Mr. Blair, of New Hampshire. No wonder Mr. Reed looks gloomily upon the prospects."

WEATHER CROP BULLETIN.

The reports of correspondents of the Weekly Weather Crop Bulletin, issued by the North Carolina State Weather Service, for the week ending Saturday, October 5th, 1895, indicate a very unfavorable week. The temperature was considerably below the normal, with frosts three mornings, damaging tobacco and other crops considerably. Drought continues to prevail, practically no rain having fallen anywhere. Cotton is very poor crop, is nearly all open, and will be all gathered much earlier than usual. All late crops have been injured by the drought, and turnips are nearly ruined. Gathering corn is under way, but fall plowing continues at a standstill.

EASTERN DISTRICT. The past week has been very cool and dry, with more than usual amount of sunshine. Frosts occurred on the mornings of the 1st and 2d. The drought continues unabated, injuring peas, potatoes and turnips, and killing young berry plants. Wells and streams are low, and some mills have stopped running. Cotton, which has opened very rapidly and is poor crop, will probably all be out by end of October. Corn was beyond possibility of injury and is being housed. Peanuts being stacked. Rice crop is fair. Second crop of Irish potatoes poor. Very little planting and no fall plowing has been done.

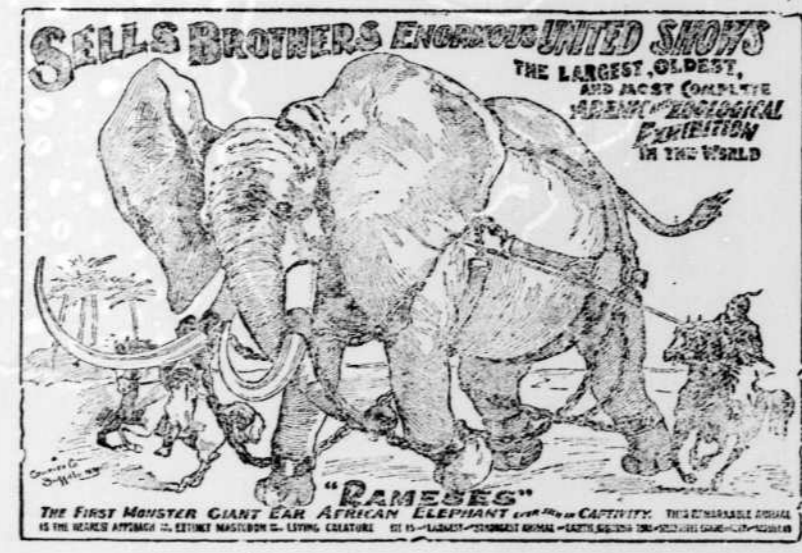

Mr. John R. Morris, so well known in North Carolina, in an interview in *News and Observer* says that John E. Hurst will be elected Governor in Maryland, that the Democrats will win, that he is a Gorman man because he and his followers represent what approves Republicanism. Mr. Morris is just from this State and has been taking part in the campaign. He is a fine talker and one of the most polished writers in this State.

It is said that Secretary Olney had told the Spanish Ministers at Washington that Spain had better hurry to her efforts to crush the insurgents in Cuba, intimating very strongly that it was not done before Congress met in December the United States might interfere. This is not believed however as this would be contrary to the policy heretofore pursued by the United States. If the strife continues though it will be interesting to see what action Congress will take. There is a growing sentiment of sympathy for the Cubans.

Gen. Mahone died in Washington D. C., on Tuesday after an illness of a few days caused by paralysis. He has had a wonderful career. He served through the late war in the Confederate army and was brave to a fault. After the war he came near being involved in a difficulty with Gen. Jubal Early in reference to a biographical sketch written for some Northern journal but he retracted what had been said about Early and the matter ended. But Gen. Mahone is more noted on account of his political record in Virginia than anything else. At one time he had the political distinctions in his hands. He came very near ruining the State and when elected to the United States Senate he acted with the Republicans and lost the respect of the Democrats. Before his death he seems also to have been forsaken by his Republican friends. Many hard things have been said about him and his lot was truly an unenviable one for the past few years of his life.

It does look as if there are some men in this world who, it matters not how successful they may be and what positions they occupy, cannot rise above the lowest type of the demagogue. Senator Butler of this State is a perfect example of this class. His whole song for the past two years has been sympathy for the farmers, and a pretended desire that agricultural products should advance in price and yet when this is being realized he comes out in the *Canoe* in a column editorial seemingly be wailing the fact that it is so, and saying that it is only done to kill out the sentiment in reference to the free and unlimited coinage of silver, and is only a political trick designed for this purpose. Instead of rejoicing at the fact that farmers are getting nearly as much again for their cotton as they did last year, way down in his heart he is sorry that it is true because it may operate against his object of keeping everybody dissatisfied with what is. He tells the farmers that if he could he would persuade them to make lots of cotton next year "Make 12 or 15 millions bales if you want to. It will not go down no matter how much you make." The reason given by this solon is "next year is election year." He adds "remember one thing, you want to get your cotton in market and sold before election." The fact of the business is that the only thing in his mind is elections and if it were not for these he would care no more about the "beloved farmer" than he pretends to care for the goldbug.

We submit that the reasons assigned by him for the advance in the price of cotton and the advice given the farmer for next year could only have originated in a mind that has been utterly debased by pursuing a course that has had nothing in it but self, and which sees no advantage to anybody, and desires none that does not help self. It is a positive calamity that we must be represented in the United States Senate by such a contemptible demagogue.

Mr. R. R. Carr, of Willow Grove, Greene county, sold 1500 pounds of tobacco on the floor of the Eastern Warehouse Wednesday for \$300.

We have written to several prominent tobaccoists in Virginia, leaf dealers that know what a piece of tobacco is when they see it, asking them for an expression of their views of how the Eastern Carolina tobacco compares with that of other North Carolina markets, as to color and texture. We have received answers from some and expect others soon. We will publish these when they are all in and let the world know what others think of our tobacco.

The first issue of the thousand extra copies of the REFLECTOR have gone out. A thousand extra will be sent out each week from now till the middle of December and we earnestly hope that some of our tobaccoist friends who ought to feel an interest in this market will help us in getting up the tobacco page. For three years we have been writing for this department, and while we have not yet been told that our articles were getting stale it would spice the news to have some help from an outside source, besides it would greatly help us.

A friend of ours, and a tobacco buyer here, tells us that while on a visit to a neighboring market a few days ago, in discussing the eastern markets a very prominent bank official told him that he considered it almost miraculous how Greenville had stood the tide of opposition and without men of very great means had made for itself a most enviable reputation and worked itself to be second to no tobacco market in North Carolina. He said that nothing but the indomitable energy and perseverance of young blood would accomplish for any town such wonderful results. He cited the thousands of dollars that had been spent in Wilson and Rocky Mount in building up their markets, while Greenville had plodded along without setting the world on fire with its great achievements, and was now the equal, if not the superior of either of these.

It is truly wonderful how Greenville has accomplished so much with so little, and two causes can be assigned for it. First, our natural advantages in growing the finest tobacco in world, and the back ground from which the market drew. Second, the projectors of the Greenville market were young men, with one exception, who had all their means, their reputation and good name wrapped up in the destiny of the tobacco market. So we repeat, with the original promoters of the market it was a case of sink or swim, live or die, survive or perish. Success, brilliant success has been accomplished at a heavy expense to those who had the market on their shoulders, and Greenville today stands out in bold commanding view of the world, the queen city of the finest tobacco region of the world.

Mr. JOYNER—I have been wanting to say something for some time and after reading your article tonight in the Daily of the 10th inst. I will do so. I don't know much about tobacco farming but I do know of building up and developing the tobacco trade of Greenville had been left to the old original Greenville its branches of industry would be flowing down the same old channels that it did ten years ago. In bringing about this change who is it that deserves the credit? Who was it that took hold of the tobacco interest here when there was not a tobacco warehouse in Greenville and kept it on through the thick-est of the opposition until today it is one of the best tobacco markets in the State? In a community, about three miles from Greenville, on the Tarboro road, not over two miles in length, the boys of the families of that section headed by Gus Evans and Olthus Joyner aided in their efforts by the friendly pen of Dave Whichard, who has at all times actively supported and encouraged these gentlemen in their efforts in building up the tobacco market, have doubled the business interests of Greenville giving employment to hundreds of idle loafers, and in many instances by so doing put bread in the mouths of the hungry, and increased the trade of the merchants of the town a great many of whom would not lend either one of them a dollar today, if they wanted to borrow unless they would give them two dollars of security for every dollar that they lent them, and increased the value of real estate around the tobacco warehouses on an average of 100 per cent, and in some instances 1000 per cent. WASHINGTON LETTER.

(From our Regular Correspondent.)
WASHINGTON, C., Oct. 11th.
President Cleveland will make a short stay in Washington as he is due at the Atlanta Exposition next week. When he returns from Atlanta he will settle down to the winter work, and he will find plenty of it on hand. In addition to other important work which he must take up, he will have only a little more than a month within which to write his annual message to Congress, and it will probably be one of the most difficult messages he has ever had to write. The message, although addressed to Congress, will really be written to the country, as nobody knows any better than the President that nothing short of overwhelming public sentiment will be sufficient to make the republican Congress accept his recommendations as to legislation, however wise they may be.

When a man makes a gigantic ass of himself the best thing he can do is to keep quiet about it. Some men don't know enough to do this. One of them is Lord Sackville West, who was British Minister to the United States until given his passport, in 1883, by Secretary Bayard, who acted under the instructions of President Cleveland, for having allowed himself to be trapped into writing a letter to be used as a republican campaign document. That Sackville should be so is natural. But in raking up the whole business in a pamphlet published for distribution among his friends he has not vindicated himself; he has only confirmed the previously held opinion of him, and shown that the years which have passed since his humiliating departure from America have added nothing to his discretion. The time museum manager who offered him an engagement then would be glad to give him double the money now, and as a freak he would unquestionably draw well.
