THE LOCATION OF THE TOWN. Greenville is situated on Tar river, twenty-five miles from Tarboro. The approach to the town, up the river, reveals on both banks great forests of timber of many varieties, which is destined to become a source of wealth to this town and section. Of this, however, we will speak later. Just here we wish to record a few facts of one of the most beautiful and delightful little towns in Eastern Carolina.

Pitt county is nearly the shape of a circle. Greenville is the county seat, and is about as near the centre of the county as it could be located. This is a great convenience to the residents of the county in coming to court. The distance across the county from north to south is about forty miles, and from east to west about forty-two miles, and all the approaches from the borders of the county to the county seat are easy and regular.

THE PEOPLE AND THEIR BUSINESS. Greenville is inhabited by 2,300 people, who are as congenial, clever, law-abiding and hospitable citizens as live within the borders of any county or State in this American Union. Their business interests are quite extensive requiring six general merchandise stores, six exclusive dry goods stores, clothing establishments, two drug stores, four millinery houses, twelve groceries, one iron laundry, one marble yard, two coach shops, both of which have wide patronage in this and from other States, one harness shop, three shoe shops and all other features of business necessary in a progressive and well equipped community. Mr. J. D. Williamson is the proprietor of one of the coach shops, and Mr. John Flanagan the other.

Mr. Flanagan has been located here in this business for over twenty years, and his reputation for good work and square dealing is widely known. There is no excuse for one to come into Greenville and foot it out of town unless he feels like exercising his limbs; for there are five livery stables here and the proprietors are so clever, that if a fellow is out of money they will ride him around free. There is one feed stable in which is always kept a full supply of the best provender for stock.

THE COX COTTON PLANTER. Just nine miles from Greenville is the Cox cotton planter manufacturing establishment. The planter is the invention of a Pitt county man, Mr. J. C. Cox. The planter has grown immensely popular since its introduction, and it will require over two thousand of them to supply the new demand this season.

PRESENT RAILROAD AND FUTURE PROSPECTS. The only transportation facilities which Greenville enjoyed from its settlement up to ten months ago were the boats on Tar river running from Washington to Tarboro, but now the snort of the mighty iron horse is heard daily as it comes and goes over the Scotland Neck & Greenville railroad, a branch of the Atlantic Coast Line. Greenville is looking forward to being in the near future the railroad centre of Eastern Carolina.

The Scotland Neck branch of the Wilmington & Weldon road is nearly completed to Bell's Ferry, and thence it goes to Kinston. The same road is now surveying a route from Greenville to Washington. It is thought this line will be extended to Wilson so that the Short Cut trains will go through to Washington via Greenville. It is also talked that a line will be built from New Bern to Bell's Ferry, and this connected with the Greenville & Kinston road will shorten the distance from New Bern via Bell's Ferry, and Greenville 70 miles, to Norfolk, and thus the road through Greenville will after awhile become the trunk line.

With these roads, Greenville will be the centre of two roads, crossing at this point which will be held in check by the river which will always afford competition and secure low rates of freight—an important item in the prospects of any town. It is also talked that the Norfolk & Southern has an eye to extending its line in the direction of Greenville, and John M. Robinson is threatening to extend his Roanoke & Tar River Line to Greenville, and thus Greenville is destined to become a great railroad centre.

With these facilities, the security of which is only a matter of little time, Greenville will be ahead of her sister county seats in the state, and will offer as quick passenger and freight facilities to outside markets as any other town, both by water and rail.

THE CHURCHES AND DENOMINATIONS. There are seven churches in the town—three white and four colored. The white churches are close together. A person standing at the intersection of two streets, near the centre of the town, is within one hundred and fifty yards of either church. The Baptist church, Rev. A. D. Hunter, pastor is known as "Memorial" church. It was built by the Baptist of the state in commemoration of the First Baptist convention ever held in North Carolina, and that convention was held in a private parlor in Greenville 59 years ago. It is a beautiful brick structure, and was erected at a cost of \$10,000. It is provided with a Sunday school department in the basement and a handsome audience room on the main floor, with a seating capacity of four hundred and fifty.

The Methodist church is a neat wood structure, with a seating capacity of four hundred. Rev. R. B. John is the pastor. Hon. T. J. Jarvis is the superintendent of the Sunday school. The Episcopal church is not a very large structure, but it is a beautiful brick building, with a seating capacity of about three hundred and fifty. Rev. Dr. N. C. Hughes is the rector.

There are some Presbyterians here, but they have not as yet built a church. Rev. Mr. Sumnerell, pastor of the Presbyterian church in Tarboro comes here once a month, and preaches for the Presbyterian congregation.

There are also a good many Disciples in and around Greenville, and the erection of a church is in contemplation. This place is headquarters for the State board of managers. Mr. E. A. Moye is the president of the board. There are also a good many Free-will Baptists here. The Watch Tower, the organ of the Disciples' church of North Carolina, is printed here. Rev. J. L. Winfield is the editor.

The colored churches are Baptist, Methodist and Free-will. THE PRESS. The Greenville REFLECTOR, Mr. D. J. Whichard editor and proprietor, is an institution well worthy of special note. Mr. Whichard is a high-toned, Christian young man of honest convictions, and labors hard to build up Greenville and the surrounding country and well deserves the patronage he gets from the people. As well as being an editor, friend Dave is also a telegraph operator and has for six years had charge of the office here which is located in his newspaper office. Dave has been in the printing business in Greenville since 1878. He is publishing a high toned family paper which is not excelled by any paper in North Carolina.

THE BAR. The bar of Greenville is composed of thirteen lawyers, and it may be said of the gentlemen of this bar that they possess and enjoy a reputation for intellect, talent, culture and refinement which might well be the envy of any bar in this land. Greenville also boasts of her physicians, one of whom has a national reputation.

TOBACCO CULTURE. Tobacco culture in this section is rapidly winning attention of some of the most progressive farmers, and it has been demonstrated by practical experiments that the bright tobacco raised here brings as high a price on the market as that raised in any other portion of the State. There are large tracts of land in this county which are specially adapted to tobacco culture, and there is no good reason why the industry should not flourish here, and cause the establishment of tobacco warehouses and manufactories both for plug and smoking. I have been told that Pitt county tobacco has taken the premium on the Henderson market for three years.

There are also a good many industries that can be started here on a very economical basis. Why do I say economical? Why, from the simple fact that nowhere in my travels throughout this State have I seen a section more abundantly provided with such rich material of so many varied kinds. Now let me say right here that the object in writing a description of this part of our beloved State and its many varied resources is not to puff, blow or to exaggerate; but to state facts as we find them. To do so would be to defeat the object in view. It is simply proposed to state plainly and truthfully such matters as may be found here, that people everywhere may know whether or not the section presents such opportunities and advantages as they are seeking. The visitor here is sure to be treated cordially and kindly. The latch strings hang outside for everybody, and on crossing the threshold one is sure to find a hearty welcome.

The country around Greenville is one of the finest farming sections of the State, and the soil peculiarly adapted to the growth of cotton, corn, peas, rice, potatoes, bright tobacco, peanuts, hay, fruits and vegetables. Grapes of all kinds flourish here. A gentleman a few years ago, while walking through the woods, found a little grapevine. He dug it up, brought it to Greenville and set it out in his front yard. From that little vine originated the celebrated James grape, which has won such a reputation in this and other States. A gentleman named James discovered the vine, hence the name James grape.

All other varieties of grapes grow luxuriantly and perfectly, and hence there is no better section anywhere for the production of native wines. Just on the outskirts of the city is Mr. Allen Warren's nursery. It is not an old establishment, but it is in a flourishing condition, and business bids fair to become quite an industry here.

Every one whom I have talked with here on the subject says that there is not a better place anywhere to erect a cotton factory. The river will furnish all the water-power necessary to run any number of spindles, while there is cotton enough shipped from here every year to supply almost any number of mills. Then again, there is plenty of labor to be procured right from the surrounding country. If some one would only make the start, a cotton mill could soon be started here; or, if some Northern capitalist would but only investigate the advantages and inducements that could be offered to start such a business, they would not be slow to invest.

While walking around among the grocery stores of Greenville, we have noticed that the shelves are loaded with all kinds of canned goods, and when we ask where they come from, we are told from Northern markets mostly. Now, the soil and climate here are both adapted to the growth of just as fine tomatoes, peas, corn, apples, peaches, and in fact everything else that is canned, and while we know that there are other sections of the State which are also particularly adapted for canning factories and a good many have started in various parts of the State, there is yet room for a good many more; and if one was started here, the home consumption alone would be a big business. All that is needed here is some one who understands the business and a little money, and success in the business will certainly follow.

THE WOODS AND TIMBERS. Among the many varieties of timbers that abound here is the long leaf yellow pine, which, instead of being manufactured right here into sash, doors, blinds, and other parts of house building, is being cut down and shipped in the rough to the planing mills and work shops of other markets. There would be a big saving, to parties engaged in working this timber, instead of moving the material to the mills, to locate the shops and mills at the material. We have noticed in our travels that overhead ceiling and decorating work of the native pine is coming more and more in use every year, and we know of no neater or prettier timber for inside finish. So far as we can see, we do not understand why it would not be a profitable business for some one to establish a shop here for getting out the narrow strips used for ceiling and inside house-building. There is also here a good deal of maple,

cypress, dogwood, gum, persimmon, hickory, oak and other varieties of woods which could be worked up into various useful articles, such as spokes, hubs and rims for wheels, also handles for axes, hatchets and other tools, and carriage material. There are also among the timber mentioned woods suitable for furniture manufacturing, and this would be a good point for some one to start a furniture factory. Certainly it cannot be said that it is for the want of material, for here it is in abundance.

In Fayetteville there is an industry that has been a success from the time it was first started, and it is only one of the kind in this State. It is the bucket shop, as it is called, but not the kind of "bucket shop" that skins a fellow of his money—speculating in produce, stock, etc., but an honest legitimate bucket shop, giving employment to a number of hard working men and turning loss a good deal of money each week among the business men of the town. They make wooden buckets of all kinds, churns, measures, and wooden implements needed about the farm and house. The same facilities that are there are also offered here for the establishment of such a business. Now let's see who will be the first enterprising man to start a like business in this section.

In addition to the timber above mentioned there is here a good deal of sycamore, red oak, and poplar. The sycamore is used to a great extent for wainscoting and to bacco boxes, while it is well known that for tanning purposes the red oak bark is very needful. Therefore it is but reasonable to say that if a tannery should be started here, there would be no trouble about getting hides, for beside what could be supplied from this immediate vicinity, there could be shipped here from adjoining towns, enough hides to keep a tannery running all the year round; and then it very naturally follows to ask the question, why could not a shoe factory become a big industry, for this section is like all other parts of the world and shoes are in demand. We venture to assert that if a shoe factory was established here a home market could be found for many dozen pair of shoes during the year. In addition to the needs stated above, and the facilities offered for insuring success, are these enterprises viz: a fertilizer mill, agricultural implement factory, knitting mill, and a well organized banking house, and last, but not least, a good land and improvement company, to promote and push forward the future growth of the town. The streets of Greenville are well shaded and handsome residences with beautiful flower yards catch the eye in any direction one may turn.

OVER THE STATE. Happenings of Interest Occurring in North Carolina.

AS REFLECTED FROM OUR EXCHANGES. Raleigh has a bicycle club. There are now 2,200 Odd Fellows in the State. LaGrange is preparing to build a cotton factory. Paul Boyton, the water man, was at Wrightsville last week. Raleigh and Wilson both had successful cattle shows last week. The Weekly says a colored child in Reidsville drank some spirits of turpentine and died in five minutes. Prof. J. L. Tomlinson, superintendent of the Greensboro graded school, died Sunday morning at 6 o'clock. John Inman and other parties are contemplating the erection of two half million dollar hotels at Asheville. LaGrange Spectator: The Georgia and Mississippi emigrants, who left here last January and February, are returning one by one. Beaufort Seaside: We learned that the troops which attacked Winslow at Ocracoke went into the hook of Cape Lookout and had charged upon and put to flight the fishermen at that place. Congressman Brower has secured a position in Washington at \$125 per month for Hannibal Simpson, of Rockingham county, who, when last heard of, a few weeks ago, was writhing under the charge of rape. Elizabeth City Carolinian: Court at Dare last week only lasted one day. Andrew Wilson, the colored man, indicted for the homicide of Monroe Johnson, submitted and was sentenced one year to the penitentiary. Lenoir Times:—Dead fish are still seen in the river here. Several large horse fish were seen floating down the stream one day last week. We have heard it suggested that it was fish cholera that was killing them up so.

The commissioners of Winston have called an election to take place on the 17th day of June for the purpose of voting upon the question of issuing bonds for the city improvements to the amount of two hundred thousand dollars. Sanford Express: It is reported that John W. Thompson, of Raleigh, John Blue of Aberdeen, and John C. Currie, of Montgomery county will soon commence to erect a large and stylish hotel at Jackson Springs, whose water is a cure for dyspepsia. Statesville Landmark: In preparing his sweet potato patch on the #2 inst., Mr. G. L. D. Eller, of Shiloh township, found sprouts from last year's crop and potatoes big enough for seed. He is a life-long and successful sweet potato raiser but never knew of a case of this kind before. Waynesville Courier: Mr. James Welch, who died about 3 years ago, was removed recently from where he was buried to another place. The body looked very natural, and everything about the burying clothes looked as though he had just been buried. The face had shrunk a little.

Scotland Neck Democrat:—Mr. J. C. Williams was up from Williamson Saturday and says that \$4,000 will soon be raised for the establishment of a furniture factory there. We are gratified at this news and hope all our towns will soon establish manufacturing industries. Williamson is able to establish any ordinary industry of the kind, if the people will only think so. Raleigh Chronicle: Some old folks say they never knew anybody with long unnes to have any luck. The names seem to keep them weighed down. There was an illustration of the truth of the old saying here yesterday. Two children were so unfortunate as to be apprenticed. Their names were George Alfonso Green Caudle, and Pearl Prentiss Rosa Minnie Candie. The Governor yesterday pardoned D. B. Jacks out of the penitentiary. Jacks was convicted of larceny in Yadkin county in 1882 and sentenced to ten years imprisonment. The pardon was granted as a matter of humanity to ward the prisoner. He had been in the infirmary four years, is completely prostrated as to health, and the opinion of the physicians is that he is a permanent invalid.

News and Observer:—It was learned yesterday from reliable authority that there will be two separate encampments of the State Guard this year, it having been decided that the entire Guard is too large a body to go into camp all at once. Accordingly the first and third regiments will go into camp at Wrightsville in July and the second and fourth regiments at Wrightsville also in August. A prominent traveling man who is stopping at the Yarboro received yesterday a package by express which contained two cute and charming pets. One was a young kid goat and the other a small chicken, both in a state of infancy. They were adorned with gorgeous ribbons and bows and made a stylish appearance. Be animated, cheerful, helpful to your fellow clerks when your own work slackens—find something connected with your business in which to be interested, for if absolutely idle you cannot feel or act lively. In idle hours, a fault too prevalent with saleswomen is gossiping with each other of their own private affairs—the new gown one aspires to—"Joe's" latest witticism—or love passages of which the hero evidently had not expected such public repetition. Sometimes absorbed in their foolish egotism, neither narrator nor listener apparently can tear herself away to attend to business, and a customer waits several minutes to be served, her request unheard or ignored. Washington Letter.

From Our Regular Correspondent.

WASHINGTON, D. C. May 16, 1890. The sensation of the week in Congress was the tariff speech of Hon. Benjamin Butterworth, Republican member from Cincinnati, Ohio. He said a great deal, and evidently meant more than he said. He has kicked out of the Republican traces on the tariff issue and will not be whipped back. It requires courage for a man to step outside of the party lines for the purpose of stating wholesome truths, but Mr. Butterworth was equal to the occasion, and, while he has no doubt invited the displeasure of the blind party press, the people who have become tired of the swish of the party lash will applaud his utterances. Mr. Butterworth said that the price of an article was not reduced on account of competition alone. It was reduced on account of the improved methods of manufacture.

The committee had tried to do the best it could in framing the bill, but it was not always safe to rely altogether upon the testimony of the beneficiaries under a law. (Applause on Democratic side.) He had indicated his belief respecting the proper function of a tariff act and would sooner resign his seat than depart one hair's breadth from that belief. Of course he respected the wisdom of the committee, but why was Paul favored and Peter turned down? Why increase the profits of certain classes? He could name capitalists whose profits had exceeded those of all the agriculturists in any State of the Union (Applause on Democratic side.) If, when we had protected equally and lifted up all our industries, and the time should come when we could not hold our own—being the most intelligent, the freest and ablest people on earth—then we had better retire from the field. (Democratic applause.) Mr. Butterworth then proceeded to expound his views touching reciprocity with Canada. He said that we were endeavoring to cultivate relations with 50,000,000 people to the southward, and yet were afraid of Canada. Abraham Lincoln and Ulysses S. Grant were not suspected of lack of patriotism, yet they favored reciprocity. There were some things in the bill he did not like. He had known of an industry that had been able to make \$60,000,000 dividends on a capital of \$1,250,000.

Protection! Why, the country could in such cases better afford to keep these men in the Fifth Avenue Hotel, pay their board and expenses, and set them up in the banking business. He favored proper protection, but these men held the world in their grip. When he said that he did not favor that kind of protection, he was told: "You are not sound on the tariff." The time is come when some little concern should be shown American homes and American firesides. A great body of employes in this country was foreign. In some factories in the East they were known on the rosters by numbers because of unfamiliarity with their names. He did not believe it was wise or prudent to make such a sweeping reduction in sugar to be supplanted by a bounty. What he wanted to avoid were such features as he had pointed out in this bill—there was a thing as paying too much for an industry. Such was the case with tin-plate. The duty would be a tax on every farmer's patch; on every can of goods. That tax would amount to \$50,000,000 before the manufacturers of tin plate could declare a dividend. He was anxious that his party should not take a false step.

It was a merry crowd, and not a thought was given to the poor farmers of Kansas, who have been burning their corn for fuel the past winter.

B. Cherry and the choir under her charge for the acceptable music furnished during the religious services; and to the citizens generally for the unbounded hospitality which has been accorded to the members of this Council during our sojourn among them. The Council adjourned at the close of the morning service Friday, and at 5 P. M. the delegates left on special train for Tarboro to join with the other Diocese in session there in celebrating the Centennial Convention. The East Diocese will meet next year at New Bern. She was 68 years old and had lived a consistent member of the Baptist church for many years. Although poor in this world's goods she was much loved by her church which is perhaps one of the tests of true christian character. She was interred in the Methodist cemetery on Sunday morning at 10:30 o'clock. May she rest in peace. AT REST. At his home in Contentnea township, Pitt county, on Sunday, May 18th, 1890, at eleven o'clock A. M., BENJAMIN FRANKLIN TUCKER quietly and peacefully passed away to his final rest. He leaves a widow, six children and twenty-five grandchildren and a host of friends to mourn his loss. Born on the 5th day of August, 1816, he was therefore in his 74th year. Photographs of Exploding Powder. La Nature contains copies of two instantaneous photographs illustrating the difference between a volley fired with ordinary powder and with smokeless powder. The pictures were taken at the moment when the commander gave the order, "Fire!"
