### CARE OF THE SKIN.

Some Things That Are Essential to Good Health.

To most persons the skin represents simply the organ of touch, and because it is customary to keep nearly all of its surface concealed its relation to the welfare of the body is overlooked. It has, however, most important functions, such as the casting out of waste matter and the maintenance of an even body temperature, disregard of which may lead to serious disturbances of health.

But aside from its purely physiological purposes the skin is an important influence for or against personal appearance, and its proper care is therefore worthy of consideration from this point of view alone.

Cleanliness is the greatest essential in the care of the skin. For the cleansing bath water as hot as can be borne is best, and a good soap should be freely applied with a moderately stiff bath brush. If the water is at all hard it is well to soften it by the addition of a little ammonia or borax. A quick sponging of the entire body with cold water should follow in order to cause the pores relaxed by the heat to contract, and the drying should be accomplished by brisk rubbing with cold water.

Although the habitual use of hot water on the face is sometimes commended on the ground that it tends to favor the relaxation of the skin and produce wrinkles, there is no danger of this if the washing be concluded with cold water.

The sponge is a thing to be avoided, as it is difficult to keep clean and forms a beautiful lurking place for germs. One washcloth should be kept for the face alone, and this should be boiled frequently.

A little oil is a good plan to rub into the face and neck, and to rub the skin of the face and then wipe it off with a piece of soft linen. It is surprising how black the latter will appear when the operation is finished.

Gold cream and talcum powder and some of the cosmetics are safe and useful, but other cosmetics do more harm than good.

The development of wrinkles can be retarded, and if present they may be lessened by gentle massage with the finger tips anointed with cold cream. A good general rule is to let the direction of the rubbing be upward and outward.

Above all, it should be remembered that cleanliness, exercise, fresh air, simple food and attention to the digestion are the most important considerations in the care of the skin.—Youth's Companion.

### HUNTING WITH A LEOPARD.

How the Swiftest Animal on Earth Goes After His Prey.

Four miles beyond the palace gates of Jaipur you may see a cheetah hunt. Now and again in the noonday heat you may have seen a leopard crouching along beside his master—querulous, uncertain, half timid, heavily hooded with blue silk, and finding the trimmed stone of the pavement maddening hot beneath his silent paws. But it is a different animal when at last, after a tedious stalk of a herd of black buck, the leopard is unloosed from the whining bullock cart and left to his own work.

In all the world there is little left so savage and so beautiful as this sleek spring cat when he scents his quarry. In a flash he has dropped to the plain, belly flat upon the hot stones, while he works his way to a ten inch patch of sagebrush, all elbows and seemingly but four inches above the ground. You may see the trail of him as he goes. From one bush he makes for another or a fold of ground. One watches him with a touch of his own silence, though the little caravan of bullock carts must still be kept moving lest their stopping should alarm the buck.

So it goes on, this yellow demon edging himself nearer and nearer to his chosen prey till, fifty yards away yet, the buck raises his head. Whether he temporizes his danger at once or not, there is no chance of stalking him a yard farther, and the cheetah makes his dash. There is not a sound on either side. Two of the fastest animals on earth—the cheetah is beyond all question the swiftest—engage in a life and death race. It is soon over, for if the cheetah does not bring his prey down in 200 yards he throws up the chase and returns for another hunt. If he catches the buck there is another final of jetting life blood and convulsive limbs and glassing eyes, interfered with by the cheetah's master, who brings a huge wooden spear filled with blood and entrails, which he forcibly substitutes for the buck's neck under the still snaking noose of the sated leopard. But whether he catch it or not the cheetah's flight over the ground for 200 yards is a thing that is worth going to Jaipur to see.—Jaipur Review, in London Telegraph.

### WOMEN AS HARD WORKERS.

labor Co Heavy Than the Strongest Men.

In Warsaw I once saw a troop of women going back and forth from a building in process of construction, emptying hods of dirt and carrying in loads of brick or mortar. They were splendid women physically, light limbed, slender, with a hips, strong limbs and stout ankles. They were all young, and when I inquired why it was the foreman said, 'The work does for them in a very short time, and when they break down they are no longer of use to us.' At thirty the women are already old and unfit for further usefulness to the purchasers of labor, so they sit at home like grandmothers, waiting the passing of their time. Indeed, throughout Poland and Russia one sees women bearing burdens which seem far beyond their strength.

In all the countries of Europe we see them engaged in occupations of the most laborious kind. There is no more revolting sight than to see women doing the work that is done by men. Here and there one sees a girl harnessing a cart or pulling a heavily loaded wheelbarrow. On the canals and rivers everywhere women take turns with men in pushing with heavy poles or in pulling the long freighted canal boats. Here they are competing with the men in the railroad, and there scraggy as hoaders, they are then one sees them in the coal pits and about the iron works. In certain industries there is no limit to their hours. On the boats, for instance, they must work both night and day to get the cargo to market. In this way women become beasts of burden and remain so until they are past middle age.—Robert Hunter in Cosmopolitan.

The Democrats of Indiana, South Dakota, Missouri, Arkansas and Ohio having declared in favor of the nomination of Bryan for president by the Democratic National Convention in 1906, makes apertly strong showing for the Nebraskan this far ahead.

Some of these days the people of Pitt county may learn that interest on a bond issue sufficient to build good roads all over the county would not take as much money from their pockets each year as they now pay for road taxes, to say nothing of the profit it would bring in other ways to have good roads.

That was a commendable step on the part of the Water and Light Commission to decide to give Greenville day electric current. The gentlemen composing the commission are staunch business men who have the best interests of the town at heart and want to take any steps that means progress and development. At the same time they desire that the water and light plants shall be remunerative to the town, and to accomplish this the support and patronage of every one should be given.

The Greensboro Industrial News is poking fun at the Raleigh News and Observer because the latter is putting up such a fight against the proposed change of schedule of the night train from Raleigh on the Southern railway. The Industrial News accuses the News and Observer of making a great howl about it, but its three to one if every person west of Raleigh who is indignant over the proposed change, and every business man of Greensboro who opposes it, should notify the Industrial News that their patronage to that paper would cease the moment the contemplated change comes into effect, the schedule would remain just as it has been the last twenty years.

The Italian Consular agent stationed at Charleston, and United States Attorney Holton, of the Western North Carolina district, have been to Marion investigating the reported outrages and found such conditions may lead to international complications. The Italian government may make heavy claims on the United States for damages.

If a man has anything to sell it is his right to get as much for it as he can, but at the same time justice and equity should govern his transactions. The Reflector has been told that some persons owning land along the proposed line of the Raleigh & Pamlico Sound railroad with the idea that it is right to extort every dollar possible from a corporation, are demanding several times more than their land is worth for rights of way through it. They may have the legal right to ask what they please for this land, but mistakes are sometimes made in this particular. It is better to encourage enterprises that will develop the country rather than drive them away by extortion. Because the railroad is going to build from Raleigh to Washington is no reason it not could deflect from the proposed line where unreasonable demands are made for right of way.

The insurance grantees feel quite vindicated, since the exposure of the greater grafting of the railroads.

John Dalzell, the Pittsburg Congressman and one of the boss stand-patters, acknowledged in a speech in Congress that the trusts are selling cheaper abroad than here and seem to be the only thing that will save the country from ruin.

But with the prospect of being rebuffed 99 percent under this Republican system, its constituents must be getting tired of the discrimination in favor of foreigners.
