

Bryan Turner
Deed
to Nathan & B. F.
Stanly

This Indenture made on the First day of November
A.D. one thousand eight hundred and forty seven
between Bryan Turner of the County of Jones and
State of North Carolina on the one part and Nathan
Stanly and Benjamin F. Stanly of County of Jones and
State of North Carolina on the other part Witnesseth
that the said Bryan Turner for and in consideration
of the sum of Two hundred and twenty five Dollars
to him in hand paid by the said Nathan and
B. F. Stanly's at the time of executing these presents
the receipt whereof is hereby acknowledged hath
granted bargained sold conveyed aliened and confirmed
and by these presents doth grant bargained sell
convey alien and confirm unto the said Nathan and
B. F. Stanly's their heirs assigns a certain tract or parcel
of land (formerly owned by Edward M. Gilbert dec'd
and fell to his two Sons Nathan B. Gilbert and Arctus Gilbert
heirs at law and was conveyed from the said Gilberts
to Bryan Turner deed bearing date 10th day of January 1845)
in the County of Jones and State of North Carolina lying
on the South side of Chingopine creek adjoining the
lands of Wright Stanly and the said Nathan & B. F. Stanly's
Beginning at a red oak near said creek one of Wright Stanly
corners and run with his line South 100 pole to a pine
near a branch another of his corners thence with another of
his lines North 77 West 84 poles to a gum the said Nathan
& B. F. Stanly's corner thence North with their line 44 pole
to a stake another of their corners thence West with
their line 50 pole to a water oak another of their corners
thence North 30 East with their line 9 pole to another of
their corners thence North 3 East with their line to the run
of said creek thence down the run of said creek to
another of their lines thence South 3 West to another of
over

their corners thence with their line to the beginning containing by estimation One hundred Acres be the same more or less to have and to hold the said lands and premises and all and singular the tenements hereditament wood ways waters mines minerals improvements rents issues profits remainders reversions privileges and appurtenances thereto belonging or in any wise appertaining to them the said Nathan & B. F. Stantley their heirs and assigns to them and their proper use and behoof in fee simple forever. And the said Bryan Turner and his heirs all and singular the premises hereby conveyed to the said Nathan & B. F. Stantley their heirs shall and will warrant and forever defend from the lawful claim or claims of any and all persons whatsoever —
