Helplessness of Men in Court.

Referring to the recent Massey-Pilot libel suit in Norfolk, the *Landmark* of that city says that those who read the accounts of the cross-examination of Rev. John E. Massey by Capt. John S. Wise, and Capt. Wise's speech, must have been struck by the very extraordinary license which he took. It continues: "Those who heard the examination and the speech, more than those who read of them, were impressed by their brutality and absolute disregard of any of the delicacies and proprieties of court decorum. Many persons have thought since this episode that there is no limit whatever to the privilege which a lawyer may assume of abusing and outraging a witness or principal when under the protection of a court." It is very rare indeed, that any such limits are set upon a lawyer. We have often read and heard of helpless witnesses appealing to the court for protection against the mercilessness of counsel, but have rarely ever heard of the plea being answered. Under the rules and precedents it would seem that the litigant or witness has no hope except in the gentility of counsel and the sense of right which will not permit a fair-minded man to take advantage of the condition of another who is so circumstanced that he cannot speak for himself, to say about him things which the facts do not warrant and which offend the decorum of courts and the proprieties of life.—*Charlotte Observer*.

The new woman has appeared in a New York court, charged by her husband with being most of the time away from home, and neglecting the children. Her plea was that the husband should look after the little ones, but he says he can't do that and go to work every day. The wife was paroled for trial.

Hon. John S. Henderson says the people of North Carolina are paying more attention to the establishment of cotton mills than they are to politics. That is what the people need now. The return of general prosperity will go farther toward helping the Democrats regain power than anything else could. LEARN TO RUN.

A Good Exercise for All-Around Development.

Don't Go Flat-Footed—The Old Injunction Against Breathing Through the Mouth Is Best Ignored—A Graceful Swing.

Running is one of the best of exercises for the whole body. It rounds out a hollow chest, drives the oxygen into the farthest air-cells of the lungs, wonderfully increases the capacity and develops the leg, thigh, stomach and waist muscles. But it must be learned, just as skating, swimming and bicycling have to be learned, and there are two things which must be kept in mind by the learner. The first is—whether in sprinting, distance or cross-country running—to run entirely on the ball of the foot, or, as they say on the track: "Get up on your toes!" By striking on the ball of the foot, which is a natural springboard, the runner takes a longer stride, and the spring that he gets enables him to lift his foot more rapidly and repeat the stride more quickly than the runner who goes flat-footed. As length and rapidity of stride are what give speed in running, it follows that a flat-footed runner can never be a fast one. Another reason against pounding away flat-footed is that the delicate mechanism of the ankle, knee and hip is jarred and may in time be injured.

The second point for a runner to observe is his method of breathing. Breathe through both the nose and mouth. Nearly every boy when he first begins to run has the insane idea that all the breathing must be done through the nose. There was never a greater mistake. When a boy runs his heart beats much faster than it does ordinarily, and pumps out just so much more blood. All this must be aerated or purified by air from the lungs. The oppression that one feels when beginning to run is due to the lungs demanding more for the extra quantity of blood which the heart is sending out. Nature has looked out for this and provided a way by which air can be furnished to the lungs very rapidly. It is a very simple way, and consists of merely opening the mouth. Breathe, then, through the nose in ordinary life as much as possible, but when you are running or exercising violently open the mouth and take in air in deep rapid breaths, not gulping it in through the mouth alone, but letting the mouth and nose have each their share.

Take as long a stride as possible, but without overbalancing the body. Bend the body slightly from the hips, for if it be held too erect the stride will be shortened. Let the bent arms swing easily and naturally a little above the level of the hips, swinging out and back with every

stride. This keeps the muscles loose, prevents them from becoming tired so easily as they would if held rigid, and balances the body better. Take especial pains to keep the body from being stiff; let it swing as easily and lithely as possible. In sprinting the stride is shorter and more rapid than in long-distance running, and a sprinter usually runs with body thrown further back, in quite different form from the long, easy lope of the distance runner.—S. Scoville, Jr., in *St. Nicholas*.

FIRST FLAG INTO RICHMOND.

Massachusetts Cavalry Carried It Upon the Confederate Evacuation.

Charles Wheaton, retired captain United States army, referring to a flag which was floated in Detroit on last Memorial day by Capt. Foster, says there is an error in crediting Capt. Foster's flag with being the first American flag carried into Richmond. Capt. Foster said the flag was floating from the steamer *Commodore Perry*, as she led the advance of the fleet up the James river and into Richmond on April 9, 1865. Capt. Wheaton says the confederates evacuated Richmond on the night of April 2, 1865, and that about half-past seven on the morning of the 3d a part of the Army of the James, commanded by Maj. Gen. G. Weitzel, entered and occupied Richmond, carrying American flags. This was nearly a week before Capt. Foster reached there on the *Commodore Perry*. According to Capt. Wheaton, the first American flag entering Richmond was the colors of a squadron of the First Massachusetts cavalry, commanded by Maj. Atherton H. Stevens, provost-marshal.

AROUND THE WORLD.

How a California Couple May Win a Tidy Sum.

W. T. Williams, Jr., and his bride have left their Los Angeles home on a novel trip around the world. They left without luggage or money or food, with nothing but the clothes on their backs and a few things in their pockets. Mr. Williams is a son of District Attorney W. T. Williams. Like his father, he is a big, stalwart man, capable of withstanding all sorts of hardships. Some three days before his wedding he surprised his friends by announcing his intention of getting married and then turned up with a lovely bride and spent his honeymoon at the Russ house. The story now goes that he made a wager of five thousand dollars with his uncle that his wife had courage enough to undertake a journey about the world without either of them having any money or luggage.

The condition was imposed that not more than two years should be occupied in the trip, and that the travelers must not receive any help from friends, but must earn every

cent they get from the time of departure until their return. The conditions were promptly agreed to, and as no particular preparations were necessary, it was decided to commence the long journey at once.

The friends of the bride and groom assembled at the hotel, and the crowd was increased by a number of curious spectators so that when the last good-bys were said and the plucky little woman and her big husband took the first step toward the doors they were greeted by cheers from an assembly of several hundred people. They bowed their thanks, and trudging along were soon at the city limits and fairly started on their way. San Francisco and Seattle being visited, then their road lies straight for the orient. The undertaking is actuated by a desire for sight-seeing and adventure as well as by the five-thousand-dollar purse which is made up on the venture.—*San Francisco Examiner*.

Held by a Hair.

In a gathering of officers, after the Franco-Prussian war, a French officer claimed that the French nation is the most artistic nation on the earth; and that her artisans can make a thing of beauty out of anything, however ordinary or crude.

The great Prussian general, von Manteufel, who was present, plucked a hair from his shaggy beard, remarking: "Let them make something beautiful out of that."

The French officer sent the hair to a friend in Paris, telling him the circumstances, and urging that, as the Prussians had defeated the French in the late war, they should not be permitted to defeat them in the claim to artistic supremacy. Giving the hair to capable artisan, with proper instructions, the result was a beautiful scarf pin, representing a Prussian eagle, artistically wrought in gold, standing on a rock, and depending from his beak was the single hair, at the ends of which were two beautiful gold medallions, on one of which was inscribed "Alsace" and on the other "Lorraine."

Thus, the artistic scarf pin aptly described the political situation: Prussia, as the eagle, with its conquered provinces dependent, but held by a hair; for the temper of the people of Alsace and Lorraine was bitter towards the Germans, and the tie which held them was very slight.

Our former invaluable friend, the horse, that looked on the bicycle as the forerunner of his coming doom, will doubtless feel that doom sealed by the reports of the race of horseless carriages in France. The steed of the future, for uses both of pleasure and labor, will doubtless be an automation, driven by electricity and managed by a touch.
