DOINGS IN RALEIGH.

Raleigh, N. C., March 27.—Governor Russell had today a warrant issued on Treasurer Worth for \$350 in favor of Captain Day and ex-Judge MacRae, who are to appear for the governor in the injunction case at Greensboro. This causes comment, because both lawyers are general counsel for the Seaboard.

Attorney General Walser says the governor has full authority to employ counsel.

Today some prominent republicans here offered to bet that the federal judgeship of this district will go either to Governor Russell or to Charles Price. It is true that Russell said at first nothing would please him so much as the judgeship. It is equally true that he now says he does not want it. But it is asserted by some that this latter declaration is because of his anger at the way republicans are "nagging" him and trying to get him out of the position of governor.

It is ascertained that James H. Young, the negro editor of The Gazette, who is given the position of chief fertilizer inspector, is still in the race for the postmastership of Raleigh. His paper so announces.

The case involving the constitutionality of the new act regarding the hospital for the insane comes before Judge Adams at Greensboro next week. The supreme court will dispose of it before May, it is believed.

Representative Hodges, of Beaufort county, one of the most extreme of the bolting populists, is here on his way from Washington home. He became very angry with Editor Ramsey of The Progressive Farmer because the latter denounced the bolters as "pie hunters." But now that Editor Ramsey, as secretary of the board of agriculture, gets so large a slice of pie Hodges today renewed the subscription to his paper which he had stopped during the legislative session. He says he thinks Ramsey has reformed and is right in line.—Wilmington Messenger.

THE COST NOT PAID.

And the Smile Was on the Judge.

Some right amusing things happen in the court room now and then. At the last term of court J. A. Walston was convicted of an offense and could not pay the costs. He put up such a plea in his own behalf as touched Judge Robinson's tender heart and he ordered that Walston be released on his own recognizance, adding "If he does not pay the costs I will pay it myself." When court was ready for business Monday the Solicitor was calling the docket, and upon reaching Walston's case asked, "Mr. Clerk, has the cost in this case been paid?" "No, sir!" came the prompt reply. At this a smile began to play over the bar and all eyes looked towards the Judge. His Honor, however, appeared quite busy over his desk and never even looked up, but he evidently remembered the cost incident. The Solicitor had Walston called and as the latter came forward the titter became so audible that the Judge raised his head and smiled too.

Walston approached the bench and delivered another touching plea asking for further time. Until September court was offered, but he said he could not pay by then. December court was suggested, when Walston pointed dramatically to the jail, saying, "Judge send me to jail for 10 or 20 days and I can pay it that way quicker than any other." At this the audience laughed, when Judge Robinson looked around and said "Gentlemen, I don't understand the feelings you possess that cause you to laugh at a man's poverty." "I don't either," added Walston as he turned about. But it was Walston's manner and expression that provoked the laugh, and not his declaration of poverty. The Judge assured him that he should not be sent to jail, and told him to go home and return Wednesday and he would be instructed what to do.

We learn that on Friday of last week a meeting was held at Snow Hill looking to building the railroad from that town to some point on the Wilmington & Weldon or Atlantic & North Carolina railroads. A committee was appointed to make a canvass of Wilson, Goldsboro, Kinston and Greenville, and the town offering the best inducements will secure the road. One important thing to be considered in connection with Greenville is the advantage of water transportation. The people of Snow Hill by having their goods shipped from the north by water to Greenville and then on to their town over this new road, instead of having to get them all the way by rail via one of the other towns named, would save thousands of dollars in freights. This point is worth considering.

The Senate of Alabama has passed a bill allowing women, single or married, to practice law when properly qualified, in every court of the State. This is the first Southern State to recognize women lawyers as regular members of the profession.

Othello, in one of the scenes of that play, rushes upon the stage, where Cassio and Roderigo are fighting, and exclaims: "Put up your swords: he who strikes makes me his foe!" Governor Russell has raised the thing a little and says: "He who crosses my path shall eat dirt!" or words to that effect.—Raleigh Tribune.

As Thomas B. Reed has been again elected speaker of the house, his length of service in that office, past and present is six years. In duration this record was never beaten but twice—by Henry Clay, who served as speaker for ten years, and by Andrew Stevenson, of Virginia, who occupied the speaker's chair continuously for seven years. Besides these, Nathaniel Macon, of North Carolina, Schuyler Colfax of Indiana, Jas. G. Blaine and John G. Carlisle served each as speaker six years.—Asheville Gazette.

Senator Hanna has now made his debut as an orator. His first speech, delivered yesterday, was characteristic of the man. It was short and to the point. There were no rhetorical flights, no poetic imageries. It was delivered, however, with all that earnestness which is so predominant in Senator Hanna's make up, and without the slightest trace of embarrassment in his tones. He said: "Mr. President: I desire to introduce a bill for a public building at Cleveland, Ohio." Evidently, Senator Hanna has been taking oratorical lessons before he made his debut. Otherwise, it would have been impossible for him to have given to the opening words, "Mr. President," all that fervor and delicate inflection with which they were invested. Then the emphasis which he placed on the word "I" demonstrated the master elocutionist. His next word "desire," was rich with mellifluous rhythm and accompanied with appropriate gesture. When he reached the main subject of his talk "to introduce a bill," he let his soul go forth in passionate eloquence, but it was not until he mentioned "public building at Cleveland" that he rose to really sublime height. Then all the art of the orator burst forth in untrammelled fashion and he held the senate, accustomed though it is to flights into the empyrean, in absolute thrall. Nor was Mr. Hanna's effort without its touch of humor. It will be many a long day before the bill becomes a law.—Washington Post.

A BIG RAILROAD DEAL.

From persons interested, it is learned that an extremely important railway deal is being arranged between the Baltimore and Ohio railway and the Seaboard Air Line by which each attains an object—the Seaboard to get into New York, which it will do over the Baltimore and Ohio tracks, while the latter will enter the south, using as much as it desires of the Seaboard's tracks.

It is also learned that the Baltimore and Ohio is at the back of the building of the short line from Richmond to Ridgeway, which will reduce the distance between Raleigh and Richmond by forty miles. Under the arrangement made, these roads will jointly use this short line and also the Seaboard tracks from Ridgeway to Hamlet. The Baltimore and Ohio will purchase the Palmetto railway, from Hamlet to Cheraw, and from the latter place will build to Columbia or Augusta, most probably to Columbia, as there it will connect with the Southbound railway. It has proposals from two or three roads at Columbia.

In case the Baltimore and Ohio desires it can use the Seaboard's tracks into Atlanta, but the construction of the line above described seems to be agreed on. The Baltimore and Ohio has secured a charter for a line south from Cheraw.

An official of the Baltimore and Ohio has been here, in cognito, and has also been over the entire proposed line.

The link between Ridgeway and Richmond can quickly be completed. About half is graded and the stone piers across the Roanoke are built. Under arrangements made both the Baltimore and Ohio and the Seaboard Air Line can run solid trains between New York and points in the far south via Raleigh.

The Baltimore and Ohio tried some years ago to get into the south via the Roanoke and Southern, but this plan failed. The new movement is of great importance and interest.—Wilmington Messenger.

No Good.

A school teacher has turned up in Ohio who was evidently constructed without a soul. Here is the evidence. He was a bashful young man, only twenty, and was teaching a country school. He had among his scholars a bevy of farmers' daughters, who hoped that their charms might make some impression upon the bashful young pedagogue. Finding that there was no responsive chord in his callous heart they waylaid him one day and held him until each one in turn had kissed him. The booby, when released, fled panic stricken and left the neighborhood for good.

Of course he is no good and the patrons of the school do well to be rid of his services. Had he been so overcome by the lavish dispensation of rural sweetness that it would have been impossible for him to proceed with his daily duties without first taking a vacation for the purpose of recuperation, it would not have been strange; but a fellow who would run off from such a punishment has no more idea of what constitutes superlative bliss than a cast iron monkey. Near Relatives.

A New Hampshire man, as administrator of his brother's estate claimed an allowance for car and coach fare of himself and wife and of a sister and brother-in-law in attending the funeral, also for his own services and time spent on that occasion. The court did not make the allowance.

A New York man who voluntarily opened his house a few hours for the funeral of an intimate friend, who was also his wife's cousin, as well as a distinguished scholar, historical writer, and public man, demanded \$100 of the executor for this use of his premises. He also claimed \$50 for going down street to an office and several restaurants in search of his missing friend, who had been temporarily staying with him, but failed to return at the usual hour. He wanted more pay for writing the funeral notices for the papers and calling a clergyman to officiate on that sad occasion, and also for following the remains to a vault. He sued the executor to enforce these claims, but the court failed to sympathize with him and said his claims were "extraordinary."

For Housewives to Try.

Try hanging brooms in the
cellarway to keep them soft and
pliant.
Try taking the tea kettle from
the fire the moment it boils if the
hot water is to be used for cooking
purposes.
Try filtering impure water
through charcoal to render it
pure.
Try keeping lemons in water
until they are wanted for use and
they will be improved.

Try wrapping cutlery in coarse
brown paper to keep it from
rusting.
Try setting a pan of hot water
in the oven if it seems too hot
after a cake is put in; it prevents
scorching.

Try saving every scrap of tissue
paper that comes into the house
for wiping looking glasses. It
gives a peculiar lustre to the
glass.

Try spirits of turpentine for
removing ink spots from the
clothing.

Try wrapping a baked potato
in a towel as soon as it is done,
and press slightly until it bursts
open and it will be sure to be
mealy.

Try taking out grease spots
from wall paper with a piece of
blotting paper and a hot flat iron.

Try rubbing knives and forks
with a piece of orange or lemon
peel: the taste of fish seems to
cling to them.

Try washing oyster shells and
keeping them on hand, as two or
three boiled in the tea kettle once
a week will prevent rust from
forming.

Try making oil cloths durable
by applying a coat of luscseed oil
and brush with varnish when
thoroughly dry.

Try rendering hard water soft,
until it rivals distilled water, by
dropping a two ounce vial into
the kettle. The impurities will
adhere to the bottle.
