LIST OF THOSE REPORTED KILLED.

Fifteen Thousand Troops Left Key West—Germany Does Some More Denying—Other News.

Fifteen Thousand Strong

Washington, June 13.—The first troops which sailed from Key West to day comprised seven hundred and seventy three officers, fourteen thousand five hundred and sixty four privates.

Washington, June 13.—A despatch says the army of invasion sailed at day break from Key West, fifteen thousand strong.

Washington, June 13.—Bills passed today granting American register to Northern Pacific Railroad steamers to transport troops to Manila and to the Arcadia to transport troops to Cuba. The bill providing for the payment of British Behring sea award went over. Newlands then began speaking on the Hawaii annexation resolution.

The war department has chartered two more vessels to transport troops to Porto Rico.

Reed signed the war revenue bill.

General Outlook

Washington, June 13.—Plans of administration are now showing definite shape. Forming a rendezvous near Key West marks the beginning of the general invasion of Cuba. The Porto Rican campaign goes forward on the heels of the Santiago movement. The third expedition to Manila will sail probably Wednesday. If overtures for peace have been made by foreign representatives abroad none have been received here. No attention will be given the peace talk. The Guantanamo skirmish is being discussed. Despite the reports to the contrary one cable to Cuba remains uncut. When the administration is assured that troops have landed on Cuba and three expeditions enroute to Manila, the army is ready to capture San Juan, the capital of Porto Rico.

duration. Again not a man was
killed on our side.

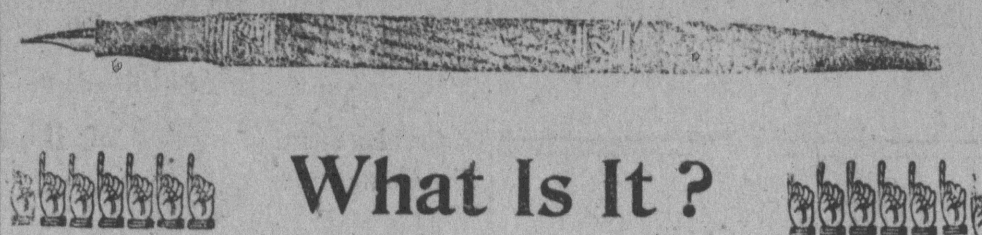
What does it mean? Bad Span-

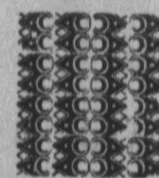

SUNDAYFIRE.

TWO PRIZE HOUSES and OTHER BUILDINGS BURNED.

Fire Almost Causes a Panic for Awhile.

Greenville had anything but a quiet day on Sunday. As the church bells were ringing just before 11 o'clock calling people to the morning worship a fire alarm was sounded. Volumes of dense smoke were seen rising from the tobacco section of the town and every heart was filled with fear as to what would be the result. Those who had already reached the churches hastily left, and those on the way there as quickly changed their course to the scene of the fire.

The fire was found to be burning fiercely in the feed room to the row of stables just in the rear of the Gorman factory occupied by the American Tobacco Company, and on the other side almost adjoining, the prizery belonging to O. Hooker and occupied by M. P. Jordan & Co. Everyone quickly realized that a fire in such a thick quarter meant disaster, and that it would require almost superhuman efforts to prevent the greater part of the tobacco buildings from being swept away.

In the stables where the fire originated was stored a great quantity of hay and nothing could have stopped a fire in there. The distance was so great and the firemen being unable to pull their engine by hand through the sandy streets, much time was lost before they could get horses to help carry the engine to the cistern at Roberts & Ficklen's factory. Before this could be done and a stream could be turned on one end and almost the entire roof of the Jordan factory was a mass of flames. The situation seemed to demand such urgent efforts that the firemen also made a mistake in trying to use a double stream at such a distance. The very inferior hose which they have would not stand the necessary pressure and the bursting of section after section seriously handicapped the firemen in their efforts.

Almost before it could be realized the fire had leaped over to another prizery belonging to Mr. Hooker and occupied by Strause Bros. and in a few moments that also was a mass of flames. The day was oppressively warm, and the heat from these two tall buildings was so intense that it could not be endured. The firemen would advance on the flames only to be driven back, and several of them, as well as a number of citizens who were aiding them, were overcome by the terrific heat and fell in their tracks. Others feeling the warning of approaching collapse had to withdraw. As nothing could be done to save these buildings attention had to be given to surrounding houses that were by now in great danger. The Gorman factory was closest to the body of the fire and was only saved by the hardest of work after being on fire several times. The Eastern and Greenville warehouses also had remarkably narrow escapes.

On the other side of the burning prize houses the dwellings on Dickinson avenue were in jeopardy. The fire soon spread to W. O. Barnhill's machine shop and destroyed that and then the dwelling house occupied by Robert Nichols and owned by W. T. Godwin. The stables on the W. S. Leggett property were destroyed and the large dwelling occupied by H. L. Coward was damaged and narrowly escaped. On the other side of the street the houses of Herbert Edmonds, H. F. Harriss, Zeno Moore and James Long (occupied by B. T. Baily) were in close danger. Some of these caught several times and had the flames got a good hold on either of them the many buildings behind them on Pitt street and out toward Little Washington would have been destroyed. People all along there had to move out for safety.

While the fire was at its height in the prize houses a brisk wind set in from the south-west that sent great

burning embers over the heart of town. This almost caused a panic and numbers of people had to hurry away to protect their homes. The dwelling of T. E. Hooker, the W. H. White house occupied by W. F. Morrill, buildings on the premises of C. D. Rountree and Wiley Brown and some others caught but were quickly put out.

The total loss by the fire is estimated at from \$8,000 to \$10,000. O. Hooker was the heaviest loser, his being \$4,000 with \$2,500 insurance. All the others, we understand, had some insurance. While everybody in the vicinity of the fire suffered some loss it will require the adjustment to deter-

mine the amount. Fortunately for the tobacco men the fire occurred when they had but little stock on hand so that they did not lose much beyond their fixtures and office equipments.

How the fire originated is not positively known, but it is rumored that boys had previously been caught in the stables playing cards, and the supposition is that some must have been in there smoking when the fire occurred.

Considering the odds against them the firemen, both white and colored, did heroic work. Willis Clark and Robert Hodges, of the hook and ladder crew, led the fight on their side of the fire and stuck to it until they fell exhausted.
