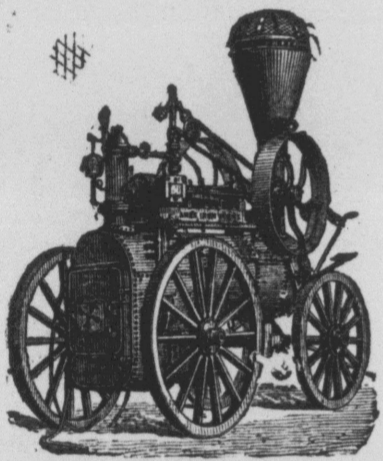

IN THE STORM

North Carolina Volunteers Suffered.

Corporal W. W. Perkins, of Co. E, second regiment of the North Carolina volunteers, stationed at Tybee Island, Ga., sent THE REFLECTOR a copy of the Savannah Press published the afternoon following the great storm that occurred last week. From the Press we take the following:

At no place along the coast near Savannah was the heavy wind more severely felt than at Tybee. This Island was in a bad fix almost all of last night. The wind is estimated to have blown almost 100 miles an hour at times during the night and it looked as if the most substantial houses would go down. The soldiers on the island suffered a great deal. This was particularly so of companies A and E, Second regiment North Carolina volunteers. These men suffered torments. They were housed in small tents until late at night and were only given about five minutes to prepare to seek better quarters. Some of them went to Wortham's and some to the United States fort. Others spent the night in boxcars. They were in such a hurry to get to substantial shelter and the wind was blowing such a gale that they left many articles of wearing apparel to wreck in the sand. Many of the soldiers came to the city on the train which arrived from the island this morning. They presented a most pitiful aspect. Many of them were without shoes and some had no hats. The men wanted to leave the island yesterday afternoon, but Major Withers, who was in command of the camp, declined to allow them to do so. He placed provost guards at the entrances of the train and kept everybody on the island. The men think this was unjust treatment when the island was overhung with clouds and the wind was blowing a gale. They went to their tents and tried to sleep, but no man closed his eyes. The wind simply played with the canvas coverings and about midnight swooped down upon them and carried the tents away entirely. Then the order was given to seek cover. The men did so as best they could. Many of them have not got the sand out of their clothes and eyes yet. About 15 of them came to Savannah this morning. They had no money and had had no breakfast. The commissary was completely destroyed by the storm. Kindhearted Savannahians placed food in their mouths and put hats on some of their heads and shoes upon the feet of others. They were worse off than Cuban refugees. There are some of the troops missing now, but those who came to the city think they will turn up all right. There were 216 North Carolina volunteers on the island, besides the officers. The regulars, who are housed at the fort, did not fare as badly as the volunteers.

Those troops who reached Savannah are loud in their praise of Captain J. T. Smith of company E, who, they say, did all he could for them and tried to get the major to let the men come to the city last night. The men left camp this morning without leave, but say they can stand the consequences. A courtmartial is preferable to another day on the island with the wind blowing almost a hurricane.

The water at Tybee rose a fearful height. It almost covered the island and made sleeping in tents on the ground almost impossible. The wet sand stuck to the men's coats and flannel shirts. When the order came for them to seek shelter the soldiers broke for the houses that seems the most sub-

stantial in double quick time. Many guns are now rusting in the sands of Tybee because their owners were in too big a hurry to get out of the twe to care for them. Hats, shoes, and underclothing can be found in the sand.

The Tybee railroad was not so badly washed but that trains could run over it. A train left the island this morning at 8 o'clock and reached Savannah about noon. The run was a long one, but those on the train were so glad to get away that they did not kick at the slow rate of speed of the train.

Later we received the following letter from Corporal Perkins:
SAVANNAH Ga., Sept. 1st '98.

DEAR MR. EDITOR:
No doubt you will be surprised to hear from me, but I thought I would send you an account of the terrible storm we had at Tybee Tuesday night you can read the paper and get fuller account than I have time to write. I have never experienced such before and I hope I never will again. You, or any one else that has never been in such a storm, don't know what it is. It was terrible. A crowd of us started to Savannah Tuesday evening about 7 o'clock, for we had heard there was a storm predicted. But Capt. Smith heard of it and sent down and had us arrested and sent back to our quarters. It was raining so awful hard we went to our tents and to bed, never expecting the

storm was going to be so bad. The wind blew hard and about 11 o'clock one of us looked out and every tent in Co. A & E was down and in about five minutes down came ours. We were undressed and without any light at all for the wind was too hard to keep one. Three of us kept the tent up so one could dress. I came out with no shoes, hat or shirt on and there were others in worse condition than myself. We came out and left everything behind us for we knew that it was impossible to save anything. I rushed out, the wind just took me off of my feet and carried me about 50 feet before I struck the ground and when I struck I caught on to a plank walk and had to hold on to it and walk to get to some place of safety. During this time it was raining hard and the sand nearly blinded and smothered any one. At last we reached the railroad track and there were several boxcars in which we took shelter until we got scared of the tide coming on us and ran and got on a side of a house and stayed there until daybreak. Houses were blown down, water works destroyed and the tin on the box cars was ripped off. The house we were seeking shelter under rocked and shook the windows were blown out and the roof of it blown off. But we did not move for we knew that it meant death to do so. Well we stayed up all night with wet clothes on for we had no dry ones and at 7 o'clock we took the train for Savannah. It took the train four hours to make the trip of 18 miles. We had to get off every five minutes to clear the track of sea weed and wreckage. There were about 50 soldiers aboard and we got soaking wet again for it was raining all the while we were coming.

I guess all of us will catch it when we go back, for we run away, but are going back today as it has fair'd up. You will see in the paper that the kind hearted Savannah people gave us dry clothes and shelter but I have not any of it. Ed. Greene and myself see together and are at a boarding are paying our own bills. The house and is nearly covered with tide and rain water.

We killed an alligator yesterday coming up to the government property and thing of the government are destroyed all our personal things. I have not. But I do not know yet for I have not been to camp since I run out that night. All the tents were new, but to come out of the factory, but are to shreds now. I do not know what are going to do but I guess you will receive a letter from some one else in a few days.

I can assure you and the people of Greenville that you do not know what a storm is. I would not go through it again for a \$1,000.

While 350 officers and men have been killed in battle or died of disease in camps between 1,200 and 2,000 volunteers and regulars. The Tribune has secured the names of 1,284 who died in camp, on transports, or at home after contracting the dread malady alone of the camps.

There is no doubt about the 1,284 whose names have been secured. Neither is there much doubt that there are hundreds dead whose names could not be secured on account of lack of records, and the inability or unwillingness of army officers to furnish lists of the dead.

The Tribune gives the following statistics of dead in each camp giving in every instance a full list of names and the nature of the disease. The list by camps is as follows:

Camp Thomas, 342; San Diego 341; San Francisco, 78; Camp Alger, 75; Camp Wikoff, 63; Jacksonville, 50; Tampa, 58; Miami, 26; Fernandina, Lakeland, Camp Meade, and other minor camps, in private hospitals, at home, &c., 115; State camps, 36; transports and hospital ships, 90; total 1,284.

Deaths are attributed to the following causes: Typhoid fever 515; yellow fever, 84; dysentery, 63; meningitis, 47; malaria 87; pneumonia, 61; cause reported as fever, 106; miscellaneous ailments or diagnoses not reported, 327.

Of the regular army, 290 are dead; Massachusetts is second with 130; Illinois third with 100; Michigan fourth with 91; and New York fifth, with 85.—Chicago Tribune.

His statement will command the attention and respect of every intelligent North Carolinian. The Newton Enterprise gives the following letter to a citizen of Newton, written by Mr. Page.

Rockingham, N. C., Aug. 29, 1898.
 My Dear Sir and Brother: I was from home when your favor came. I have time to reply briefly. The reports of the dreadful results of the reign of the vilest characters in some of the eastern counties are not exaggerated. Indeed, the "half has not been told." I am sure if the honest white men of the central and western portion of our good old State would come east and see for themselves they would return home with the resolution, every one of them, to work and vote to help throw off the yoke that is so oppressive and humiliating to the white men and white women in the eastern counties.

Things must change very soon or some portions of our beloved State will be reduced to degradation, poverty and ruin. The good people of this section are making a determined effort, and scores of white men who had strayed off into the fusion combine, are coming back to the angle-saxon banner, and will vote for honest government. Let the west heed the earnest, honest appeals of their brethren in the east and all will be well.

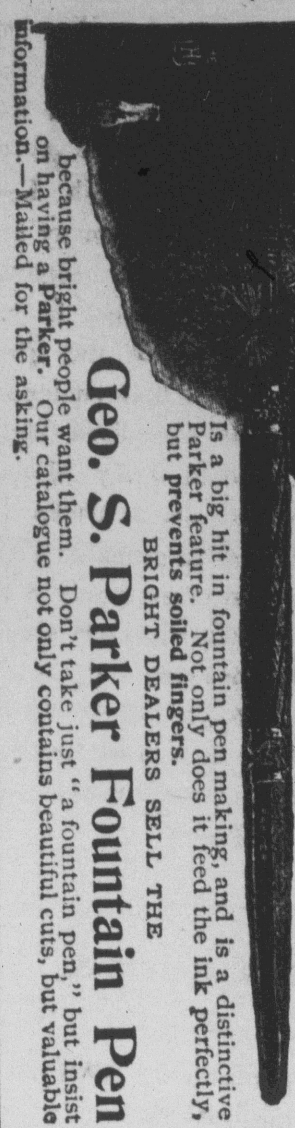

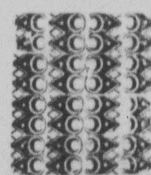

WILL BE MUSTERED OUT.

The orders have been issued at Washington for the mustering out of service of the second North Carolina regiment. The companies composing the regiment are doing garrison duty at different points, but they will all be brought back to Raleigh in a few days. Upon their arrival thirty-day furloughs will be issued to the men. All furloughs will be made to expire the same day, and any one failing to report at Raleigh on that day will be considered a deserter. No traveling expenses will be allowed the men who go to their homes, but they will receive commutation on furlough rations at the rate of twenty-five cents each a day.

Sufficient details of men will be retained in Raleigh to guard the government's property and assist in the clerical work of winding up the regiment's affairs.

At the muster-out the men will be examined, physically, in a most thorough manner. They will then receive all pay and allowances due them.

Since the above was put in type we see from Sunday's papers that there was a change at the last moment and that the second regiment was to stay in service and that the first would be mustered out. Commenting on this change the Raleigh Post says:

It is understood here that the order mustering out the First Regiment instead of the Second was made at the instance of Governor Russell, and that the Governor's influence was exerted in the interest of his political friends who are officers in the Second, although it is notorious that the privates, almost

to a man, have been clamoring for weeks, to be mustered out. On the other hand, a large proportion of the First Regiment are willing to go to Cuba under General Fitzhugh Lee, though it is not claimed that many are anxious to go. It is a fact, acknowledged by all who are informed in regard to military affairs, that the First Regiment is one of the best equipped, best drilled and best disciplined regiments in the Seventh Army Corps. No one has put forth similar claims in behalf of the Second Regiment. That the Third Regiment of negroes is to be retained in the service while our crack regiment is to be mustered out, is so notoriously in the interest of the Governor's colored friends who are drawing fat salaries from the government that to mention it is sufficient.
