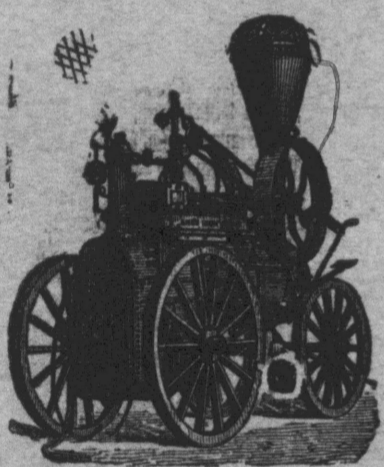

The reports that come in from the primaries Saturday are most gratifying. At every precinct there was a large attendance, showing the interest that white men feel in the approaching election and the return of good government. Greenville township has never before had such a large primary meeting, between 200 and 300 being present, and the same seems true of every other township. A number of former Populists participated in the primaries. Now let everybody come to the county convention next Saturday. Whether you are a delegate or not, come, and let such an inspiration go out from the great gathering that will bring Democratic success and the restoration of white supremacy in the county.

After the Greenville township primary had finished its regular business Saturday afternoon, Mr. A. A. Forbes was called on for a speech. He responded in a manner that brought round after round of applause. Mr. Forbes was the Populist Senator for this county four years ago. He said he was honest in leaving the Democratic party as he thought it was departing from its principles. He then thought the principles of the Populist party were right, and they would have been right had not the party gone head and boots to the Republicans. At the age of 17 years, he said, he put aside his school books and joined the Confederate army to battle for his home. He is no less a patriot now than then, and in defense of his home, his wife and his children, he takes his stand with the white men for a white man's government. He said he does not believe there is any Democratic party in Pitt county nor any Republican party, and he knows there is no

Populist party—but there are two parties, the white party and the negro party, and it is clear enough which one every white man should belong to.

Nothing could be plainer than that fusion in Pitt county means that the Populist leaders are under the control of the Republican bosses and are trying to deliver the rank and file of the Populist party into the Republican camp. Look at the facts in the case for a moment: On Saturday, 10th inst., the Republicans held their convention. C. M. Bernard stated in open convention that they would fuse with the Populists until they could get an election law like they wanted engrafted in the constitution so that the Legislature could not change it, and as they needed the Populists to help them do this they were going to divide the offices with them again on the same basis as two years ago. He then went on and named the men whom they should nominate for their part of the ticket. Being boss of the situation, his convention endorsed what he laid before them. Now when the Populists county convention met on the 15th what do we see? When J. A. Lang, chairman of the executive committee, called the convention to order not one reference did he make to fusion, and the matter was not put before the convention at all to give the delegates any voice in it. And when R. L. Joyner took the seat as permanent chairman of the convention he went ahead calling for nominations for the offices that the Republicans had left, giving no reason why the other places were skipped over, showing that the Populists were simply doing the bidding of Bernard and Harry Skinner. A. J. Moye, who was placed before the convention for renomination for the Senate, soon discovered that he was not the choice of the Republican boss and his allies among the Populist leaders, and withdrew as stated in our report of the convention. He had tried to keep the Populist party from being swallowed by the Republicans, and while in the Senate two years ago prevented the passage of a bill which had for its object the placing of Greenville under a still worse government than it now is. Slade Chapman occupied a similar position as Mr. Moye and both of them voted against Fritchard for Senator. For these reasons they did not want such men any more. The Republicans could not use them as they wished and did not want that kind of men nominated. Those nominated were just such men as the Republicans wanted, men they can use in carrying out their plans. It is no wonder that the better element of the Populist party is repudiating such a deal and on election day it will be found that large numbers of them will not support the fusion ticket.

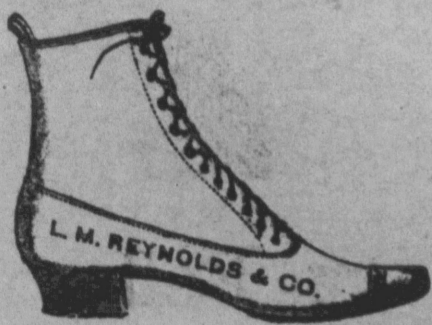
