THE RAWLS TRIAL.

The Evidence in the Case.

[Continuation of the defendant, Rawls testimony.]

I went to Sugg's office, did not know at time whether King was struck. I shot because he had fired on me and I thought I was in danger as he was trying to shoot again. I had no purpose of seeking difficulty when I first started through alley and had no knowledge of King's presence at stable. Had my wound dressed in Sugg's office, left down as soon as that was over, and went home. Remained home till Friday and went to Hathaway's about two miles away. Left the county about a month later and went to Beaufort county, came back home occasionally till September and remained home until November. Then left for Little Rock, and from there went to Galena, Kas., stayed there until April, '92 and went to Oklahoma. Left there and came back home for two months then went to New York, left there in '95 and came back home again. That fall I settled in Hertford county and lived there since, mother, sister and son being with me. I avoided arrest because I did not think I would be safe in jail as it was in charge of deceased's brother, and did not think I could get a fair trial with the Sheriff's office in his connection. Through friends I offered to surrender if permitted to give bond. I knew deceased was an overbearing, violent man.

Cross examined—Homicide occurred in '90. Tucker was Sheriff at time. R. W. King was deputy Sheriff, King succeeded Tucker and went out of office in '96. I had settled down then and never came back to the county until brought here. Was in the county perhaps seven or eight times after first leaving. Went by name of Moore in Kansas and Oklahoma, Hyman in New York and Teel in Hertford. Was never arrested in Oklahoma. Married out there, my father-in-law visited this town. I never had lawyers retained, don't know what Hyman did. Never came to surrender. Father-in-law came here in spring of '95. I had no fixed home at that time. I knew Harrington was elected Sheriff in '96. I knew King was violent man but had never had any trouble with him before that Saturday. I was frightened at his manner then and was also mad. I felt outraged at his conduct, was not armed. Brought a pistol from home with me Monday. It was 38 caliber and had four balls in it, one chamber empty. Don't remember about testifying at Mayors trial, I was not found guilty of disorderly conduct. I might have used expressions that morning that cannot now be recalled. Was in Sugg's office that morning, did not tell him I was going to whip King, but Sugg told me King was making threats against me and I had best avoid him. I kept out of his way. Through the alley was my nearest way to go to store after bundle, did not go on after Hyman stopped me. I did follow on shortly behind them to see what they did. I did not go for the purpose of taking a hand in fight. Had no particular love for King at the time. I wanted to see what was going to take place. Hyman pushed King back, they

did not get out of my sight, a lick or two passed when they first clinched. King did not offer much resistance while being pushed back it was perhaps 30 feet from where they clinched to where they stopped around corner of barroom, I only moved enough to keep in view of them. When I first saw his pistol it was leveled at me. As King walked with Hyman toward me he said he could whip me, don't remember what Hyman said. I don't remember seeing anyone except keel and the parties engaged, others may have been present. Keel and myself were previously on good terms, I used his horse to go home Saturday night. He spoke to me on train when I was being brought here, I did not recognize him at first. I asked him not to do anything against me, he told me he would tell only the truth.

Don't remember Dr. O'Hagan saying to me on day of homicide that I had better go on home or I would get in trouble with King, don't remember what we had started to L. & S. office for.

Re-direct examination—Tucker was Sheriff when trouble occurred and Dick King deputy, King succeeded Tucker, Harrington succeeded King in '96. I did not surrender when my father-in-law came out here because I did not have funds to pay for a trial.

Re-cross examination—My father-in-law was not a man of much means. He was a lawyer and said he would appear for me. Do not know about other counsel, don't know what Hyman had done about getting counsel. I was in indirect communication with Hyman most of the time I was away.

J. G. MOYE.

I knew Rawls prior to April '90, his general reputation was good. I know general reputation of Hyman, it is good.

W. H. RAGSDALE.

I knew general reputation of Rawls up to '85, it was good.

B. C. PEARCE.

This was a witness for State which the defense did not cross examine. He was here recalled by the defense. I knew Rawls prior to '90, never heard his reputation discussed. General reputation of Hyman is good. I knew J. M. King, but can't say what his character for violence was previous to the difficulty.

ALEX SPEIGHT.

I was on Greenville police force in 1890. On the Monday of difficulty about 11 o'clock I had conversation with Rawls, went toward Hooker's bar after conversation and was met by King, who was standing in front of stable alley way while I was talking with Rawls. I started towards bar and King started in same direction, we met

about corner of building, King asked me "what did that d— have to say about me?" I told him he said nothing, and that if he would let Rawls alone Rawls would not trouble him. He replied that he was going to whip Rawls. I had been on police force several years. Can't say that I knew public opinion of King's reputation for violence.

Cross examined—I had heard that the trouble between the parties had been settled at time I was talking with Rawls. It was three hours or more before homicide.

J. L. HARRINGTON

I live at Aulander, Bertie county. I know defendant, have known him three years by name of G. A. Teel. He lived about 3 miles from Aulander, Hertford county, for 3 years. His general character among the people was good.

ALEX LASSITER

I have known defendant 3 years he lived about 4 miles from Aulander, in Hertford county, under name of George A. Teel, general character good.

W. T. MINTON.

I live at Aulander, Bertie county am a member of the Board of County Commissioners. I thoroughly knew character of defendant in the community and had much dealing with him, his character is good.

W. B. GREENE

I knew Rawls prior to homicide, his general character was good. I was employed by W. H. Cox at time of difficulty. Rawls traded with Cox and had account there at time. Cannot say whether he bought anything that particular day I have hunted for books but think they have been destroyed.

Cross examination—Cox store at that time was on corner near post-office, where H. C. Hooker now keeps.

S. V. JOYNER

I knew the deceased, his general reputation was that he was a man of high temper and would fight, and a violent, overbearing man.

Cross examination—He had a high temper and would fight.

A. D. HILL

I knew the deceased, he had the general reputation of being a violent, high tempered man, he would weigh 200 pounds or more and was a strong muscular man.

STATE RESUMES

The defense here closed its side of the case and the State put on rebuttal evidence.

DR. C. J. O'HAGAN

was recalled. Said he was in Sugg's office [CONTINUED ON SECOND PAGE.]

office and saw Rawls before homicide. Rawls said he had been insulted and wronged and was going to whip King. I told him to sit down, that he could not whip anybody, that King could wipe up the earth with him. This was some 20 or 30 minutes before pistol shots.

Cross examined—Rawls was drunk, his physical condition was not the equal of King. General character of Rawls and Hyman both very good. Did not know anything of deceased's general character for violence until after his death. He lived about 15 miles from Greenville.

T. B. CHERRY.

I saw a portion of the difficulty. I was going through alley way from street to stables, saw Hyman, King and Rawls, had heard of some trouble between them but thought it was settled. I passed by them into stables but from their manner thought trouble was on again. Hyman knocked off King's hat, King struck Hyman in mouth, Rawls went back next to left gate of stables, Hyman pushed King back, Rawls fired and King gave away. Two more quick shots followed when Rawls caught hold of his left leg and left towards street. Hyman was letting King down when I stepped up and said turn him loose. Hyman said he would do so if I disarmed King. I took King's pistol. Rawls fired first shot. They were about 15 feet apart. Don't know how many times King was struck. It has been so long and there was so much passing I do not remember who was there. Think I saw Whitehead, Skinner and Harriss.

Cross examined—I heard one shot, then heard two so close together could not distinguish them. King was giving away when the two shots were heard. keel and myself have been talking the matter over this morning in room before other witnesses. keel was reading evidence published in THE REFLECTOR and all were discussing it. King and Hyman were standing between back door of barroom and stables, Rawls was over on other side of alley, I was just inside of stable door. I would have been further down stable but stopped when heard the remark. Do not recollect seeing any body as I passed through alley from street to stables. Harriss was near stable door next to office of stable, 3 or 4 feet inside.

E. A. MOYE.

I knew deceased, he was a man of undoubted courage, quick to resent an insult, but never considered violent. I was Clerk of Court at time.

Cross examination—Was said to be distantly related to deceased but did not know how near it was. Am now closely related by marriage.

TESTIMONY CLOSED

Another character witness was introduced and the State showed its inability to get W. C. Dancy and again closed the case. Council then discussed the detail of argument before the jury and Court took a recess.

At the opening of Court Thursday afternoon counsel began arguing the case before the jury. J. L. Fleming opened for the State and was followed by Donnell Gilliam and F. G. James for the defense. These speeches consumed the afternoon session and Court took a recess until Friday morning.

FRIDAY.

This morning Solicitor L. I. Moore resumed the argument for the State and was followed by Harry Skinner for the defense, the two speeches occupying the morning session of the Court.

This afternoon Gov. Jarvis made the closing speech for the defense, not being quite through when THE REFLECTOR closed its forms for the press. He was to be followed by C. B. Aycock with the closing speech for the State. A session of the Court will be held tonight when Judge Moore will deliver his charge and give the case to the jury.

A large number of ladies were present this afternoon listening at the speeches.

STATE NEWS.

Happenings in North Carolina.

The messenger says Spring Hope is moving to have an electric light plant.

Four prisoners escaped from the penitentiary at Raleigh about 3 o'clock Wednesday morning. Two of them were Uriah Bell and Sherrill Bell, sentenced to 30 years from Beaufort county for the murder of Mr. Bonner at Aurora. Sherrill Bell was re-captured, but Uriah is still at large.

Three boys of about 14 years of age have been imprisoned at Raleigh for highway robbery.

Several towns in the State have organized anti-saloon leagues.

C. H. Eubank, a soldier from North Carolina, died of typhoid fever in Havana a few days ago.

The battle flag of the Second North Carolina Regiment, C. S. A. that was taken by a Massachusetts officer during the war, has been returned to the State. It is said to be well preserved.

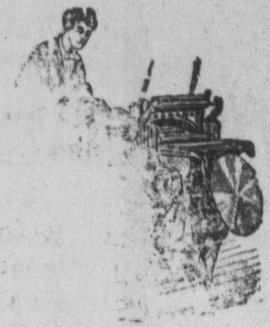

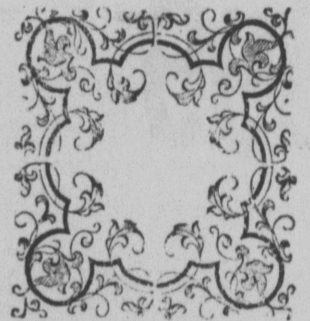

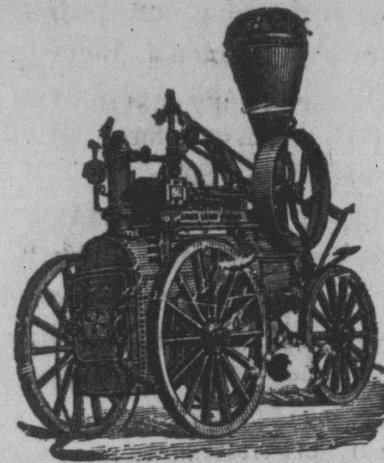
