THE LEGISLATURE.

They Keep Doing Good Work.

SENATE.

Below are some of the important matters introduced:

Senator Whitaker—To provide for the election of a State Librarian.

Senator Ward—To provide separate cars for the races.

Senator Daniels—To increase the permanent school fund of the State.

To appoint W. H. Long a justice of the peace. **KLE**

To validate the registration of deeds and mortgages where clerks of courts are parties.

To validate certain deeds and mortgages that have been registered without sufficient certificate of notary public under seal. Not to affect purchasers for value without notice.

HOUSE.

Mr. Eaton—To regulate appointment of guards over convicts employed on State farms.

Mr. Winston—To regulate trials of civil actions before justices of the peace, and to amend Sec. 833 of the Code.

Mr. Barnhill—For the better protection of landlords in certain cases.

Mr. Allen of Wayne—To regulate the fees of county officers in probating and registering certain legal instruments.

To regulate the fees of county officers and reduce the salaries and fees of the same, introduced by Mr. Winston, of Bertie. Tabled.

To amend Sec. 2155 of the Code, in relation to the probate of wills.

To amend Sec. 3736 of the Code, in relation to Solicitors of Superior court, so as to make it unnecessary for them to attend purely civil terms of that court, and provides against any fees, etc., being paid them at such terms.

Mr. Carroway—To create graded school system at Kinston.

Mr. Mauney—For the better protection of hotel and boarding house landlords and livery stable keepers.

Mr. Winston—Providing for the separation of white and negro passengers on railroad trains—another "Jim Crow Car" bill.

To pay Judge Norwood \$580 back salary as judge of the Superior Court.

For the relief of sheriffs and tax collectors, authorizing those in whose hands the books for 1895-'96-'97 are to collect taxes according to the law as it exists at the end of the present session of the Legislature.

The War.

Matters are reported quieter around Manila today. There was some little fighting yesterday but it did not amount to much. The American losses in Sundays engagement were 35 killed and 40 wounded, while the Filipinos lost 2000 killed and 3500 wounded and 5000 taken prisoners.

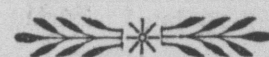

"MAKES THINGS"

Charity and Children, the thoughtful and interesting paper published at the Thomasville Orphanage, says in its issue of this week:

"The growth of Charlotte is astonishing. The progress it has made within the past three years—hard years they are called—gives glowing promises of its future. They claim to have 25,000 people now, and they are mostly white folks, too. They make things and this is the secret of their success. You cannot build up a city by simply selling calico."

That hits off the case to a nicety. Charlotte is prosperous and growing because it "makes things." It makes them and sells them to outsiders. No town can ever prosper under a system of merely swapping dollars among its own citizens.—Charlotte Observer.

We want the business men of Greenville to read that sentence over several times: Charlotte is prosperous and growing because it "makes things." Then ask the question, what is Greenville doing? or rather, what is Greenville making? Here we have a town of more than 3,000 people, with unlimited natural advantages surrounding us, and not a manufacturing enterprise larger than a buggy factory. True the town has had much growth of late years, but this can be attributed solely to the tobacco industry, not the manufacturing but the developing of a big market. Had the town kept pace along other lines and established factories, its growth and progress would have been much more rapid.

It seems that every man who comes to Greenville prospecting goes to looking for a store with a view of engaging in the mercantile business. And this is one business that is already over-supplied here, there being stores enough to furnish the needs of at least double the number of people who do their trading in Greenville. (It might be said, too by way of parenthesis, that some of the stores here are not making enough to afford to advertise in their town paper—at least they say they can't afford to advertise, but they ought to do so to make money.)

What we need is not more stores, but something to bring more trade to stores already here. We need factories that will give people employment and distribute largesums among them, factories that will "make things" and sell them to outsiders. This doctrine has been a key note of THE REFLECTOR through all these years and it is

going to keep on singing that tune. Yes, Greenville needs factories, and the sooner our business people become aroused to the fact the better it will be for their business and for the town.

On Monday the Senate ratified the treaty of peace with Spain by a vote of 57 to 27. For some days there had been doubt as to the result when the test vote should come, but after the outbreak of the Filipinos on Sunday it was expected that the ratification would prevail.

The big meat packers of Chicago say that Miles' recent talk about that embalmed beef has cost them millions of dollars. Next time they should not work off a lot of bad meats on the government for our soldiers to eat. Miles' exposure serves them right. The public believes they did put off the bad beef on the soldiers, and that's where the trouble comes in.

Some people go to almost any extreme to bring out something novel to attract attention. A few days ago there was a telephone wedding at Williamsport, Pa., the bride and groom standing seventy miles apart and having the ceremony performed over the telephone.

The Amendment to The Constitution.

The following is the amendment to the Constitution proposed by the Committee on Elections in the present General Assembly. Both the Senate and House have had a joint Caucus, and a great majority of the members are said to be in favor of submitting the proposed amendment to a vote of the people.

The General Assembly of North Carolina do enact:

That article VI of the Constitution of North Carolina be, and the same is hereby repealed, and in lieu thereof shall be substituted the following article of said Constitution:

ARTICLE VI.

Section 1. Every male person born in the United States and every male person who has been naturalized, 21 years of age and possessing the qualifications set out in this article, shall be entitled to vote at any election by the people in the State, except as herein otherwise provided.

Sec. 2. He shall have resided in the State of North Carolina for two years, in the county nine months, and in the precinct, ward or other district in which he offers to vote, six months next preceding the election: Provided, That removal from one precinct, ward or other election district, to another in the same county, shall not operate to deprive any person of the right to vote in the precinct, ward or other election district, from which he has been removed until six months after such removal. No person who has been convicted or who has confessed his guilt in open court upon indictment, of any crime, or may hereafter be, imprisonment in the State prison, shall be permitted to vote unless the said person shall be first restored to citizenship in the manner prescribed by law.

Sec. 3. Every person offering to vote shall be at the time a legally registered voter as herein prescribed and in the manner hereafter provided by law, and the General Assembly of North Carolina shall enact general registration laws to carry into effect the provisions of this article.

Sec. 4. Any person presenting himself for registration or voting shall be able to read and write any part of the Constitution in the English language, and shall have paid by the first day of February the poll tax for the previous year, as prescribed by law, and shall exhibit the receipt therefor. Poll taxes shall be a lien only on assessed property, and no process shall issue to enforce the collection of the same except against assessed property.

Sec. 5. No male person who was on January 1, 1867, or at any time prior thereto, entitled to vote under the laws of any State in the United States wherein he then resided; and no son or grandson of any such person not less than 21 years old at the date of the adoption of this amendment of the Constitution shall be denied the right to register and vote at any election in this State by reason of the educational qualification prescribed in this article, provided he shall have registered prior to December 1, 1902, in accordance with the terms of this article, and no person shall be allowed to register under this section after that date.

Sec. 6. A separate registration under this section shall be made by the registration officer who shall, at the close of the registration in the year 1902, make a sworn copy in duplicate of the list of persons registered under this section, showing in detail whether the applicant registered as a voter of 1867, or prior thereto, or as a son, or grandson of such voter, and the registration officer shall deposit one of said duplicates in the office of the Secretary of State, to be by him recorded and preserved as a part of the permanent records of his office, and the other of said duplicates he shall file with the clerk of the Superior court of his county, to be by him recorded in a book provided therefor. All persons whose names appear on said list shall be admitted to register for all elections in this State, unless otherwise disqualified. The General Assembly shall, at its first session after the adoption of this amendment, provide the manner in which the classes of persons provided for in this section shall register.

Sec. 7. All elections by the people shall be by ballot, and all elections by the General Assembly shall be viva voce.

Sec. 8. Every voter in North Carolina, except as in this article disqualified, shall be eligible to office, but before entering upon the duties of the office he shall take and subscribe the following oath: "I, ———, do solemnly swear that I will support and maintain the Constitution and laws of the United States and the constitution and laws of North Carolina, not inconsistent therewith, and that I will faithfully discharge the duties of my office as ———, So help me God."

Sec. 9. The following classes of persons shall be disqualified for office: First, all persons who deny the being of Almighty God. Second, all persons who shall have been convicted, or confessed their guilt on indictment pending and whether sentenced or not, or under judgement suspended, of any treason or felony, or any other crime for which the punishment may be imprisonment in the penitentiary, since becoming citizens of the United States, of corruption and mal-practice in office, unless such person shall be restored to the rights of citizenship in a manner prescribed by law.

Sec. 10. This act shall be in force from and after its ratification.

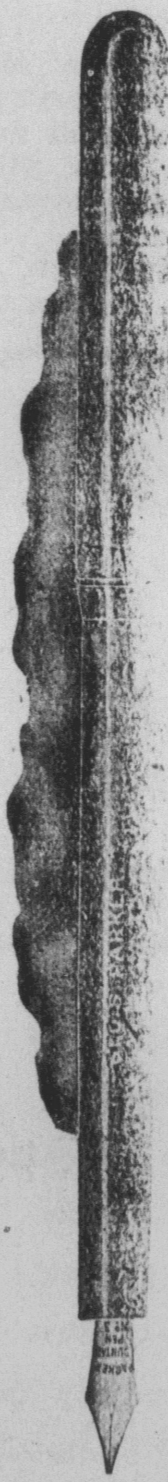

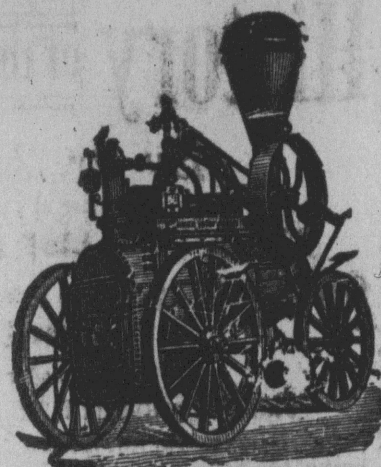
