### HOMICIDE AT BETHEL.

W. C. Nelson Kills W. N. M. Hammond.

Mr. Robert Staton keeps a bar room at Bethel. Mr. W. C. Nelson was a clerk in this bar room, and he also owned a pool table which was run in connection with the saloon. Mr. W. N. M. Hammond was one of the Saturday night patrons of the establishment. After being there sometime he and Nelson got into a dispute about a small amount that Hammond owed for the use of the pool table. In the dispute Hammond struck at Nelson with a beer bottle and Nelson shot at him with a pistol. This was followed by a fusillade of beer bottles from one side and of pistol shots from the other, and when the smoke cleared away Hammond lay dead upon the floor and Nelson's skull was fractured.

The Coroner, C. O'H. Laughinghouse, went over Sunday to hold an inquest, and the above is about the sum of the evidence brought out at the investigation.

Here is another striking lesson from the open bar room and gambling den. A corpse, a widow and several orphans, another home wrecked because the father's hands are stained with blood, relatives on both sides crushed with sorrow and filled with bitterness that a life time will not blot out. All this to satisfy the greed for gold of the men whom the law gives a license to stand behind the bar and carry on a business that damns men's souls and fills the land with widows and wretchedness. And Christian people stand aloof and allow such to continue instead of rising in their might and driving the evil from the land.

### FIRE AT SNOW HILL.

Several Buildings Destroyed.

THE REFLECTOR learns by telephone from Snow Hill, the county site of Greene, that a very destructive fire visited that town Sunday morning. The fire was discovered about 3 o'clock in the store of J. B. McGowan, and this, together with the stores of J. J. Potter, J. F. Harper, J. H. Aswell, Ferrell's barber shop and the law offices of G. M. Lindsay and L. V. Morrill, were destroyed. Several other buildings caught and were more or less damaged.

We could not learn the amount of the loss or how much was covered by insurance, except that our informant said he thought but few of the losers had insurance. Such a fire is a serious loss to Snow Hill.

### SUPERIOR COURT.

April Term in Session.

The April term of Pitt Superior Court began this morning with Judge Fred Moore presiding and Solicitor L. I. Moore representing the State.

Flanagan, J. R. Pippin, G. A. Clapp, Franklin Edwards, W. A. G. Gaskins, L. B. Elks, J. R. Buck, W. A. James, Jr., C. J. Briley, E. M. Cheek.

The Judge made an able charge to the jury and began the work of the term in that business like way that characterized the two former courts at which he has presided in this county.

Upon the calling of the docket several State witnesses failed to answer to their names, and the Judge ordered the Clerk not to allow any to prove their attendance after today who fail to be present and answer when called.

### SMALLPOX AT PARMELE.

The Infected Man at Large.

A case of smallpox was discovered Saturday at Parmele and that town was very much excited over it. We hear that the case was a negro who ran away from Parmele sometime ago for some crime, contracted the disease and came back. So it seems that smallpox caught him if the constable could not.

It was also rumored here this morning that the man was driven away from Parmele Sunday and was traced in the direction of Greenville as far as Staton's mill. This may only be a false rumor, as we could hardly believe the people of Parmele would be guilty of driving out a man infected with a disease to scatter it over the county, instead of taking proper steps to isolate the case and stamp out the disease.

Since writing the above we inquired by wire to Parmele and were told that the man, whose name was Bill Dancy, ran away from Parmele Saturday night going in the direction of Greenville or Washington. If the man was seen at Staton's mill he was evidently headed towards Greenville and the authorities here should keep a lookout for him.

The flood of prosperity seems to be turned at last toward North Carolina. From every locality in the State comes news of new industrial enterprises, fostered by the money and energy of our own people, as well as attracting that of others.

## WHITE SUPREMACY MADE PERMANENT.

### Full Text of The Constitutional Amendment to be Voted On By The People In August, 1900.

It Allows All White Men Who Register Under It Before 1908 To Vote For All Time, Whether They Can Read And Write Or Not.

Section 1. That Article VI of the Constitution of North Carolina be, and the same is hereby abrogated, and in lieu thereof shall be substituted the following Article of said Constitution:

#### ARTICLE VI.

### SUFFRAGE AND ELIGIBILITY TO OFFICE—QUALIFICATIONS OF AN ELECTOR.

Section 1 Every male person born in the United States and every male person who has been naturalized, twenty-one years of age, and possessing the qualifications set out in this Article, shall be entitled to vote at any election by the people in the State, except as herein otherwise provided.

Sec. 2 He shall have resided in the State of North Carolina for two years, in the county six months and in the precinct, ward or other election district in which he offers to vote, four months next preceding the election: Provided, That removal from one precinct, ward or other election district to another in the same county, shall not operate to deprive any person of the right to vote in the precinct, ward or other election district from which he has removed, until four months after such removal. No person who has been convicted, or who has confessed his guilt in open court upon indictment, of any crime the punishment of which now is, or may hereafter be, imprisonment in the State Prison, shall be permitted to vote, unless the said person shall be first restored to citizenship in the manner prescribed by law.

Sec. 3. Every person offering to vote shall be at the time a legally registered voter as herein prescribed and in the manner herein provided by law, and the General Assembly of North Carolina shall enact general registration laws to carry into effect the provisions of this Article.

Sec. 4. Every person presenting himself for registration shall be able to read and write any section of the Constitution in the English language; and before he shall be entitled to vote, have paid, on or before the first day of March of the year in which he proposes to vote, his poll tax as prescribed by law, for the previous year. Poll taxes shall be a lien only on assessed property, and no process shall issue

to enforce the collection of the same except against assessed property.

Sec. 5. No male person who was on January 1, 1867, or at any time prior thereto, entitled to vote under the laws of any State in the United States wherein he then resided, and no lineal descendant of any such person, shall be denied the right to register and vote at any election in this State by reason of his failure to possess the educational qualifications prescribed in section 4 of this Article: Provided, He shall have registered in accordance with the terms of this section prior to December 1, 1908. The General Assembly shall provide for a permanent record of all persons who register under this section on or before November 1, 1908, and all such persons shall be entitled to register and vote at all elections by the people in this State, unless disqualified under section 2 of this Article: Provided, Such persons shall have paid their poll tax as required by law.

Sec. 6. All elections by the people shall be by ballot, and all elections by the General Assembly shall be viva voce.

Sec. 7. Every voter in North Carolina, except as in this Article disqualified, shall be eligible to office, but before entering upon the duties of the office he shall take and subscribe the following oath: "I do solemnly swear (or affirm) that I will support and maintain the Constitution and laws of the United States, and the Constitution and laws of North Carolina not inconsistent therewith and that I will faithfully discharge the duties of my office as..... So help me, God."

Sec. 8. The following classes of persons shall be disqualified for office: First, all persons who shall deny the being of Almighty God. Second, all persons who shall have been convicted or confessed their guilt on indictment pending, and whether sentenced or not, or under judgment suspended, of any treason or felony, or any other crime for which the punishment may be imprisonment in the penitentiary, since becoming citizens of the United States, of corruption and malpractice in office, unless such person shall be restored to the rights of citizenship in a manner prescribed by law.

Sec. 9. This act shall be in force from and after its ratification.

### PUNISHING AN EDITOR.

The Curious Method Adopted in a South American Country.

Curious methods of punishing indiscreet editors are in vogue in some countries. In "South American Sketches" Mr. Crawford describes the interesting experience of an editor who had been unfortunate enough to give offense to the ruling powers by the freedom of his criticisms.

The editor was arrested and confined in a narrow passage between the cages of two jaguars, notorious for their bad tempers and their intense dislike for human society.

### A LESSON IN COOKING.

How a Hobo Served Up a Dish of Toast Chicken.

"The first time I ran away from home I learned a trick or two that was worth the while. I had a well known business man. Three of us was caught a freight train and got some 60 or 70 miles away from home before the first nightfall. Then we didn't know where to spend the night. Several attempts to quarter ourselves in empty box cars on the side track of a little village only resulted in our being chased away and threatened with arrest, so we went to the outskirts of the place and built a fire on the bank of a little creek. Of course we hadn't.

"Well, he said, 'if you fellers'll ketch a chicken I'll show you a trick that'll be useful to you.

The veteran member of the nonaue fraternity wrung its neck, perked off its head, cleaned it and going down to the creek wadded it up, feathers, feet and all, in a big ball of yellow clay. This he rolled into the fire and scraped the burning embers up around it. The clay soon hardened, and we could see it among the wood coals gradually becoming a bright cherry red. When it did so, the cook rolled it out again, let it cool a little and then broke it open with a stone. The feathers had stuck to the baked clay and a clean, inviting chicken was ready to be served. 
