BETHEL CASE ENDED.

Defendants Enter a Submission During Progress of Trial.

The testimony for the State in this case was completed early Monday afternoon and the defense began putting on its witnesses, not having finished when court took a recess for the night.

At the opening of court this morning counsel for the defense entered a submission to murder in the second degree for Cullen Moore, manslaughter for Hoyt Moore and assault and battery for Wm. Wilkins. This submission was accepted by the State and Judge Hoke instructed the jury to render their verdict accordingly.

In passing sentence upon the defendants Judge Hoke said he thought this a wise and proper conclusion of the case. Cullen Moore was sentenced to hard labor in the penitentiary for a term of 21 years, and Hoyt Moore for a term of 11 years. Judgment was suspended over Wm. Wilkins, and after administering the insolvent debtors oath to him he was released from custody.

DEWEY IN NEW YORK.

New York, Sept. 26.—The United States cruiser and flag ship, Olympia, with Admiral George Dewey on board, arrived this morning, two days ahead of schedule time. The Olympia was sighted to the south-east of Sandy Hook lightship at 5:49, and steaming slowly past the hook at 7:15 dropped her anchor in the lower bay.

As the big white vessel came in the Admirals salute was fired from the proving grounds and the Olympia responded with the guns that spoke such terror to the Spanish fleet in Manila Bay. Every whistle in the harbor screeched a welcome.

The city is gorgeously decorated in preparation for Dewey's reception and thousands of people from all parts of the country are coming in.

LAW ABIDING PEOPLE.

Judge Hoke Says This of Pitt County.

The people of Pitt county have cause to feel a just pride at the high compliment paid them by Judge W. A. Hoke, who is holding this term of our court. At the conclusion of the second murder trial before him at this term he took occasion to speak of the demeanor of the people through these severe trials they had passed in the last few months.

Judge Hoke said "I want to commend the conduct of the people of Pitt county. They are a law abiding, self-contained people. Your county officers are efficient and your juries are careful and wise. You bring your criminals to the bar to have them dealt with instead of taking the law in your own hands. To deal with crime as you have in the past week will go far towards lessening its occurrence. I have never seen a community where the people showed more self-restraint under such a wave of crime, and acted more wisely than have the citizens of Pitt county."

THE REFLECTOR thanks Judge Hoke for this compliment to our people. While they have respected the law and shown great self-restraint and calmness under the many shocking crimes that have occurred, we can also add that the manner in which His Honor has conducted this term of our court, his marked ability, firmness and fairness in every case before him, has greatly increased their respect for the majesty of the law. With such men as Judge Hoke on the bench the people have no need to take the law in their own hands, but can rest assured that justice will be done.

WASHINGTON LETTER.

From Our Regular Correspondent.

Washington, D. C., Sept. 25, '99

A distinction without a difference is that made by Republicans who say that Mr. McKinley will not make some speeches in Ohio, but will probably make speeches from the rear platform of the train upon which he will pass through Ohio on his coming trip to and from the west. It really looks as though that trip had been arranged solely for the purpose of giving Mr. McKinley an opportunity to make some speeches in Ohio, which he has been assured by his party managers are very much needed. He and his party managers may call them "rear-platform" or any other kind of speeches they please, but the people will know them for the stump speeches they will be, and they will not be inclined to think any more of the President of the United States, who is willing to engage in such business, even to pull his party out of a very deep hole.

Boss Platt has been in Washington, and it is believed that he tried to make a deal for the Vice-Presidential nomination for a New Yorker, it being now pretty generally understood that Mr. Hobart is to "voluntarily" retire, and that Governor "Freddy" doesn't want the nomination. It is said that Platt told Mr. McKinley that any man from his State would please him, but suggested Senator Depew and Secretary Root as available men. One of Mr. Depew's close friends say that having just secured a full term in the Senate, he would not for a moment think of giving it up to accept the Vice-Presidential nomination. Secretary Root might take it, if he could get it.

Since Reed's retirement there has been much talk about members of the House being allowed more liberty at the coming session of Congress. Those who did this talking believed in it, but an announcement of Speaker-to-be Henderson's programme for the Republican financial bill, does not indicate an increase of liberty for members; only a transfer of silent obedience from Czar Reed to King Caucus. It is said to be Mr. Henderson's intention to bring the financial bill before a Republican caucus, as soon as Congress meets and to get it endorsed and ordered passed. Then the bill will be railroaded through the House before the committees are announced. The excuse given for this action, which will be decidedly unusual, in dealing with one of the most important subjects that Congress is called upon to handle—the country's money—is that if the bill was allowed to take the usual course, it might never get

out of committee on Banking and Currency, to which it should properly be referred after being introduced in the House, or might be changed by that committee. If this programme is really to be carried out, the House caucus should first vote to abolish the Banking and Currency committee.

Representative Berry, of Ky., has been somewhat annoyed by being misrepresented as to his attitude towards Col. Bryan. While in Washington, a day or two ago, Col. Berry took occasion to say, with an emphasis which left no doubt of his meaning every word: "My opinion is that Bryan will be the nominee of the Democracy, and I have a further opinion that he will get votes enough to elect him President of the United States."

The kicking of Senator Wellington out of the chairmanship of the Maryland Republican State Committee has, in the opinion of those who know the situation thoroughly, made the carrying of the State by the Democrats a certainty. A Maryland Republican is quoted as having said: "I would not be surprised if Smith should be elected Governor by 40,000 plurality. The Wellington incident, the independent revolt, and the Schley affair have given the Democrats an advantage that cannot now be overcome." Democrats have expressed confidence in redeeming the State from the beginning of the campaign. The turning down of Wellington makes it certain that he will join Senators Hoar and Mason in attacking the Philippine policy of Mr. McKinley, in the Senate, and with the assistance of Democratic Senators, they can and will give the administration considerable trouble. Take it all in all, Mr. McKinley has no reason to look forward to the coming session of Congress with pleasant anticipations.

Late advices do not bear out the statement so often made in official documents, that Filipino private soldiers only participate in the war because they are afraid of their officers. Gen. Otis believed in that theory once, but since he offered \$40 cash and personal immunity to every Filipino soldier who surrendered a gun, he has changed his mind. Only one Filipino offered to take advantage of that offer, and before the money was paid to him, it was found out that he was acting in partnership with one of our own soldiers, who had captured the gun surrendered, and was trying to secure some pocket money through the credulity of Gen. Otis. Speaking of the Philippines, there is much talk in Washington concerning the recent activity and daring of the Filipinos, who seemed to be able to operate during the rainy season, even if Gen. Otis cannot. Their attack on a train within 35 miles of Manila was certainly not the act of cowards.

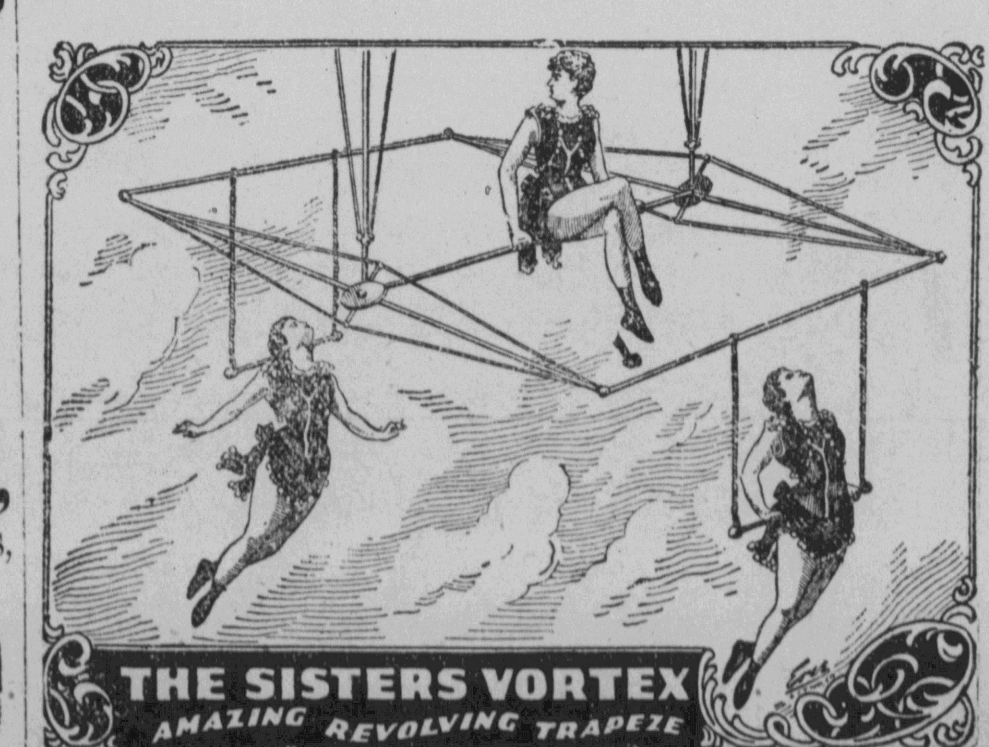
