HORRIBLE DEATH.

Mr. Buck Cox, of Contentnea township, met with a horrible death last Friday. He went to Grimesland to do some trading, going on a cart so he could haul a barrel of flour back.

Profits of Oil and Steel Trusts.

The New York Journal thinks the immense profits of the oil and steel trusts will be an issue in the Presidential campaign. It says:

The joint profits of the Standard Oil Trust and the Carnegie Steel Company amount to \$120,000,000 a year. That would pay of the entire bonded debt of the United States in a little over eight years.

It is twice as much as the whole in come of the national government when Mr. Cor. egie and Mr. Rockefeller were boys.

The profits of these two combinations are enough in a single year to absorb almost the whole outstanding note circulation of the Bank of England. In two years they would more than equal the net stock of gold in the Treasury of the United States. In 18 months they would match all the gold in the Imperial Bank of Germany. They amount to as much in a single year as the gold in the national banks of Italy and Spain combined.

WILL ASK TO HAVE CHARTER REPEALED.

Of Blackwell Durham Tobacco Company Held by Tobacco Trust—There are Majority of Stockholders Who Get No Dividends.

Maj. W. A. Guthrie at the next meeting of the Legislature will make a thrust at the American Tobacco Trust.

He will present a bill to the Legislature asking that body to put the Blackwell Durham Tobacco Company which is a branch of the American Tobacco Company into the hands of trustees, and empower the trustees to wind up the business of said company, pay off the debts of said company and divide the residue among the stockholders.

The Whites Will Vote.

New Feed for Hogs

Mr. G. M. Wier tells us of a new feed he has discovered for hogs—or more properly speaking one he has adopted. It is poke salad. We have known of its being cooked up with meal, hominy, peas, turnips and the like but Mr. Wier is the first person to cultivate it for that purpose as far as we know.

Finding that his hogs ate it with great relish and seemed to thrive upon such diet, Mr. Wier has undertaken to cultivate or propagate the plant. He has set out 500 hills and will plant more. He puts them about in the fence corners, along hedge rows, on ditch banks, and other waste places thus incumbering no land that might be used for other purposes.

Boiled with a little meal and slops he says the poke salad is a good feed for hogs and he would at her have the meal from on of corn cooked up in this way than four ears of corn to be fed dry. He has tried it and knows what he is talking about.

The poke sprouts put out early, grow rapidly and last a long time and Mr. Wier thinks others would do well to give it a trial. No cultivation is required and absolutely no expense is incurred. The only labor necessary is to plant the roots and gather the leaves.—Henderson Gold Leaf.

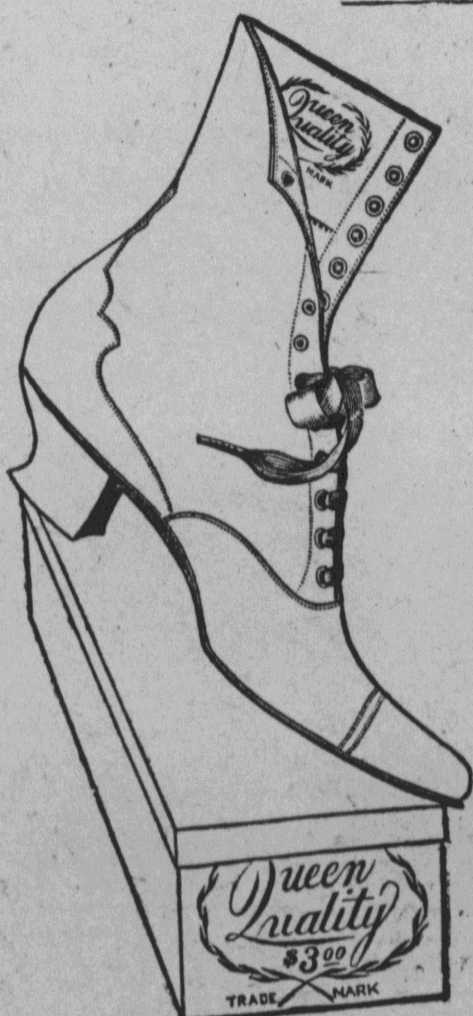

Porto Rico is outside the Constitution but it is inside the Dingley tariff, and the Dingley tariff is worse than the Spanish one.

Philadelphia has raised one fourth of that \$100,000. Now Mark Hanna, who has been really hard up, can begin the campaign work which was deferred for lack of funds.

Porto Rican merchants announce that the island is worse off now than under Spanish rule. There is no reason to doubt their statements. The annexation has cut off the few resources that the island had under Spanish rule and has given nothing in return.

William of Germany is having much trouble in getting his navy increased. Why doesn't he follow up his declaration that 99 years make a century by announcing that his present navy is twice as big as it seems to be. This would settle the question with satisfaction to all.

Possibly there are many republicans who are opposed to trusts. But the party as a whole sits supine and lets them work their will on the country, without even making an effort to curb their destructive powers. If the party is wise, it will try to do something before the next election.

The esteemed New York Tribune exults over the progress of the administration in framing a reciprocity treaty with Spain. Considering that the Republicans in Congress have throttled one reciprocity treaty and show no inclination to adopt any of the others already negotiated, the Tribune's rejoicings seem premature.

The Republicans are in a bad way. They all claim that McKinley will have a walk over this fall, but nevertheless they are walking gingerly than a great party ever did under similar circumstances. They are afraid to push the Paunceforte treaty, the subsidiary bill or the reciprocity treaties, of which are party measures, if they are in imminent peril of being defeated on the Porto Rican bill.

The Right Ticket

The nomination of Marion Butler by black radicals for governor, and Spencer Adams for lieutenant governor, will strike most men of fair sense and observation as particularly appropriate, even fortunate. We do not know two white-skinned men who will be better paired. Butler in 1898, shamefully abused in his speech at Rocky Mount, and outraged truth and decency, but out of which he tried to lie late, but in vain. Again he showed in his late fiery harangue at Raleigh that he was a revolutionist and anarchist of the Kentucky Taylor stripe, filled with malice, gangrened by jealousy, embittered by disappointment, made reckless by necessity, and was ready to resort to race war to carry out his infernal plans. Consumed by ambition and made desperate by circumstances, this latter-day conspirator against the people proclaimed himself ready to join white Republicans, his deceived party friends among populists, and the black contingent he and other palefaces had so long misused and abused and abused for the most selfish, sordid purposes that with this force the entire body of white Democrats might be driven out of North Carolina. No doubt he is depraved and malicious enough to seek such a dreadful appeal, but there are not enough other fools in the state to join him in this wild and hazardous crusade against the virtue, intelligence, and manhood of North Carolina, to make the movement of and every great hazard or importance. One old fashioned "rebel yell" heard from the mountains to the sea would put to route Butler and his rabble.

Adams is the fellow who at Columbus court in 1898, so disgraced the ermine of the judge by a slanderous and disgusting diatribe from the bench aimed at the white men of the state. It was a fitting partisan harangue to be printed under the same cover with Linney's railings in the United States house, the foul and villanous talk of bumptious George White, the kinky-headed Solomon of negrodom and the editorial of the scoundrel Manley that assaulted pure Womanhood in North Carolina.

Let the nomination of Butler and Adams be made. They are veritable Siamese Twins in political inquiry—yoke-fellows in defamation of better men—hail-fellows in partisan sins of commission and ready tools for the lowest party and the vilest combination ever formed for the injury of the old state, the degradation of humanity and the injury and outrage of the white race, the master builders and hope of the world. They are the exact ticket for plotters and despoilers—the rabble "with their large professions and little deeds," with their "large professions" and "vile trecheries." Yes, nominate that ticket so representative of the low gang every way, and let the white men of the state have a good, open chance at it. That ticket will deceive no one—not even the negroes for

THE AMENDMENT.

The following is the amendment to article 6 of the State constitution, adopted by the General Assembly of 1899, and to be submitted to the voters for ratification next August:

Section 1. That article VI of the constitution of North Carolina be and the same is hereby abrogated and in lieu thereof shall be substituted the following article of said constitution:

ARTICLE VI.

SUFFRAGE AND ELIGIBILITY TO OFFICE—QUALIFICATIONS OF AN ELECTOR.

Section 1. Every male person born in the United States, and every male person who has been naturalized, twenty-one years of age, and possessing the qualifications set out in this article, shall be entitled to vote at any election by the people in the State, except as herein otherwise provided.

Sec. 2. He shall have resided in the State of North Carolina for two years, in the county six months, and in the precinct, ward or other election district in which he offers to vote, four months next preceeding the election; Provided, That removal from one precinct, ward or other election district to another in the same county, shall not operate to deprive any person of the right to vote in the precinct, ward or other election district from which he has removed, until four months after such removal. No person who has been convicted, or who has confessed his guilt in open court upon indictment of any crime the punishment of which is, or may hereafter be, imprisonment in the State prison, shall be permitted to vote, unless the said person shall be first restored to citizenship in the manner prescribed by law.

Sec. 3. Every person offering to vote shall be at the time a legally registered voter as herein prescribed and in the manner hereinafter provided by law, and the General Assembly of North Carolina shall enact general registration laws to carry into effect the provisions of this article.

Sec. 4. Every person presenting himself for registration shall be able to read and write any section of the constitution in the English language; and, before he shall be entitled to vote, have paid on or before the first day of March of the year in which he proposes to vote, his poll tax as prescribed by law, for the previous year. Poll taxes shall be a lien only on assessed property, and no process shall issue to enforce the collection of the same except against assessed property.

Sec. 5. No male person who was, on January 1, 1867, or at any time prior thereto, entitled to vote under the laws of any State in the United States wherein he then resided, and no lineal descendant of any such person, shall be denied the right to register and vote at any election in this State by person of his failure to possess the educational qualifications prescribed in section 4 of this article: Provided, he shall have registered in accordance with the terms of this section prior to December 1, 1908. The General Assembly shall provide for a permanent record of all persons who register under this section on or before November 1, 1908, and all such persons shall be entitled to register and vote at all elections by the people in this State, unless disqualified under section 2 of this article: Provided, such persons shall have paid their poll tax as required by law.

Sec. 6. All elections by the people shall be by ballot, and all

elections by the General Assembly shall be viva voce.

Sec 7. Every voter in North Carolina, except as in this article disqualified, shall be eligible to office, but before entering upon the duties of the office he shall take and subscribe the following oath: "I, _____, do solemnly swear (or affirm) that I will support and maintain the constitution and laws of the United States, and the constitution and laws of North Carolina not inconsistent therewith, and that I will faithfully discharge the duties of my office as _____ So help me, God."

Sec. 8. The following classes of persons shall be disqualified for office: First, all persons who shall deny the being of Almighty God Second, all persons who shall have been convicted or confessed their guilt on indictment pending, and whether sentenced or not, under judgment suspended, of any treason or felony, or any other crime for which the punishment may be imprisonment in the penitentiary, since becoming citizens of the United States, or corruption and malpractice in office, unless such person shall be restored to the rights of citizenship in a manner prescribed by law.

Sec. 9. This act shall be in force from and after its ratification.

Fritz Korwein, who was forced to take a bath before being put into a cell in the county jail in Chicago, has brought suit against the Sheriff for \$10,000, on the allegation that the enforced ablution blinded him in one eye and threatened the sight of the other, through inflammation. The plaintiff says he was made to undress immediately after a chilly ride in a patrol wagon and to walk over a cold flagging and plunge into the bath without any chance to warm up.

A Washington correspondent chanced to look up at the directory of a private office building in Washington the other day, and there he saw the names of no less than nine ex-Congressmen, not to mention those of other ex-officials. The inclination to linger about Washington is so strong that men who have been poisoned with the taste for official atmosphere cannot be content to try their fortunes at home.

The Difference.

The Citizen has frequently mentioned the fact that in North Carolina there are two distinct classes of Republicans: national Republicans and Black-and-Tans. In any discussion of the amendment this distinction must be borne in mind. The national Republicans are Republicans from principle, because they believe in the policies of the Republican party. The Black-and-Tans, while calling themselves Republicans, are not Republicans; they are merely anything for office. They care nothing for Republican principles, nor any other principles. Their whole political faith may be summed up in three words: Anything for office.

The national Republicans are not in favor of negro rule in any part of North Carolina. They have enough sense to know that negro rule is a blight; that negro rule means rule of both the white man and the negro by the negro. They have enough manhood to say they want no negro rule for themselves and do not wish to see other white men under negro rule. They have the business sense to know that there can be no progress where there is negro rule.

Not so with the Black-and-Tans. They are filled with lust for office. So long as they can have office they care nothing for people who pay their salaries. They know without the negro vote they cannot get office, and as long as they can use the negro to climb into office they care nothing for the progress of the State. Without principles themselves, they cannot understand principle in others.—Asheville Citizen.
