#### Proceedings of the April Meeting.

The Board of County Commissioners met in regular session Monday, April 2nd. Present R. L. Davis, Chairman, O. W. Harrington and C. J. Tucker.

The following sums were paid out of the treasury:

Cynthia Patrick was released from payment of taxes on one town lot valued at \$100, erroneously charged.

Edwin Smith (dead) was stricken from the pauper list.

Phillis Clark was added to the pauper list at \$1.00 per month.

So far a large majority of the counties in their conventions have endorsed the movement for a primary election to determine who shall be elected United States Senator by the next Legislature. Sentiment in favor of such primary election grows stronger every day. Until now there is hardly a doubt that the State Convention next week will adopt it. The election should be held in November when we vote for Congressmen and Presidential Electors.

## OUR RALEIGH LETTER.

State Convention Next Wednesday and the Probable Results.

Special Correspondent of Reflector.

RALEIGH, N. C., April 3, 1900.

Well, gentlemen, you can begin to pack your grips and purchase your tickets for Raleigh ("free passes" have played out, I believe); the State convention meets next week—and we are expecting you, all of you.

Chances are that over one thousand delegates and alternates will be here, to say nothing of the "visiting statesmen," and on Wednesday there is going to be the greatest Democratic love feast held in this State in many years. Many of these old-time "shouters" will be present to enliven the occasion, and after the ticket is formally born the convention will form itself into a sort of White Brotherhood jollification meeting.

## AYCOCK AND HIS RUNNING MATE

Of course we all know it is going to be Governor Aycock, and by acclamation, for, I take it, Mr. Davidson will yet retire from the contest before the ballot for Governor is taken in the convention.

It is the duty of every true party man to listen to the demands of the majority of his party, and it is his bounden duty to accept any trust his party sees fit to impose upon him and to make the fight for his people.

It is probable that Col. Cunningham will be nominated for Lieutenant-Governor by acclamation also, at least after one vote has been taken, if not before. It is very evident that he is the choice of the majority and will be nominated on the first ballot by a large majority. Under the circumstances it will be his duty to accept.

Most Democrats whom I have heard talk on the subject, especially Mr. Aycock's original supporters, very freely state they think the honor of a nomination by acclamation is due Col. Cunningham, and that it should be tendered him, under all the circumstances.

THE STATE PRIMARY FOR SENATOR.

It seems altogether probable

that the State Primary (to settle the question of who shall be the Democratic successor to Marion Butler) will be ordered by the State convention, according to the recommendation of the Democratic State Committee at its last meeting. It will be set for November of course, on the day Congressman and Presidential Electors are to be voted for. This is believed, by most of the party leaders and the masses alike, to be by far the best and most satisfactory method of settling the question, because it will be in the interest of neither candidate, and will effectually eliminate the Senatorial controversy from the State campaign, and therefore not be allowed to interfere with the success of the Amendment as it otherwise would.

The people are now demanding to have a direct voice in the election of their U. S. Senators, and last week the Democrats of Georgia ordered a State Primary to select the successor to Senator Bacon, the latter approving of the plan. In South Carolina and a dozen or score of other States the primary plan has been in vogue for years, and it is significant of its success that the people will not tolerate or listen to a change of the system. The time has evidently come when North Carolina demands it also, although there has been a studied avoidance of the question in some counties by some of the local leaders.

## CLOSE CONTESTS FOR OTHER OFFICES.

And right here the certainty ends. I could not tell you who the Treasurer or Secretary of State or Auditor or Attorney General will be, much less which of the "smaller fry" are likely to escape the net of defeat.

Ben. Lacy and Henry A. London appear to lead, and in the order mentioned, for Treasurer; but the friends of Boushall, Everett and Burgwyn are still sanguine.

For Secretary of State Col. J. Bryan Grimes and Hon. Dan Hugh McLean appear to be the favorites, although the friends of Hon. W. P. Wood are still active and hopeful.

The Auditorship and the Attorney Generalship are likely to "go west," if McLean or Grimes is successful. But whether Pearson or Dixon or Holman for auditor, and Gilmer or Jerome for Attorney General, it is impossible to say. If the east gets a chance at the Attorney General's place, Frank Winston and Charles F. Warren are to be counted as possible winners also.

The Labor Commissionership is

unsettled. If Lucy is defeated for Treasurer it will be hard for either of the aspirants for his old shoes to prevent the convention from renominating him. If Lacy is named for Treasurer then Varner, James or some western man will be nominated for Labor Commissioner.

The west also gets the Commissioner of Agriculture (Mr. Patterson will be renominated) and one of the Corporation Commissioners (Mr. Rogers; probably, the present incumbent.) The west already has the State Librarian and other minor places. So that section will be pretty well provided for.

Col. Cunningham is the only man from the 5th Congressional district likely to be placed on the ticket. The 3rd district has only one candidate, McLean. All the other districts have more than one aspirant for honors. Somebody is going to be temporarily disappointed of course, but nobody is going to "kick" or get sour or cross or sulky, even a little bit. Everybody is going to be happy next week!

## GOV. AYCOCK TO ADDRESS ODD FELLOWS.

On April 26th the Odd Fellows all over the country will celebrate the eighty-first anniversary of American Odd Fellowship. In Raleigh there are three prosperous Lodges of this order with an active membership of about 500, and these are now taking steps to properly celebrate this anniversary event publicly. Hon. Charles B. Aycock, who is a member of the order, will deliver an address on that occasion. Other speeches will be made and an interesting musical program is being arranged. Visiting Odd Fellows in Raleigh on this occasion will find a cordial reception and experience a most enjoyable time.

## MAJOR HALE FOR DELEGATE AT LARGE.

I have heard a great many party men allude to the candidacy of Maj. E. J. Hale, the able editor of the Fayetteville Observer, for delegate at large to the national convention and without exception he has been endorsed. Four years ago he was conspicuous at Chicago in bringing about the nomination of Mr. Bryan, and without going into details here, it may be correctly stated that he is the "logical candidate" this year again. There is hardly a doubt of his selection by the State convention next week.

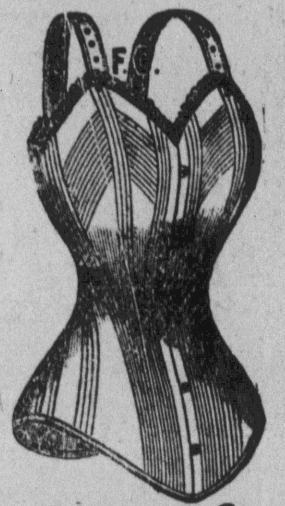
