The Fayetteville Bar held a memorial session in honor of the late Judge Dossey Battle. Judge A. M. Moore, his successor, was one of the speakers.

Several of our exchanges have congratulated THE REFLECTOR upon Greenville's prospects of soon having a good hotel and a cotton mill, and we have also received a number of letters along the same line and rejoicing with us. This shows the interest in Greenville that is felt elsewhere.

Next Saturday is the day for holding the township primaries. Every Democrat should be present and express his choice in the selection of delegates to the County convention.

The success of the party in Pitt county is going to depend largely on the work of the county convention and it is important that there be wise delegates and that they make wise nominations.

Cursed By a Negro Vote.

The political conditions of the South, especially in States like North Carolina where there is such a large illiterate negro vote, grow worse with each year. It does not take an expert to observe this state of affairs, but the most casual observer easily sees that the negro vote is a curse to our fair Southland and that the only remedy for this evil is the disfranchisement of this ignorant vote.

The Baltimore Sun has a member of the staff of that paper making a tour of the South, and in viewing the situation a few days ago had the following to say, which shows that many Republicans will join the Democrats in blotting out this curse forever: "In Virginia, as in every other Southern State, the Republicans are cursed by the negro vote. In every campaign the race question arises and instead of a campaign fought out on State issues or national issues the one question upmost is that of white supremacy against negro domination. Of course in States with a large negro vote this solidifies white men in one party. The best thing that could happen to the Republican party in the South would be the disfranchisement of the negro. Until that is done there is no hope in Virginia for instance, of building up a strong minority party, the need of which is as greatly felt here as elsewhere."—Durham Herald.

WASHINGTON LETTER

From Our Regular Correspondent.

WASHINGTON, D. C., May 4, 1900.

Does the administration really favor the Nicaragua Canal? In view of the known condition of public sentiment, that question may sound odd, but there were things said in the debate which preceded the passing of the Nicaragua Canal bill by the House which made it pertinent. Representative Hepburn, of Iowa, who was in charge of the bill, had a sensational row with Representative Cannon, of Ill., a man close to the administration, whom he charged with working in the interest of the Panama Canal ring, in trying to defer action on the bill. Representative Burton, of Ohio, also a man close to the administration, made a speech against naming the route of the canal in the bill. These things were enough to arouse the suspicion that the administration was not acting in good faith, and there were others. It is said the failure of the Canal Commission to make a preliminary report was owing to a hint from the administration. Perhaps Boss Hanna thinks of working the Panama Canal Company for a big campaign contribution. At any rate, it is well known that the bill just passed by the House will not be acted upon by the Senate at this session.

The republican majority in the Senate stood by the trusts and voted down Senator Berry's anti-trust amendment to the army bill, which merely instructed purchasers of army supplies to give preference to bidders not connected with a trust. Not a single democrat voted against the amendment but Jones and Stewart, of Nevada, who once claimed to be populists but who both seem to have returned to their republican affiliation did. Teller, Pettigrew and Wellington voted with the democrats, for the amendment. Senator Berry said: "The trust question is the greatest problem of the day, and we may yet fight it out in this chamber."

Capt. Chadwick has found out that the protection extended to Rear Admiral Sampson's friends. Secretary Long's letter reprimanding Chadwick—the second within a year for the same offence—published this week, for slurring at Rear Admiral Schley, was about as stinging a document as was ever sent by Secretary of the Navy to an officer; but the universal verdict is that Chadwick got no more than he deserved.

Senator Sewell, of New Jersey has more nerve than most of the republican Senators on the trust ques-

tion. His republican colleagues works for the trusts on the quiet, but he had the audacity to say in a speech on the floor of the Senate that the Standard Oil trust and the Sugar trust were public benefactors. A few more benefactors like them and there will be no more trusts. Benefactions of the sort they bestow contain the germs of revolution. Senator Pettigrew presented figures showing that neither of the trusts named by Mr. Sewell had done any thing which was not directed toward the crushing out of competition and the increase of their own profits.

The U. S. Supreme Court, after spending two days hearing arguments in the Kentucky case, took a recess until May 14, when the decision will probably be made public.

It looks as though the republican leaders in Congress had become afraid to carry out an imperialistic programme mapped out by Mr. McKinley, until after the Presidential election. The Spooner Philippines bill, which gives Mr. McKinley autocratic control of the Philippines under civil government, which he now exercises under military government, is slated for postponement until the next session of Congress. Public sentiment has frightened the Republican steering committee of the Senate and its members ignored the Spooner bill in preparing a legislative programme for the remainder of the present session. This does not mean the abandonment of that imperialistic measure, but that the republicans are afraid to pass it now for fear of its effect upon the voters.

Mother of Twenty-two Children

Catherine Sharp, a bright and lively colored woman of Davie county, was in Salisbury Saturday. It being known that she was the mother of quite a large number of children and that she was comparatively a young woman, inquiries brought forth the startling information: Catherine stated that she was married at the age of 12 and that her husband was 35 years of age. She became a mother when 14, and now at the age of 40, has 22 children with only one pair of twins. She is one of a family of 25 herself, and she seems to have ambition of outdoing her parents. This is probably Davie's record-breaker.

The Standard Oil Company, heeding the mutterings of a labor storm, has raised the salary of its 25,000 employees 10 per cent.

Small Defends North Carolina.

Washington, May 3.—Representative Small addressed the House briefly today upon conditions in North Carolina. His time was limited because of the action of the majority in limiting general debate. Mr. Small referred to the fact that North Carolina has recently been discussed in both branches of Congress in a manner unwarranted and unjust; that the Republican Senator from that State had introduced a resolution in the Senate calling attention to the proposed constitutional amendment and asking the Senate to find that North Carolina was arrayed against the Federal constitution and did not possess a republican form of government. In the advocacy of this resolution he was zealously sustained by his political ally, Senator Butler, and their congenial pair of colleagues in the House, Linney and White, who had played the act of "me too," and joined in the chorus of defamation against the fair name of the State they so conspicuously misrepresented; that all these libelers of the State could not sustain their contention of law or fact and perhaps it was due to the people in other States that they should be refuted.

Is Aguinaldo Dead?

Manila, May 3.—The belief is growing that Aguinaldo was killed by the Igorottis. There is no proof that he has been alive since Maj. Peyton C. Marsh, of the Thirty-third regiment, abandoned the chase after the Filipino leader in the Benquet mountains, although an insurgent officer who recently surrendered to General Young says that the insurgent general, Tinio, believes him dead.

Friends of Aguinaldo's wife assert that she has heard nothing from him since they parted. She is in a delicate condition and nearly prostrated with worry.

At Louisburg court a woman was granted a divorce from her husband. In an hour after the close of the trial she married one of the jurors who decided to give her the divorce.—Greenville REFLECTOR. 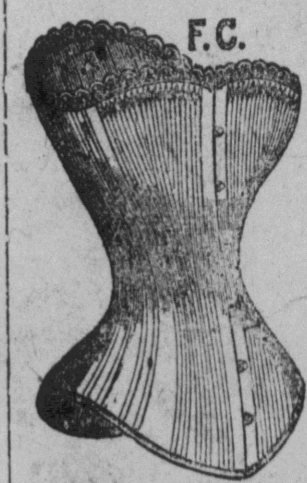
