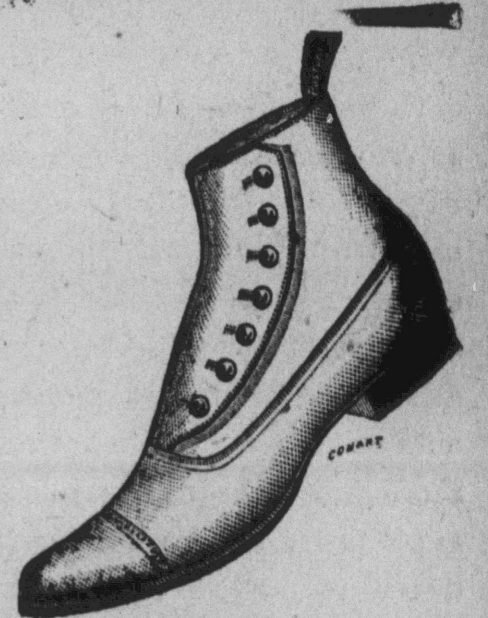

The strike of the telegraph operators of the Southern Railway has proved a failure and been declared off.

When it comes to jobs to rob the government, perhaps about the biggest one is this armor plate business, the projectile and gun makers coming in close seconds. Carnegie, the Cramps, Krupp, and others of their ilk, have pocketed millions and millions of Uncle Sam's gold for the stuff they make to put on our war boats to make them impregnable to attack. The manufacturers of the stuff have a sharp way to work their racket. They rush up to the government with a sample of plate that "will withstand anything," have it taken out to the testing ground and shot at a few times, and scoop a contract for a big pile of it. After delivering the goods and getting the cash they slip around and get some fellow to invent a gun or projectile that will knock a hole in that plate. This is announced with great alarm and gives them a chance to rush up with another kind of armor plate that the new projectile cannot puncture and another big contract is the result. And so it goes—first the armor plate and then the gun, and vice versa whenever they want to work off a job on the government for several millions.

Now just as the government is congratulating itself upon having a set of armor clad war ships that no nation in the world can lick, and the plate makers fearing they might be out of a job for sometime ahead, here comes the startling announcement that another fellow has put up a shell that will go right through any of the armor plate like it was so much wood, and the whole layout is declared worthless. And Uncle Sam's Senate has become so alarmed at the announcement, through fear that some other country will get a supply of this shell before we can make a cinch on it and knock the bottom off our boats, that secret sessions are being held to discuss the matter behind closed doors. You can look out for some more big appropriations and still more contracts for war ship trimmings.

The Country Printers Report.

The Latrobe, Pennsylvania, Advance accomplishes a very neat presentation of city competition with country job printing offices. It calls attention to the fact that the city offices have been canvassing Latrobe for job work, and offering prices that the local offices cannot meet; and says that it is easy to say to the local printer that his prices are higher than city offices demand. The Advance goes on to remark:—

"The turniture man in the city advertises goods away down, and we go to the local dealer, and ask him about it.

"And he truly says: 'Inferior articles.'

"The city dentist says he will make teeth at half the price charged here.

"The local dentist truly says: 'Inferior work and material.'

"The city tailor says he will make a suit for a whole lot less than the local man.

"The local tailor truly says: 'Not well made.'

"The city grocer, dry goods man and others quote prices the local men don't touch; but the local truly remarks: 'Not the same goods.'

"The doctor advertises to cure you for a small price, but the local physician simply and truthfully says:—

"'Quack.'

"With a daily paper before us just now, we see all these things advertised, so we know that printing is not the only commodity offered away down. Oh, no; not by a lot.

The moral is: 'The local printer is not the "only pebble on the beach" who doesn't compete with the cut-throat fakir.'

"Mr. Business Man, you don't compete successfully either; why do you expect your neighbor in the printery to do so?"

War has slain its thousands, but pestilence and famine are slaying their tens of thousands. The British casualties if the present war in South Africa have been, as we remember, not quite 20,000. Hardly a quarter of these, however, have been killed, the greater part being losses from capture and wounds. The number of men killed in battle in the Union armies during the civil war was 67,058, the number dying of wounds 43,012, dying of disease 199,720, with deaths from accidents and other causes 40,154. Total deaths in the Union army 319,944. The number of Confederate soldiers who died of wounds or disease was 133,821. These latter are terrible losses and yet the number of famine-stricken people in India today is 93,000,000 according to the Associated Press dispatch in Sunday's Observer, and with the most strenuous efforts of the English government and the sweet charity of the world at large there is hope for relief for only 5,000,000, of the 93,000,000 starving human beings. This statement is colossally appalling and pathetic.—Charlotte Observer.

Two Blacksmiths Killed on the Track.

Asheville, May 8.—Lynch Jackson and his son, W. G. Jackson, commonly called "General Jackson," local blacksmiths, lying on the track, probably drunk, at Gash's Creek crossing, were run over by a Southern Railway freight train bound to Salisbury, this morning, at 8 o'clock. The bodies were mangled and the heads of both cut off. The coroner's jury adjourned till to-morrow to secure trainmen to testify.

Possible and Impossible Trust Remedies.

If Trusts could have been demolished by the promulgation of antagonistic party platforms the country would have been long ago rid of them. But the makers of Trusts and platforms are really members of the same joint stock company. They play into each other's hands. By properly using its power to regulate interstate commerce or by withdrawing the statutory inducement to monopolistic combination embodied in favoring tariff duties, Congress might give immediate relief. But the Interstate Commerce law has been stubbornly maintained in such an inoperative shape as to induce the formation of a great railway trust as a means of defence against ultimate destruction of the value of the properties involved; and no step has been taken to reduce the tariff rates that have no other purpose than to invite the spoliation of the consumer. Congress will not budge. In the White House and the Capitol at Washington is the place where the Trusts are most formidably entrenched.

It is now proposed, as a further means of staving off any effective legislation against Trusts, to set on foot a project to so amend the Federal Constitution as to forbid and abolish them. This is the most impudently transparent of all the devices so far put forward to etherize and stupefy the people of the United States in order that their pockets may be picked during a further term of years. There is no possibility for amendment of the Federal Constitution to deal with Trusts and there is no intention of amendment, and there is no necessity of amendment. Congress and the States have all the needed power for correction or abolition. The Trusts are only mischievous in so far as they enjoy special privileges conferred upon them either by Federal or State power. Take away these protective advantages and they are defenseless.—Philadelphia Record.

A battle royal is on between the Standard Oil Company and the Canadian government. The Standard Oil Company, pursuing the same line of policy which established its monopoly in the United States, bought up the Canadian refineries and afterwards made arrangements with the Canadian railroad companies to so advance the rates on oil manufactured elsewhere as to enable it to put up the price to Canadian consumers. In the United States this game was successfully worked. There was, in fact, a guilty complicity upon the part of some of the Legislatures. It is much to the credit of the Canadian authorities that they have prohibited the preferential rates collusively established by the Canadian railroad companies. The Standard company will have to find some new plan of levying special taxes upon the Canadian consumers.—Philadelphia Record.

Mrs. Bagley, mother of Worth Bagley, who was ensign on the torpedo boat Winslow, and killed off Cardenas, Cuba, during the Spanish war, has sent to the Bath Iron Works plans for a handsome memorial tablet, which will be placed on the torpedo boat now under construction at the Bath Iron Works in his honor. The tablet will be of bronze in the shape of a shield. The border will represent cannon balls, and on it will be the name "Worth Bagley." On the lower part will be an eagle surmounting a shield and sword, while in the center will be the dates of his birth and death. It will be placed on the conning tower of the oat.—Portland (Me.) Press.

Negro Suffrage.

North Carolina is moving to cure a great evil—the rule of the negro in political and governmental affairs. In Virginia the white folks are in action now and in two or three months will adopt a constitution for the state that will deal with negro suffrage in a repressive way. Louisiana lately held an election since the new constitution was adopted. In the last election the negroes registered some 125,000. This year they registered but 7,000. In the last election the whites registered not far from 120,000. This year 117,000. The new suffrage qualification set aside the hitherto negro rule that was such a curse and ruin to the state, as Senator McEnery so forcefully exhibited in the senate some months ago. In North Carolina probably 60,000 negroes will continue to vote and under enlarged educational facilities will yearly increase. With an amendment the white man's government will vote more money for the education of the negroes. With the Amendment defeated, there will be very little of the people's money expended hereafter for negro education. With the negro still on top white men will not bleed themselves to educate their enemies.—Wilmington Star.

Story of a Pass.

The following is the history of a railroad pass which, if true, is very good of its kind. When R. N. Rice, who was afterwards President of the Michigan Central Railroad, was the general manager of the New York central, he received by mail an expired pass, across the back of which the holder had written in red ink:

Bless my stars! no more on the cars
As a deadbeat I'll ride on the rail.
Unless Mr. Rice should take my advice
And send me a pass by the mail.
Without a moments hesitation
Mr. Rice turned the pass over and traced in red ink on its face the following:

The conductor will pass this bundle of gas
From July till the middle of Lent,
Like another deadhead, without paying a red,
Let him ride to his hearts content.
The pass was never taken up, and is today kept in the family of the holder.

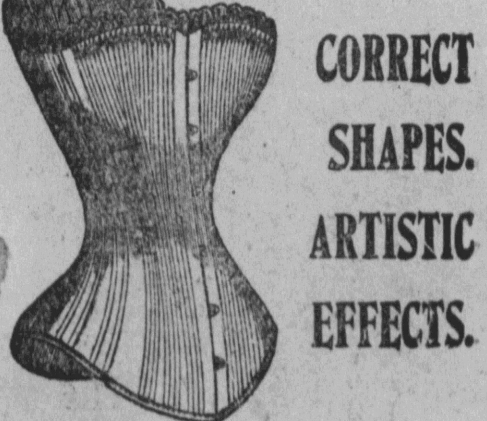
