#### JORDAN FACTORY BURNED.

#### ANOTHER SERIOUS LOSS TO GREENVILLE

#### Firemen Do Splendid Work in Saving Adjoining Property.

About 9 o'clock Tuesday night the tobacco factory of M. P. Jordan & Co., located near the railroad, was found to be on fire. When discovered the roof of the boiler room was all in flames. The fire department and hundreds of citizens hurried to the scene but the fire had made such headway that the factory could not be saved.

The storage warehouse just south of the factory was also destroyed. Both the buildings belonged to Mr. R. A. Tyson. The factory was occupied by M. P. Jordan & Co., of Danville. They had about one hundred and fifty hogsheads of tobacco in the building and only four hogsheads could be rolled out.

As the factory shut down about a month ago for the season, the origin of the fire is a mystery.

The loss is estimated at about \$15,000. M. P. Jordan & Co. had insurance on stock for \$7,850, and on machinery for \$1,600. R. A. Tyson had on factory building \$3,000, on storage warehouse \$200 and on stock in warehouse \$400. The total insurance was \$13,050, all of which was in H. A. White's agency.

The Farmers Warehouse was slightly damaged and covered by insurance.

Mr. Tyson was just getting material together preparatory to having the factory enlarged before the next season.

The firemen did splendid work on adjoining buildings and no doubt saved thousands of dollars worth of property. The large Farmers Warehouse had a very narrow escape. Had that building burned there is no telling how far the fire would have gone.

Hope Fire Company put their steamer at the cistern near Roberts & Ficklen's factory and soon had a good stream going through nearly a thousand feet of hose.

The nozzlemen and backers had hot work before the intense heat, but with the aid of breastworks made of empty hogsheads and doors they kept their post.

The colored firemen dammed the ditch running near the Farmers Warehouse thus making a good reservoir of water, and with their hand engine also did fine work. They stuck to their work bravely. Both the white and colored firemen were complimented for their work. Beside saving the Farmers Warehouse, they put out some of the burning hogsheads so that portions of the tobacco was saved.

## OUR RALEIGH LETTER.

### Scheme of the Political Twins to Secure a Triangular State Canvass

Special Correspondent of Reflector.

RALEIGH, N. C., May 22, 1900.

It is really the fact that some of the Populists "leaders" are anxious to secure a joint debate between Aycock and Cy. Thompson and on the day when Chairman Simmons declined the proposition of Chairman Butler to that effect a prominent Pop-Rep. office-holder here said to me that "Simmons' declination doesn't settle the matter; we'll get 'em yet."

Since their opposition twins have been scheming to bring this about and when Simmons wrote to Holton two weeks ago and solicited a joint debate between Aycock and Spencer Adams and the other Democratic and Republican nominees, several leading "fusionists"—for they are fusionists still, and are to-day working as loyally and harmoniously together as ever, and to the same common end—at once saw the opportunity to work a scheme, when successfully managed, would accomplish their purpose.

Chairman Holton did not get Chairman Simmons letter of invitation promptly, it is alleged—the accommodation mail got out of joint somehow, or else this particular letter must have fallen into a convenient hiding place on Holton's desk and refused to come to light until a few days ago, ten days or more after date.

This was all very obliging on the part of that erratic epistle, and especially fortunate and accommodating, not to say "foreordained" for Holton and Butler.

But the latter learns of its existence "through the newspapers," and it is said that it at once became highly important to the "dear people" that Butler should arrange with Holton for a "joint canvass" between the twins—ludicrous as it may appear to the uninitiated. Then you see, in order to secure a discussion between the Democratic and Republican candidates Mr. Holton would hold that it was necessary to start a triangular debate—because he (Mr. Holton) could not be so discourteous to his twin brother (Mr. Butler) as to show partiality in accepting the invitation of Mr. Simmons and refusing the "challenge" of Mr. Butler.

### SCHEME TO SAVE ADAMS.

One of two results (either of which would be preferable to having Aycock flay Adams alive and exhibit the latter gentlemen's deficiencies and general unfitness all over the State to a disgusted constituency) must follow: There

would be no joint canvass at all (in case Simmons continued to refuse to consider the Populists as a party "entity" and therefore not entitled to the consideration shown a regular and separate organization), or else Thompson would be let into the game to help Spencer, incidentally, and the opportunity desired—that is distracting the public mind from the real question at issue—would be secured. Mr. Holton's reply to Mr. Simmons will reach the latter to-day, probably, according to the statement made by Holton while here last Saturday. The letter has been seen and it positively declines Mr. Simmons' offer of a joint canvass, as Holton became convinced that the three-cornered-fight scheme could not be worked.

It was a nice, innocent, amusing little game, and so well played as to turn out to have been entirely harmless as well. Butler dies hard—but he is dying.

Why, under the sun, any real friend of Dr. Cy. Thompson should actually and really desire to sacrifice him upon the altar of Aycock's eloquence and argument is more than I can conceive. The scheme must have been hatched by his enemies and a few deluded friends fooled into advocating it.

Dr. Thompson is unquestionably the best speaker and shrewdest politician in the Pop-Rep. aggregation—and that is easily said—but those who heard the debate between him and Mr. Aycock in 1898, and particularly the discussion at Concord (which this writer reported for a Raleigh daily paper) all know that he is no match for the "oratorical gladiator of the east," and in the very nature of things would suffer severely from a bout with him this year—even if he had a just and popular cause to advocate. With opposition to the Amendment for his text Dr. Cy. would simply be annihilated by the man who is endowed and equipped as few men in North Carolina have been, and who commands and wins the admiration (and generally the votes) to all who listen to his superb speeches.

### ANY HOPE FOR TOBACCO GROWERS IN THIS?

The organization a few days ago of another big tobacco manufacturing company, or "trust," in New York, with P. H. Hanes & Co., and Brown Brothers (the two largest plug men of Winston), and several in Virginia as members, is important to the tobacco growers of North Carolina and the South, possibly. Will the new company provide competition on the warehouse floors of our local markets, and thereby cause a rise in the price

of certain grades of tobacco grown here? If so, it is to be welcomed. The new concern is represented to have an initial capital stock of \$25,000,000, and starts out with twelve large factories having a combined output of 18,000,000 pounds, exclusive of cigarettes which some of them manufacture and which feature may be greatly enlarged. Looks like it ought to be able to do some business—if it is not "absorbed" before it cuts its infantile teeth.

### OLD CONFEDS OFF TO THE REUNION.

Division headquarters will leave Raleigh next Monday (May 28) at 3:50 for Louisville, via Asheville, in a through special Pullman car train. General Julian S. Carr, Commander-in-Chief of the N. C. Division of Confederate Veterans who will head the division at the Louisville Reunion next week, has announced the full list of Maids of Honor, including seventy-five of the most beautiful young women in North Carolina, and all the children or descendants of Confederate soldiers. Miss Esther Ransom of Northampton, as Sponsor, and Miss Martha W. Phillips of Edgecombe, as Chief Maid of Honor, were selected some time ago. The Reunion at Louisville this year promises to be one of the most successful of all, and the splendid contingent which Gen. Carr will carry from North Carolina will contribute largely to that end.

### LATE NEWS NOTES.

The State Board of Agriculture will hold its next meeting here on June 12, Col. John S. Cunningham president, presiding.

At Populist headquarters here, it is announced that the "third party" will not formally begin their State campaign till June 10.

This is Charlotte's gala week, and though President McKinley will not be among the attractions and "exhibits," there is no end to the others, and the biggest "20th of May celebration" in history is being followed by several days of fun and enjoyment for the great crowds of visitors.

The aspirations of Ike Meekins were murdered by boss Carl Duncan last week, when the First District Republican Convention refused to make a nomination for Congress. Wonder if Col. Harry Skinner intends to make a contest again this year, and was this action taken accordingly?

There will be the usual annual reunion of Alumni at the A. & M. College here during Commencement week, May 27—30.

Commencement Exercises of old St. Mary's School here occur on May 30 and 31.

The Republicans of the 7th dis-

trict have nominated J. Q. Holton of Yadkin for Congress. He is a brother of the Republican State Chairman.

Secretary Bruner, of the Agricultural Department, who went to Paris to look after the North Carolina exhibit at the Exposition, cables that he left Glasgow for home on Sunday, May 20.
