#### Women's Gambling Room Raided.

Wild and shrill were the screams when the police suddenly appeared in force in 264 Eighth avenue today. Upwards of half a hundred women were gambling on the races, the place being known as a poolroom for fair patrons only. The manager gave her name as Grace B. Ryan, but the police declare that she is Gussie M. McKee, recently married to Lieut. Hugh Martin, of the United States army, now at Fort Hancock facing charges of financial irregularities.

Strong arms alone prevented some of the excited women from leaping from the windows to the street, a distance of 15 feet. Several fainted. Nearly all wept. Many got out of the back windows and escaped over the roofs. The police arrested 34 of the women.

It is possible that several homes may be broken up as a result of the raid. Many of the prisoners are married and their husbands now learn for the first time that their wives are in the habit of playing turf events. Some are stated to be daughters of respectable and perhaps wealthy men.—New York Letter to Baltimore Sun.

The Board of Commissioners of the town of Washington have decided to refuse to recommend to the County Commissioners for license to sell liquor any person whom they have reason to believe engages in the sale of liquor on Sunday. The Messenger says that while parties engaged in the sale of liquor have been believed by the people to sell it on Sunday, as cases of intoxication on Sunday would indicate, still it has been impossible to obtain sufficient evidence to convict the parties, and this resolution of the Commissioners was passed to meet such cases.

Pitt county is handsomely represented by Senator James and Representatives Barnhill and Nichols. These three gentlemen have been recently renominated in Pitt, and will come again next January.

Senator James is an old favorite in the social realm in Raleigh, having been one of Judge Strong's most popular law students in 1878, and is now serving his third term in the Senate. He has the happy faculty of keeping his tongue, until the maturity of his thought justifies its loosening. And some Senators, there are who haven't. But they don't "get there" as often as Senator James.—Raleigh Post.

### New Election Law as Amended.

H. B. No. 2083.—A Bill to be Entitled an Act to Amend Chapter 507 of the Public Laws of 1898, Entitled An Act to Regulate Elections.

Section 1, which provides for the State election on the first Thursday in August and each four years thereafter, is amended by providing for biennial elections for such other State officers as are not named in this section.

Section 3 is amended to provide for election of judicial district solicitors, same as clerks of Superior courts—each four years.

Section 6, is amended slightly ament making provision for compensation of the State board of elections.

Section 10, amended so as to allow county boards to meet at "such other times" as the chairman or any two members may direct.

### REGISTRATION REQUIREMENTS.

Sec. 11. That before the next general election on the first Thursday in August, 1900, provided for in this act, there shall be an entirely new registration of all persons who shall be entitled to register, in every voting precinct in the State; and only such persons as are registered shall be entitled to vote in any election held under this act.

That in all cases the applicant for registration shall be sworn by the registrar, before being registered, and shall state and answer his name, age, place of birth, place of residence (stating ward if he resides in an incorporated town or city), number of his house if numbered, and if not numbered, then a designation of its locality by streets; and if not the owner, then the name of the owner or renter.

If not a resident of an incorporated town or city, he shall then state his place of residence in the election precinct; and if he is not the owner of the house in which he lives, then he shall state the name of the person who does own the same, or upon whose land he lives, the time of his residence in said county, ward of election precinct; and if not known to the registrar, to be qualified to register, his avocation, place of business, where and by whom employed if employed; if a new-comer, from whence he comes and his postoffice address before removal; whether he has been disqualified as a voter by judgment or decree of any court, and if so by what court reinstated; and any other questions of the identity and qualification of the said applicant to be admitted to registration.

The registrar, if in doubt as to the right of the applicant to register, may require other evidence satisfactory to him as to the qualifications of the applicant.

And thereupon, if the applicant shall be found to be duly qualified and entitled to be registered as an elector shall register the applicant (giving his race opposite his name) and shall record his name, age, residence, place of birth, and the township, county or State from whence he removed, in the event of a removal, in the appropriate column of the registration books; and the registration books containing the said record shall be evidence against the applicant in any court of law in a proceeding for false or fraudulent registration; provided, that nothing herein contained shall prevent any elector or judge of election, on the day of election when the elector presents himself to vote, from challenging the right of the elector to vote.

If any elector has previously been admitted to registration in any ward, township or precinct in the county in which he resides, he shall not be entitled to register again in another ward, precinct or township in the same county until

he produces a certificate of the registrar in the former township, ward of precinct that his name has been erased from the registration books of the ward, precinct or township from which he has removed; and the identity of any person claiming the right to be registered in any precinct of the same county by virtue of said certificate of the person named therein shall be proven to the registrar, if not known to him.

Every person qualified as an elector shall take the following oath:

"I do solemnly swear (or affirm) that I will support the constitution of the United States and the constitution of the State of North Carolina not inconsistent therewith; that I have been a resident of the State of North Carolina for twelve months and of the county of \_\_\_\_\_ for ninety days; that I am 21 years of age; that I have not registered for this election in any other ward, precinct or township; That I am the identical person that I represent myself to be and that I am a boni fide resident of \_\_\_\_\_ precinct. So help me God." And thereupon if qualified, shall be entitled to register.

Section 17. Amended so as to allow appointment of judges of election "at such other times as may be necessary."

Section 20, now provides: "No registration shall be allowed on the day of election; but if any person shall give satisfactory evidence to the registrar and judges of election that he has become qualified to register and vote after the time for registration has expired, he shall be allowed to register and vote on that day."

Section 29, amended by adding the words, "and make out and sign a return or statement of the result of the election" to the first section and the addition of the following: "Provided, that the chairman of any political party in the State may file in the office of the Secretary of State a ballot or ballots designating the officers to be voted for on any State, districts or county ticket; and no ballot shall be rejected that contains only the names of persons to fill the offices so designated on account of containing the names of more persons than the elector had a right to vote for."

Section 34, amended so as to provide for canvassing also of returns of the vote cast for and against proposed Constitutional amendment.

Section 35, amended by adding 6) Representatives in Congress, (and also (7) amendment to the Constitution.

Sections 36, 43, 45, 46, 38, similarly amended as section 35.

Section 64, defining the State Board of Canvassers, amended so as to comprise that board of the "Governor, Secretary of State and four members of the State Board of Elections."

### AS TO JUDICIAL INTERFERENCE.

Section 58. That upon any application being made or any action or proceeding of any kind commenced or had before any judge of any court in this State, for a mandamus or order in the nature of a mandamus, injunction, restraining order or order in the nature thereof, to compel, prevent, prohibit or restrain the performance of any act in respect to his duties against any officer or officers provided for in this act, the matters stated in the affidavit, petition or complaint upon which such application is based or action or proceeding had, shall be taken and deemed to be denied, and no such judge shall issue any such order, temporary or otherwise, until the facts have been submitted to and found by a jury at a regular term of the Superior court of the county

in which such officer resides. No such order shall be made or issued upon any case agreed, or upon facts found by a jury at a special term.

Section 19. That when a jury has found the facts and any judge shall issue a mandamus or order in the nature of a mandamus, injunction or restraining order, or other order in the nature thereof to compel, prevent, restrain or prohibit the performance of and act in respect to his duties against any officer or officers provided for in this act, such officer or officers shall have the right to appeal from such order to the Supreme court, upon giving bond in a sum not to exceed the sum of \$100, conditioned to pay to appellee all such costs and damages as may accrue by reason of such appeal. The said bond shall be received and approved by the clerk of the Superior court. A deposit of money, of the amount of the penal sum named in such bond shall be received by the clerk in lieu of such bond. And upon filing such bond or making such deposit such order shall be vacated until affirmed by the Supreme court; and until so affirmed the election officer shall proceed to perform the duties imposed by this act, notwithstanding such order.

Section 90. Repeals all previous conflicting laws.

Sister Maggie Whitley and Brother Henry Duff presented their Juvenile class of Greenville. A duet was sung by two members of the class and prayer was offered by little Pattie Gorham. Joseph J Norcott while preparing to come with the class was drowned in Tar River. A collection was taken for the Juveniles to assist them in burying their deceased member. Prayer was offered by Rev Z H Berry. Deputy R C Cuffee, Moyock, made his report which spoke well for the Eastern Samaritan. He has cuffs the impurities out of his lodges, for which the G L gave him the second Samaritan medal.

#### NIGHT SESSION.

The Grand Lodge was called to order at 8 o'clock by G C, L H G Jones, password in the 3rd degree taken up.

Brother Moses King, Deputy of the Greenville district, presented his report through Sister Helen B Wooten. The report showed him to be the King on N C Samaritans to whom the Grand Lodge bowed in gratitude.

tears from Bro King and many others.

Committee on good of there order made their report, which brought remarks from Revs Moore and Norman.

M F Department. Sister Mary W. Steward, of Winston, spoke in favor of this department and proved herself to be one of the best debaters of her sex.

The Grand Lodge retired to the cemetery to assist the Juveniles in burying their deceased brother, J J Norcott.

Returning to the hall a resolution was offered changing the time of the meeting of the Grand Lodge from the second Tuesday in June to second Tuesday in July. The resolution was adopted by a vote of 36 to 32.

At 12:30 recess was taken for dinner.
