GLORIOUS BLACK JACK.

Banner Precinct of the County.

It has long been a saying that Chicod township never does things by halves. And when the date was set for having a Democratic picnic and barbecue on the 19th, people naturally concluded that it was going to be a record breaker, and it is no wonder that it drew attendants from nearly every section of the county. Like ex-Treasurer John Flanagan said when we found him among the crowd "I always did love to come to Black Jack in the campaign, and could not resist the inclination to come this time." And about four thousand people were of the same opinion, for a conservative estimate of the crowd places the number in attendance at fully that figure.

Four miles this side of Black Jack about a hundred mounted red shirts with the Osceola Band met the speakers—Hon. T. W. Bickett, of Louisburg and our countyman, Col. J. Bryan Grimes, candidate for Secretary of State—and escorted them to the village. There was music and shouting all along the course of the parade, and when they came in sight of the assembled multitude there was such a hurrah as sounded like the whole State had agreed to holler at one time. The noise was only surpassed by the dust.

The Osceola Band played two or three airs while the crowd gathered around the speakers' stand. Chairman A. L. Blow, of the county executive committee, called the

assemblage to order and made some announcements. By way of closing he congratulated the immense gathering and said when the election returns come in he wanted them to show that Chicod, like every other township in the county, had done her full duty.

Capt. J. J. Laughinghouse, who is the acknowledged commander-in-chief of all Chicod, arose to introduce the first speaker, but before doing so said "I don't like the way the chairman of the county refers to we Black Jackers. Instead of saying he wants us to do our duty—we always do that—he should have asked how many majority we can send up to cover up any deficiencies that may come from any other quarter." The crowd readily saw the point and there was a shout of applause. He then introduced Mr. Bickett, who spoke for an hour and a half. It was a fine speech all through and listened to attentively. Mr. Bickett made some of the clearest points on the Constitutional Amendment and the best argument in meeting objections raised against it by the opponents of the measure that we have heard in any speech of the campaign so far. He made everything so plain that even the most unlearned could readily comprehend it. If any white man who heard Mr. Bickett votes against the Amendment he will do so either through prejudice or because he thinks a negro is just as good as himself.

After this speech Prof. W. H. Ragsdale in behalf of the commit-

tee of arrangements announced dinner and instructed the crowd how the committee wished all to deport themselves at the table. We do not believe it possible that a dinner for 4,000 people could be managed with better order than this. The table was formed in a square and measured nearly 300 yards. The ladies went on the inside of the square and the men on the outside, and nobody touched the table until a given signal. The food was already prepared and placed on the table, and when the word was given for all to help themselves the people went about it in the most orderly manner.

There was no pushing, no grabbing, but everything was as quiet as if it had been a big family reunion. As one man with somewhere about eleven children said, there was as much racket around his table most any day as there was at this dinner. Every man connected with the management deserves the highest credit.

After dinner the crowd returned to the stand to hear a speech from Col. Grimes, the band having given them several more tunes in the meantime. Col. Grimes began by saying he felt glad when the appointment was made for him to come to his native "county of Chicod" to speak for he knew a great crowd would be present, but he had no idea the whole "State of Pitt" would be on hand. His campaign over the State for the last three months has given him rank among the very best speakers. He made a most excellent speech on this occasion. His argument on both National and State issues, as well as upon the Amendment was strong and spirited, and he was given the closest attention.

It was past 5 o'clock when the speaking closed. It was one of the best day's work for Democracy Pitt county has known. It is already evident that the ticket and Amendment will be overwhelmingly victorious, and if every township in the county does its duty at the election as well as Chicod, the only question left to decide is how large shall the majority be.

Power of Speech Returns to a Girl Who Was Dumb for Six Years.

After having been unable to talk for six years, Miss Sarah Landis, 21 years old, of Ephrata, has had her speech return to her as suddenly as it departed.

In the summer of 1893 the subject, then an attractive, well-educated girl, was prostrated by illness, and has never since been able to leave her bed, nervous and spinal disorders complicating her original complaint. Finally her speech suddenly left her while she was engaged in conversation. Skilled physicians were not only unable to help her, but were puzzled to account for her sudden affliction.

As time passed, the victim became reconciled to her lot, and through necessity, invented an entirely new sign language, by which her family speedily came to learn her every want. The once robust girl passed into so frail a womanhood that she is now reduced to a mere skeleton. Yesterday, while lying in bed, she had some want, and on the spur of the moment called to her sister, who was in the next room. In spite of her years of silence she spoke clearly, and since then has been able to speak as well as ever she did, but the effort tires her.

She was greatly overjoyed at first over the return of speech, but now appears to feel no emotion whatever over its recovery.—Lancaster, Pa., Dispatch, 15th.

Outrages By Commissioners.

The State has rung with the outrage perpetrated in the case of Registrar Thompson, of Winston, who was arrested for refusing to register negroes not entitled to register and who was held to court by a United States commissioner in a bond of \$2,000; and yet this is not nearly so flagrant a case of Federal interference in State affairs and of arbitrary action on the part of a United States official, as that reported in our Asheville correspondence yesterday as occurring in Jackson county. A Democratic registrar was arrested for refusing to register three Indians and was dragged off to the county seat for trial, in the face of the provision of law that such trial should be before the nearest commissioner and there were three nearer than that at Webster. A Republican lawyer hiring appeared for the prosecution and there were only two other lawyers in reach and they were just hurrying off to Asheville on important legal business. One of these, however, appeared before the "court," stated the facts and asked, in view of them, that the

case be continued until the defendant could be represented by counsel and get his witnesses. The "court" denied the request, saying that the defendant needed no counsel and no witnesses, and while the attorney was still talking, proceeded to swear the witnesses for the prosecution. The defendant registrar thereupon waived examination and was bound over to court in the sum of \$2,000.

This is a simple story but it is pregnant with meaning.

This goes the case of Commissioner Beckerdite, of Winston, one better.

Here was a manifest case of political prosecution, and denial of even the justice to be had in ordinary times at the hands of the average United States commissioner.

The people of North Carolina do well to refrain from giving active expression at this time to their resentment of such outrages as this, that at Winston, and those in numerous other localities, which have been reported in the press from time to time within the past two weeks, but they can be depended upon to resent them properly at the polls in August.—Charlotte Observer.

Niggers Would Like to Spit on White People.

When Senator Pritchard talked about niggers spitting on white people last Saturday in the court house here a few white men clapped their hands and made the welkin ring with yells of approval. It is a horrible state of affairs when one white man cheers at the idea of a nigger spitting on another white man. It suggests an inquiry as to whether some people don't really think more of a black man than they do of a white man. Is it a fact that we have in our midst white men who delight to see negroes run over white people? Do they laugh when they hear a nigger speak of good honest white men or women from the country as poor country trash? Are the white people who live on the farms to be forced to pay taxes to educate niggers for all time to come and continue to be looked upon with contempt by the very niggers they have educated? The negro accepts the school tax from the poor white man and then turns and calls the white man poor white trash. This is base ingratitude.—Lexington Dispatch.

Spencer Adams condemned the Democratic party last Saturday in his speech because the board of elections had appointed a number of negro poll-holders in eastern counties. The election law says two judges shall be appointed of different political parties. You can tell a man's politics in the east by the color of his skin. White people all vote the Democratic ticket and the negroes all vote the Republican ticket. So any man with half sense can see the board of elections was compelled, according to law, to appoint a negro to represent the Republican party. Russell and his gang had more than one thousand negroes in office from 1895 to 1898 holding down paying jobs. That's what they want again.—Lexington Dispatch.

The sympathy of the entire town goes out to Mr. R. R. Warren. This morning his barn containing all his corn, fodder and hay was discovered to be on fire with the result all of its contents were destroyed. Mr. Warren is unable to tell how the fire could have possibly originated, and there is some suspicion that it is of an incendiary origin. This is the third time we think, Mr. Warren has suffered from fire.—Washington Messenger.

The Rep-Pops and the Silversmiths at Ephesus.

The Republican and Populist office seekers who are crying out against the elimination of the negro vote are in the same attitude that the silversmiths of Ephesus were when Paul went into their city preaching the gospel. The uproar of the anti-amendment office-seekers has lasted for more than three months. The reason for the uproar with the silversmiths was that the overthrow of the goddess Diana meant that they would lose their living, for "By this craft," said they, "we have our gain." With the anti-amendment office-seeker it is, "By this gang, the negroes, we have our votes."—Monroe Enquirer.

Why should Populists vote against the amendment? Their State platform does not declare against it and does not make it a party issue. On the contrary the Populist State platform declares that "the People's party is and has always been more distinctly than any other party in North Carolina a white man's party."

If this be true then surely every Populist ought to support the amendment more heartily than the Democrats do. And the leading Populists are supporting it. We mean of course those who are really and sincerely Populists, and not office seekers who pretend to be Populists and yet are nothing but Republicans at heart.—Pittsboro Record.

The people of Greensboro and Guilford county have apparently overlooked the fact that a State campaign, centered on the vital issue of restricting negro suffrage, is in progress, and are devoting themselves to discussing the dispensary—whether liquor shall be sold in a dispensary, in saloons or not at all. The Republicans are of course shoving this issue to the front with all their might and while the Democrats are belaboring each other their enemies hope to step in and carry the county. If the agitation of the dispensary question at this critical time doesn't defeat the Democracy of Guilford we shall be surprised.—Statesville Landmark.

A Republican editor in Kansas killed himself a few days ago. This is not surprising. The editor who is expected to defend and whoop it up for the Republican party with its present record has a hard ordeal to go through.—Wilmington Star.

W. H. Buffalo, republican sheriff of Northampton county, Saturday at the convention refused renomination at the hands of the negroes assembled, saying he could not afford to vote against the suffrage amendment.

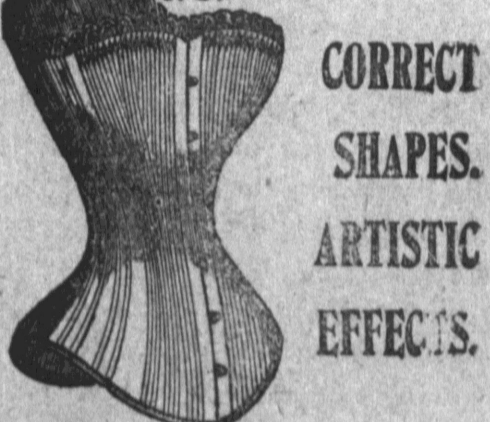
