## TRIBUTE TO G. B. HUGHES

When the telegram announcing the death of Geo. B. Hughes was made known here this morning, while his friends were not altogether unprepared for it, there were many sad expressions of genuine, heart-felt regret. About six weeks ago he was taken sick at his father's in Chase City, Va., with what the doctors thought was typhoid fever. A few days ago it was determined that an operation for abscess of the liver was necessary. The operation was performed and doubtless had he not been so weak from fever he would have recovered but the tax was too great and Tuesday evening about 7 o'clock, just as the last shimmering sunbeams of the day were dancing among the oaks that stand like sentinels of old in the spacious grounds of the old Virginia homestead, there passed from earth one of the noblest men that it has ever been my pleasure to know.

To me he was a true, loyal friend and partner, and in his death I feel very keenly a severe personal loss. He always made friends wherever he went and he seemed to take great pleasure in scattering sunshine and flowers among those with whom he came in contact. Doing all the good he could for his fellow man, rendering every act of kindness within his power, wishing even his enemies, if he had any, no ill will, he was the typical ideal of the true Southern gentleman that he was. Around the death bed scene of this good man when it was known that life was extinct and the cold damp dew of death had gathered on his manly brow, surrounded by his devoted wife, relatives and friends, I know it was a sad, heart-rending scene. Words are not adequate to express our feelings but the emotions of many hearts go out to the bereaved ones in this their saddest and most desolate hour.

## North Carolina's Election.

Below we give a comment of a number of leading papers in other States upon the recent election in North Carolina. A reading of these will show that out of all classes—Democratic, Populist and Republican—the New York World, claiming to be Democratic, is the only paper that throws an insult at our State.

**New Orleans Picayune (Dem.):** It is important to note that the educated and intelligent negroes voted for the constitutional amendment which disfranchises the ignorant and thriftless of their race.

**Louisville Courier-Journal (Democrat):** One of the pleasing prospects to be looked forward to from the North Carolina election is the succession of a Democrat to the seat in the senate occupied by little Marion Butler.

**Augusta Tribune (Populist):** Hon. Marion Butler got it in the neck heavy, and he is now wondering where he is at, or where he might have been if he had not listened to the seductive voice of Chairman J. K. Jones and old Senator Stewart.

**Chicago Times-Herald (Rep.):** It may be safely assumed that the amendment will be rigorously carried out. The ultimate consequences of its enforcement will be the degradation of the white voter and the development of a desire on the part of the negro for education which the state cannot ignore and the Democrats cannot repress.

**Columbia State (Dem.):** Now that the negro is to be eliminated from the problem the Populists and white Republicans of the state will probably fuse, and in time they will be joined by a growing element now nominally Democratic, but at heart for the Republican policies. With the negro out of the way North Carolina will again become debatable ground.

**Nashville American (Democrat):** We congratulate the people of North Carolina on their great victory. We doubted the wisdom of the "grandfather's clause" of the constitutional amendment, but, as we have said before, the people of North Carolina know their business and understand the management of their own affairs better than any one else.

**New York World (Dem.):** In so far as it permits white illiterates to vote, the amendment is as frank a violation of the federal constitution as the methods of intimidation and violence by which it was carried were a frank violation of the usage of civilization. The benefit of the amendment is that it will exclude a great mass of wholly unfit illiterates from the polls. The evil is that it is a monument to violation of law and justice.

**Birmingham News (Dem.):** With Butler but a memory and Pritchard laid on the shelf two years hence, as he surely will be, North Carolina will be prepared to resume the proud place which it held in the sisterhood of Southern states when Vance and Ransom were its representatives in the United States senate, and men like Fowle and Carr sat in the gubernatorial chair and white rule held sway. The Democrats of the Tar Heel State did a splendid day's work.

**Memphis Commercial Appeal (Democratic):** With restoration of Democratic supremacy should come a period of lustration and cleansing when the time-servers who have been smirking at and courting dominant Populism may be extirpated and only those grounded in

the faith, those who have proven true and who have never wavered or made compromises, during the dark days, be permitted to full membership without probation. There are many who have preached Democracy and practical Populism.

**Baltimore Sun (Dem.):** There is no disposition in North Carolina to treat the negro unkindly. His best friends in that State are among the most ardent advocates of the amendment adopted yesterday. He will be educated and cared for in the future, as in the past, by those who voted to disfranchise the illiterate of his race.

**Philadelphia Times (Independent Democrat):** Thus South Carolina, Mississippi, Louisiana and North Carolina have simply followed in the footsteps of the Republican national leaders, who first made the experiment of indiscriminate negro suffrage and who were compelled to make the first experiment absolutely revoking the franchise by placing the District of Columbia under a government entirely removed from the power of the people. It is simply the inevitable that has come to North Carolina, and that it has come in violence and lawlessness only proves how supreme was the necessity for eliminating the race issue in North Carolina.

**Richmond Times (Dem.):** Once more we ask what good things has Mr. Butler accomplished, either for himself or for his state? He has gained notoriety enough to satisfy any politician's ambition, and he has gained position, but he is today the most cordially hated man in his state, if not in any state of the Union. The great body of North Carolinians despise him and hold him in contempt, and there is such rejoicing as has rarely been known in the old North State that Marion Butler has been defeated and retired. Marion Butler has a "talent for turbulence," and he has employed it against his own kith and kin. He has succeeded in making strife in his native state, he is responsible largely for the race troubles that have existed, and the blood of black men who trusted him is upon his hands. He arrayed race against race, and even brother against brother, and he aroused the Red Shirts of the state to the fighting point. He tried, what other shrewd politicians tried in this Southern state and that, to organize the negroes and through them to govern the whites. He succeeded for a time as his predecessors in other states succeeded for a time, but the day of his triumph was short and the punishment was sure. Let others who would attempt this damnable thing take warning from the rise and fall of Marion Butler.

**New York Commercial Advertiser (Republican):** The certain discouraging fact is that nearly all local public opinion of a quality that would be taken into serious account in the North supports negro disfranchisement, openly or

tacitly, without regard to party. This becomes more evident as the issue flows over into border states, where negroes are fewer and Republicans more numerous. This practical race unanimity is assurance that neither federal legislation nor judicial decisions will check the spread of negro disfranchisement into every state where the negroes are a political factor. Then the question of basis of representation will become a burning one.

**Norfolk Landmark (Democrat):** This restriction of the franchise in North Carolina will do the negro good as well as the white man. All who are familiar with the history of the past decade in that State know very well that the colored voter has not voluntarily made himself obnoxious, but that he has been a tool in the hands of designing politicians who played the iniquitous game of fusion to get the government of the State away from those who had the State's interests at heart. The colored vote was the stiletto with which these schemers wounded the Commonwealth. In itself, the stiletto was not very dangerous. It was the force that wielded it that was to blame.

The adoption of the amendment will prove beneficial to North Carolina in more than a political way. With the friction between the races reduced to a minimum and white supremacy assured, the material development of the state will be greatly promoted.

**Richmond Dispatch (Democrat):** The result, when the franchise amendment eliminating the negro vote adopted, and the state Democratic ticket returned, and when the party secured an overwhelming preponderance of the members of both branches of the legislature—and all by a majority of upwards of 50,000—was but the sequel to the Wilmington revolution of 1898. We say revolution, for that demonstration was nothing else. It was not a riot or a sporadic uprising on the part of the whites, as it has been frequently and loosely misnamed. It was armed protest against a tyranny worse than the tyranny of kings and princes.

Chicago's postmaster is very proud of the "tremendous" business done by his office. The total for July was \$476,940.80, an increase of \$100,748.78 over 1898, and of \$55,338.46 over last year.

There will be 1522 polling places in the Greater New York this year. There are 1583 in Nebraska and 1513 in North Carolina.
