### FIREMEN THANKED.

Commissioners of Washington  
Adopt Resolutions.

Following is a copy of resolutions adopted by the commissioners of Washington, Friday, Sept. 14th 1900, and sent to Mayor Moye:

Whereas, during the devastating fire which visited our town on the 13th inst., which, at one time, threatened the destruction of the entire business portion of the town appeal was made to certain of our sister towns for aid in fighting the fire.

And whereas the towns of Greenville, Tarboro, Rocky Mount and Wilson, promptly responded, announcing their readiness and desire to do all in their power to assist us, with men and engines; expressing their sympathy and in every way manifesting a courtesy and consideration truly appreciable;

And Whereas the Greenville Fire Company came down with their engine and rendered most valuable aid in suppressing the fire conducting themselves in a manner most highly creditable to their manhood and firemanship;

And Whereas the Rocky Mount Department had started men and engines, but was notified that the

fire was under control, and their coming not necessary;

And Whereas the towns of Wilson and Tarboro were in readiness to come immediately upon being notified of the necessity thereof;

Be it Resolved that for and in behalf of the citizens of Washington, we, their representatives, do express to authorities and fire departments of the said towns of Wilson, Tarboro, Rocky Mount and Greenville our deep and lasting gratitude and appreciation, with assurances of our ever standing ready to demonstrate this gratitude and appreciation when possible.

Resolved further that a copy of these resolutions be sent to the Mayor of each of the said towns, to be by him presented to the Board of Commissioners and Head of the Fire Department.

Resolved further that a copy be published in each of the local papers.

The awful threat is held over us by Representative White, colored, of the second district of this State, that if the courts uphold the constitutional amendment he will move to New York and that 50,000 negroes will leave the State. Those of them who contemplate going with Col. White to New York will, along with him, be interested in the following story in The Observer's New York correspondence, Sunday, of a parade of a colored club in that city:

The other night the Elberon Club paraded. For the size of the club, or rather for the number of paraders, it had the biggest escort of police ever seen in this town. The paraders amounted to eleven colored men and the drum and life corps—total, 22 "coons." Their escort consisted of ten policemen in front fourteen behind, and more than four hundred, including detectives, along the sidewalks.

This was an average of 19 and a fraction policemen to each parader, and will indicate to our darkies how hospitable a welcome awaits them in New York.—Charlotte Observer.

## ALMOST A FIRE.

### Little Blaze in some Trash.

There was a little excitement on the street early Tuesday night when it was learned that some fire had been found between the walling and engine room at the John Flanagan Buggy Co's. factory. Parties living near by saw the blaze among some paper and trash and ran over there and put it out.

There was some talk of incendiarism and the blood hounds were taken there at once. They struck a trail and caught a colored man down on the river, but there seemed to be nothing against him. He might have walked by the building. There is a public path that goes through the lot near where the fire was seen, and anyone passing that way could have thrown a match or cigarette stump in the trash.

r. Greene, manager of the buggy company, says that he does not believe it was any attempt at burning but that some one passing accidentally dropped the fire.

United Christian—J. F. R. Leonard, of Iowa; Charles M. Sheldon of Kansas.

Anti-Imperialists—William J. Bryan, of Nebraska; no endorsement.

National—Donaldson Caffery, of Louisiana; Archibald M. Howe, of Massachusetts.

National Union Reform—Seth Ellis, of Ohio; Samuel T. Nicholson, of Pennsylvania.

**AN OPEN LETTER.**

**Hon. F. M. Simmons Refutes Charges Against Him.**

J. D. ALLEN, Esq., Falls, N. C.

DEAR SIR:—

I am in receipt of your recent favor, in which you say that it is being charged against me, as an aspirant for the Senate.

First, that Senator Vance opposed my confirmation as Collector upon grounds derogatory to my personal character.

Second, that I am charged with being a secret agent of the Southern Railway Company, and that it and other corporations have been, and are now, paying me large sums of money to protect their interests as a lobbyist and otherwise, and you express the opinion, in which I concur, that as I am a candidate for their suffrage, the people are entitled to know the facts with reference to these charges.

In reply, I beg to say that Senator Vance's opposition to my confirmation was not based upon personal grounds and no charge against my personal character was made in connection with that matter. At the time of my appointment as Collector, Senator Vance, together with the other Senators and all the democratic congressmen from North Carolina, favored me. The subsequent opposition of Senator Vance to my confirmation arose out of complications connected with the appointment of the Collector for the Western District of North Carolina. The records of the Senate and the delegation in Congress from this State at that time will bear out these statements.

With reference to the second charge to which you refer, I beg to say that it is not true that I am attorney or agent, either secret or otherwise, of the Southern Railroad. I have never appeared for that railroad in any capacity. It has never paid me a cent of money in my life, except a contribution made to me as Chairman of the Committee in 1898, which was spent for the benefit of the party. On the contrary, I have appeared and am appearing against it in many suits. During the last three years, since I commenced to practice law in Raleigh, I have been of counsel in recovering a number of judgments against it, one of them for as much as sixty-three hundred dollars, and I now appear of counsel in quite a number of cases against it, in which my clients claim damages for from thirty to forty thousand dollars. I am also of counsel against it in the tax assessment cases.

It is not true that I am, or have at any time been, a secret agent or

attorney for any corporations or person, nor that I am a lobbyist, nor that I have at any time been in receipt of any personal income from any source whatever except such as comes legitimately to any North Carolina lawyer enjoying a moderate practice. I neither lobbied in the last Legislature, nor discussed with its members subjects connected with their duties not pertaining to general legislation, such as the Constitutional Amendment, the Election Law, etc. I am sure no member of the Legislature of 1899 will dispute this statement.

During the last three years, since I have been living in Raleigh, my whole income from all sources has been barely sufficient to support my family, although we live economically.

My entire estate, including property belonging to my wife, would not probably sell for more than seventeen or eighteen thousand dollars and it is encumbered by unpaid mortgages of over three years standing for eleven thousand dollars. Even my home is mortgaged for about half its purchase money.

I do my banking business with the Citizens National Bank of this city, and its books will show I have not had to my personal credit at any one time during the last two years as much as one thousand dollars.

When the campaign of this year closed, the committee was very much behind. There were a number of urgent bills to be met, for which I was responsible. I borrowed, upon the endorsement of a friend, from the Commercial & Farmers Bank of this city, one thousand dollars and gave it to the Committee as my contribution to the campaign.

Painful as it is to do so, I deem it proper to make this statement about my private affairs that the people of the State may see how unjust and cruel are the charges with which it is being sought to injure and destroy my reputation. During the last three years I have given to the Democratic party a year of my time without any compensation, having actually borrowed money to pay, in part, my expenses while engaged in this work, and I have also given to it this year more than one-seventh of my net fortune.

I have done this ingrudgingly and if my State should ever again fall back into the horrible conditions from which it has been rescued, and again wish my services I shall not answer not now, but at a more propitious season. I have not made, and do not intend to make any demands upon the party

for the sacrifices. A party has a right to expect, in time and money sacrifices from its adherents, but no party exigencies can require the sacrifice of a man's character.

During the last three years the fusionists have heaped upon me a degree of slander and vituperation which perhaps never before fell to the lot of any man in the State. I have borne these assaults with patience, counting myself fortunate that I was considered worthy to suffer in the name of the cause for which I was struggling. This abuse has been directed against me not only as an individual, but I have been denounced by the enemies of Democracy for everything done by the Democratic party which has not pleased them.

It now seems that these charges made by the fusionists have been revamped and are being circulated to my detriment by men in my own party, because, forsooth, I am in the way of the ambition of their favorite. So be it, I am not the only victim. Others, yea thousands of others, have felt the mailed hand of a power which brooks no opposition to the accomplishment of its purpose, and which, though it was not always so, has recently become in this country a power mightier than "the man" himself.

There is no skeleton in my closet. For three years the enemies of Democracy, with evil and vicious eyes, have turned the searchlight of inspection upon my life and character. In the midst of it all I have stood defiant, asking no quarters and giving none. I ask none now, but there is a difference between injustice from foes and injustice from friends. The former may be regarded with indifference; the latter is shaper than a serpent's tooth.

My Democracy is without qualifications. I stand straight, square and flatfooted for every principle and declaration in our platforms, State and National, and for Mr. Bryan, the great leader of our hosts.

There is a well defined and largely successful movement in certain parts of the State to organize, against me and in favor of one of my opponents, certain interests and influence which, though usually acting with the Democratic Party, are out of sympathy with and actually hostile to some of its principles and policies, and more or less unfriendly to our candidate for the Presidency. I have no apologies to make to anyone for my advocacy of the principles of the Democratic National platform, nor for my earnest admiration and support of Mr. Bryan. I stand for these principles separately and

collectively; not for a part of them, but for each and everyone of them. I am glad that my position in these regards is fully understood in North Carolina, because I do not want to secure any man's vote upon false pretences.

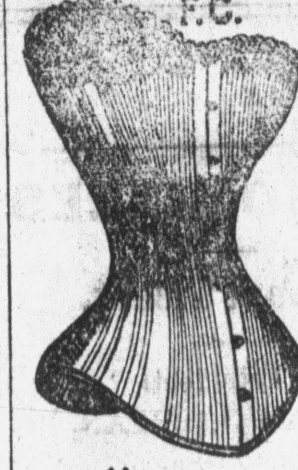

The grand jury returned a true bill for murder against Annie Dixon, colored, for poisoning her husband.

William Peace, assault with deadly weapon, guilty, judgment suspended upon payment of costs. He was also convicted in two other cases of resisting officer and carrying concealed weapon, judgment suspended upon payment of costs in each.

The Negro Caught.

Some time ago, just previous to the election, it will be remembered that Mr. R. R. Carr, of near Willow Green, Greene county, was assaulted by two negroes. He was struck several times over the head with a chair by one of them and was severely injured. The negroes escaped, and a reward of \$100 was offered for their capture. We have heard it rumored that one of the fellows was captured in Greene county. All trace of the other one, Albert Barrett, was lost until last night, when Detective J. Geo. Wolfe and Officer F. M. Barham, of Norfolk, Va., came to Kinston from that city, bringing the negro to Kinston, and placing him in jail. They left early this morning for Snow Hill with their prisoner, where they will claim the reward. The negro had been shadowed in Norfolk for several days, and when his identity was beyond question the arrest was made. He was simply paralyzed with fear.—Kinston Free Press.

The census bureau places the population of Norfolk at 46,624, an increase of 11,753 in the last ten years.

A severe storm—in fact, a hurricane—swept over a portion of Wake and Franklin counties Saturday night and wrought considerable havoc. It is from Wake Forest to Youngville that the most severe damage thus far reported was done. The path of the hurricane was very narrow, ranging from sixty to a hundred feet.

The most serious damage was at Youngville, where the Methodist and Baptist churches were demolished, as was a tobacco prizehouse nearing completion, and several residences badly wrecked. A negro woman, whose name could not be ascertained, was seriously injured by falling timbers when her house succumbed to the fury of the wind.

At Wake Forest the office of Mr. J. D. Briggs, the superintendent in charge of the new cotton mill there, was blown down and the plans for the factory so badly damaged as to necessitate duplication. The scaffolding about the factory walls was also blown down.—Raleigh Post.
