TWO CLOSE CALLS.

Fire Alarms Turned in Twice Today.

This morning a fire alarm was sent in from Hotel Macon, and for a few minutes there was much excitement. In Mr. E. B. Ficklen's room in the second story of the building the draperies around the mantel caught fire from the stove pipe. From the drapery the flames were communicated to the window curtains. Fortunately someone went in the room before the fire had caught any of the wood work, and with a little water the flames were quickly put out. The drapery and curtains were destroyed, and articles on the mantel and the bureau were ruined or damaged.

It is fortunate that the fire was discovered so early, for with the winds that prevailed this morning it would have been a bad time for fire.

SECOND ALARM.

A little past noon the fire alarm rang a second time, the Godwin house next to the Presbyterian church, on Dickinson avenue, being on fire. The house is occupied by Mr. R. A. Nichols. Sparks from the chimney fell on the roof and set it on fire. The fire department turned out, but their service was not needed as the fire was quickly put out. The damage to the building was slight.

Fire At Robersonville.

The town of Robersonville was visited by a destructive fire Monday morning. It originated in the old market house which was unoccupied. The following business houses were burned: Bailey & Barnhill, loss \$4,000; G. A. Gulford loss \$3,000; S. L. Andrews, loss \$1,000; Kirk Roberson, two vacant stores; R. L. Smith & Co., loss \$4,000; Wm. Jones, bar, loss \$500; post office and contents; Bailey & Barnhill, one vacant store; stores belonging to A. F. Roberson & Co., and G. D. and J. C. Roberson. Several other buildings, stables, barns, woodhouses etc., were destroyed. Quite a number were damaged, among them Miss Katie Tankard, milliner \$200 to stock. The whole loss is roughly estimated to be \$15,000, partly covered by insurance.

This legislature ought to put an end to the fee as it relates to solicitors by giving every solicitor a salary and putting the fees into the State treasury. The fee business is not the proper way to pay public officers in any branch of government, but it is specially unwise and dangerous to let the salary of a prosecuting attorney depend upon the success of the prosecution of men charged with crime. The salary ought to be the same in all the districts and it wouldn't be a bad plan if they were elected by the whole State and rotated just as the judges do.

Within the past four years congress has changed the fee business and district attorneys are now paid a salary. North Carolina would do well to put the same reform in practice in this State.—Raleigh News Observer.

STATE NEWS.

Happenings in North Carolina.

J. T. Mallory, of Durham, a prominent cigar manufacturer, died Tuesday.

The citizens of Charlotte are discussing pro and con, the establishment of a dispensary in that city.

Mr. J. B. Hardison, an aged and honored citizen of Latham's, Beaufort county, died on the 11th inst at noon. Mr. Hardison was an earnest member of the church of Christ.

The body of an unknown white man was found suspended from a limb near Marion. There was nothing on his person by which he could be identified. It is believed to have been a case of suicide.

The number of State convicts has now fallen to but little over 800. of these 275 are in the prison proper, while 475 are on the State farms. One of these farms is owned by the State and two are leased, but the leases expire this year. The remainder of the convicts are on railway construction.

Mr. Small's Bill.

Congressman John H. Small, of this district, on the 9th inst. introduced the following in Congress:

A bill to prohibit the sale or manufacture of distilled spirits, fermented liquors or wines, under the authority of the United States, in States where the same is prohibited by the laws of said States. Be it enacted by the Senate and House of Representatives of the United States of America in Congress assembled, that no persons, under the authority of the United States, shall sell distilled spirits or fermented liquors, as defined by law, or wines, in any State or any subdivision thereof, where the sale of distilled spirits, fermented liquors or wines is prohibited by the laws of said State, and no license shall be issued by the United States permitting such sale; and no person shall, under the authority of the United States, begin the manufacture of distilled spirits, fermented liquors or wines in any State or subdivision thereof where the manufacture and sale of same is prohibited by the laws of such State, and no license shall issue by the United States authorizing such manufacture.

TRAINING HORSES.

Preparing the New Animals For the Circus Ring.

All through the winter circus men are training the animals for new tricks for the next summer. The winter is by no means an idle time. Training horses for the ring is interesting work. The first thing done is to put the new horses in the stables with the old circus horses to get them used to their new company, and a queer thing noticed is that the old horses are jealous of the newcomers.

A great deal of patience and time is required to train the horses to run around the ring. They are blindfolded and taught to run around the ring in a circle. The natural tendency of the horse is to run straight, and it is a hard thing for him to learn. A system of checks and lines makes the training easier than formerly.

The horse is an observant animal and apt to do what he sees another horse do, so when the blindfold is removed he is placed alongside an old trained horse, and the man who is to ride the new animal does tricks with the old ones, then tries them on the pupil. A good, intelligent horse soon learns and actually helps his rider.

Horses are very sensitive to applause and with that stimulus will do twice as much work as without. They are just as likely to lose their heads as human performers and have to be carefully watched. A well trained ring horse is easily worth \$1,000, and riders who are stars usually own their horses. The most careful attention is given these animals. Before each act their backs are rubbed with resin, which has to be washed off afterward.—San Francisco Chronicle.
