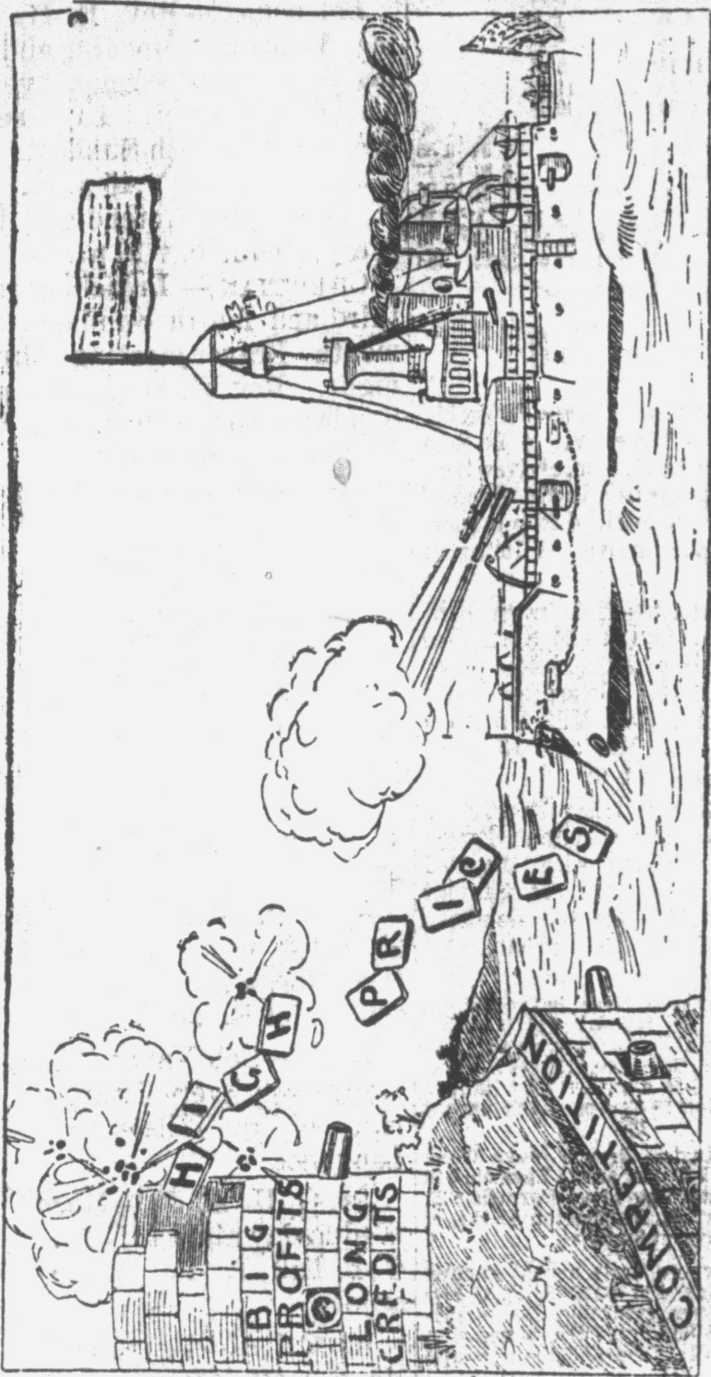

COUNTY COMMISSIONERS.

Proceedings of the September Meeting.

The Board of County Commissioners met in regular session on Monday, 2nd, all the members being present.

The amount allowed to paupers was \$160.53; for County Home \$142.62; bridges \$108.65; Constable fees \$38.95; Coroner \$23.30; vaccination and smallpox house \$24.58; printing, stationery and books \$32.50; witness tickets \$14.25; making tax lists \$400; taxes refunded \$25.80; jail \$125.57; Sheriff \$15.80; Register Deeds \$18.50; Commissioners \$33.80, sundries \$9.75.

The Treasurer and Superintendent of Health presented their monthly reports.

The Register of Deeds was ordered to turn over to the Sheriff the tax books for 1901.

The keeper of Greenville bridge was authorized to order lumber necessary for repairs.

The following persons were added to pauper list to receive the amount stated per month. Simon Johnson \$1, Tom Pollard \$3, John W. Carson \$2, Annis Parker \$1, Nanie Summerell \$1, John Hagans \$1.

Petition to discontinue public road leading from Ben Stokes' in Swift Creek township across Clay Root swamp to Susau Adams' at Greenville and Vanceboro road in Chicod township, was deferred to October meeting with committee to investigate.

The Sheriff was ordered to lay off a public road from a point on the Tarboro road near G. F. Evans home place to the Stauntonburg road near the corner of F. M. Smith place.

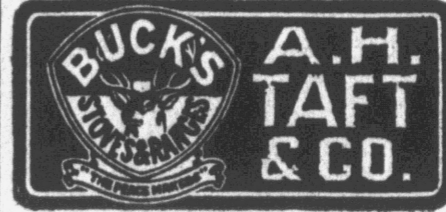

AUGUST TOBACCO SALES.

Tremendous Gain Over Last Year.

Mr. M. A. Allen, Secretary of the Greenville Tobacco Board of Trade, handed THE REFLECTOR the report of sales on the Greenville market for the month of August, with comparative figures for the same month last year. The sales for August, 1901, were 1,653,694 pounds, while for August, 1900, there were 632,741 pounds sold. These figures show a gain for this year of 1,020,953 pounds, an increase of more than 260 percent.

As our readers may be desirous of knowing what neighboring markets are doing we also give the figures from Wilson and Kinston for comparison. In August this year Wilson sold 3,125,304 pounds, last year 1,322,476, a gain of 1,802,828. Kinston sold this year 1,864,094, last year 1,047,569, a gain of 816,525.

These comparative figures show that Greenville made the largest percentage of increase of either of the three markets. Just why sales have increased so much this year we are not able to say, unless it be due to the good prices prevailing. Surely there is not as much tobacco raised this year and last, and at the rate it is coming to the market the crop will all be sold before Christmas.

Strange Phenomenon in Ashe.

Ashe county has the strangest phenomenon yet reported as a supposed result of the continuous rains. On Phoenix Mountain, about four miles from Jefferson, crowds have been gathering for several days to see the openings in the sides of the mountain. There are three of these openings, varying in width from two to nine feet and of a depth of from two to six feet. There are no slides of earth at the points, but a sharp division of the soil and the rocks imbedded therein. The dead trees which are lying on the surface are dragged to one side of the opening, or left spanning them; the rocks, which lay upon the surface, are upon one side or the other of the openings, with their edges suspended over the cavity. Strangest of all, the trees which were growing at the place of the cracks in the earth, are split at the bottom and now span the opening in the earth, one half the tree on one side and the other half upon the other. Where the edge of a tree just touched the point of division in the earth, that edge is shaved off and the tree left standing.—Charlotte Observer.
