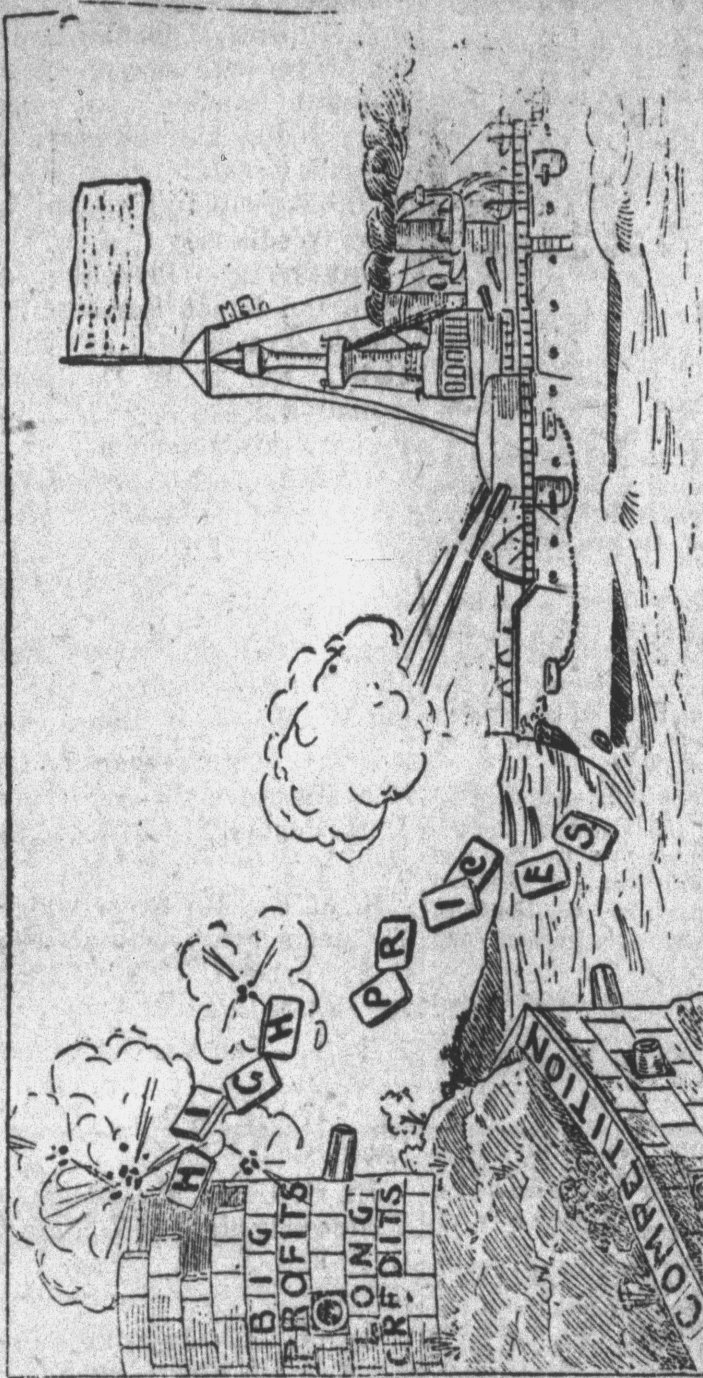

**THE PRESIDENT WORSE.**

His Condition Alarming and the Worst Feared.

Thursday night President McKinley's condition took an alarming change for the worse and now there are the gravest apprehensions of the result. The following bulletins were given out this morning:

Buffalo, Sept. 13, 3:30 A. M.—An alarming change for the worse has taken place in the President's condition. Senator Hanna, Vice-President Roosevelt, members of the Cabinet and relatives were mostly summoned to his bedside. Two emergency operations were performed.

Buffalo, 3:40 A. M.—Secretary Cartleyou says prepare for the worst. President McKinley is still conscious but sinking rapidly.

Buffalo, 9:30 A. M.—Physicians worked constantly over the President up to an hour ago, when his heart responded to their treatment and he rallied slowly. He is now in a forced sleep from exhaustion and in extreme danger of the end.

Buffalo, 9 A. M.—The President's condition causes the gravest apprehension of the worst.

Buffalo, noon—At this hour it is not thought the President can live four hours.

About one o'clock the President was thought to be dying, but just before going to press it was reported that Senator Hanna still expressed the hope that he would pull through. The doctors, however, have no hope whatever.

After making her trip Thursday the steamer Myers went on the ways at Washington for repairs and will not be up again until Monday. The steamer Edgcombe is on the run in place of the Myers, but that steamer takes no passengers.

The street was crowded with vehicles and the girl drove into and locked wheels with a wagon. She seemed to have no idea about driving, and was noticed trying to back the horse and clucking the animal forward at the same time. The result was quite a mix up and a narrow escape from accident.

A writer in the Southern Farm Magazine, Dr. J. A. Killebrew, makes some strong points against mortgaging farms and shows conclusively why the farmers of the South are now prospering more than the farmers of the West. He says that immediately after the Civil War farmers in the West could easily borrow money at 7 and 8 per cent. while the farmers in the South were without credit and seemed ruined. The Western farmers borrowed money and reveled in luxuries while the Southern farmers struggled with poverty, the framers in the South were forced to depend on themselves, and being forced to depend on themselves they became independent. As a result Dr. Killebrew says: "The farms in the South are in the main free of mortgages; the farmers are generally out of debt. What they control is their own and they are dependent upon no capitalist or bank to furnish them with the means to gain a subsistence."—Scotland Neck Commonwealth.

United States Senator Wellington, of Maryland, who because of a personal dislike for President McKinley made disparaging remarks about his attempted assassination, has been expelled from the Union League of Maryland of which he was a member.

What will be the outcome of the injunction started against the officials of the town to prevent the sale of the bonds for improvements, of course cannot be told yet. THE BOND INJUNCTION.

The Notice and Complaint in the Case.

Below THE REFLECTOR gives copies of the notice and complaint in the bond injunction proceedings as served on Mayor W. H. Long. Pitt County—In Superior Court. S. T. Hooker and others

vs. The Town of Greenville. This cause coming on to be heard at Chambers before His Honor O. H. Allen, Judge, and it appearing to the Court the plaintiff is entitled to relief.

It is considered, ordered and adjudged, that the defendant appear before His Honor H. R. Bryan, Judge of the Third Judicial District in the town of New Berne, on Monday, September 30th, 1901, and show cause why an injunction should not be granted in this cause as prayed for by the plaintiff.

It is further considered and adjudged by the Court that upon the execution of a bond in the sum of two hundred dollars payable to the defendant and to be approved by the Clerk and filed in the cause, and conditioned upon the payment to the defendant of all such costs and damages as they may sustain by the wrongful issuance of the restraining order, that the Mayor, the Board of Aldermen and all officials of the said town by whatsoever name called, and each of them, their agents and attorneys are hereby restrained and enjoined from issuing, selling, delivering, or in any way disposing of any of the bonds mentioned in the complaint filed in this action, or attempting to collect the tax levied to pay interest on said bonds until the further orders of the Court.

Pitt County—In Superior Court. S. T. Hooker and others

vs. The Town of Greenville, The plaintiff complaining of the defendant alleges,

1. That he is a citizen and tax payer of the said town of Greenville.

2. That by an Act of the Legislature of 1901, the said Town was authorized and empowered, through its properly constituted authority and upon certain conditions therein required, to issue interest bearing coupon bonds to the amount of \$75,000.00, provided a majority of the qualified voters of said Town should so vote—

3. That he is informed and believes that at the election called to ascertain the wishes of the qualified voters of said Town that a majority of the qualified voters of said Town did not vote—

4. That he is informed and believes that the new Registration under which said Election was held was not in accordance with the Election Law of the State governing such Election, nor in accordance with the Act under which said Election was held.

5. That there is no provision made in said Act for the payment of the principal of said Bonds when they mature.

6. That the sale of the said Bonds are not properly guarded in said Act, no direction as to whom the money derived from the sale of said Bonds shall be paid and no person legally authorized to receive the same and in such uncertainty it would be dangerous to the interest of the tax payers of said Town to permit their sale.

7. That said Act authorizes the Board of Alderman of said Town, if Graded Schools shall be established in said Town, to turn over \$5,000.00 of the proceeds from the sale of said Bonds to the directors of said Graded Schools to be used in the erection of suitable build-

ings for said Schools, that no graded schools have been established in said Town, but the plaintiff is informed and believes that if a sale of said Bonds is permitted that the said Board of Aldermen will turn over said \$5,000.00 to an illegally constituted Graded School district in disregard of the spirit and meaning of said Act and thus unlawfully divert a part of said fund.

8. That the Act of the Legislature authorizing the issuing of said Bonds requires the Board of Aldermen each year, at the same time other taxes are levied to levy a sufficient tax on the taxable polls, taxable property and other taxable subjects to pay the interest of said Bonds, and the plaintiff is informed and believes that no such levy has been made as is required by said Act, and that the levy that was attempted to be made is void.

9. That he is informed and believes that the Board of Aldermen of said Town have agreed and contracted to sell, and are preparing to deliver said Bonds at a price far below their real value, and at a great loss to the tax payers of said Town, and that said sale was made without proper advertisement.

10. That the plaintiff has caused a summons to be issued against said defendant returnable to the October Term of Pitt Superior Court.

Wherefore plaintiff prays judgment.

1. That the Mayor, Board of Aldermen and officials of said Town be perpetually enjoined and restrained from issuing, selling or in other wise disposing of said Bonds or any part thereof.

2. That the tax collector or other office of said Town be enjoined and restrained from collecting any part of the special tax attempted part to be levied for the purpose of paying the interest on said Bonds.

3. For such other and further relief as plaintiff may be entitled, and for costs. F. G. JAMES, Att'y for plaintiff.

S. T. Hooker, plaintiff above named, being duly sworn deposes and says, that the facts set forth in the foregoing complaint are true of his own knowledge, except those matters and things stated on information and belief and those he believes true. S. T. HOOKER.
