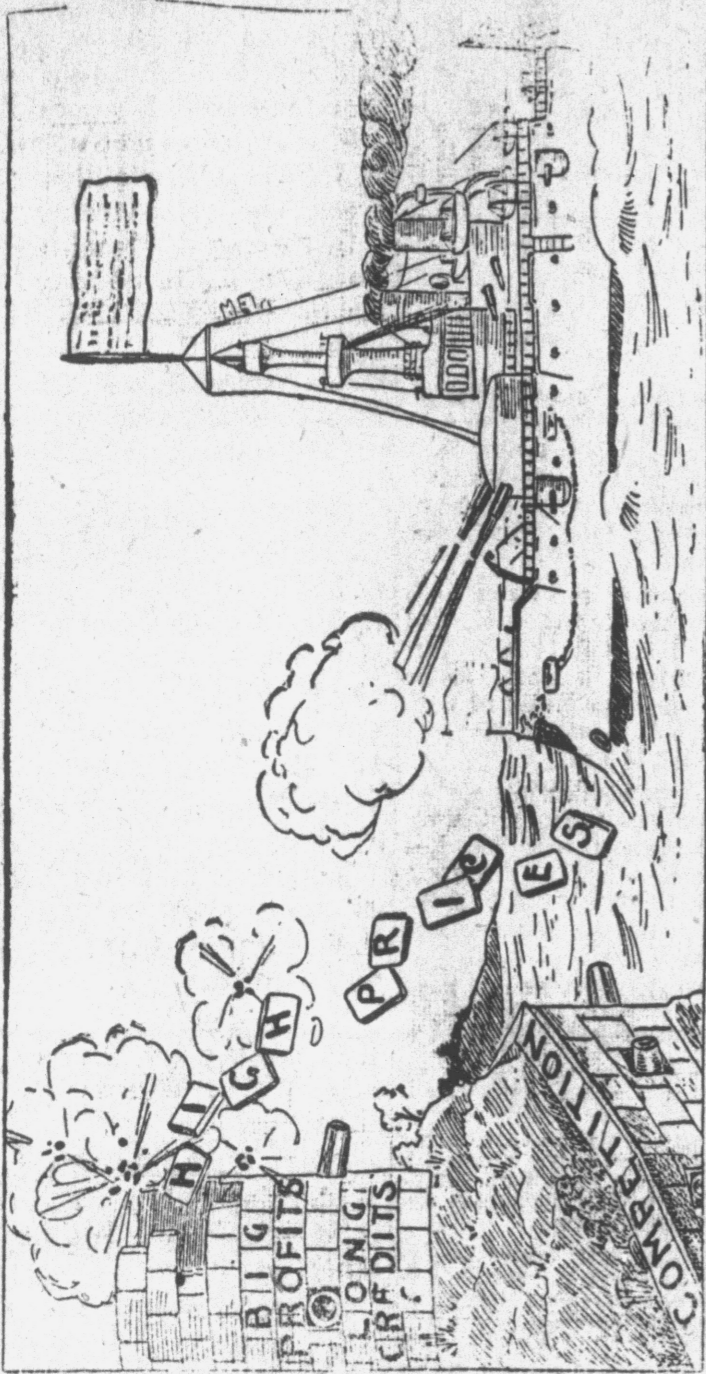

THE GREENVILLE BAR INDOSE JUDGE WINSTON.

The October term of Pitt county Superior court adjourned sine die Saturday night about 9 o'clock. Many important cases were tried and disposed of and on the whole it was a very busy week. Hon. Francis D. Winston, of Bertie, owing to the continued sickness of Judge Henry R. Bryan, presided. This is Judge Winston's first court in Pitt and among the first courts held by him since his appointment to the Bench in July. To one un-informed he appeared as a Judge of long experience, and the impression he has made upon the people of Pitt county during his one week stay in our midst was indeed a most favorable one. He was courteous and polite at all times, quick to grasp a proposition, fair and impartial in all his rulings, and is preeminently qualified to fill the high position to which he has been appointed.

Just before adjournment of court, upon motion of Hon. Harry Skinner, the Greenville Bar held a meeting at which Hon. A. L. Blow presided, and resolutions were adopted, thanking Judge Winston for holding the court, which he held without any remuneration whatever, and expressing their admiration for the manner in which he had conducted the court and for the uniform courtesy which he had shown the Bar during the term. Upon the adoption of the resolution many members of the Bar, including Hon. Harry Skinner, Goy. T. J. Jarvis, Judge A. M. Moore, Hon. L. I. Moore, Col. Isaac A. Sugg, W. F. Harding, Esq., and others, gave expression to the very high esteem in which Judge Winston is held by the Greenville Bar, and testified to his preeminent ability and fairness as a judicial officer.

Pitt county is to be congratulated that Judge Winston is to preside over the Spring terms, 1902, of its Superior courts.

No Decision Arrived At.

The charge against Powell is making false returns of stamp cancellations and selling stamps illegally. He was taken before a United States Commissioner and bound over to the Federal court in the sum of \$1,000.

ORDERED TO COLLECT.

Tax Books Turned Over to Collector.

At the special meeting Monday night the Board of Aldermen ordered that the town tax books be turned over to the Tax Collector with instructions that he proceed to collect the taxes thereon.

This order and instructions applies to both the general and special taxes levied by the town, the special taxes being for interest on bonds and for graded schools.

Owing to the injunction instituted against the Aldermen restraining them from selling the bonds and from collecting the special taxes, the books have been withheld from the Tax Collector until now. When the matter came to a hearing before Judge F. D. Winston last week he dissolved the injunction, hence this order from the Aldermen that the Tax Collector proceed to collect the taxes.

However, the plaintiff in the

action took an appeal to Supreme court which leaves a suit pending against the town and the matter still unsettled. The people being aware of this and knowing that it will yet be some time, perhaps several months, before the matter will be determined, with the uncertainty of how it will end, is going to make collecting, particularly the special taxes, hard work for the collector.

With this view of the matter, it would, perhaps, have been better—at least easier for the Tax Collector and more satisfactory to tax payers—if only the general taxes had been ordered collected now, and let the special taxes stand until the suit is settled.

Judge Thomas C. Fuller, aged 70, a native of North Carolina, and Associate Justice of the United States Court of Private Land Claims, to which he was appointed by President Harrison, in 1890, died in Raleigh Monday.

As sensible a man as Booker Washington is reputed to be, it would have been a wise hit on his part if he had shown sense enough to have politely declined the invitation to dine with President Roosevelt at the White House. Such a course on the part of Washington would easily have made him the most famous of the two, and entitled him to the most respect.

This vicinity seems to have arrived at that stage of development where a jury may be relied upon to give a verdict against a corporation on any kind of a pretext. It is a condition that warrants sober reflection—on both sides.—Winston Journal.

Winston is not alone in that particular, for it strikes us that in almost every section of North Carolina there is great injustice done corporations by juries. Let a body come to court some kind of complaint against a railroad company or telegraph company, or against a municipal corporation, it matters not how lame the complaint, the jury in almost every instance goes against the corporation. This thing is wrong, too. The corporation ought to have just as good rights in court as the individual, and a jury should be just as slow about giving a verdict against a corporation as it should against an individual.

PERJURY.

No honest lawyer would encourage false swearing; but when a lawyer is guilty of encouraging perjury in a witness he should be sent to the penitentiary along with the perjurer. Morally guilty of crime also is that lawyer who abuses witnesses, attacks the dead, assails character and makes base appeals to the ignorance, the passions, the prejudices of jurors. There appears to be a looseness about the law or the courts and the practice that permits crimes and acts against justice and decency and truth and fairness to be committed with almost absolute impunity in the very temple of justice. Rarely is there a determined attempt to punish the perjurer, who is too often aided and abetted by those who profess to be honest and respectable. The courts, of which lawyers are a part, are to blame for much of this. The solemnity of an oath should be emphasized. The violation should be speedily punished. False swearing is a villainous crime to which many are too easily tempted, and it deserves severe punishment.—Nashville American.

WASHINGTON LETTER.

From Our Regular Correspondent.
 WASHINGTON, D. C., Oct. 21.

As was to be expected a split has come between the President and Senator Hanna. While those who had the best interest of the party at heart wished that these two gentlemen might be able to get along together they had little ground on which to base any such hopes. Mr. Hanna had so long exercised a dictatorship authority over the party and had so carefully laid his plans to secure the nomination for himself at the next national convention that the succession of Mr. Roosevelt was a severe blow to his ambitions. Mr. Roosevelt with his positive disposition, his iron convictions and his forceful method of putting them into execution was almost bound to run counter to the feelings of the Ohio "boss" even if he had no ambition for a second term, which he certainly has. During Mr. McKinley's administration Mr. Hanna had complete control of all appointments in the South and had so used them as to cement together a solid machine which would stand bound to do his bidding at the next convention. President Roosevelt has upset all this good work and proposes to make Southern appointments to suit himself. The appointment of Ex-Governor Jones was a direct set back to the Hanna machine and more will, therefore Senator Hanna is sulking and talking of resigning, a threat which will not have the slightest effect upon the President.

President Roosevelt started out with the determination to build up a republican party in the South and by his first appointments, but even more by his expressed sentiments, made a most favorable impression. So impressed by the statement of his plans was old Col. Howell, of Atlanta, that he expressed himself as believing that the President would succeed in building up quite a respectable party, but he concluded with the sage advice that Mr. Roosevelt and his party must "talk protection and let the negro alone." This, unfortunately for Mr. Roosevelt's ambitions, he could not do, and with that love of the spectacular which led him to appear at the National Convention at Philadelphia in his Colonel's uniform, he invited Booker T. Washington to dine at the White House. Washington came and as he demolished the President's viands, so he demolished his popularity in the South, and today all the good that had been accomplished by the appointment of Ex-Governor Jones, Dr. Clayton and others, has been extinguished, and the Southerner feels that Mr. Roosevelt is no better than any other republican President, and that the first act of a successful local republican party would be an attempt at his humiliation by the exaltation of the negro.

Secretary Gage has not added in the least to his popularity by the expression of his views to the bankers at Milwaukee. Whatever the republican party leaders may think on the subject of the retirement of the greenbacks, they are not prepared to defend any such issue before the country and they are annoyed with the Secretary of the Treasury for having utterance to such views while still a member of the President's Cabinet.

Assistant Secretary of the Navy Frank W. Hackett, has asked to be relieved, and it is stated that Judge Charles H. Darling of Bennington, Vt., will be his successor. There is a rumor about that Mr. Hackett was to be made the scapegoat for the Bureau of Navigation, and that he refused to submit and resigned. I can find no confirma-

State and Federal Courts.

They have strange doings in the Federal Courts sometimes, as we have remarked aforetime. When a revenue official, for instance, commits a crime—kills or maims somebody—in the supposed discharge of his duty, his case is always taken to the Federal Court for trial and then the district attorney and assistant district attorney defend him and the power of the government is used to acquit him. If he is prosecuted a State solicitor must volunteer to do it or the man's friends must employ counsel to prosecute. We suppose if the man had no friends to push the prosecution the officer would not be prosecuted at all. On the other hand, if a citizen shoots or kills or in any way molests a revenue officer in the discharge of his duty the citizen is prosecuted by the government in the Federal Court and must get his own counsel to defend him.

In our State courts it is different. If a sheriff or other officer kills or injures any person he is prosecuted by the State solicitor just as if he were a private citizen, a little more vigorously if any difference, and instead of the power of the State government being used to defend the officer it is used to convict him. Such is the difference.—Statesville Landmark.

WILL FIGHT THE CASE.

The Town Takes an Appeal.

The Board of Aldermen held a special meeting Monday night to consider the matter of taking an appeal from the verdict of the jury in the case of E. C. Williams against the town, tried last week in the Superior court, resulting in a verdict of \$333 for the plaintiff.

Messrs. T. J. Jarvis and F. G. James, attorneys for the town, were present and went over the situation of the case with the Board, saying they did not see from the evidence how the jury could have given a verdict against the town, as it was clearly shown that the town had a right to raise the grade of the streets, and the testimony of physicians on both sides as expert witnesses showing that the surface water going on the premises of the plaintiff did not cause the death of his children.

An order was passed by the Board, the vote on it being 6 to 1, instructing the attorneys for the town to see if attorneys for the plaintiff would agree to a new trial being had, and if they did not to enter an appeal to Supreme Court.

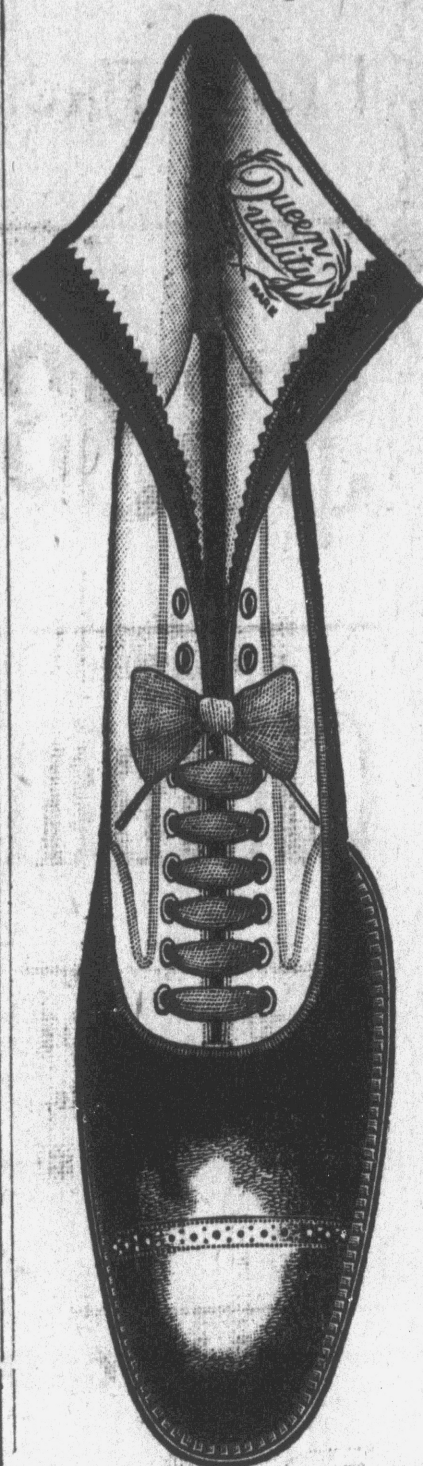
