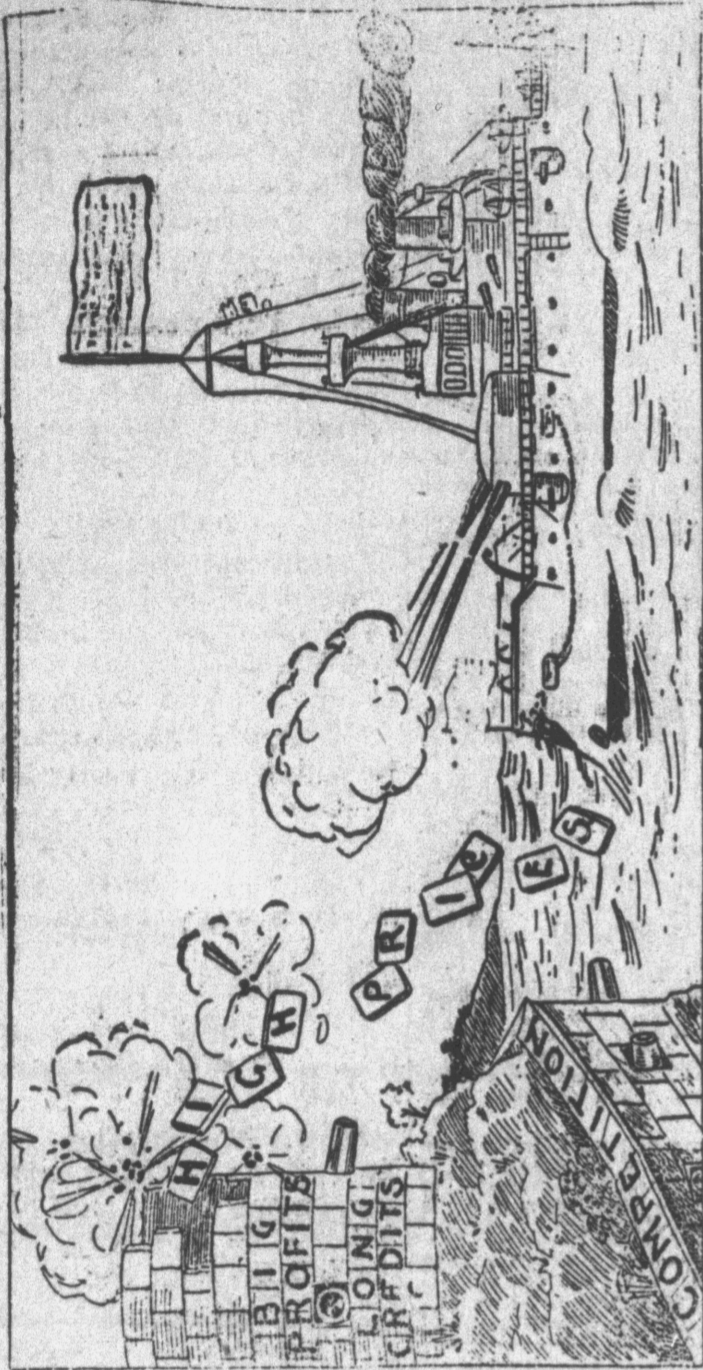

Limiting Lawyers' Speeches.

The Greensboro Record says that Judge Shaw, holding Guilford Superior Court, succeeded, last Friday afternoon, in getting the four attorneys in a suit then being tried, to limit their speeches to fifteen minutes each, and that thus a half day was saved, and The Record remarks that "the law giving the presiding judge power to limit debate should be restored by all means." This proposition is eminently sound. A great deal of time is consumed unnecessarily in our courts in arguments by attorneys, and no one knows this as well as themselves. The best class of them would hail with satisfaction the restoration to the judge of authority to limit the number and length of arguments to the jury. It is so in the United States courts, and nobody suffers. It was formerly so in the State courts but many years ago, as many, perhaps as twenty five, Judge Watts, holding court in Johnston county, was alleged to have abused the power and out of this grew the present condition. The old order of things should be restored, and in saying this we mean to imply nothing against the lawyers—the salt of the earth. They are wholly at fault, for a litigant, employing say three of them in his case, does not think they have earned their fees unless each of them speaks as long and as loud as his physical condition will permit.—Charlotte Observer.

The physicians of St. Louis are greatly disturbed by five deaths which have been traced to lockjaw following the administration of diphtheria antitoxin. The serum was provided by the city bacteriologists, and there is hardly a physician or a druggist in St. Louis who has not a supply of the same preparation. How the germs of lockjaw found their way into the antitoxin is a puzzle which the Coroner and the city bacteriologists have so far been unable to determine. These deaths show the necessity for exercising the greatest care in the choice of animals for the manufacture of antitoxin. Even with the utmost caution the serum may become dangerous to life. As a result of this experience manufacturers should take pains to test every preparation before giving it out to physicians.—Philadelphia Record.

RECOLLECTIONS OF GREENVILLE IN MY BOYHOOD.

(CONTINUED.)

The only thing on the lot, the academy excepted, was a sycamore tree. Not such a tree as Zaccheus climbed, a ladder would have been indispensable to have reached a standing place on the first limb, and to the first limb of this tree, which looked as though it might have grown out for the very purpose, was attached a swing the like of which I never since have seen.

In the dwelling on the left corner going down town Mr. J. J. Norcott lived, and afterwards Mr. Benj. Eborn. Mr. Norcott was a brother of Mrs. Bernard and a partner in merchandise with his half brother, Blount Nobles. He had two children, a son by his first wife, a sister of Mrs. Hoyt, who died in early manhood, and a daughter by his second wife, a Miss Biddle, of Craven county, who married Judge Bryan, of New Bern.

Mr. Thos. Hanrahan's store and dwelling were opposite this place on the lot on which the Methodist church now stands. He was a widower and his sister, Mrs. Elliot, lived with him. They were very clever people.

In the next dwelling Mr. Jas. Hoyle lived, and afterwards John Mansfield, who married his widow. Mrs. Hoyle Mansfield was a sister of Mr. Hanrahan's wife.

The next house on the corner opposite Norcott & Nobles store (in that day) was at one time the residence of Mr. Benj. Bell, a former Sheriff of the county and the father of Sam, Henry, Geo. and Jas. Bell and Mrs. Aruly. He had a dream many years before his death that he would die on a certain day, frequently spoke about it to his friends, made his preparations accordingly and when the day arrived took his bed and his

dream was literally fulfilled. Mr. Thos. Baswell and afterwards his widow, mother of (Miss Sally Ann Johnson) Mrs. S. A. Cherry, (lived here many years. Major Selby lived in the dwelling on the next corner (the Blount place) having moved from his old home across the street.

"There comes the Major," said some one of a group of men standing in the sunshine before Price's store door one winter morning, "see how he digs his cane in the ground. Watch boys, big news now!" "Good morning, Major!" said they all, as he approached. "What's the latest?" "Nothing, nothing," said he, and adding in a careless tone of voice, "Nothing but what you have all heard." "We have heard nothing this morning," said two or three. "Out with it please!" "Well, Bill Jones has failed and made an assignment." "Great Jehosephat!" said Dr. B. Brown Williams. "I thought Col. Jones was the richest man in the county. Are you not surprised Major?" "No, indeed! He has been keeping a pack of hounds and spent half his time hunting for the last ten years. Surprised? No, and so it will be with all of them."

About that moment there passed by a rusty looking old darkey leading by a string a poor, lank, mangy hound who could scarcely walk. And the Major seeing him, said, "That's right, my man. That's right, take the old wretch out and kill him. I wish you had every one in North Carolina to take along with you." The old darkey stopped and taking off his hat, said, "I can't kill me dog, Master, you don't know dis dog. He one er old Ratler's pups, if you just hear his voice one time you buy dis dog." "Buy the devil," said the Major, in a towering rage, "get out of this town, you old scoundrel. If Billy Williams sees that hound I'll take a gun and shoot you."

Dr. Blow, as I heretofore stated, owned and lived in the house across the street from the Brickle place as you go down town. He settled in Greenville for the practice of his profession when a young man and soon secured a very large and perhaps the leading practice of the town. He was a man of ardent and impulsive temperament, an enthusiastic Whig, and he became involved in the exciting political movements of the day, and complications in which he deemed himself unfairly treated led to his estrangement from his party and great bitterness towards him from some of his former political associates. He, however, successfully vindicated himself with the public, and his general disposition and absolute devotion to his friends under all circumstances secured to him a host of life long friends and admirers.

It was in 1846 that the fatal duel between Henry F. Harriss and Edward C. Yellowley took place, the details of which are a part of the history. The day and are too familiar to repeat. Perhaps no two men ever faced each other in mortal combat more highly endowed by nature with those characteristics which challenge the admiration of their friends. Harriss, noble, sensitive, nervous and brave to a fault. Yellowley, calm chivalrous and the very soul of honor. The meeting could not be prevented and the result was as anticipated.

The Hon. Henry S. Clark had retired from active politics and became a citizen of Greenville many years before his death. He was an ex-member of Congress, ex-State Solicitor, &c., had had a very successful career and was a man of decided ability and always went into politics to win as the following incident will show: In his canvass for Congress with Hon.
