WASHINGTON LETTER.

From Our Regular Correspondent.

WASHINGTON, D. C., Jan. 13.

The perfect discipline which prevails among the republicans in Congress and the ease with which a few leaders control the majority was well demonstrated on last Thursday when the House of Representatives voted for the Hepburn bill by a vote of 308 to 2. That the individuality of members is destroyed and the wishes of certain constituents sacrificed are of little moment to the party leaders compared with what they choose to consider the party good. One republican voted against the Hepburn bill, Mr. Loren Fletcher of Minnesota. When seen by your correspondent he stated that numerous members of his party had come to him after the vote and expressed the wish that they had dared vote as he had done, but the fear of the party lash doubtless prevented them from doing so.

There seems to be little doubt that the chief opposition to the construction of the canal now emanates from Senator Allison and Representative Cannon, chairmen of the appropriation committees of the Senate and House respectively. Both of these gentlemen express themselves as aghast at the amount of money which the enterprise will require. Mr. Cannon said yesterday: "The United States is a rich country and can well afford to undertake any enterprise which will make for its material welfare but that is not saying that it should enter into a vast undertaking of this nature without a most careful consideration of the prospective benefits and the most accurate estimates obtainable as to the eventual cost." Beyond that statement he refused to express an opinion.

The bill reported by the Census committee of the House came up as special business on Friday, in that body, and was productive of a spirited debate by Chairman Hopkins on the one side and Representative Burkett of Nebraska on the other. The fact that the measure provides for a salary of \$7,500 for Director Merriam, who is known to be a favorite of the administration, but who is receiving far greater compensation than the heads of other bureaus in the government, and the further fact that the protection of the Civil Service Commission was not assured to the clerks in the Census Bureau resulted in the bill's being referred back to the committee for revision. When the committee has made such changes as the members desire it will undoubtedly pass the House and it is believed to be regarded with favor by the Senate.

A TRAGEDY OF THE WOODS.

A story which comes from the Adirondack region is worthy of a place among Mr. Seton-Thompson's romances of animals. A young woman staying at one of the hotels went for a walk one day and wandered off into the woods, where she lost herself. Searching parties were sent out for her as soon as she was missed, of course, but the Adirondack Mountains are rather extensive territory over which to hunt one small woman, and seriousness was added to the situation by the fact that cold weather had set in and the wanderer was likely to die of cold if not from hunger before she could be found. Finally, however, she was discovered, safe and well though much exhausted by her journeyings; and the story she told was as strange as anything in fiction.

When utterly worn out and chilled, she had encountered a deer, who seemed to take in the fact that she was, if not of his own sort, at least a fellow-creature in distress. He stood by her a moment as she lay on the ground, and then laid himself down beside her, where the warmth of his body kept her from freezing as effectually as a fire would. When the searching party was heard approaching, he started up and stood at bay, and was shot where he stood.

There is really nothing more strange in this than in the well-authenticated stories of children befriended by bears and wolves in similar situations. It is, however, essentially, dramatic in its climax, and to a pessimist it might seem that this is the history of the wild animal in a nut shell. When left alone he is more than likely to be man's best friend but he generally gets shot for it in the end.

But Three Countries Outstrip the United States in Population.

The total population of the United States has grown nearly sixteenfold in 100 years. There are but three countries which now have a greater population than the United States, viz: China, the British empire and the Russian empire. China and the British empire have each of them probably between 350,000,000 and 400,000,000, or together nearly one-half of the total population of the earth. The Russian empire, with about 131,000,000 people, has more than half as many again as the United States, and has been increasing the century just closed with greater rapidity than any other European power. It had about 38,800,000 people in 1800, and has increased more than three and a half times during the nineteenth century.

France, including its dependencies, is the fourth country of the world in order of population and has about eighty-three and two-third millions, or almost the same number as the United States. Of these over 25,000,000 are in African dependencies, nearly 17,000,000 in Asia and 2,000,000 in Madagascar.

These five most populous countries together include over two-thirds of the estimated population of the world, which is placed by the best authorities at between 1,500,000,000 and 1,600,000,000.—Census Report.
