## OUR RALEIGH LETTER.

Special Correspondent of Reflector.

RALEIGH, N. C., Feb. 3.

How is the Democratic candidate for Senator to be nominated? is a question which some people are already showing a disposition to argue. Some objection is made, as usual, to leaving it to the legislative caucus as heretofore, but no really good grounds for it have yet been advanced. As to the primary method, it has few advocates hereabouts, or elsewhere in the State, as far as I can learn. Occasionally one hears a voice "demanding" that the State Convention nominate him at the same time it nominates candidates for a Chief Justice. Conservative Democrats generally appear to be averse to this, however, until an amendment to the Constitution is secured, providing for the election of Senator by the people, and the old modus operandi will probably be adhered to this time.

## LET'S SPEAK OUT IN MEETING.

The newspapers and commercial bodies of the various towns of the State, Chambers of Commerce, etc., can materially aid the committee, of which Major E. J. Hale is chairman, in securing as large an appropriation as possible for the improvement of Cape Fear river—if they will speak out in its favor, and surely that is a small thing to do, compared to the benefits involved. Not only all Eastern Carolina, but Central North Carolina and Western North Carolina are interested in this matter. It means a great deal to us.

There ought to be such sharp reduction in taxes as to bring the revenue down to a point where it would no more than meet the requirement of an economical administration of the Government. This should not be accomplished, however, by an indiscriminate repeal of what are called "war taxes." Some of the war taxes bear much more equitably upon the taxpayers than tariff taxes on hides, iron ore, coal and lumber, for example. Not an extra unnecessary dollar should be drawn from the pocket of the taxpayer, but in lightening the burden his interest should be so far considered as to retain that part of it most easily borne, cheaply collected and fairly distributed.—Philadelphia Record.

It has been discovered that adulterated bran is being sold for feed-stuff in Greensboro. An examination of some of the stuff revealed cornstalks, cobs and sawdust ground up into a very good imitation of wheat bran. It is said that one horse died from eating a quantity of it.

## Mistakes of Women.

One of the mistakes of women is not knowing how to eat. If a man is not to be fed when she is, she thinks a cup of tea and anything handy is good enough. If she is exhausted, she will write letters or figure her accounts. She would laugh at you if you hinted that reading or writing could fail to rest her. All over the country women's hospitals flourish because women do not know how to rest.

Another mistake on the list is their constant worrying. Worry and hurry are their enemies, and yet they hug them to their bosoms. Women cross bridges before they get to them, and even build bridges to cross. They imagine misfortune and run out to meet it.

Women are not jolly enough. They make too serious a business of life, and laugh at its little humors too seldom. Men can stop in the midst of perplexities and have a hearty laugh. And it keeps them young. Women cannot and that is one reason why they fade so early—there are other reasons, but we will pass them now. Worry not only wrinkles the face; but it wrinkles and withers the mind. Have a hearty laugh once in a while, it is a good antiseptic, and will purify the mental atmosphere, drive away evil imaginings, bad temper and other ills.—Buffalo Times.

### SILK CULTURE IN NORTH CAROLINA

The recent publication in the Bulletin of an article on silk culture in North Carolina has already borne fruit. Several requests have been received from persons at a distance for copies of the Bulletin, one coming from the State of Michigan, and one from a Company in New York which possesses ample capital and which proposes to establish silk farms and silk mills in some of the Southern States, where suitable land can be had at a reasonable price, and where convenient power may be available when needed. If North Carolina can secure the location of this Company it means the opening of a new and very important industry for the State. Letters received at the Department of Agriculture from this Company declare the purpose of the President and other officers to visit North Carolina, and perhaps other Southern States, at an early date, for the purpose of examining lands and mill sites: for observing climatic conditions, adaptability of the land for growing mulberry trees, and to secure such other information as they may desire with reference to establishing their business.

It is desirable to have descriptions of lands which are for sale, and upon which the Chinese mulberry thrives. The owners of such lands are requested to file with the Department descriptions, including the present condition of land and buildings, distance from railroad, accessibility to water power, how much cleared and uncleared land, whether any Chinese or white mulberry trees are now growing upon the land, price, etc.

In this connection the Department desires to secure the names of persons in the State who have had personal experience in growing silk worms, and who might desire to produce raw silk for the new Company.
