THE NORTH CAROLINA ANTI-SALOON MOVEMENT.

[CONTINUED FROM YESTERDAY.]

If then, the saloon is the worst possible medium of a traffic which is recognized by law as the fertile breeder of disorder and crime, it is reasonable to hope that a union can be affected of all who are opposed to the worst and in favor of a better solution of a confessedly difficult problem. And this movement proposes to unite all these. It welcomes to its ranks not only the Christian men of all denominations, but the decent, sober, moral men of each community who are in favor of decency and sobriety and morality. Those who believe that total abstinence and temperance are one and the same and those who make a distinction between them, those who believe in prohibition as the correct solution of the problem, those who are favorable to the dispensary system and those who will accept the dispensary as a stepping stone to prohibition can all stand together in united opposition to the saloon. Nor is it the intention of the inaugurators of the new movement to determine what form this opposition to the saloon shall take. Local questions should be settled in view of local conditions as seen by the men on the ground.

It is not a church movement, though it is one that should appeal to all Christians; it is not a woman's movement, though the aid of the women will be invaluable; as we know—God bless them—that their prayers will be incessant, for theirs is the suffering and the shame of innocence, bound by ties of blood and affection, to vice. It is not a political movement, though it is not going to be content with conventions and resolutions while the saloon sends its creatures to represent its interests in the halls of legislation. And we hope to keep the fanatics, bless their hearts, fighting in their own way in the ranks, because they are too valuable material as soldiers to waste in any merely official capacity.

As thus the platform and principles of this movement are set forth, can any man who loves the Kingdom of Christ, withhold his influence and aid? Can any man who loves his kind?

As a member of the executive committee the undersigned will be glad to receive and forward to the committee the names of any who can give their time and labor to the cause in their own localities. A committee of One Hundred, from every section of the state will soon be selected and will be called to meet in Raleigh, where the headquarters of the movement have been established.

And we are in it to stay.

Those who are in favor of fewer drunkards, fewer drunkards' wives and drunkards' homes and drunkards' graves, will please help us. We are not expecting the millennium immediately in North Carolina. But neither are we in favor of enlarging hell.

Wednesday's press dispatches gave full account of Miss Stone's release from the brigands, while Thursday's corrected the report again. And so it goes.

Business men say cash books have contained very small entries since the snow came. After a week doing almost nothing they are wishing for weather that will bring out trade.

It is claimed, says a Raleigh correspondent, that North Carolina produces more hay to the acre than the Western and Northern States. In spite of this claim, North Carolina is a large purchaser of Western hay.

A daily paper, the Observer, recently started at Gastonia, suspended after an existence of eight days, the reason assigned being that there was not enough patronage to continue it. The man who starts any business, more especially a newspaper, without being able to calculate more than a week a head, shows poor judgment. A newspaper that paid expenses the first week would be a gold mine, in fact if a paper gets on a paying basis even in a year it is a good enterprise. Don't start a newspaper unless you want to do plenty of work and see your bank account grow slow.

President Roosevelt has at last made public his opinion in the Sampson-Schley controversy, but considering that he had so much matter to go over—he says he carefully read it all—he done well to get through this soon. The President takes a middle ground position, praising Sampson for what he done and praising Schley for what he done. But as to that 3rd of July smash-up of the Spanish fleet off Santiago, the President says neither of them is entitled to any unusual credit, it being "a Captain's fight." All the same, the people are with Schley and do not think he has been treated justly since the war ended.

CHARITY IMPOSED UPON.

The Greensboro correspondent of the Raleigh Post says:

This thing of dispensing sweet charity, is a peculiar business, as Chief of Police Scott and other city officials can testify. Although the weather has moderated to a considerable extent, the calls for help are increasing in number rather than decreasing. When asked this morning how he accounted for this, Chief Scott said he supposed it was because many people were just learning that the city had "wood to burn" and was giving it away to all comers. While in police headquarters for a few minutes this morning The Post correspondent counted just six people who came for assistance. Some of them wanted wood and some wanted groceries, and some wanted a little of both, but all appeared to think that the city should furnish these supplies as a matter of course. One stout and healthy looking negro woman, who said all she lacked of being a widow was having a funeral from her house, came in and asked for bread for herself and her nine children and a load of wood to keep the family warm. There is no doubt that much of this charity is misapplied, and therefore much of it is not charity. For instance, six different negro women came to police headquarters during the day for wood and eatables. Each was given an order for wood and groceries. Late in the day an employe of the city discovered that all six of these women lived together in one house, half of which had been turned into a temporary wood shed. There was wood everywhere, while tables and chairs held sacks of flour, packages of meat and other things. These women, and there are others like them, were intent on but one thing—getting everything possible while things were going free. And there is no limit to the gall of these kind of people.

This is usually the case where there is any general movement to dispense charity in a town. The lazy, vagabond class are the ones who get most of what is given away, while the really needy are neglected. Greenville had some experience along this line a few years ago that taught the town a lesson. Instead of having relief headquarters opened to receive applications, it is better to have a committee to hunt up the really needy and help those only. Then it is an act of charity.

The Jacksonville (Fla.) Times-Union remarks that hot many years ago, in Leon county, the grass that grew there was looked upon as a curse, and now it is that county's most profitable crop. As time progresses farmers make some valuable discoveries. If some of the farmers in North Carolina spent as much time and worked half as hard cultivating grass as they do in trying to kill it they would be four times as well off.

A suit has been brought by Louis Whitfield, colored, as administrator for the estate of his brother, Geo. W. Whitfield, against the Atlantic Coast Line Co. for \$10,000 damages. The suit is brought through Whitfield's attorneys, Mess. Wooten & Wooten. It will be recalled by our readers that Joe Whitfield was killed by a Coast Line train near Grifton last May. He was riding on the cow catcher of the engine and either fell off or frightened off by Engineer Turrentine, and in some manner was caught under the wheels and killed. It will also be recalled that a wreck had occurred to the same train, at Greenville. The prosecution will introduce testimony to prove that Whitfield was asked or employed to go to Greenville to assist in doing the necessary work to remedy the wreck. They will allege that he had a right on this account to return to Kinston on the train and that it was through the fault of the railroad's agents that he was killed. Proper papers to bring the suit will be filed with the clerk tomorrow. These have to wait through a term of court to give the defense an opportunity to file a reply. The case consequently will be heard at the April term of court.—Kinston Free Press, 19th.

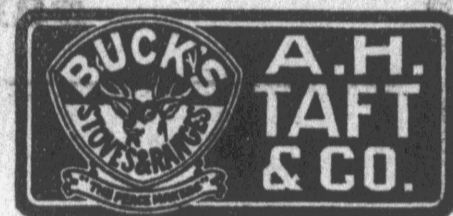
