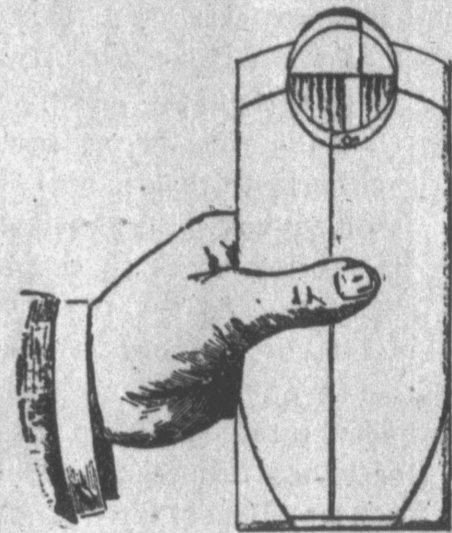
First--That the church has lost a true, conscientious and faithful member and the vestry of Saint Paul's Parish has lost its most valued councilor and co worker.

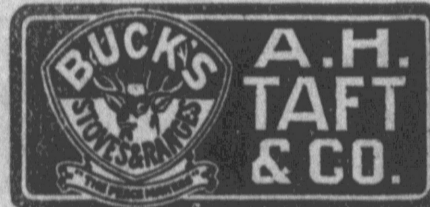
