Little Girls Seek Work.

Thinking they had only to reach Richmond to secure immediate employment at wages enabling the employment of all the luxuries of life in the city, two forlorn and bewildered little North Carolina girls alighted from a Southern Railway train at the Fourteenth street station yesterday evening. They were 14 and 15 years of age, and according to their story were neighbors in Greenville, N. C., where they were born and had lived their entire lives until this venture into the outside world of which they have so little knowledge. They came to Richmond to get work.

They had heard of the place and were looking for their only acquaintance here, Mrs. Hart, whose daughter worked in the baking powder factory. What Mrs. Hart or what baking powder factory they did not know.

In the stream of passengers who alighted from the train and worked their way toward the car lines and carriages, the two lost and shrinking children were unnoticed, but as the crowd thinned out, they were left pitiable figures, crouched into a small corner of a waiting room seat. Here they were found and told their story.

Persons interesting themselves in the little runaways, for such they seemed to be, communicated with the first police station and at once Officer Robinson, of that district, took them in charge and became their escort to the Woman's Christian Association building on Seventh and Franklin. There they were taken in for the night. Today they will in all probability be returned to their homes.

They told different stories as to their leaving home. To some they said they were sisters and orphans, while to others who questioned them they said they left home with the permission of their mothers.

The matron of the association building said last night that she was quite certain they had run away.

One of the girls is very small for her age, but the other is larger and is the spokesman of the two. They said they had worked in tobacco factories at their home and hoped to get such employment here.—Richmond Dispatch, 7th.

Perhaps this is a "fish" story. We have not heard of any girls leaving Greenville, nor are there any tobacco factories here in which white girls work.

Postoffice Building to be Closed at night.

Ever since lock boxes have been used in the Greenville postoffice it has been the custom to leave the front of the building open all night so that people could get to their boxes at any hour. The government has declared this dangerous to the office, as no doubt it is, and Postmaster Perkins says he has been instructed to have the building closed each night at 9 o'clock. A letter box will be placed at the door in which people can drop mail after the office has closed for the night.

Dog Tax.

The following is a copy of the handbills distributed by the police, relative to the dog tax:

Pay your dog tax. By reference to town ordinance, chapter VI, Section 5, you will find these words: "Every dog found running at large on the streets without a badge denoting that taxes have been paid on such dog, shall subject the owner to a fine of Two Dollars for each offence, and in case of ownership by a minor, the minor's parent or guardian shall be liable for above fine, and in the event no owner can be found, said dog shall be killed by the police after ten days advertisement."

Take Notice! That we intend that the taxes on all dogs shall be paid this year, and if you wish to avoid a warrant and cost of trial, you had better procure you a badge at once for your dog. The Police will patrol each street and all dogs found on the street at any time will subject the owner to prosecution in the Mayor's court.
