Washington Letter

Special Correspondence from the Capital of the Nation.

WASHINGTON, D. C., Oct. 11.

President Roosevelt is still "strenuously striving" to end the coal strike but so far has accomplished nothing. The lack of unity in his own party, the fear that some of the New York financiers express in regard to the President's policies, and the extent to which the capitalists of the country, including the coal mine operators, have succeeded, during a long period of republican supremacy in the national legislature, in hedging themselves about with laws which prevent federal interference with their most nefarious practices, have all contributed to the futility of Mr. Roosevelt's efforts. Now, when republican supremacy is threatened, when the people seem about to demand retribution at the polls, a republican president finds himself powerless to avert the catastrophe. Attorney General Knox, in his usual "philandering" way, has ordered an investigation to ascertain if a coal trust exists. Presumably, some time in the distant future, he will be informed that there is one and then he will institute legal proceedings which will progress with the same lack of rapidity as his suits against the beef trust and the Northern Securities Company. Meanwhile the public will suffer.

President Roosevelt recently appealed to the president of the coal miners union to send the men to work, promising an investigation of their alleged wrongs by a commission to be followed in turn by the recommendation of proper legislation. While president Mitchell has not yet replied to this proposition it is understood that his answer will be in the negative. Doubtless the miners remember how little attention was paid to Mr. Roosevelt's recommendations, made to the last session of Congress, for compulsory publicity of trust statistics and methods. They also remember how the President's earnest appeal for Cuban reciprocity was ignored by his own party and they have, therefore, little faith in the success of any recommendation Mr. Roosevelt might make. They appreciate that while the republican party dominates Congress, an appeal for their rights which must be obnoxious to the capitalistic class of the country, will receive no consideration. Under the pressure brought to bear by the President, Gov. Stone has finally ordered the entire military strength of Pennsylvania to the scene of the coal strike and now the operators have the opportunity to make good their claim that they can mine sufficient coal to meet present demands, irrespective of the miners' union.

Reports received at democratic headquarters in Pennsylvania are of a most encouraging character. It seems more than probable that Hon. Robert E. Patterson will defeat Senator Quay's candidate for governor. It will be remembered that the republicans of Pennsylvania wanted Attorney General John P. Elkin for gubernatorial candidate, but Senator Quay feared the growing popularity of Elkin and regarded it as a menace to his own boss-ship. Therefore he went to Harrisburg and forced Samuel W. Pennypacker on the convention. As a result, republican enthusiasm has waned and the democrats are growing enthusiastic over the chances of electing their candidate. It will further be remembered that the democratic candidate has already twice defeated the republicans in the Keystone state, once in 1882 and again in 1891. That he will do so again in 1902 is the prediction of many Pennsylvania democrats.

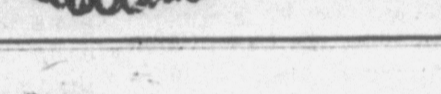

Scientific Knowledge Applied to Boiling Potatoes.

We often hear the remark that some would be cook "cannot boil potatoes." The truth is few cooks prepare this dish properly, says Alice Dynes Fealing, B. S., in Good Housekeeping. The girl who understands science knows that the potato does not boil. The water boils, and the heat conveyed by this medium cooks the potato. Physics has taught her that under ordinary pressure water never becomes any warmer after the boiling point (212 degrees F., 100 degrees C.) is reached. Therefore she allows the water to remain at boiling temperature until the heat has penetrated and cooked the vegetable. She then removes the water at once and has a mealy, flaky potato. True, without her knowledge of science she might obtain the same result accidentally, but she is quite as likely to continue the cooking until the starch is partly dextrinized, and a gummy, sticky potato is the result. The unscientific cook is quite likely to endeavor to hasten the cooking process by adding fuel to the fire, thus causing violent boiling, believing that she is thus attaining her object. She may cause the vegetable to break by the mechanical action of the water, or the liquid may splash over on the stove or pass off in steam, but in no case is the cooking accomplished in less time.

An Explanation by Reed.

John Palmer, formerly secretary of state of New York, and ex-Speaker Reed are personal friends. Mr. Palmer once called on Mr. Reed in Washington, and the two had a long discussion of the personal characteristics and traits of the then members of the house. At length they spoke of a member who was so bowlegged that General Palmer said he reminded him of the traditional man who had to have his trousers cut with a circular saw.

"What on earth could ever give a man such bow legs?" he mused. "I don't know," replied the ex-speaker, "but he looks as if he had gone up in a balloon and walked back."—New York Times.

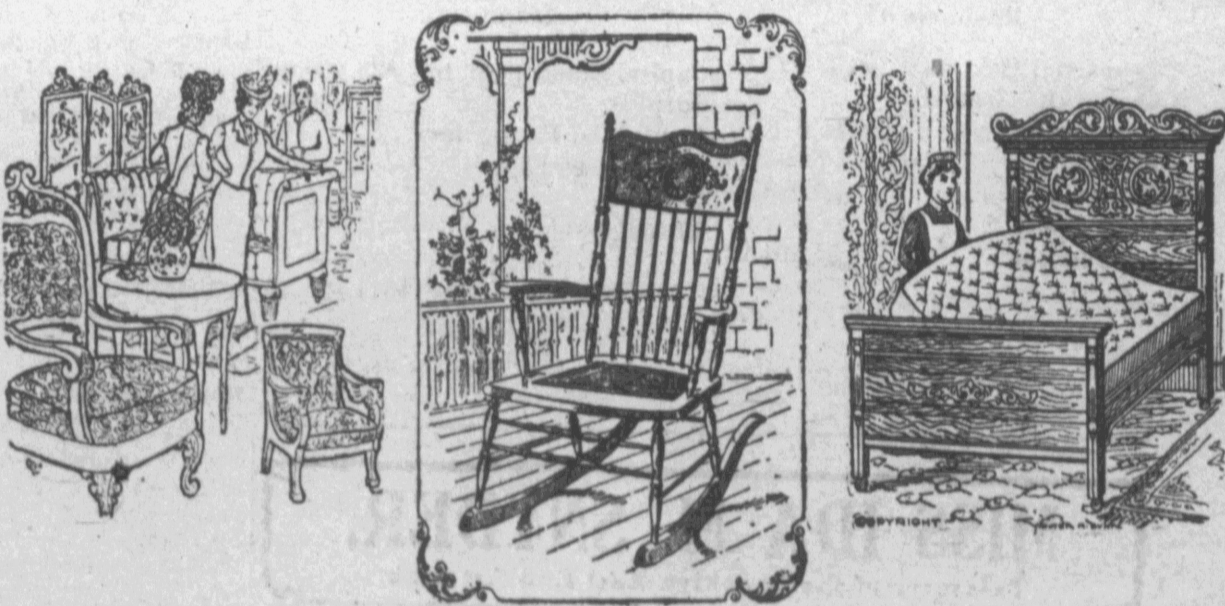
